The ornamental design for a handle with clip, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of a handle with clip of the present design.

FIG. 2 is a top plan view of the handle with clip shown in FIG. 1.

FIG. 3 is a left side elevational view of the handle with clip shown in FIG. 1.

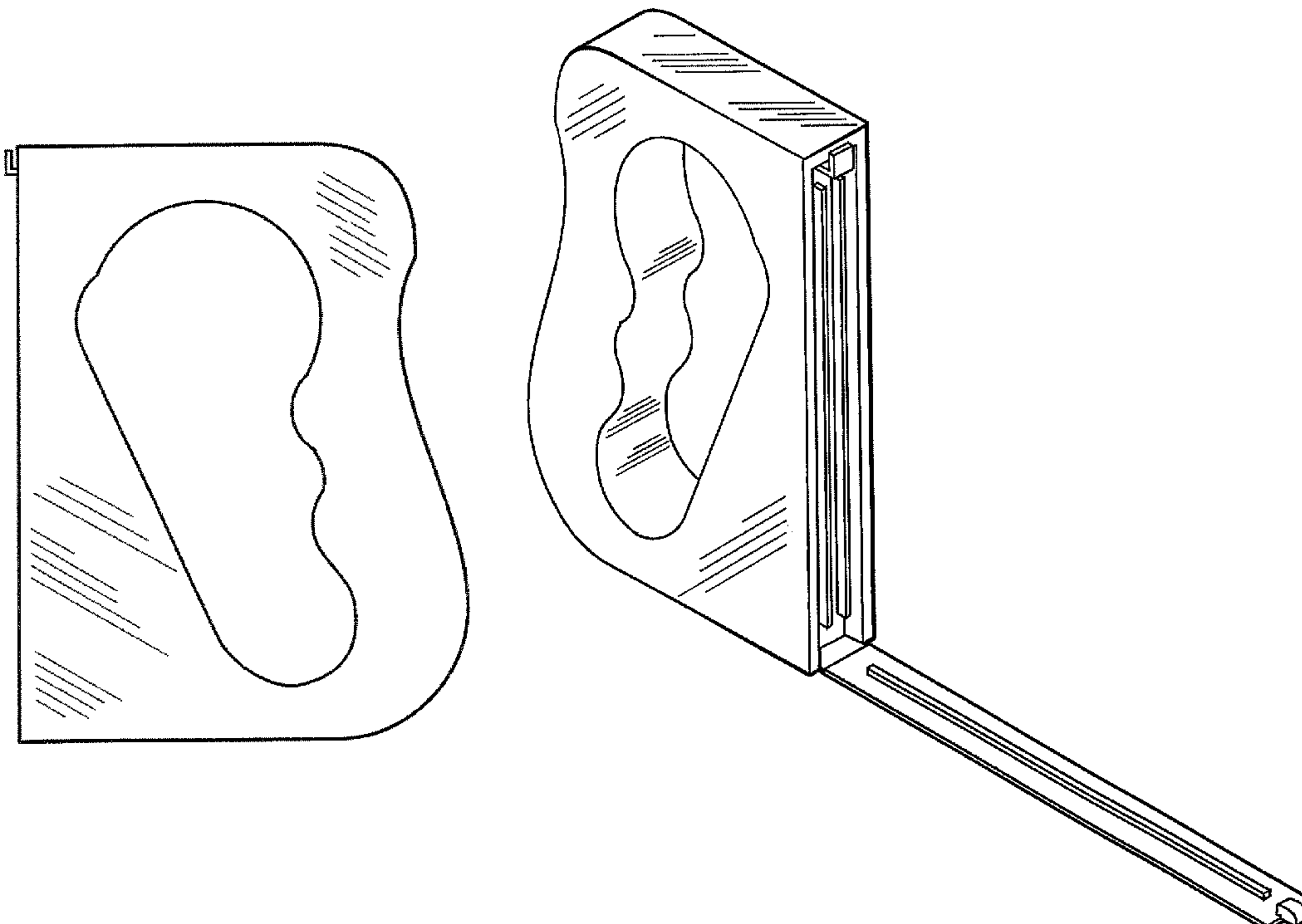
FIG. 4 is a bottom plan view of the handle with clip shown in FIG. 1.

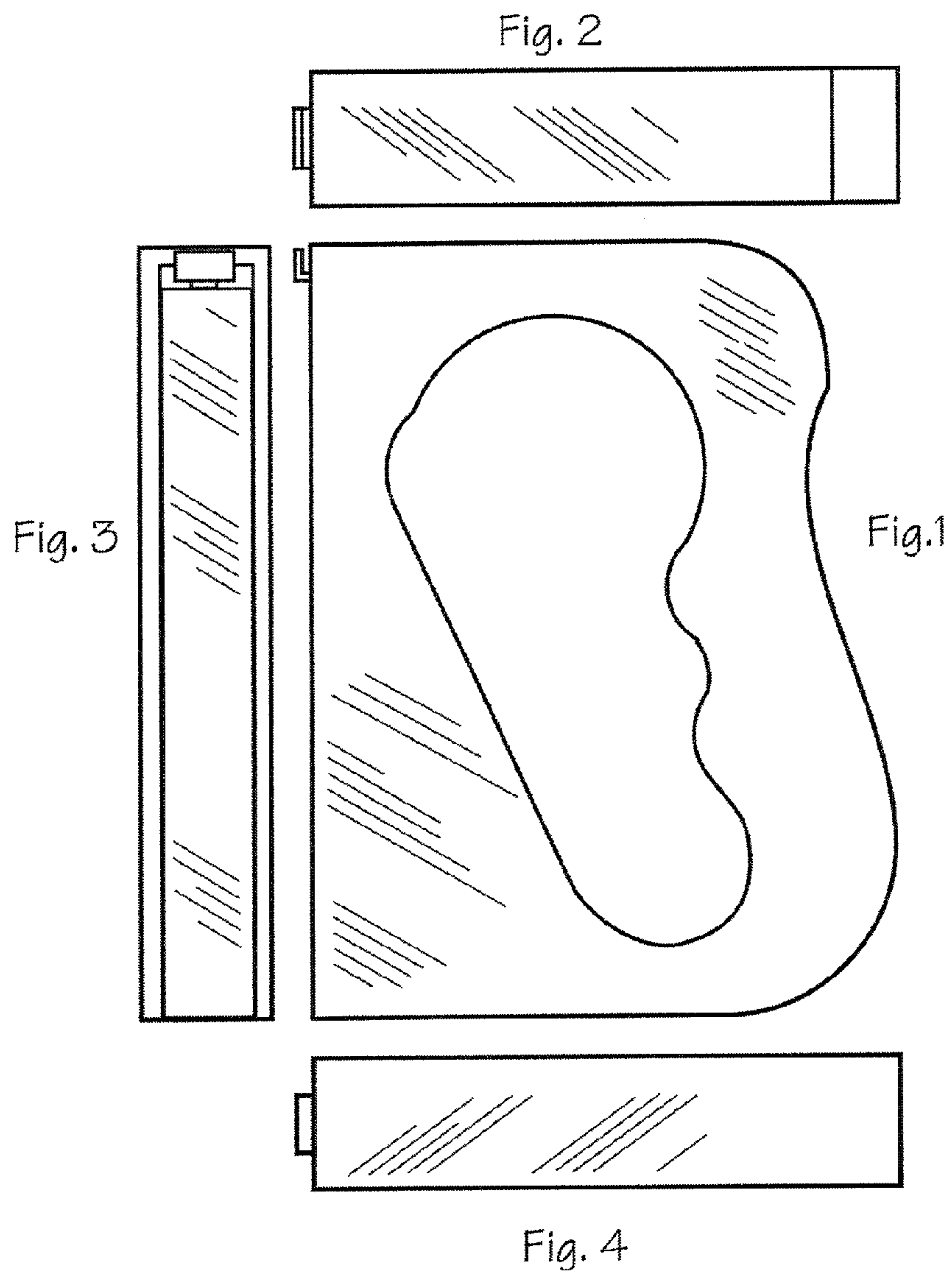
FIG. 5 is a rear perspective view of the handle with clip shown in FIG. 1, wherein the clip is in an open position.

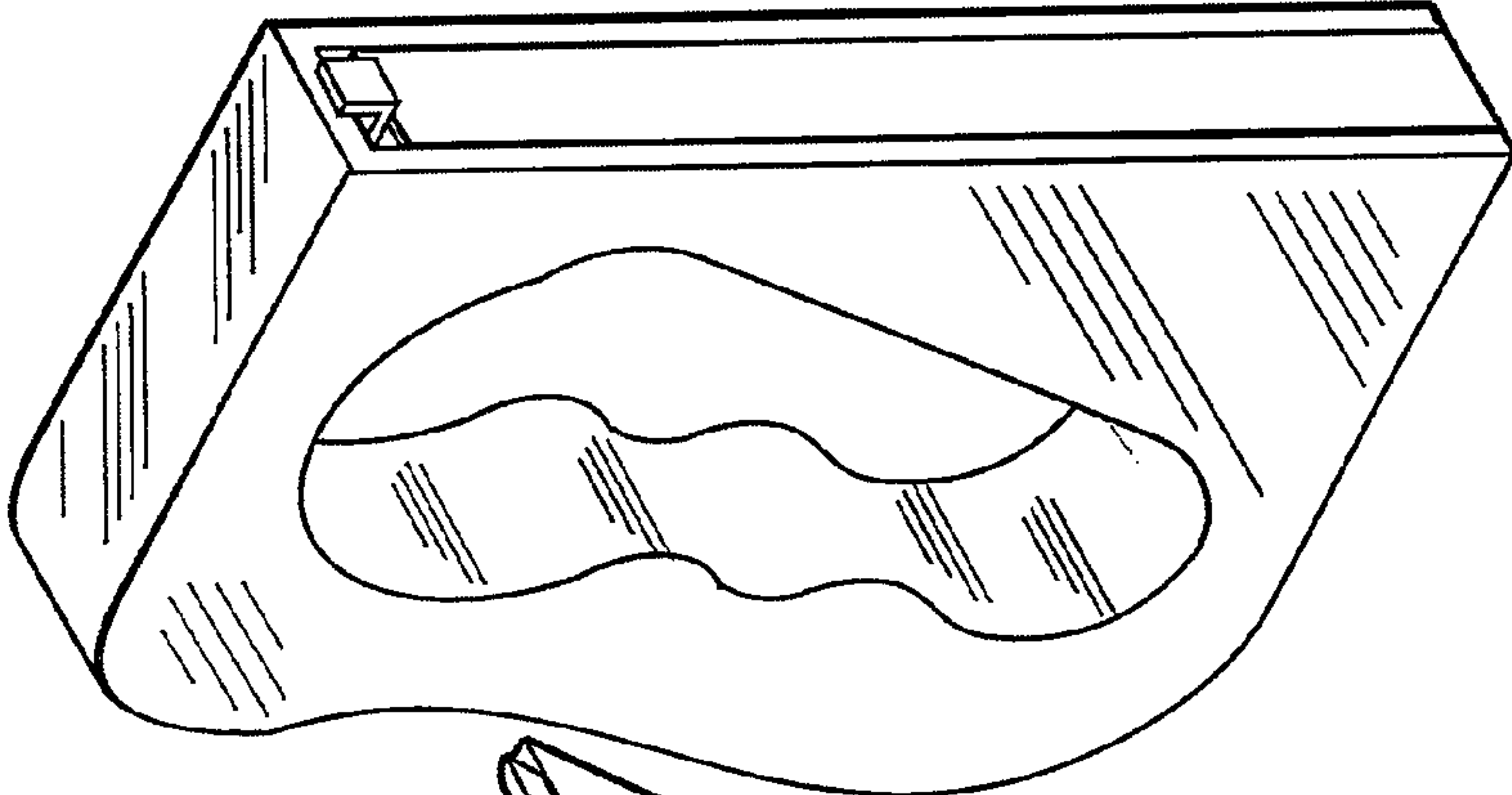

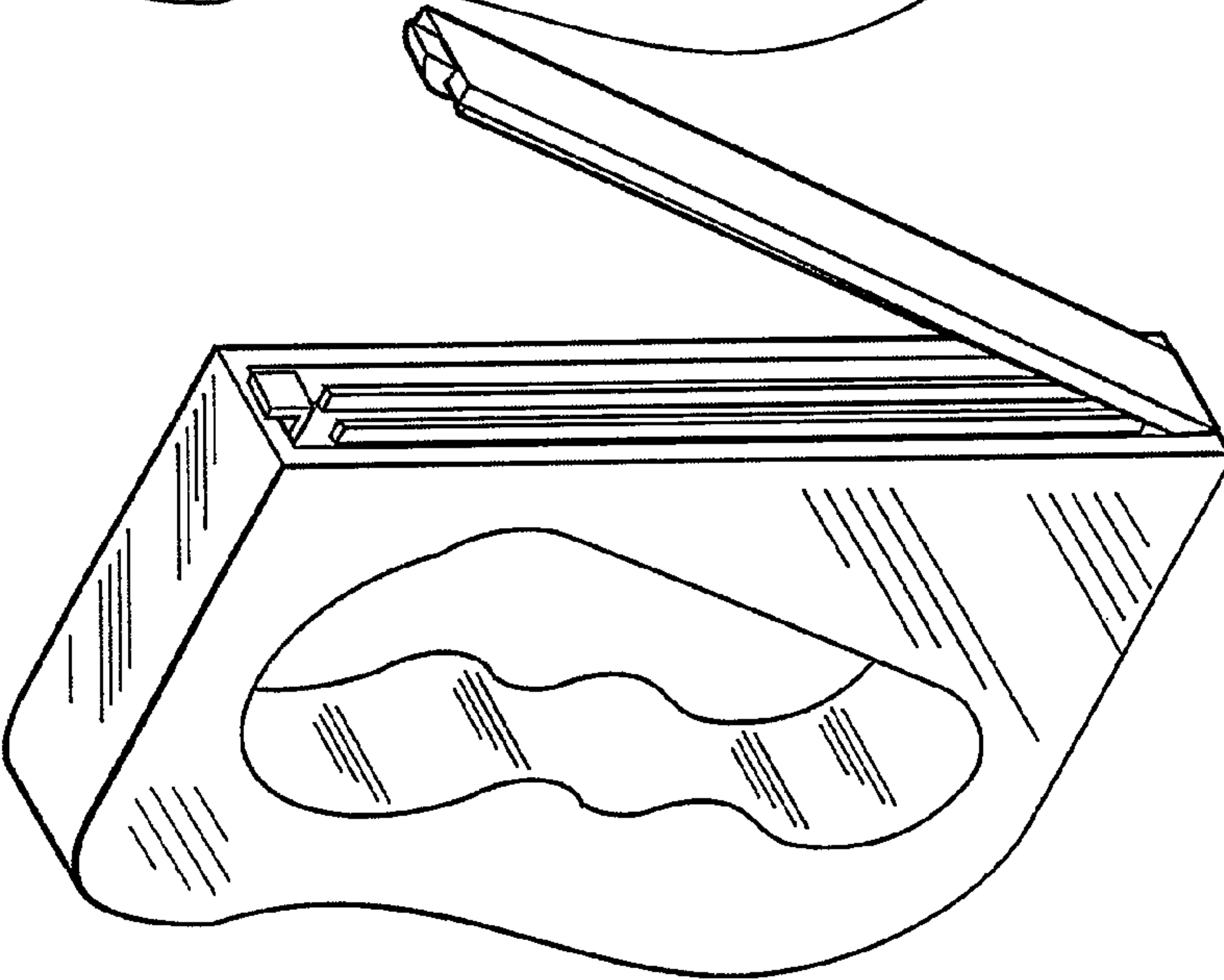

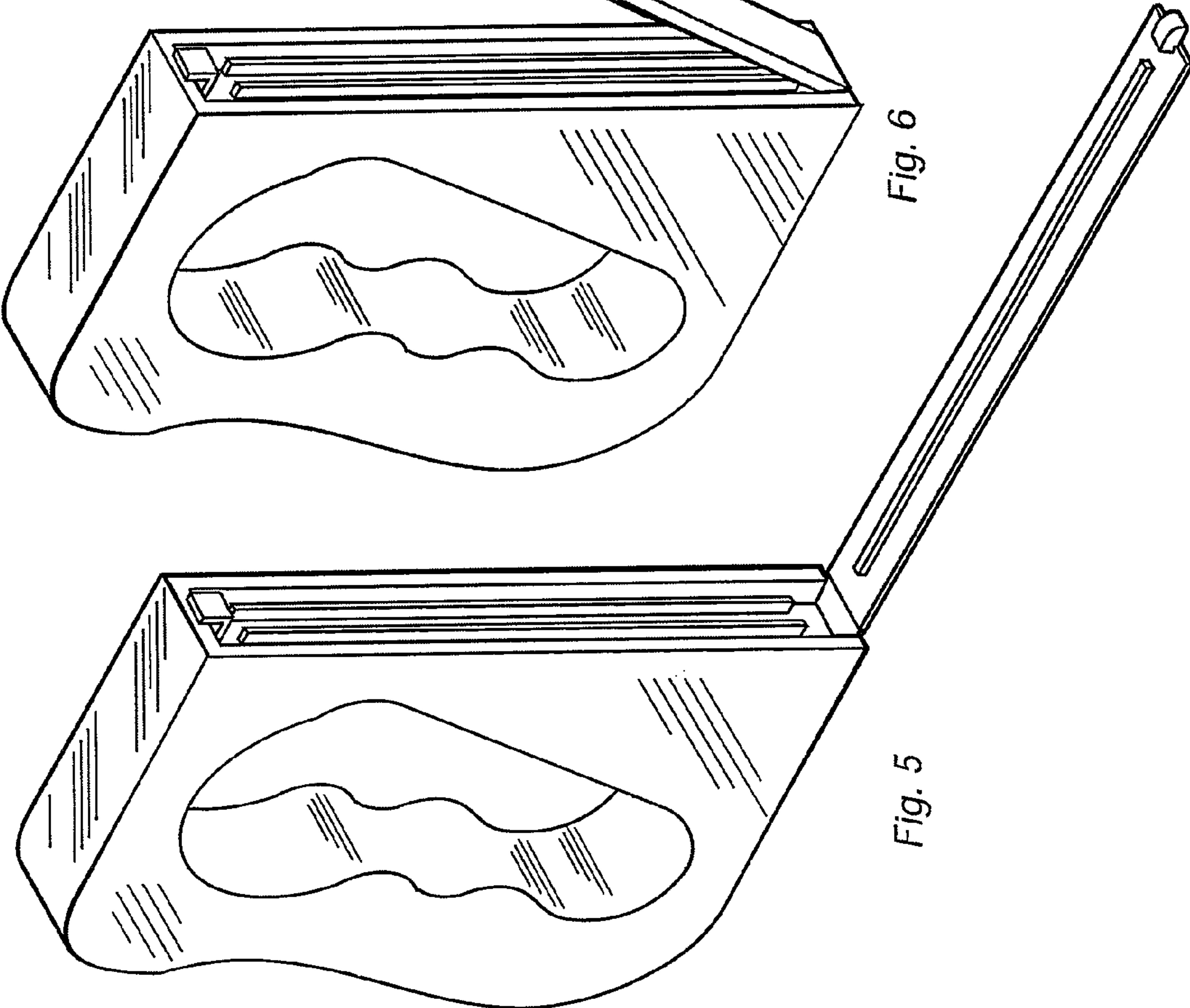
