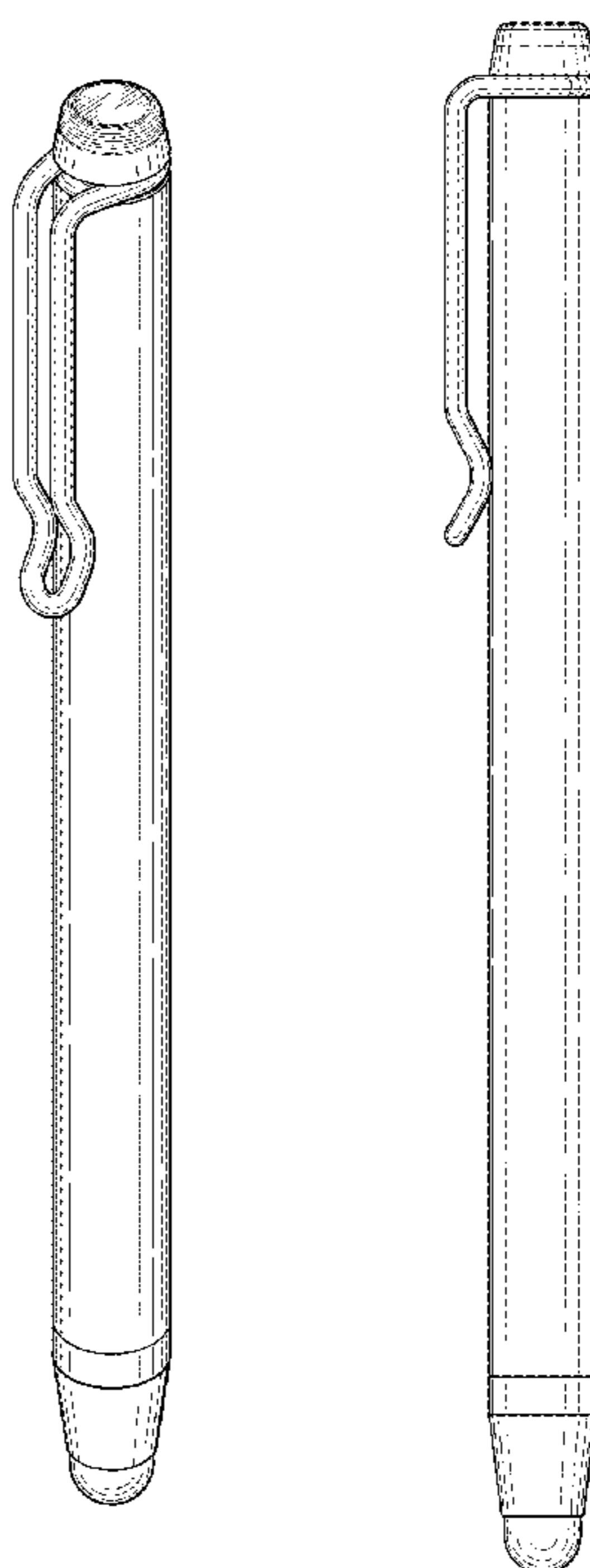
(57) **CLAIM**
The ornamental design for a stylus pen, as shown and described.

DESCRIPTION

FIG. 1 is a top front right perspective view of a stylus pen showing my new design;
FIG. 2 is a bottom front right perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a right side elevation view thereof, wherein the left side elevation view is a mirror image of the right side elevation view;
FIG. 5 is a rear elevation view thereof;

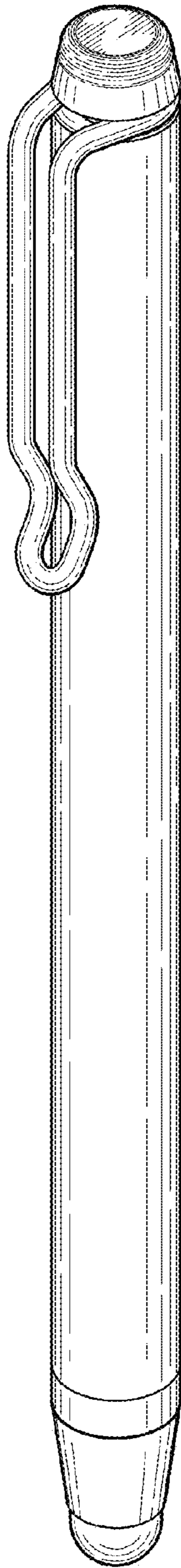

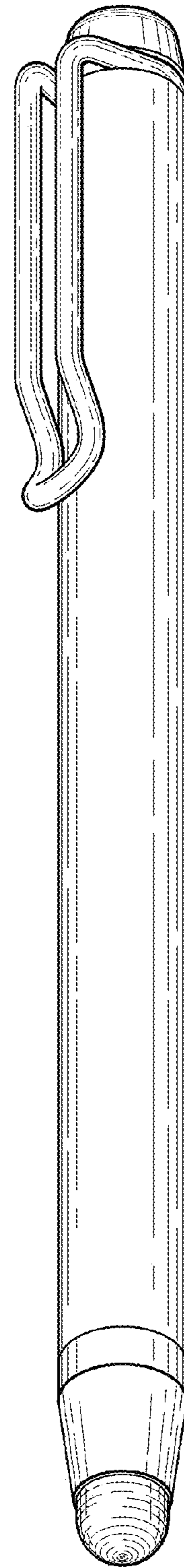

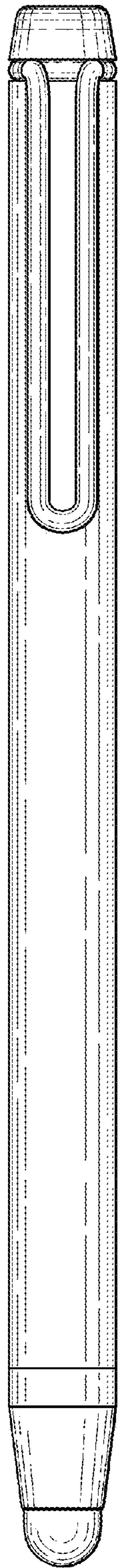

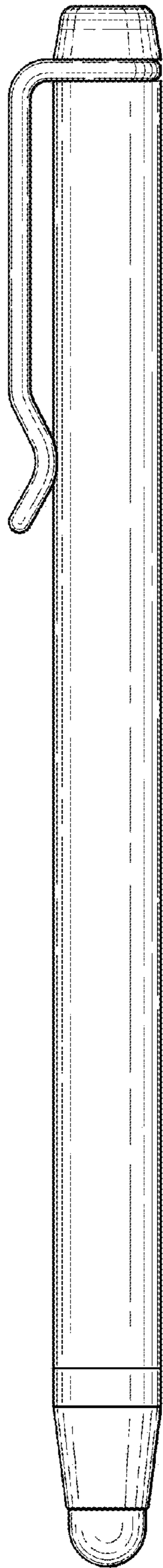

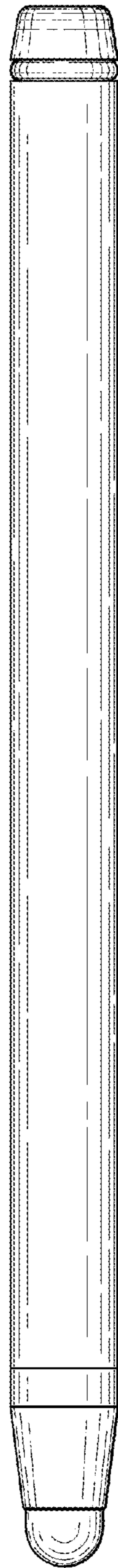

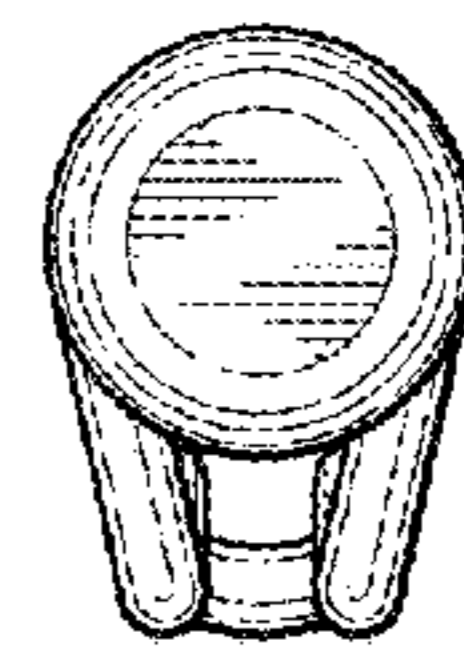

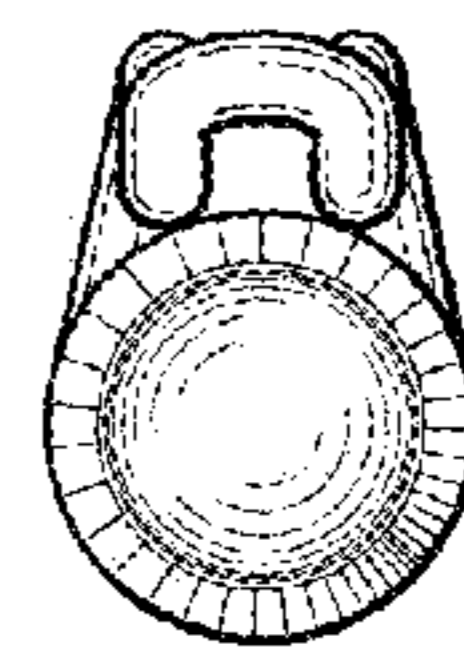
