(57) **CLAIM**

We claim the ornamental design for a display panel of a programmed computer system with a graphical user interface and an animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display panel of a programmed computer system with a graphical user interface and an animated graphical user interface.

FIG. 2 is a front view of a second embodiment of the display panel of a programmed computer system with a graphical user interface and an animated graphical user interface.

FIG. 3 is a front view of a third embodiment thereof, the first image of a display panel of a programmed computer system with an animated graphical user interface; and,

FIG. 4 is a front view of a second image thereof.

The broken line showing of a display panel is included for the purpose of illustrating environmental structure and forms no part of the claimed design. The broken line showing within the graphical user interface and the text form no part of the claimed design. The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 3-4.

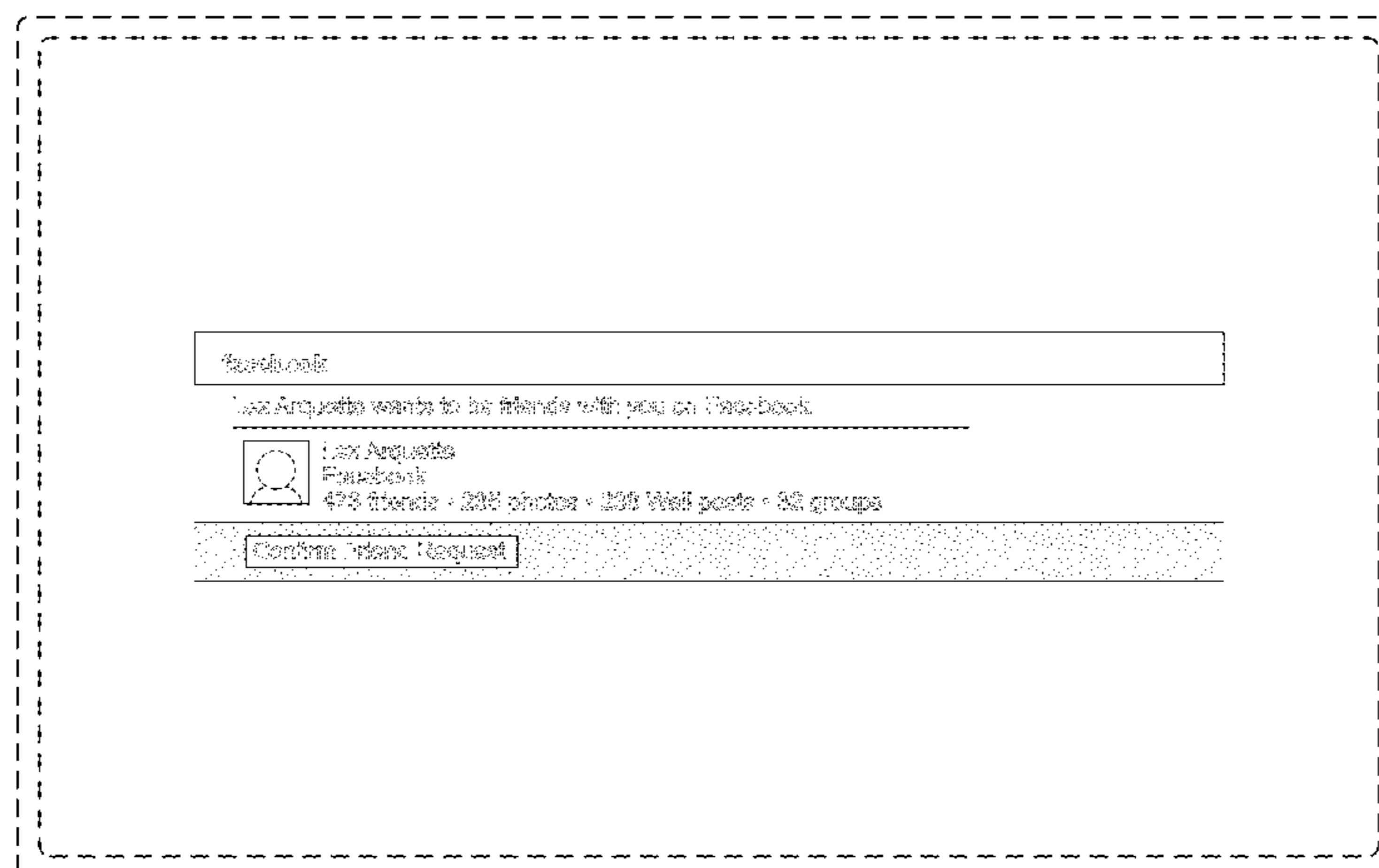
The process or period in which one image transitions to another forms no part of the claimed design.

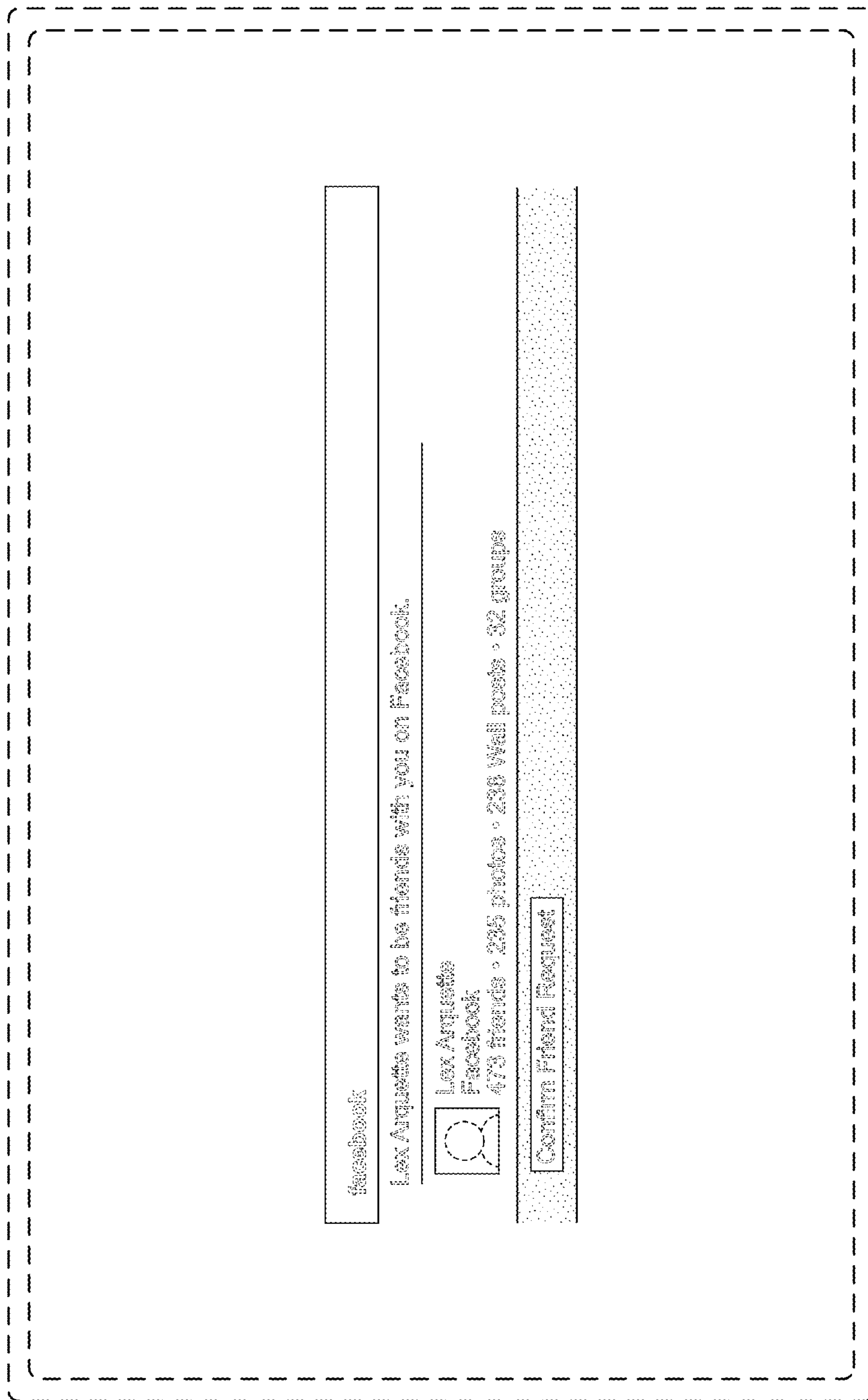

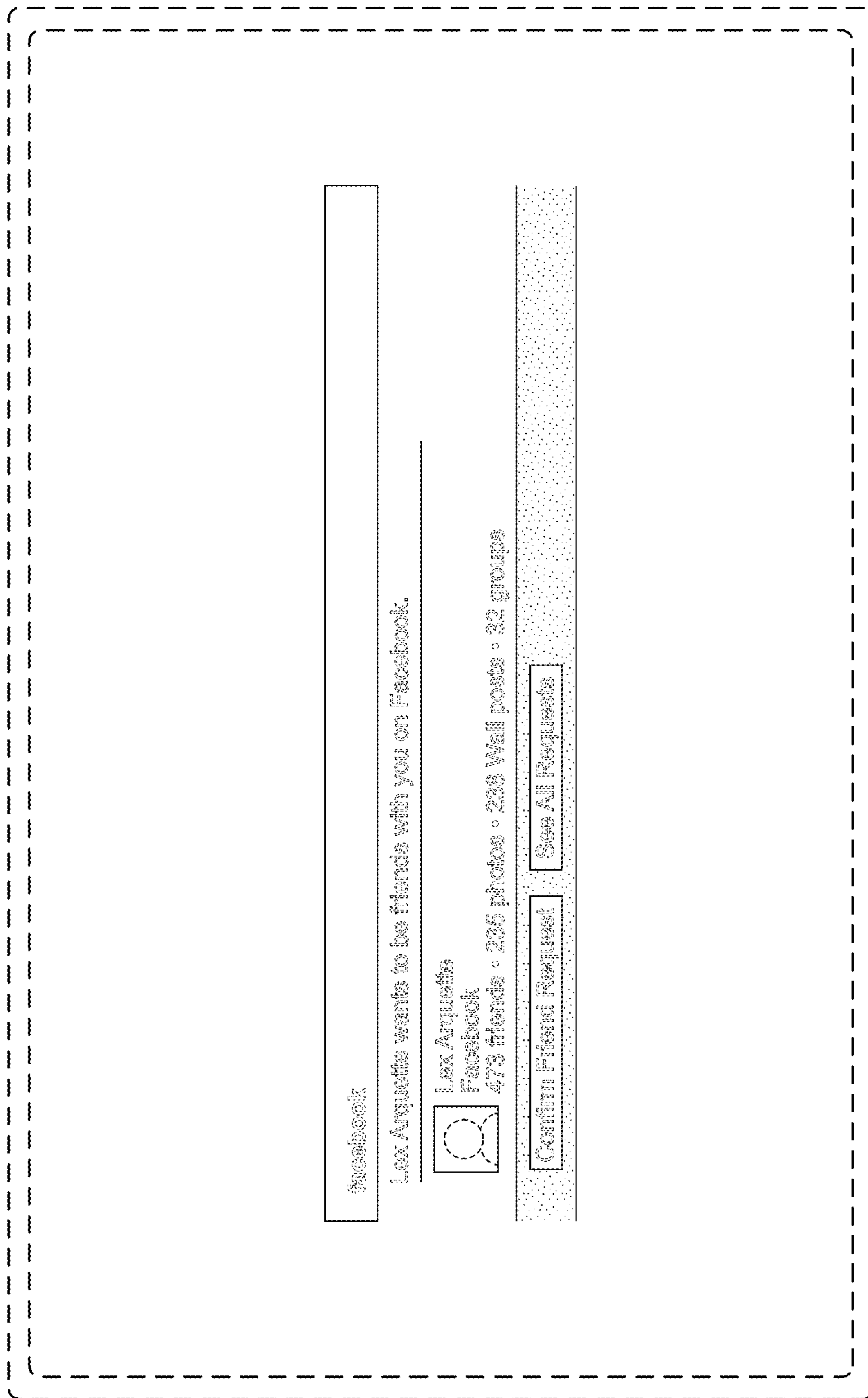

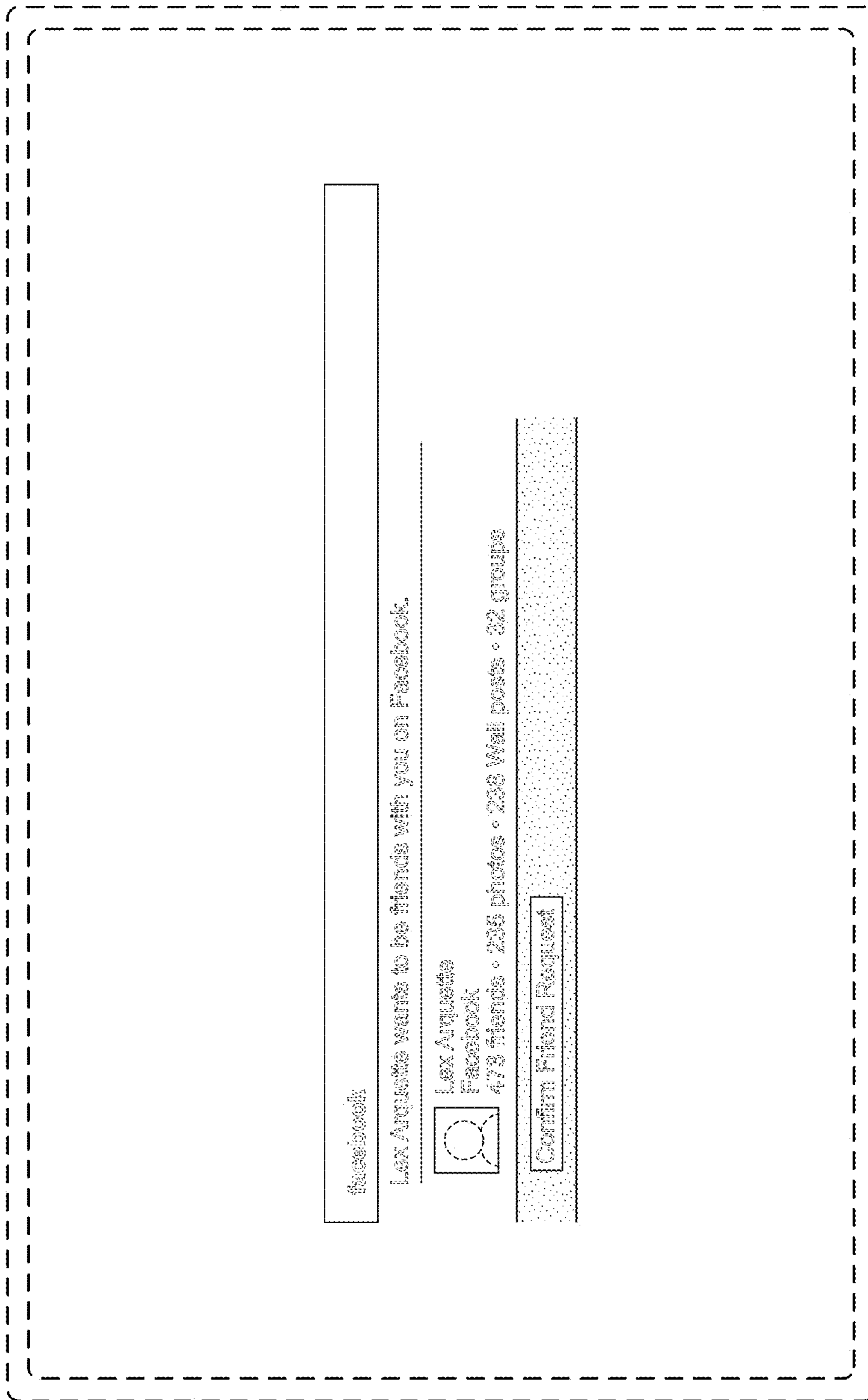

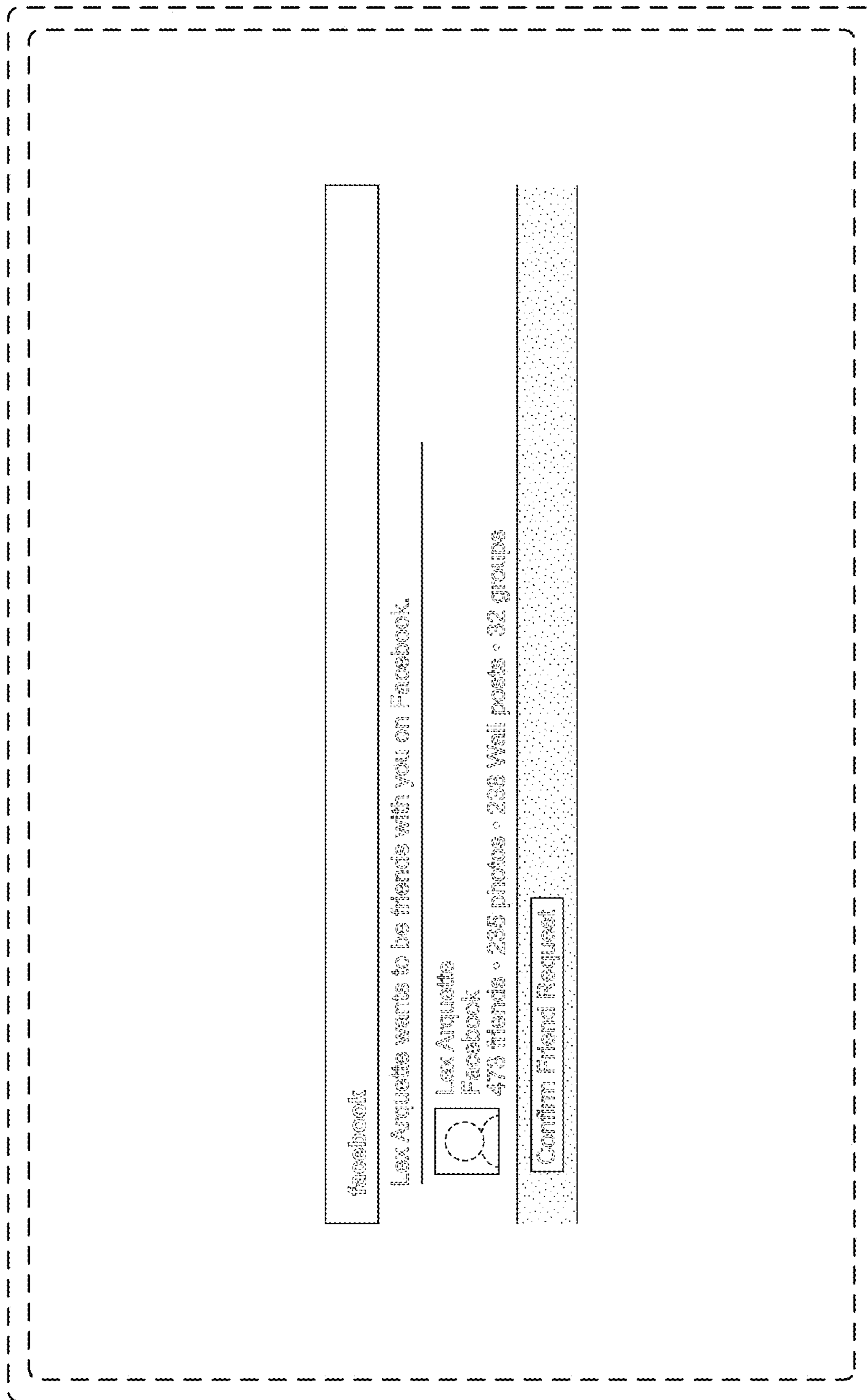
