**DESCRIPTION**

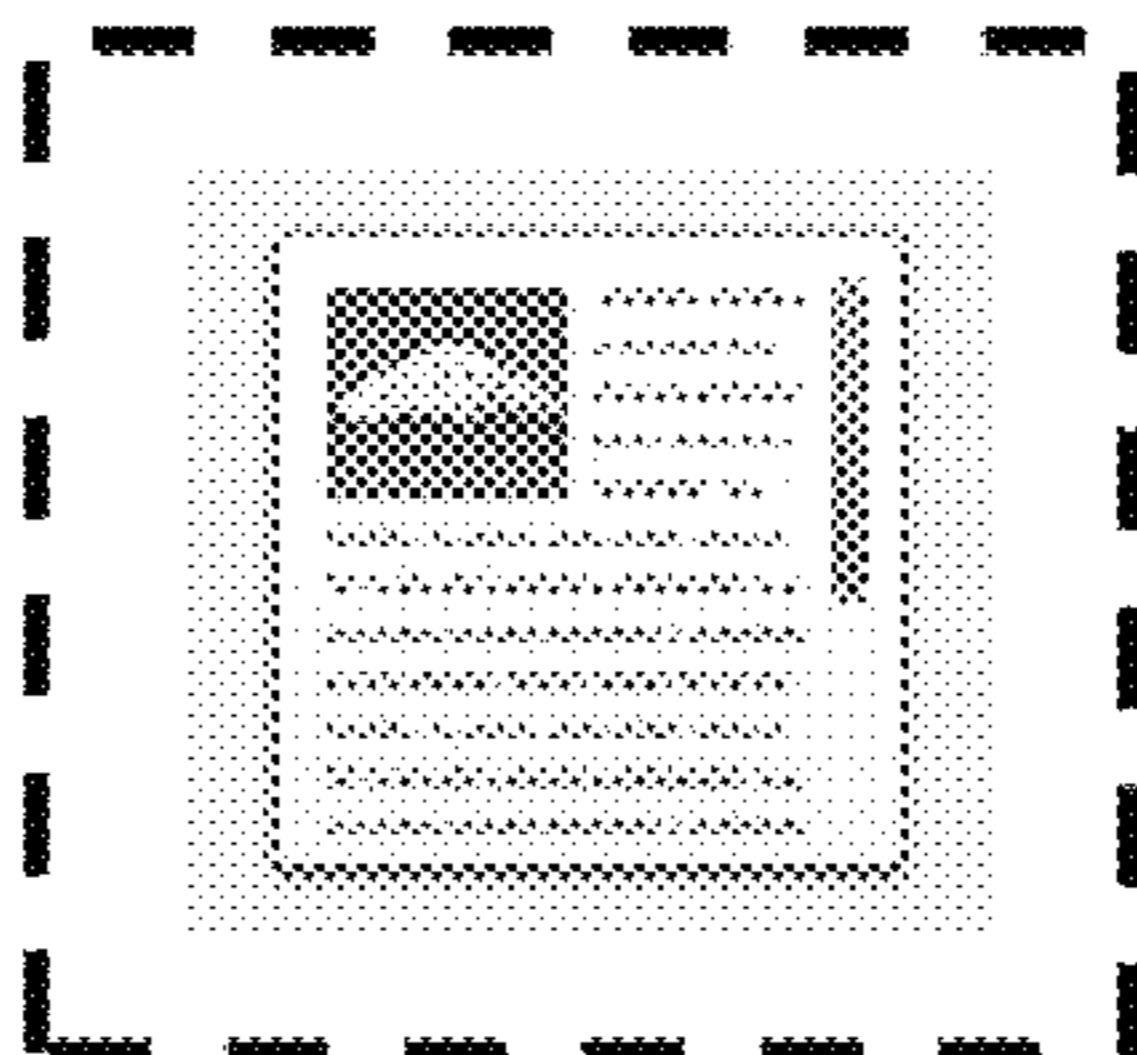

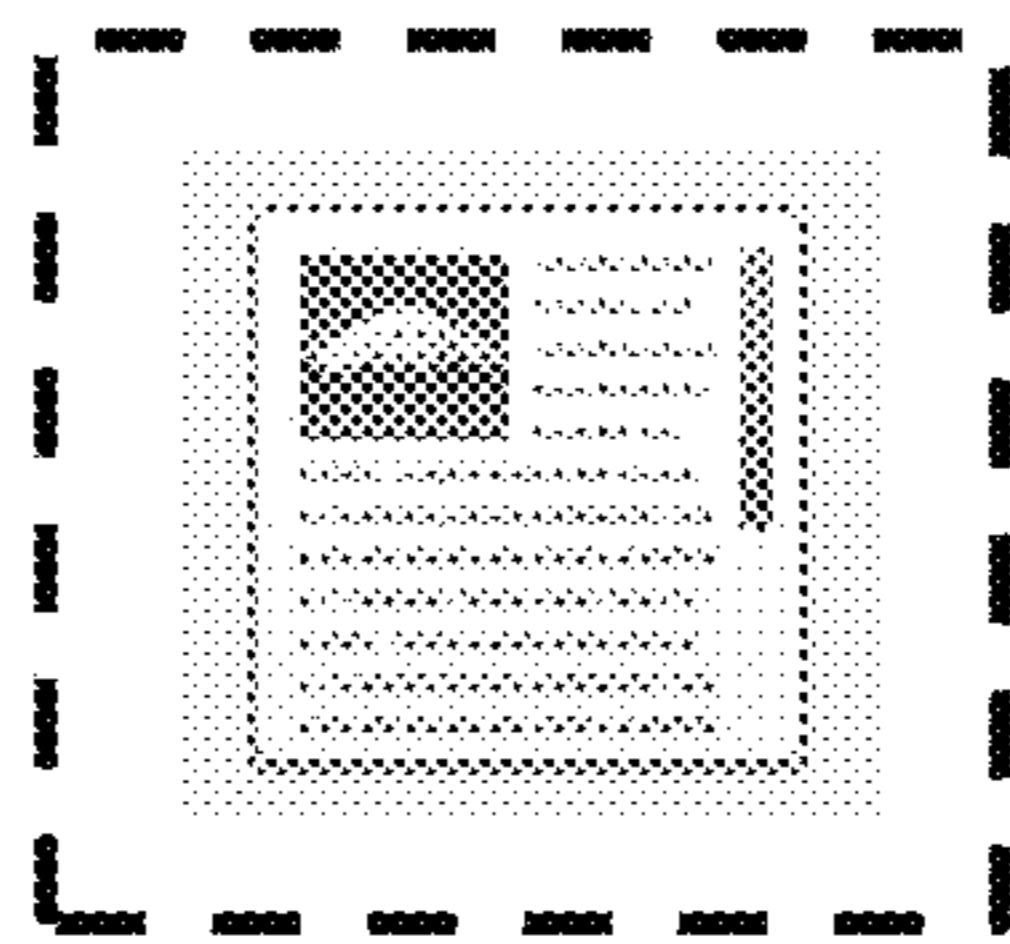

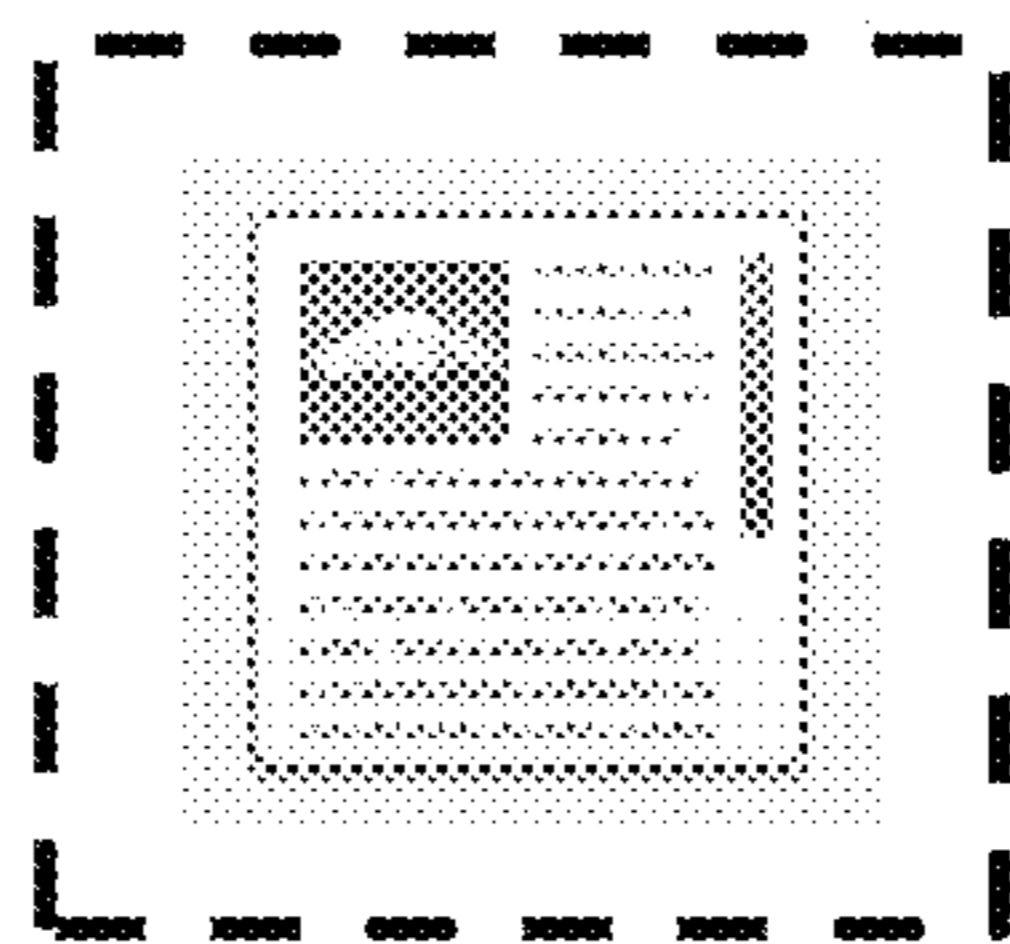
