DESCRIPTION

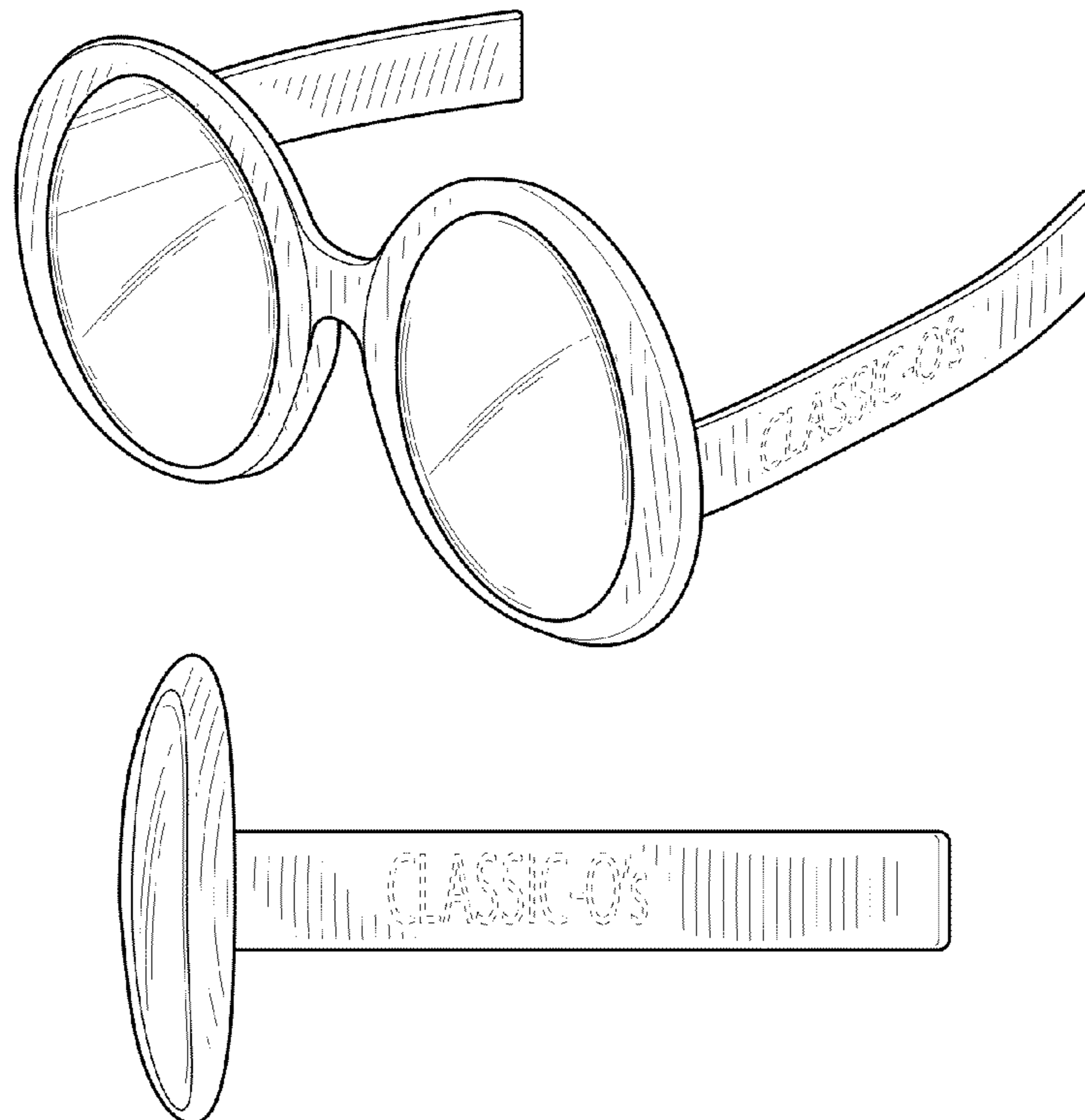
FIG. 1 is a perspective view of a pair of sunglasses, showing my new design;

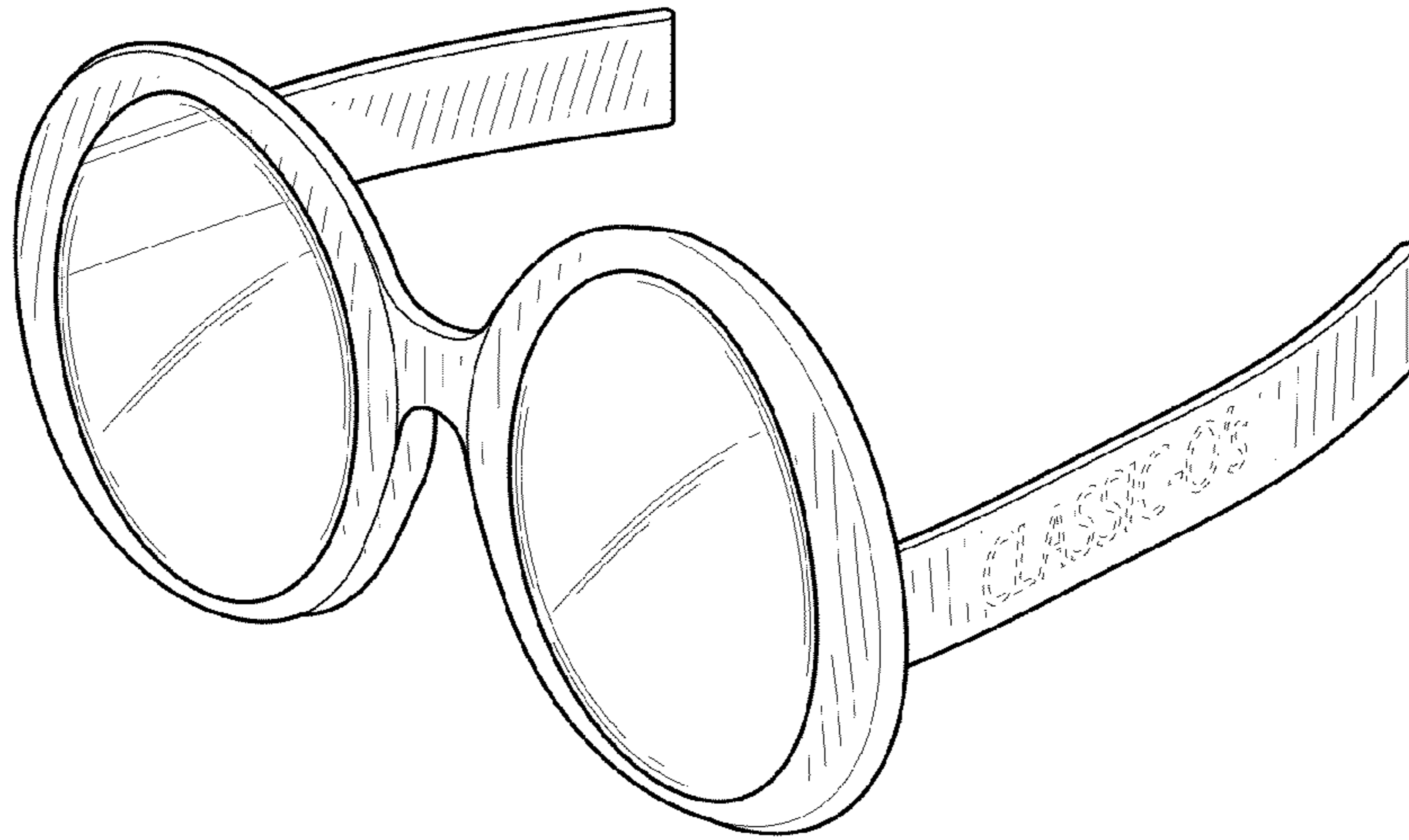

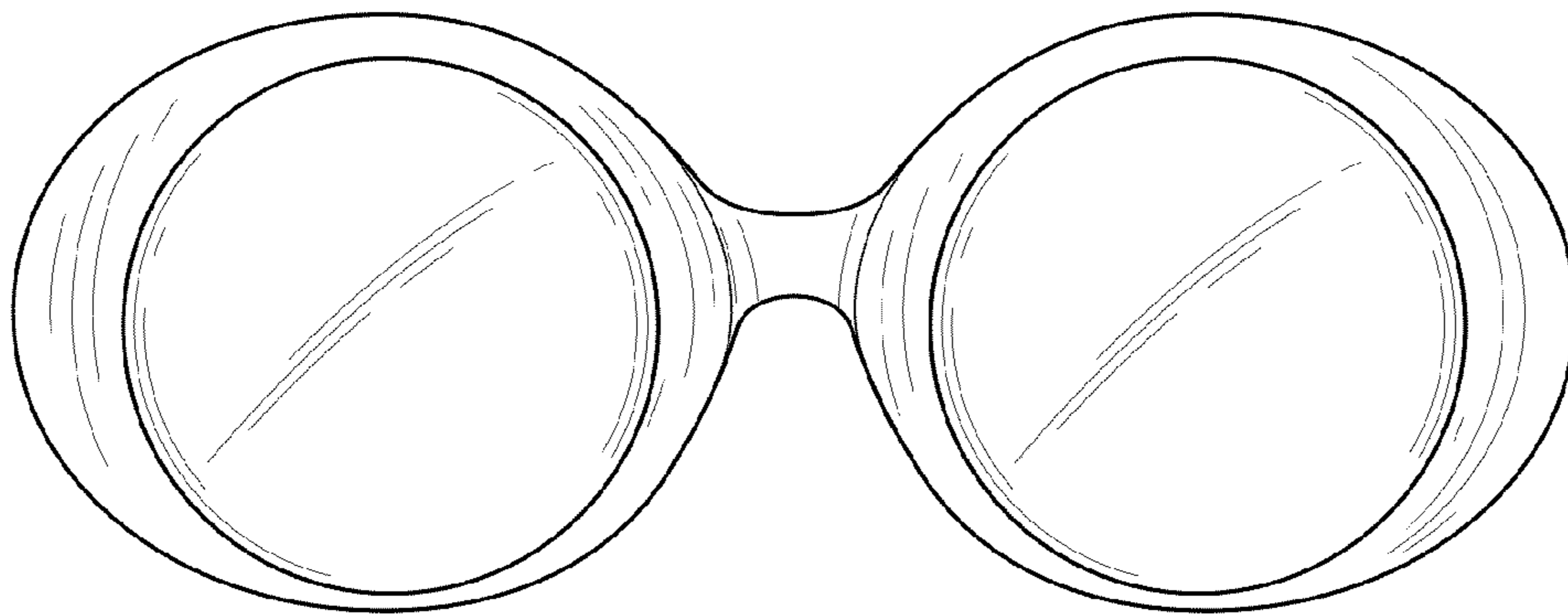

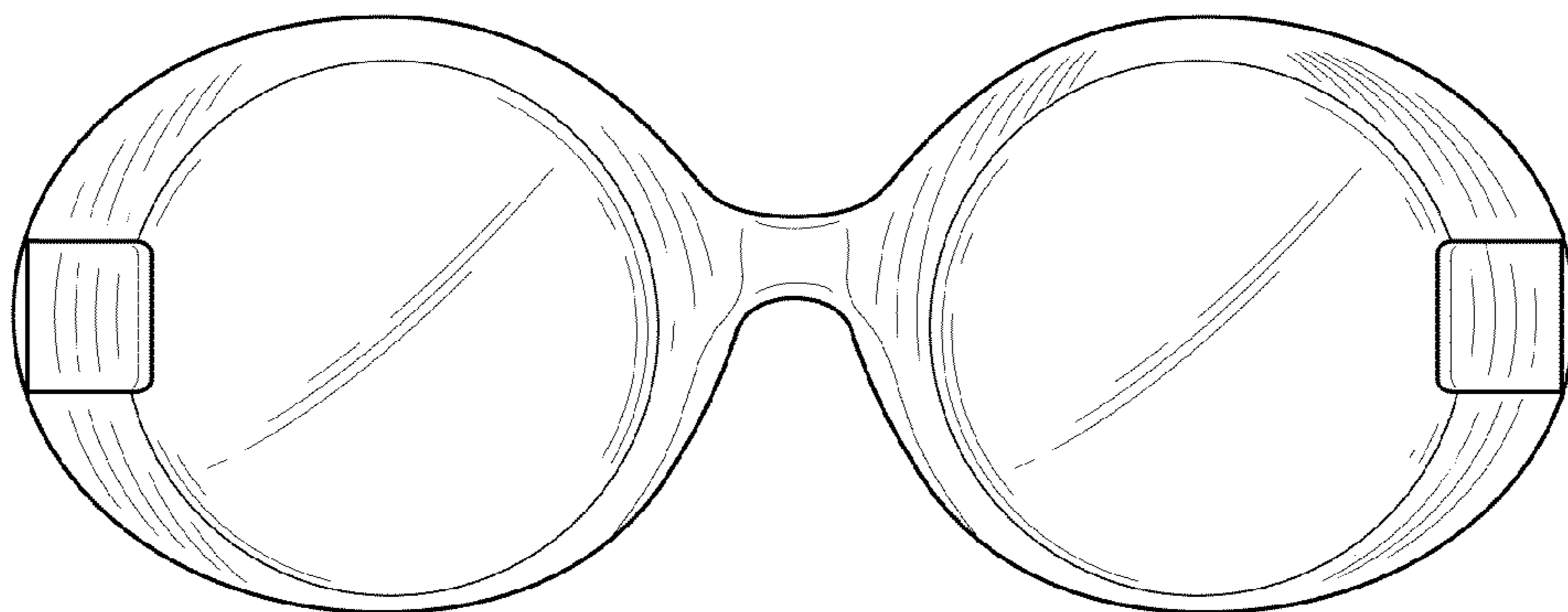

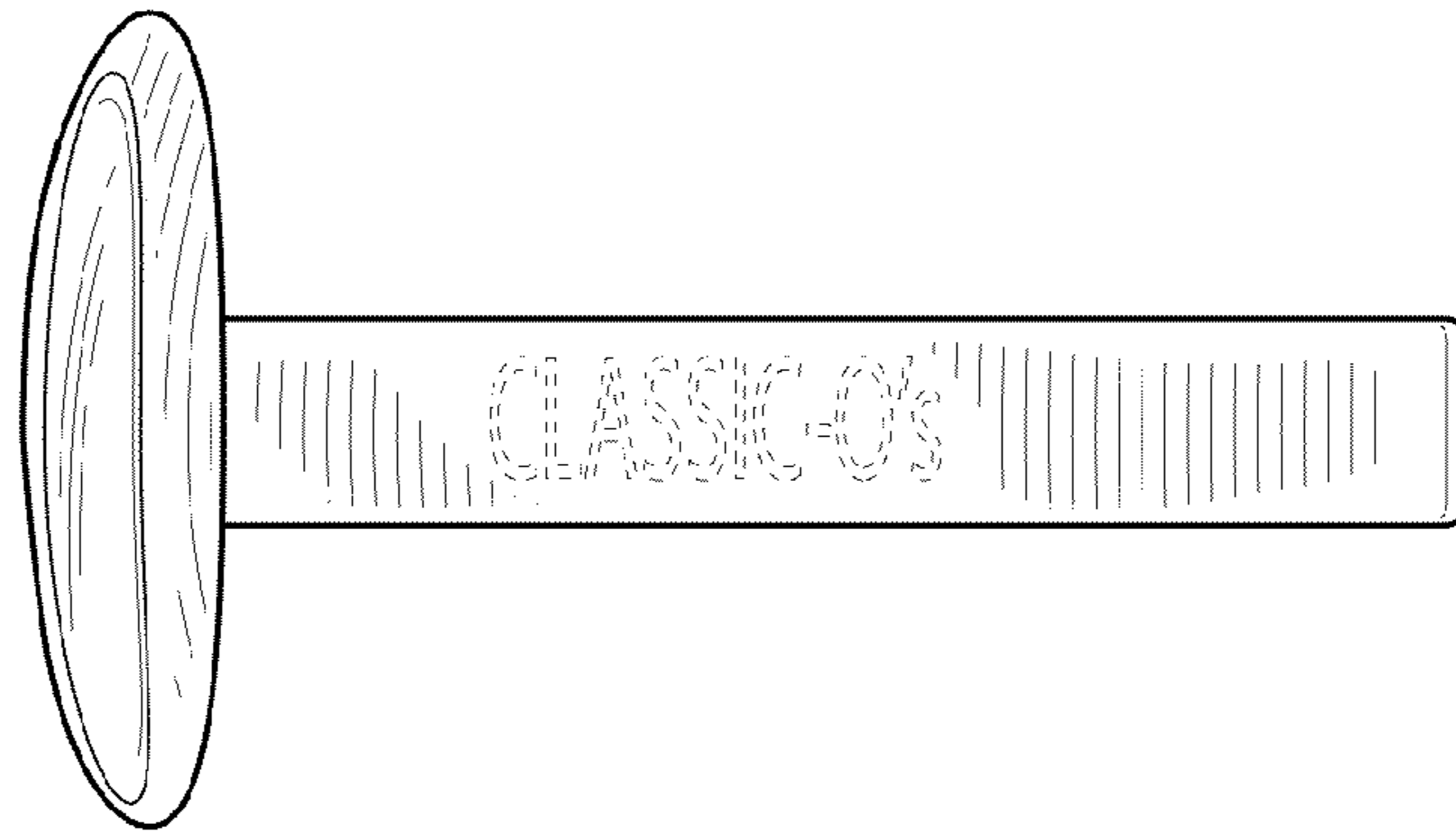

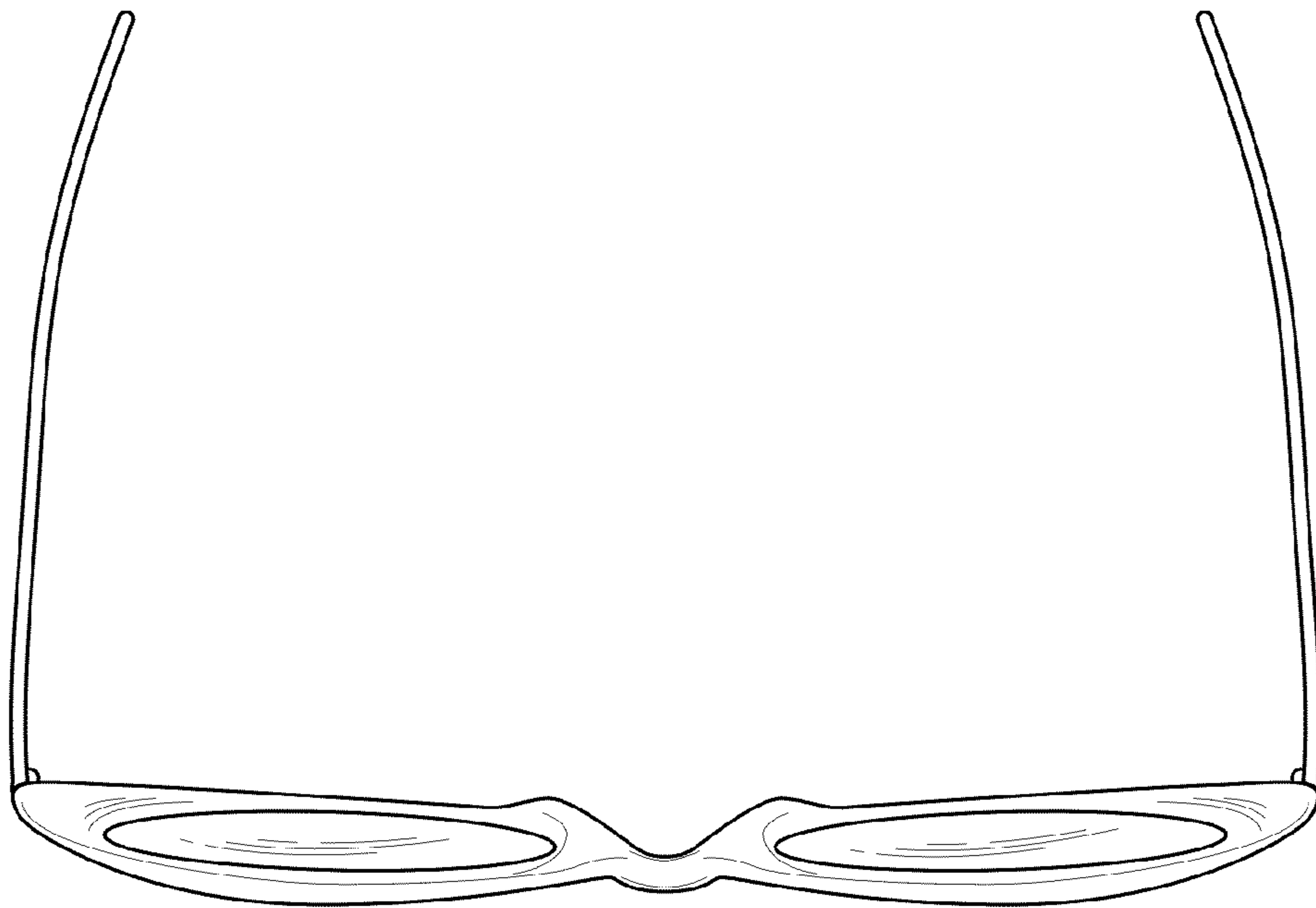

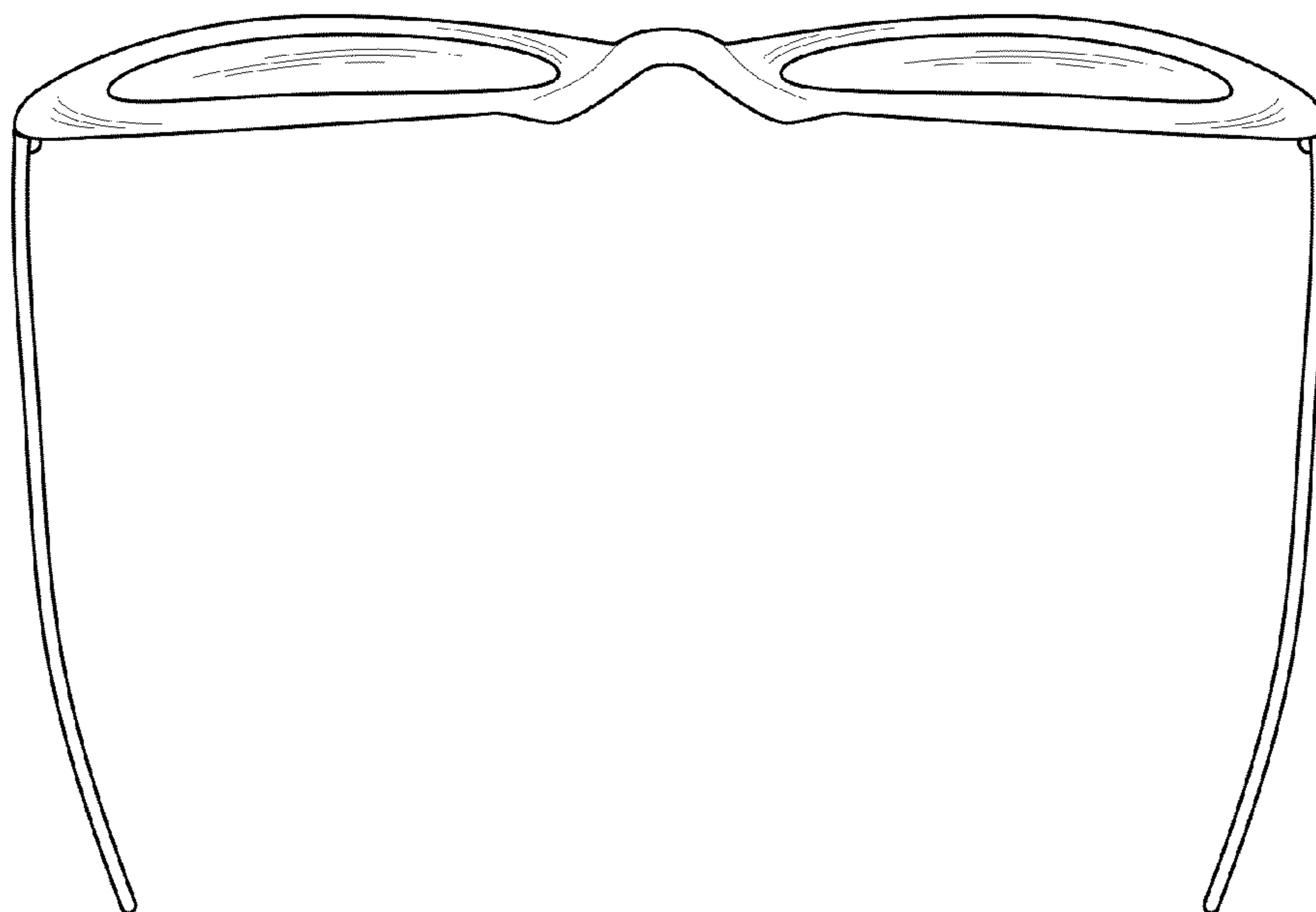
