FIG. 3 is a right end view thereof.

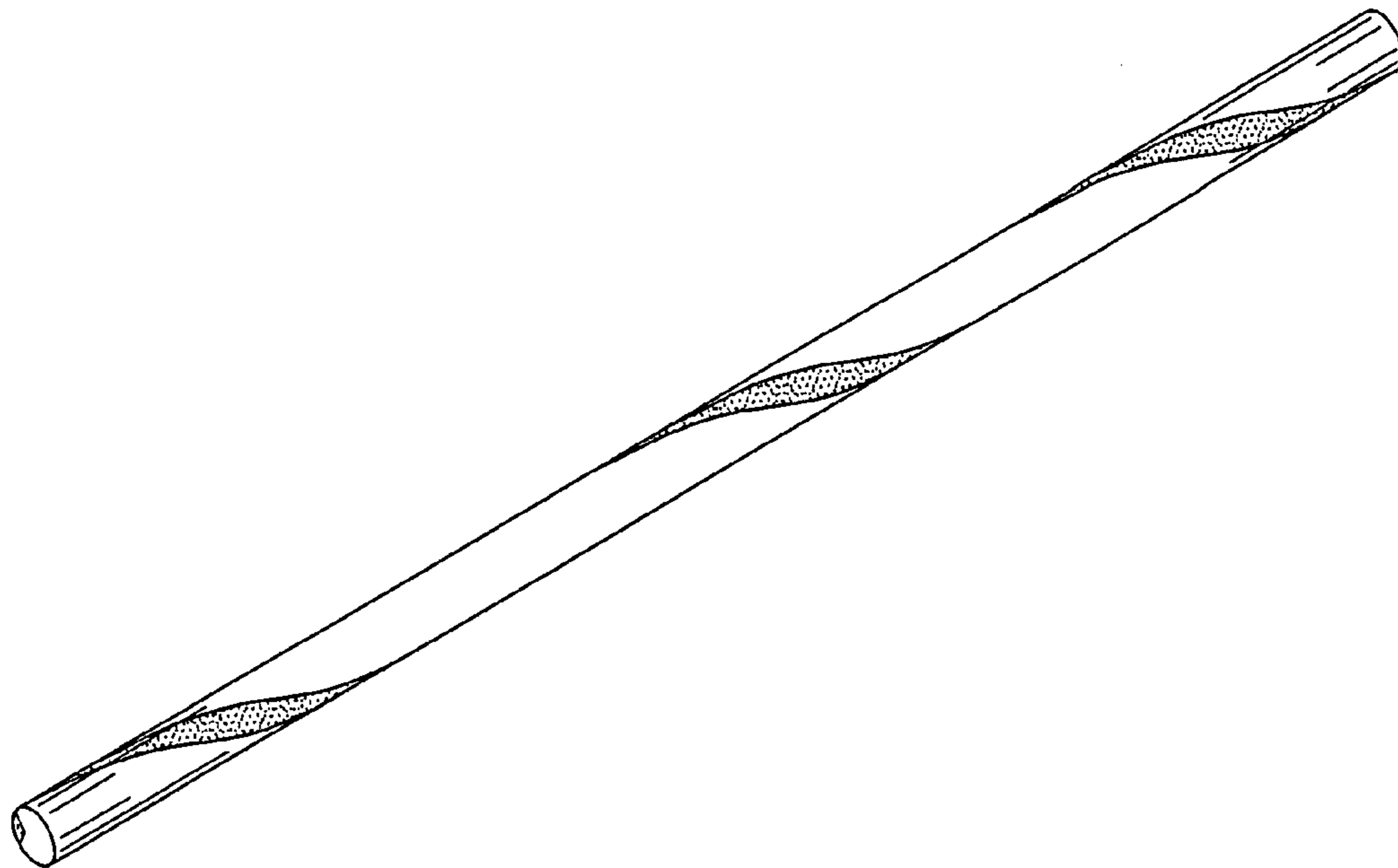
FIG. 4 is a front end view thereof.

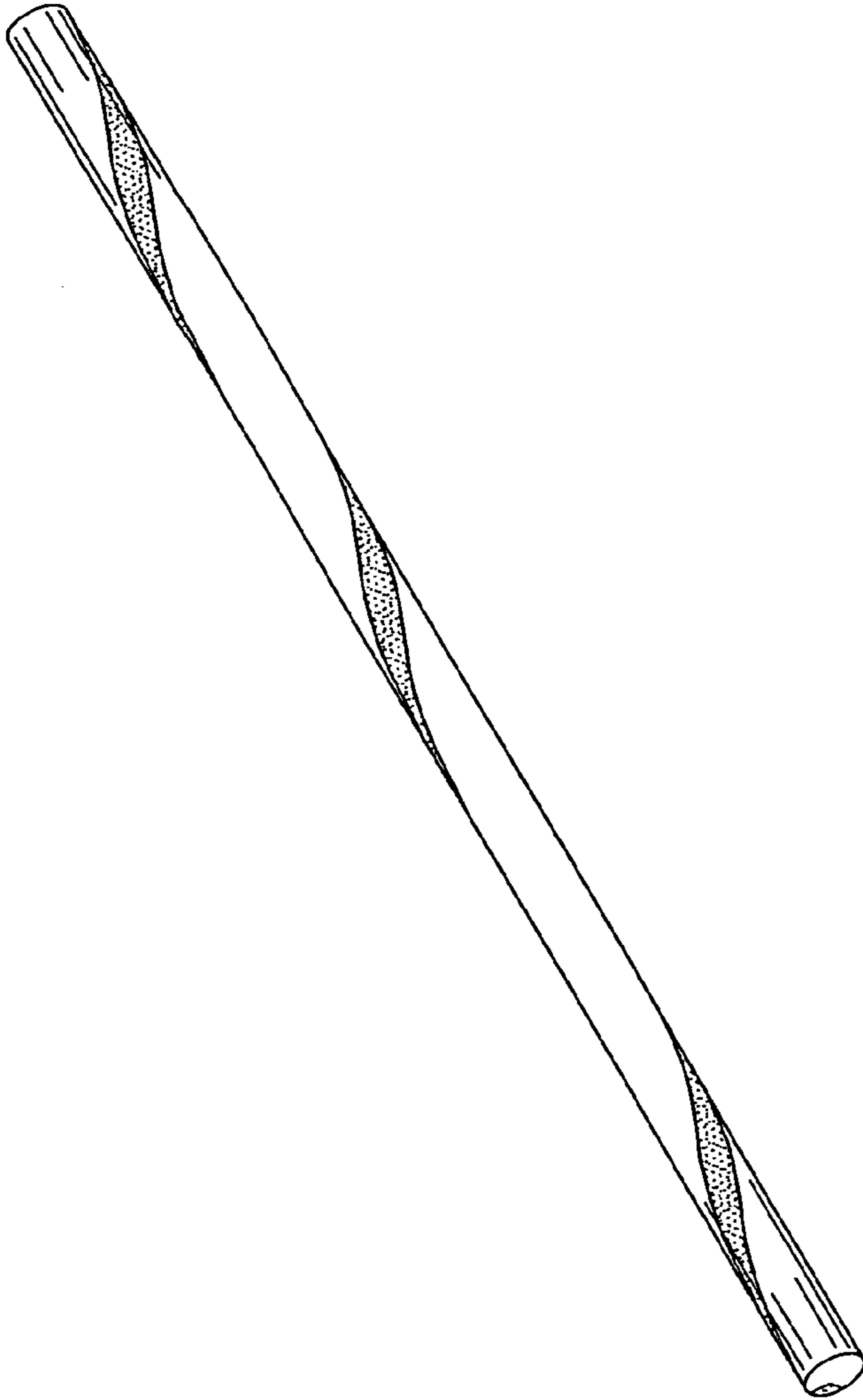

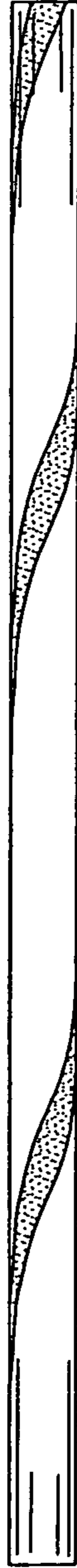
