(57) **CLAIM**

What is claimed is the ornamental design for a faucet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our new design with the spray head in broken lines;

FIG. 2 is a right side elevational view of the design shown in FIG. 1;

FIG. 3 is the left side elevational view of the design shown in FIG. 1;

FIG. 4 is a top view of the design shown in FIG. 1;

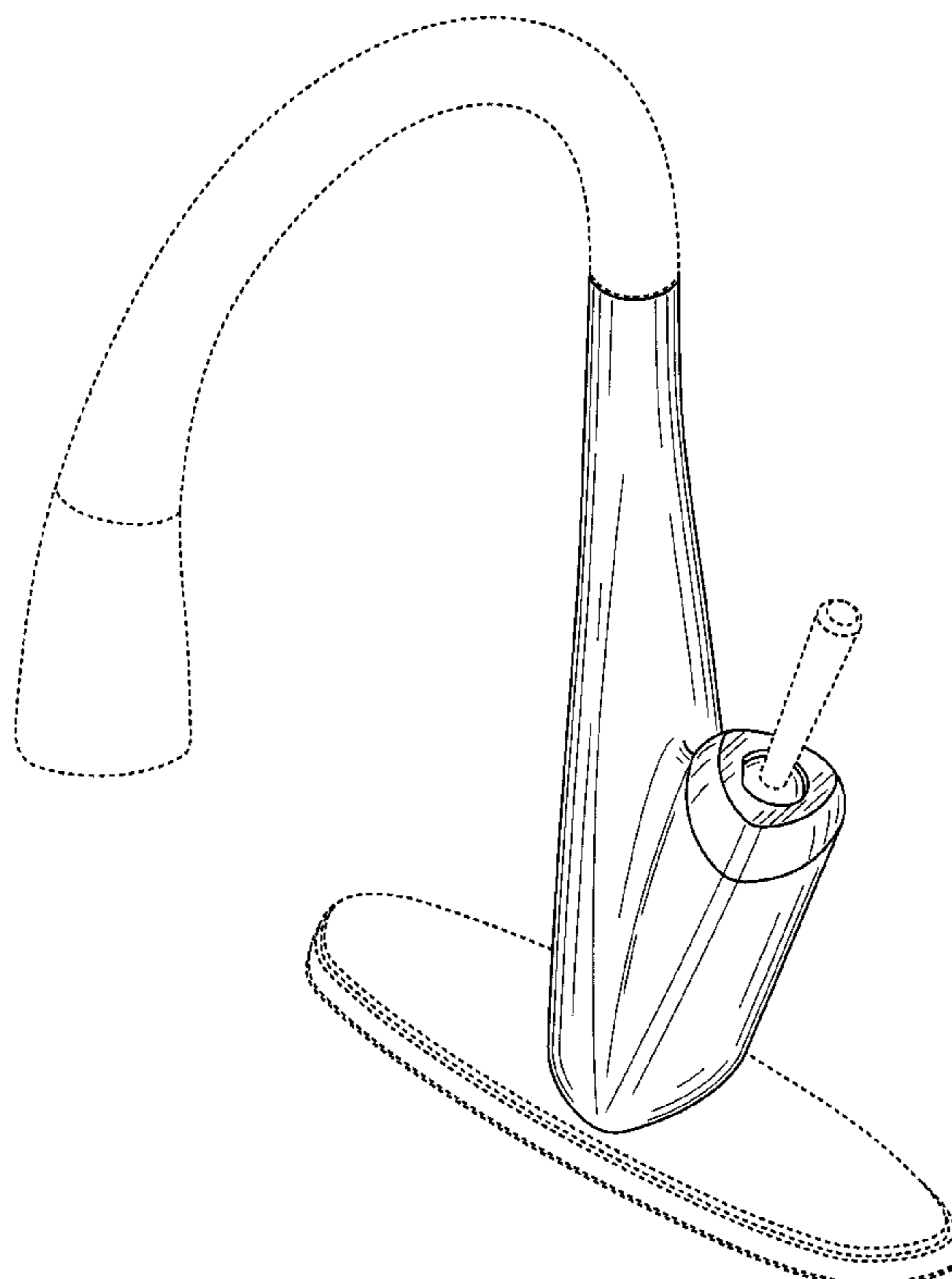
FIG. 5 is a bottom view of the design shown in FIG. 1;

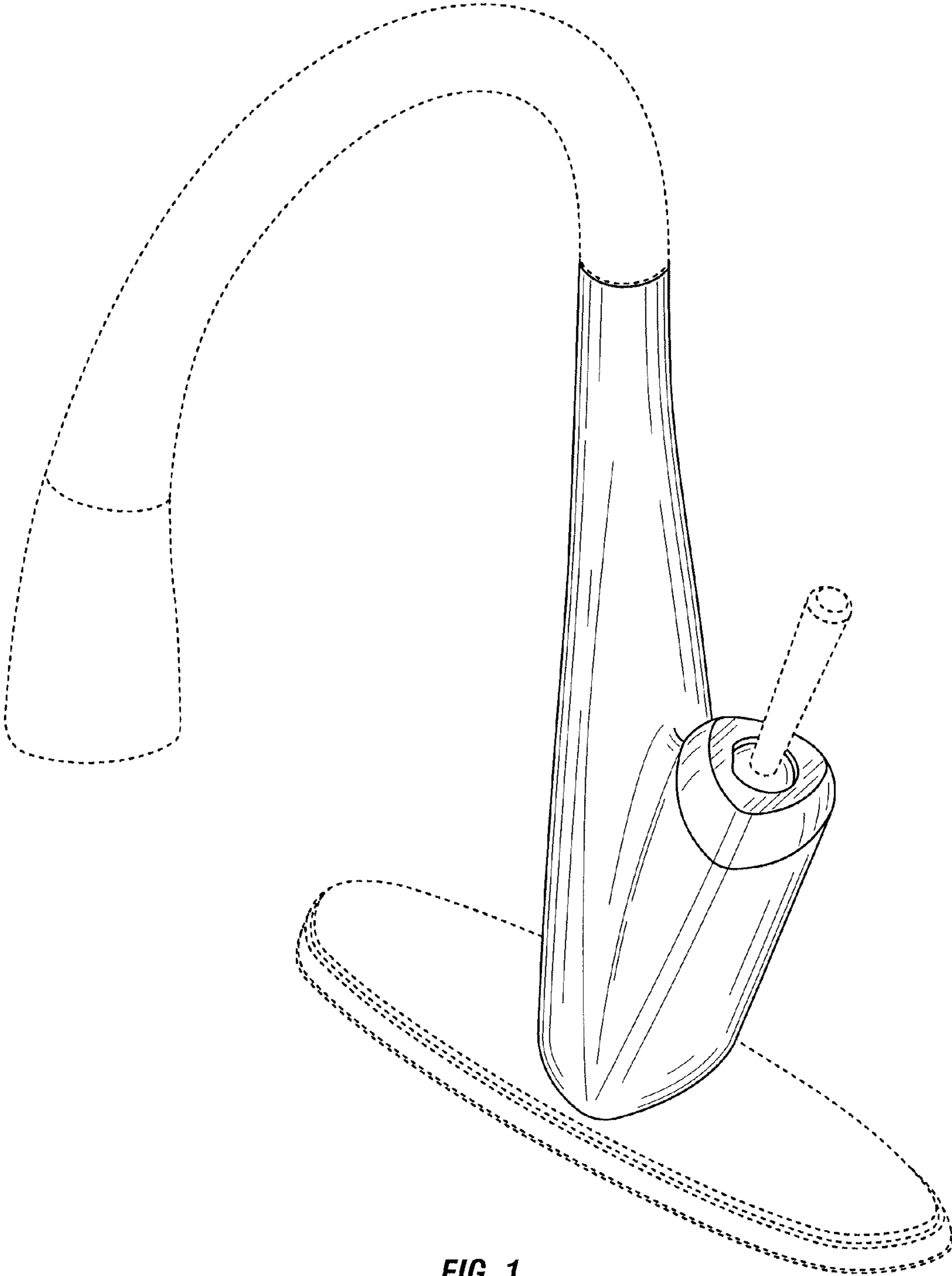

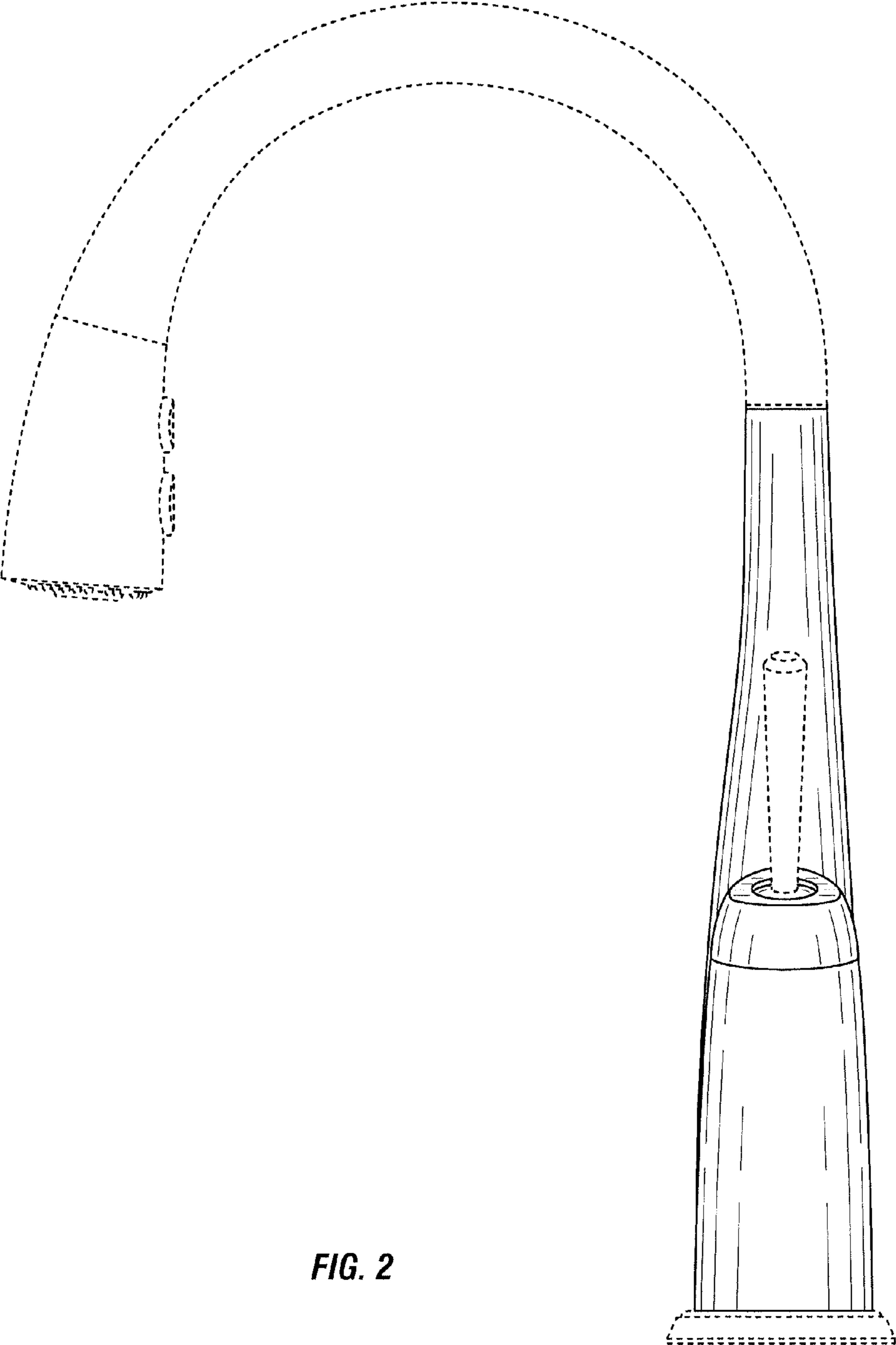

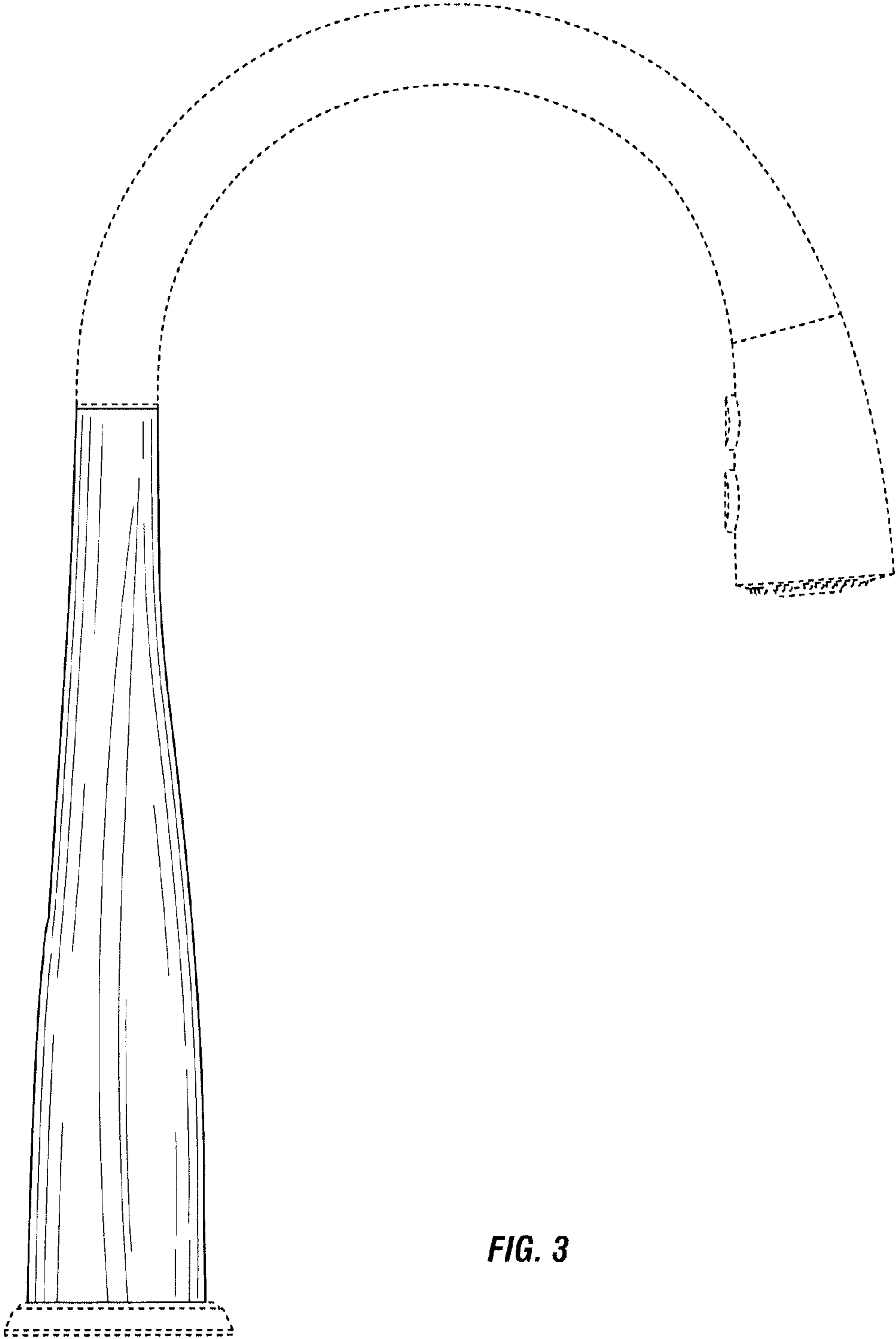
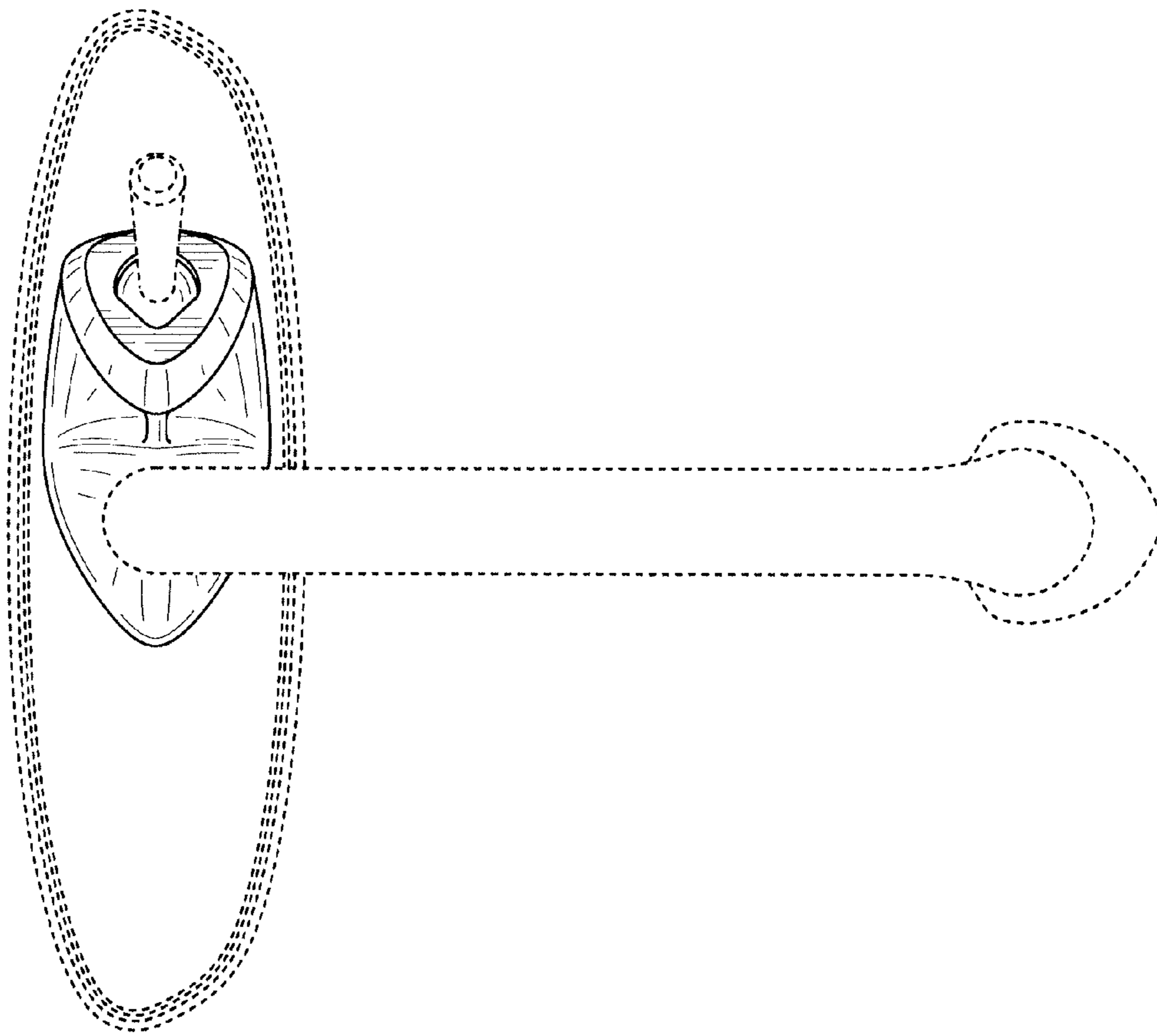
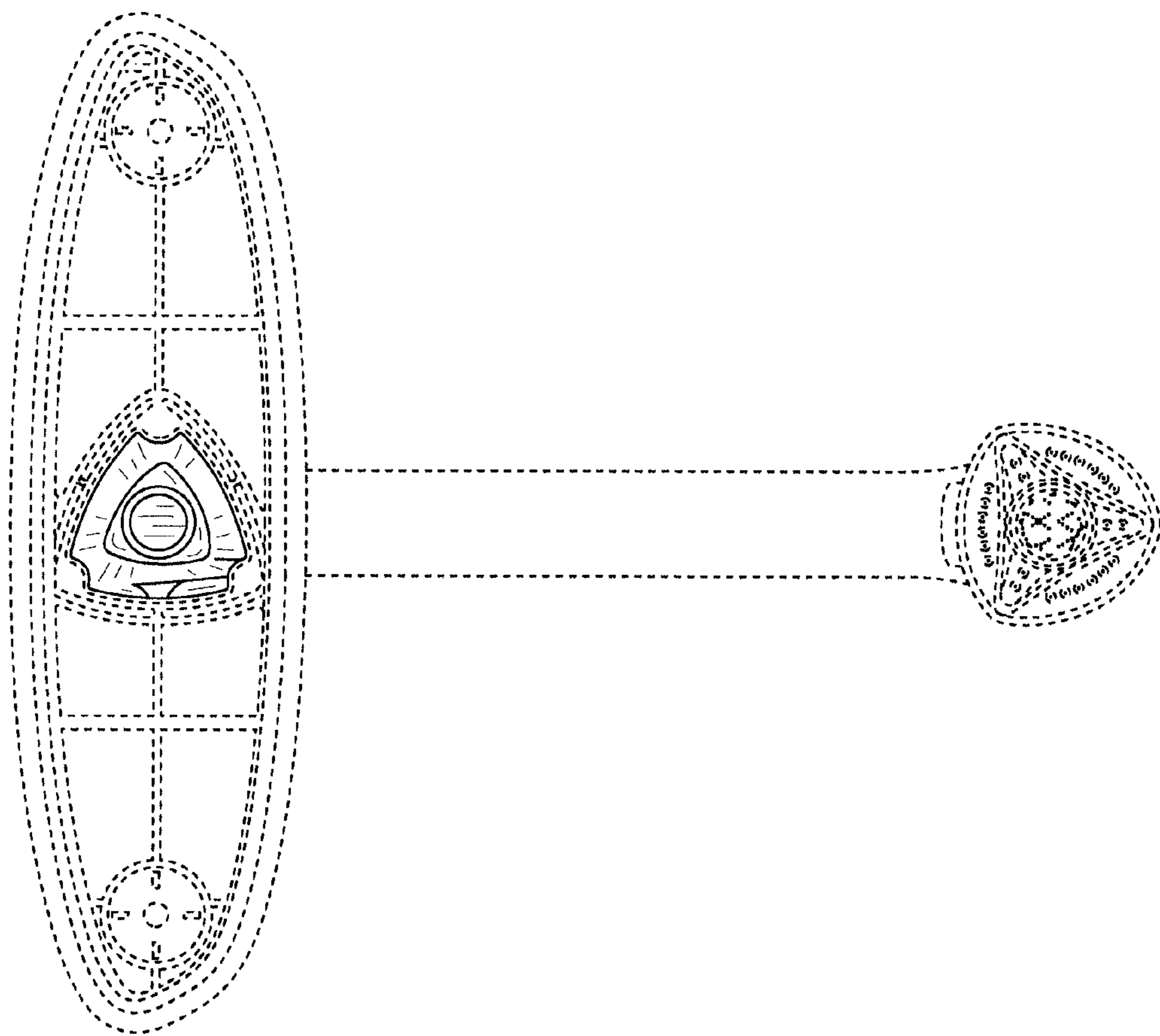


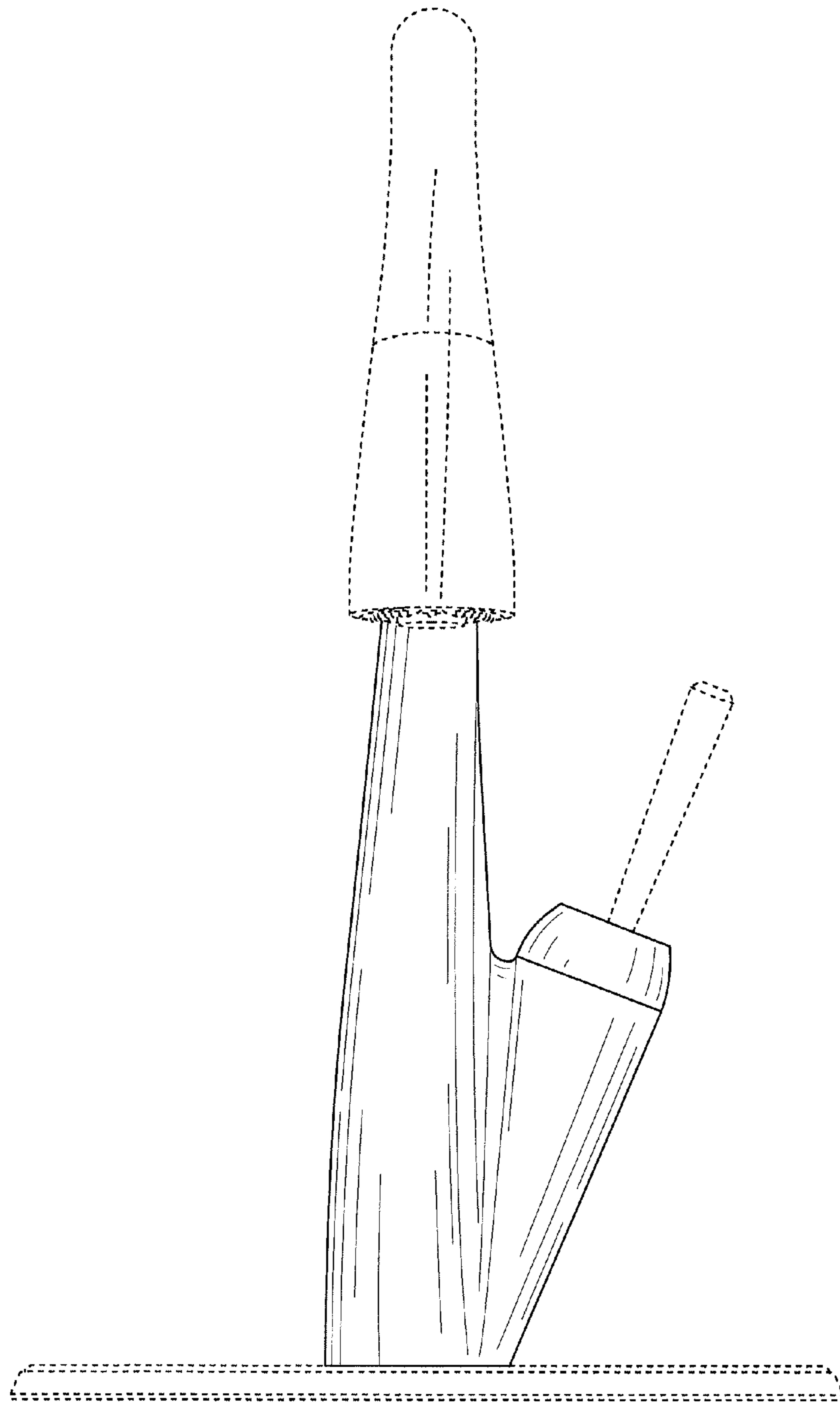

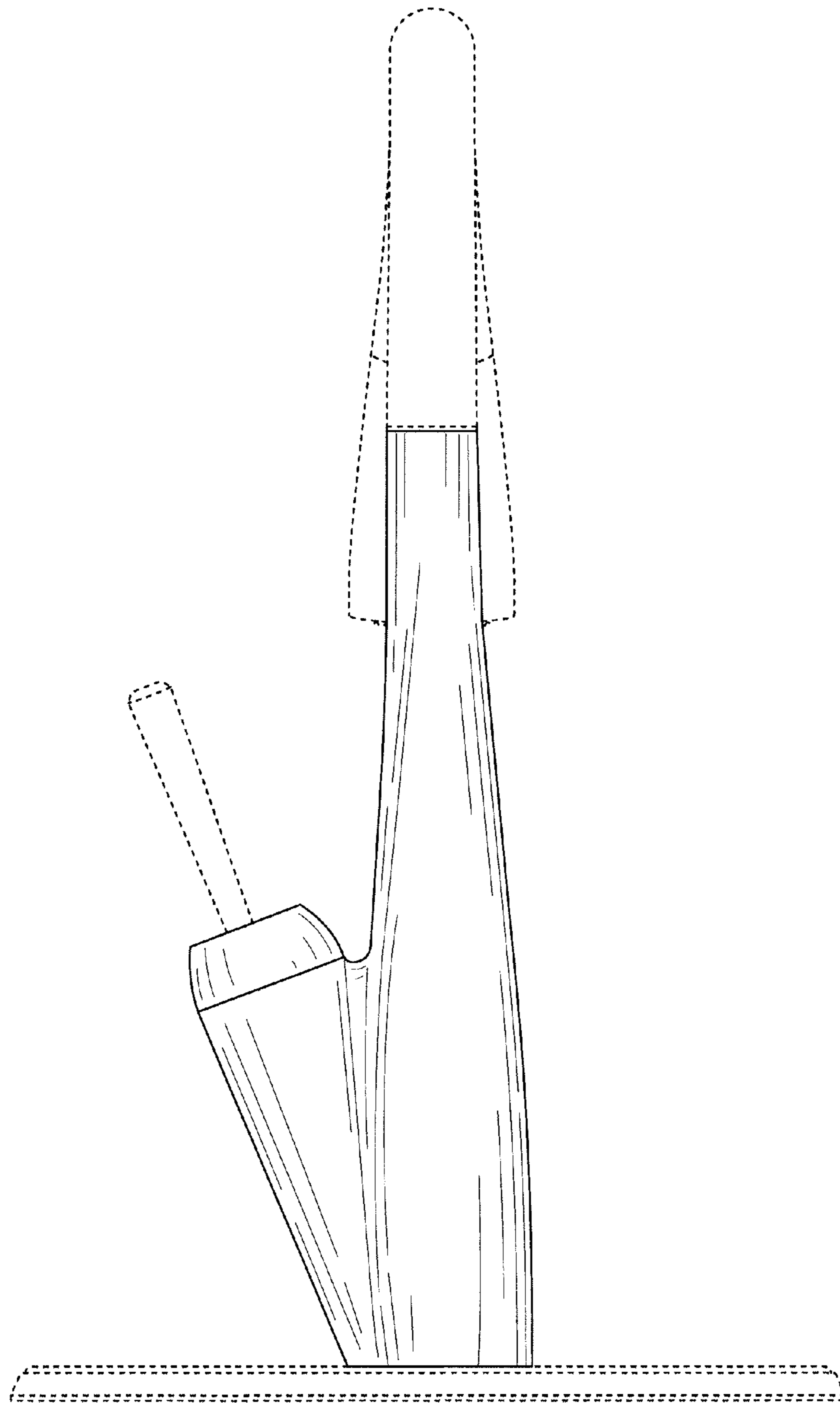
