**DESCRIPTION**

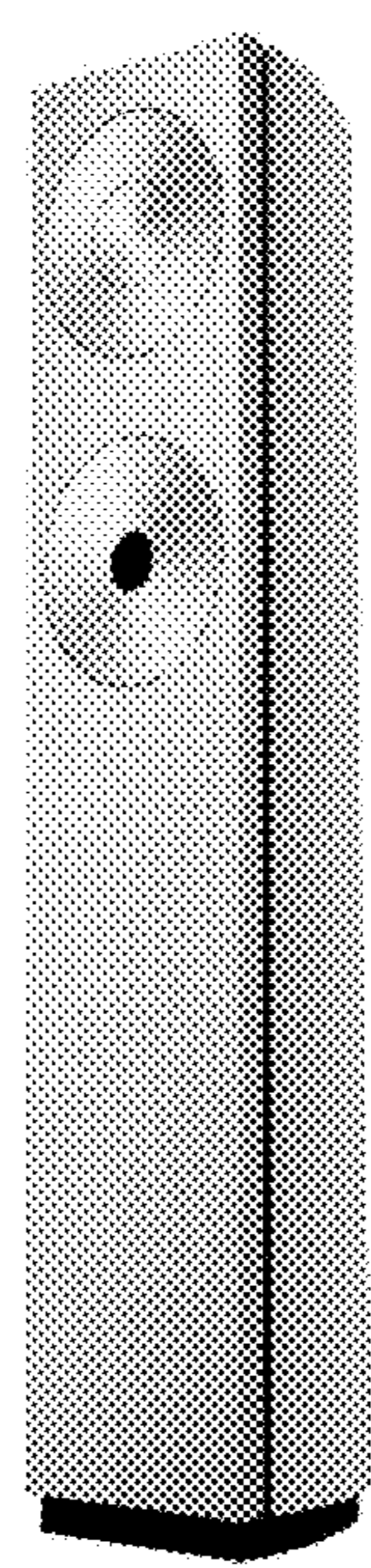

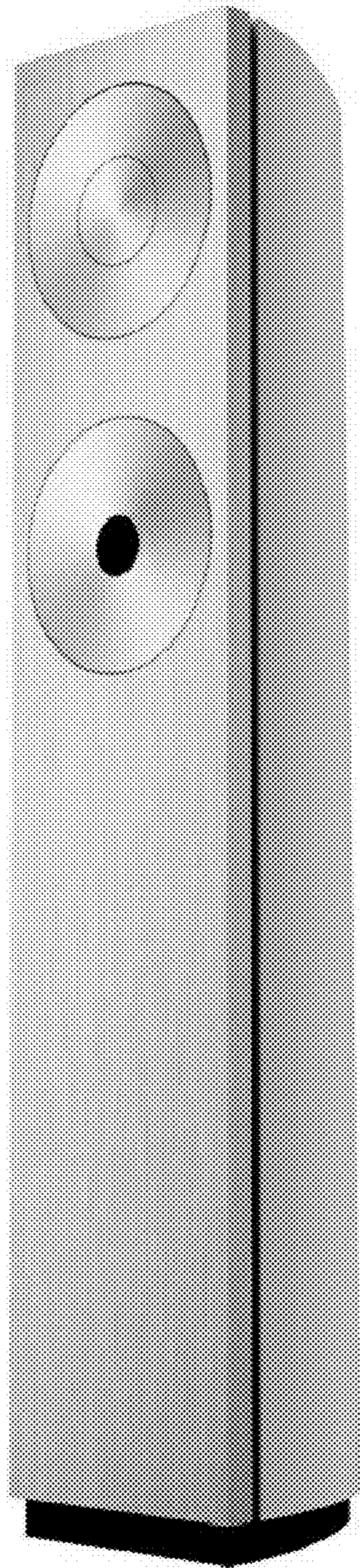

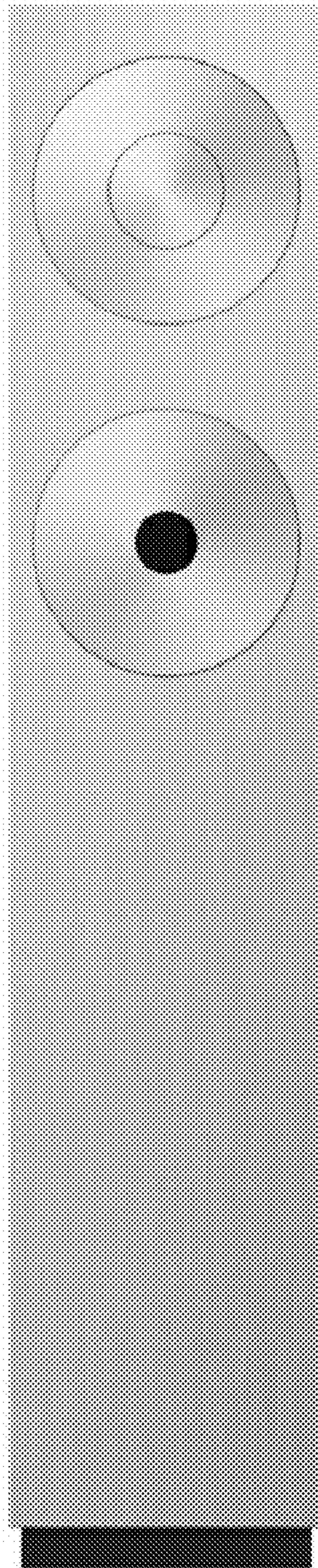

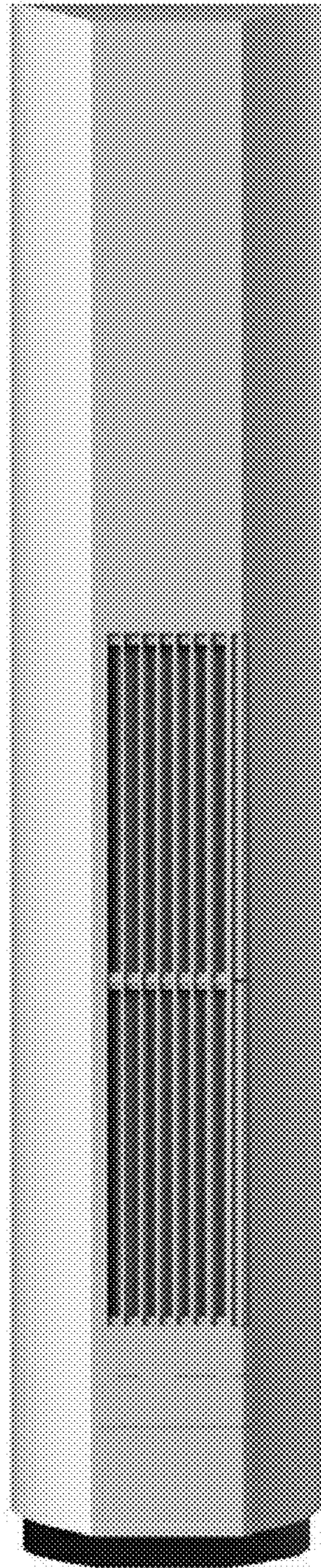

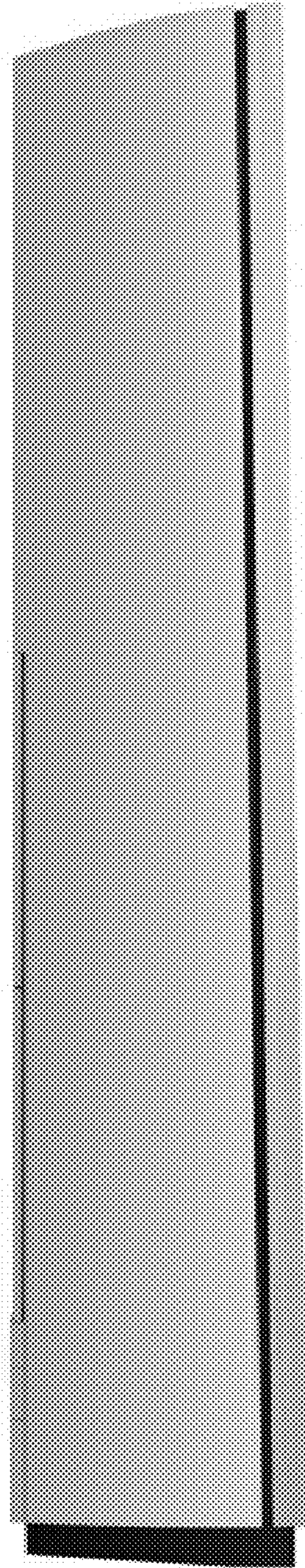

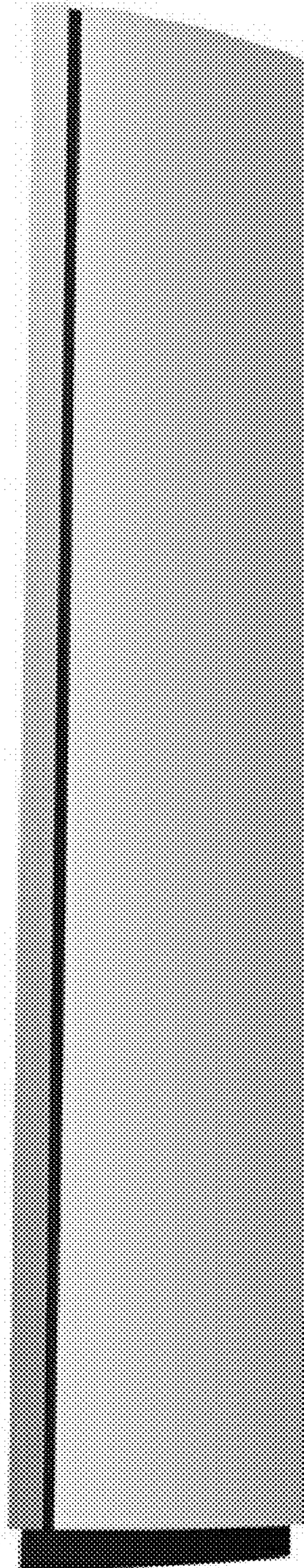

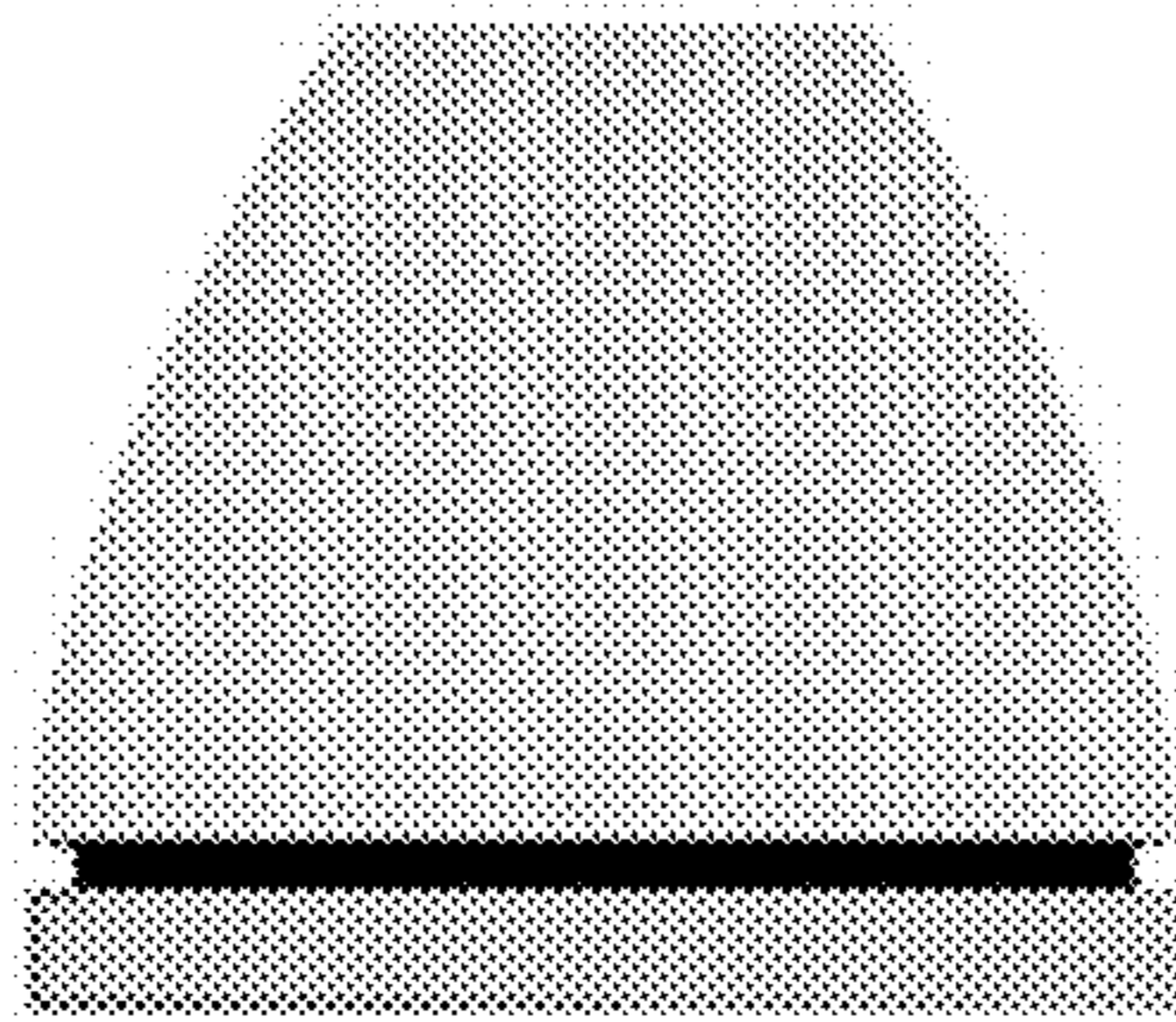

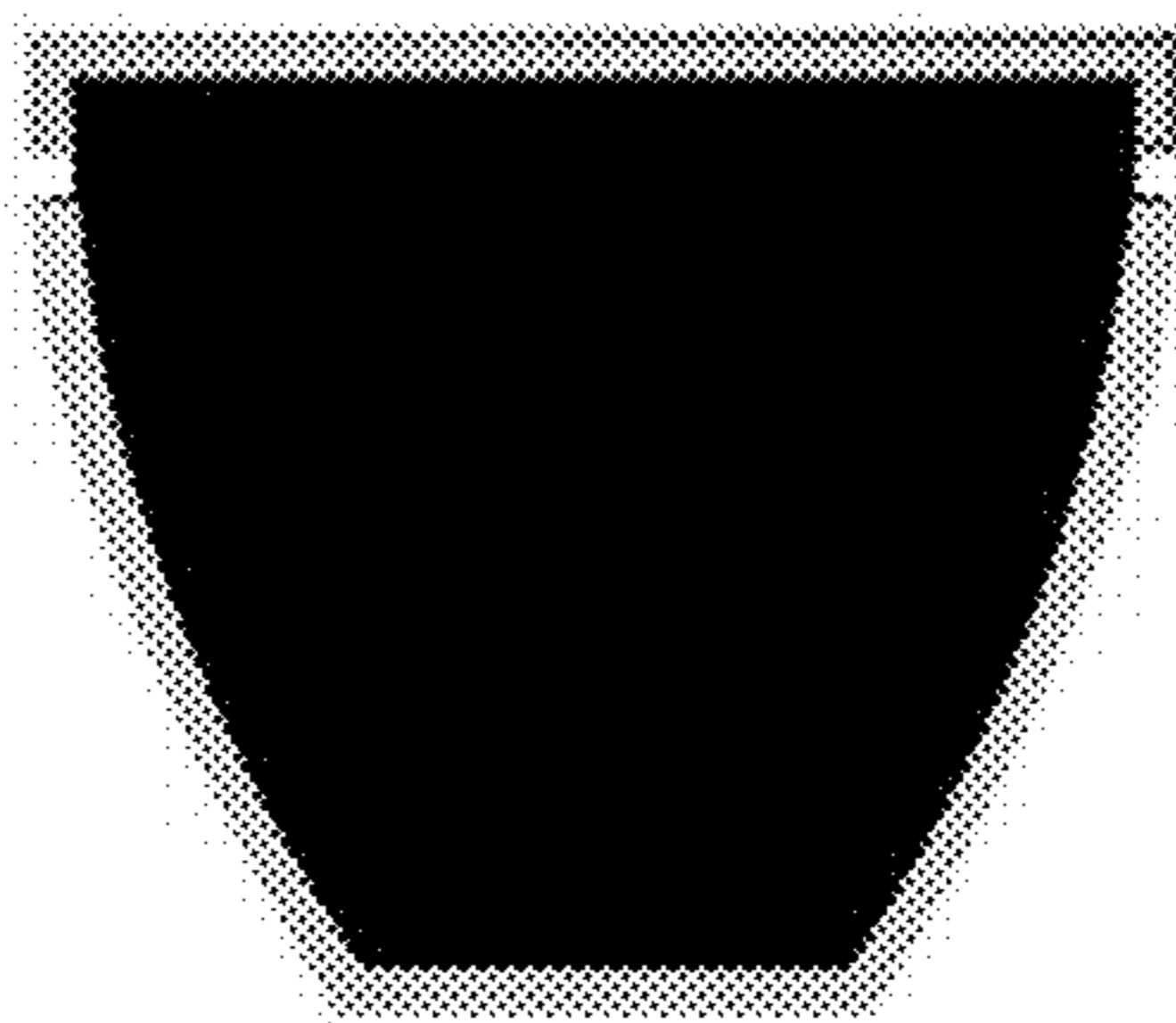

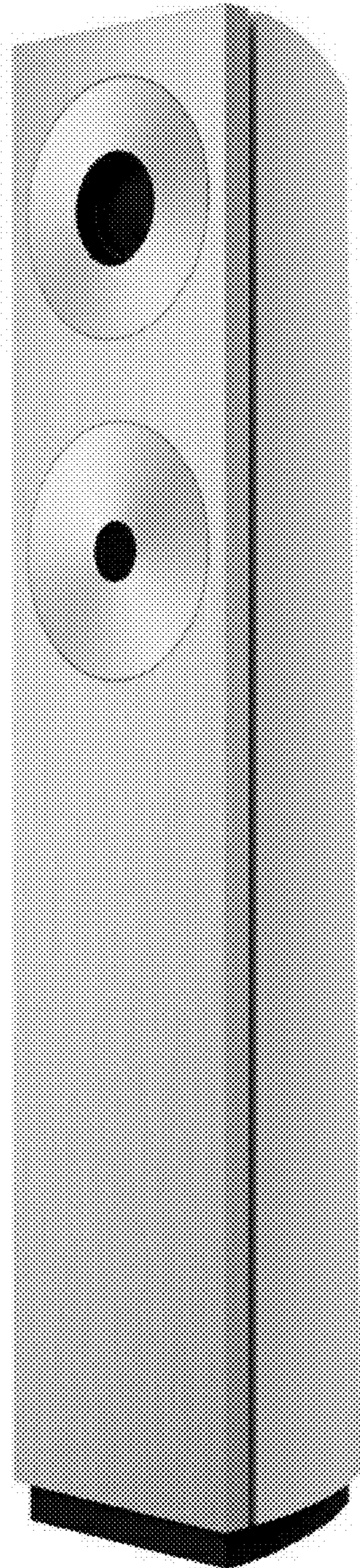

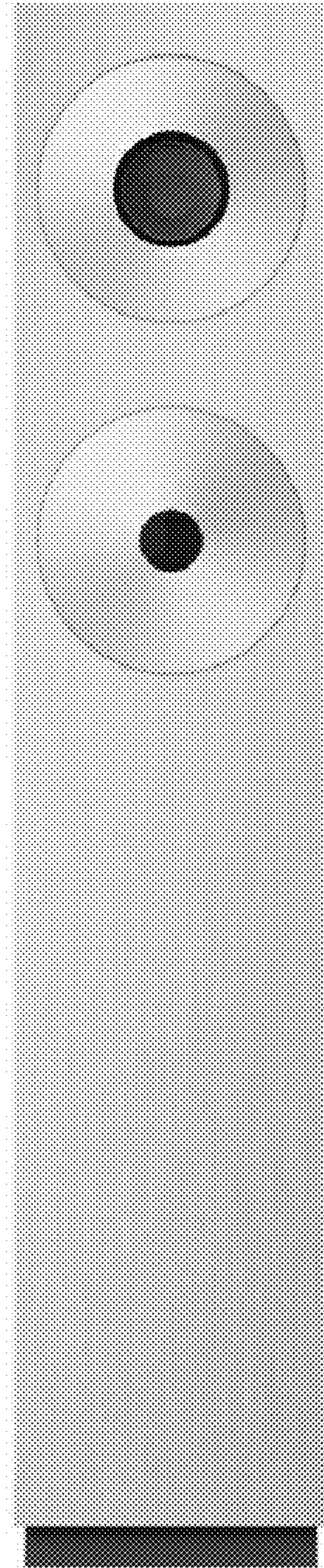

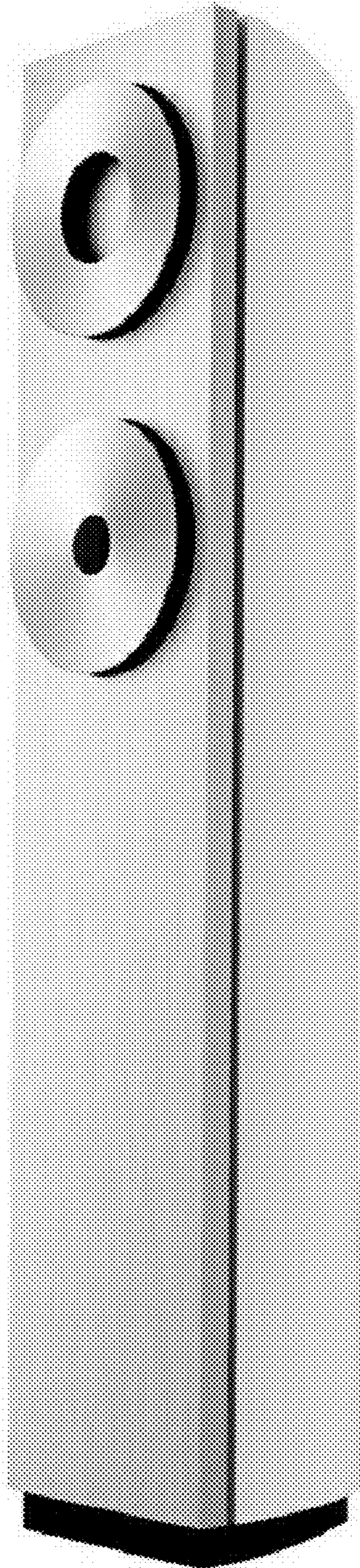

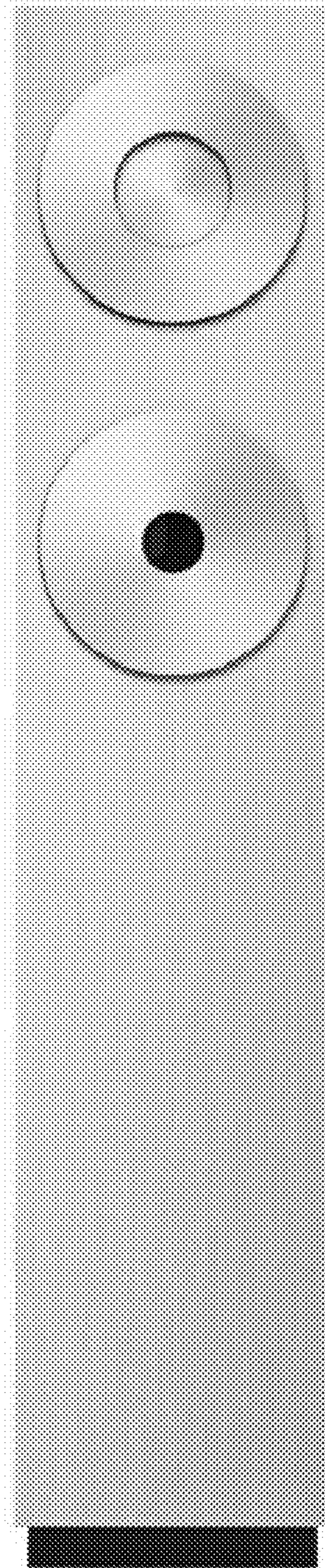

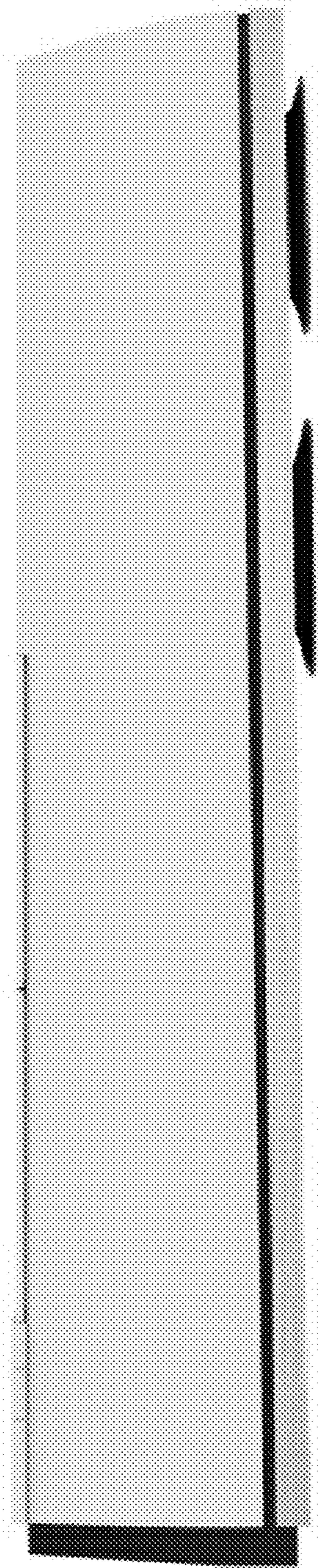

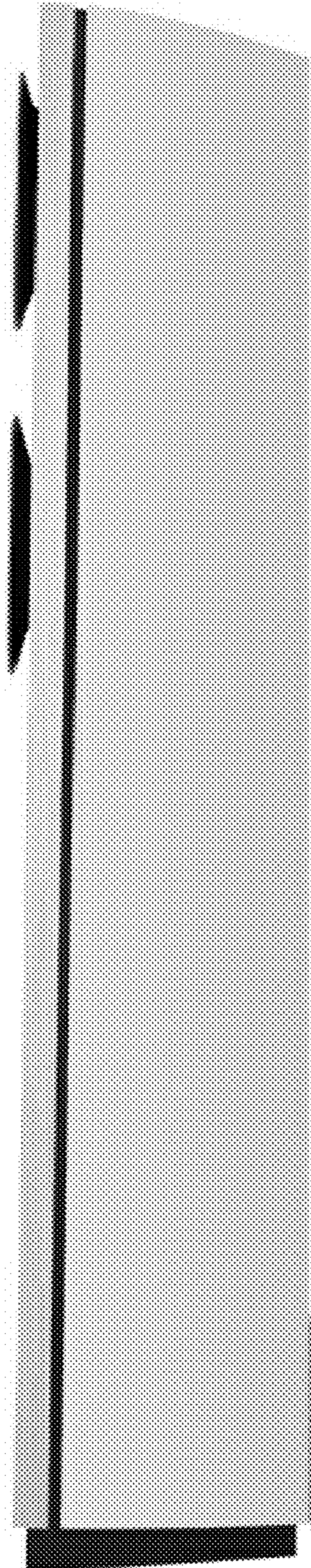

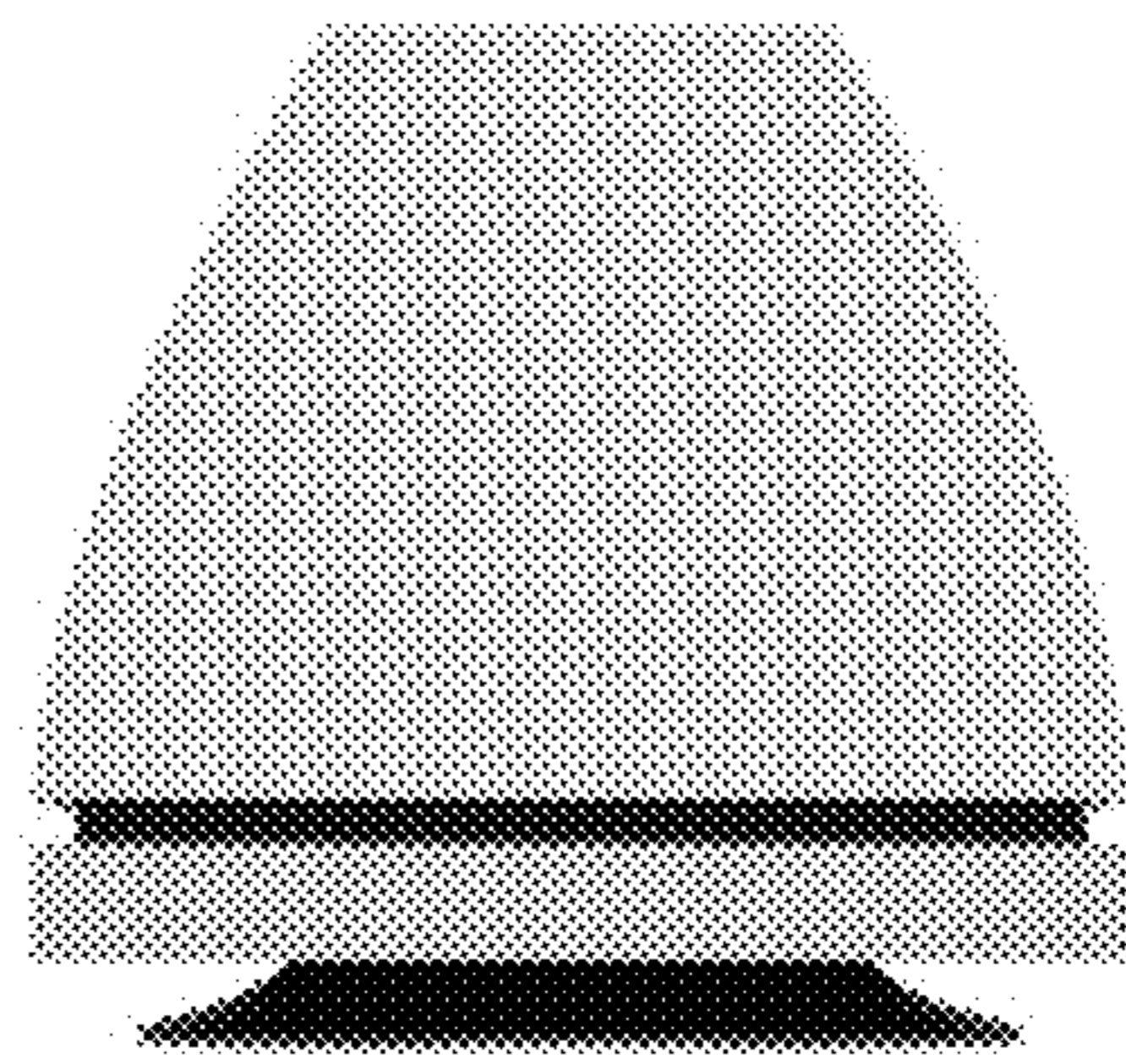
