(57) **CLAIM**

The ornamental design for a handle for a medical device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a handle for a medical device, showing our new design, wherein the break lines indicate indeterminate length;

FIG. 2 is a top, rear, right side perspective view of the handle of FIG. 1, wherein the break lines indicate indeterminate length;

FIG. 3 is a left side elevational view of the handle of FIG. 1, wherein the break lines indicate indeterminate length;

FIG. 4 is a right side elevational view of the handle of FIG. 1, wherein the break lines indicate indeterminate length;

FIG. 5 is a top plan view of the handle of FIG. 1, wherein the break lines indicate indeterminate length;

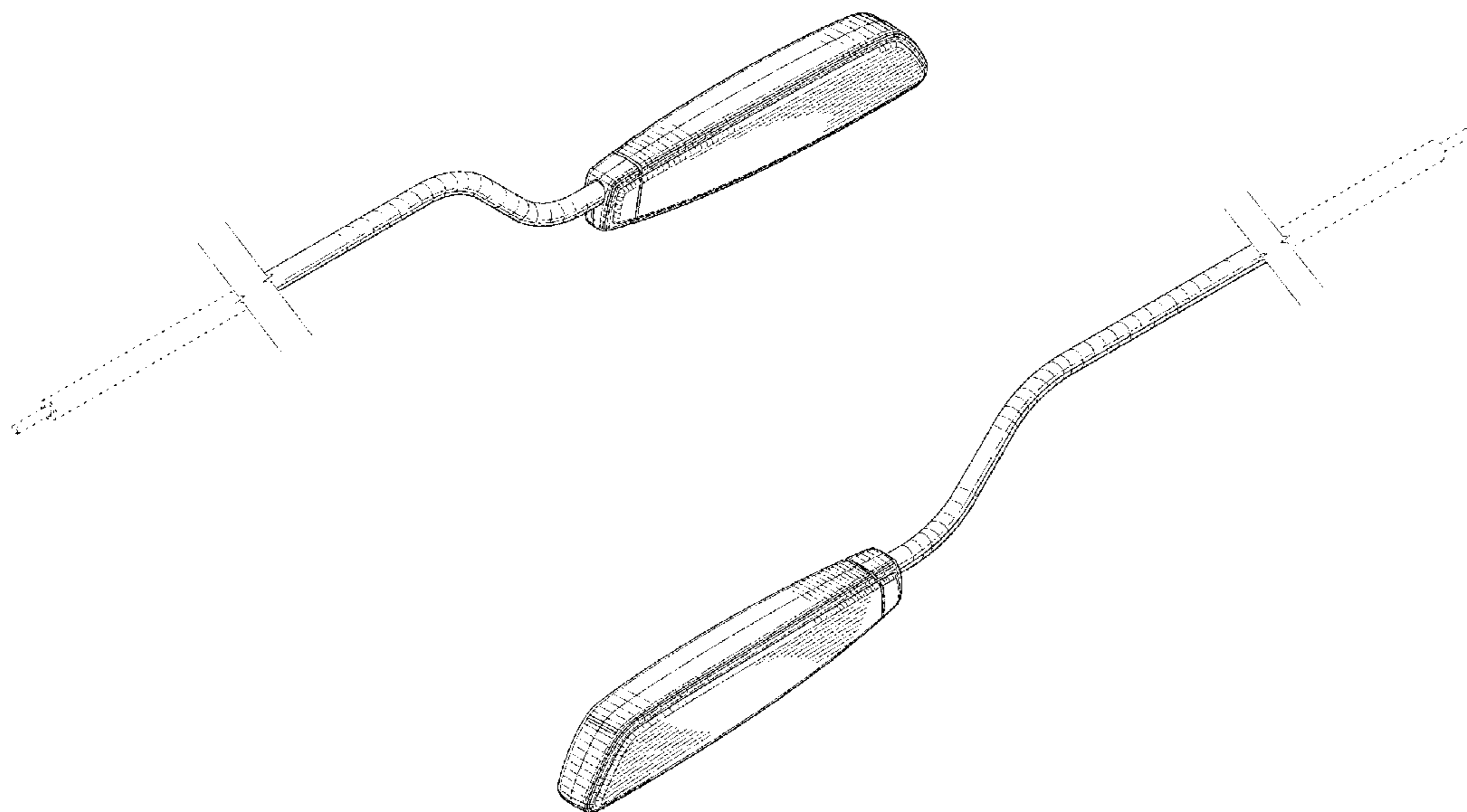
FIG. 6 is a bottom plan view of the handle of FIG. 1, wherein the break lines indicate indeterminate length;

FIG. 7 is a rear elevational view of the handle of FIG. 1;

FIG. 8 is a front elevational view of the handle of FIG. 1; and, FIG. 9 is a top, front, left side perspective view of the handle of FIG. 1, wherein the break lines indicate indeterminate length.

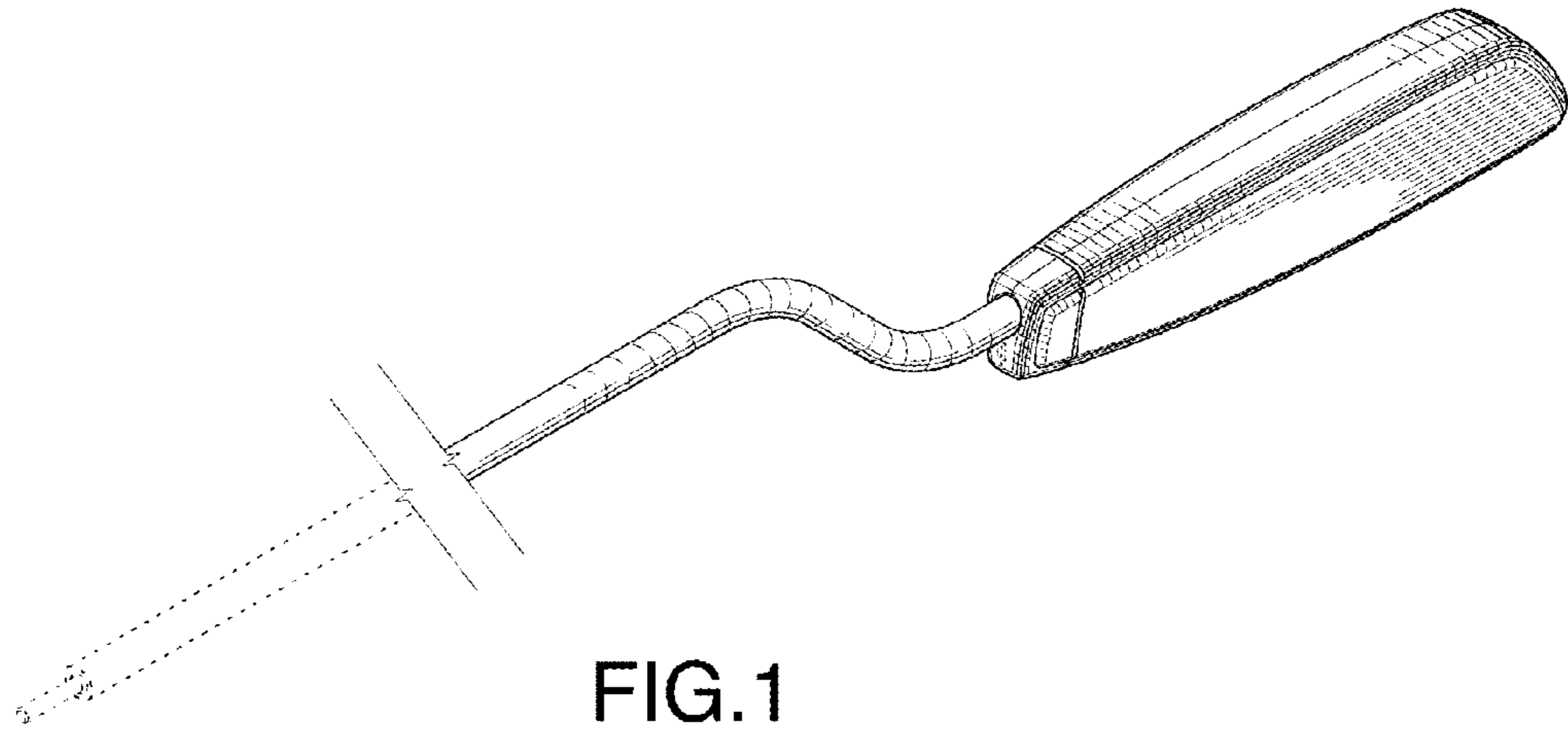

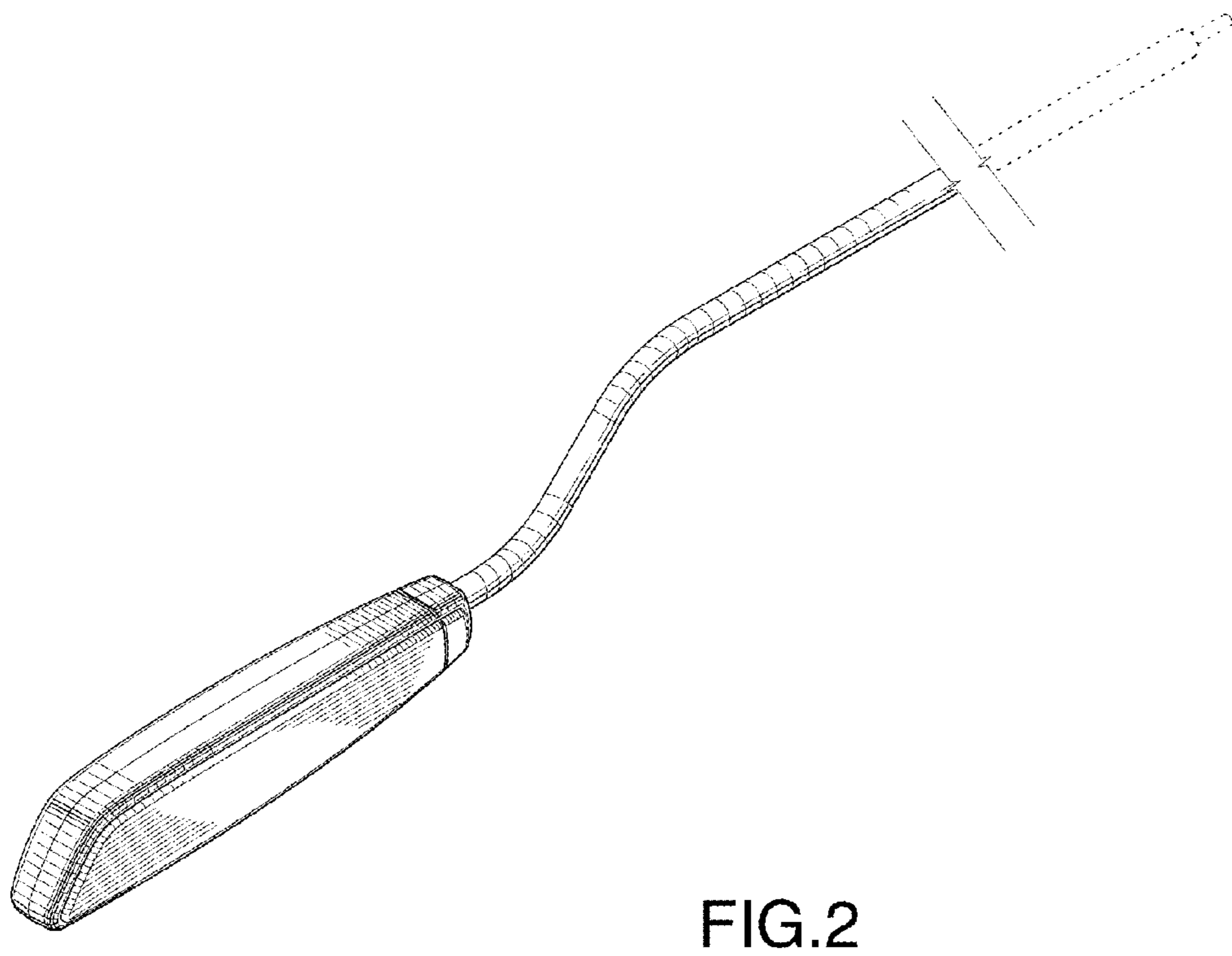

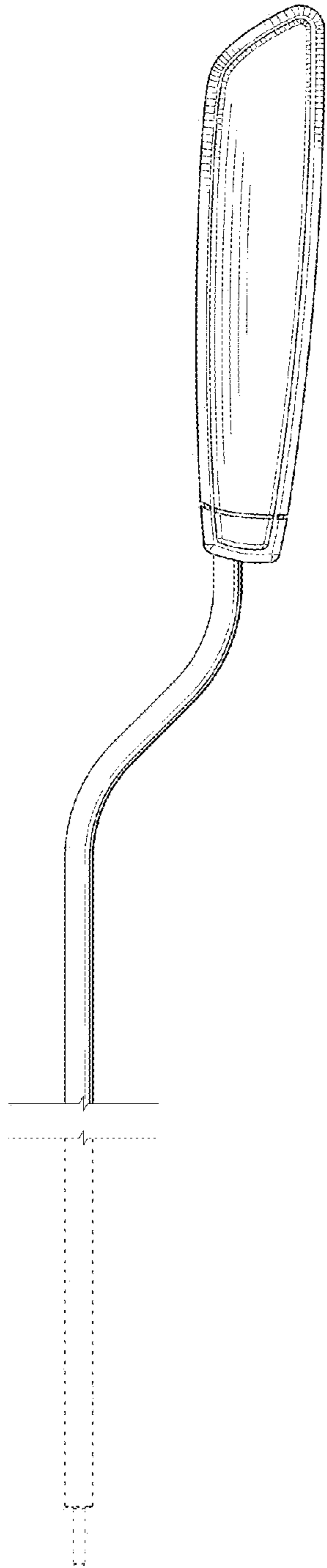

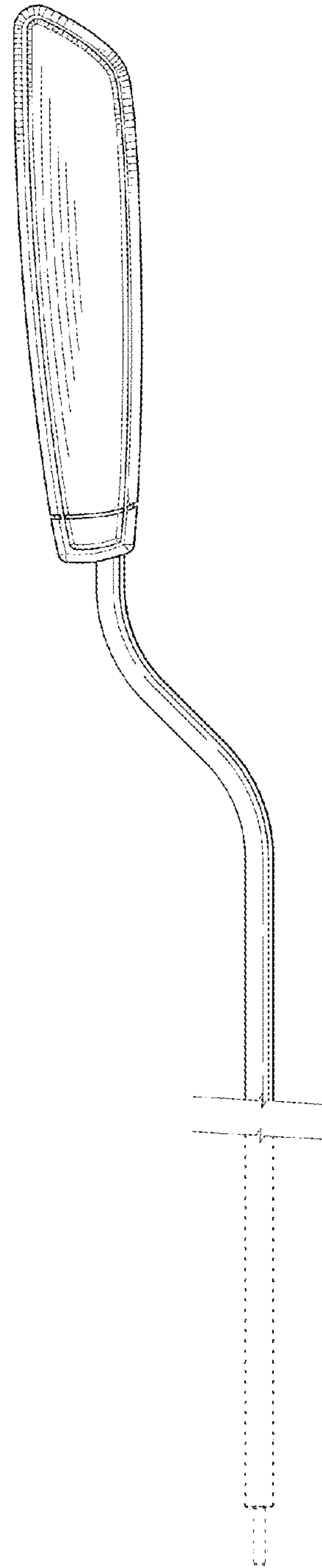

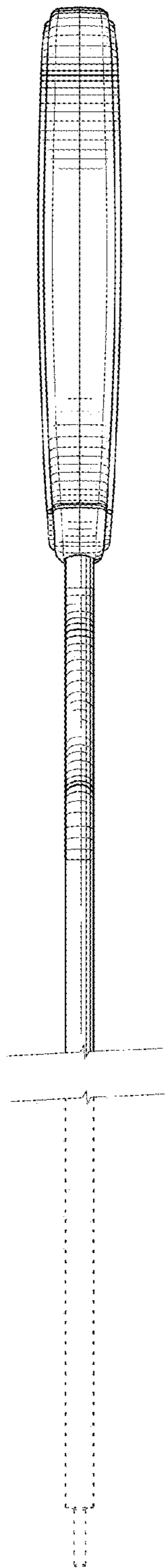

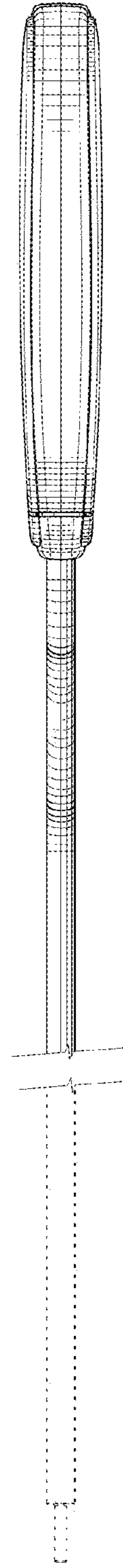

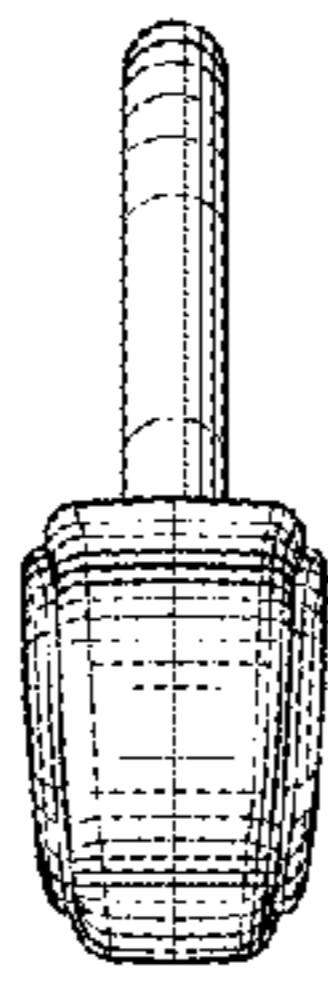

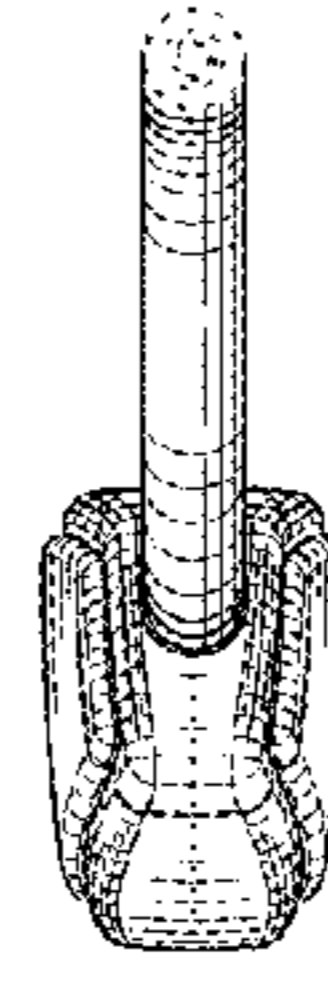

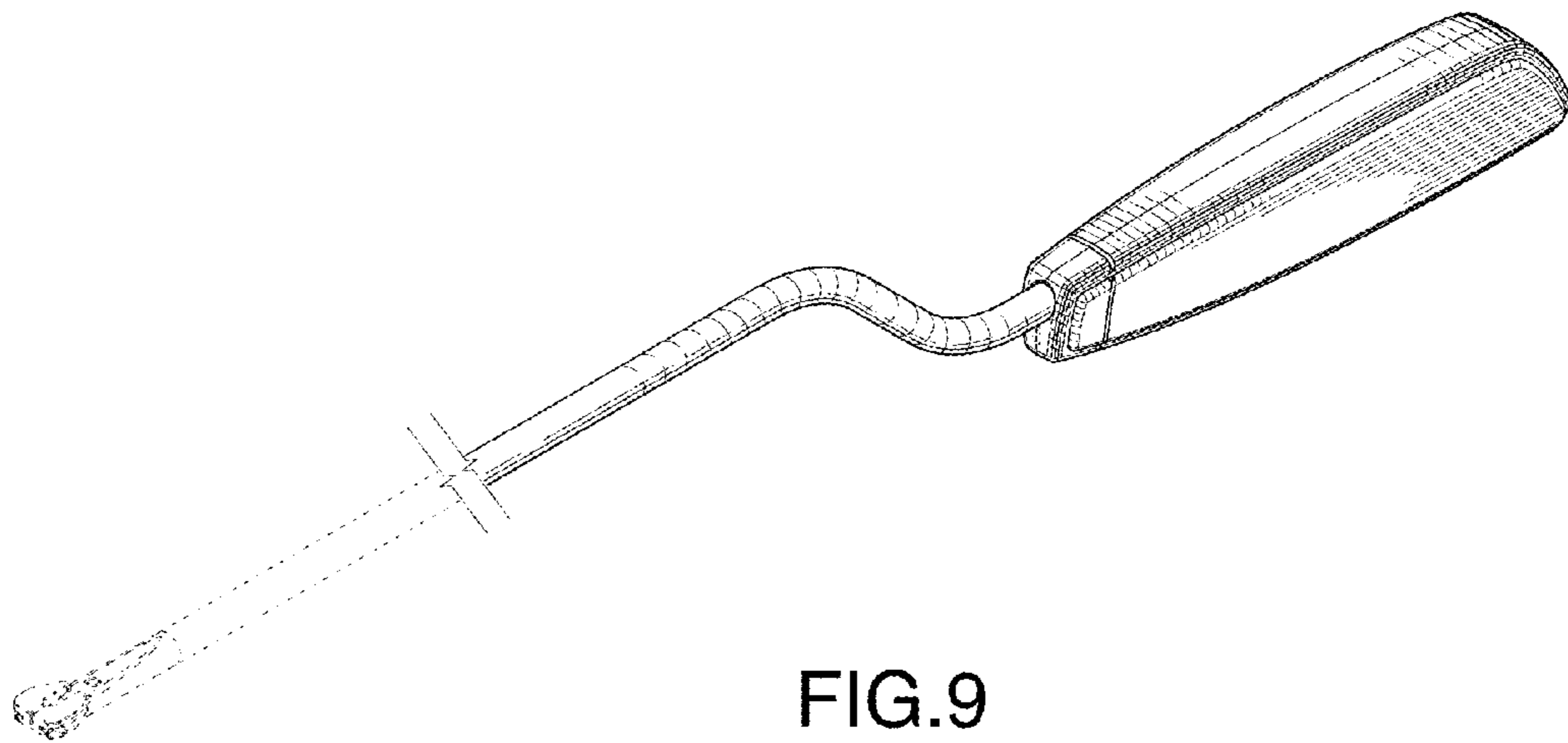
