The ornamental design for a colposcope, as shown and described.

DESCRIPTION

FIG. 1 is a right upper perspective view of a colposcope.
 FIG. 2 is a left front perspective view of the colposcope.
 FIG. 3 is a left lower perspective view of the colposcope.
 FIG. 4 is a left front lower perspective view of the colposcope.
 FIG. 5 is a left view of the colposcope.
 FIG. 6 is a right view of the colposcope.

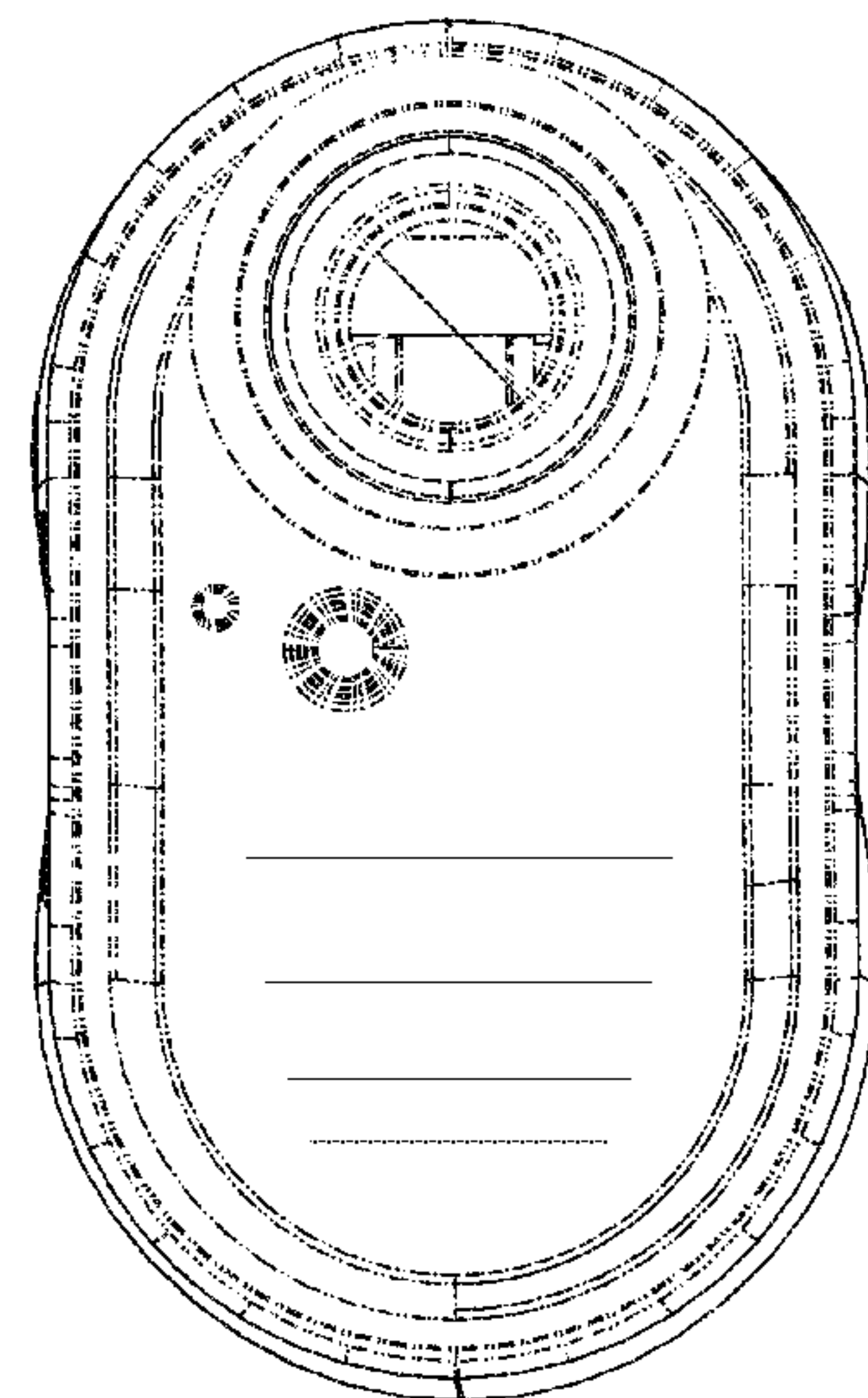
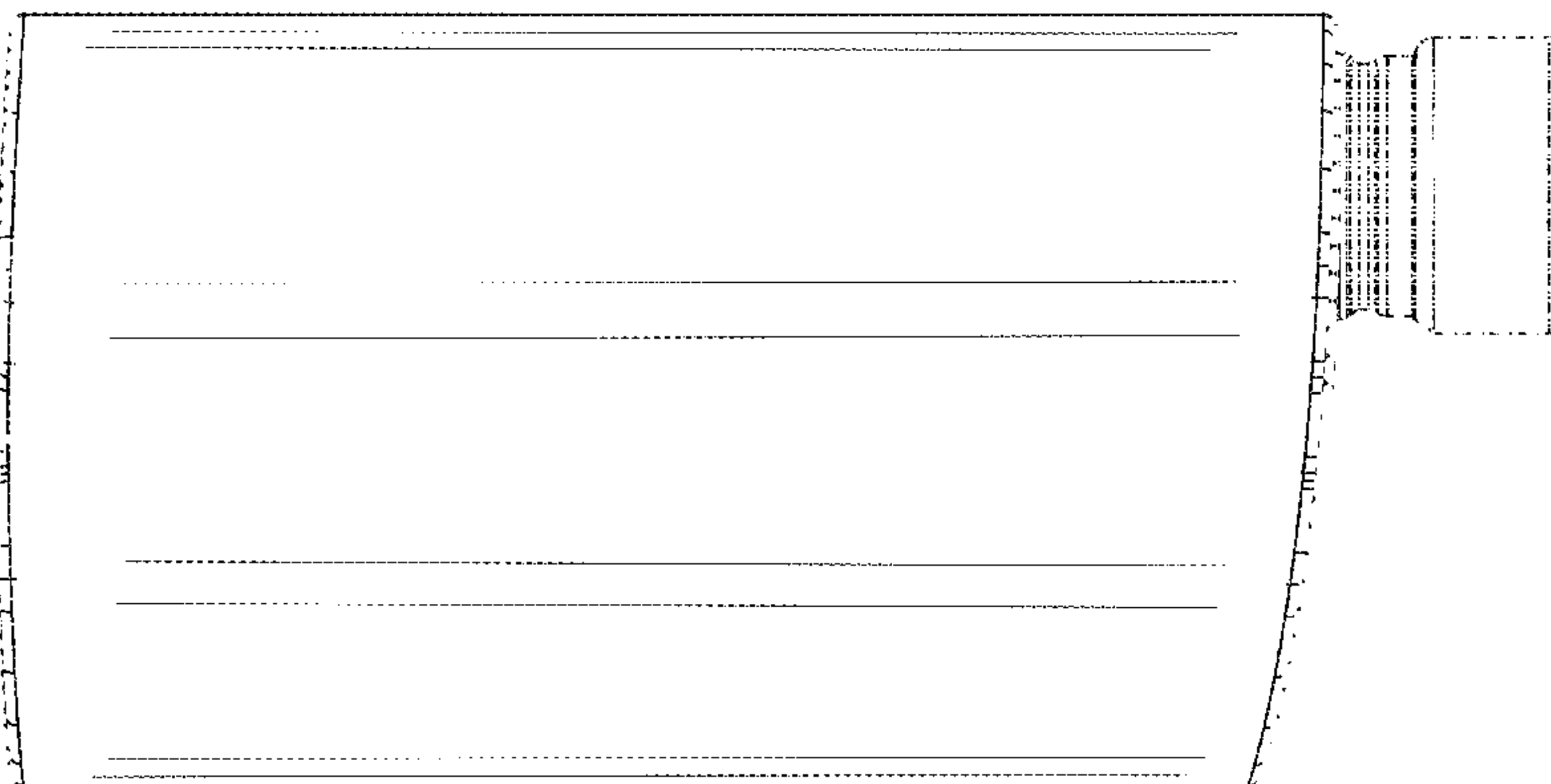

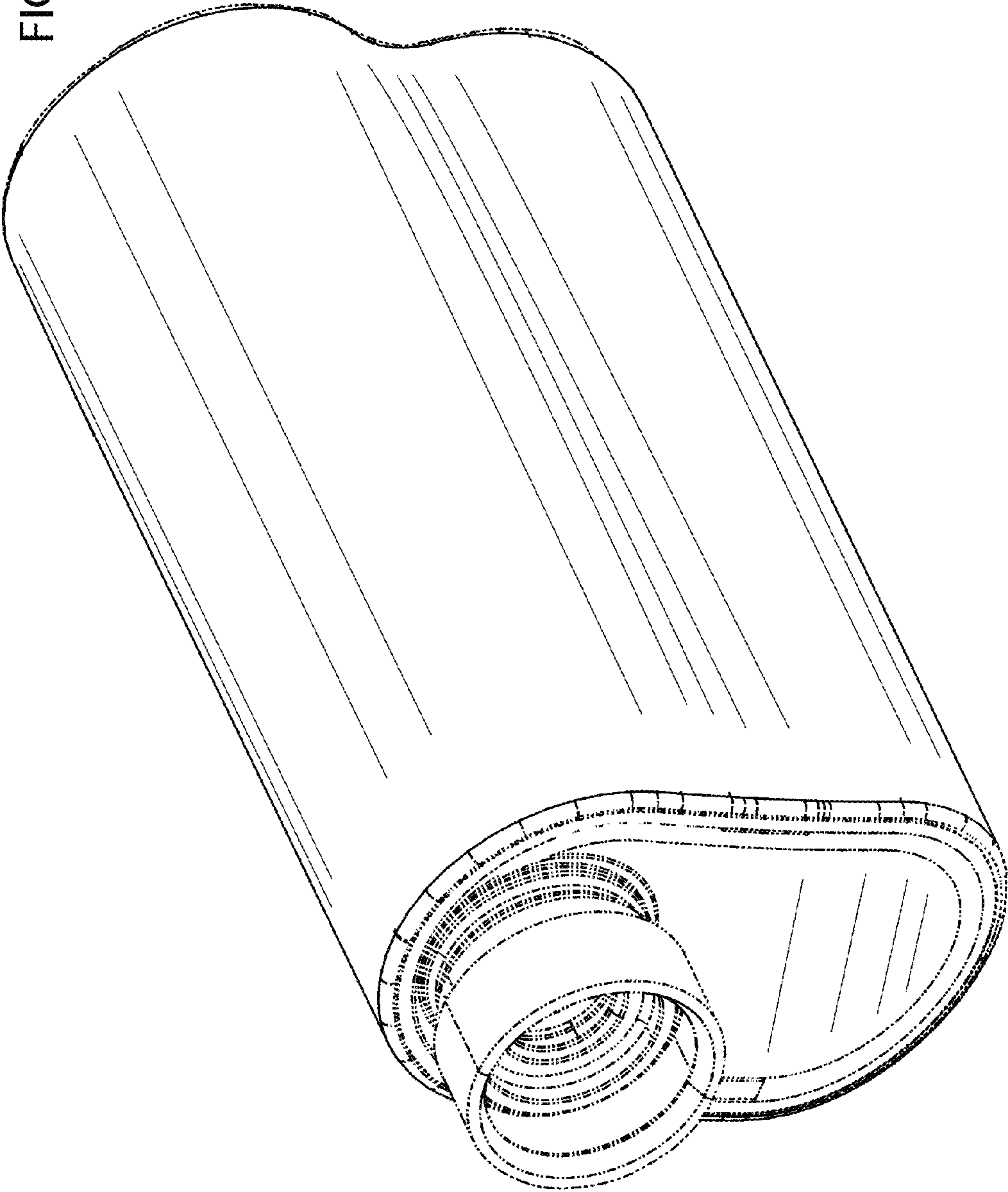

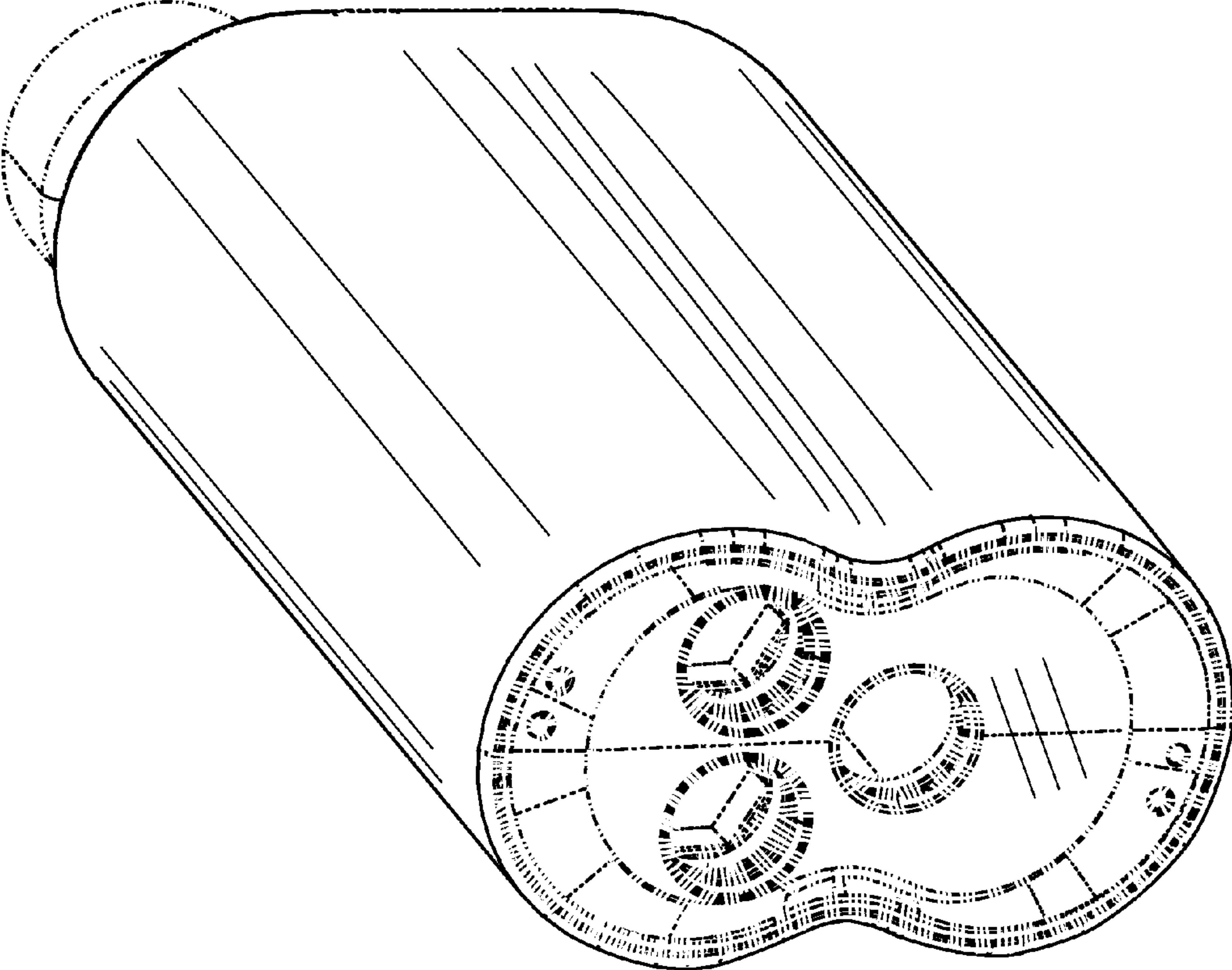

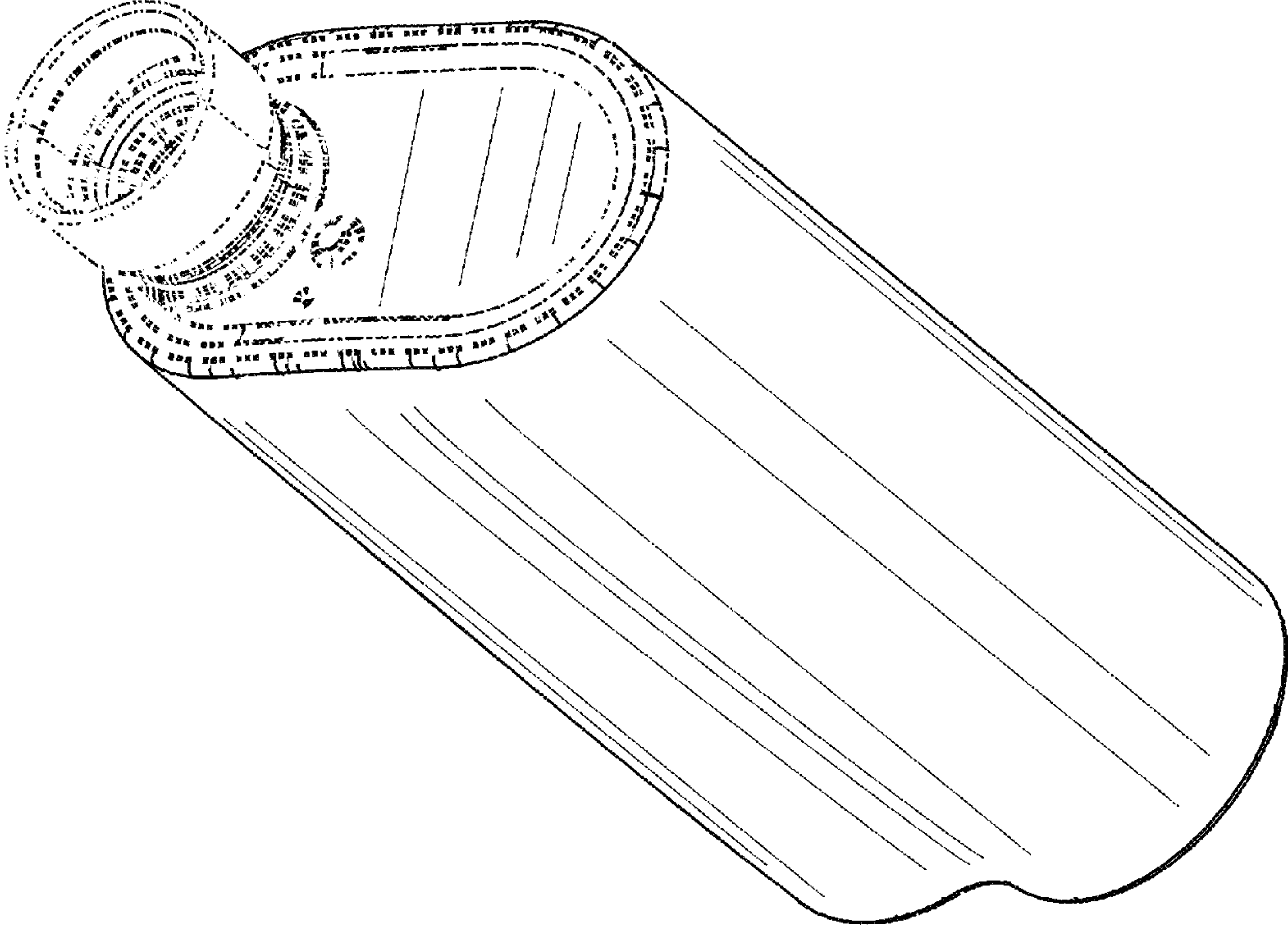

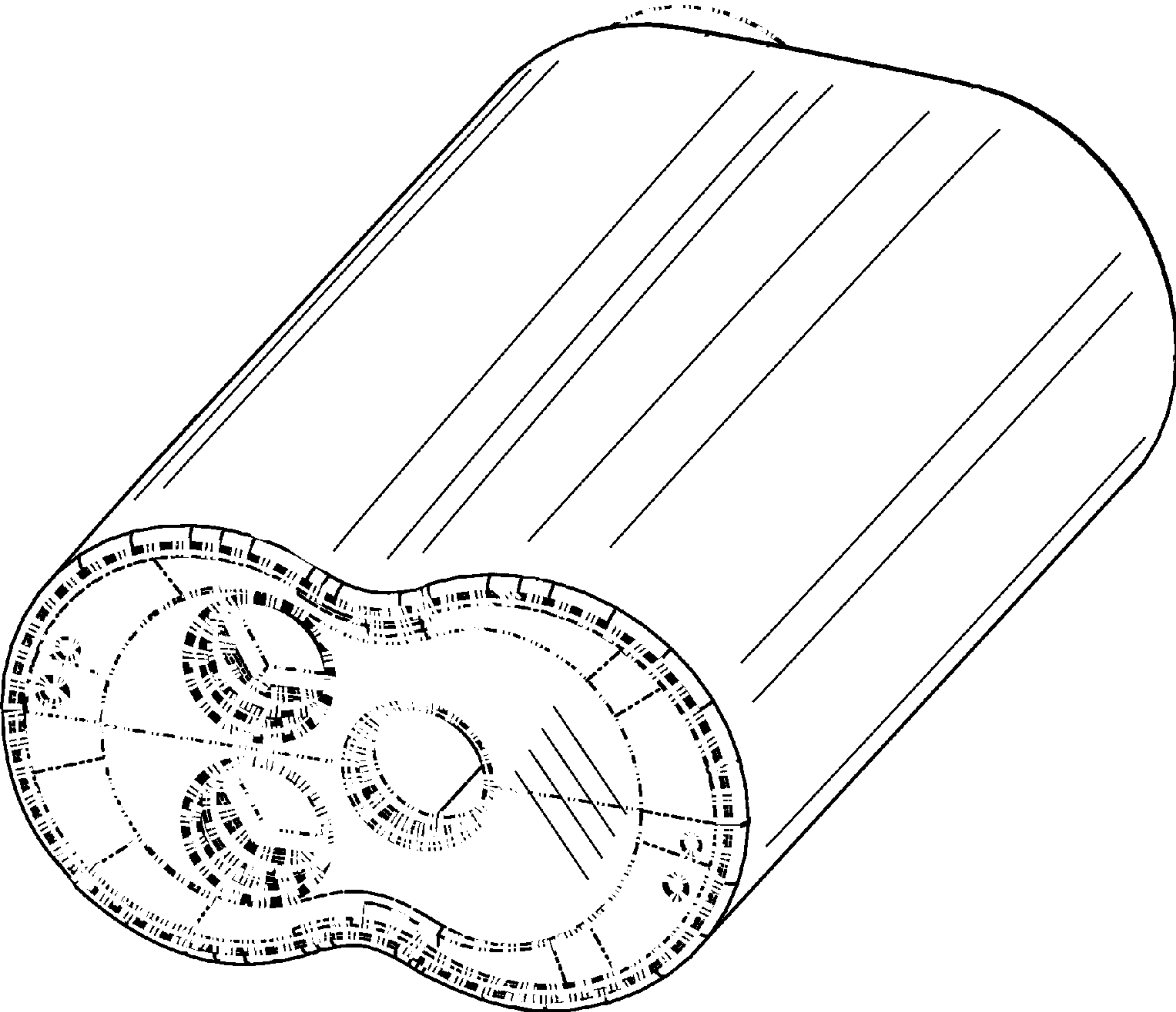

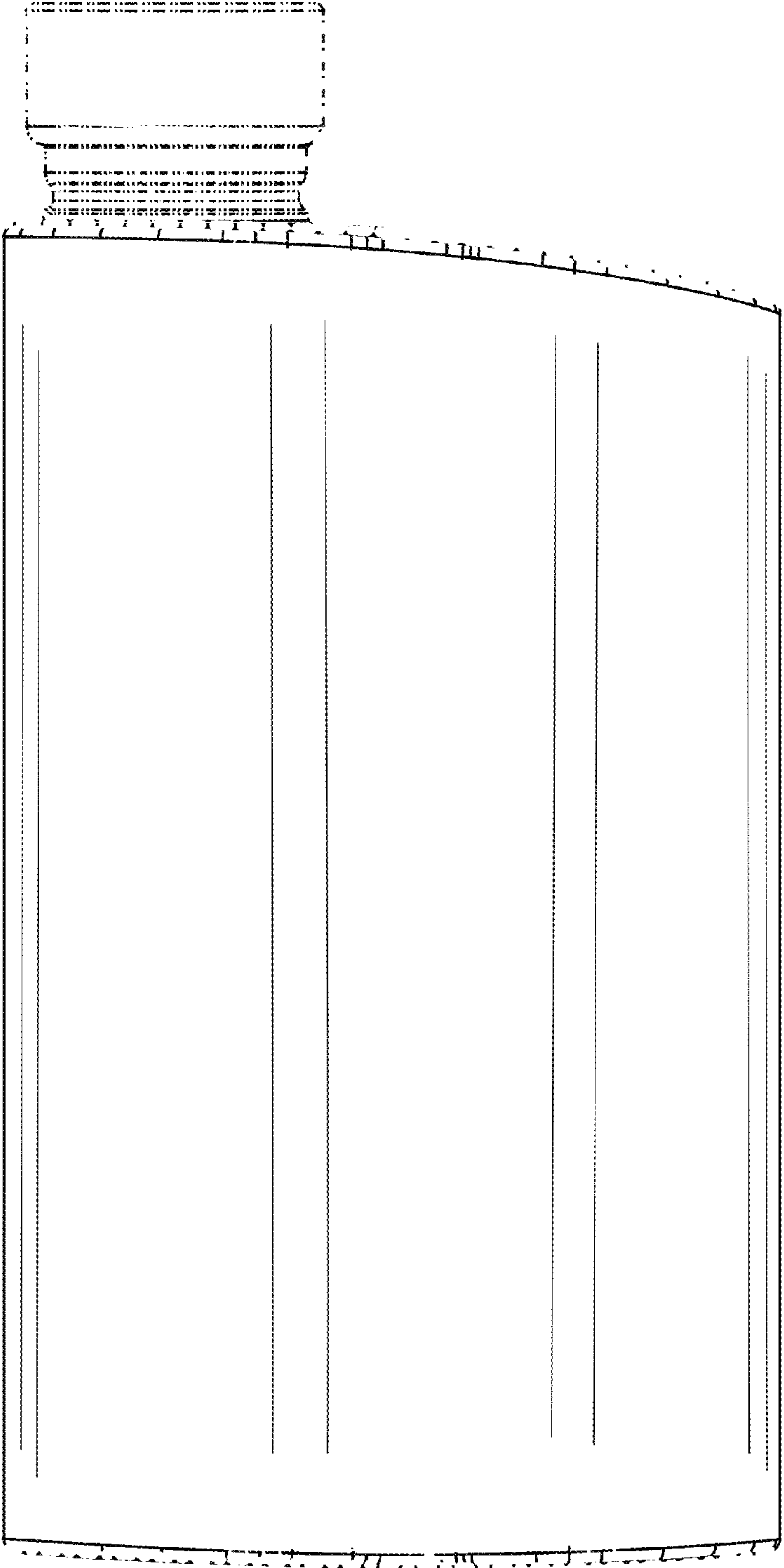

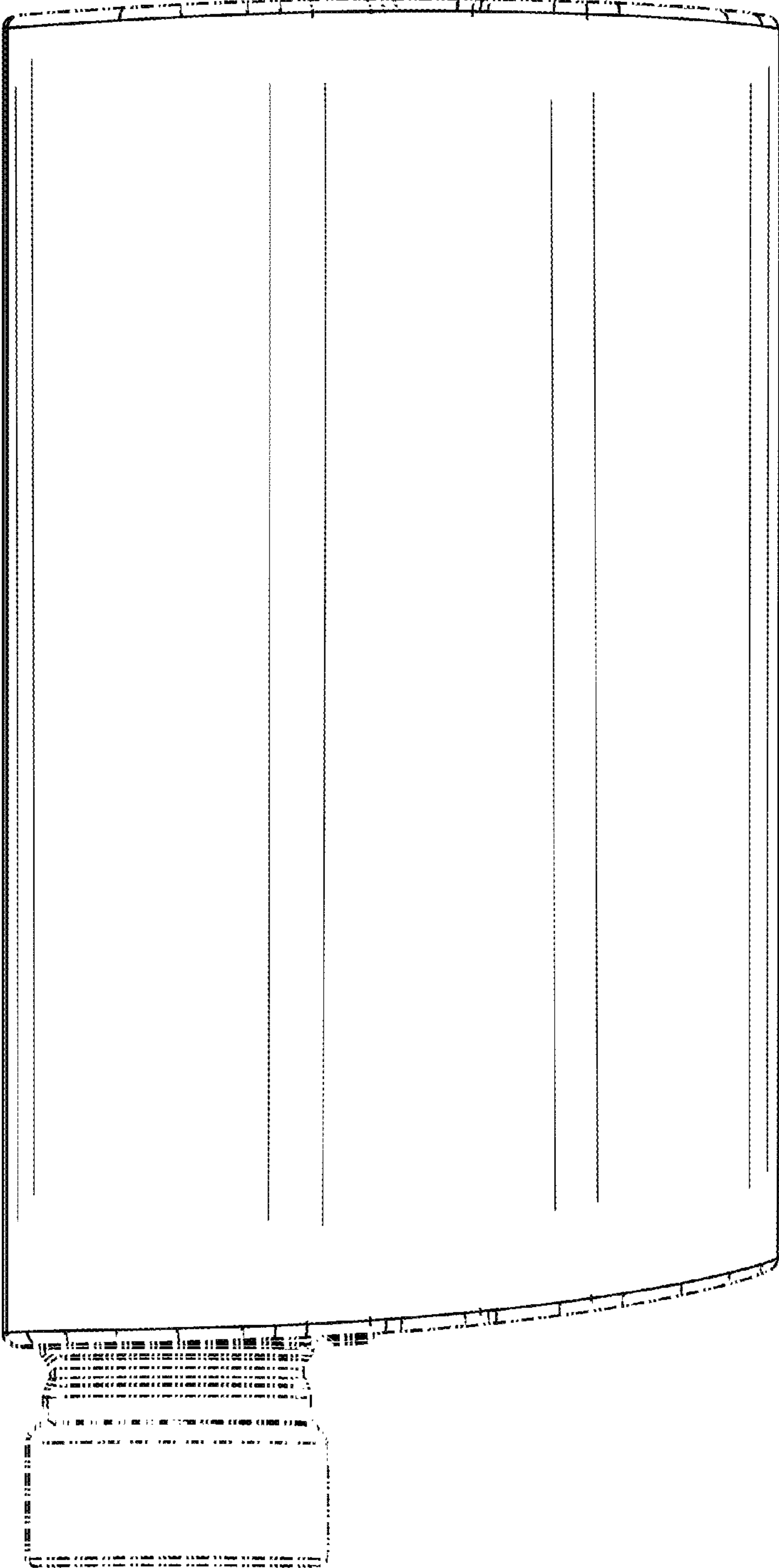

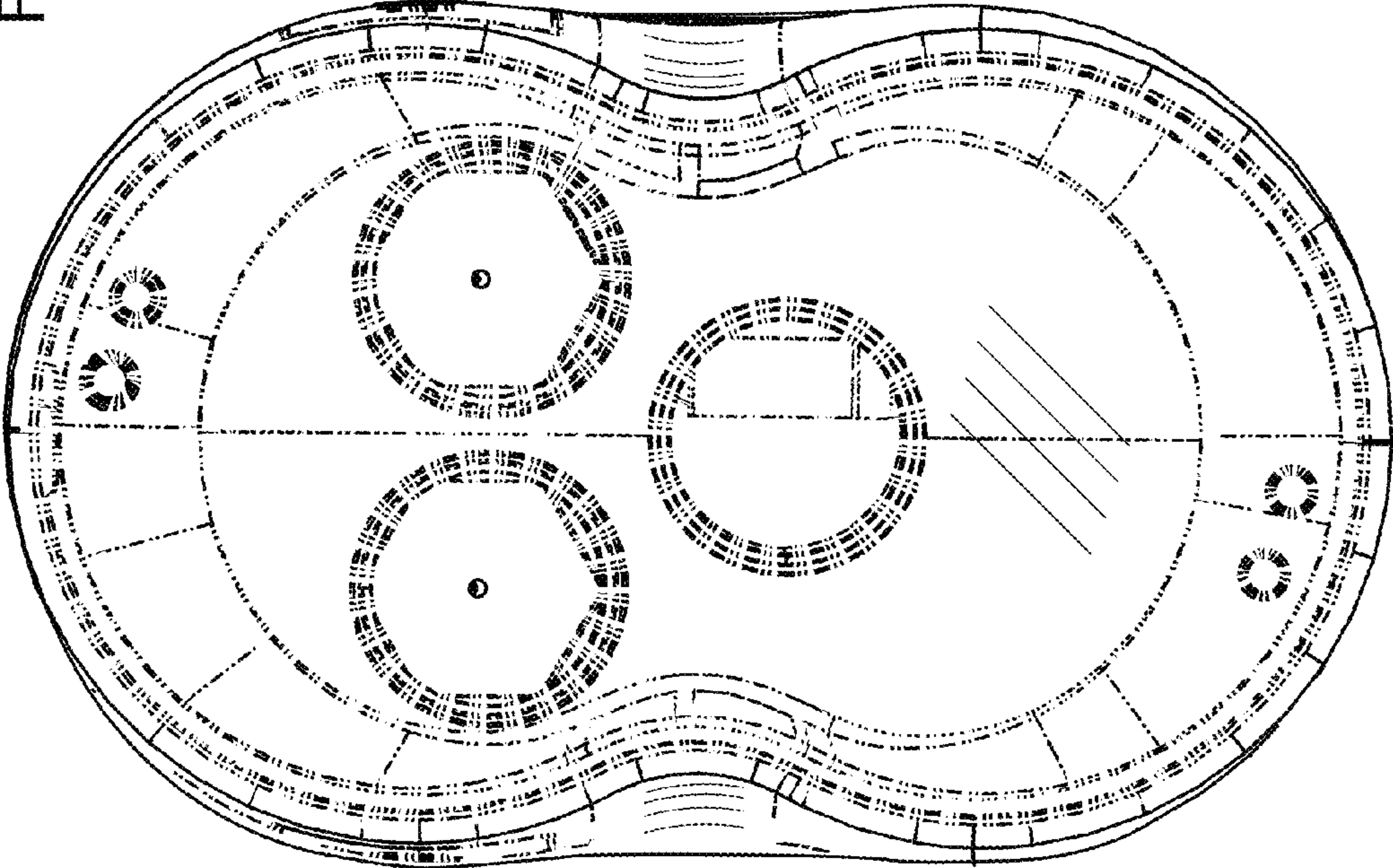

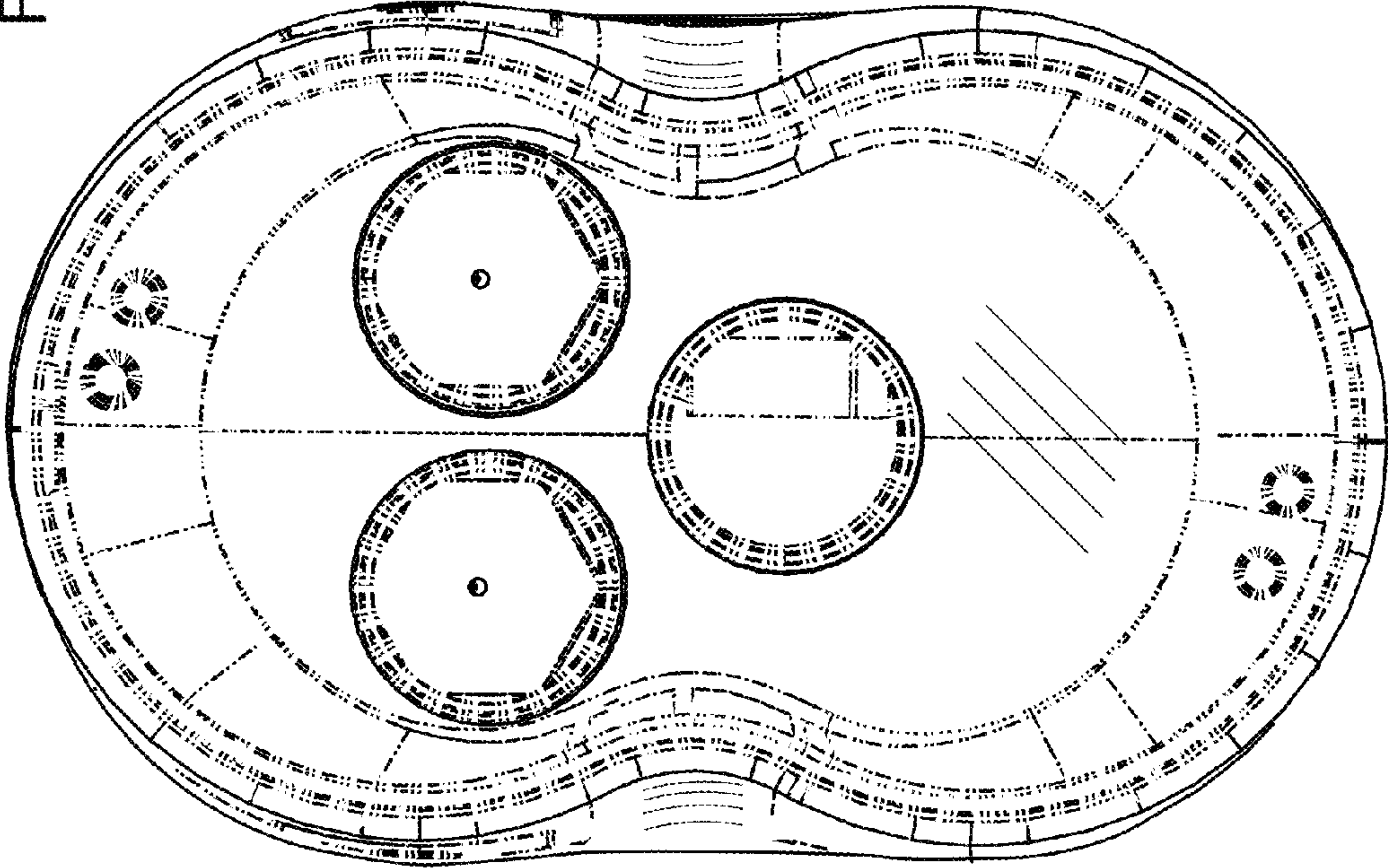

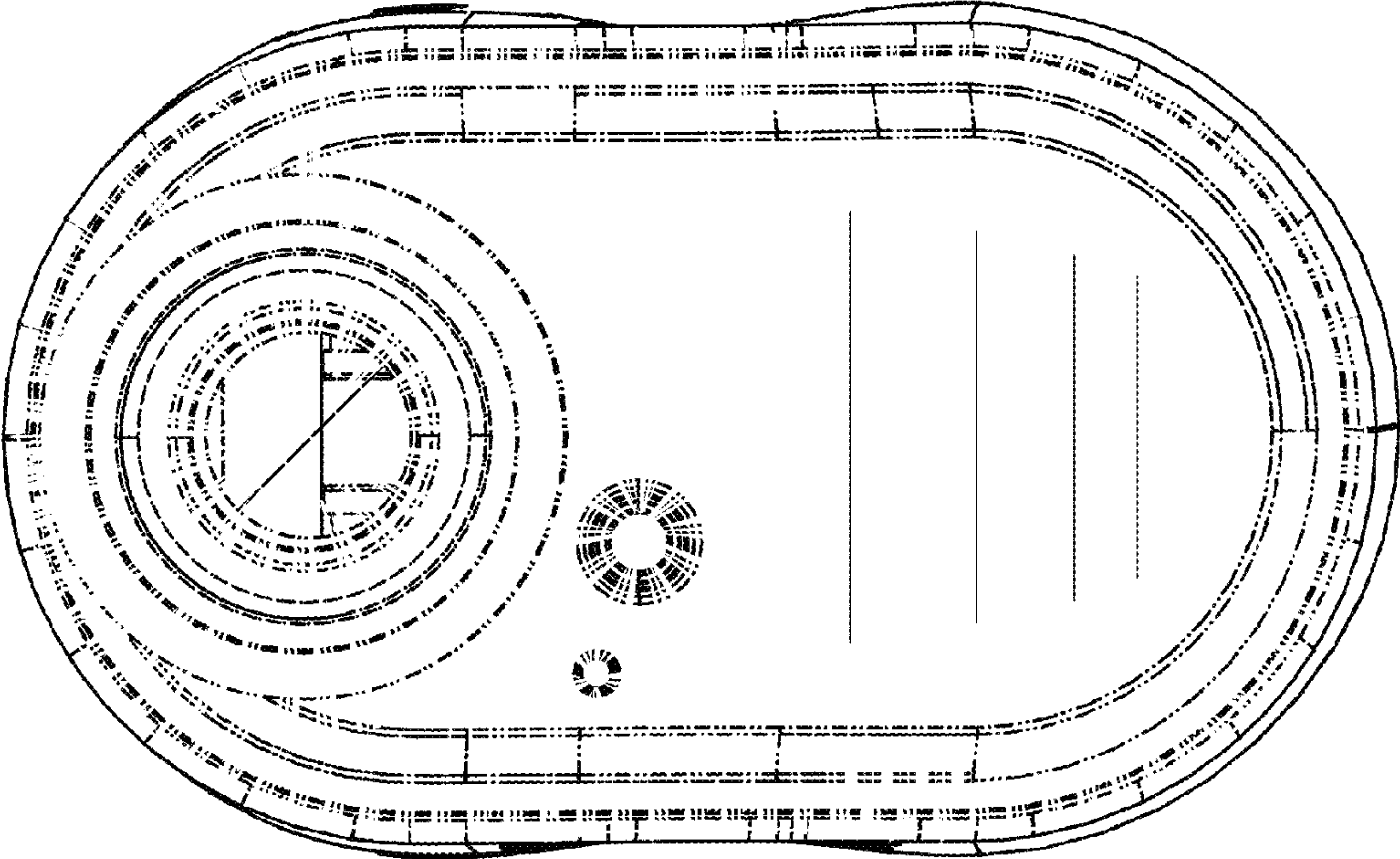

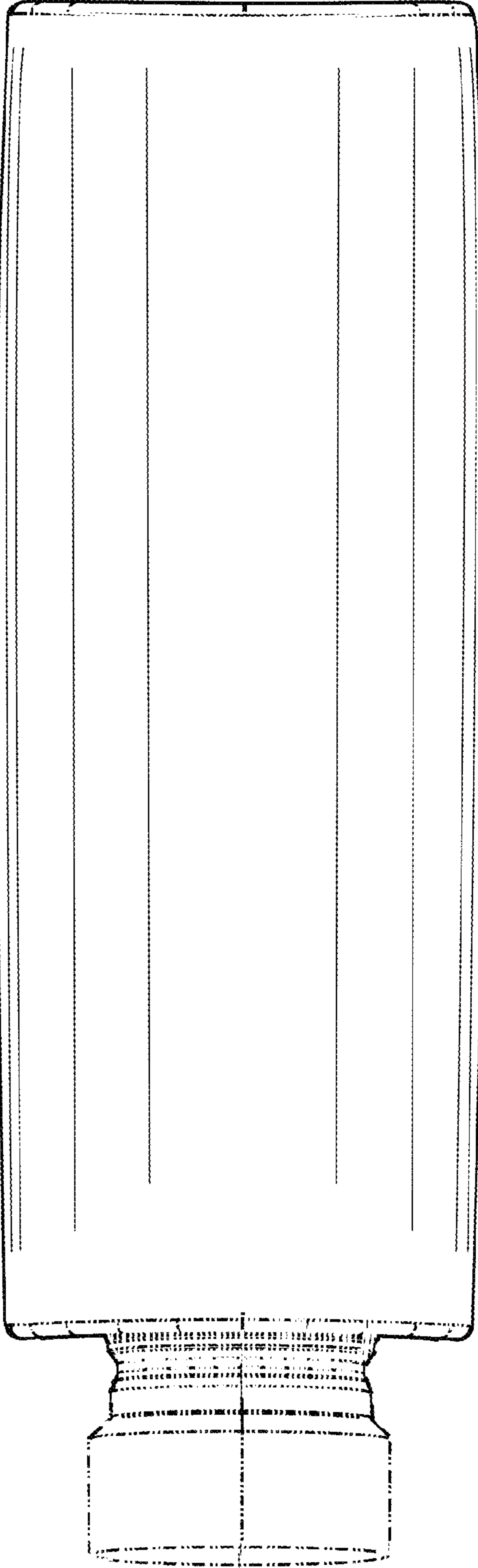
