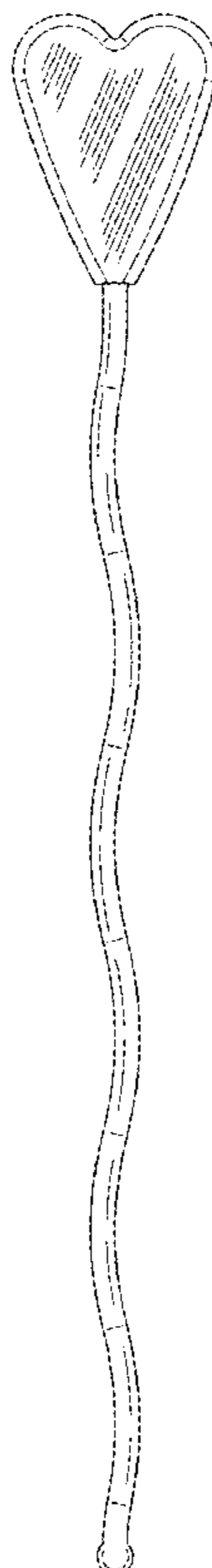
(57) **CLAIM**

I claim the ornamental design for an ointment applicator, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of an ointment applicator;
FIG. 2 is a front elevation view thereof;

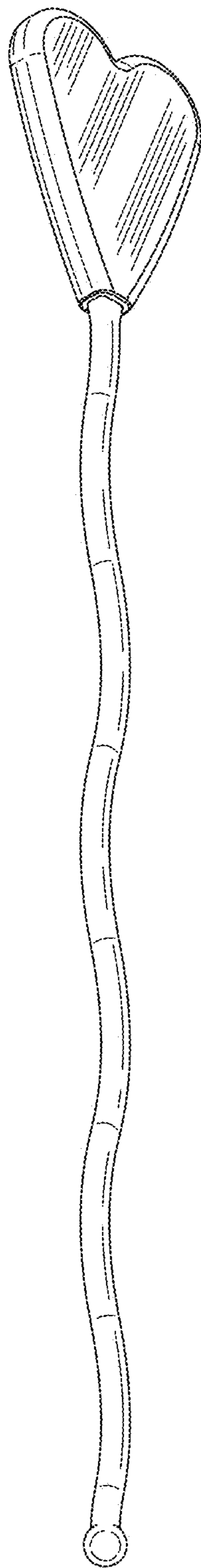

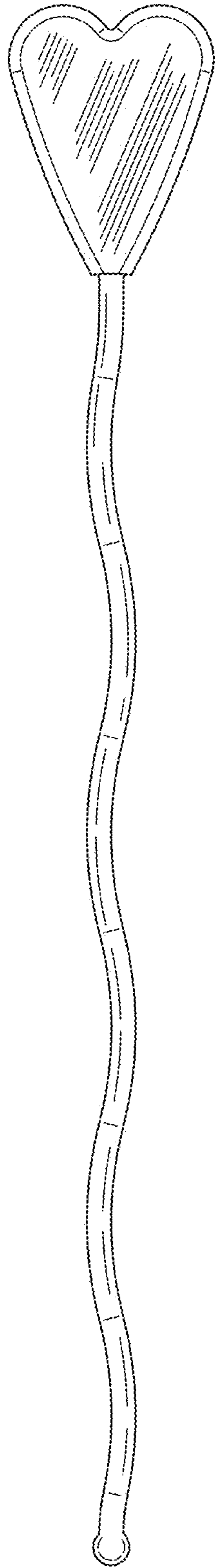

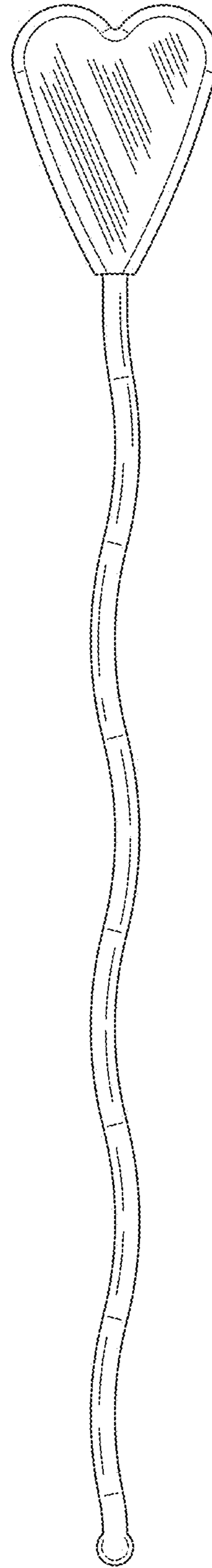

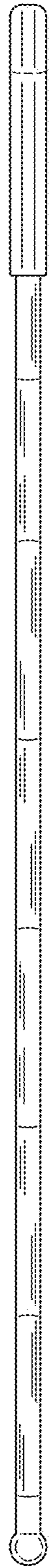

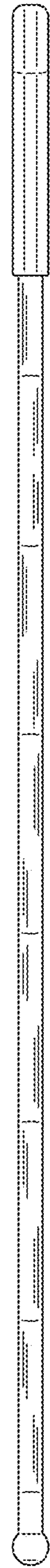

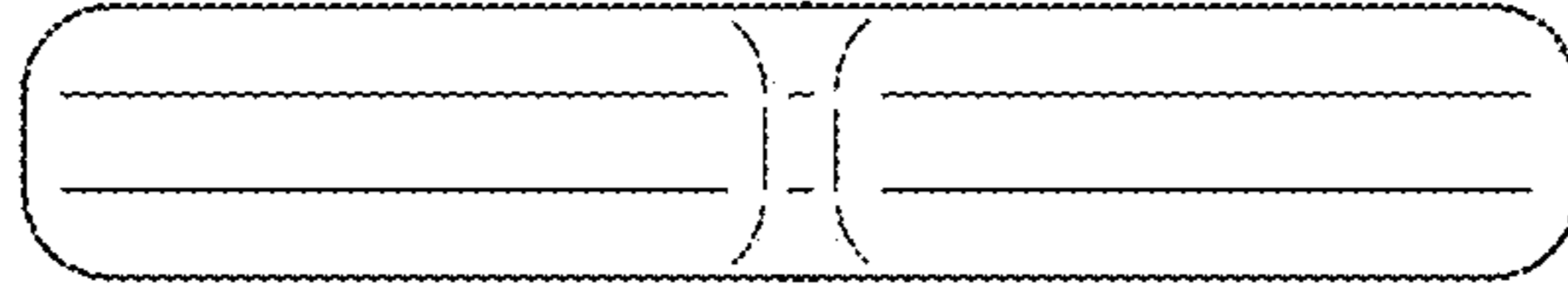

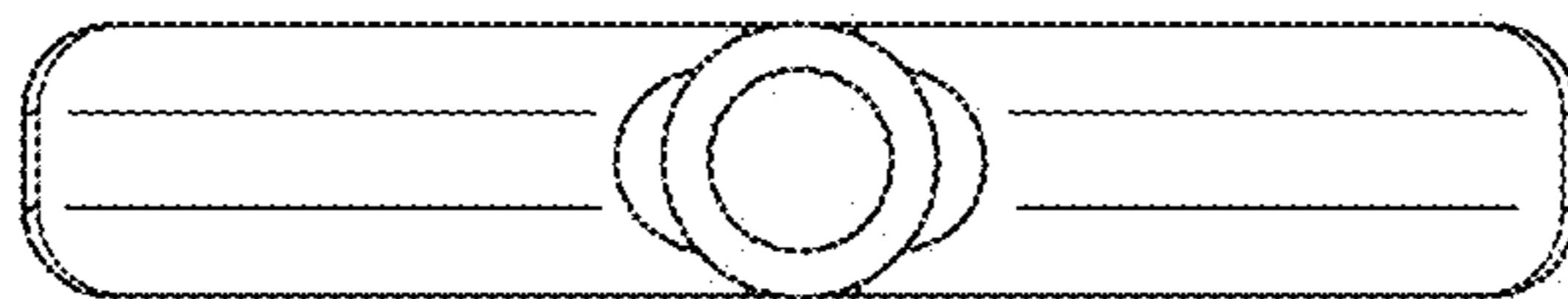
