(57) **CLAIM**

The ornamental design for a spur tie down strap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a spur tie down strap showing my new design in a deflected state;

FIG. 2 is a perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevation view thereof, the rear elevation view being a mirror image of FIG. 4;

FIG. 5 is a right elevation view thereof;

FIG. 6 is a left elevation view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of the spur tie down strap shown in a second, non-deflected state;

FIG. 9 is a top plan view thereof, the bottom plan view being a mirror image of FIG. 9;

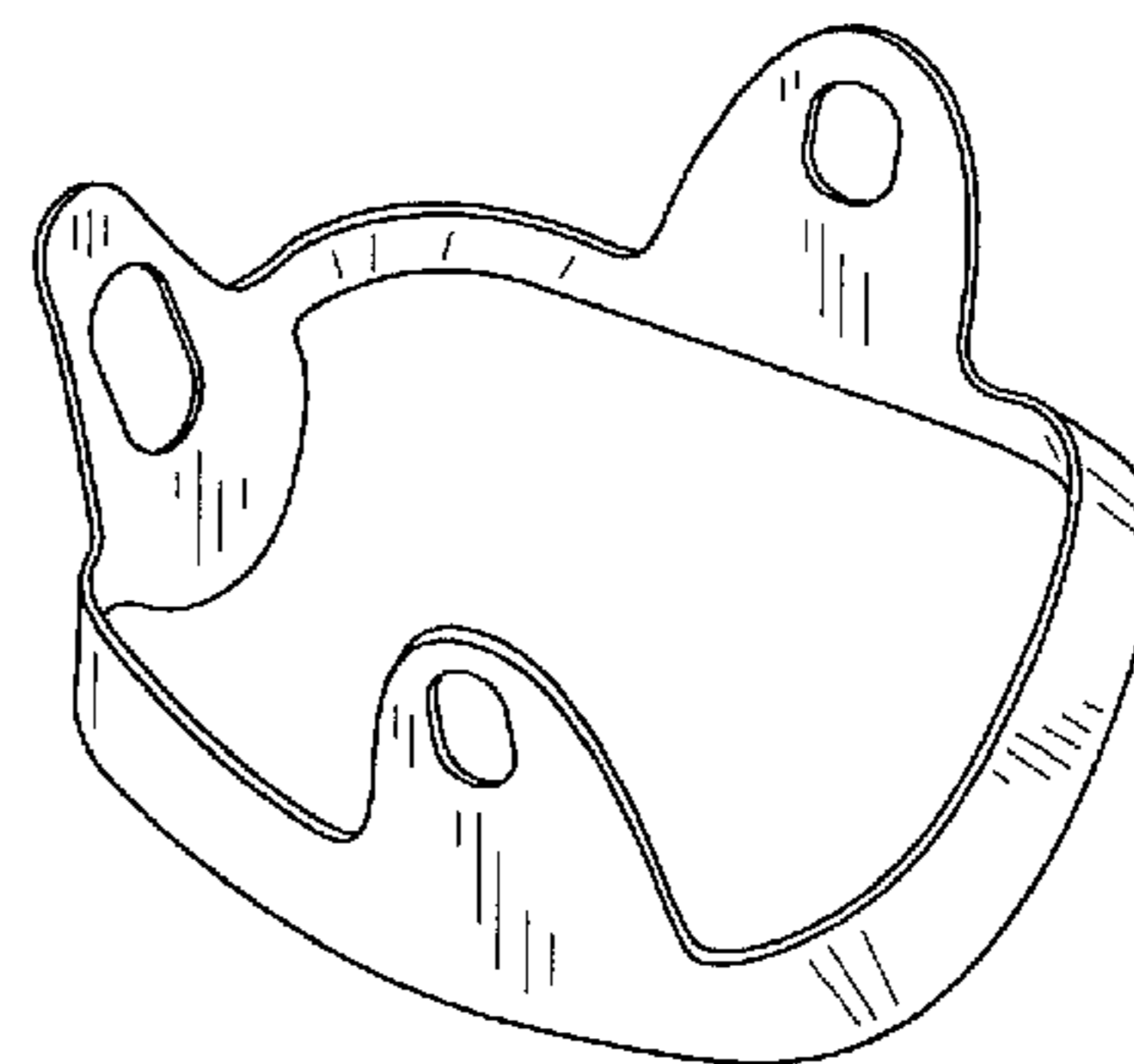
FIG. 10 is a front elevation view thereof, the rear elevation view being a mirror image of FIG. 10;

FIG. 11 is a left elevation view thereof; and,

FIG. 12 is a right elevation view thereof.

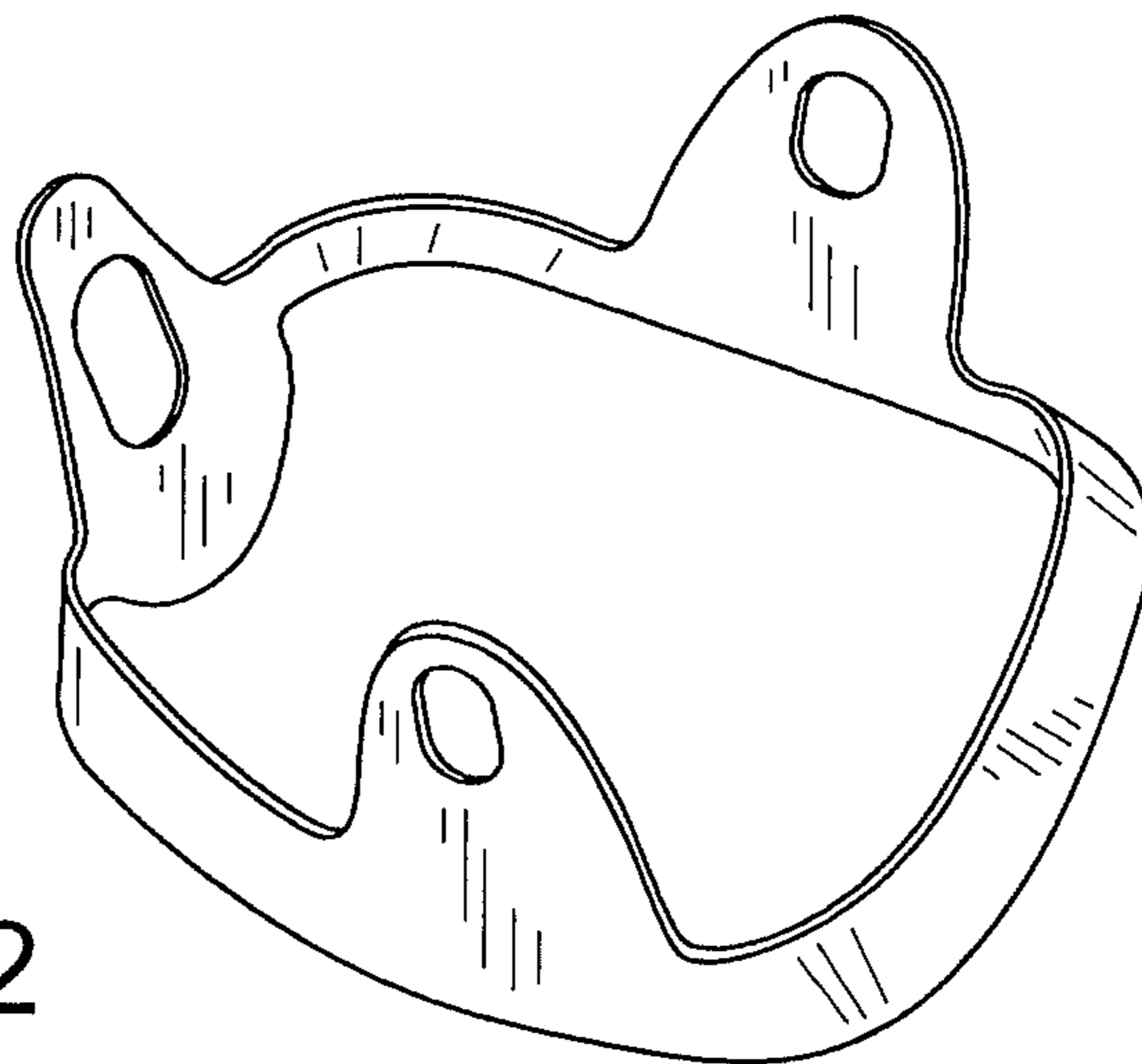

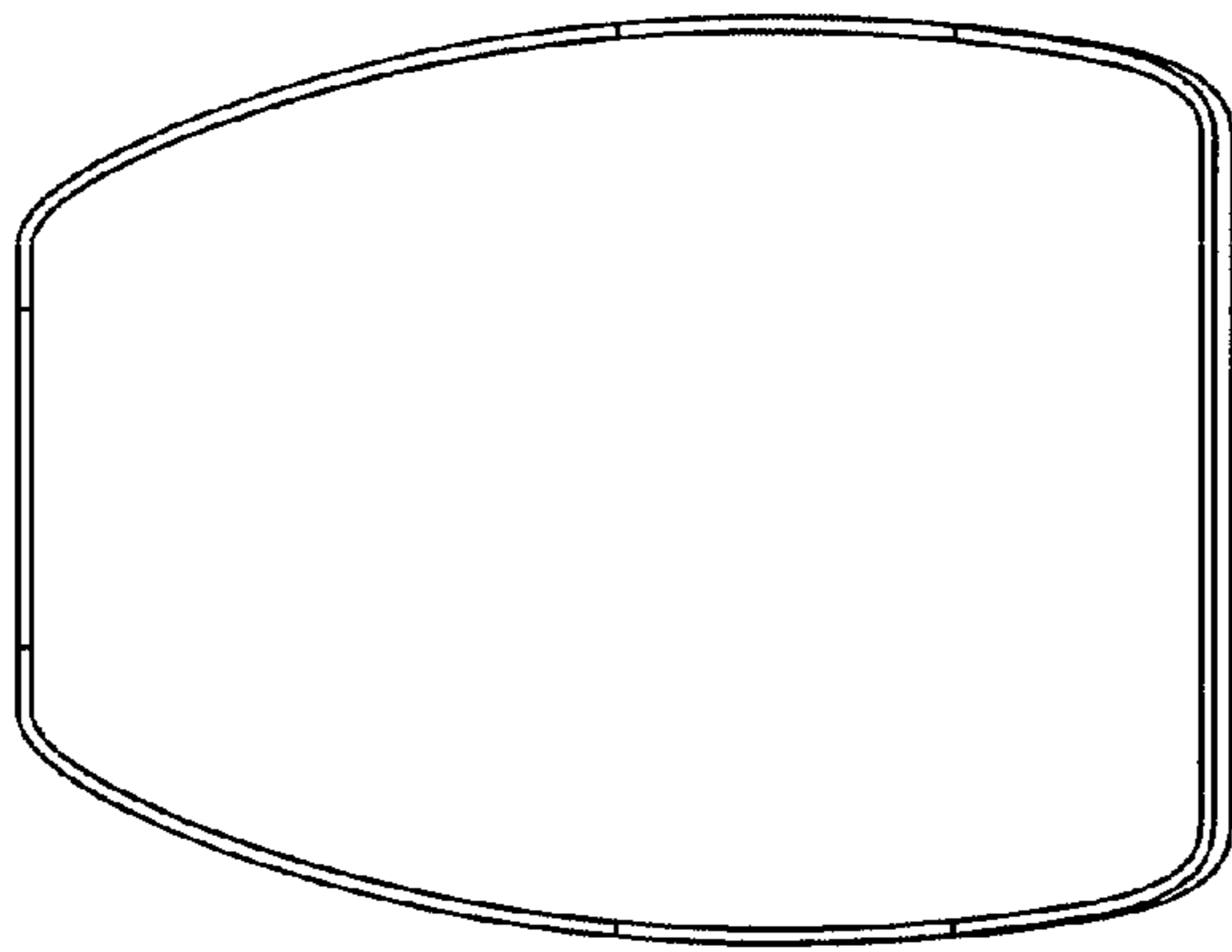

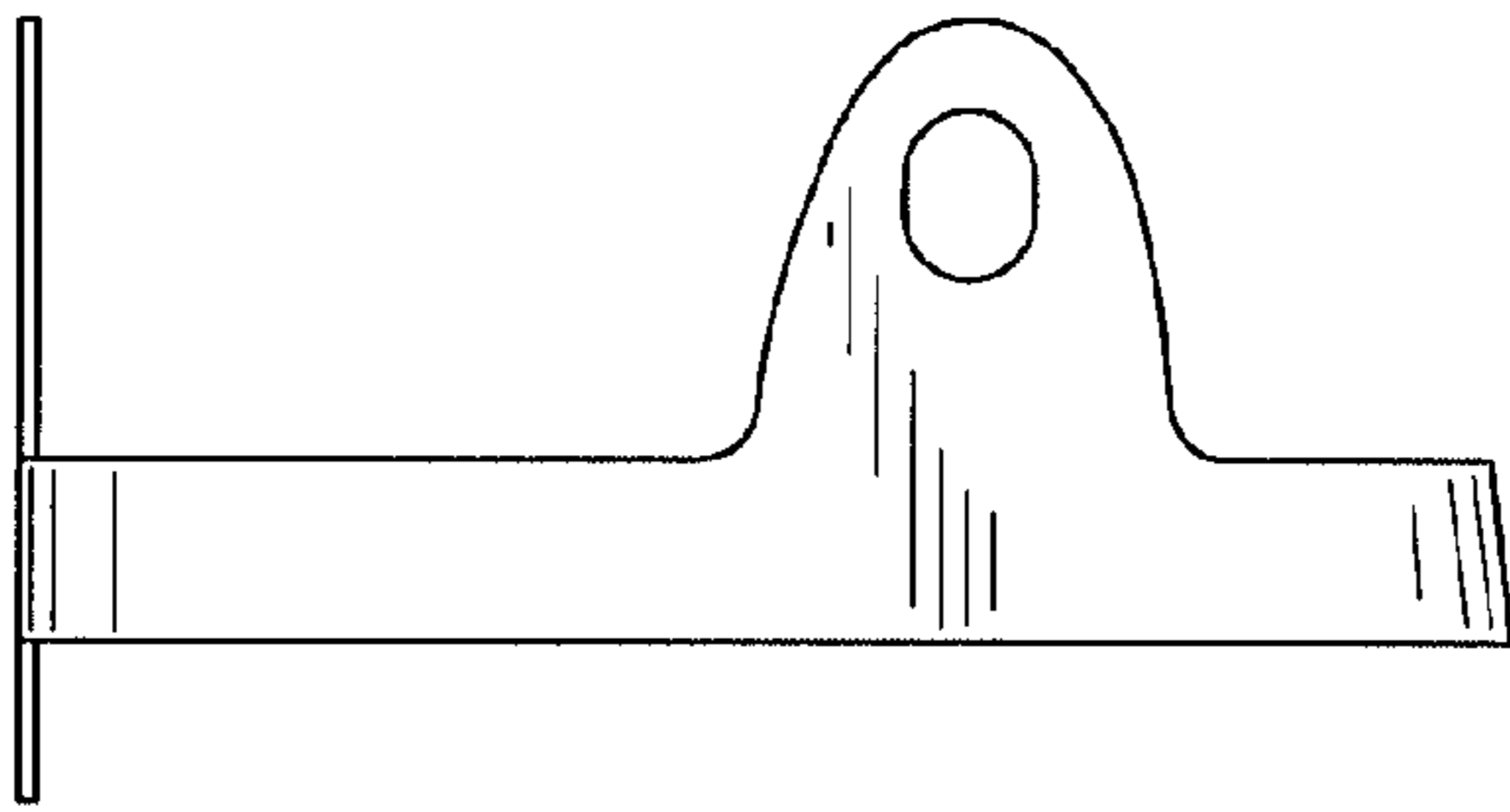

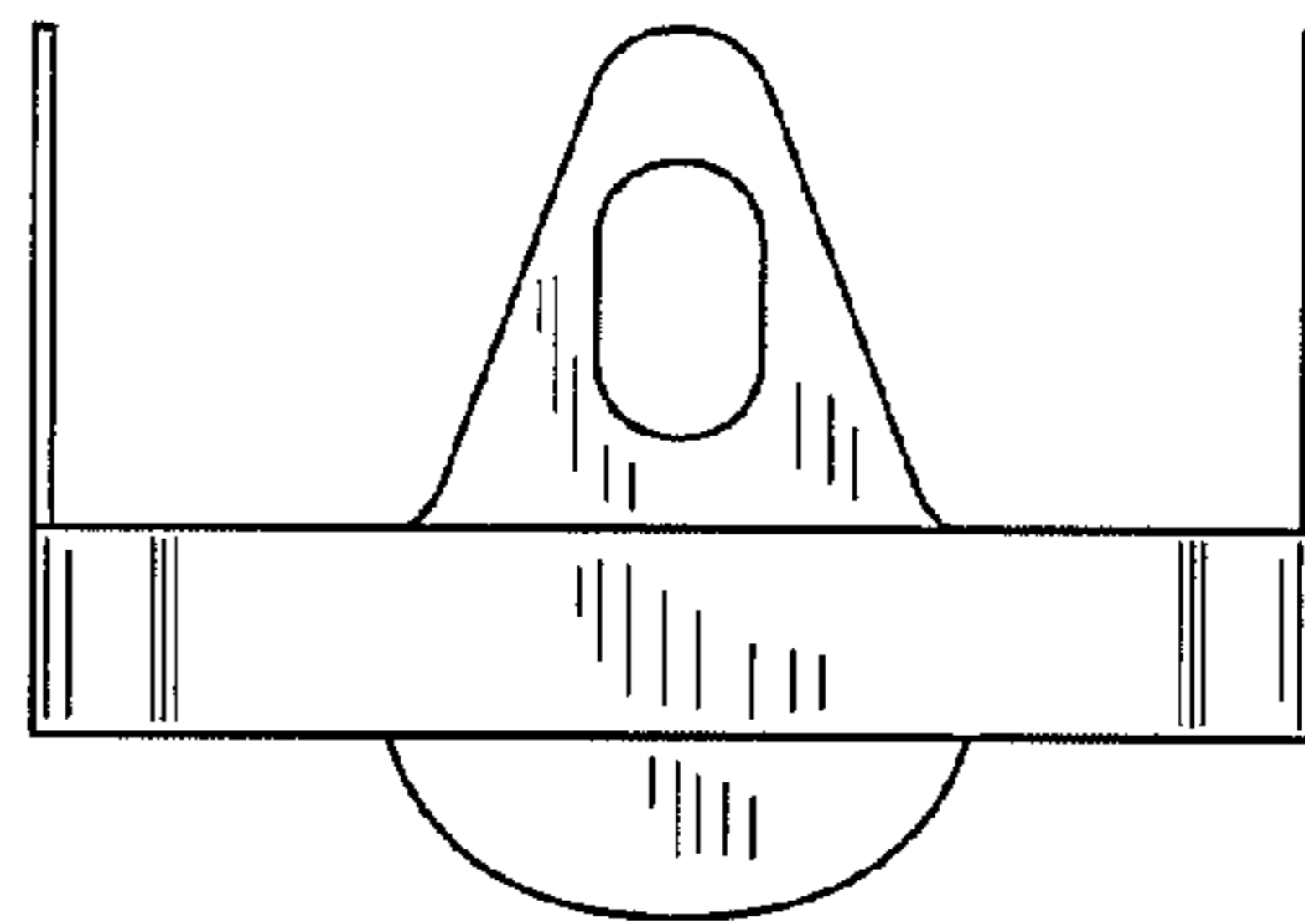

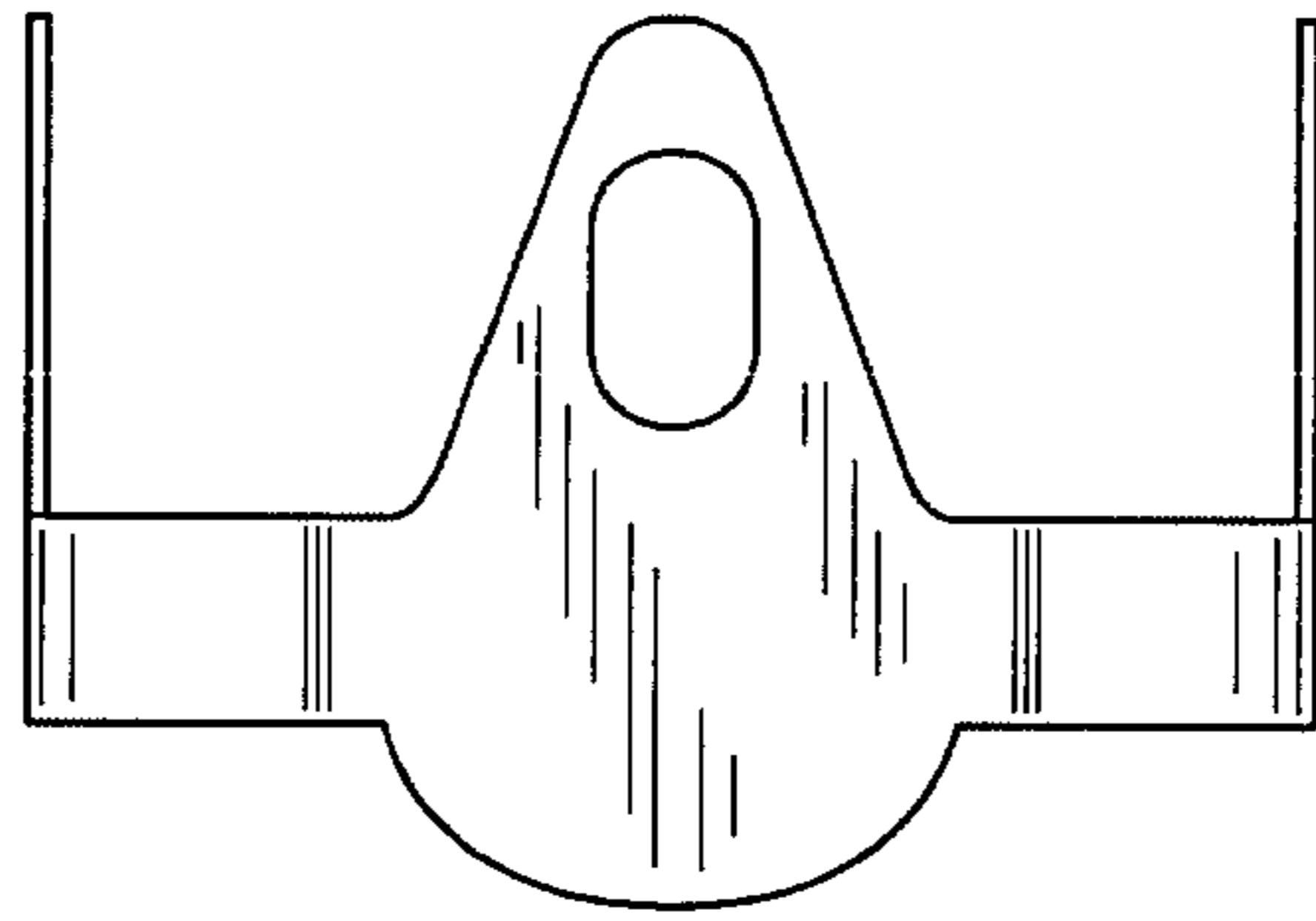

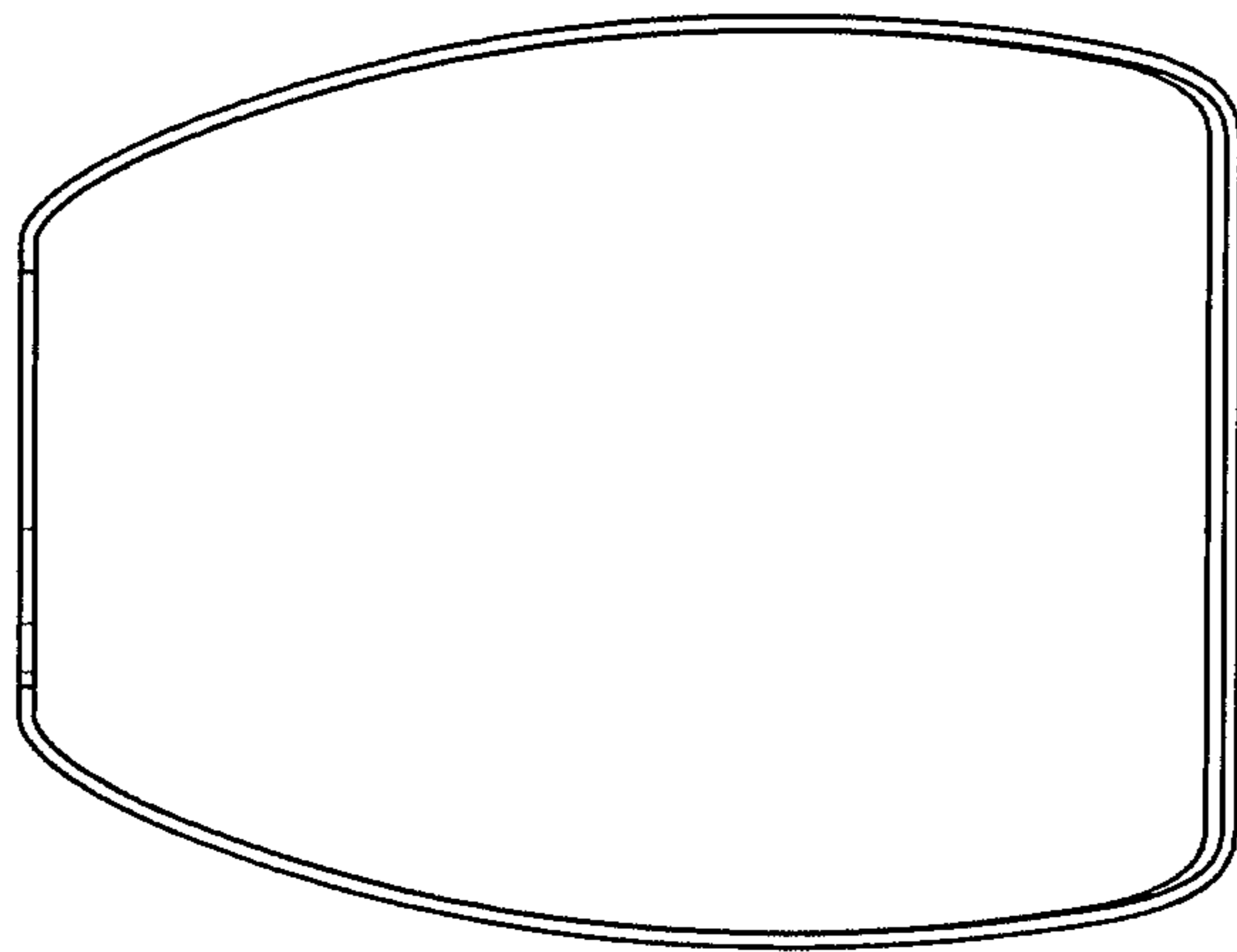

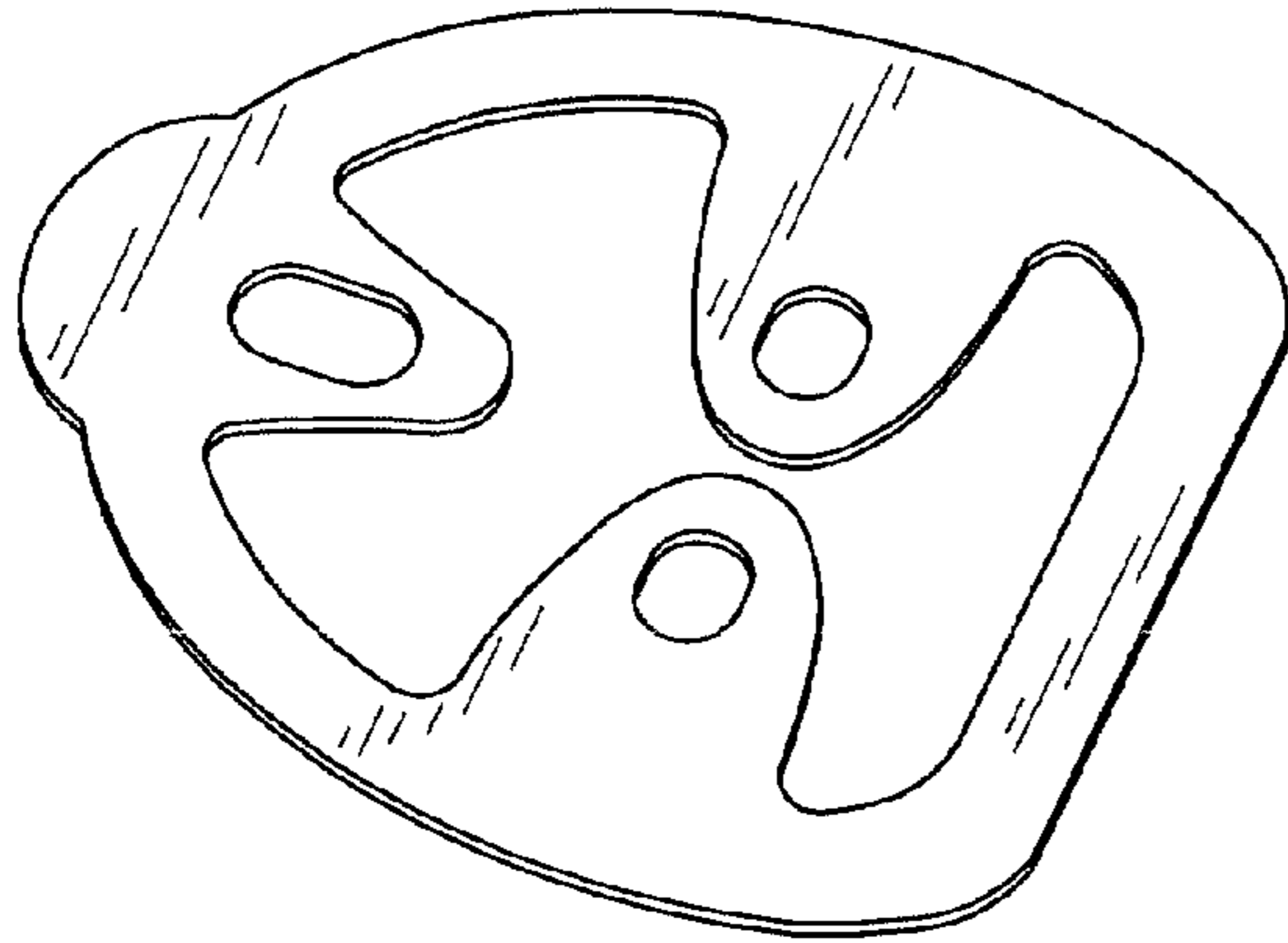

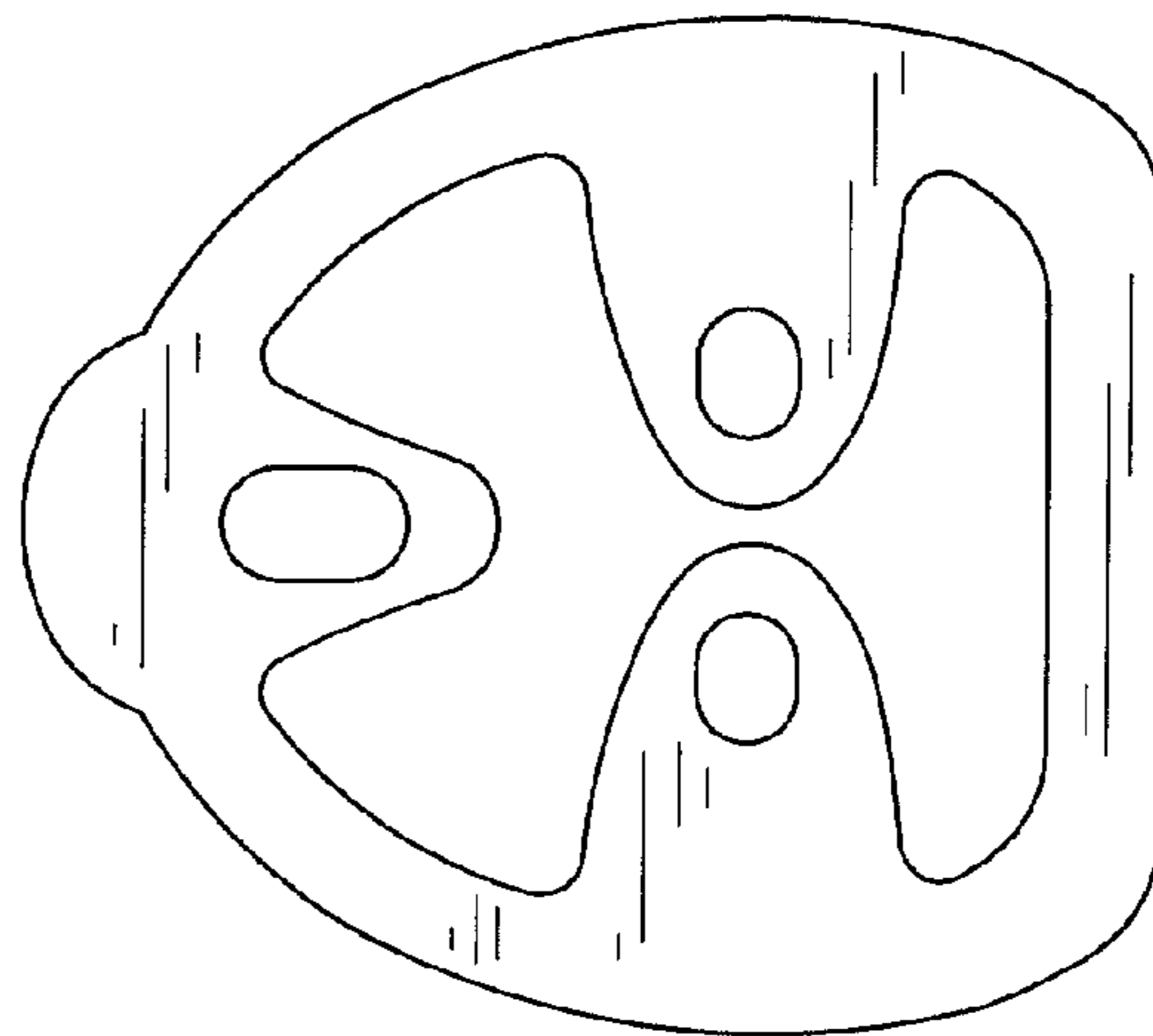

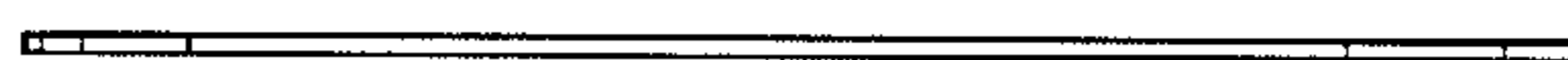
