DESCRIPTION

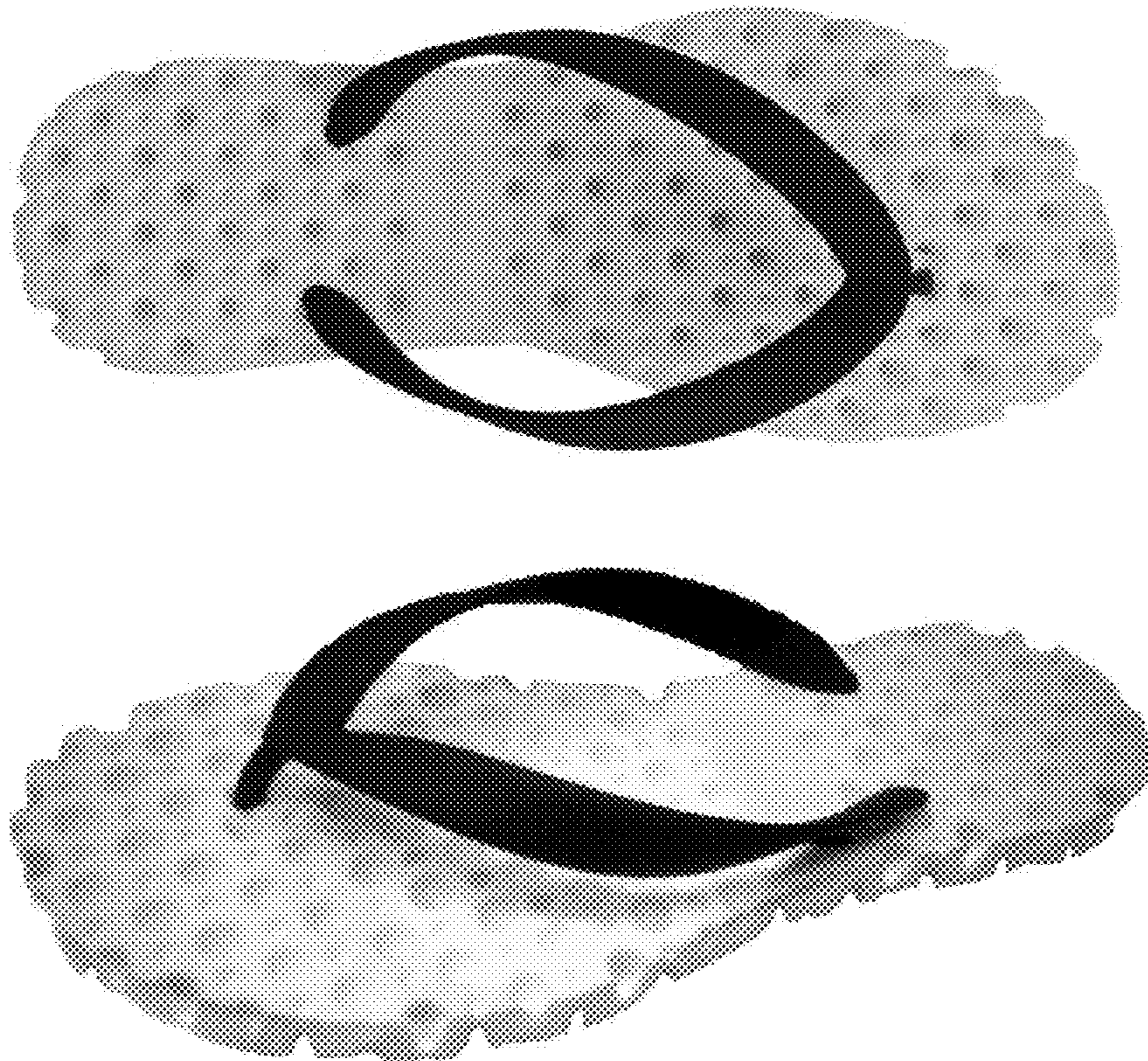

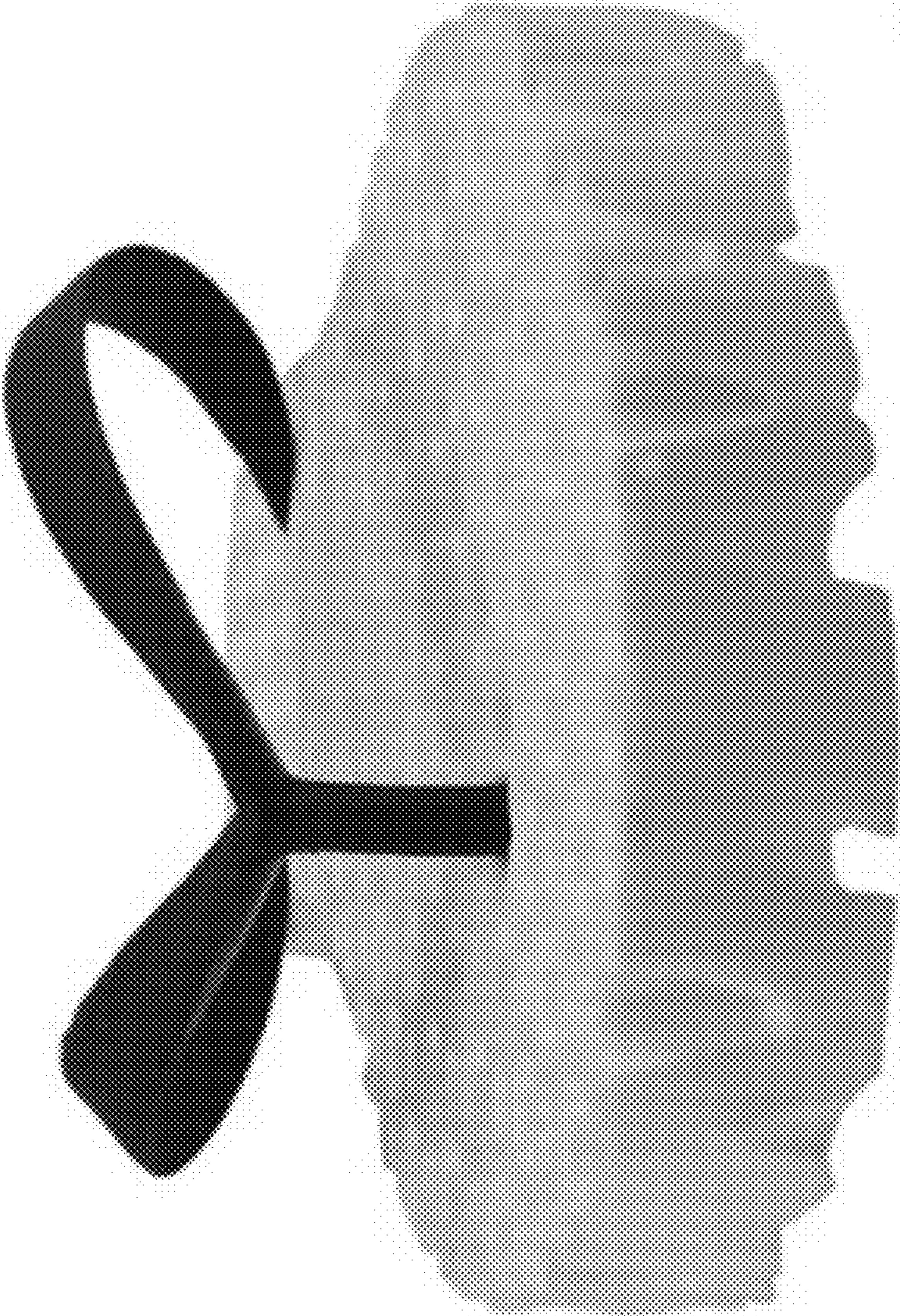

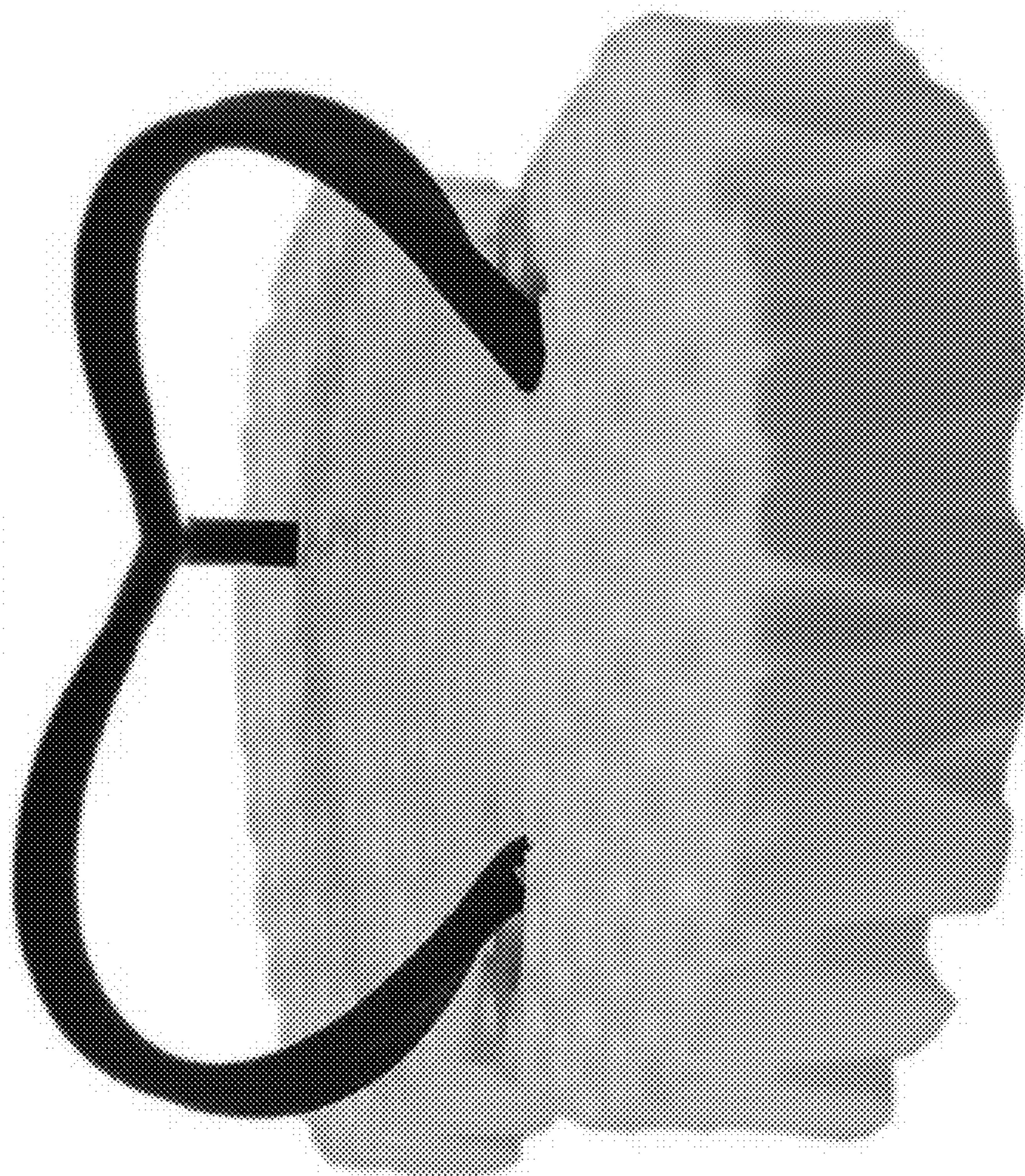

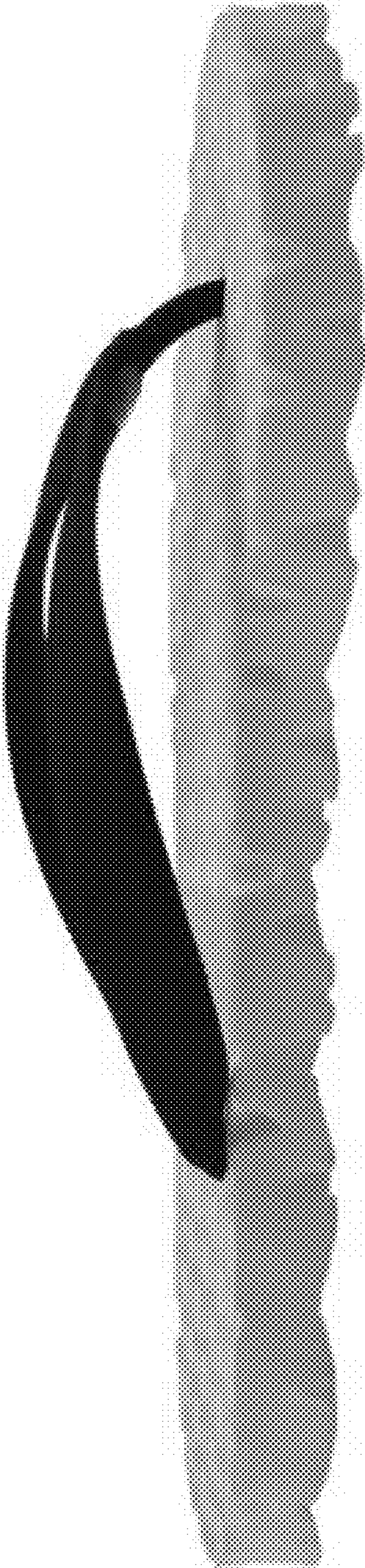

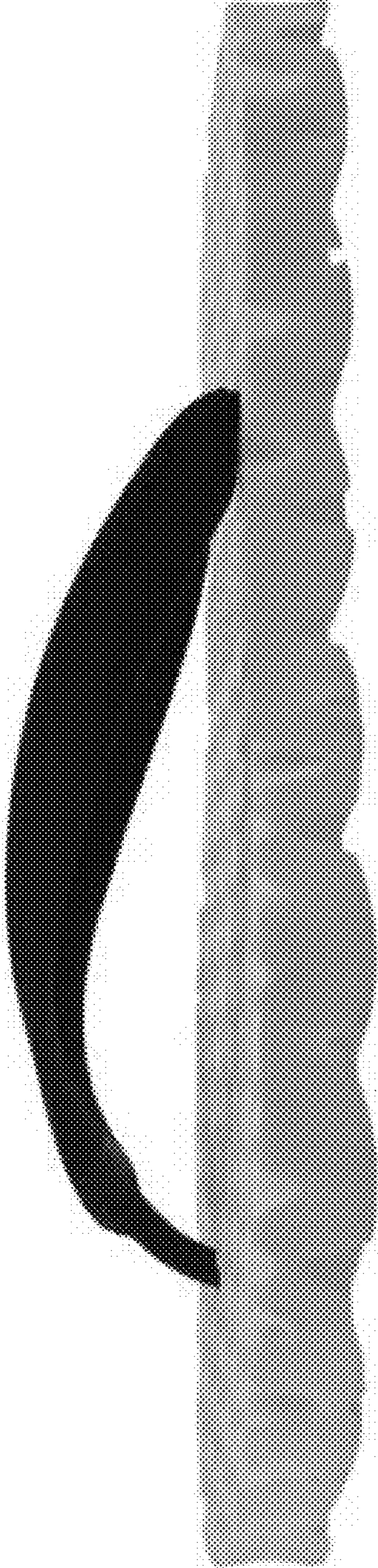

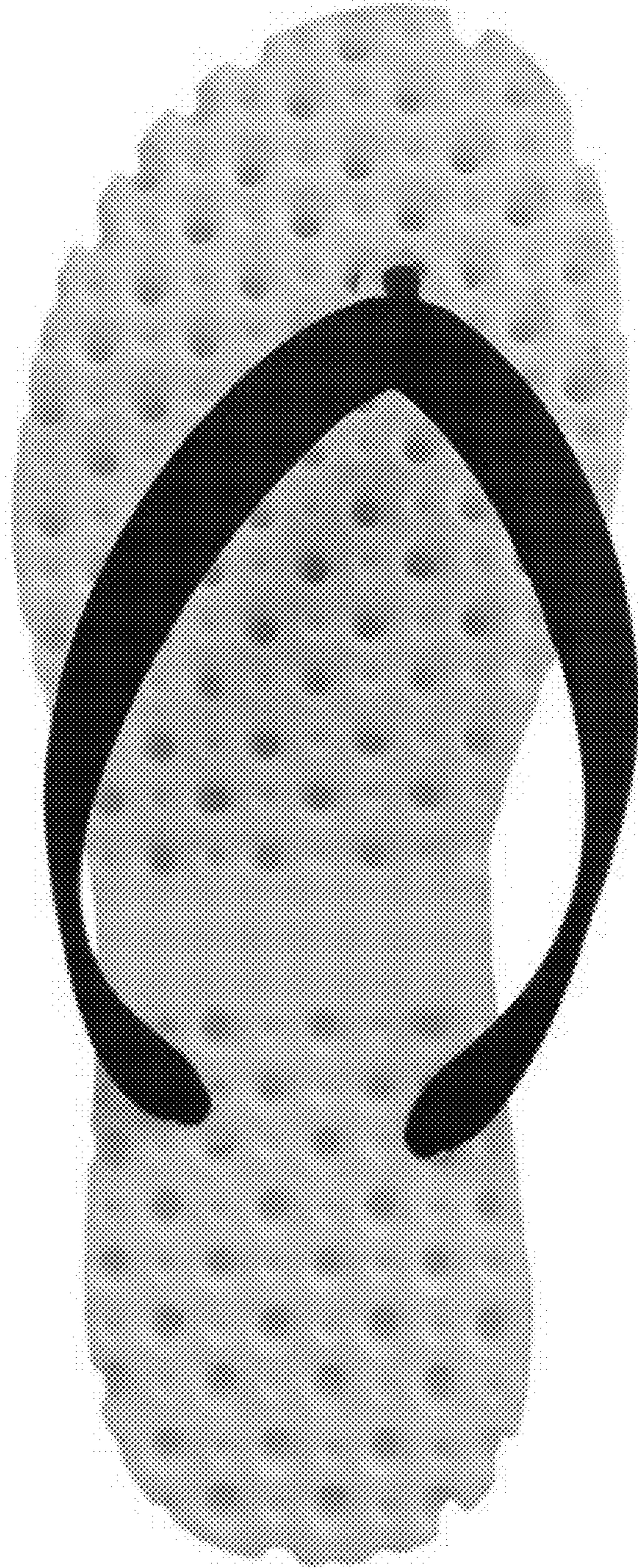
