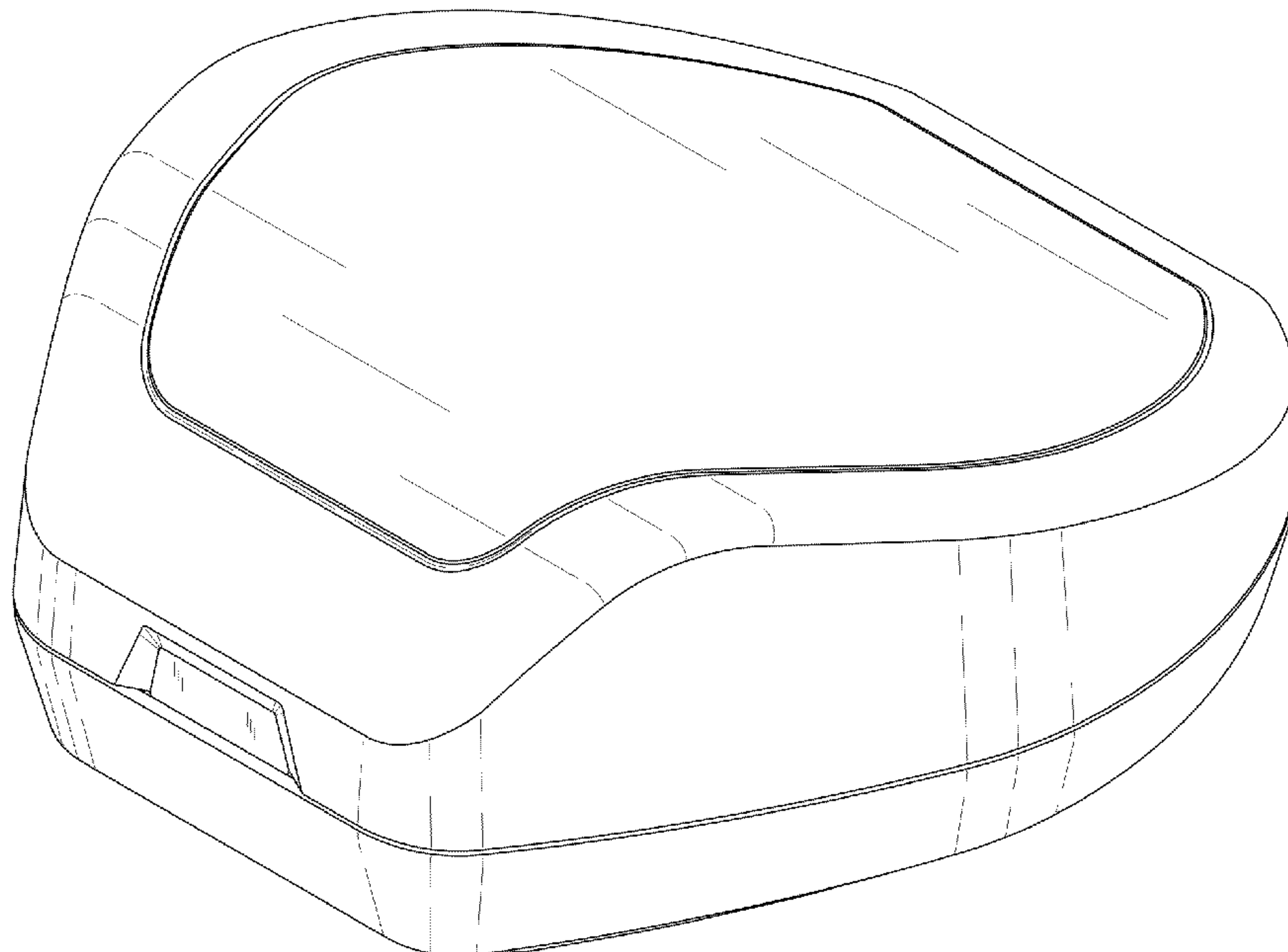
FIG. 1 is a front isometric view of a case showing our new design;

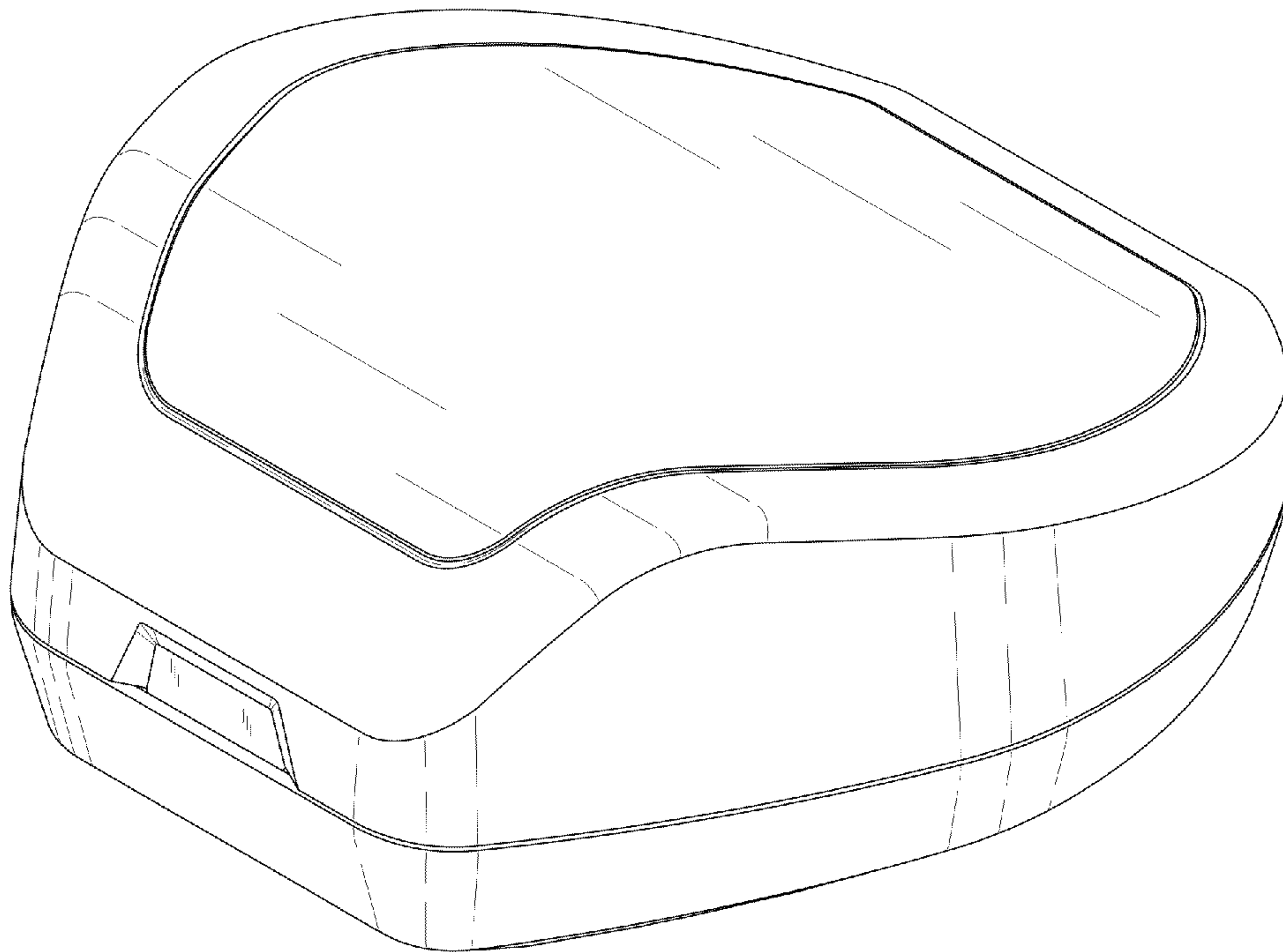

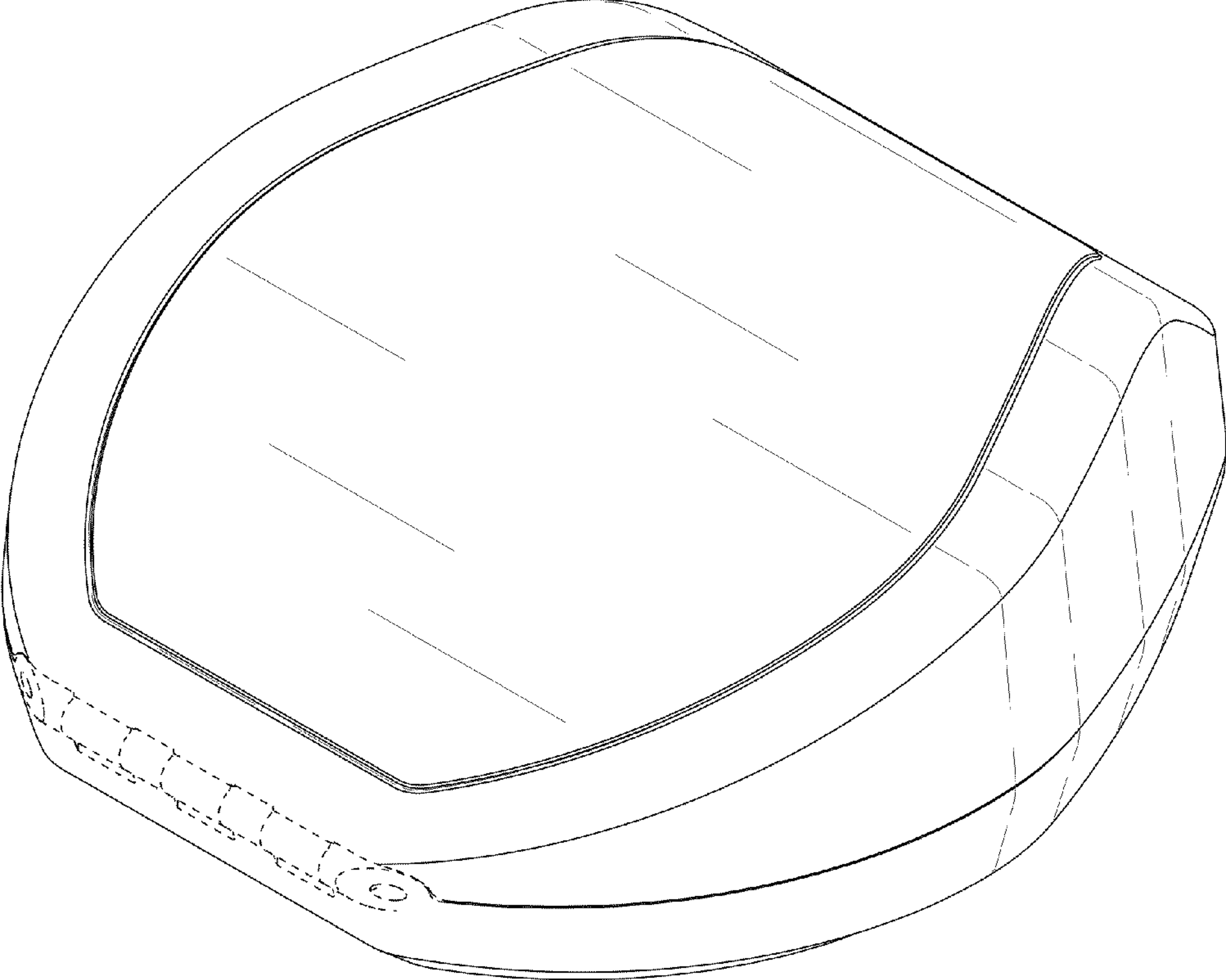

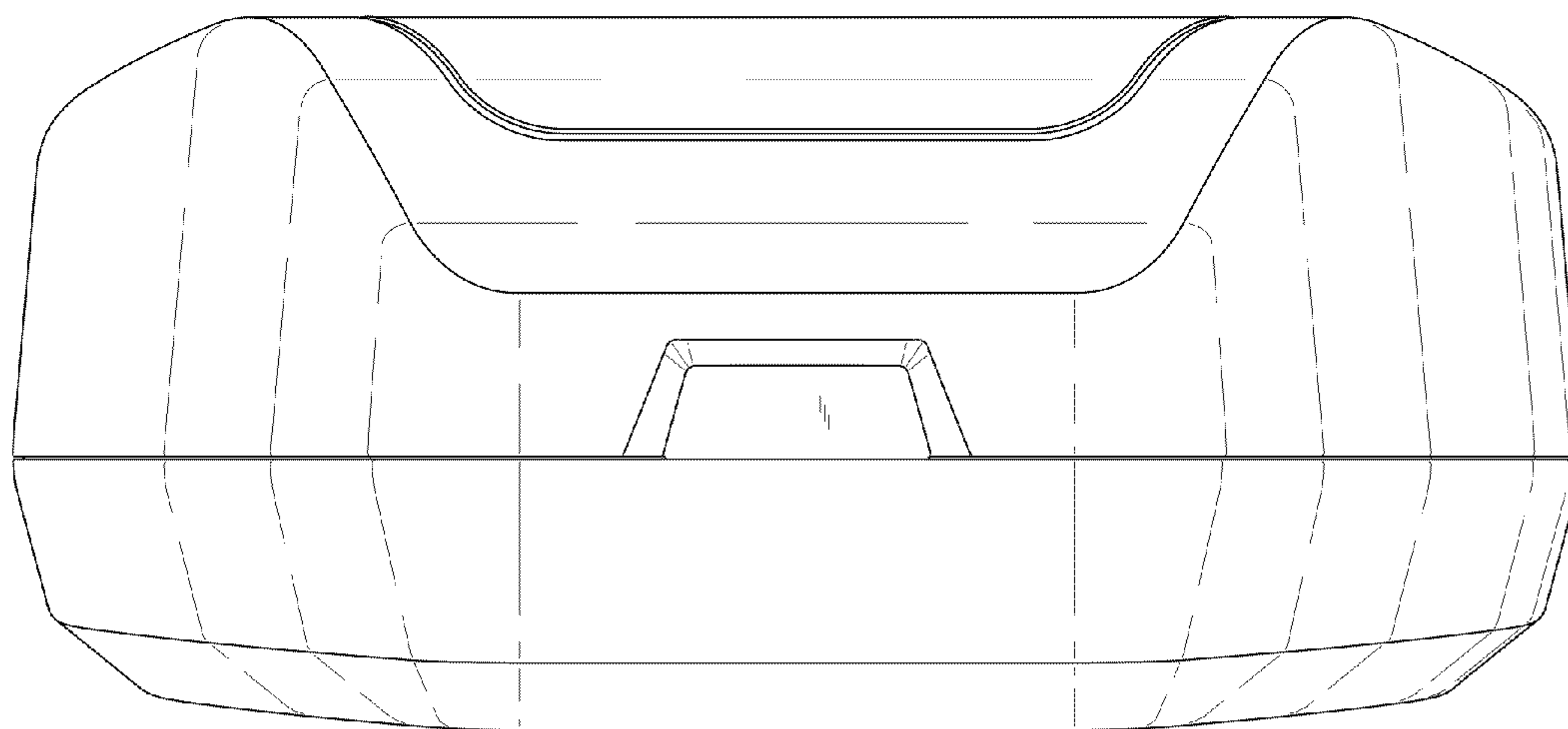

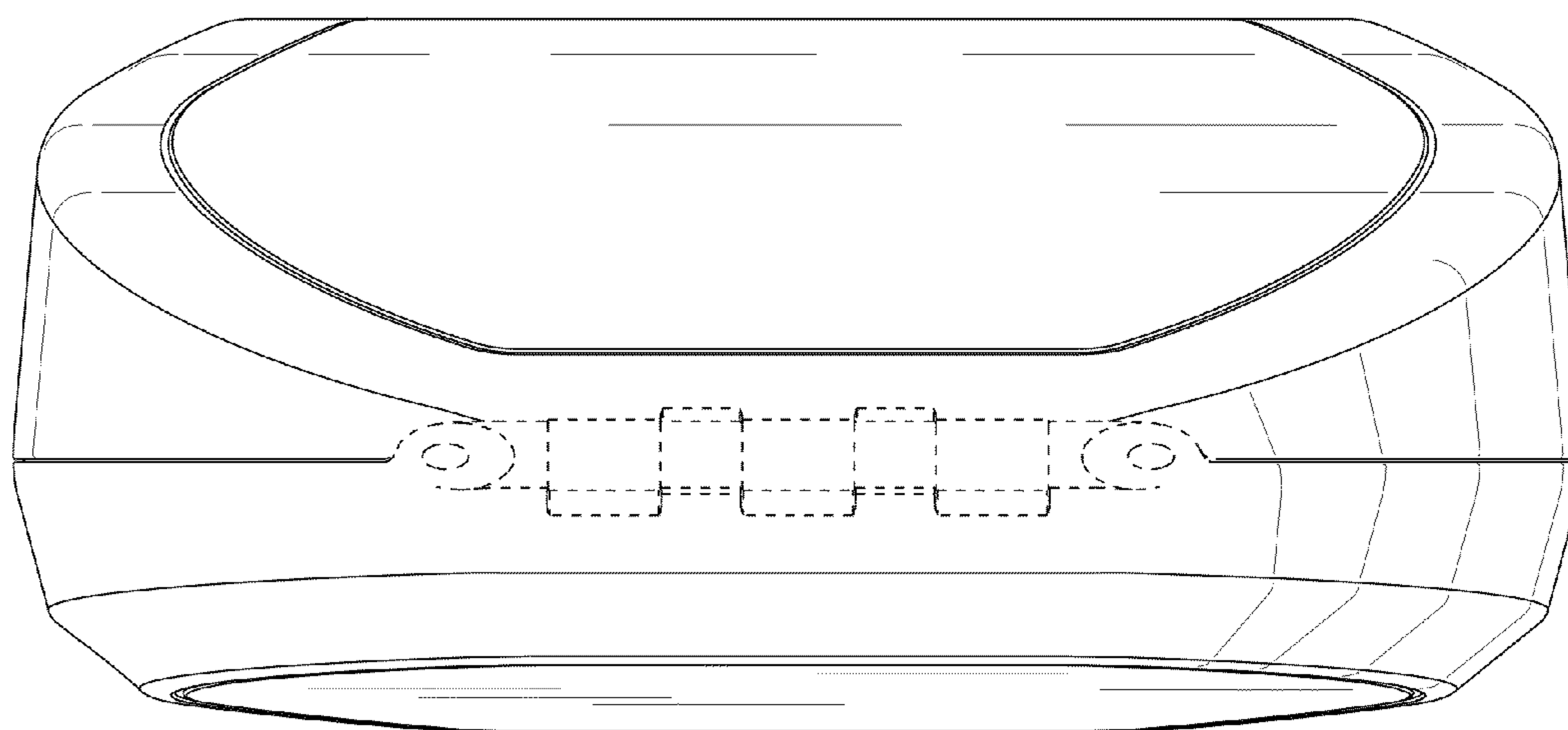

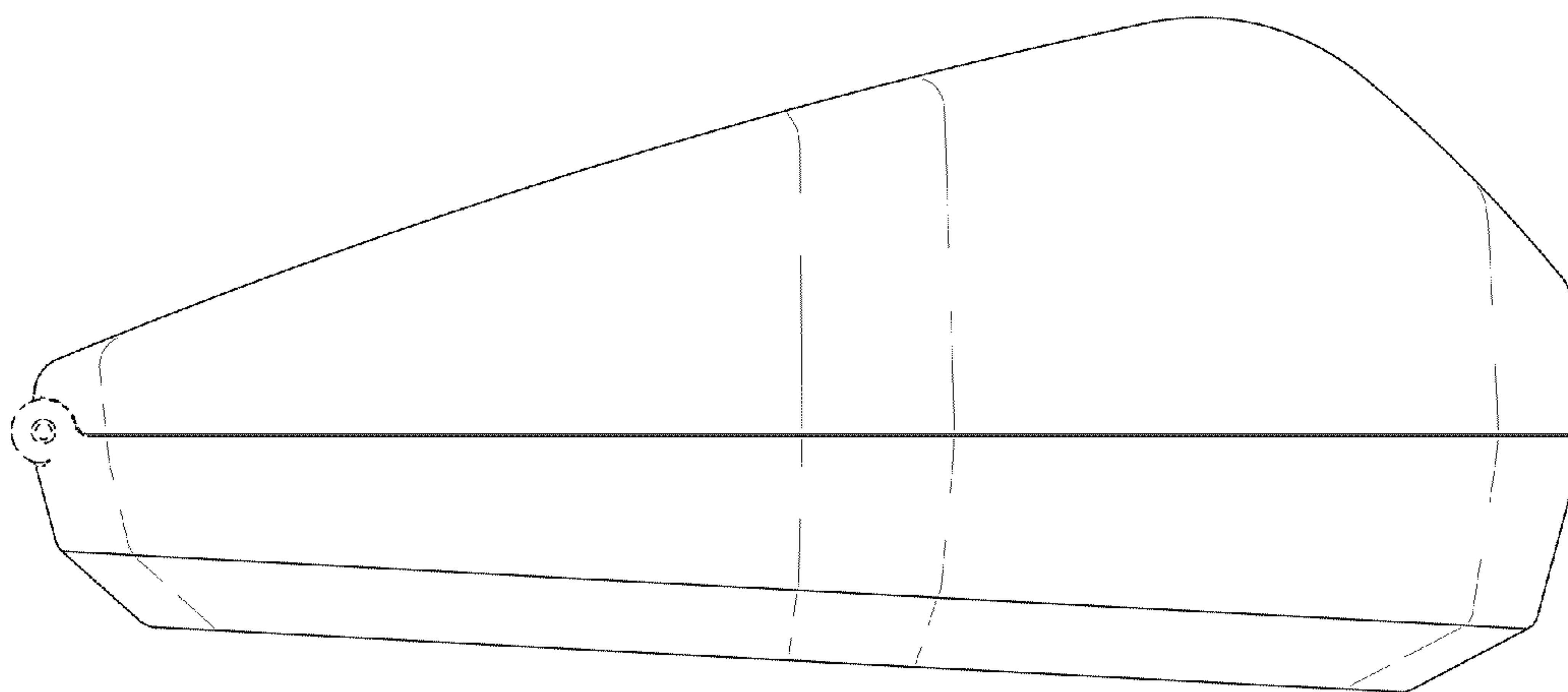

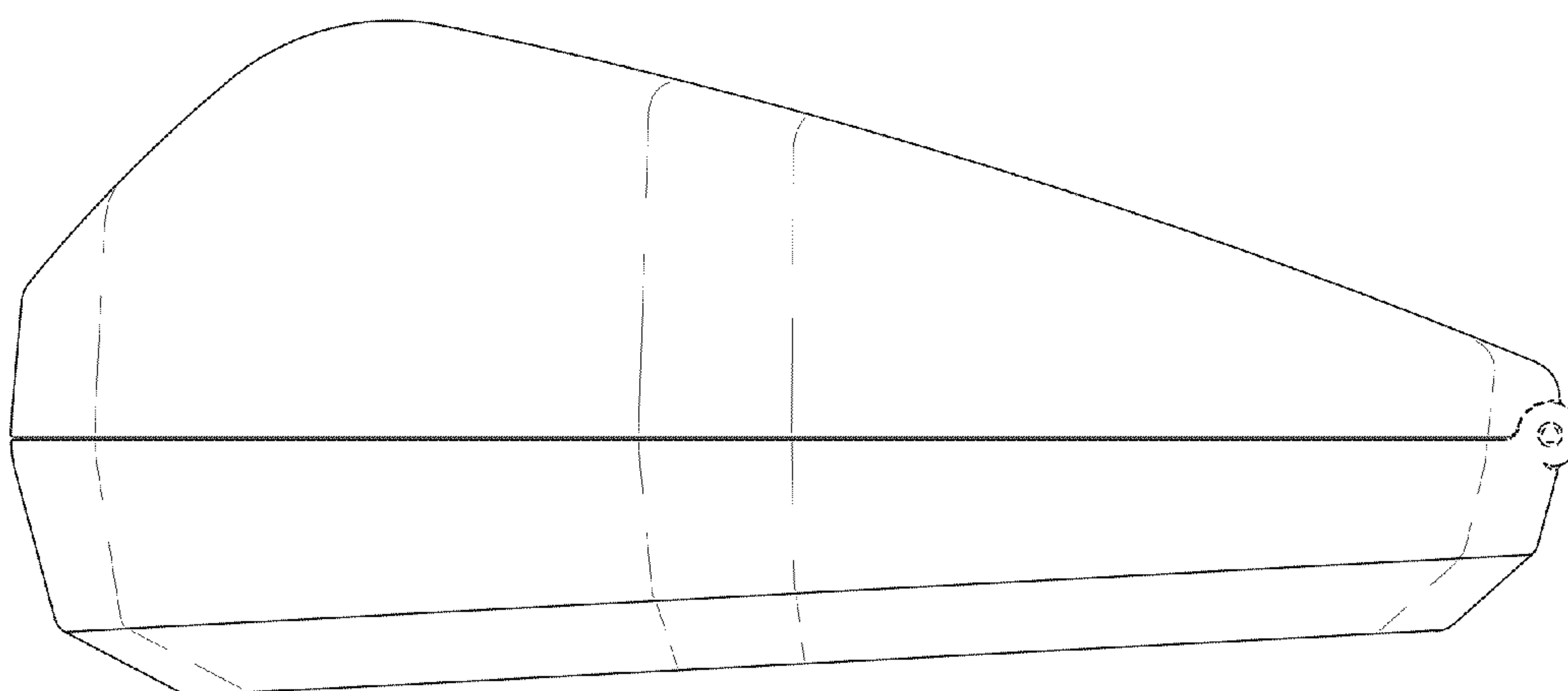

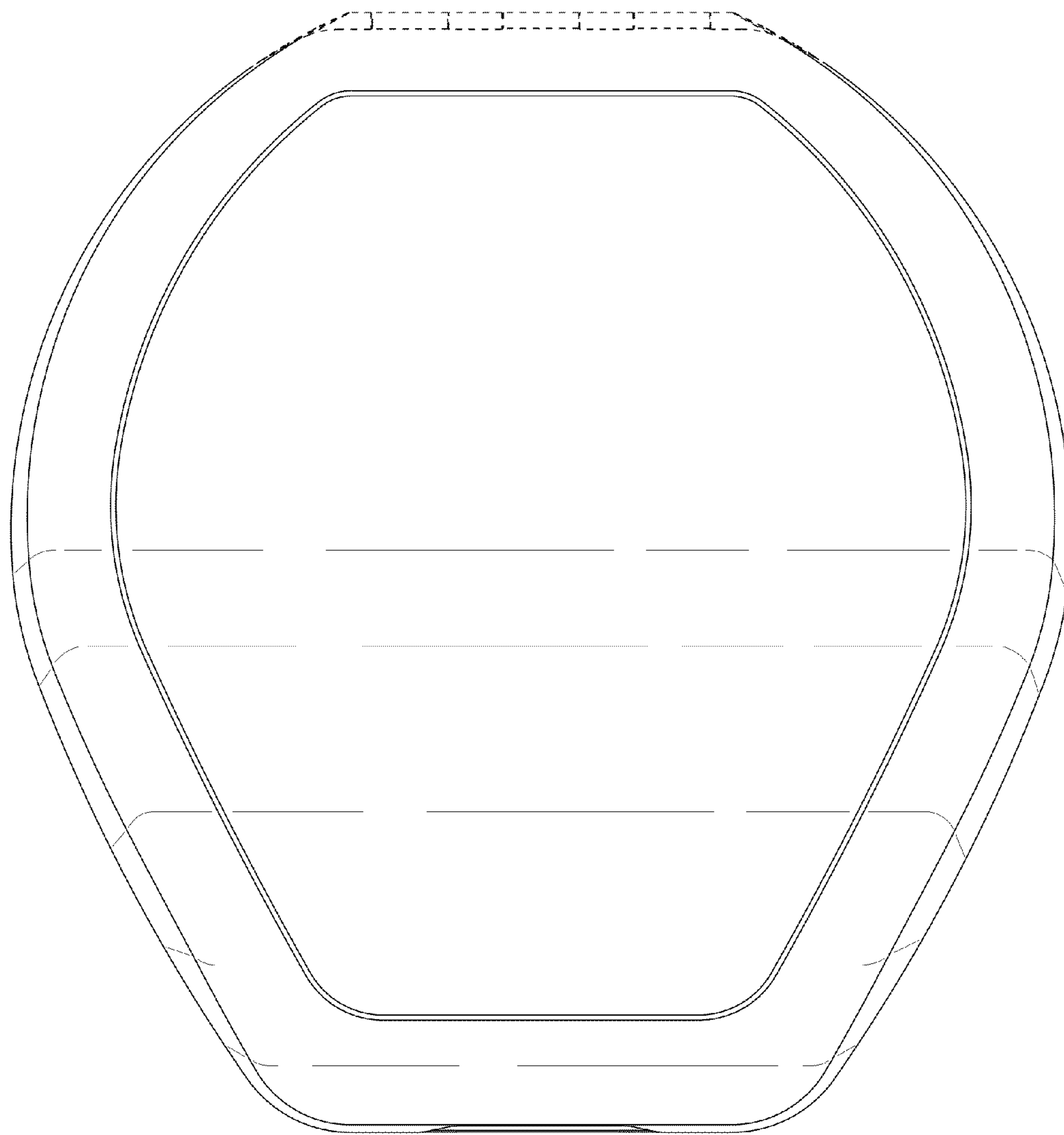

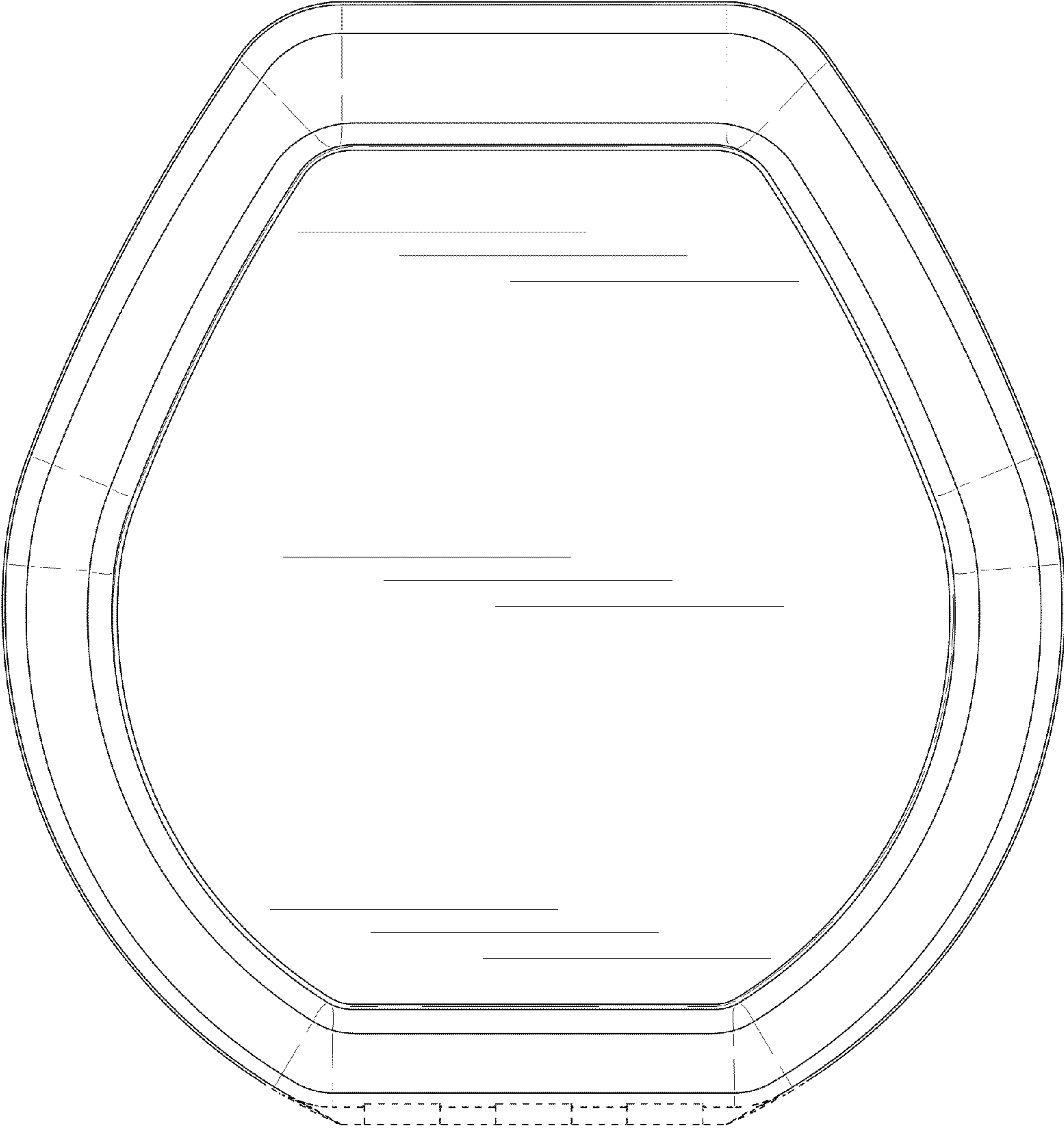
