FIG. 1 is a top, side perspective view of a mascara brush showing my new design;

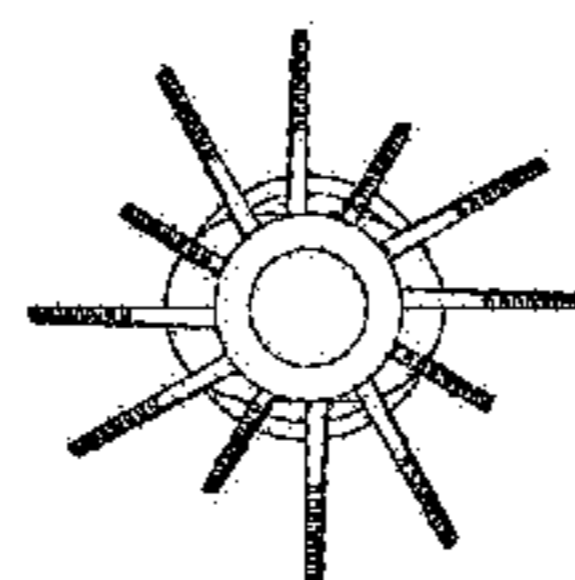
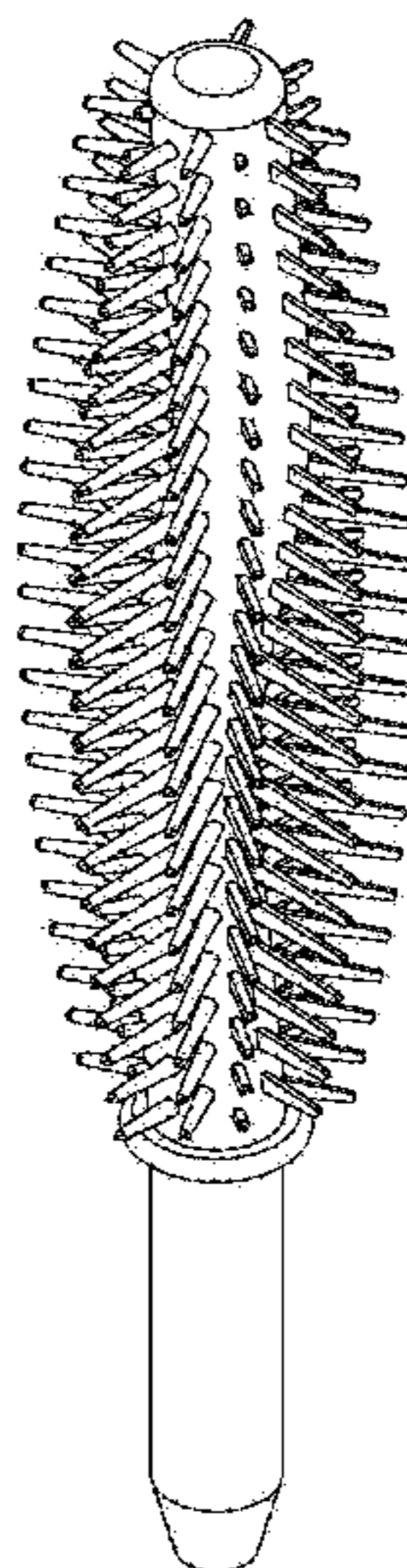
FIG. 2 is a left side elevational view thereof;

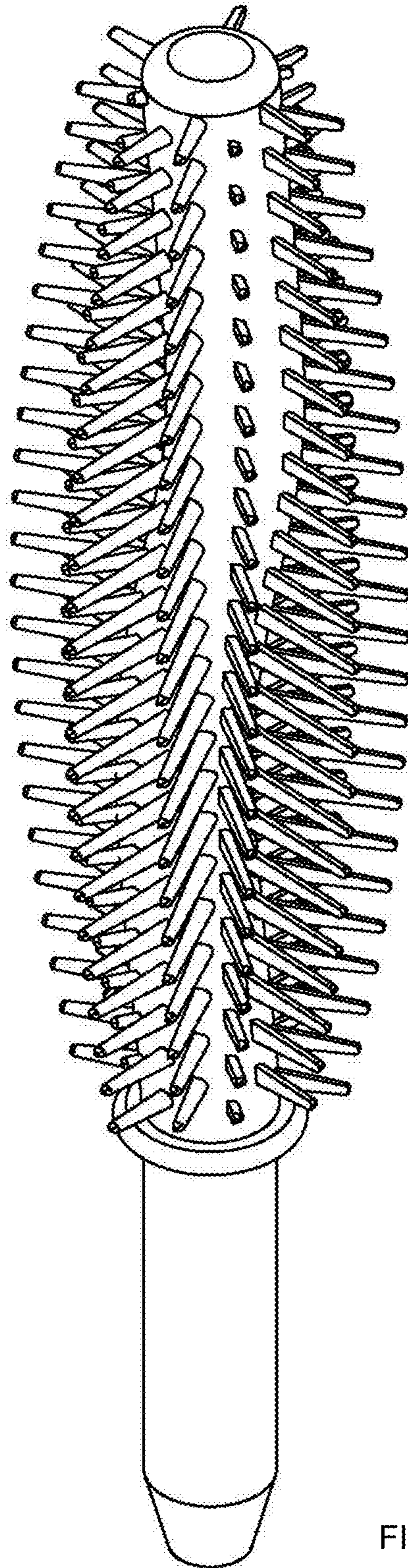

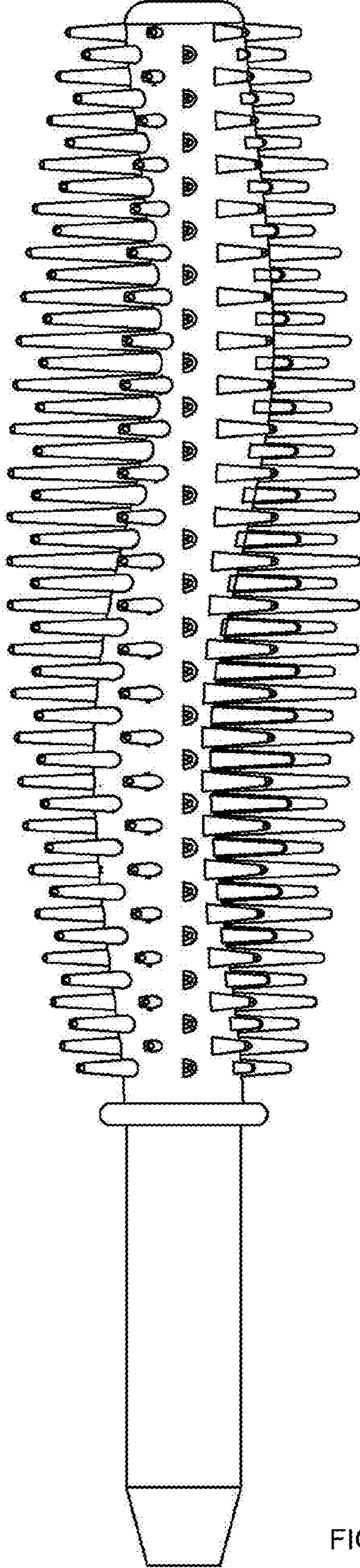

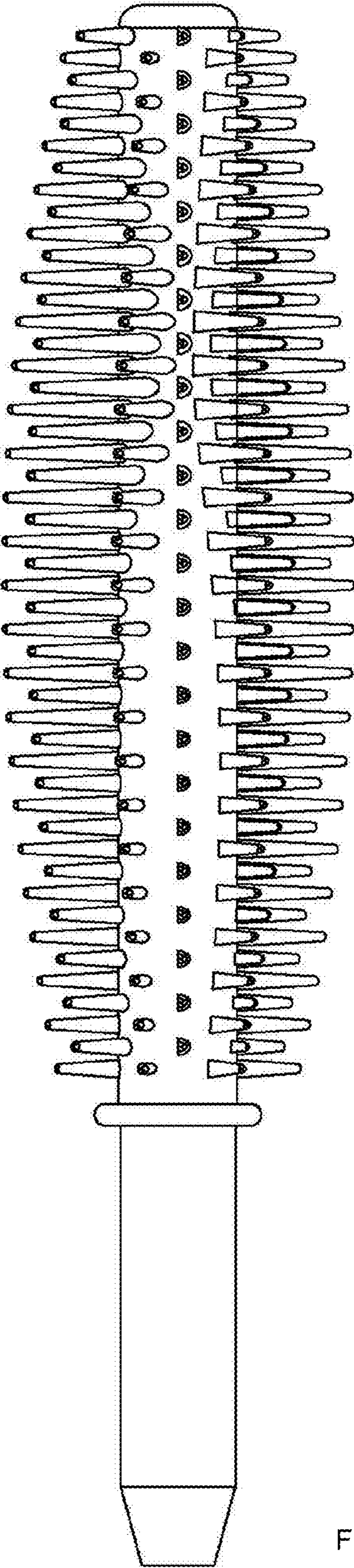

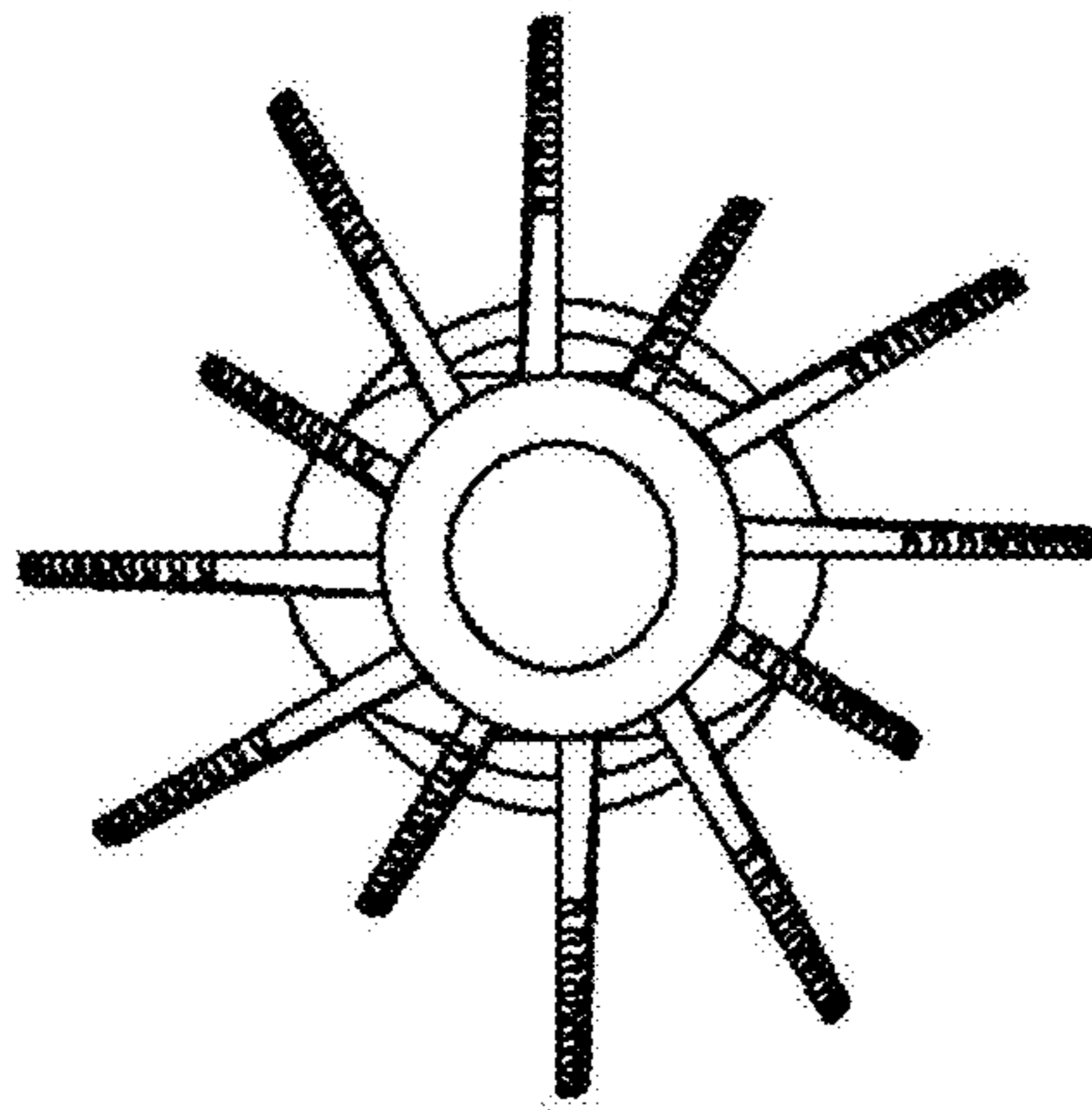

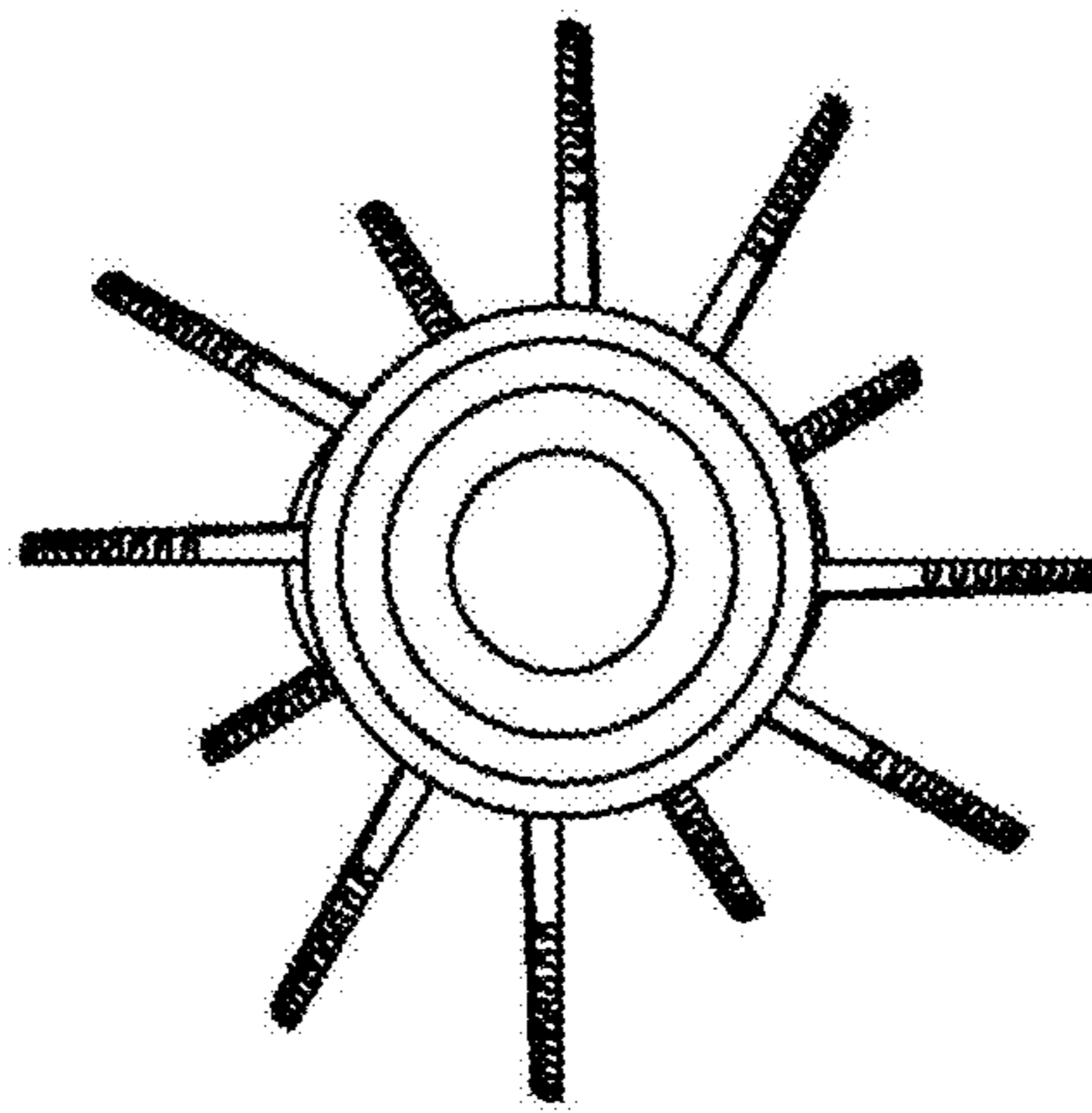
