(57) **CLAIM**  
The ornamental design for a tartan textile, as shown and described.

**DESCRIPTION**

The single FIGURE is a top plan view of a tartan textile showing our new design, the bottom plan view being a mirror image.  
The tartan textile is flat and planar. The thickness of the tartan textile forms no part of the claimed design.
