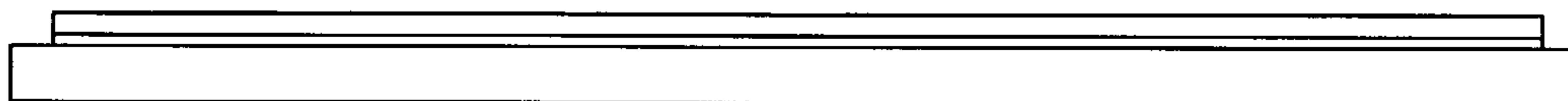
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of my locker panel. The back view would be the same.  
 FIG. 2 is a side view of my locker panel. Opposite side view would be the same.

 FIG. 4 is a bottom view of my locker panel.  
 My locker panel is characterized by the ability of the system to be assembled inside a locker to increase the storage efficiency.

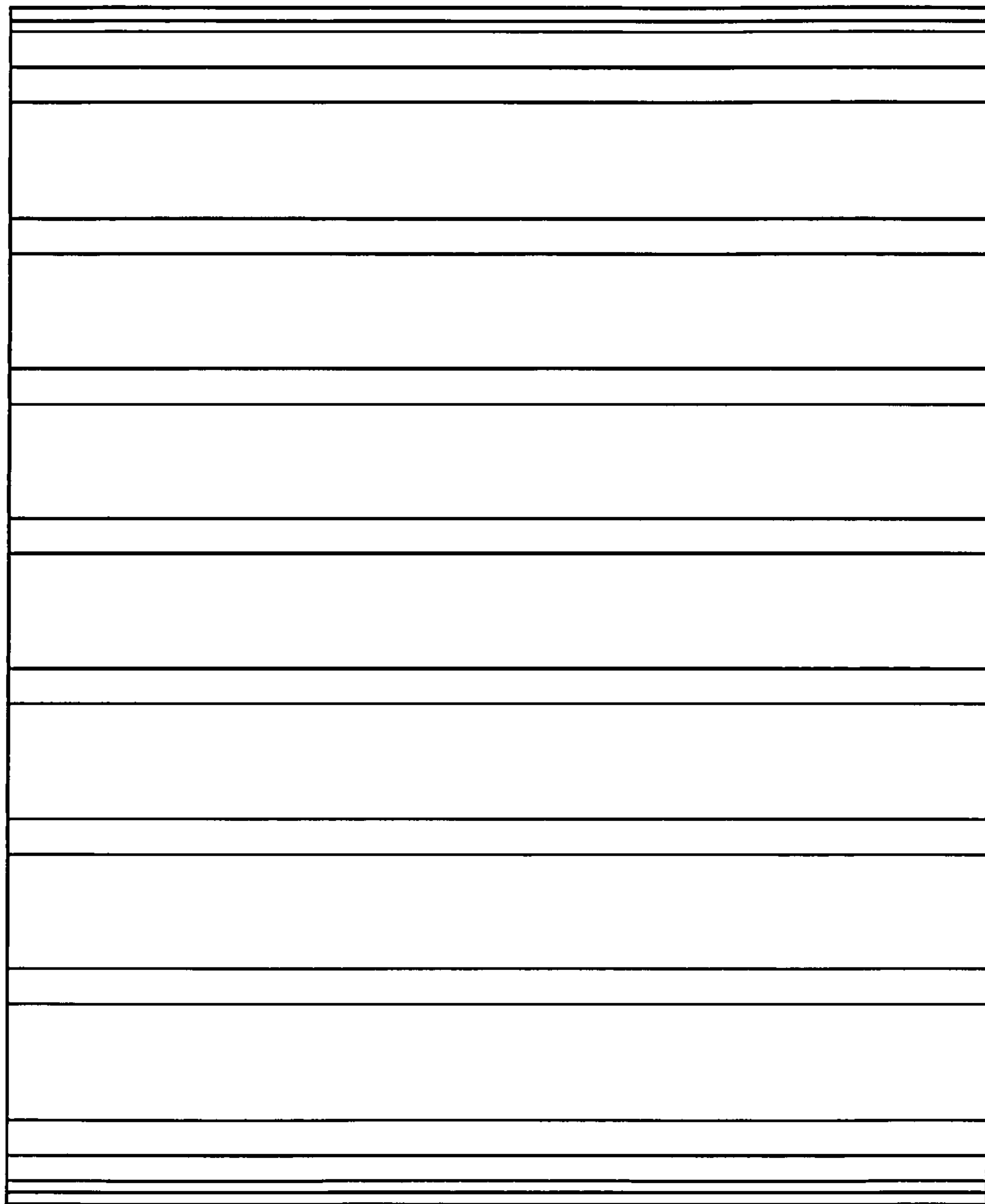

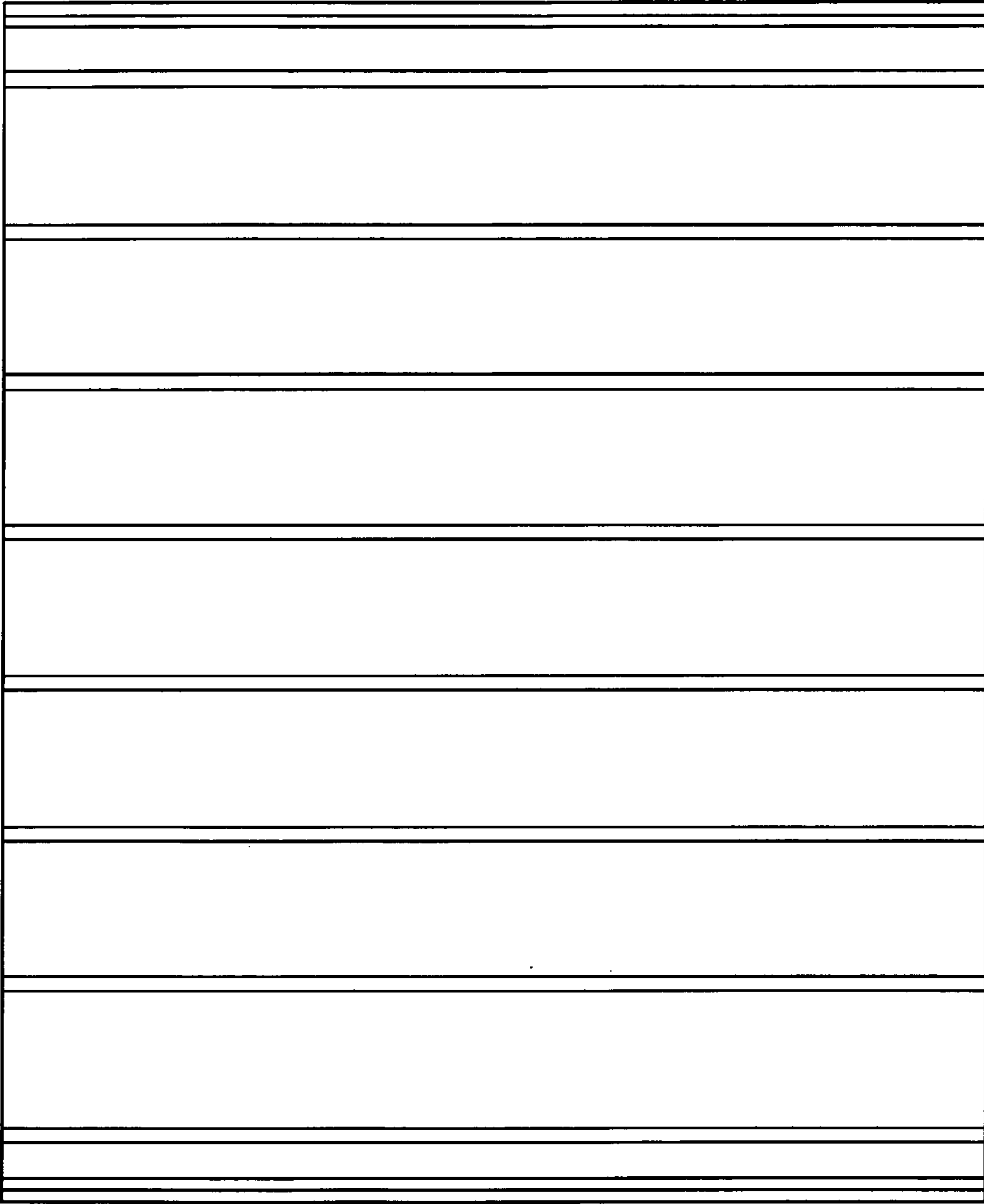
