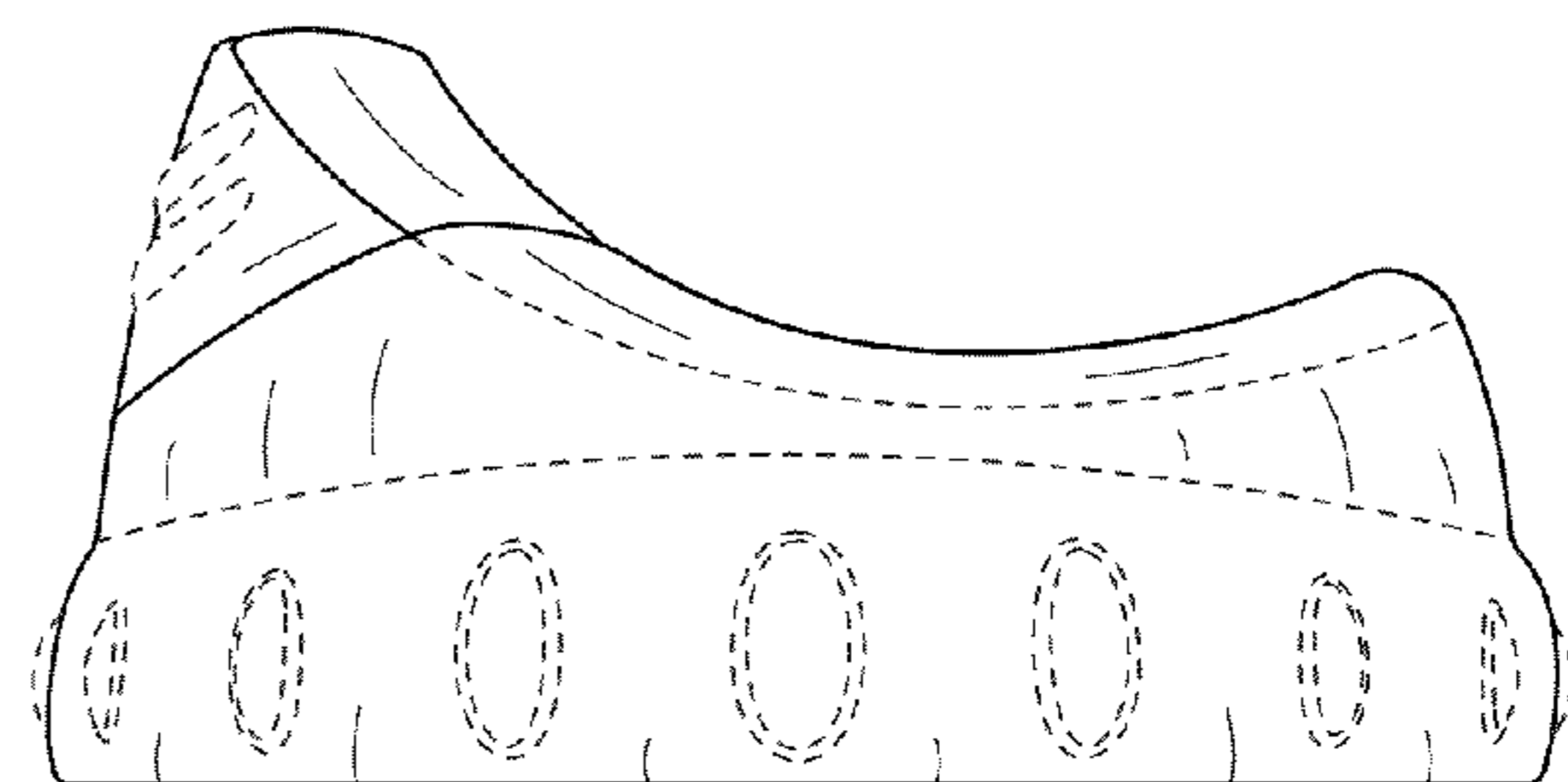
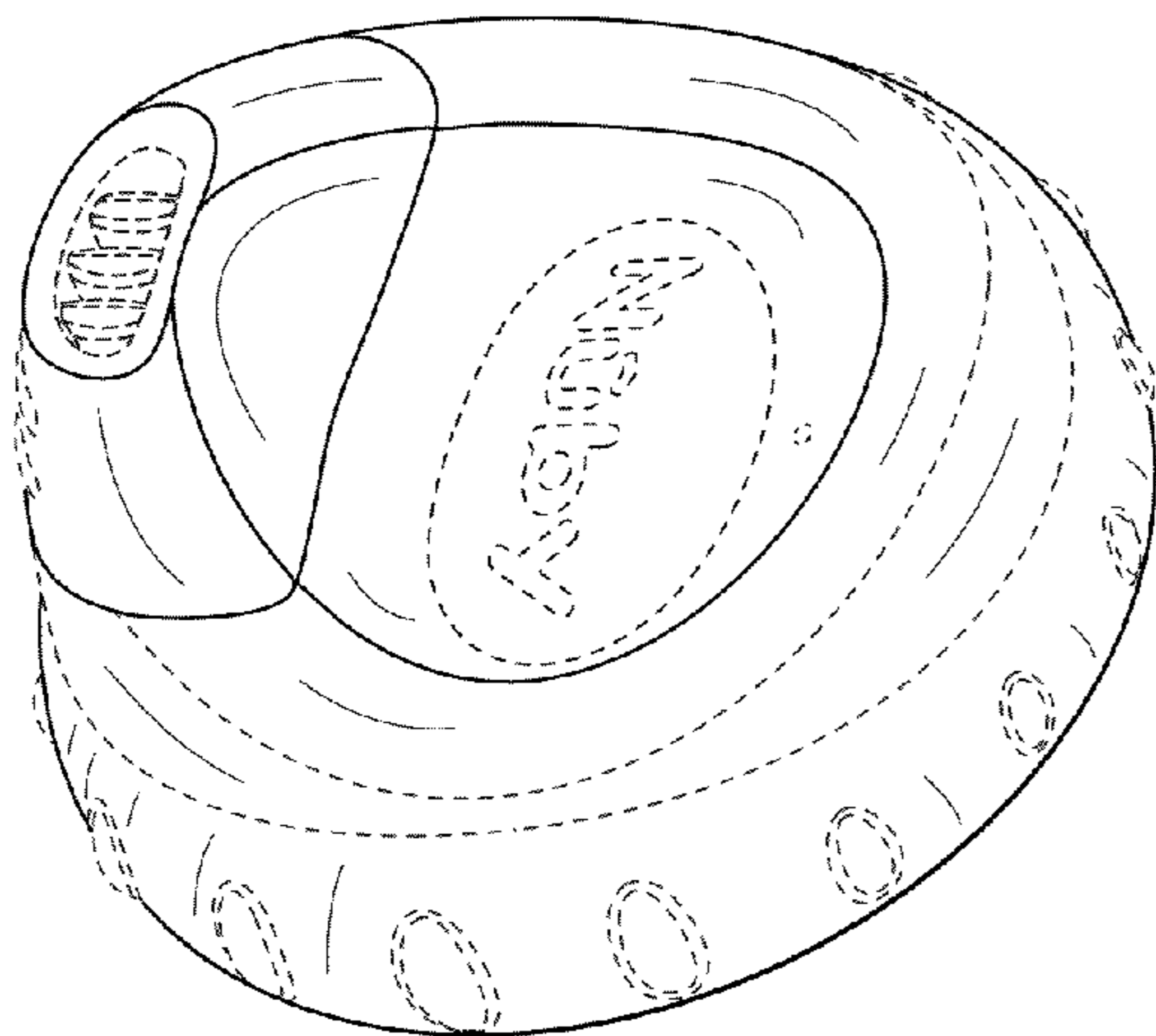
(57) **CLAIM**

I claim the ornamental design for a drinking cup top, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the drinking cup top of the present invention;
FIG. 2 is an elevational right side view of FIG. 1 with the left side view being a mirror image of the right side view;
FIG. 3 is a plan bottom view of FIG. 1;
FIG. 4 is a top plan view of FIG. 1;
FIG. 5 is a rear elevational view of FIG. 1; and,
FIG. 6 is a front elevational view of FIG. 1.
The broken lines in the drawings are included for purposes of illustration and form no part of the claimed design.

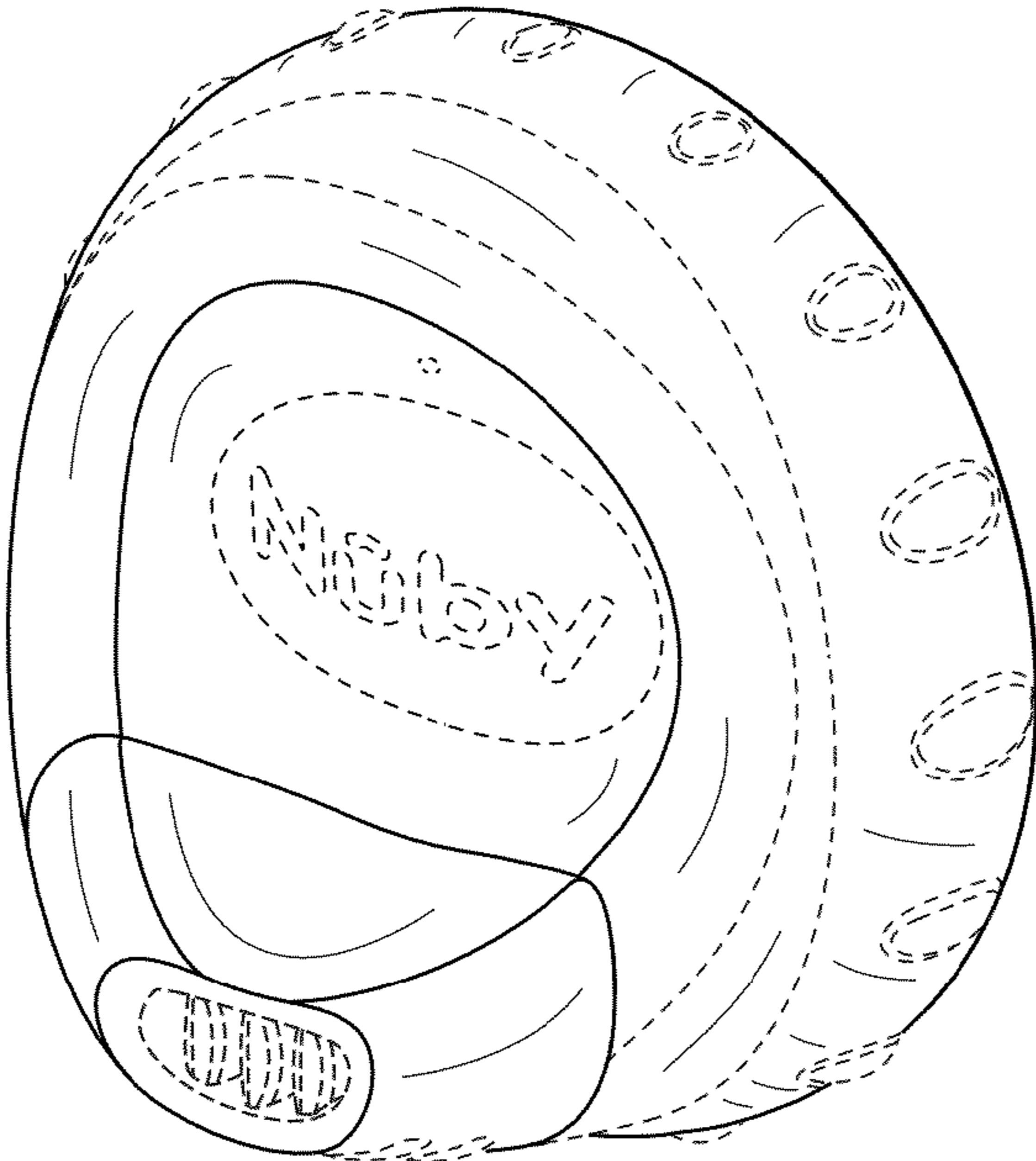

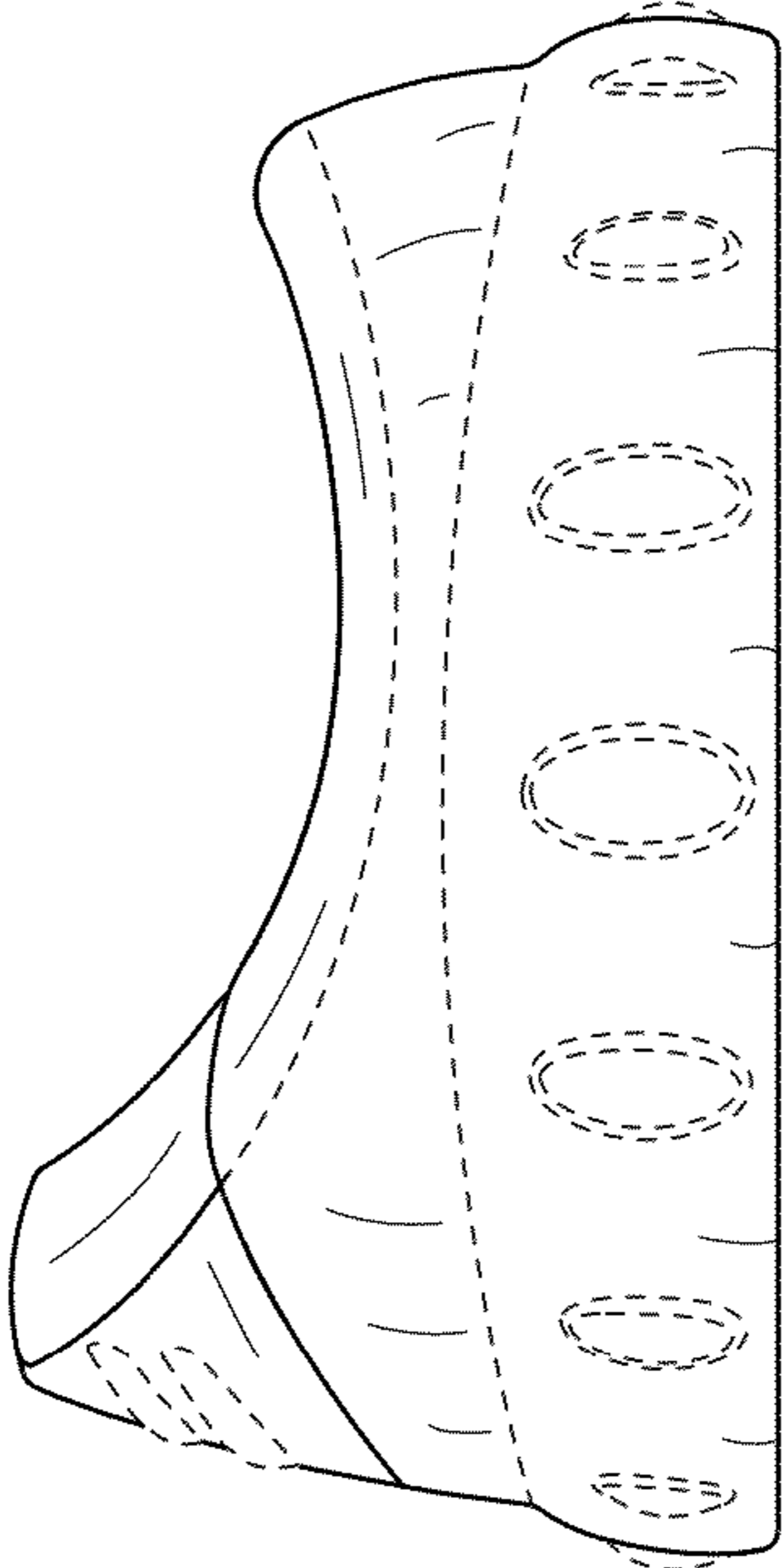

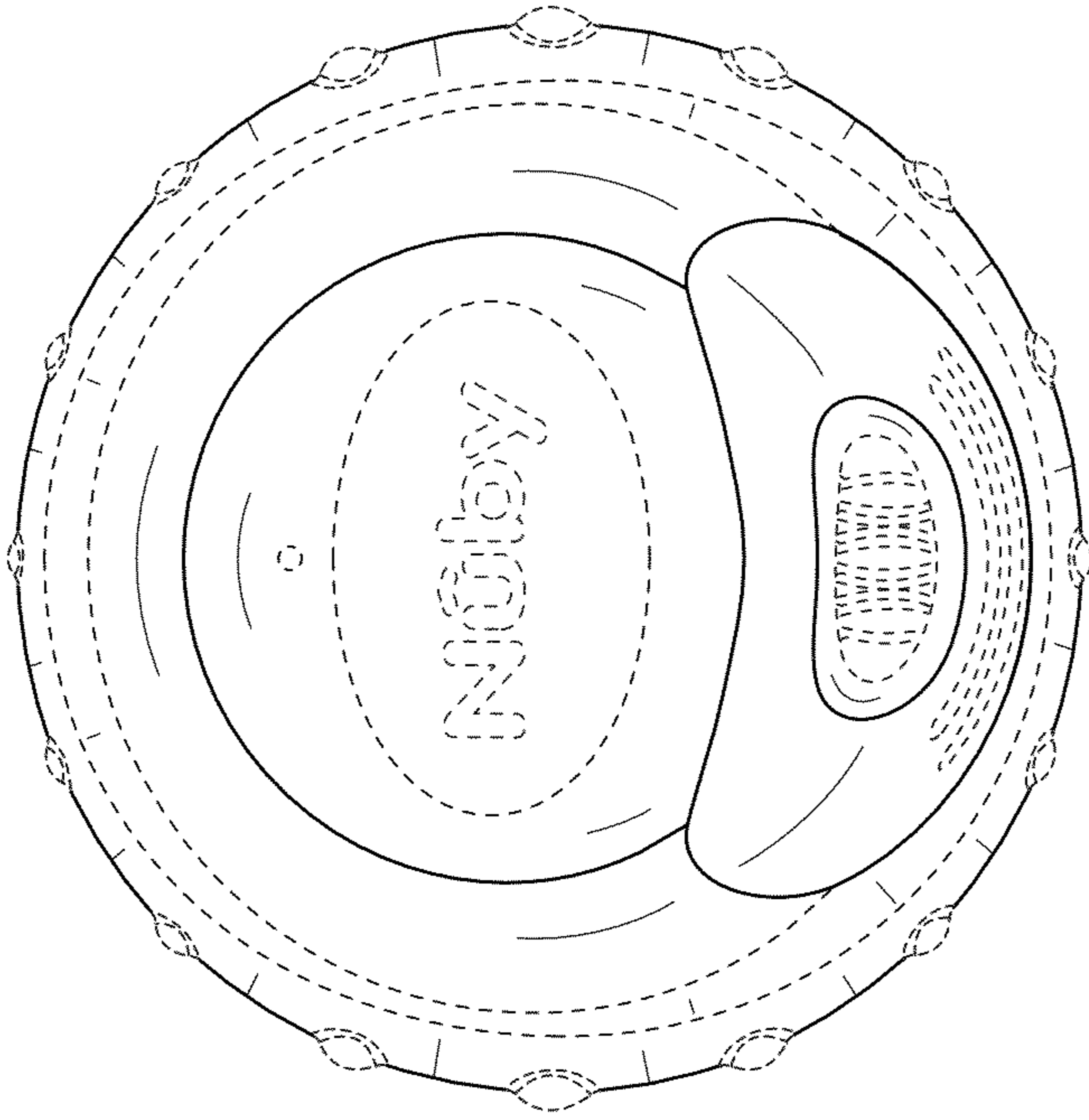

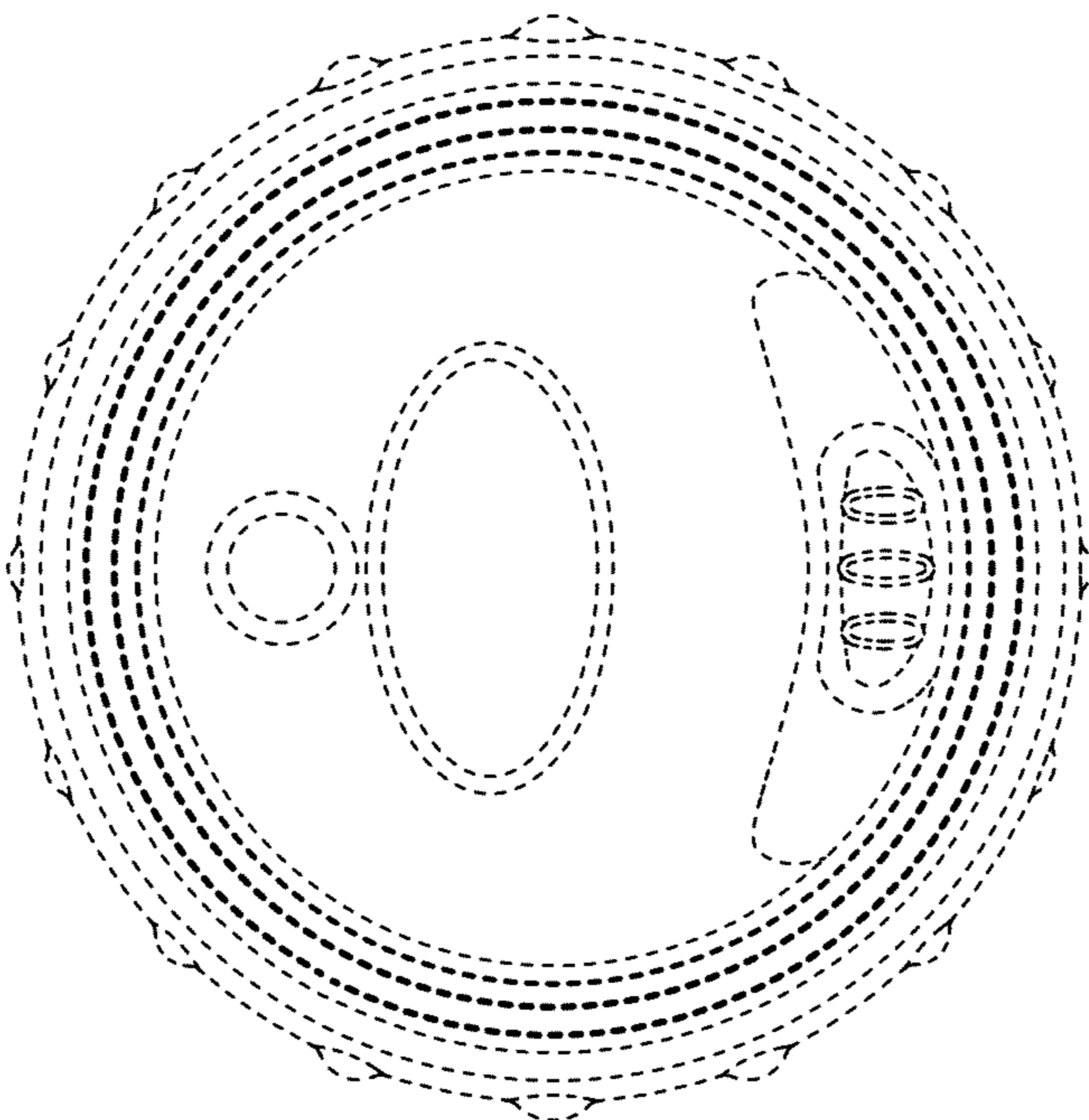

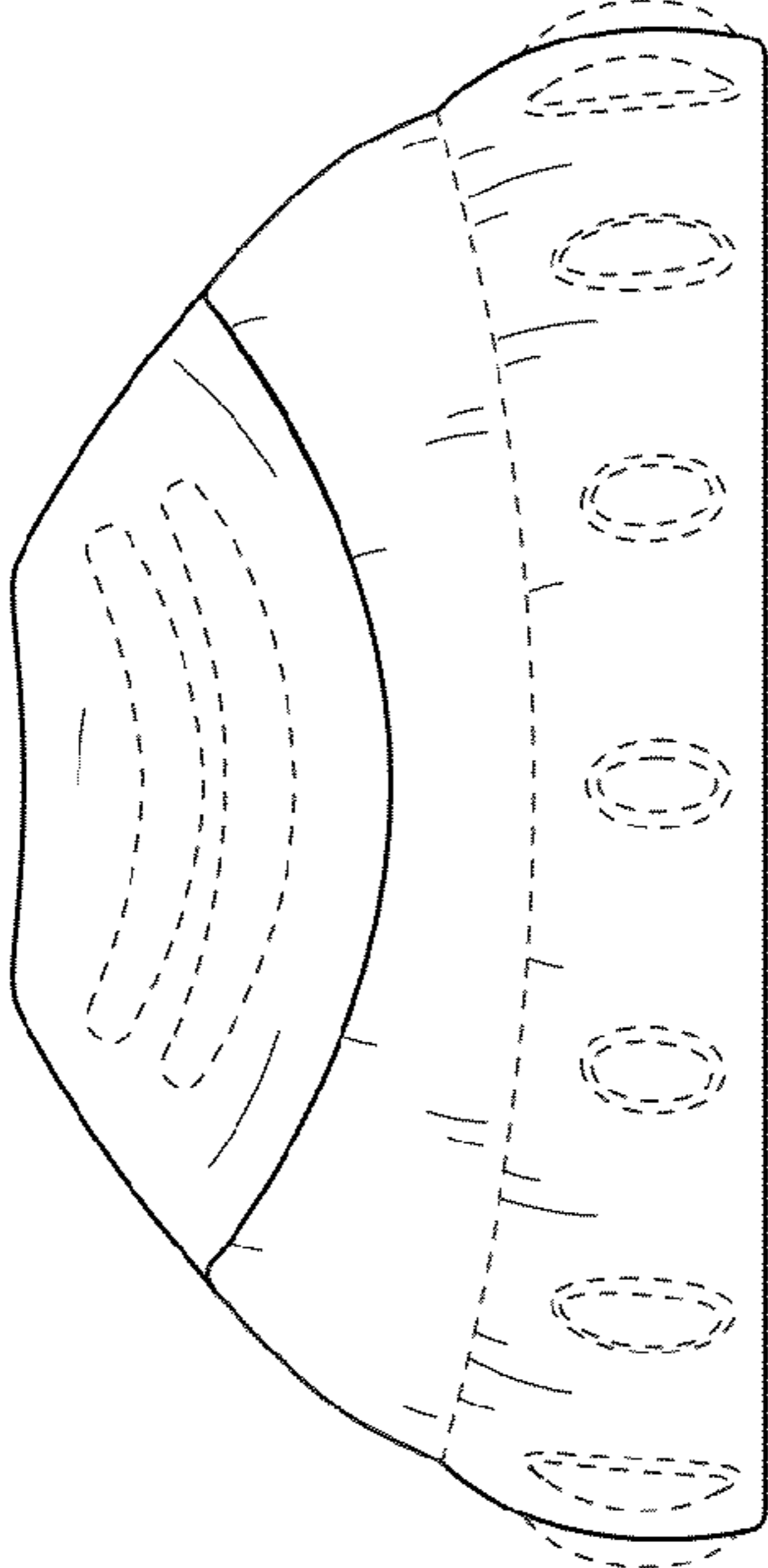

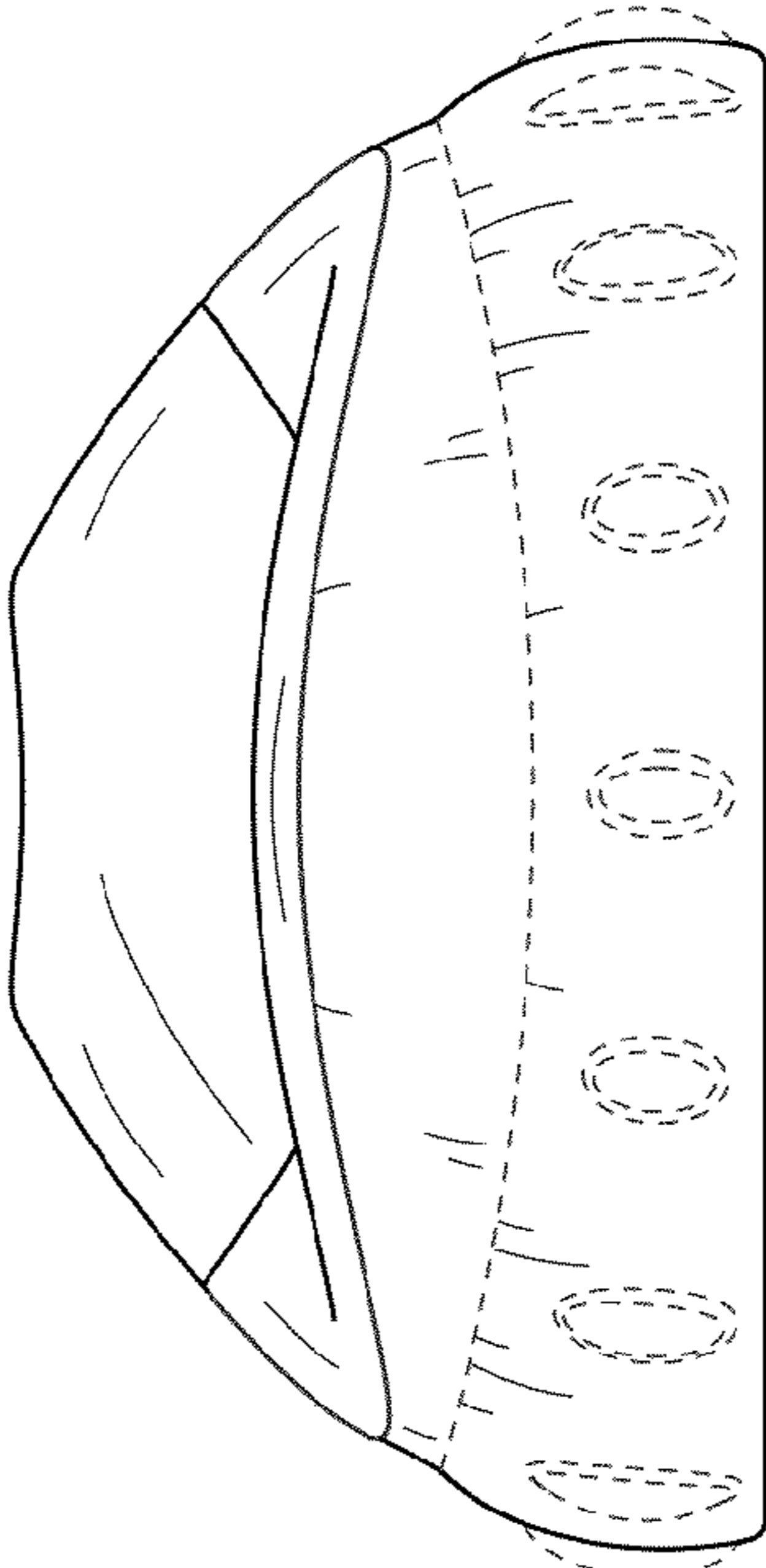
