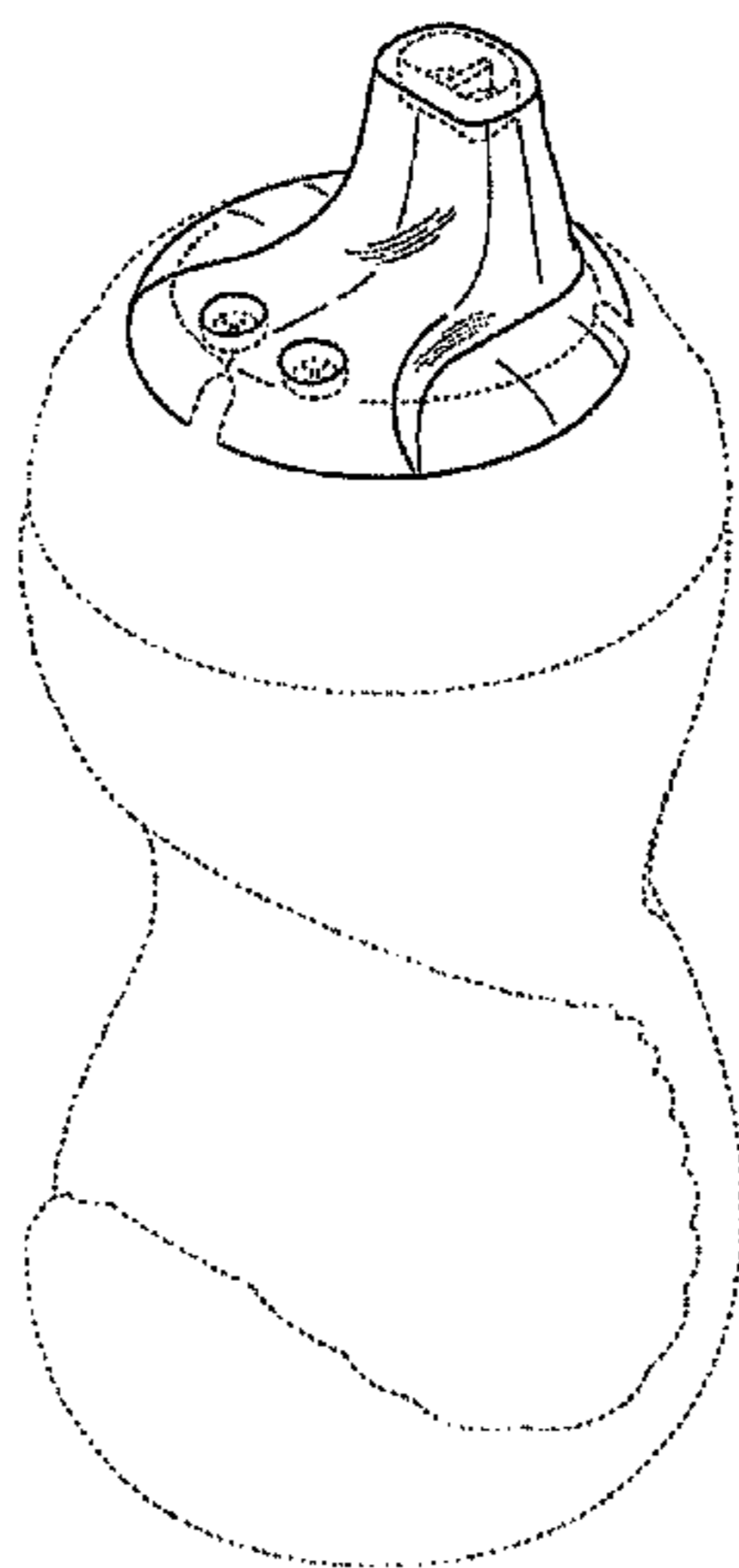

 FIG. 3 is a right side view thereof, with the left side view being a mirror image thereof;  
 FIG. 4 is a top view thereof;  
 FIG. 5 is a rear, left side, top perspective view thereof; and,  
 FIG. 6 is a front, right side, top perspective view thereof.  
 The broken lines indicate elements which do not form part of the claim herein. The shading on the figures indicates transparency.

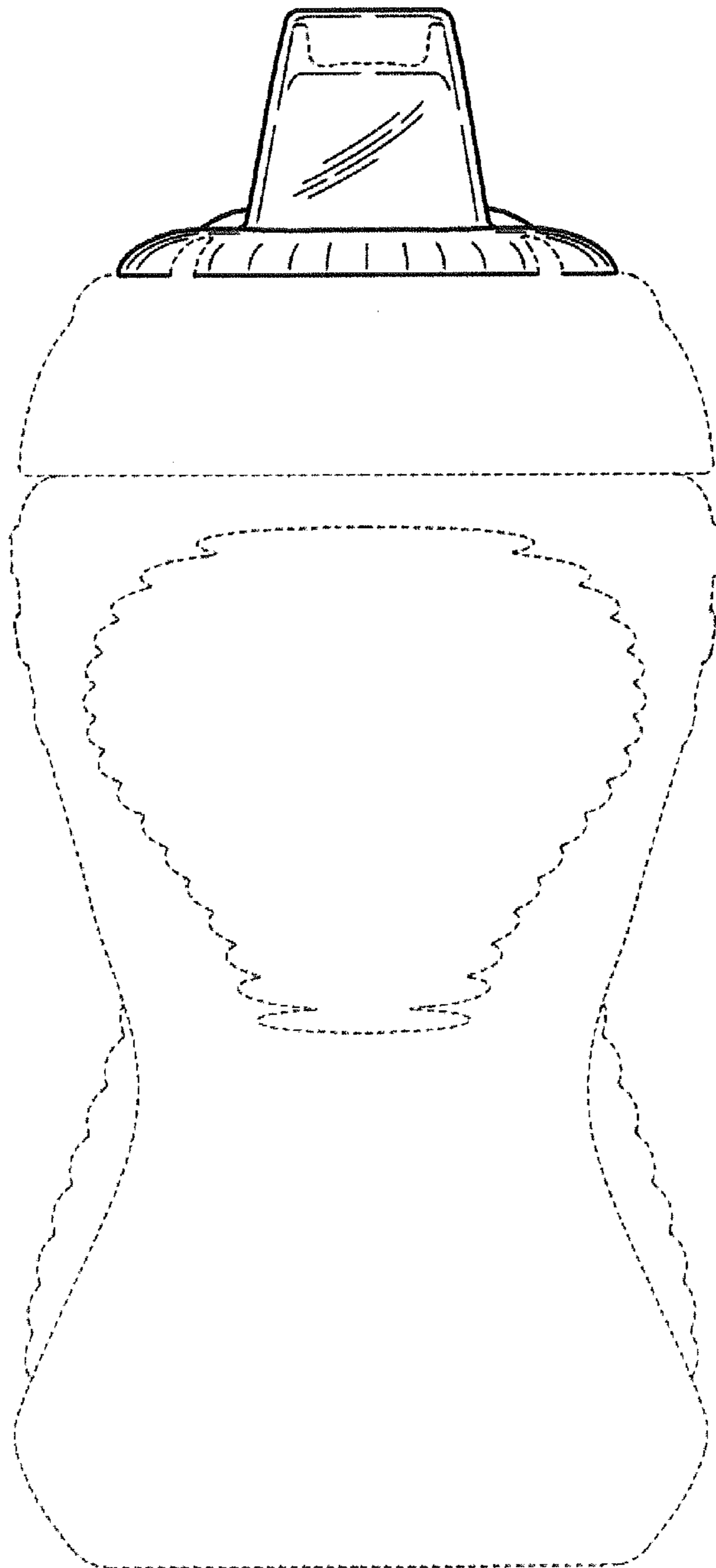

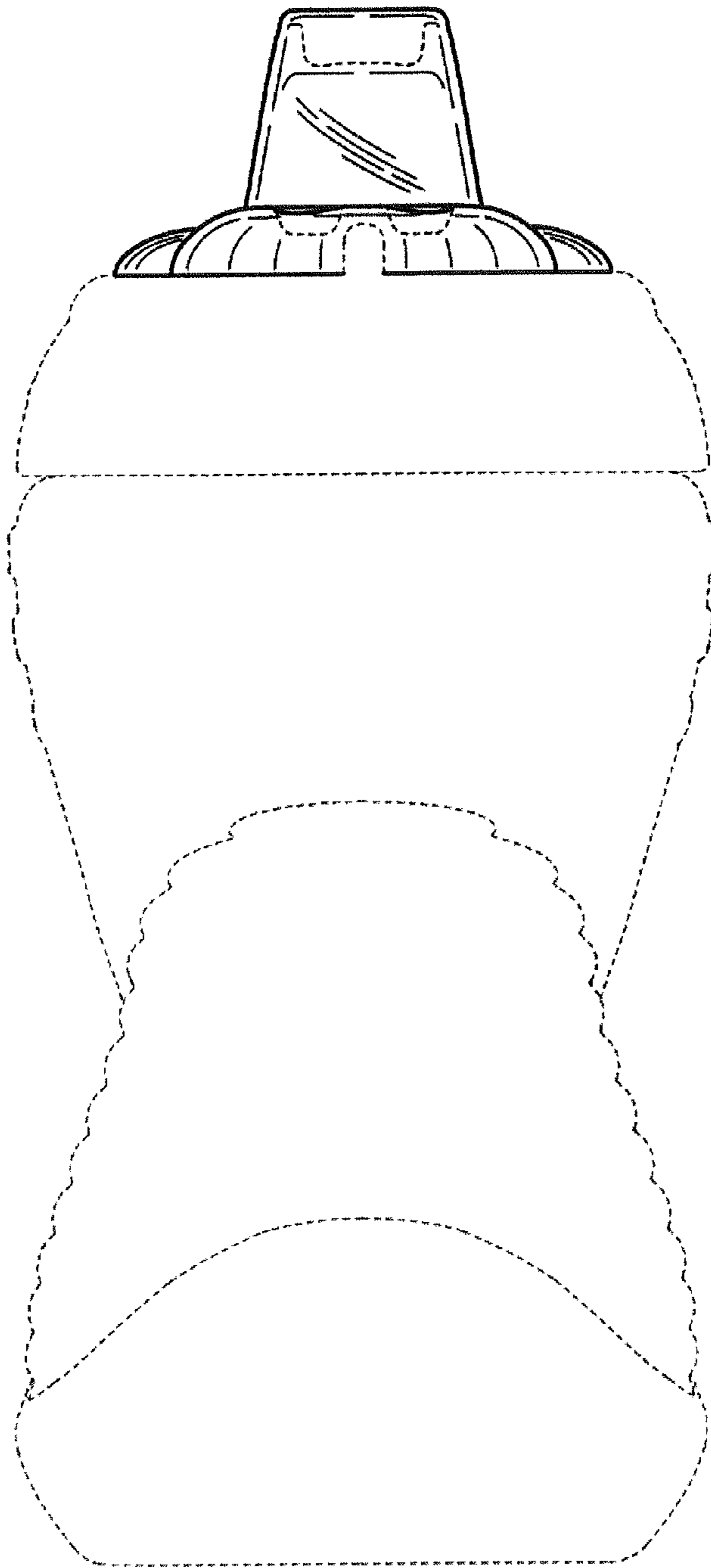

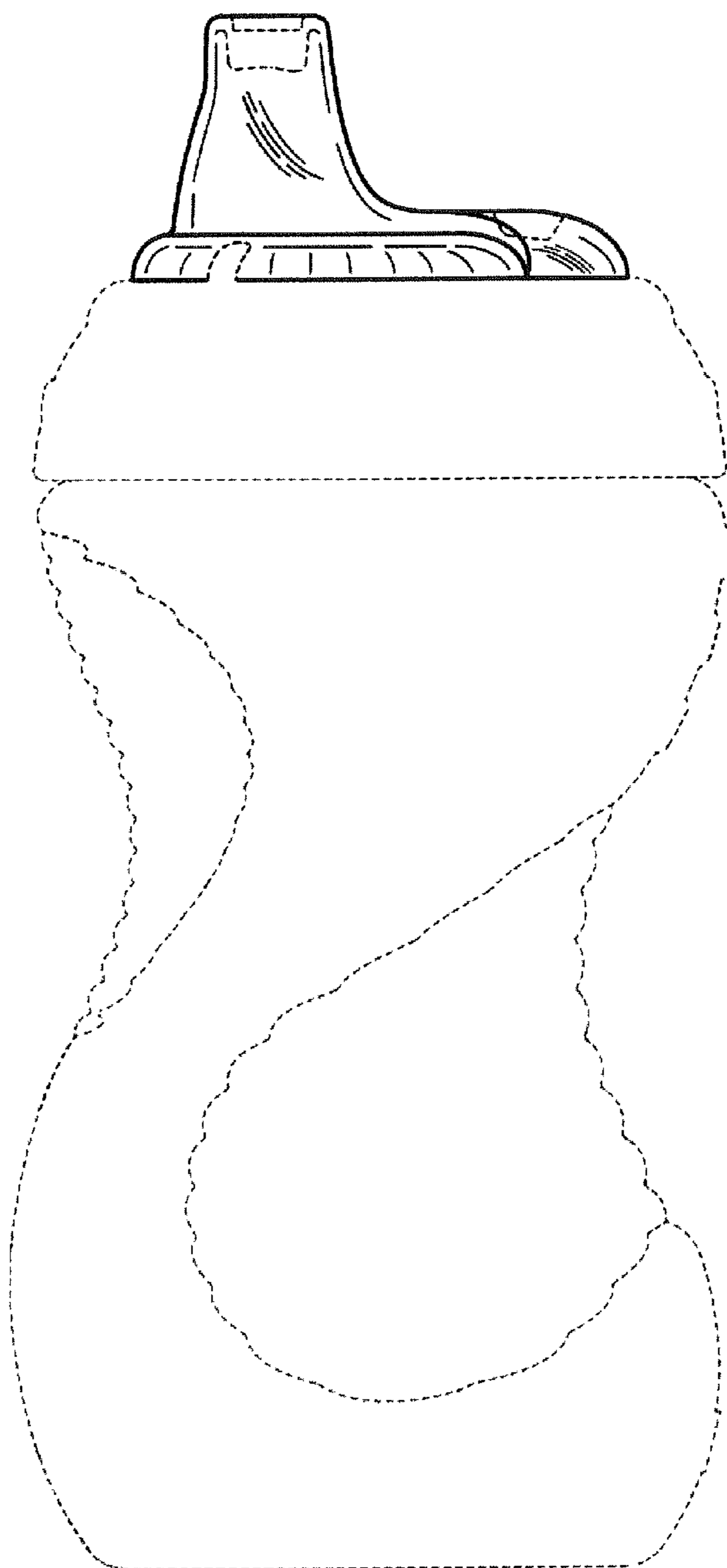

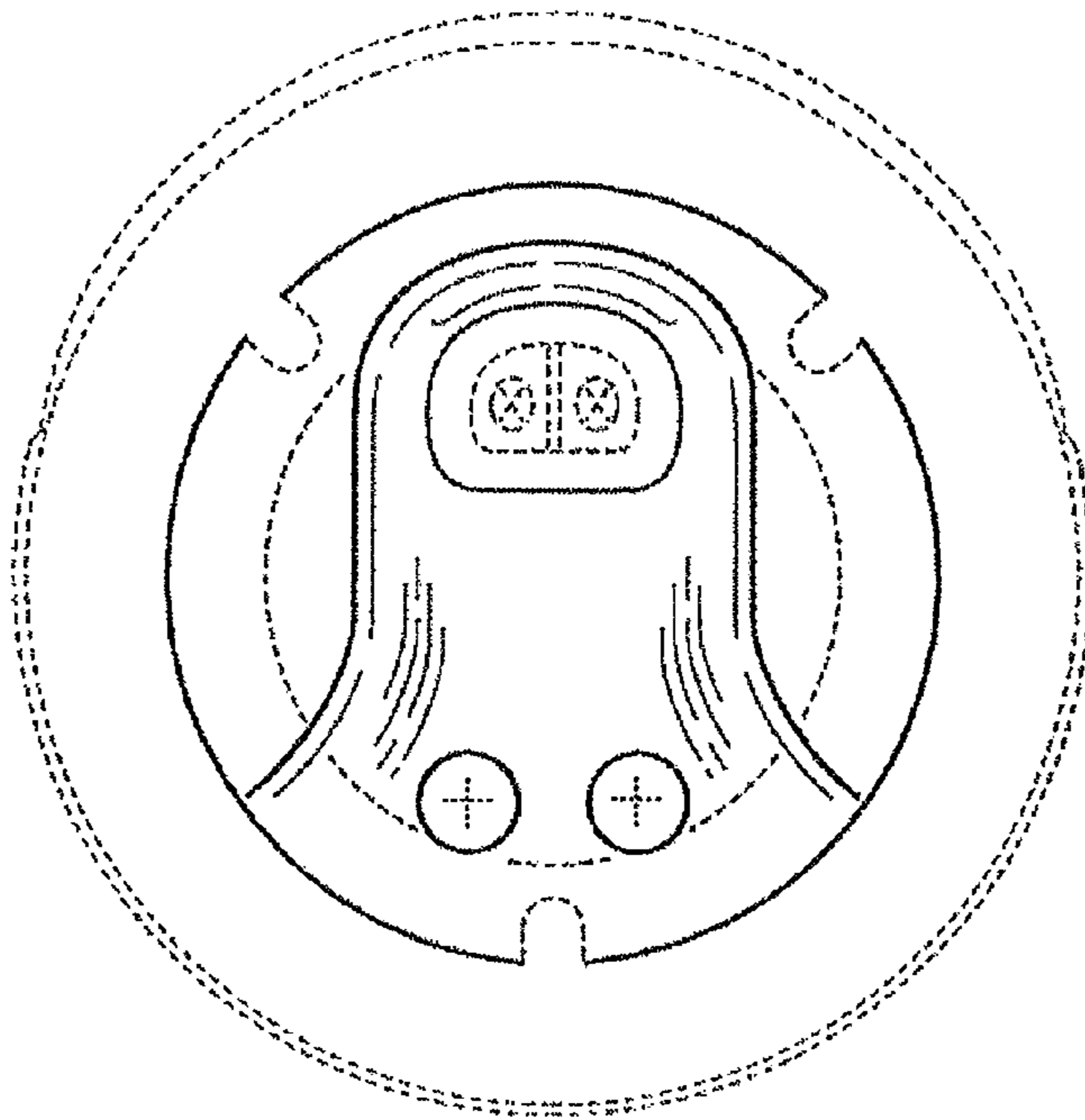

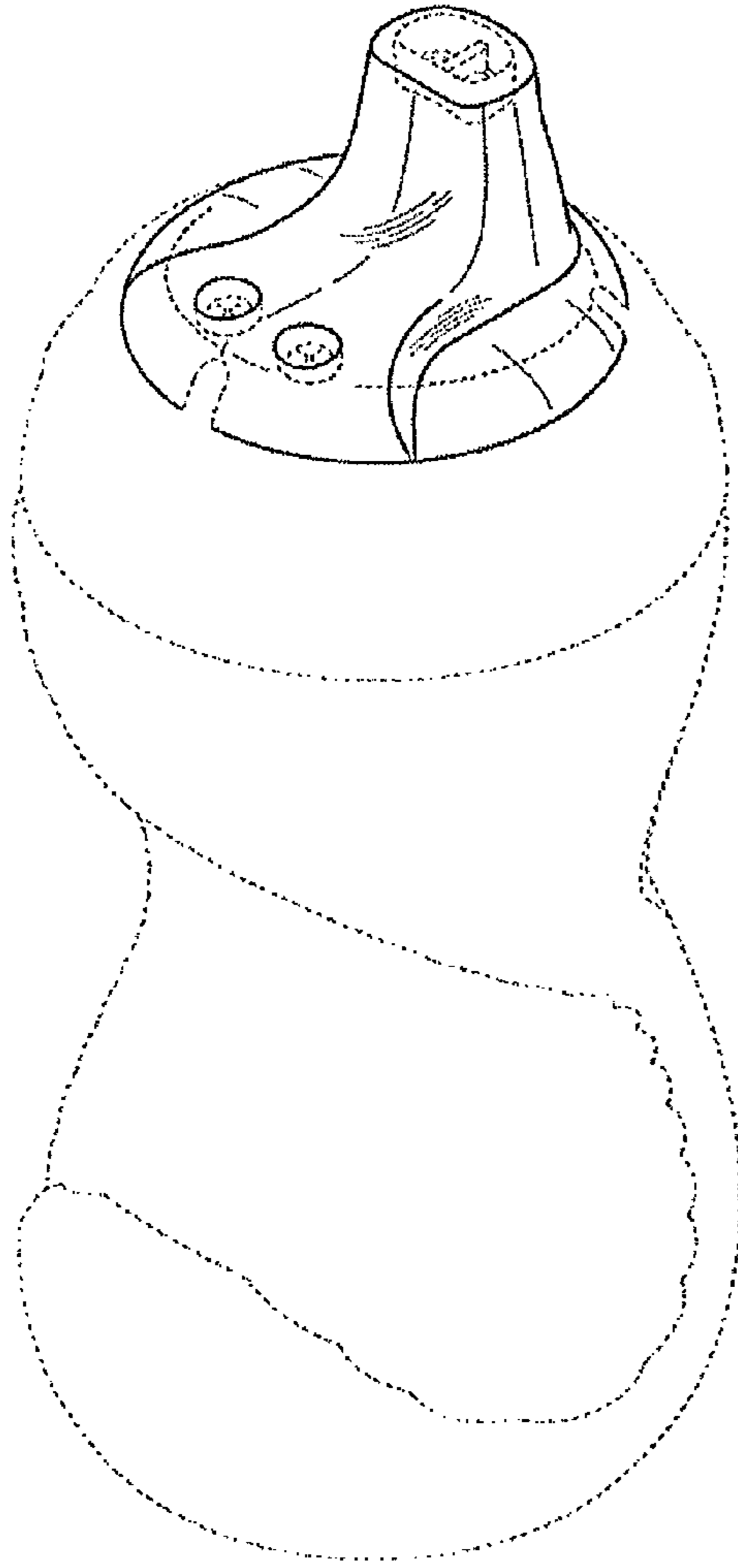

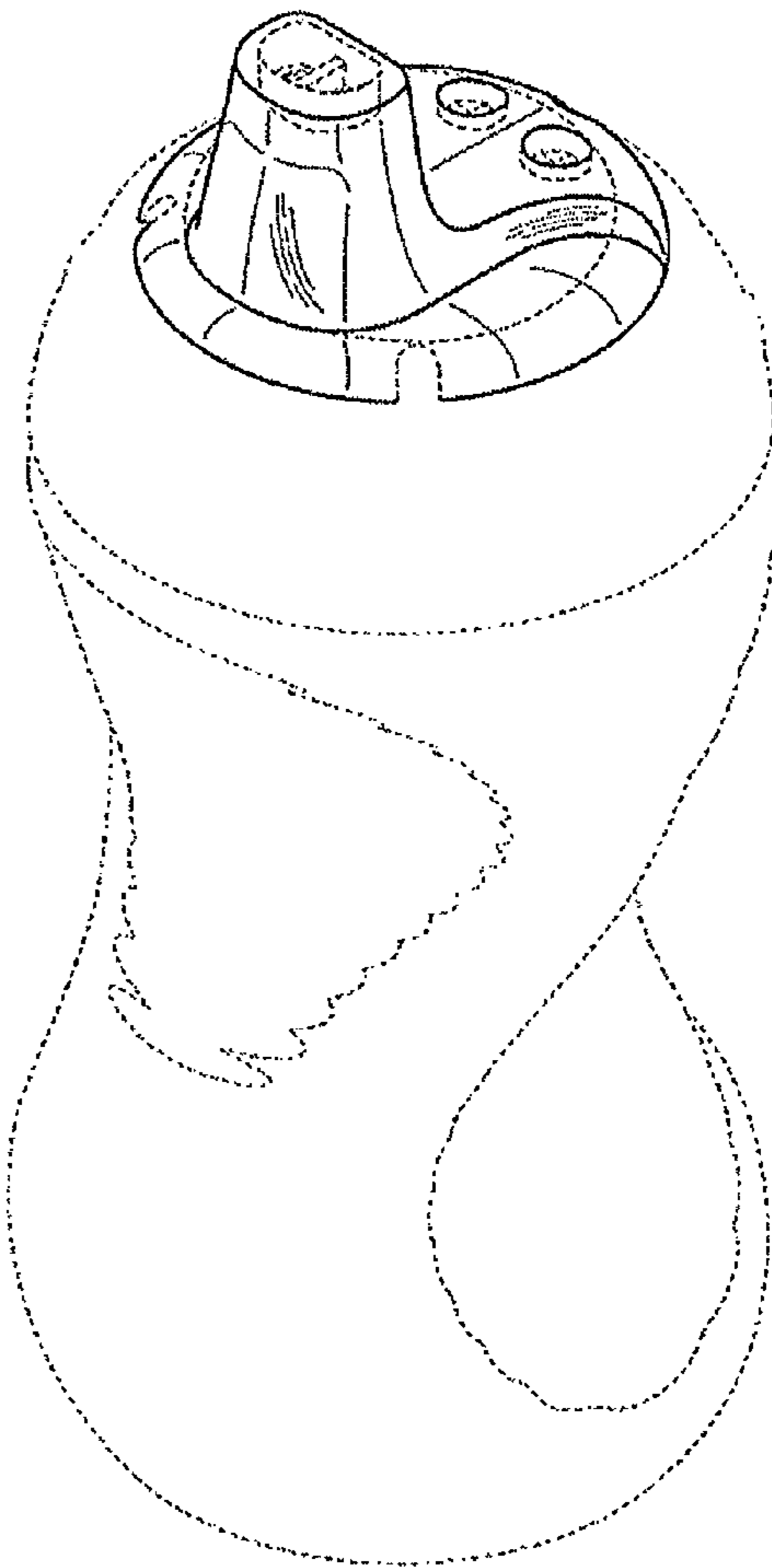
