**DESCRIPTION**

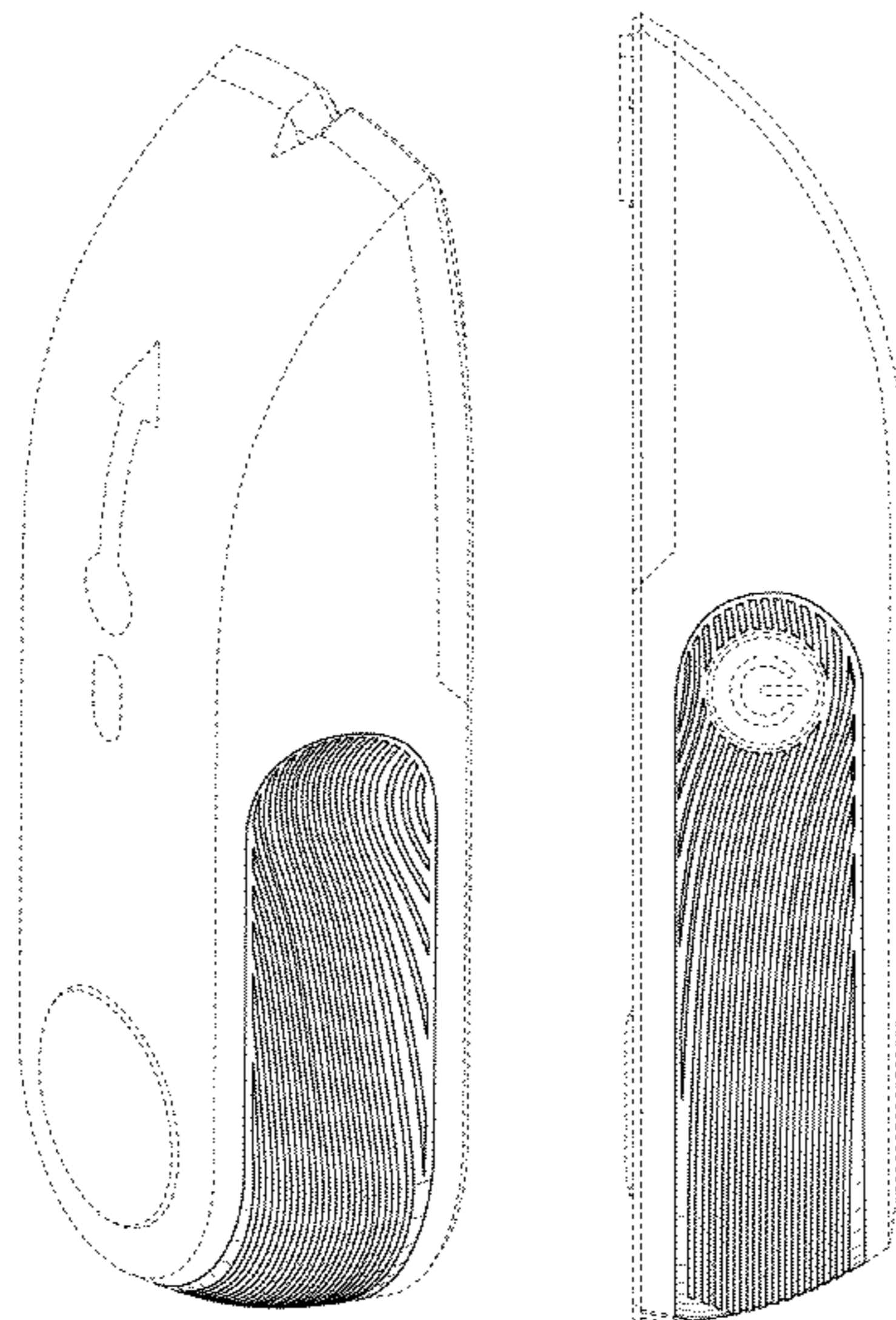
FIG. 1 is a perspective view of a tool grip according to a preferred embodiment of the present invention;

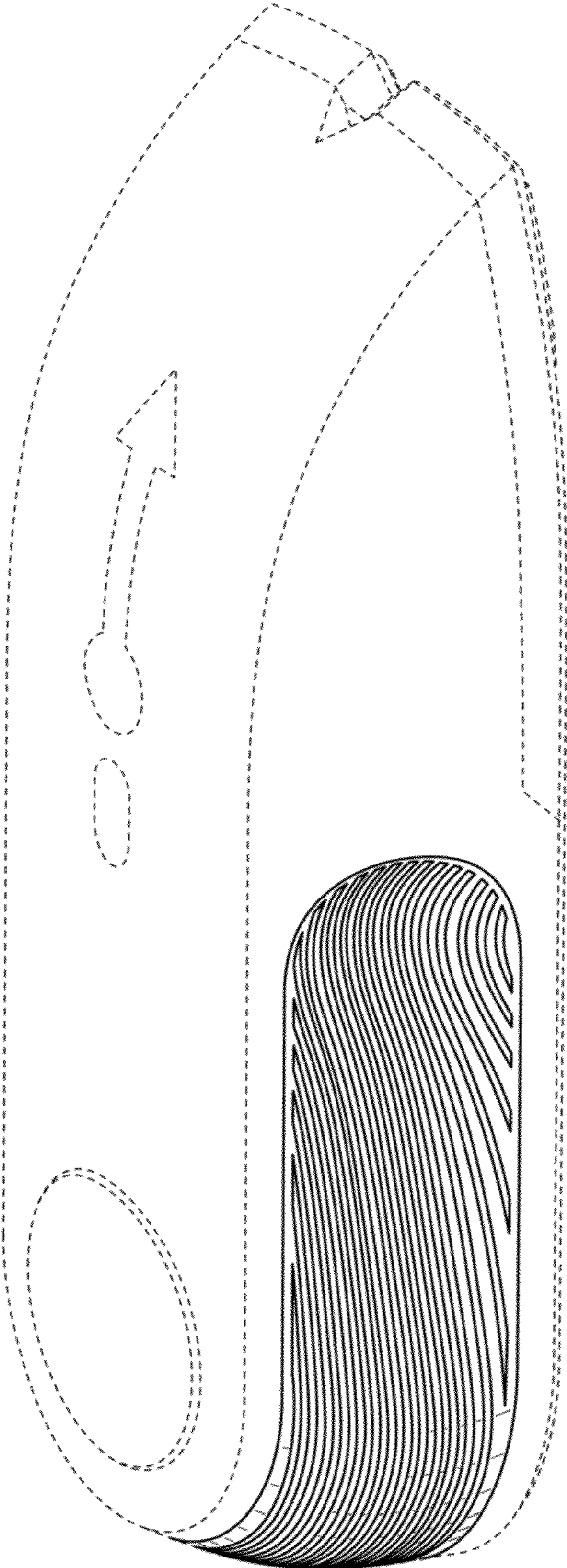

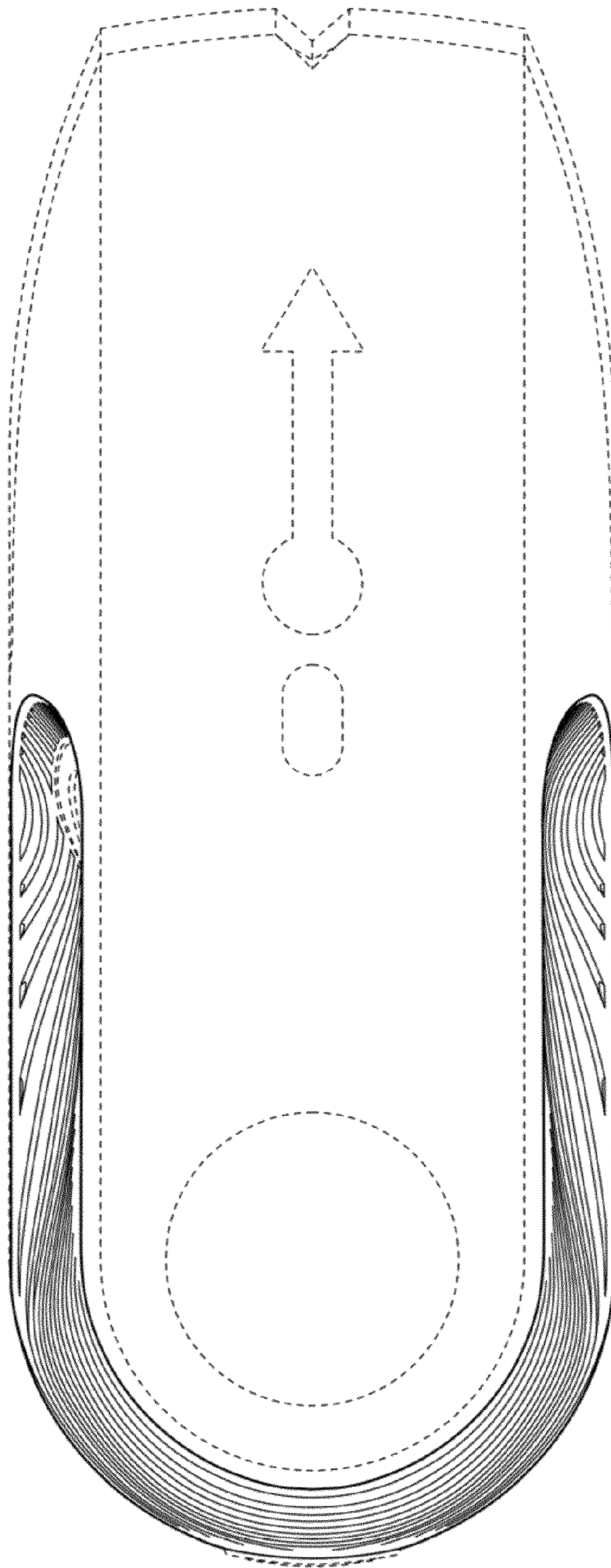

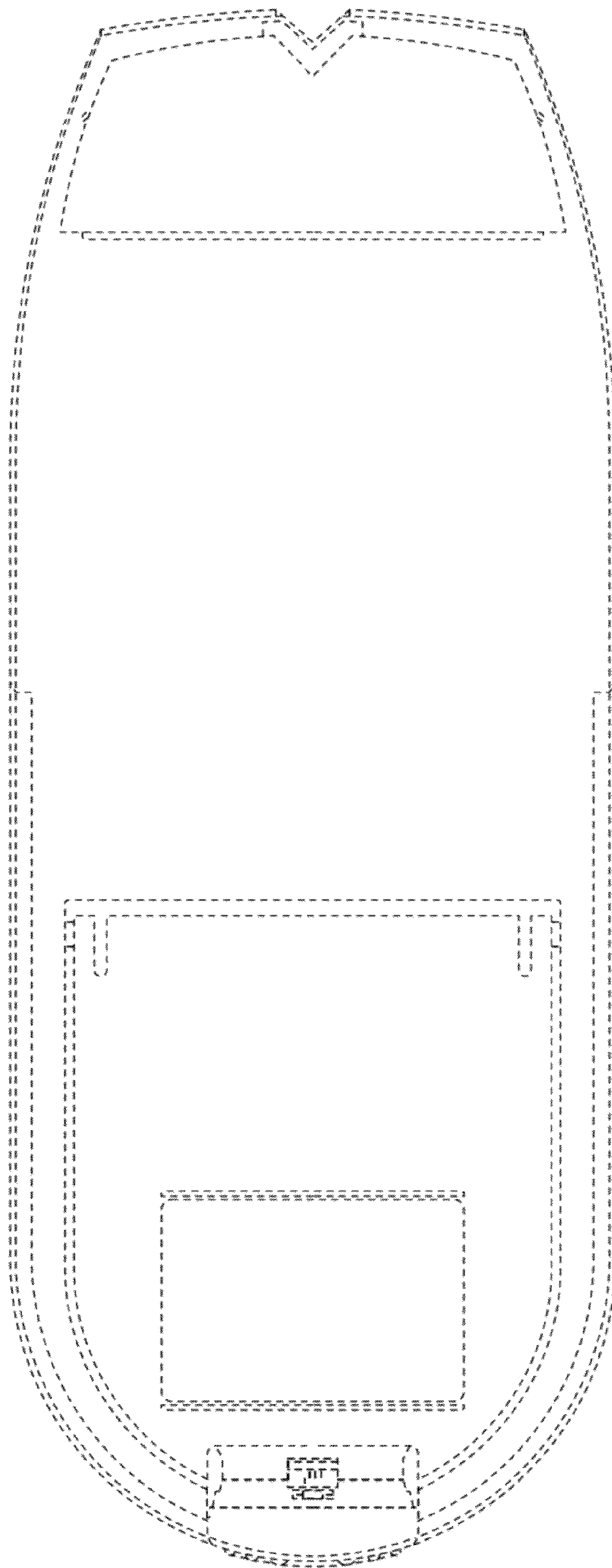

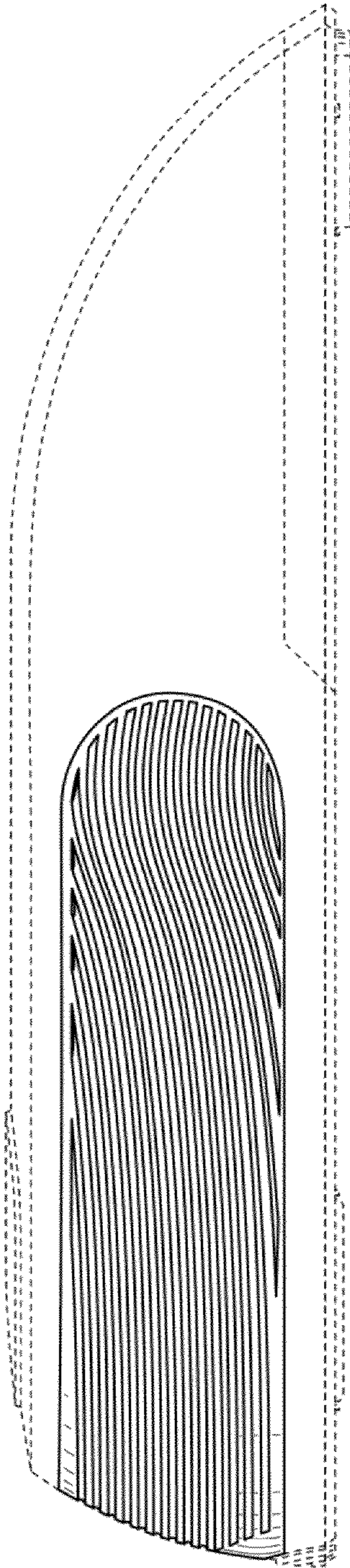

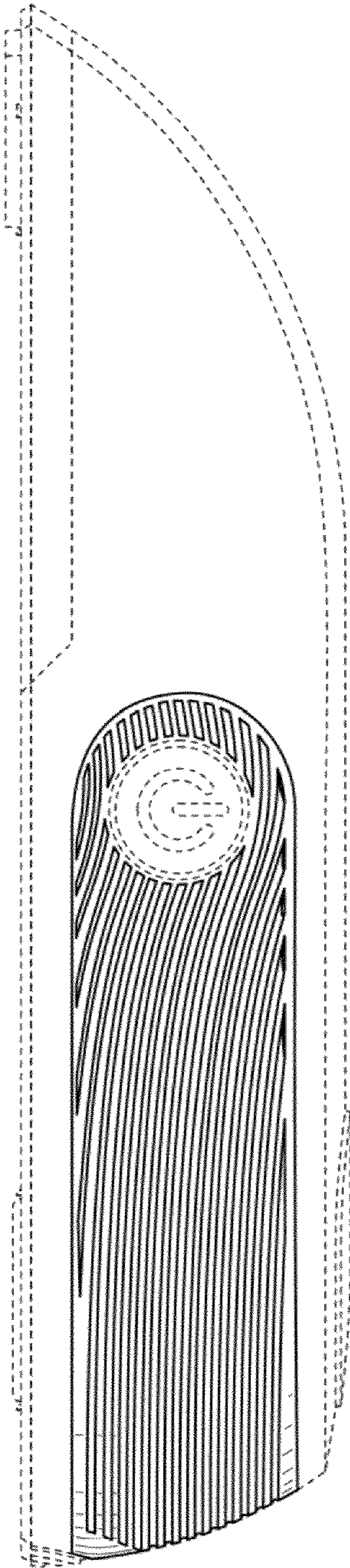

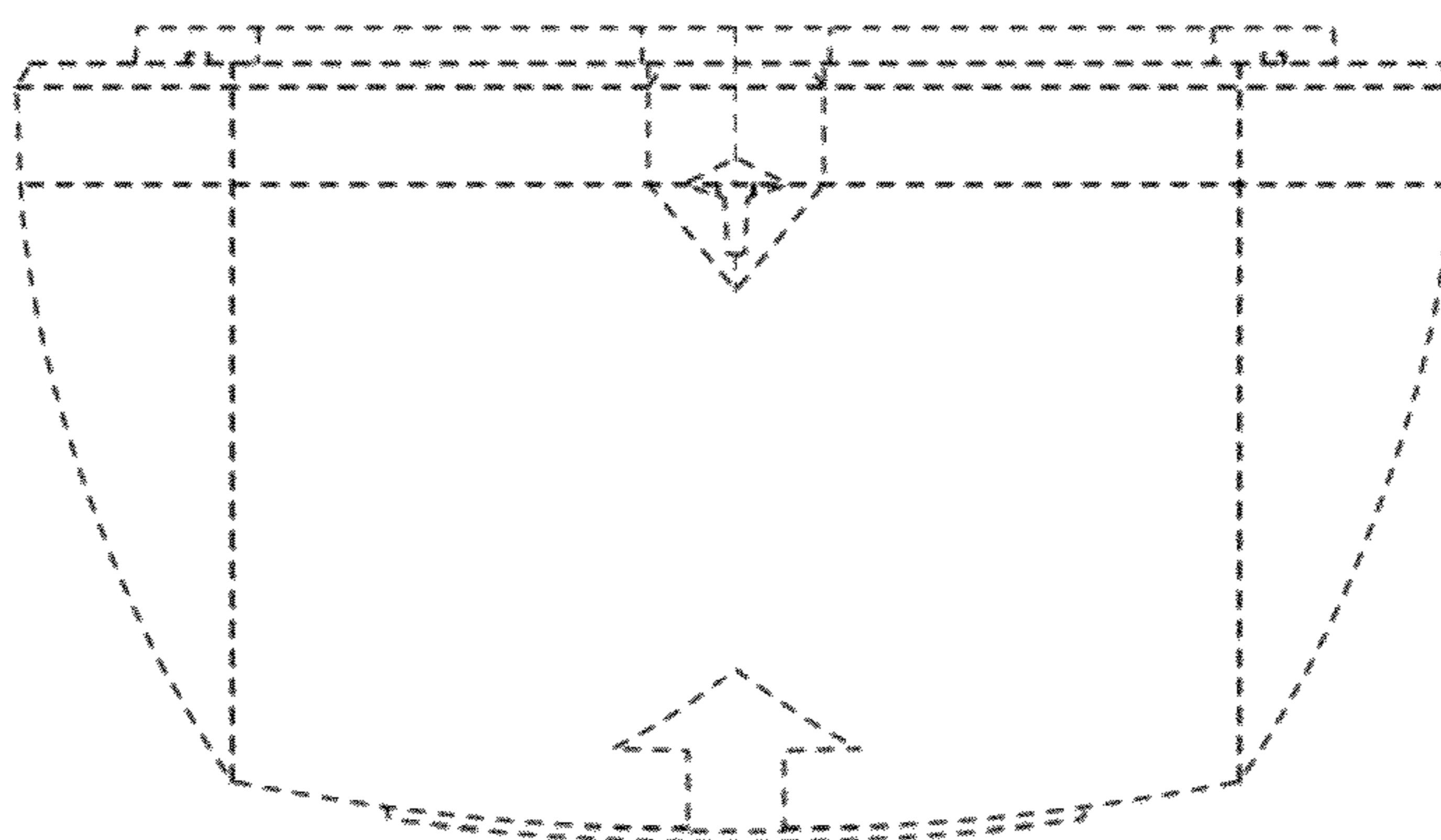

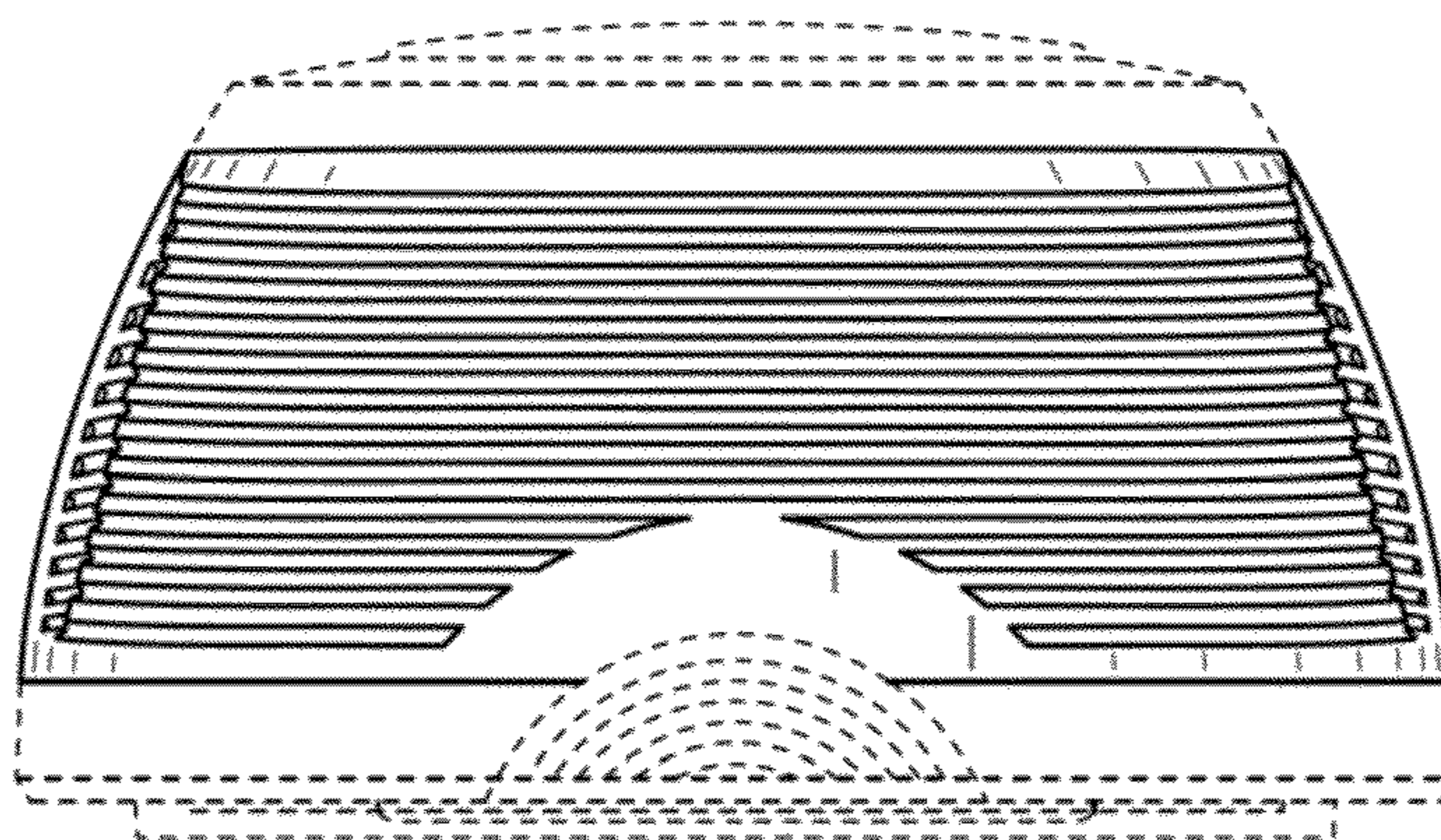
