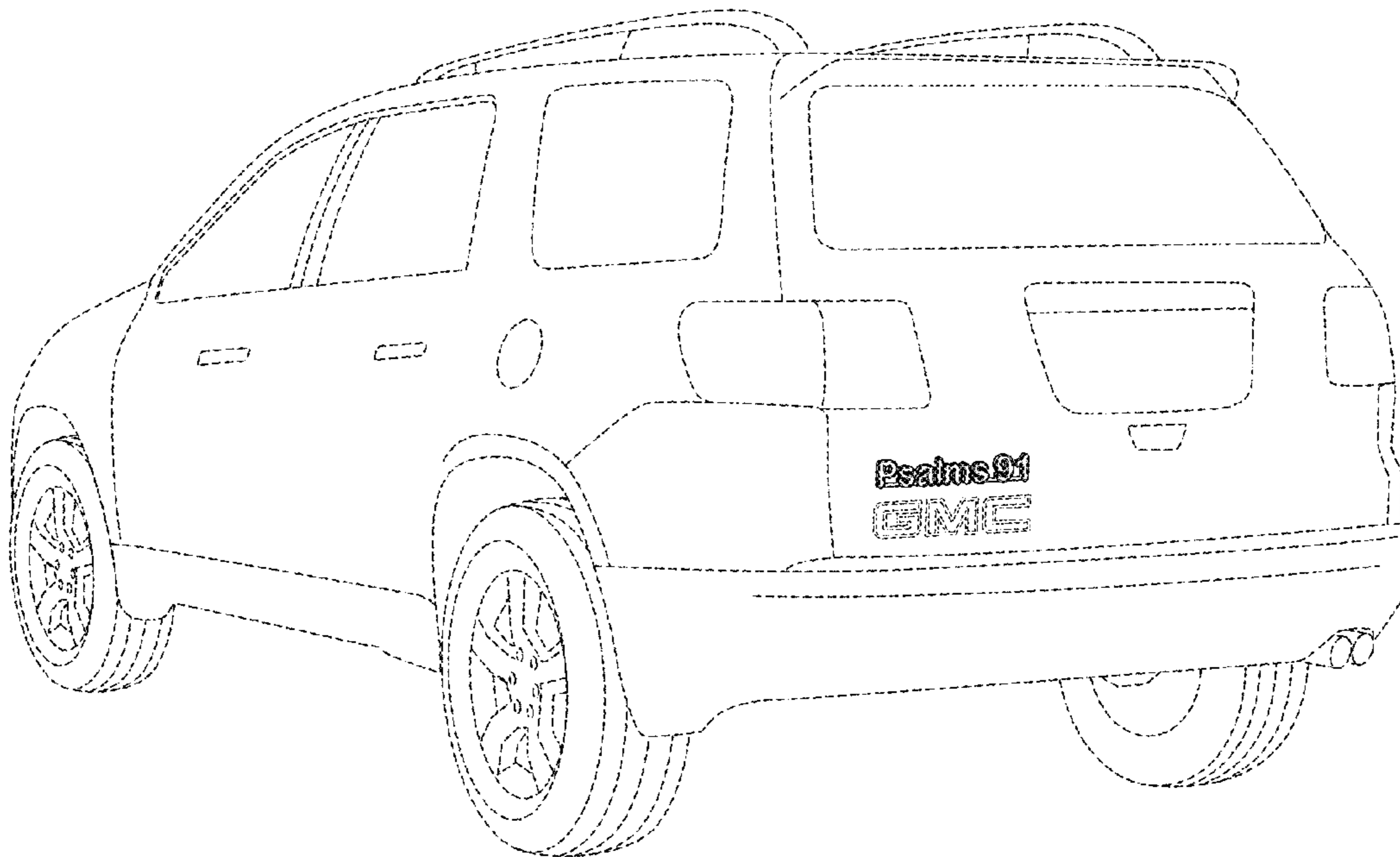
(57) **CLAIM**

I claim the ornamental design for a Psalms 91 plaque, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a Psalms 91 plaque, showing my new design;
FIG. 2 is an enlarged front elevational view thereof;
FIG. 3 is an enlarged rear elevational view thereof;
FIG. 4 is an enlarged left-side elevational view thereof;
FIG. 5 is an enlarged right-side elevational view thereof;
FIG. 6 is an enlarged top plan view thereof; and,
FIG. 7 is an enlarged bottom plan view thereof.
The broken lines showing a vehicle in FIG. 1 depict environmental matter and form no part of the claimed design.

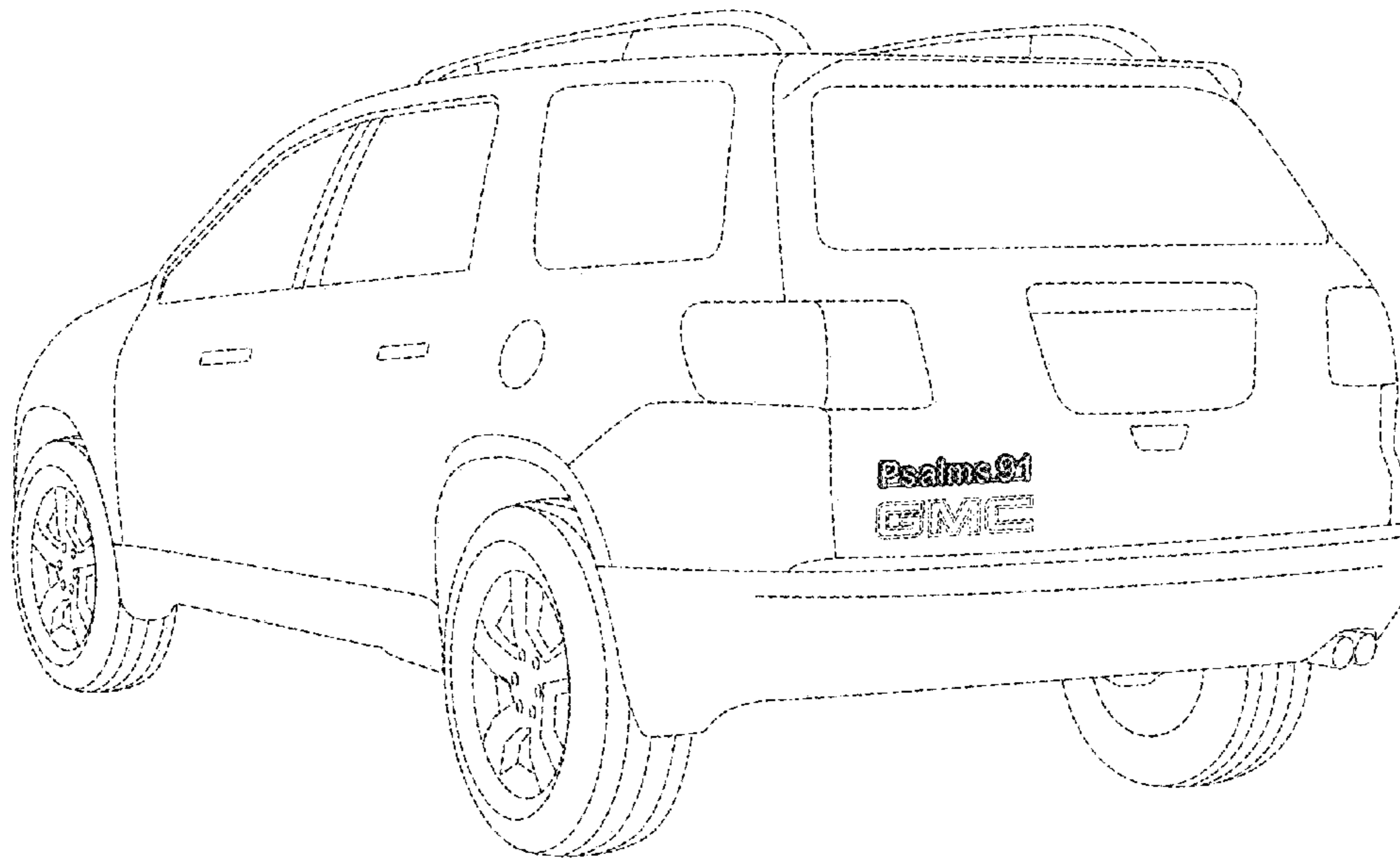

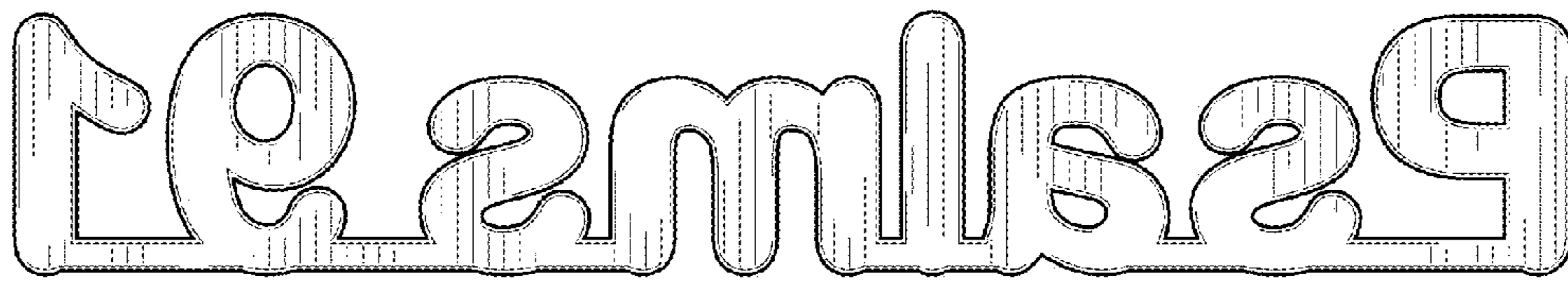

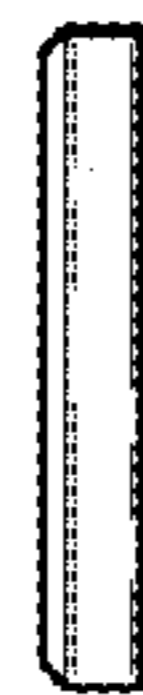
