(57) **CLAIM**

We claim the ornamental design for an insert for an air cleaner cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an insert, embodying aspects of the invention.

FIG. 11 is a top view of the insert of FIG. 8.

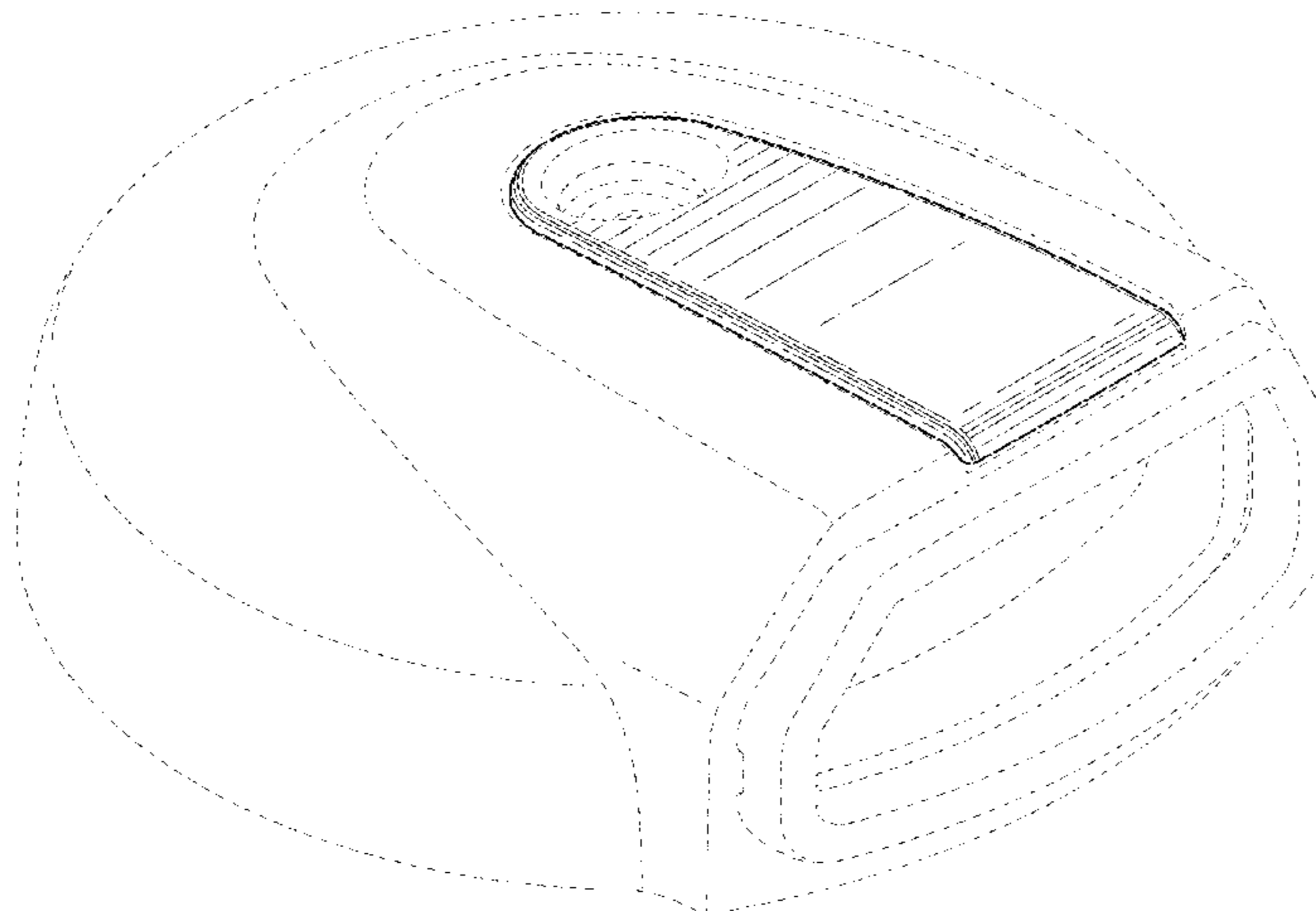
FIG. 12 is a bottom view of the insert of FIG. 8.

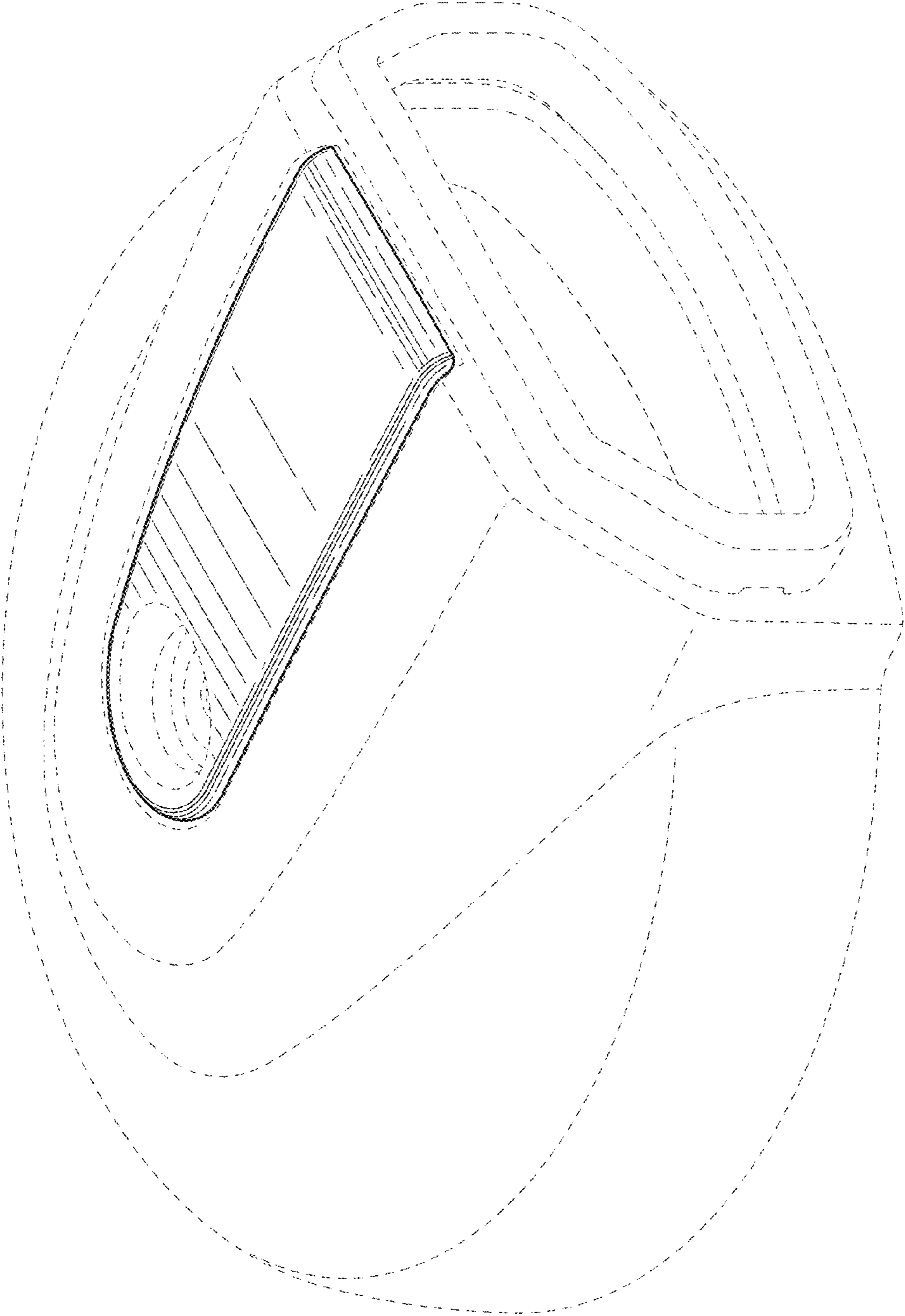

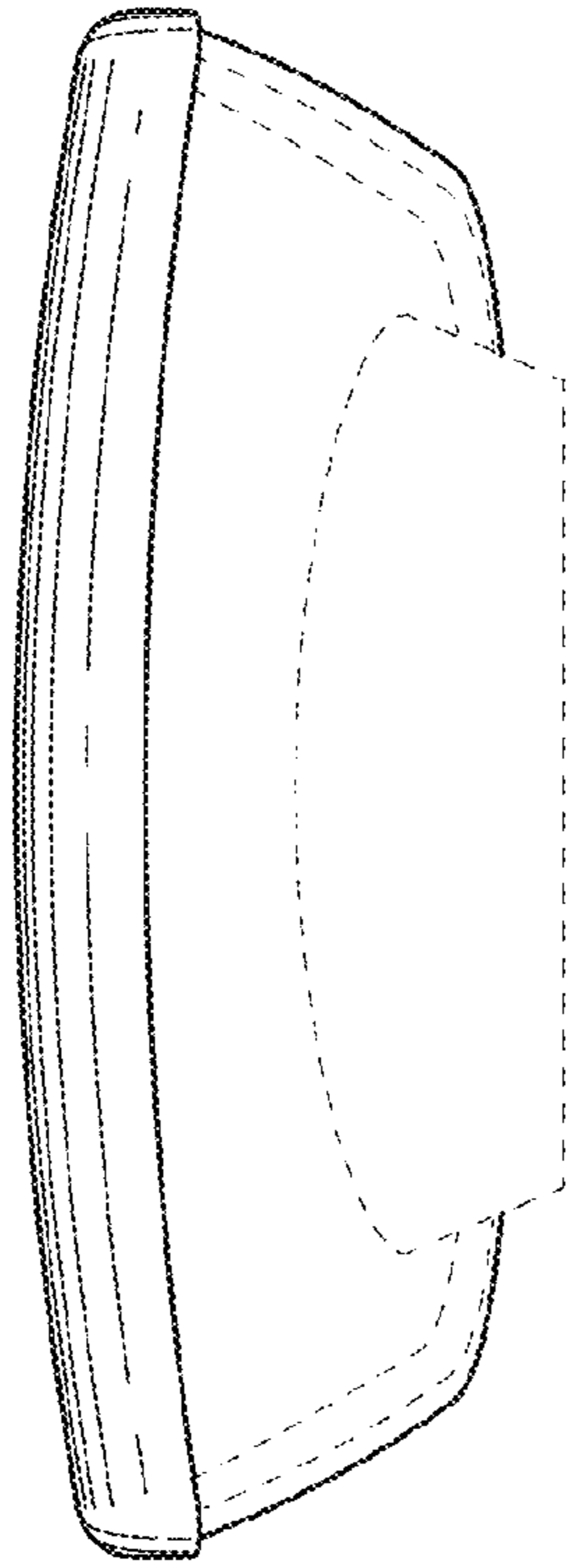

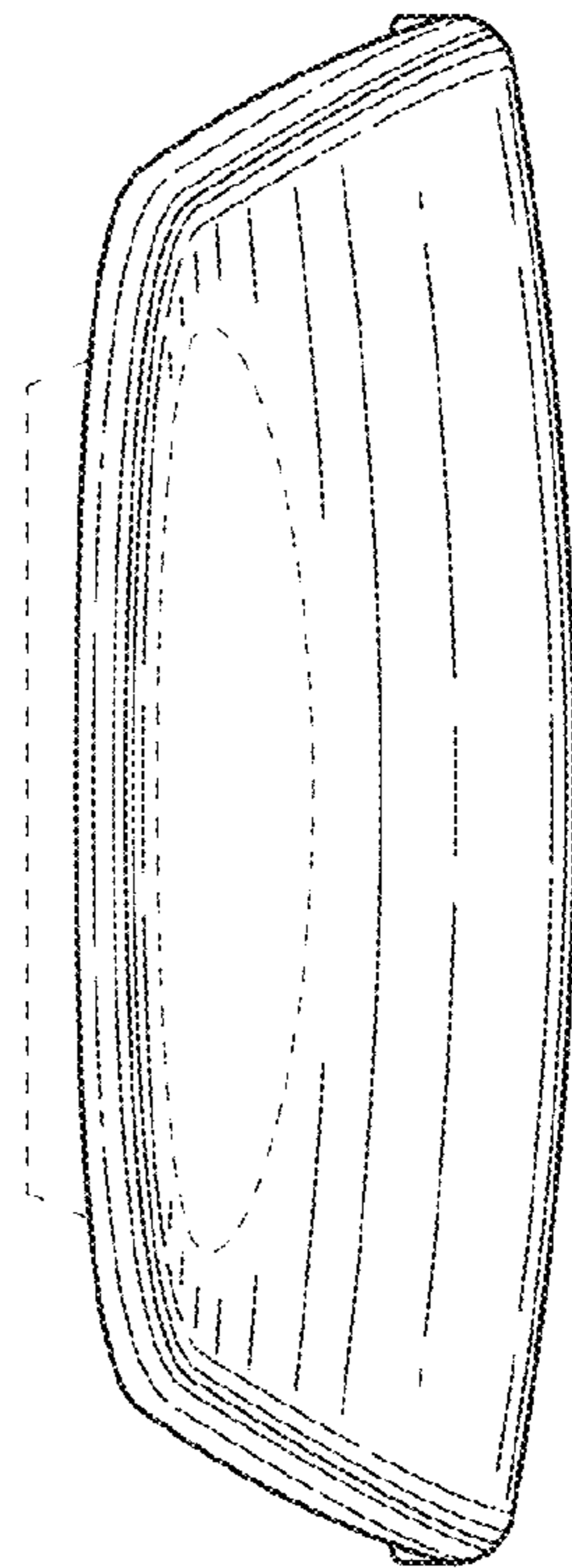

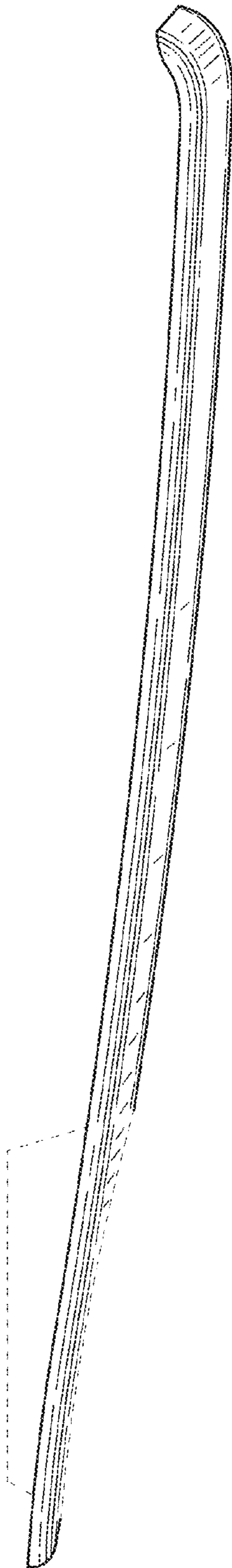

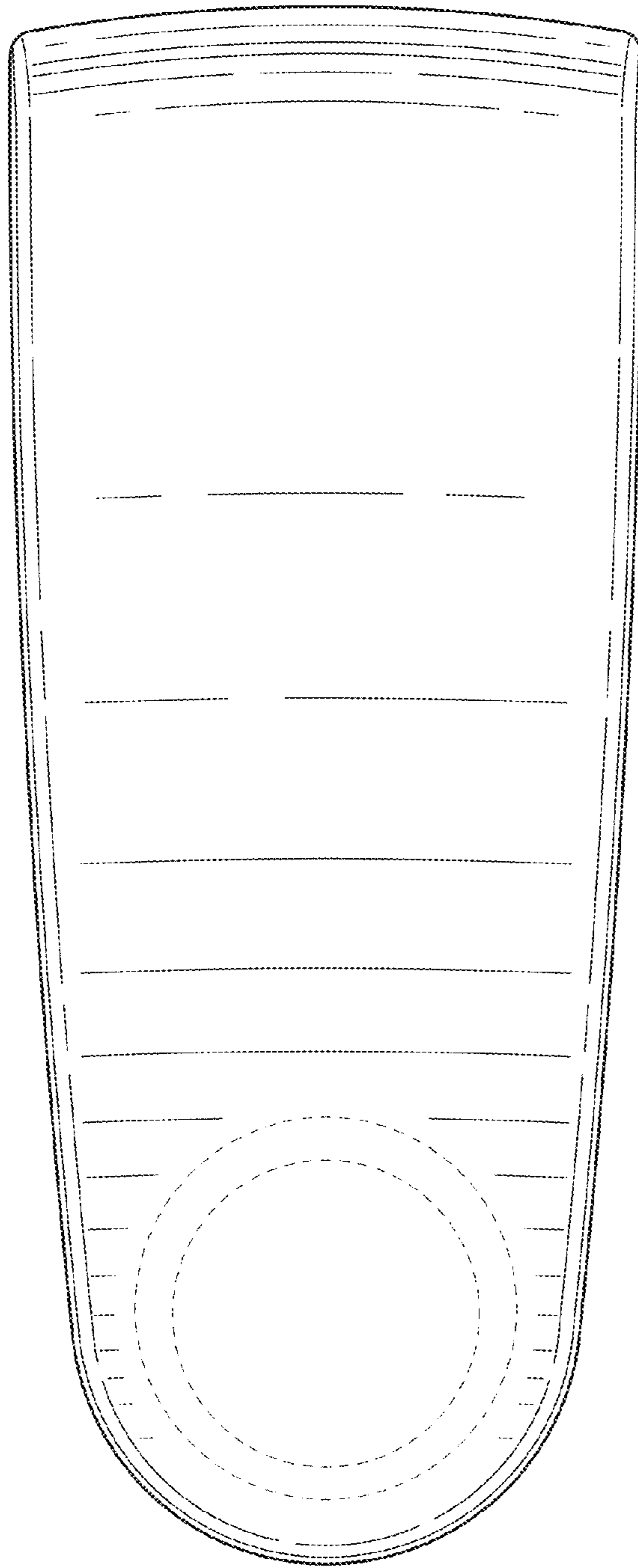

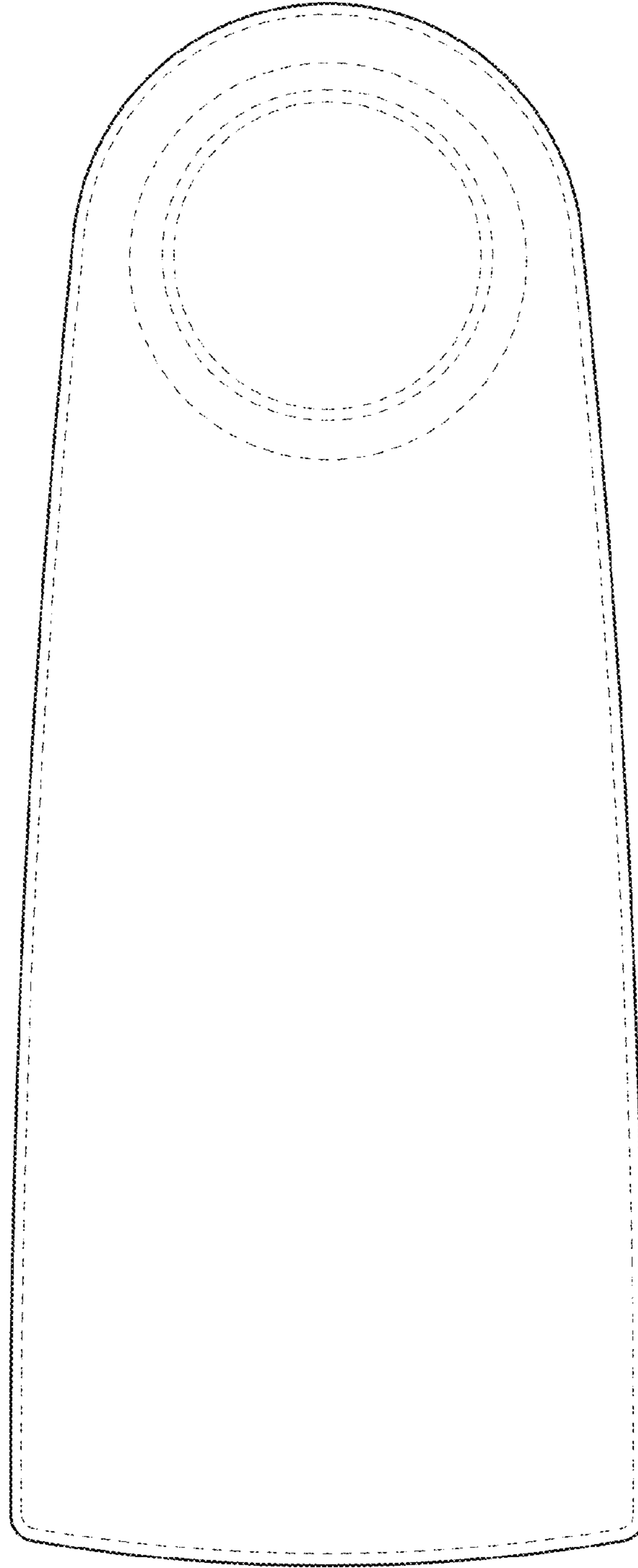

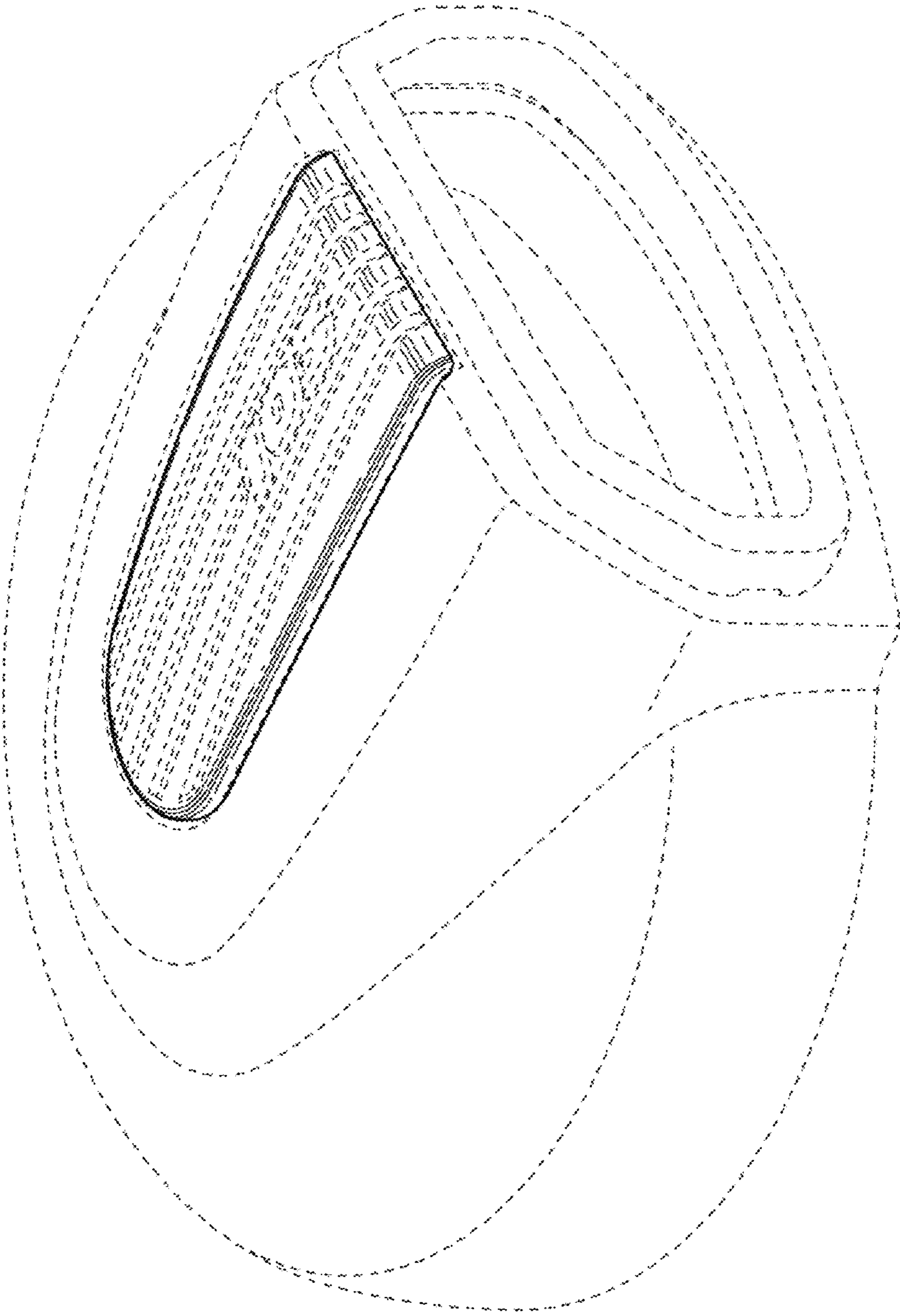

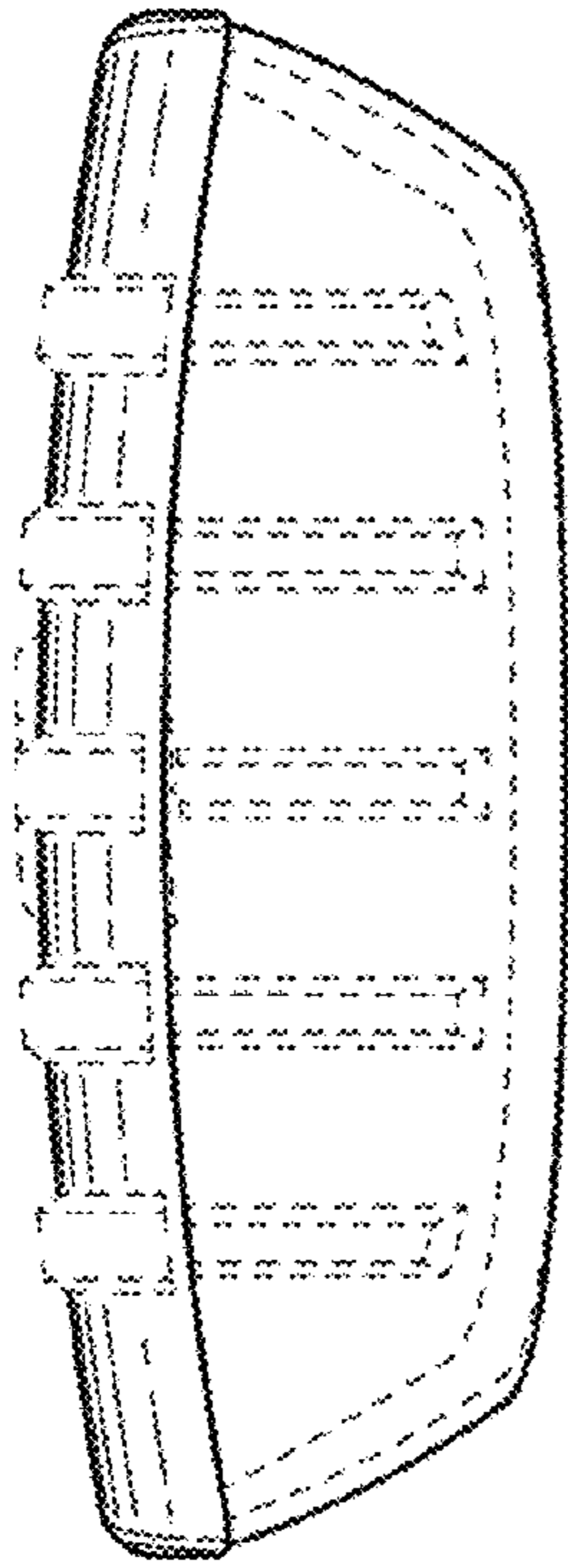

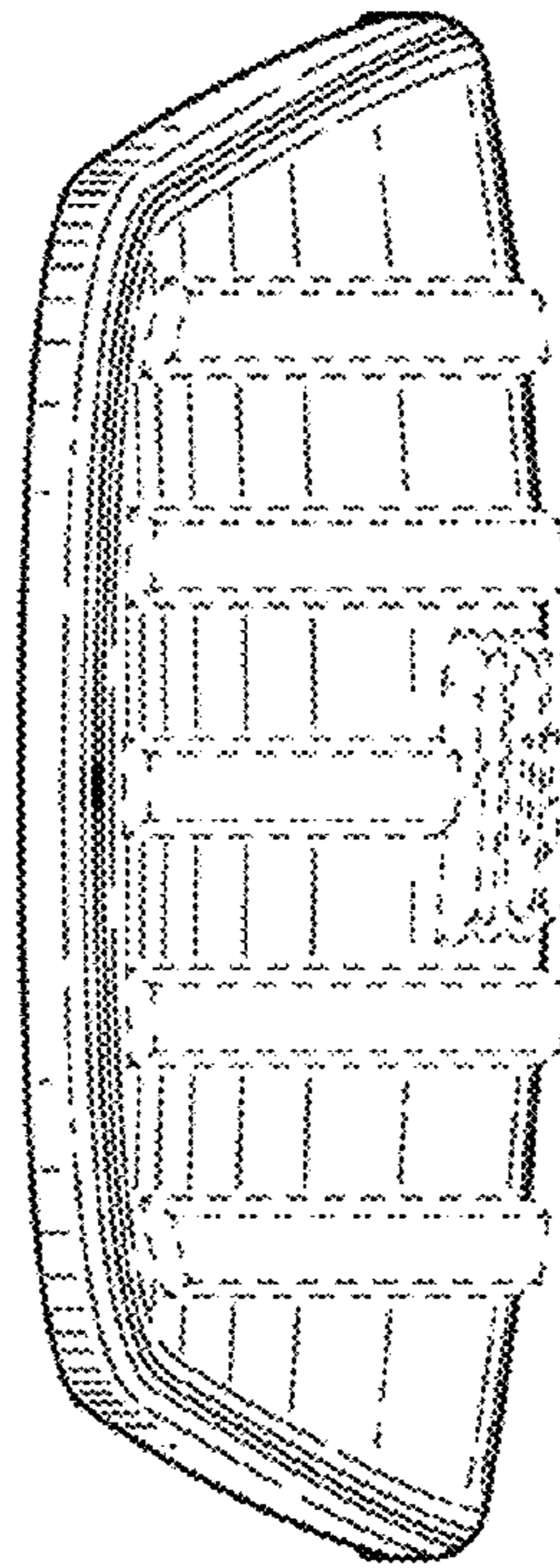

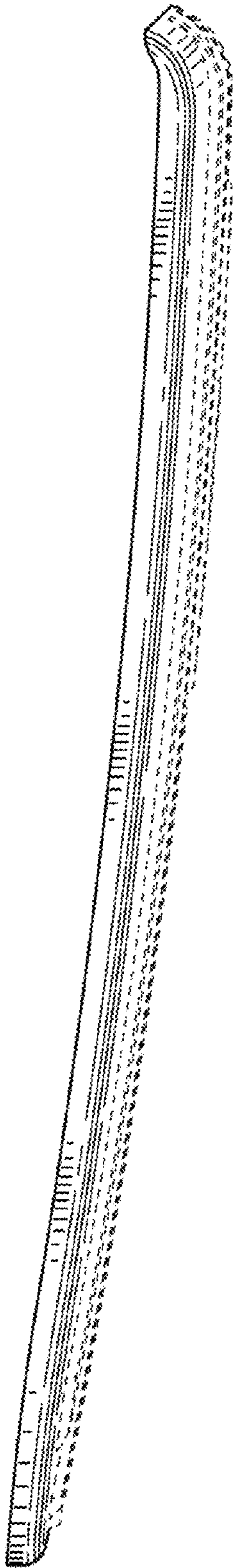

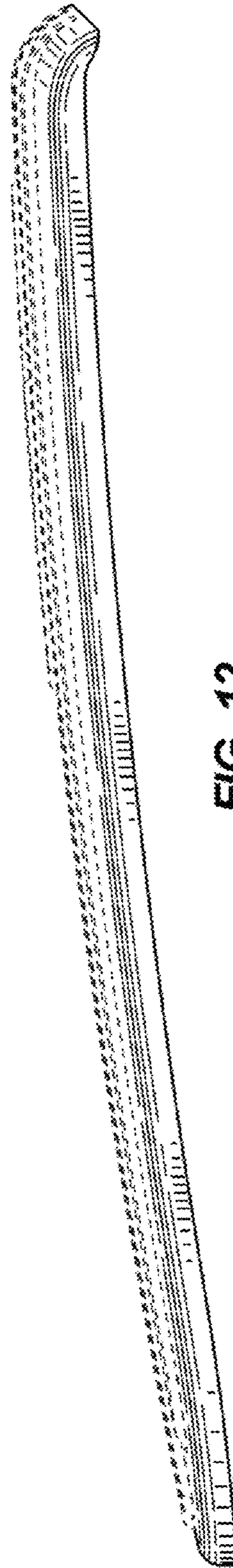

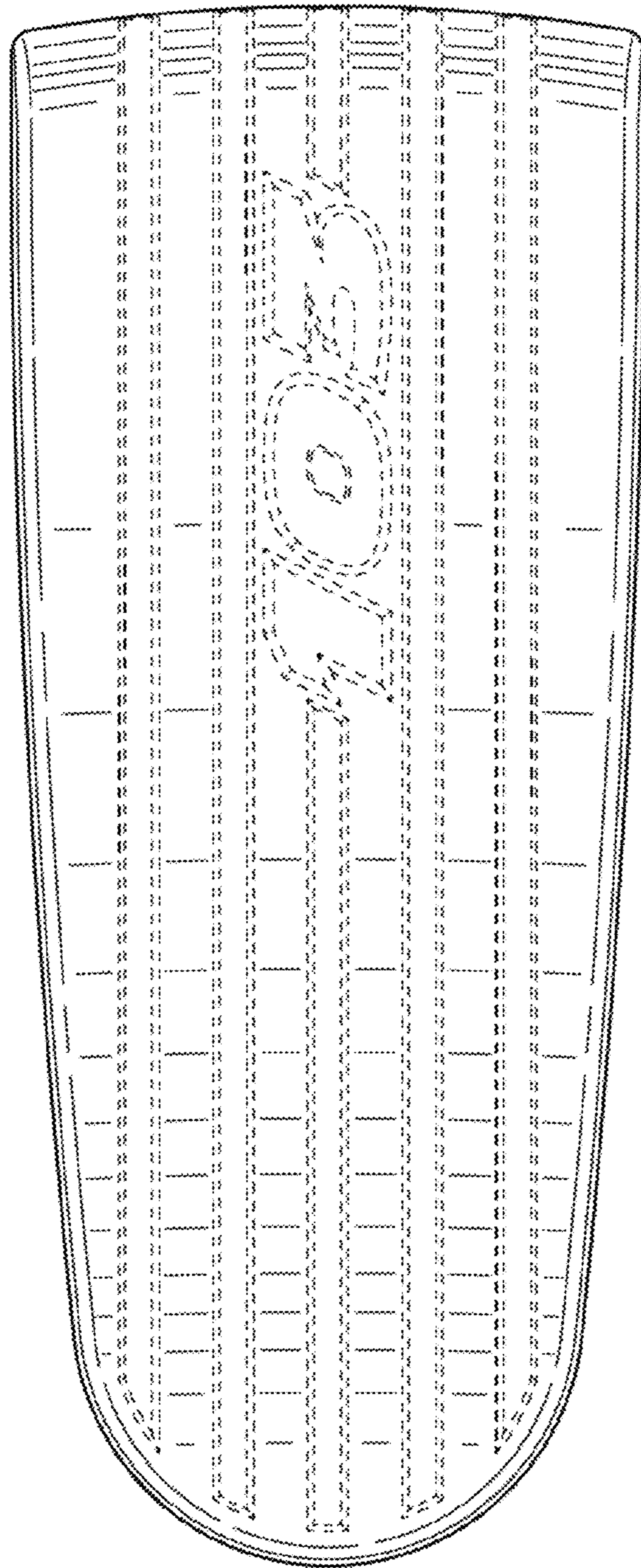

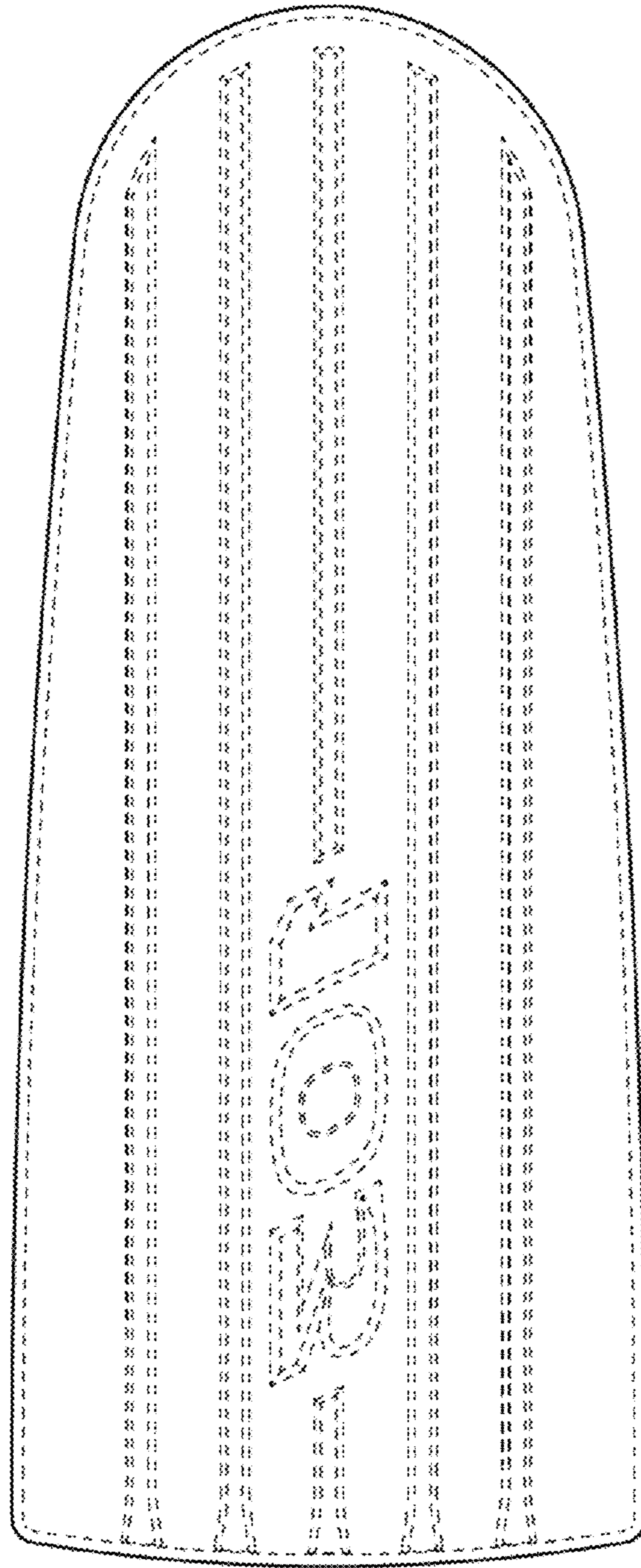
