DESCRIPTION

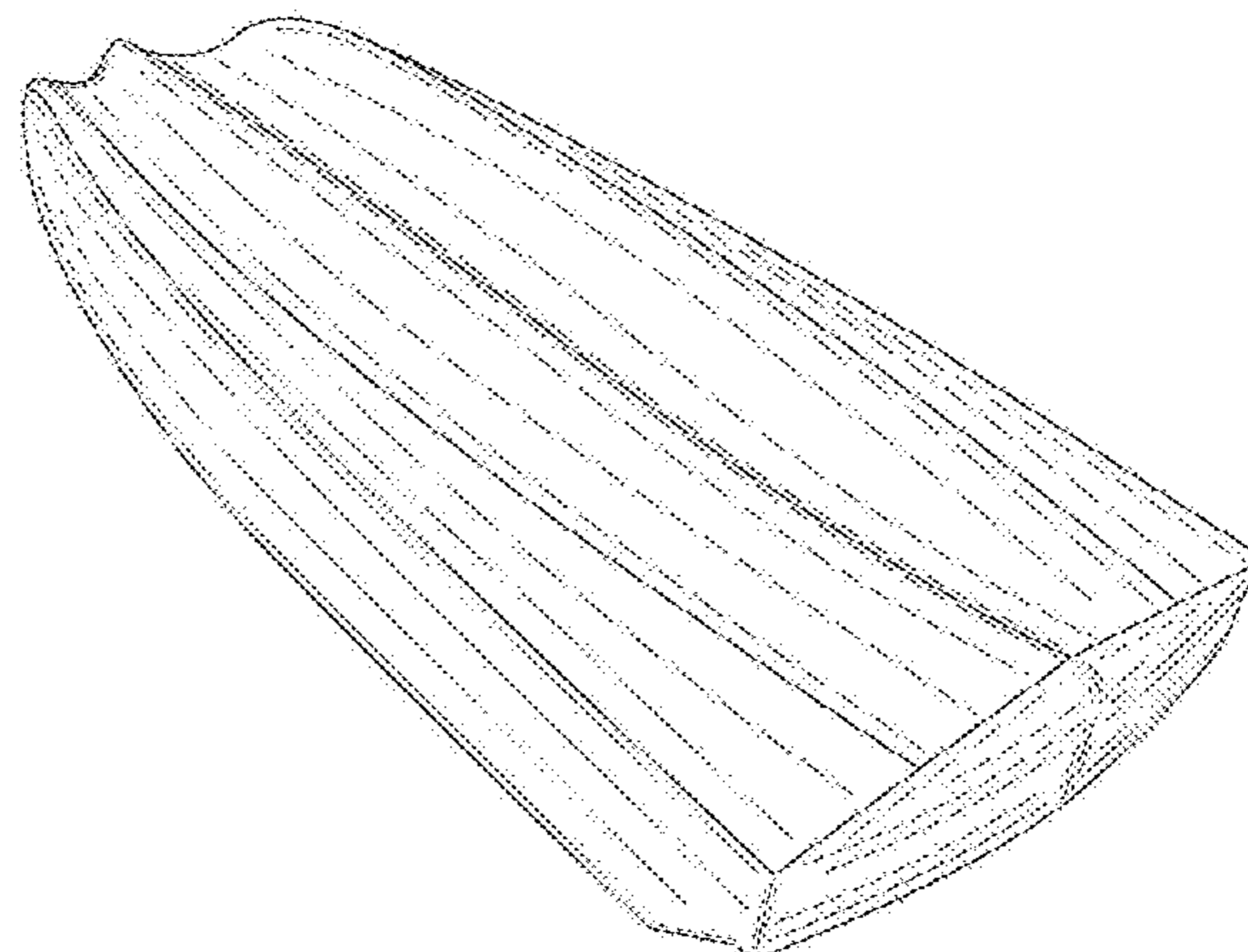
FIG. 1 is a top left front perspective view of a boat hull showing my new design;
FIG. 2 is a bottom right front perspective view thereof;
FIG. 3 is a bottom right rear perspective view thereof;
FIG. 4 is a left elevation view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a front elevation view thereof;
FIG. 8 is a rear elevation view thereof;
FIG. 9 is bottom left front perspective view thereof;
FIG. 10 is a bottom front perspective view;
FIG. 11 is a bottom rear perspective view;
FIG. 12 is a bottom left rear perspective view; and,
FIG. 13 is a top rear perspective view.
The broken lines of uneven length in FIGS. 1, 6, 8, and 13 define the outer boundary of the claimed design.

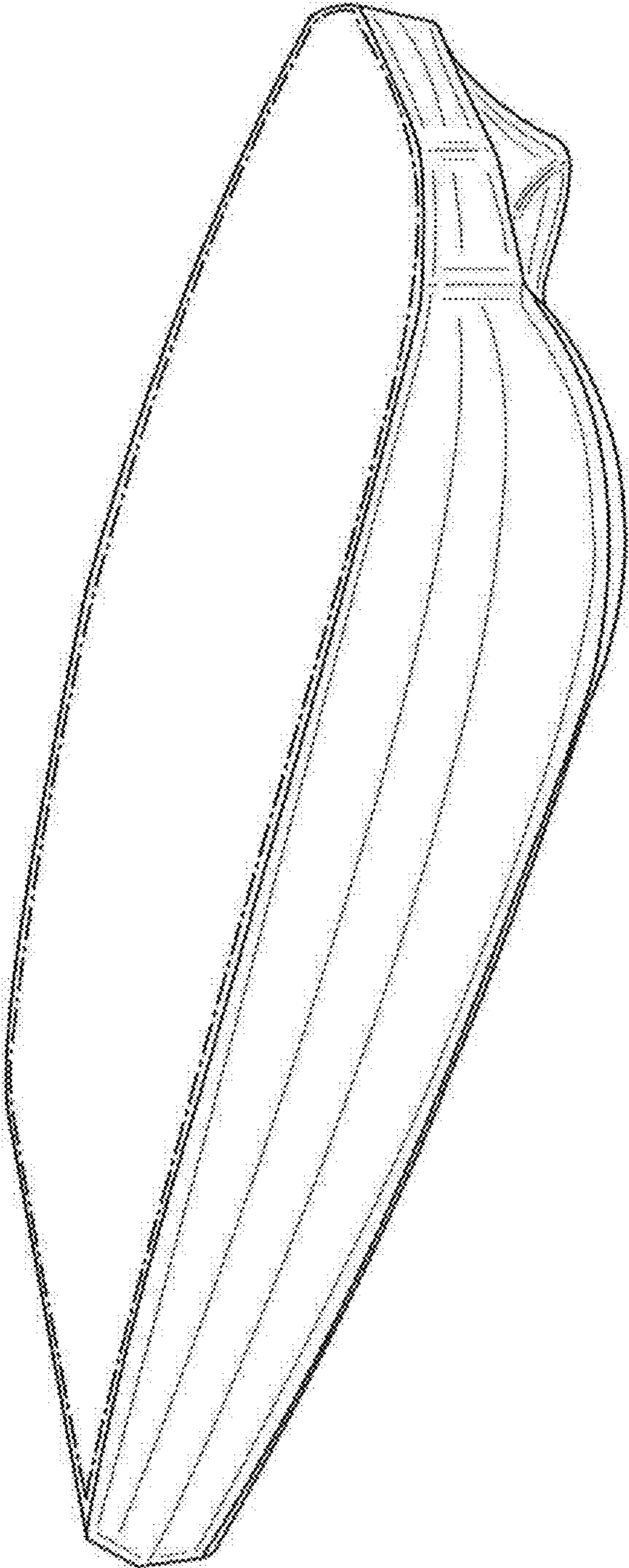

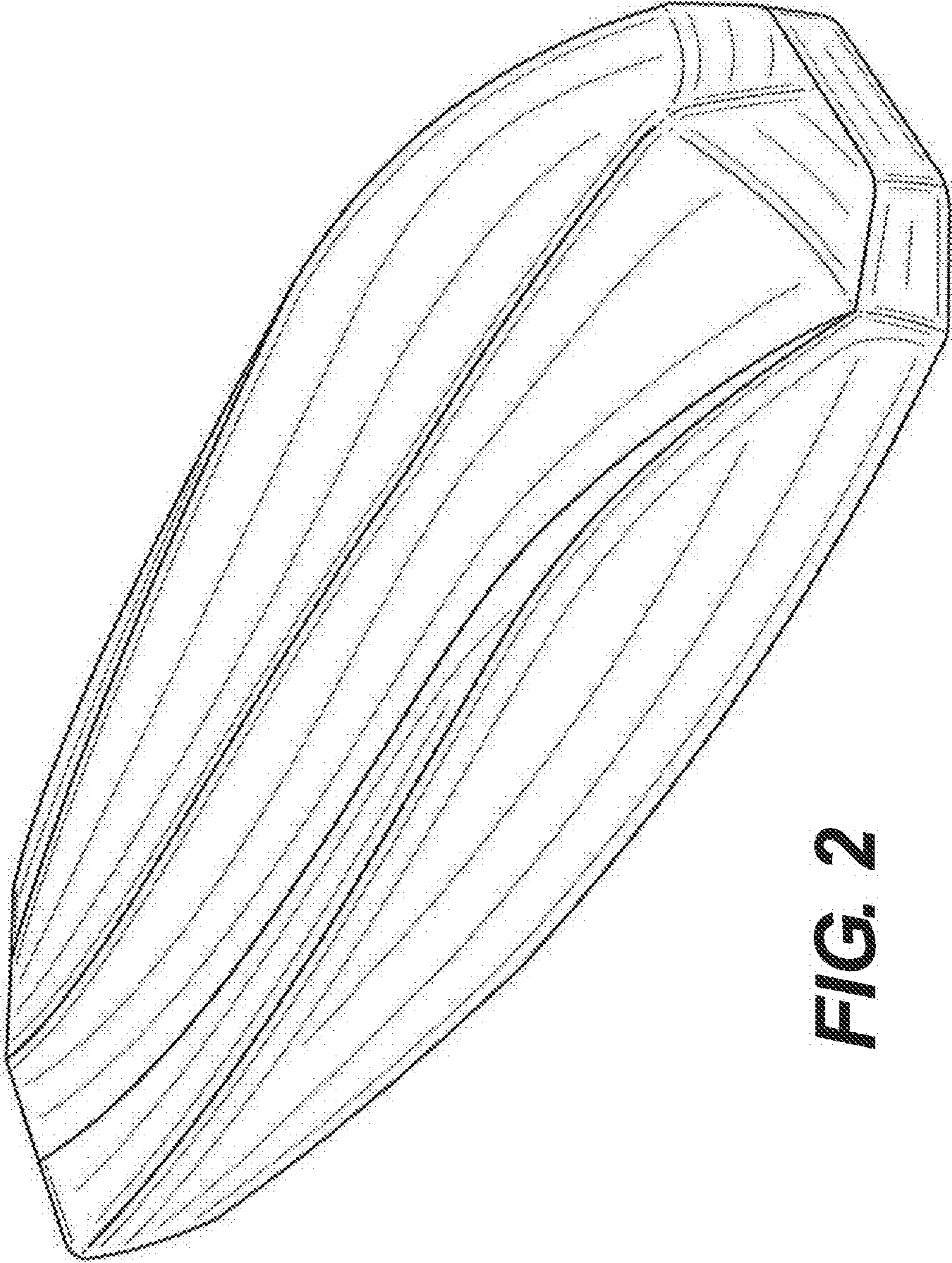

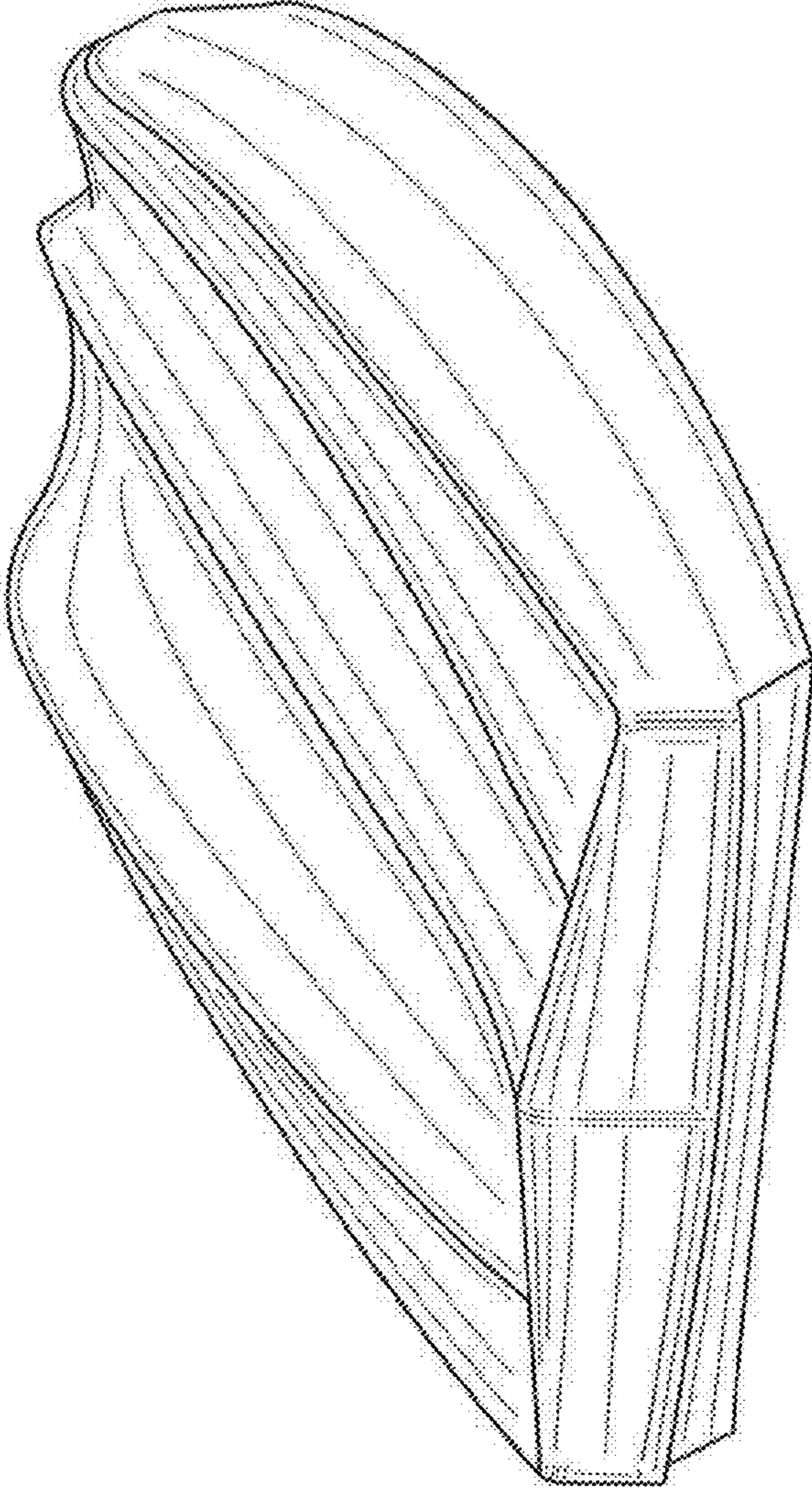

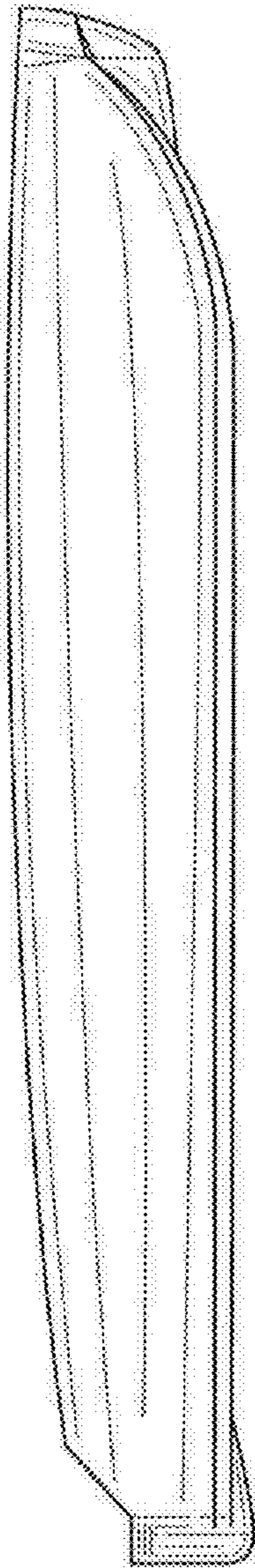

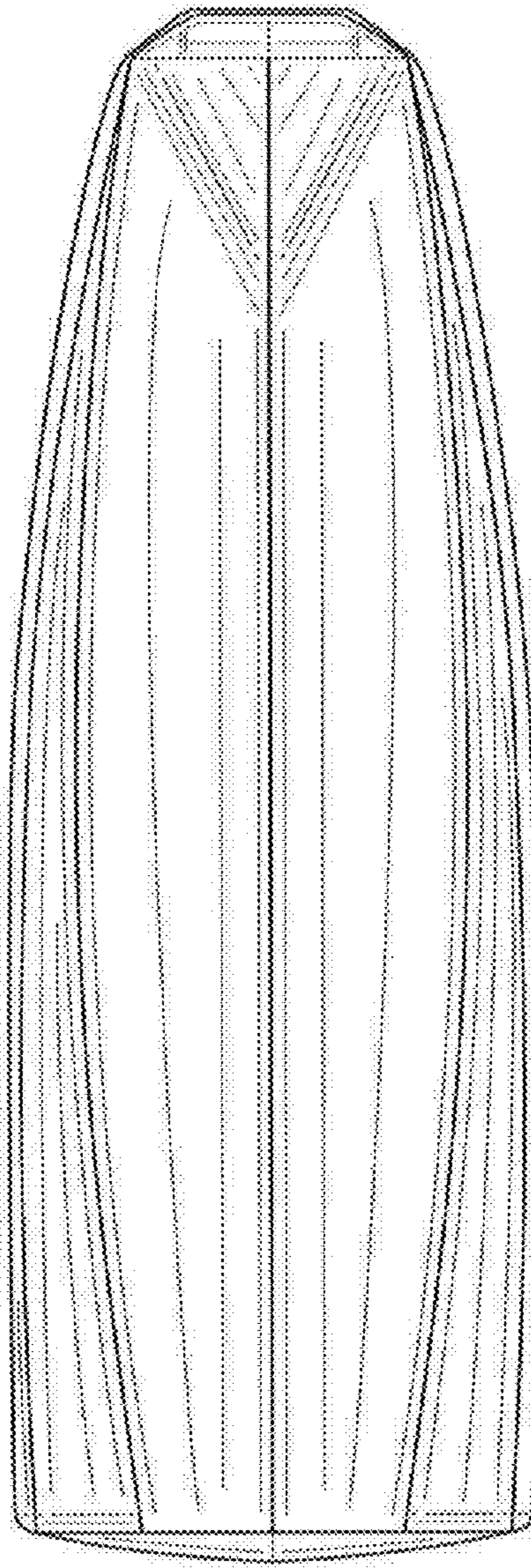

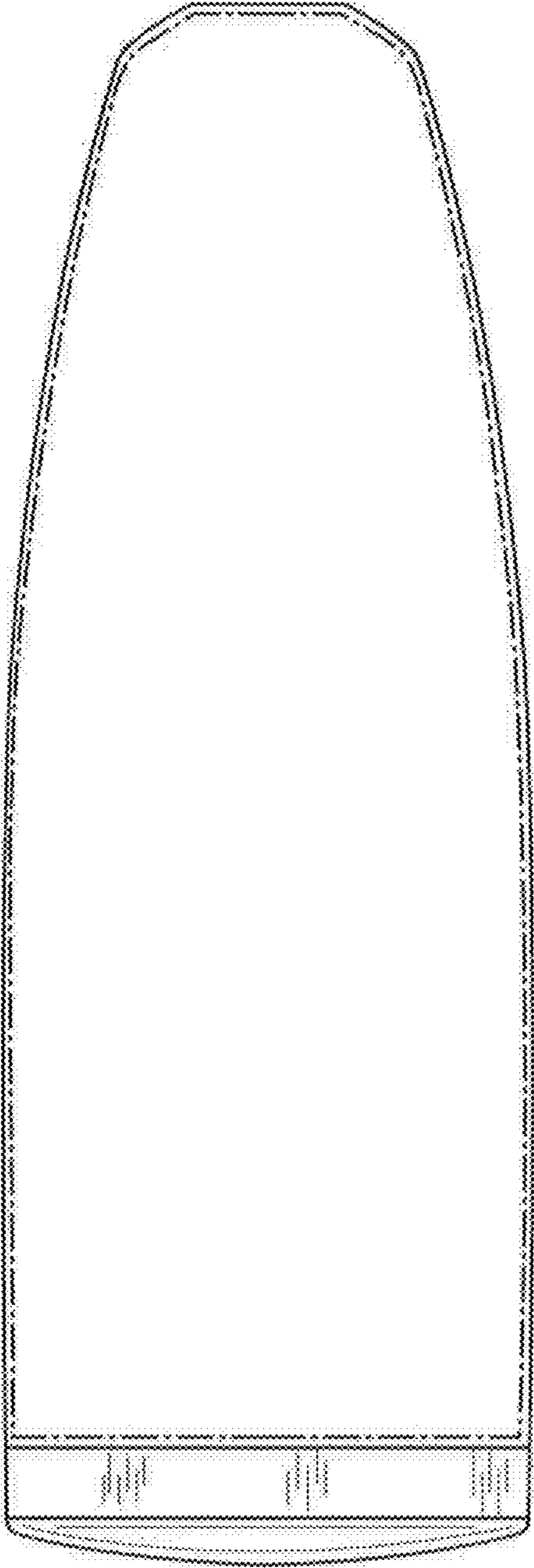

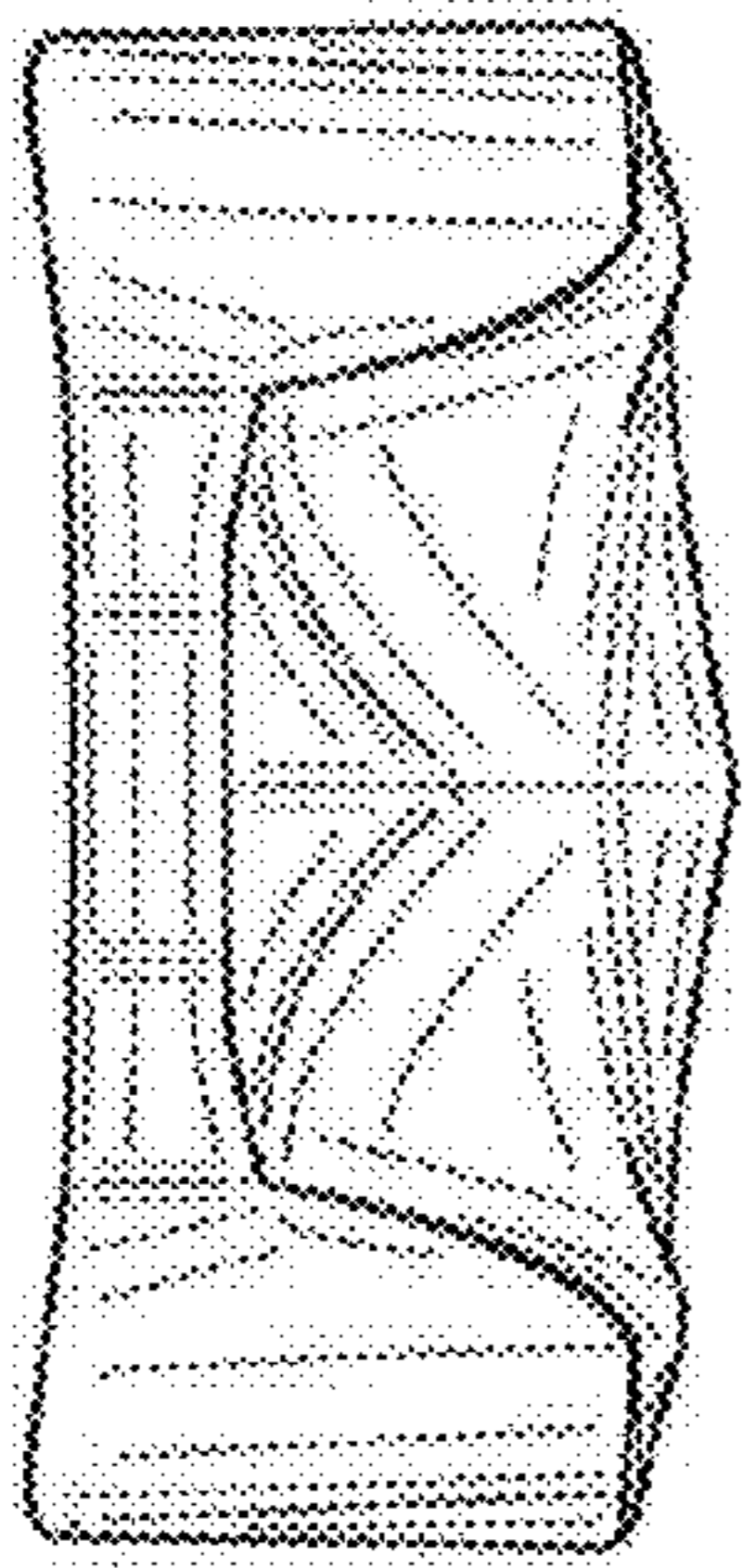

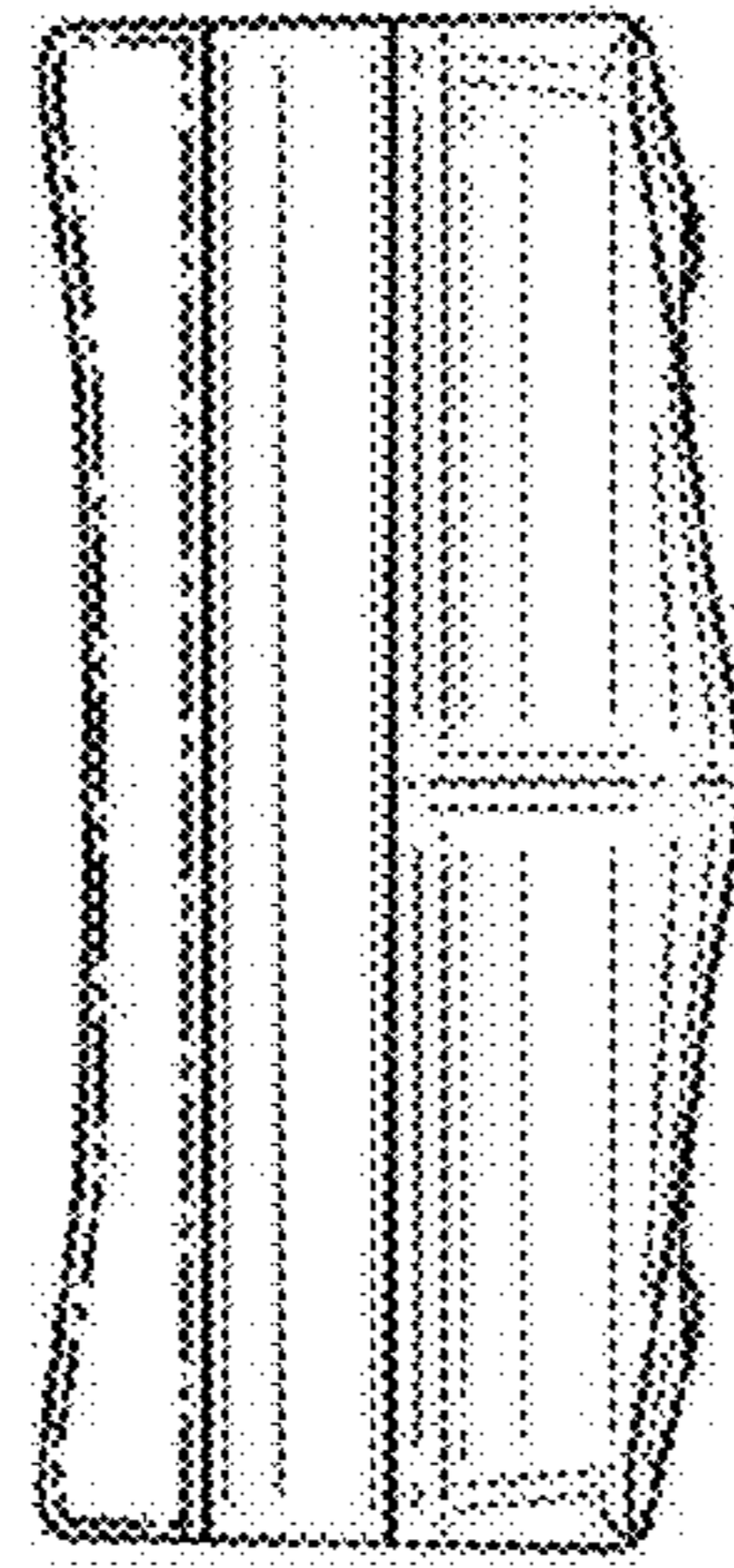

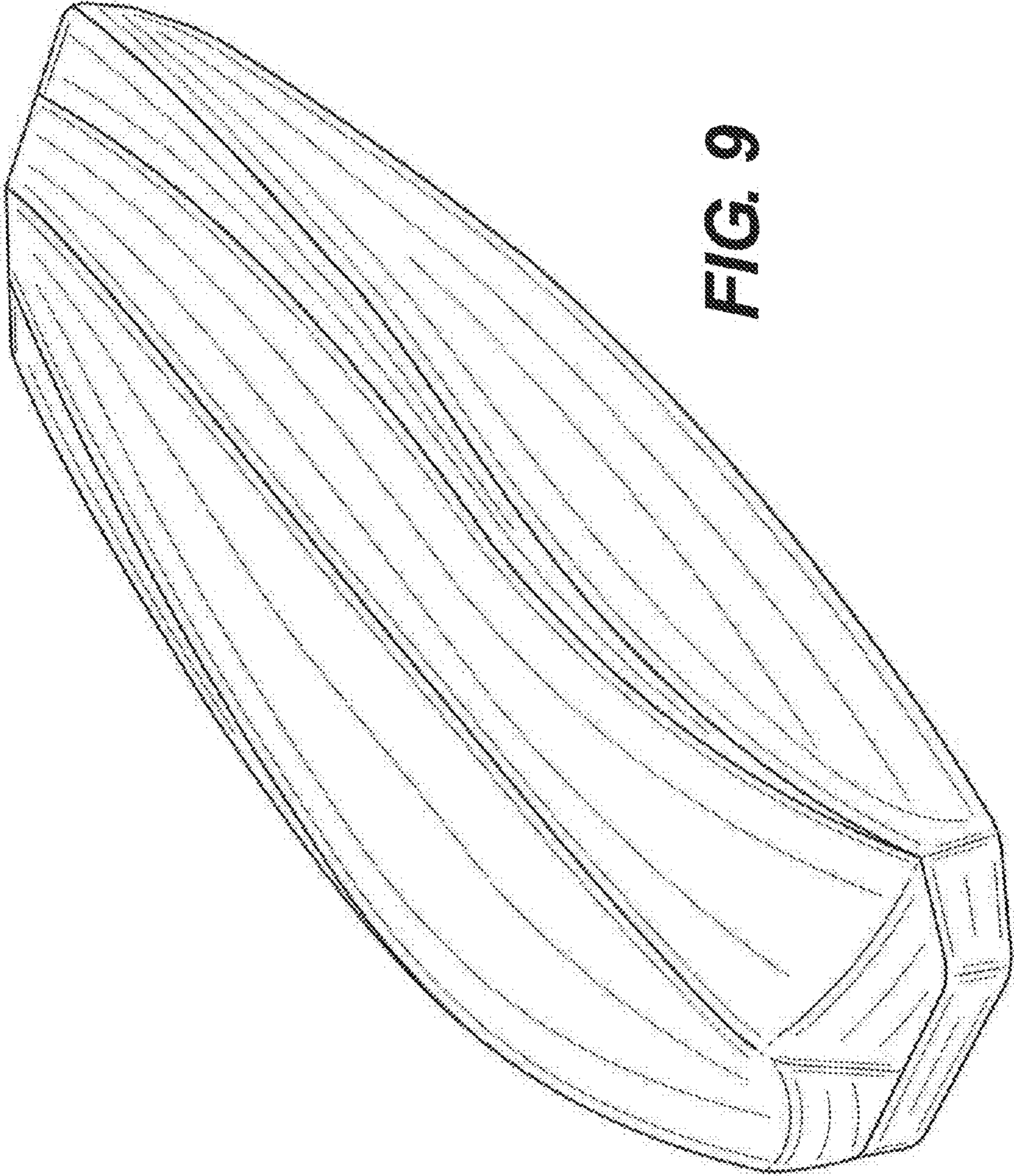

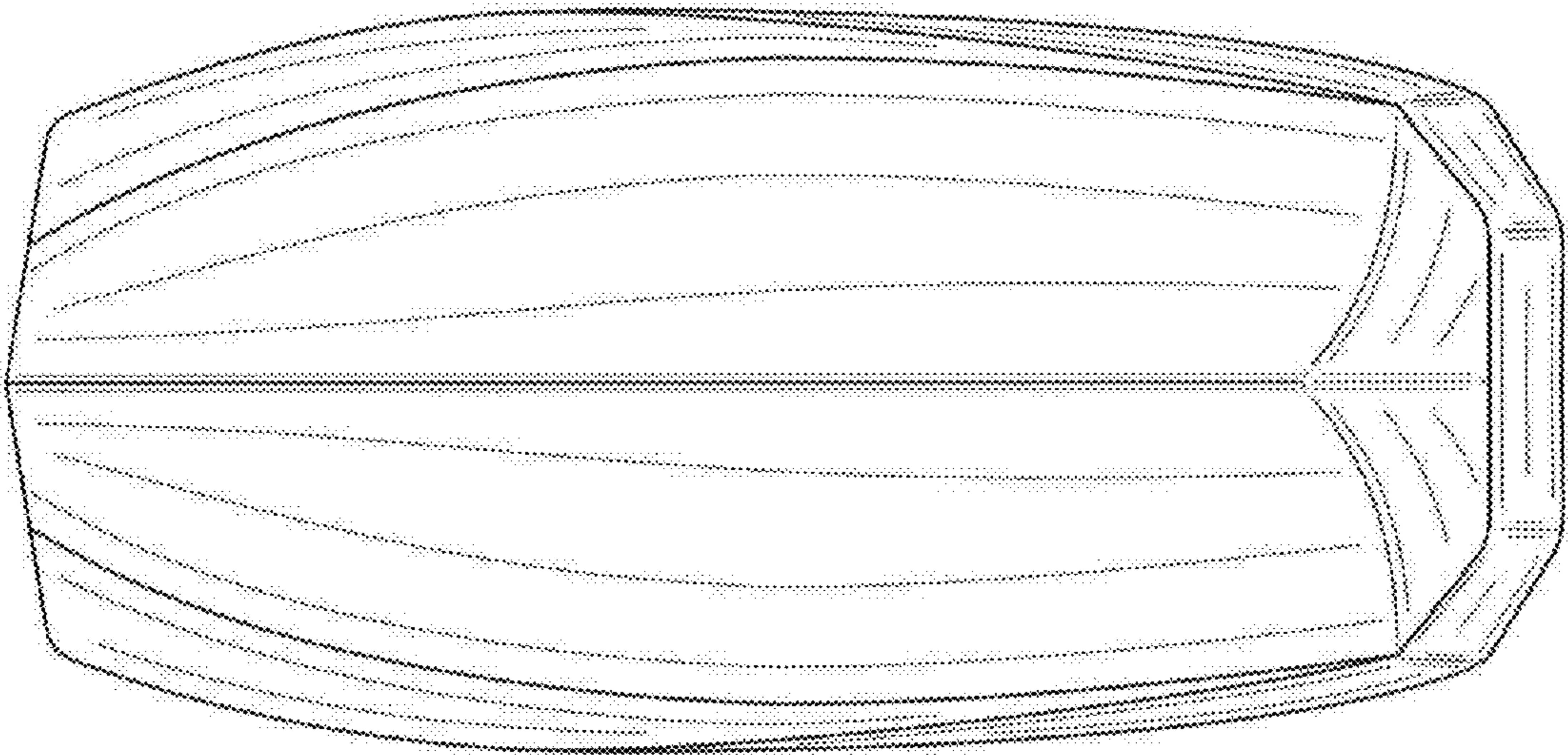

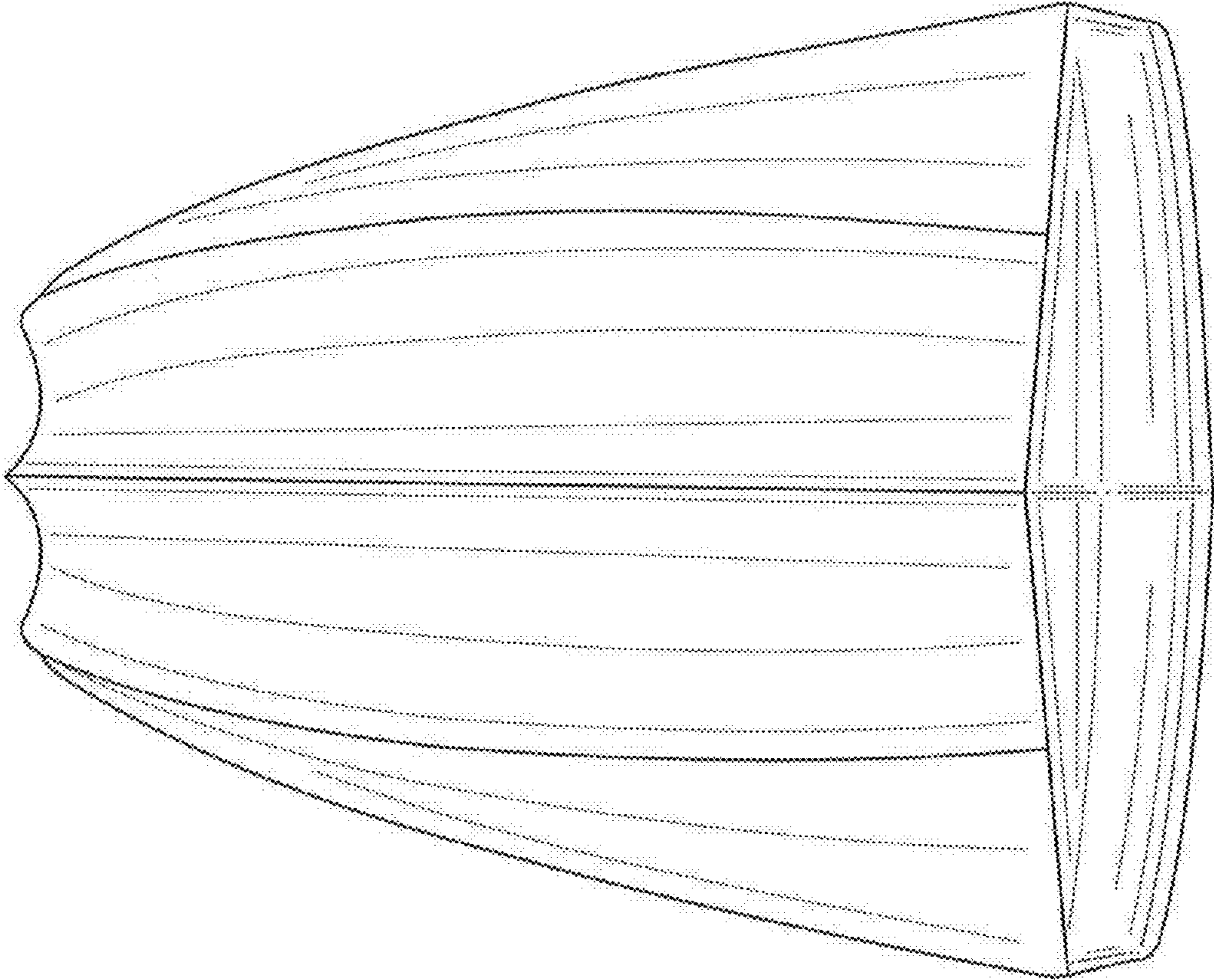

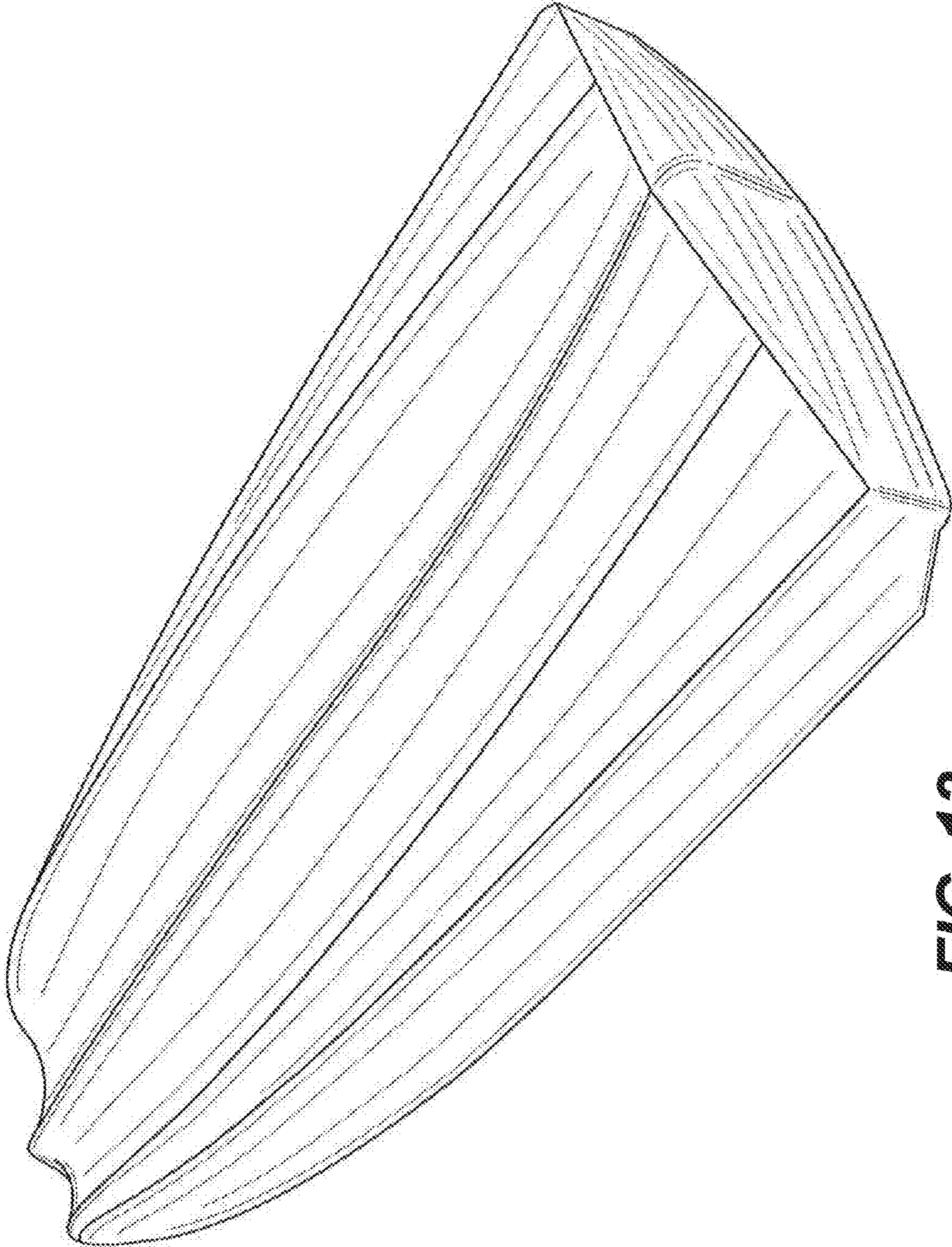

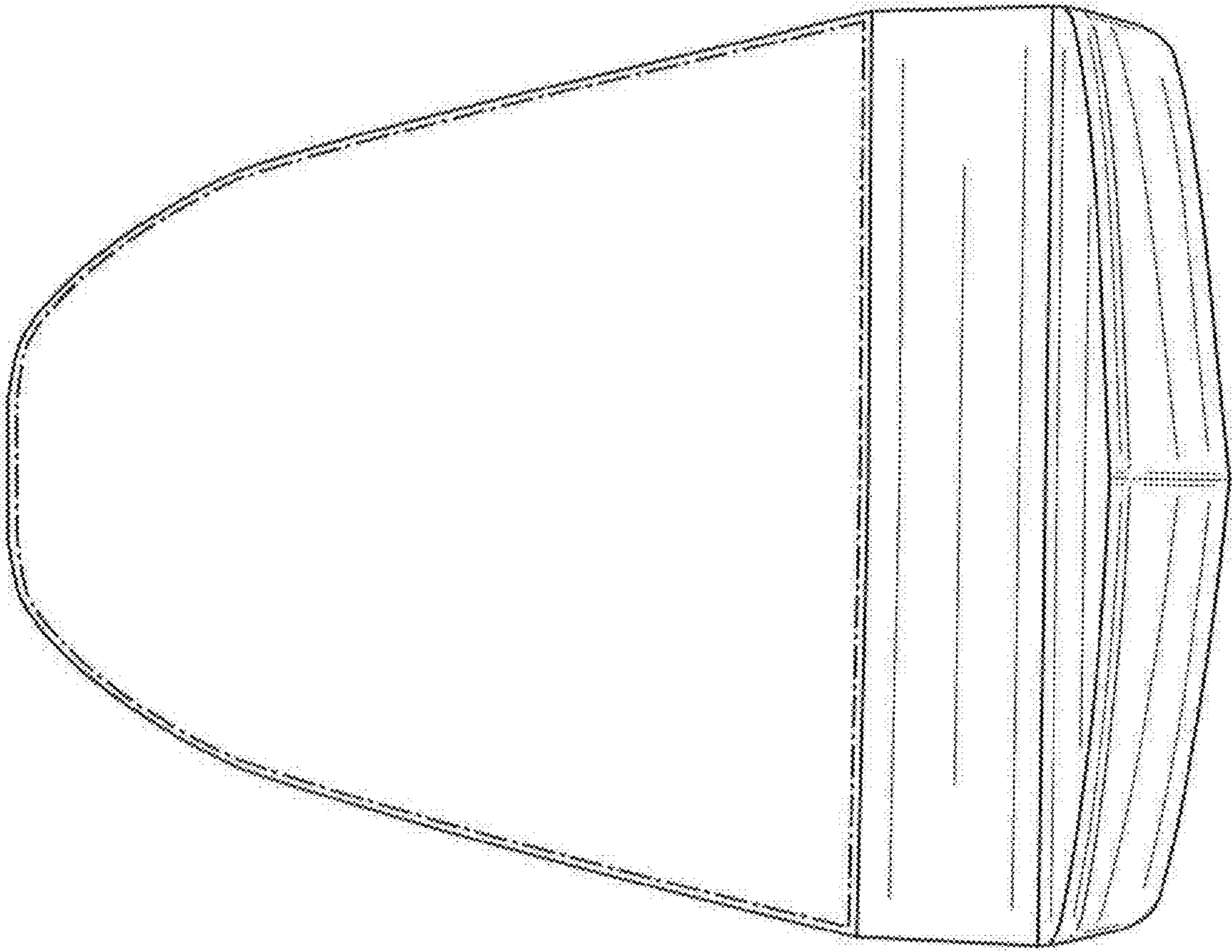
