(57) **CLAIM**

The ornamental design for a releasable attachable holder for a computer tablet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the front, right and top of the releasable attachable holder for a computer tablet showing my new design;

FIG. 2 is a perspective view showing the front, right and bottom of the releasable attachable holder for a computer tablet of FIG. 1;

FIG. 3 is a front view of the releasable attachable holder for a computer tablet of FIG. 1;

FIG. 4 is a top view of the releasable attachable holder for a computer tablet of FIG. 1;

FIG. 5 is a right view of the releasable attachable holder for a computer tablet of FIG. 1, the left side view being a mirror image thereof;

FIG. 6 is a bottom view of the releasable attachable holder for a computer tablet of FIG. 1; and,

FIG. 7 is a rear view of the releasable attachable holder for a computer tablet of FIG. 1.

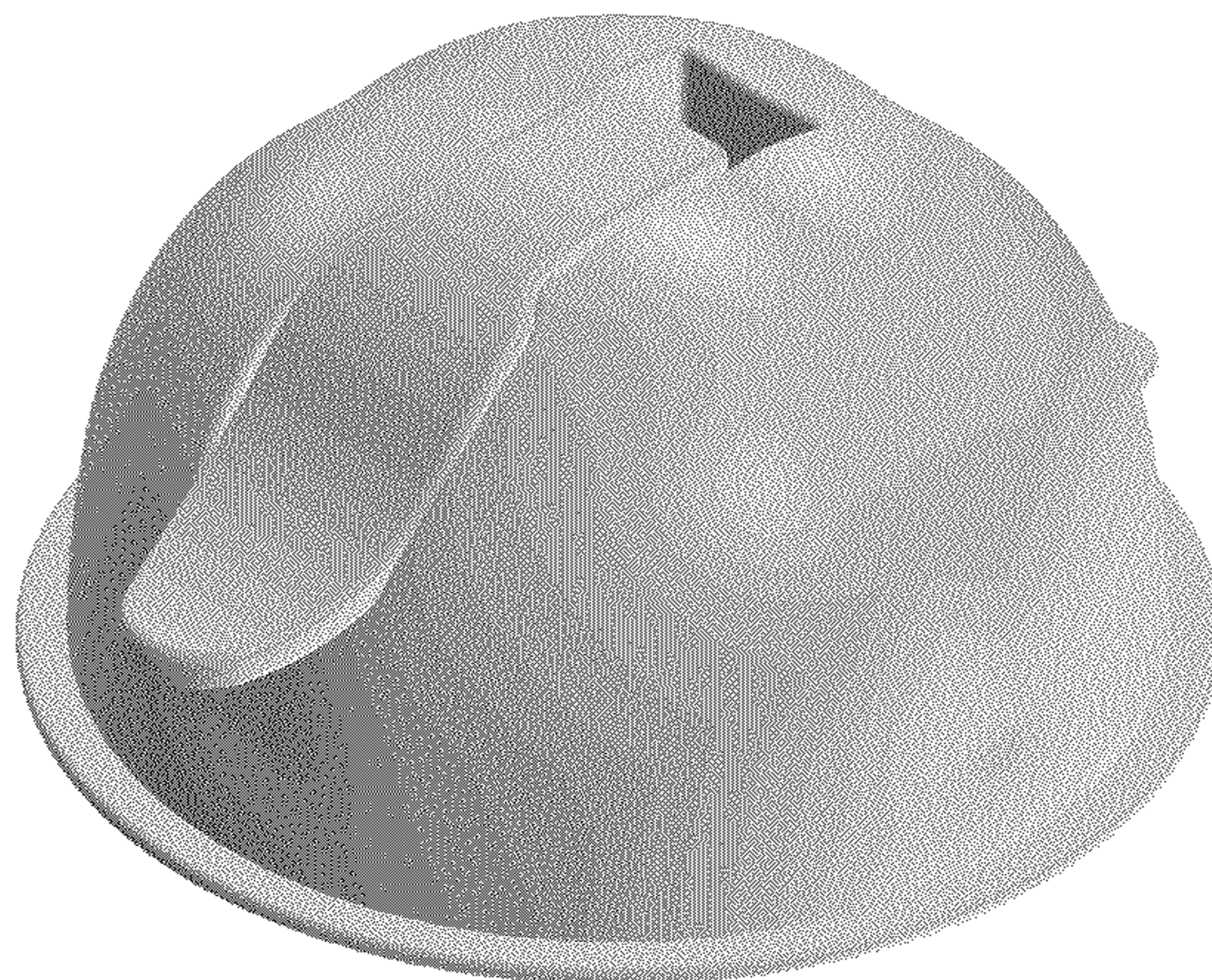

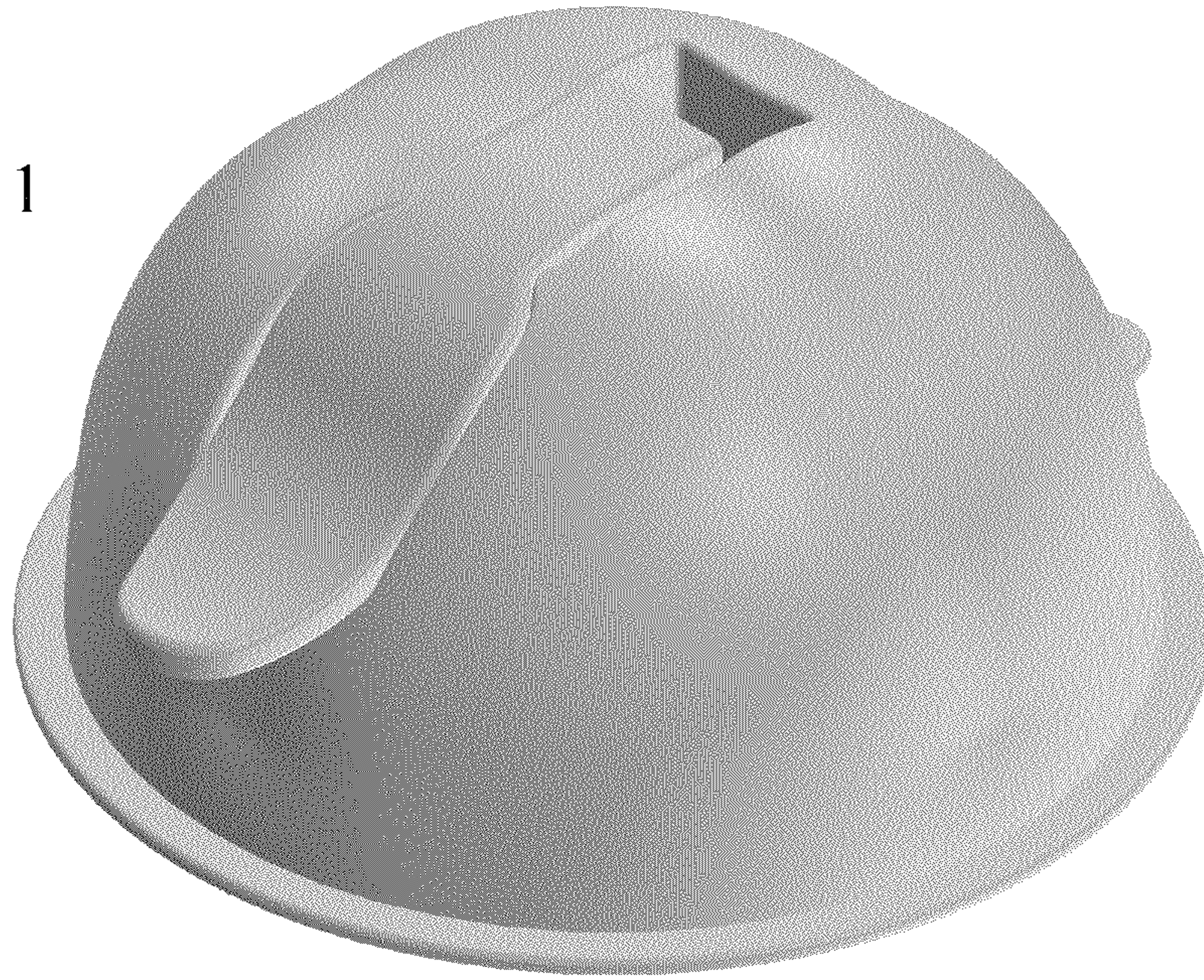

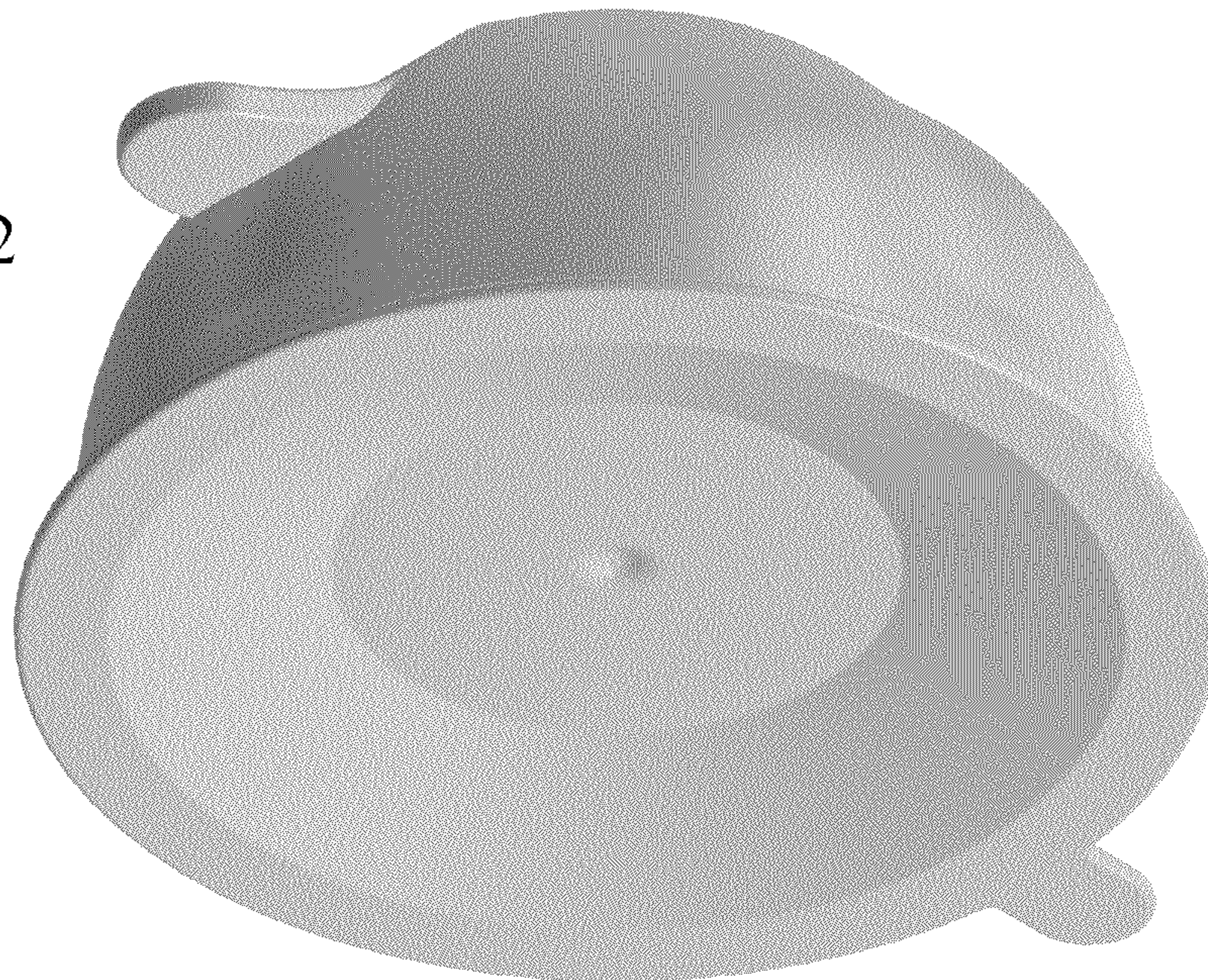

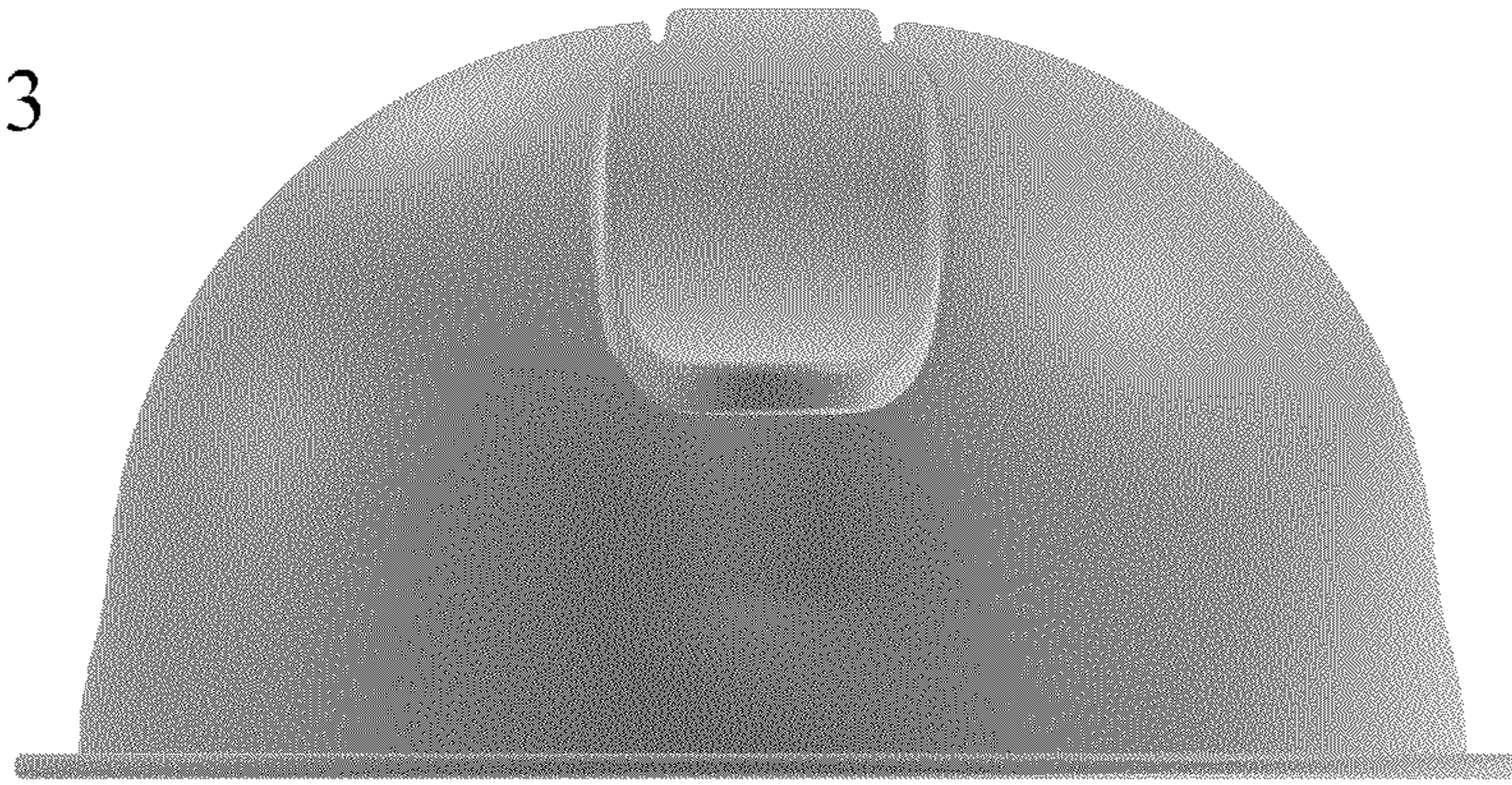

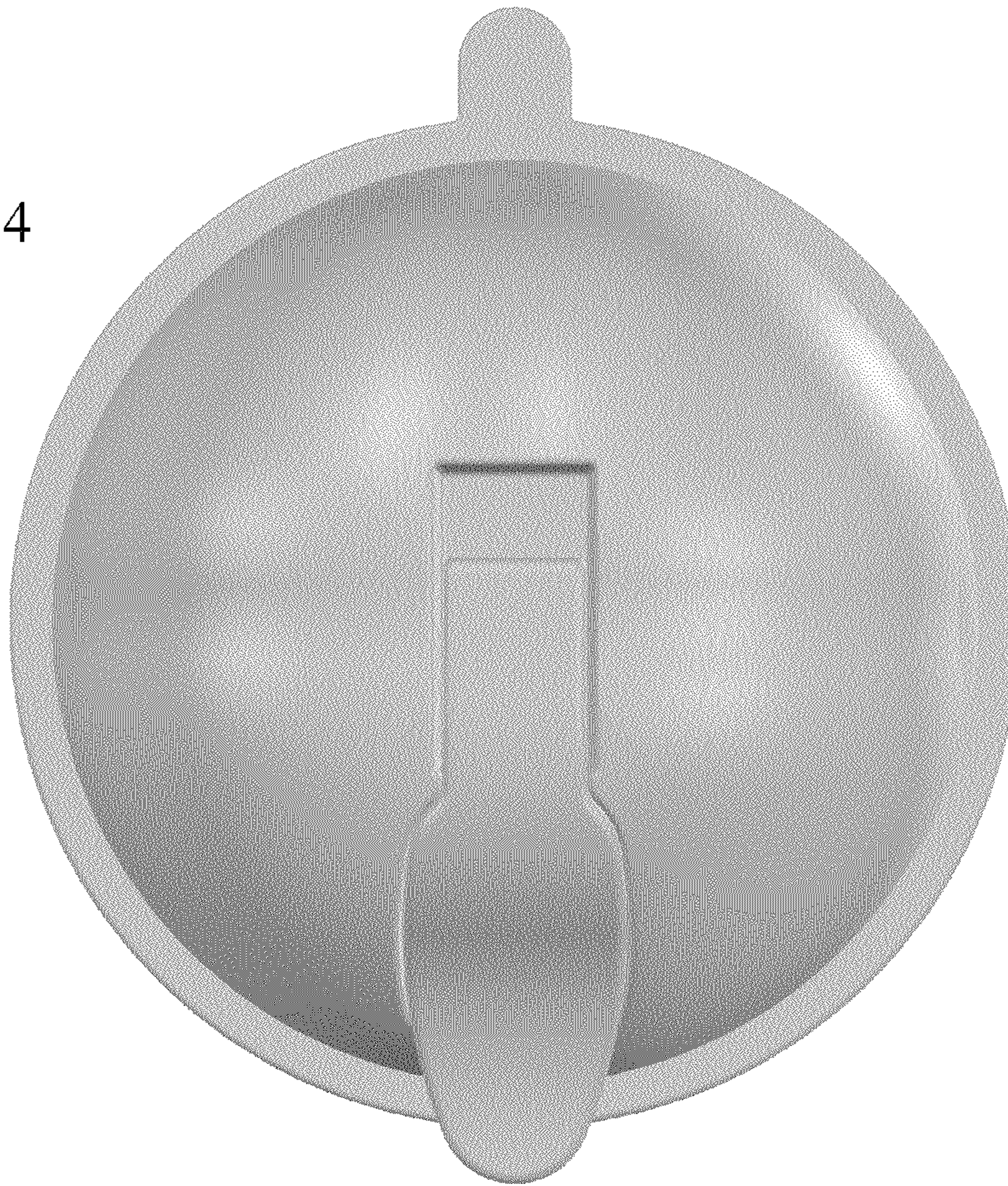

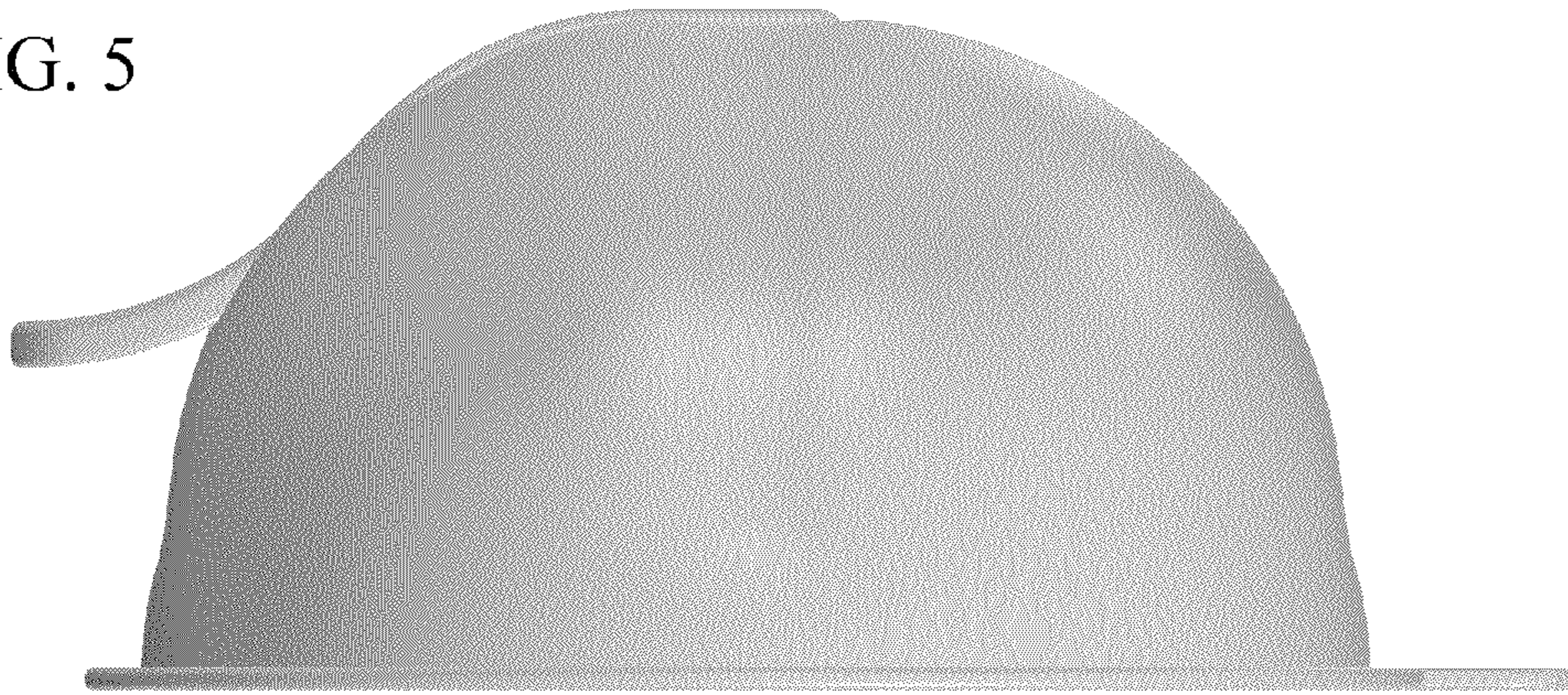

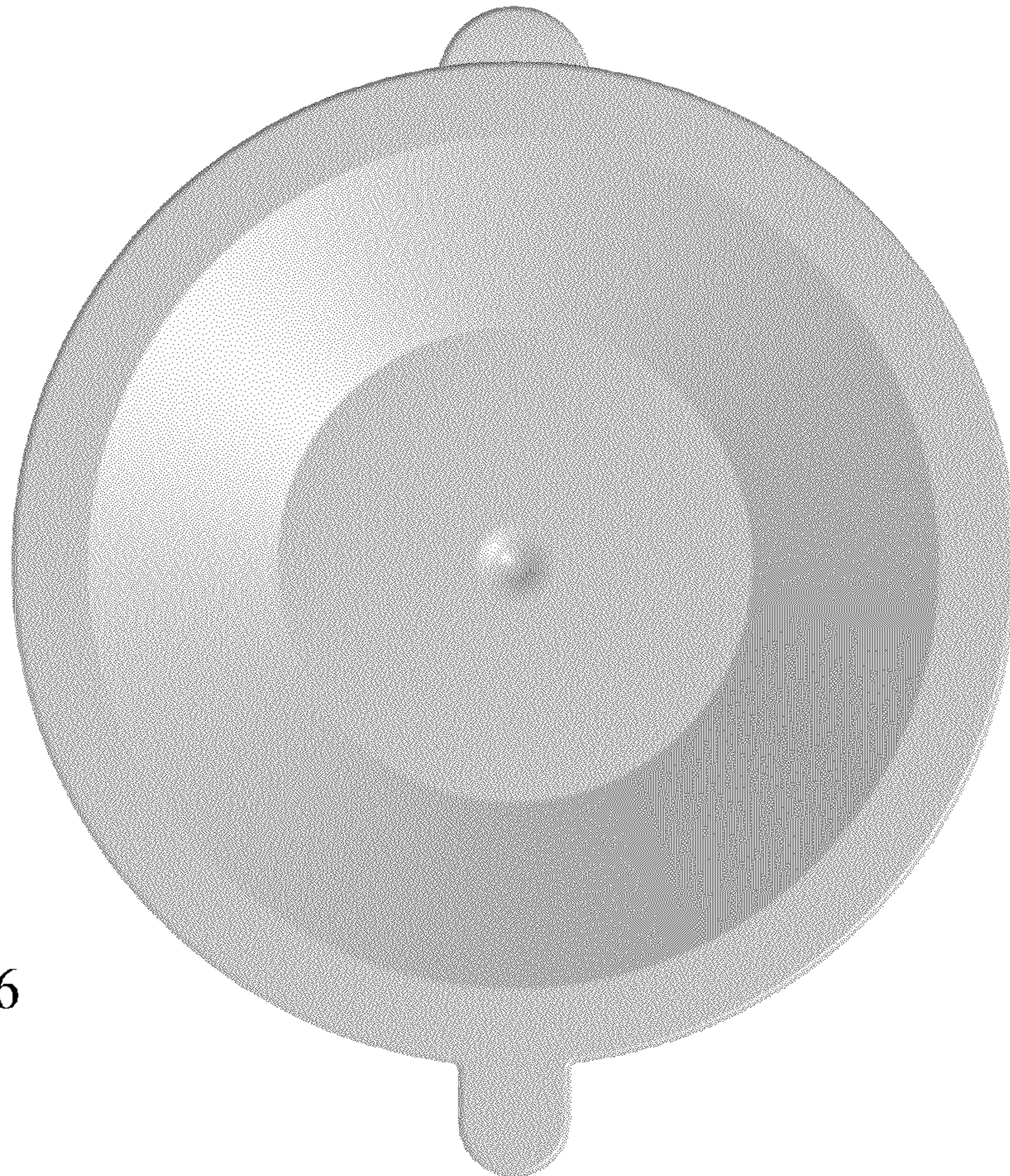
