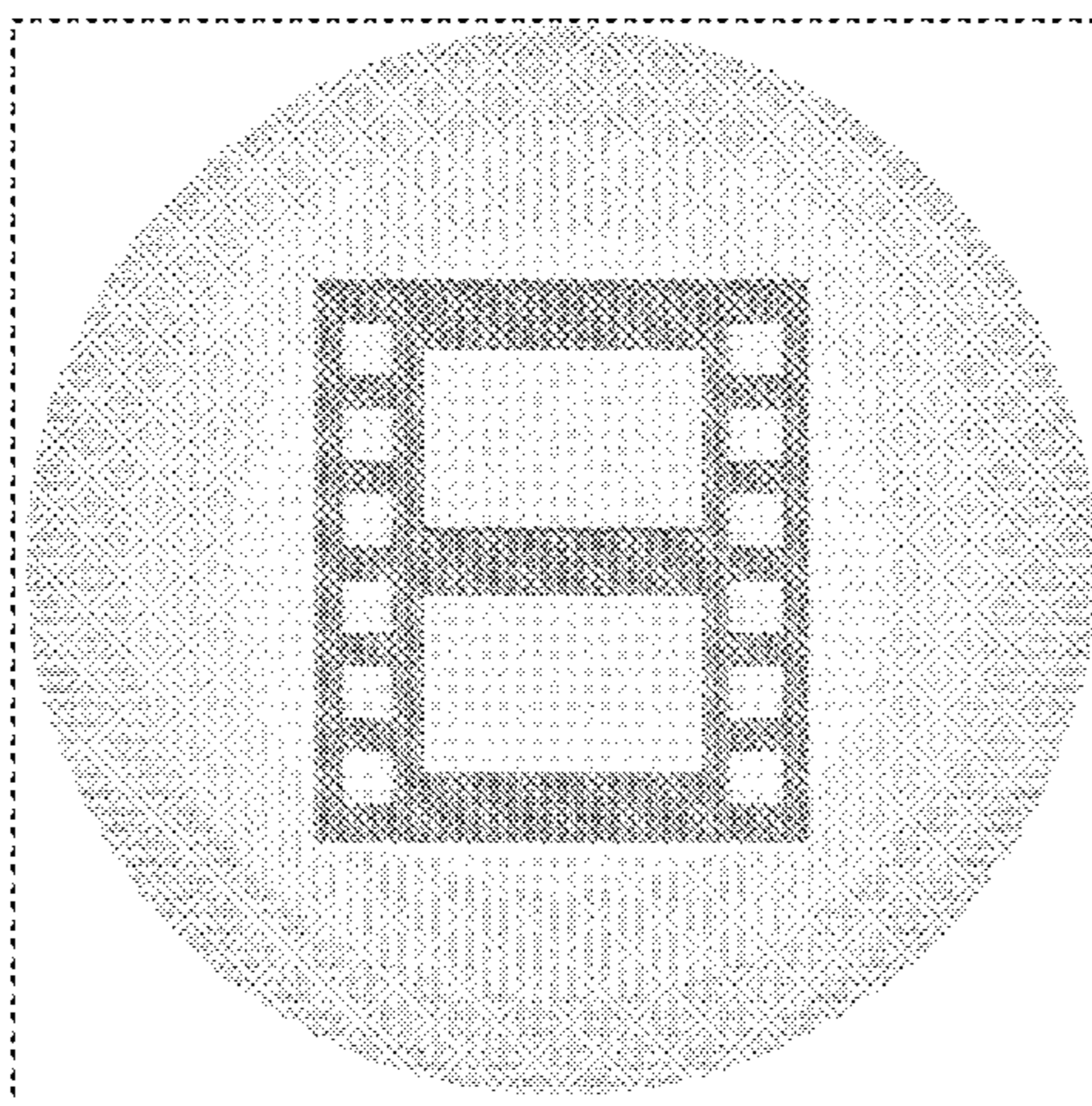
The ornamental design for a display screen with graphical user interface icon, as shown and described.
