The ornamental design for a lighting fixture, as shown and described.

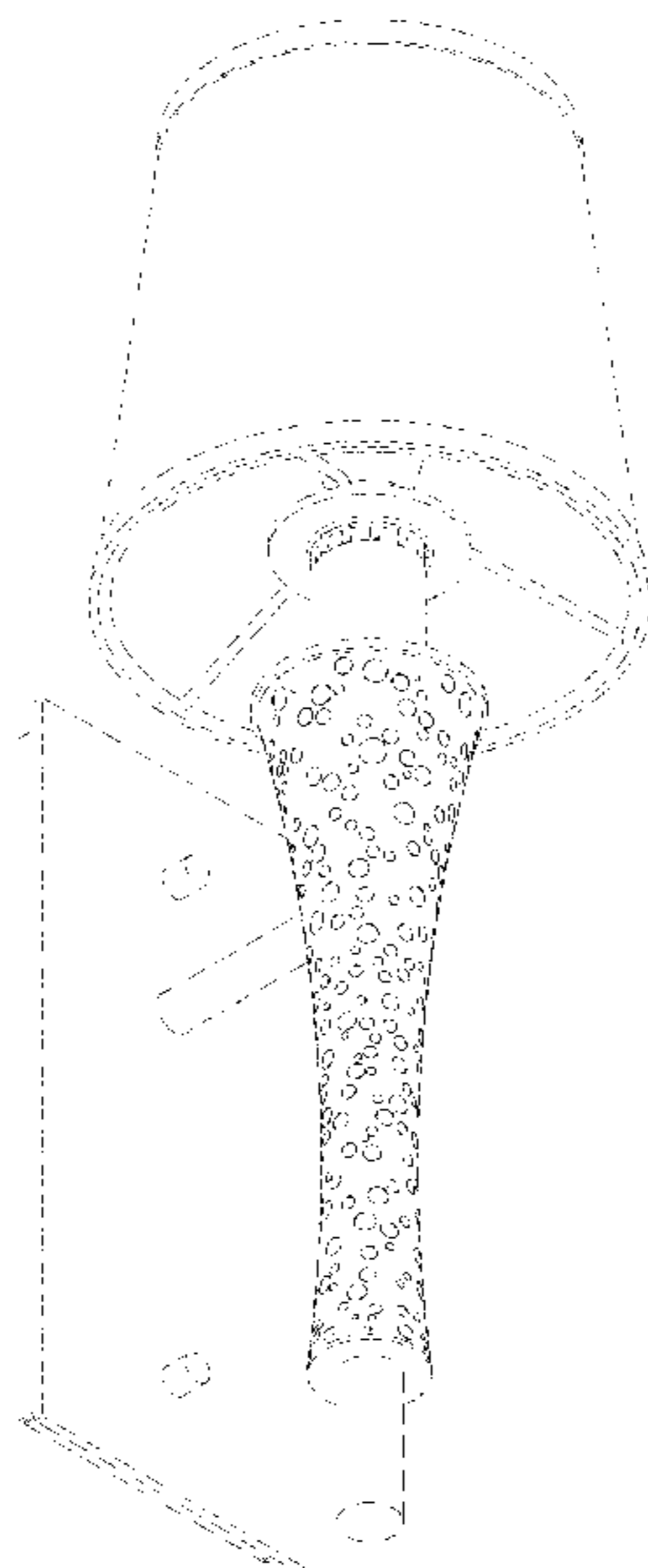

FIG. 1 is a perspective view of a lighting fixture in accordance with the new design;
FIG. 2 is a front elevational view thereof;

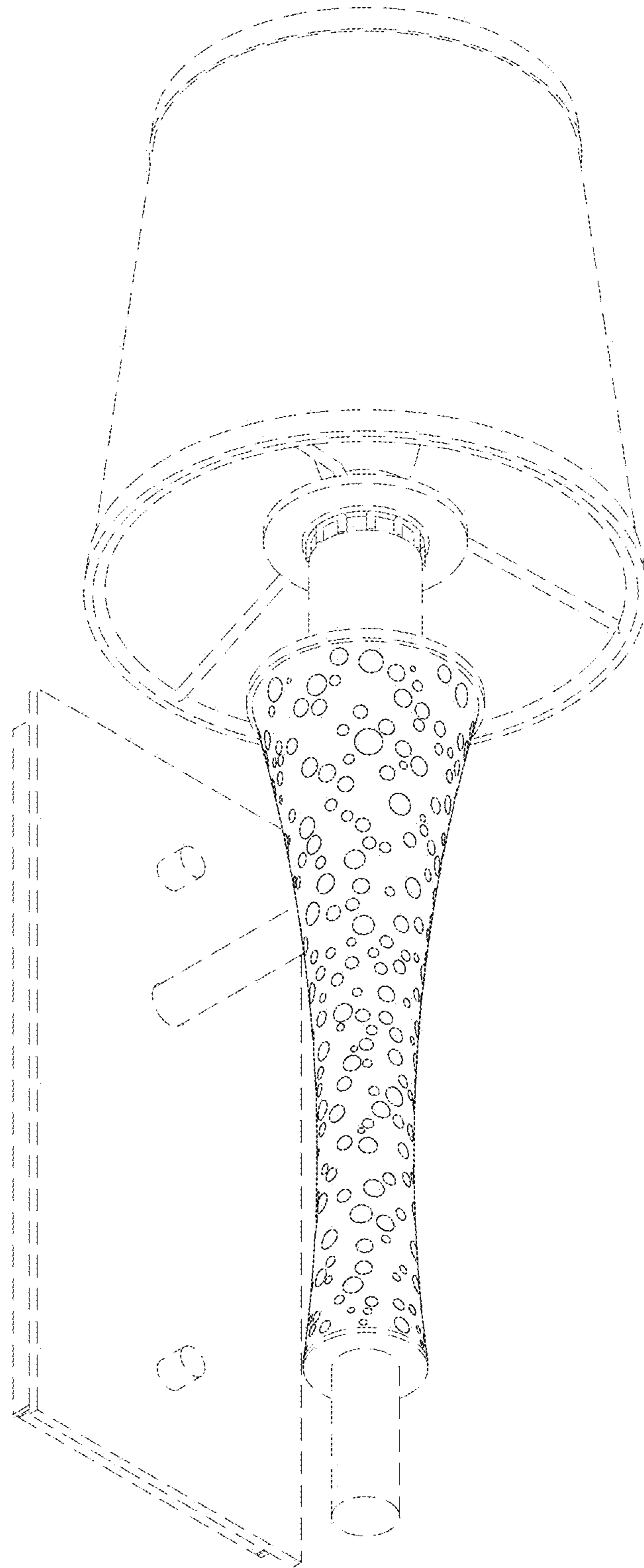

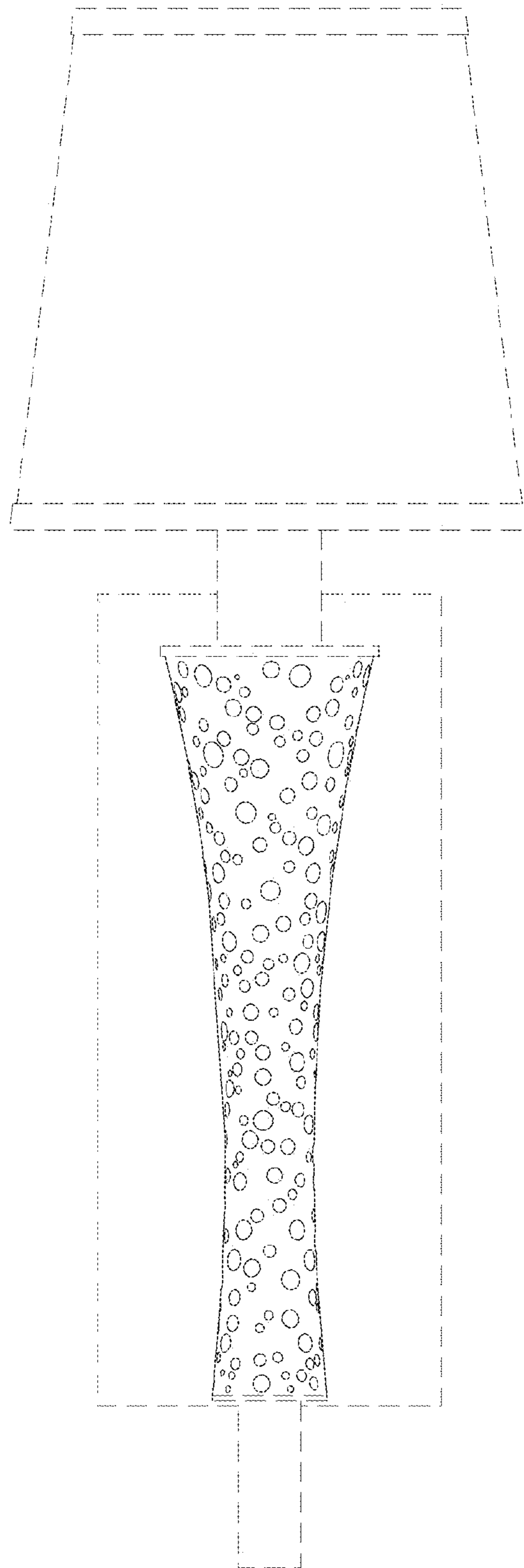

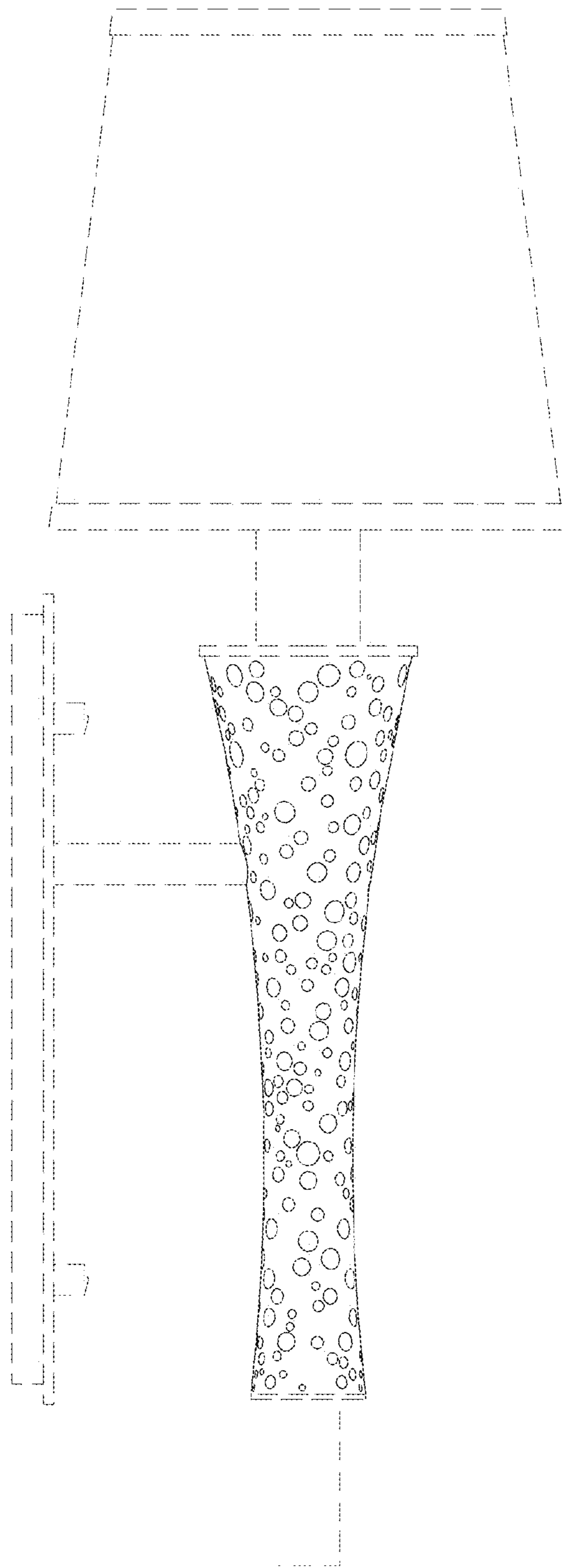

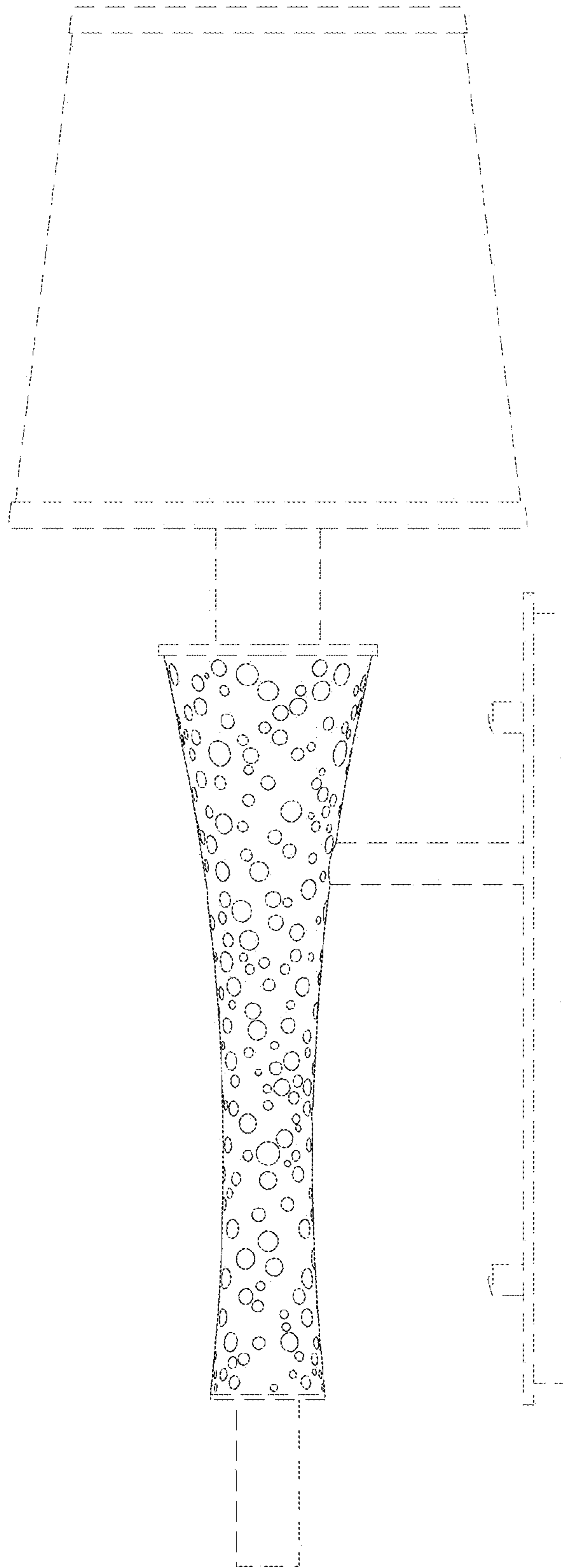

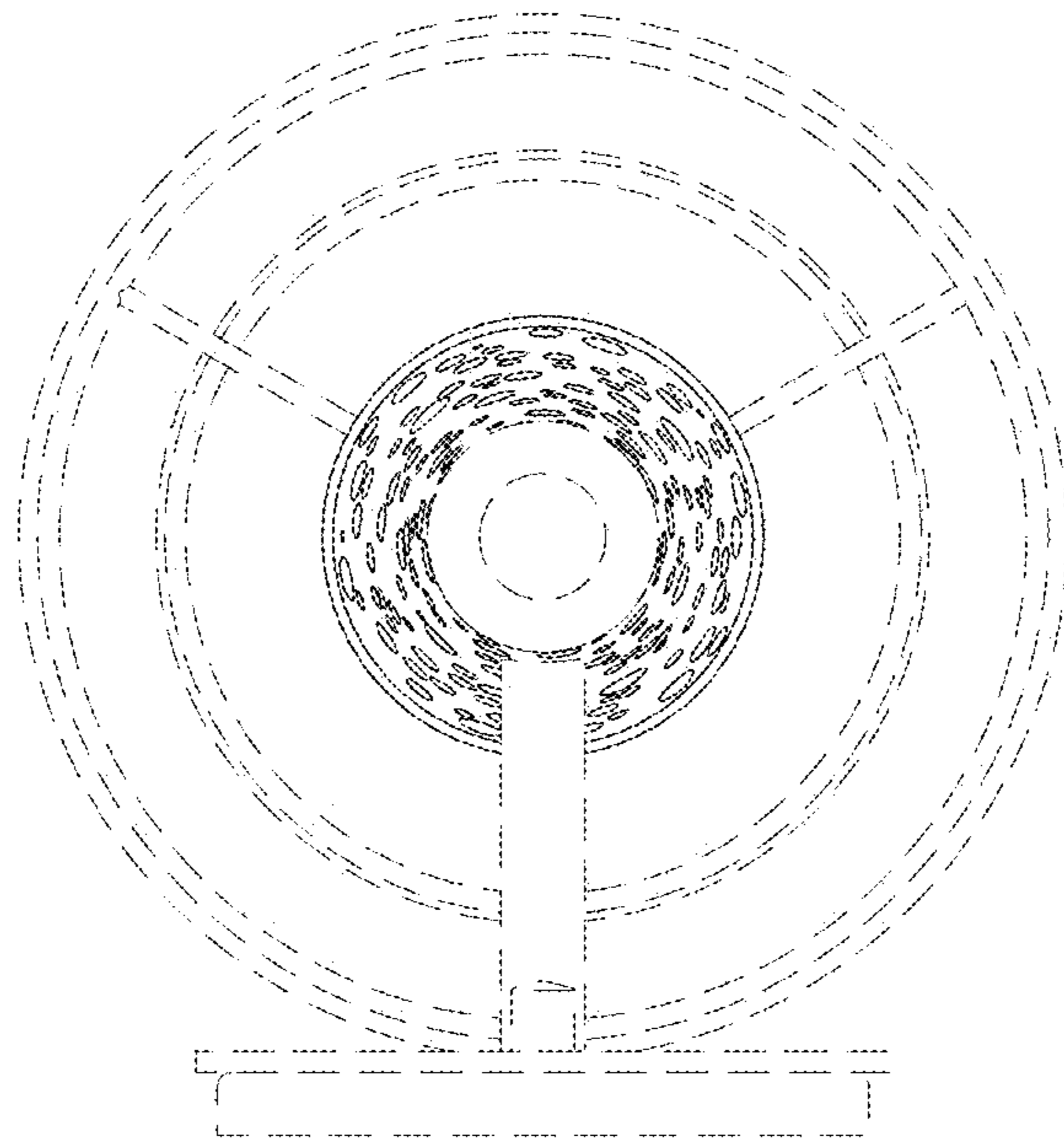
