(57) **CLAIM**

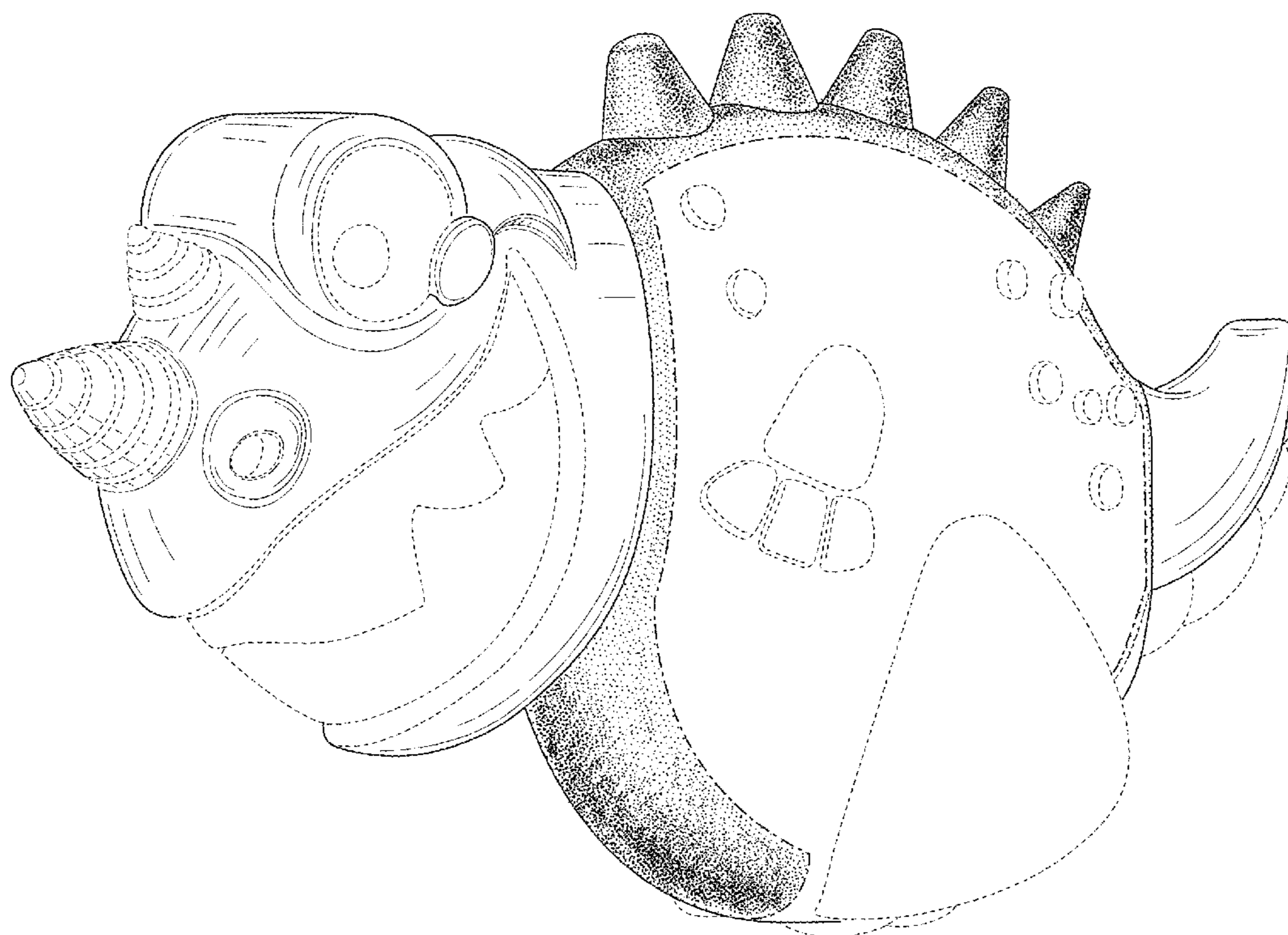
We claim the ornamental design for a pet chew toy, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pet chew toy;

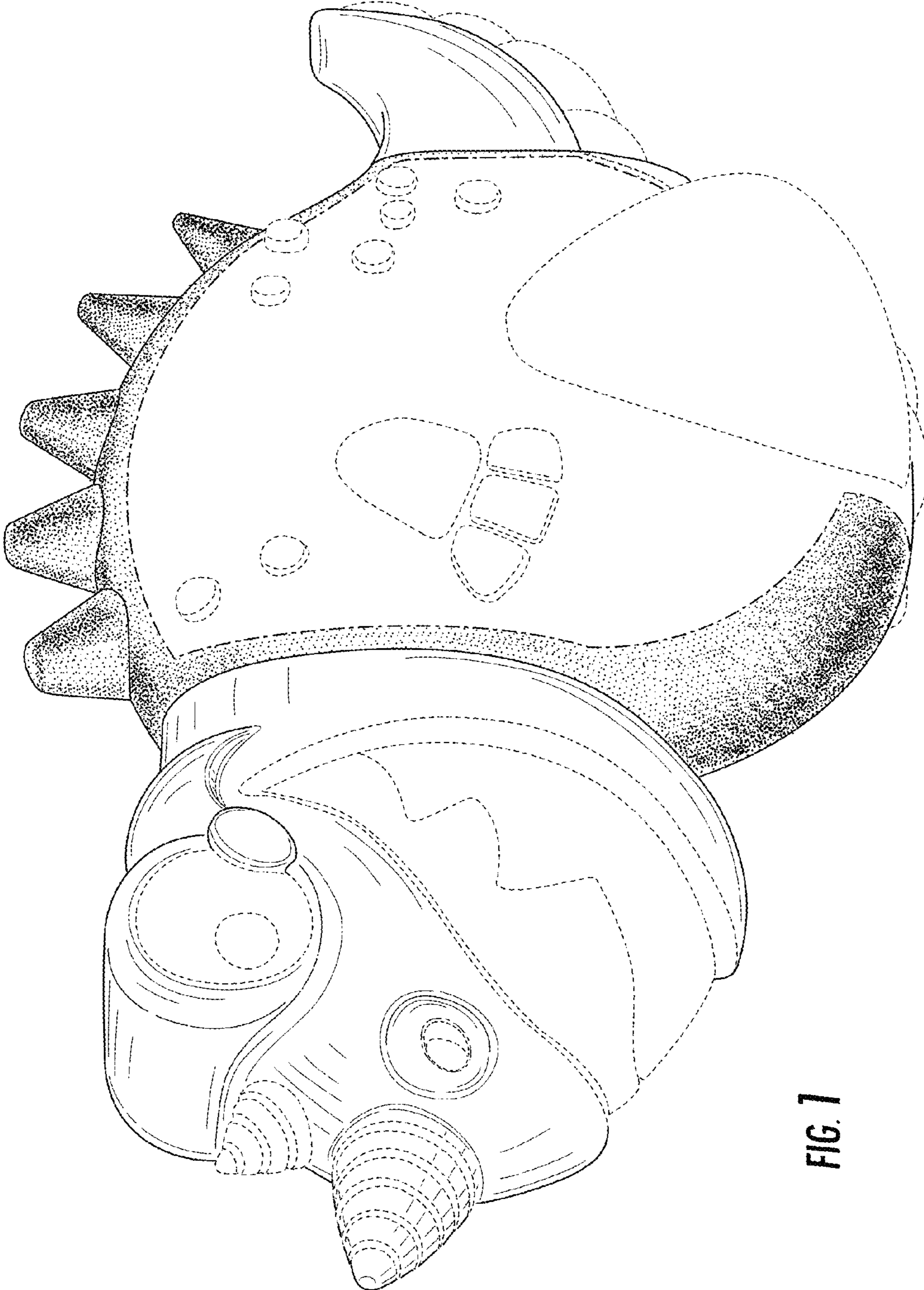

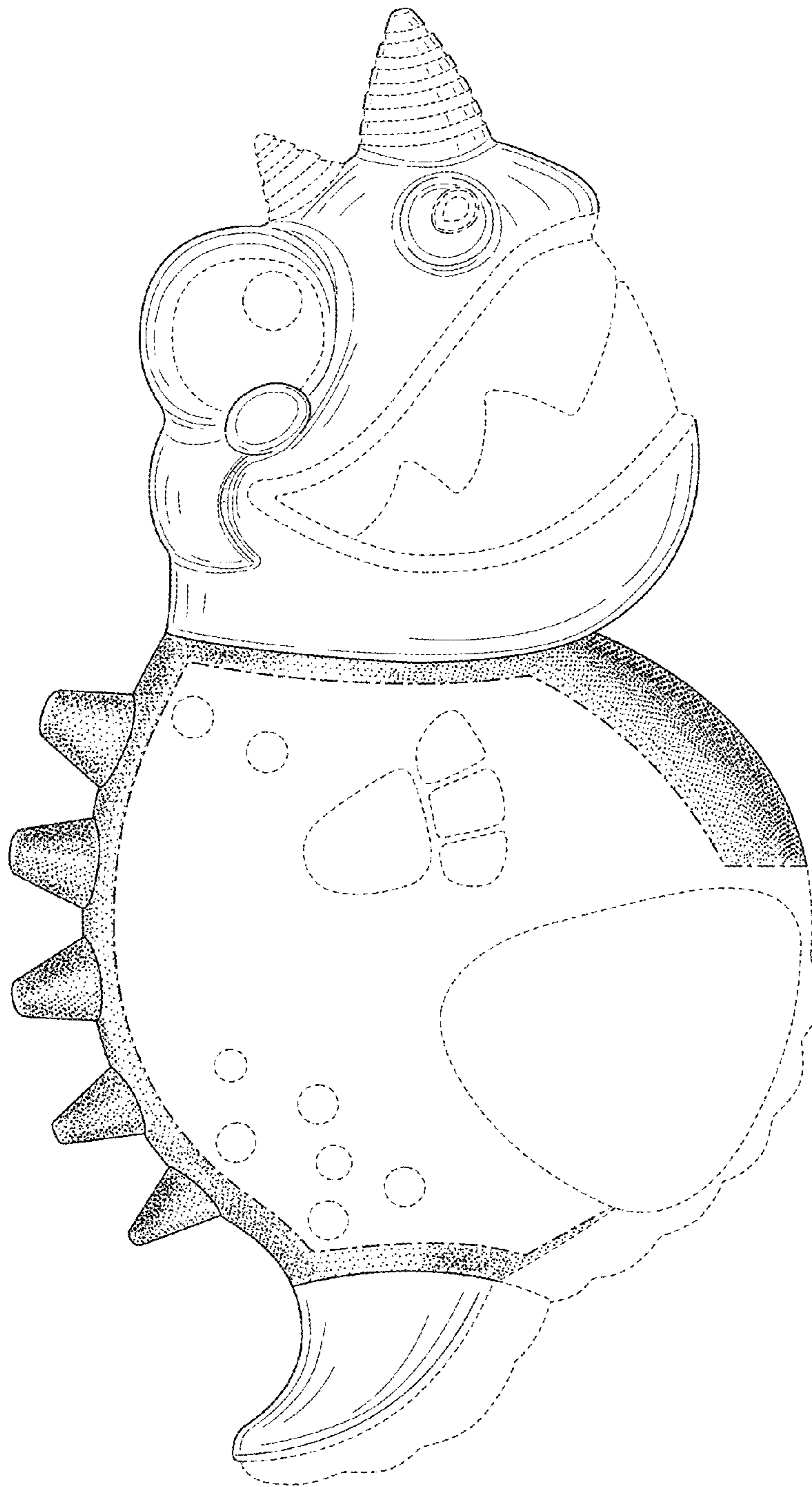

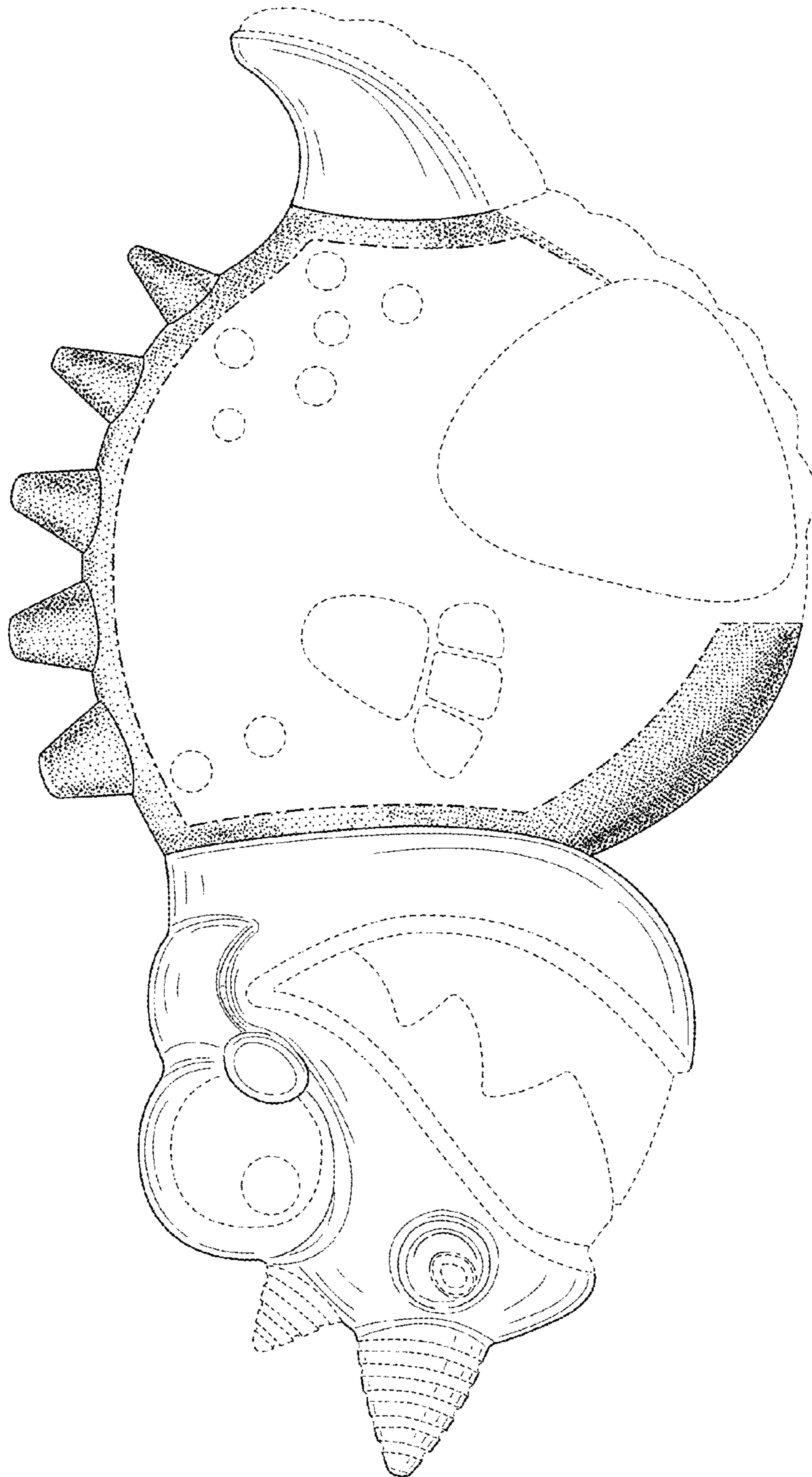

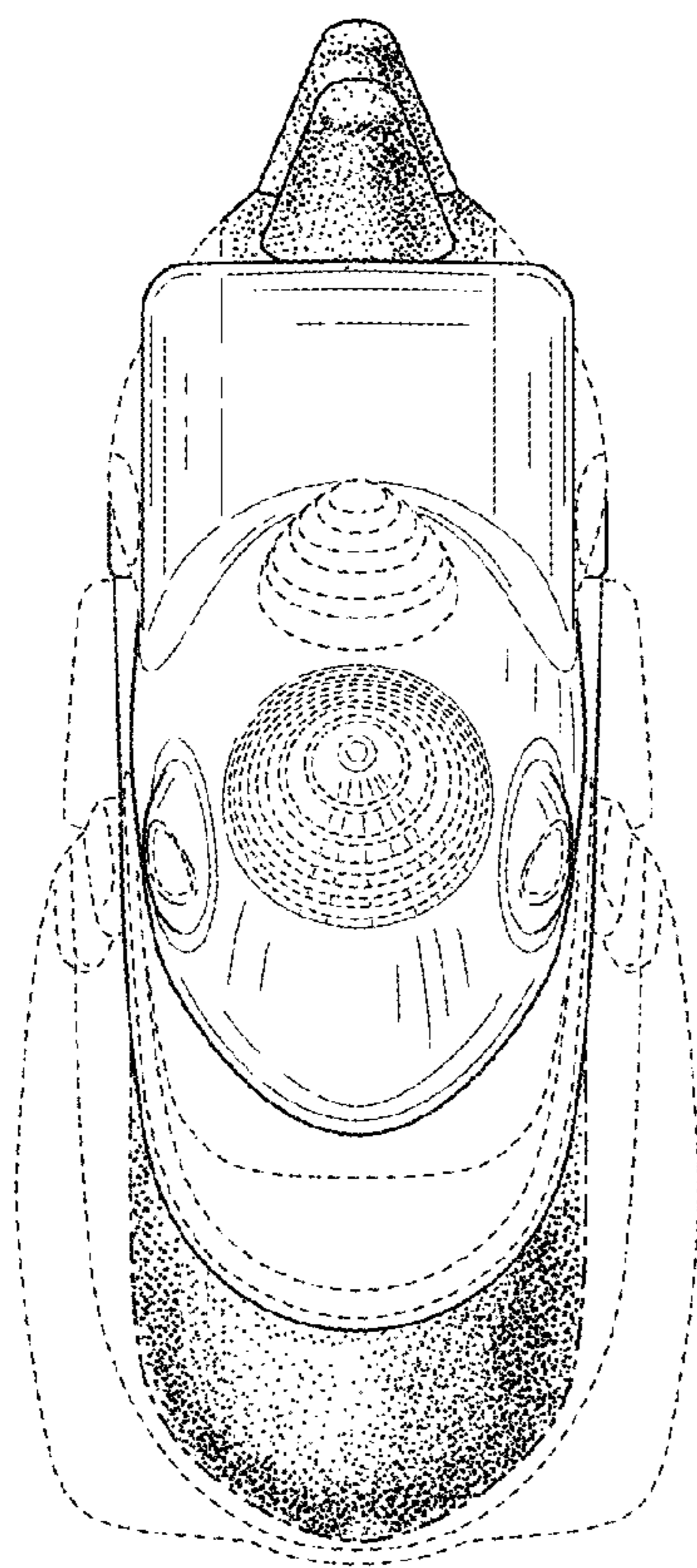

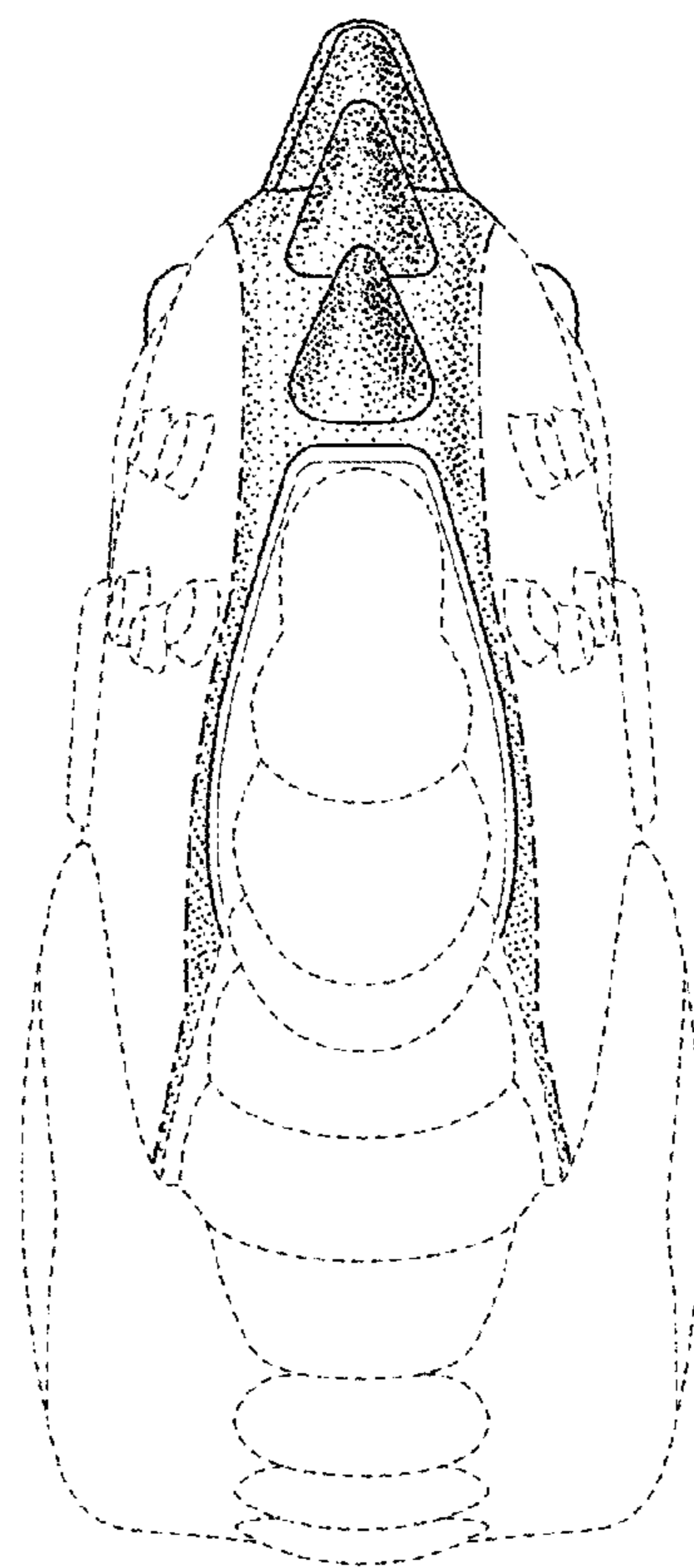

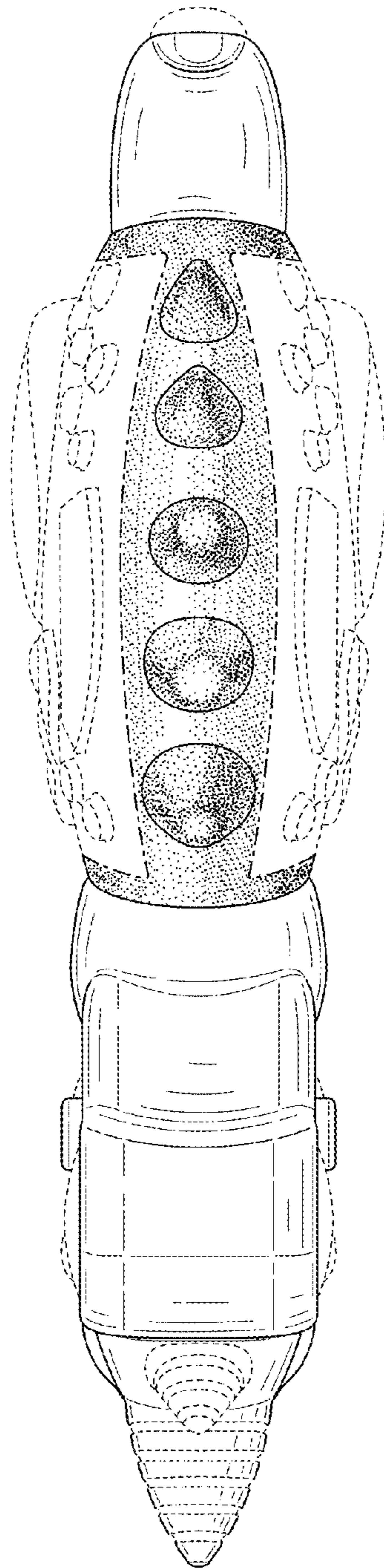

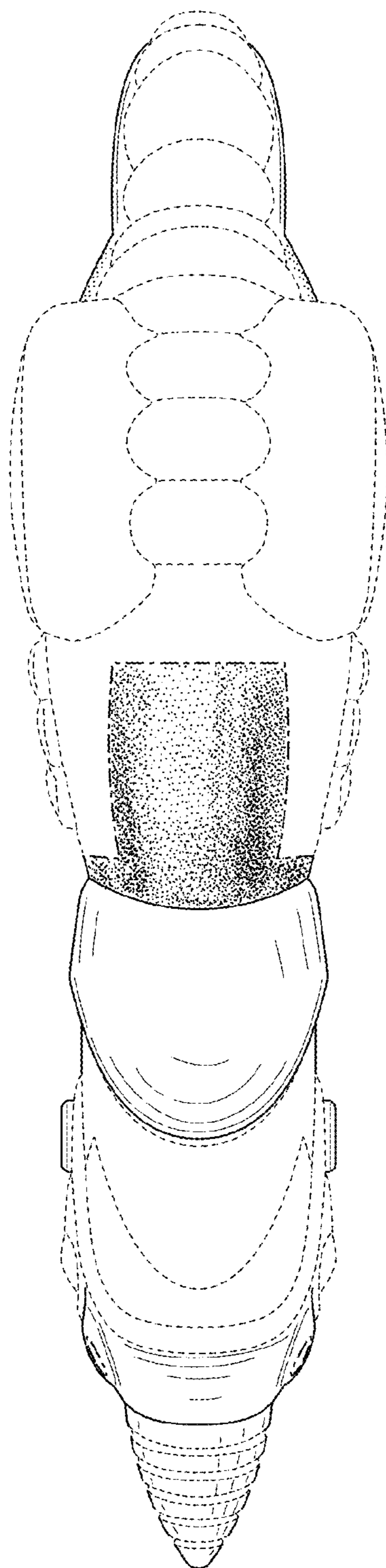
