**DESCRIPTION**

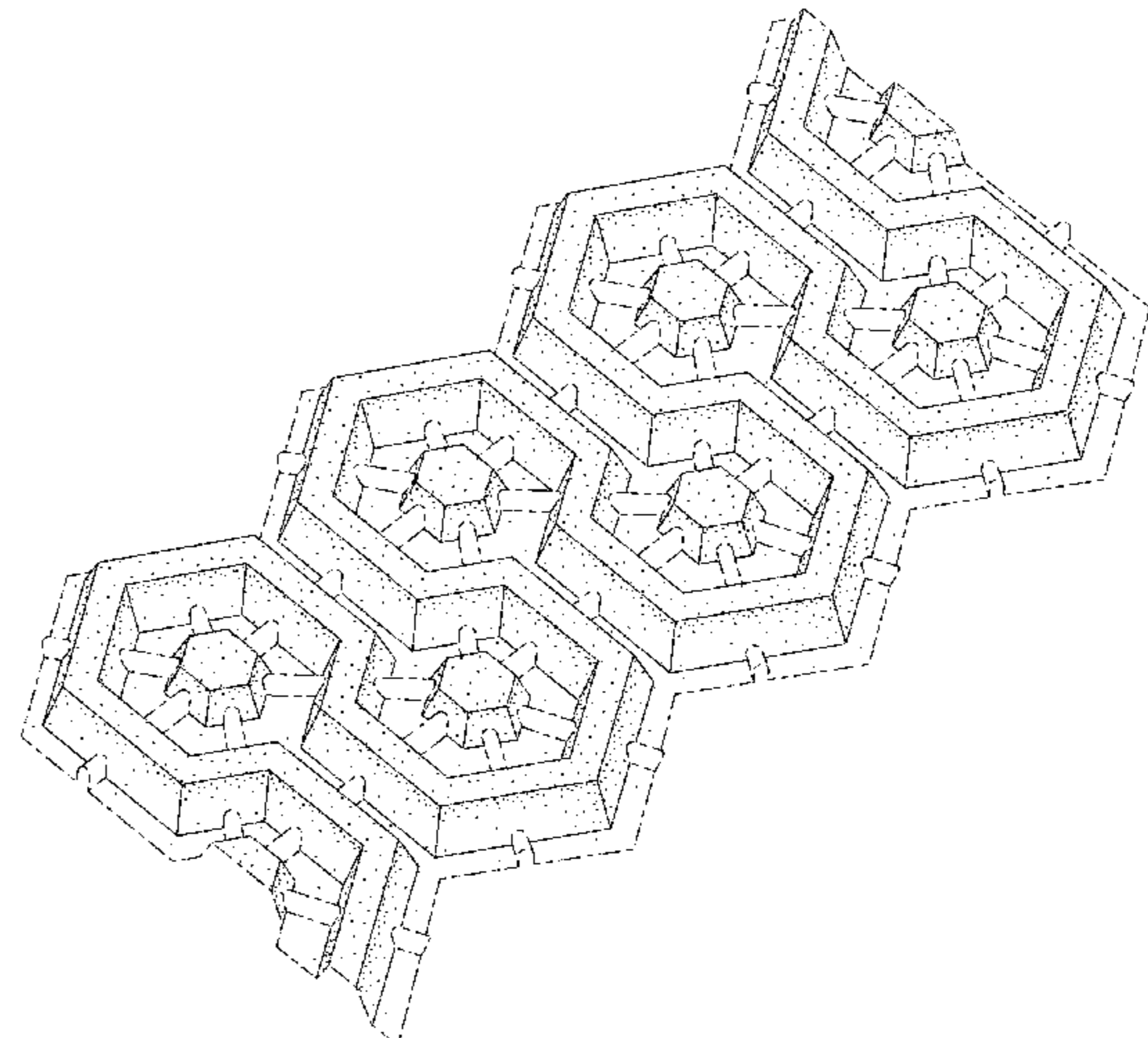
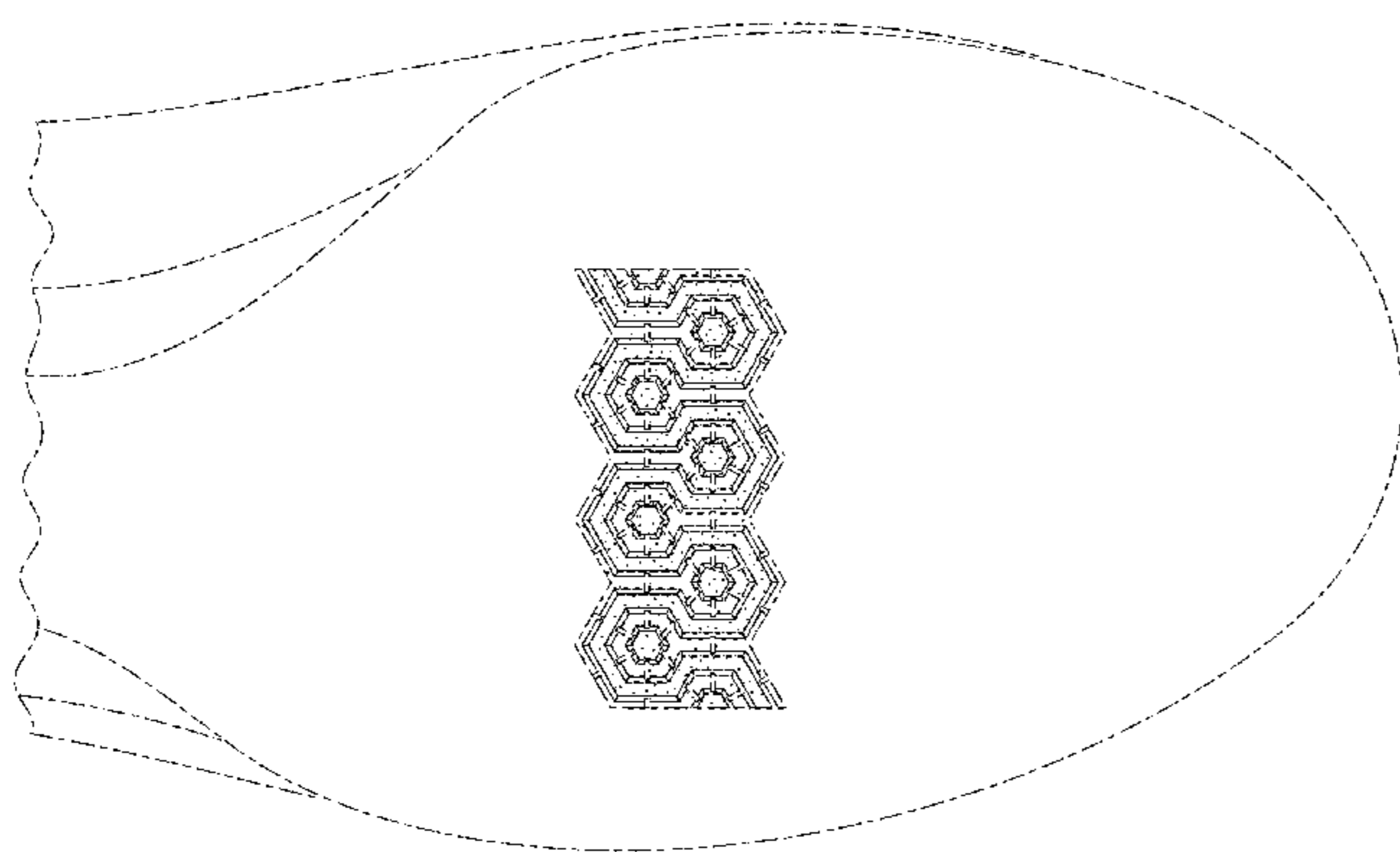
FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is an enlarged plan view thereof, wherein a portion of unclaimed subject matter shown in FIG. 1 is omitted as indicated by an imaginary break line; and,

FIG. 3 is an enlarged view of the claimed region in FIG. 1, shown in isolation.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

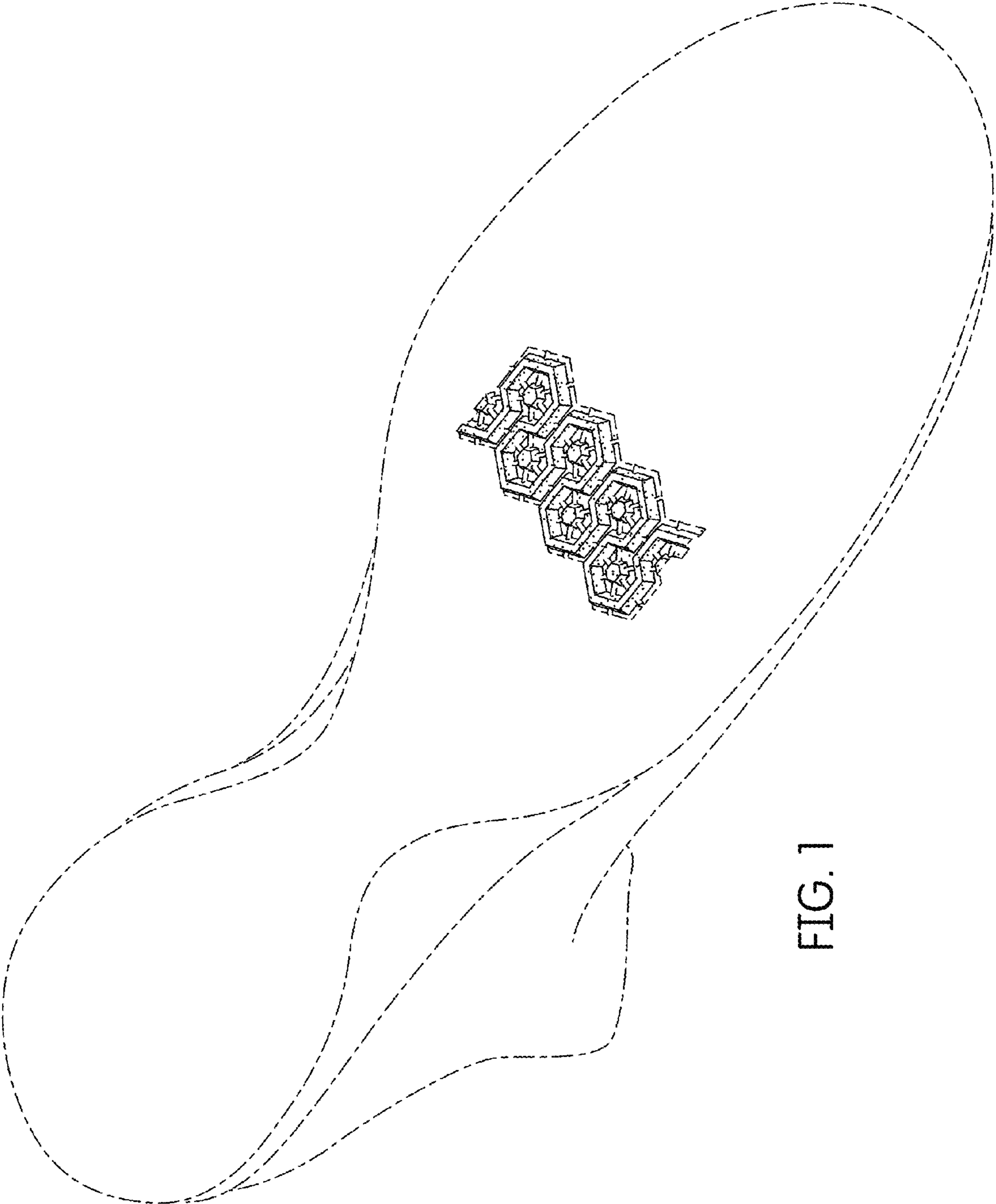

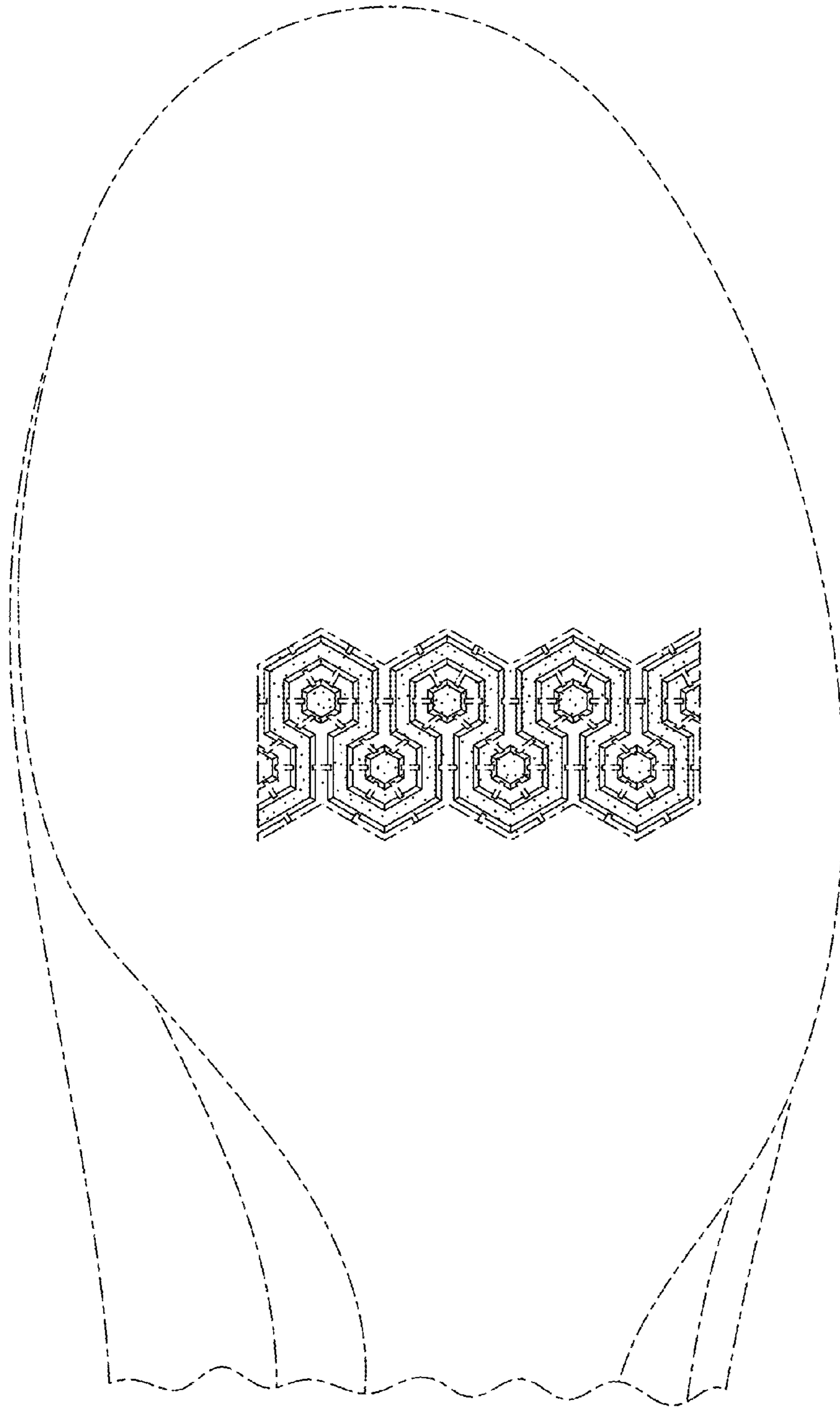

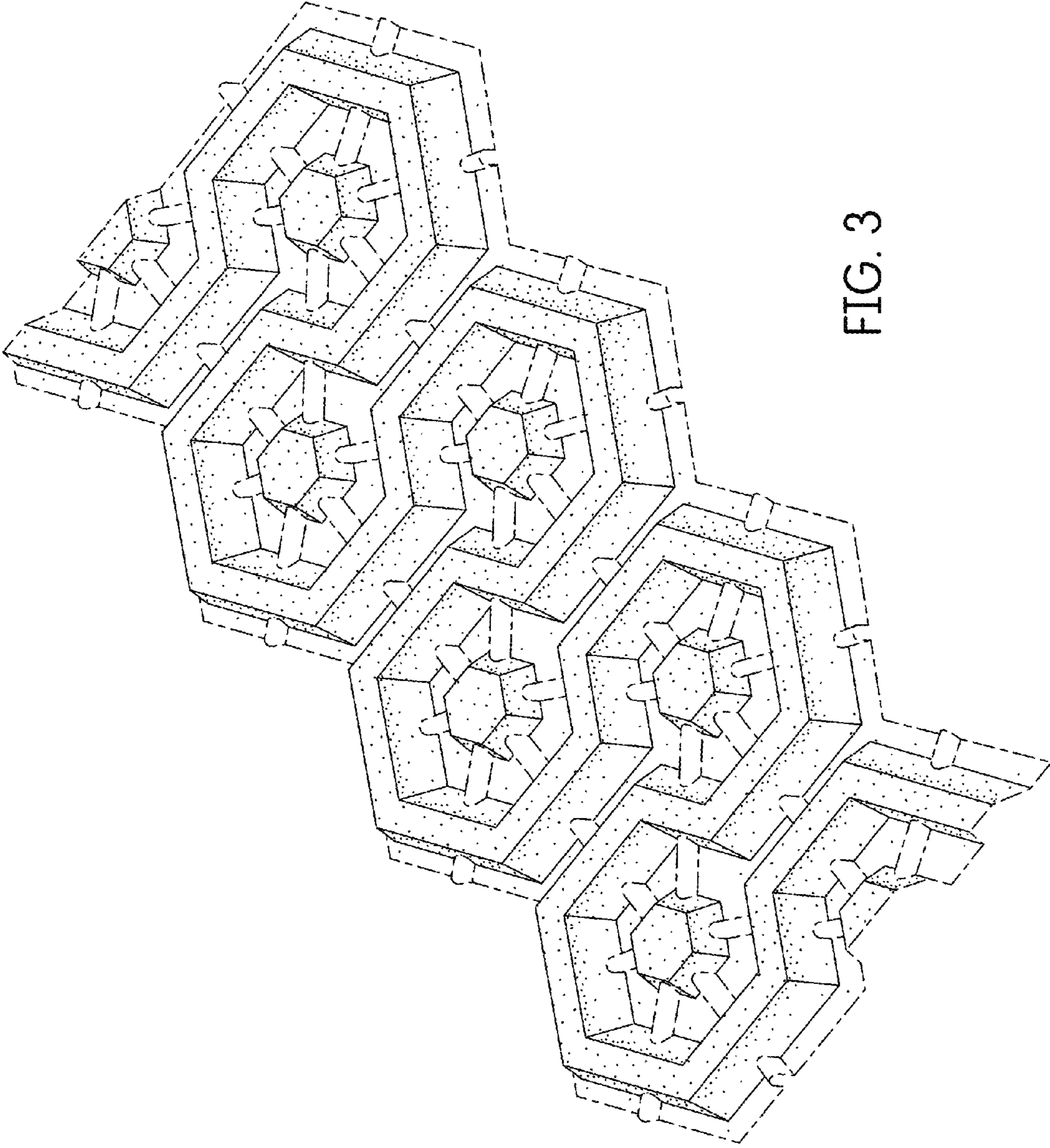
