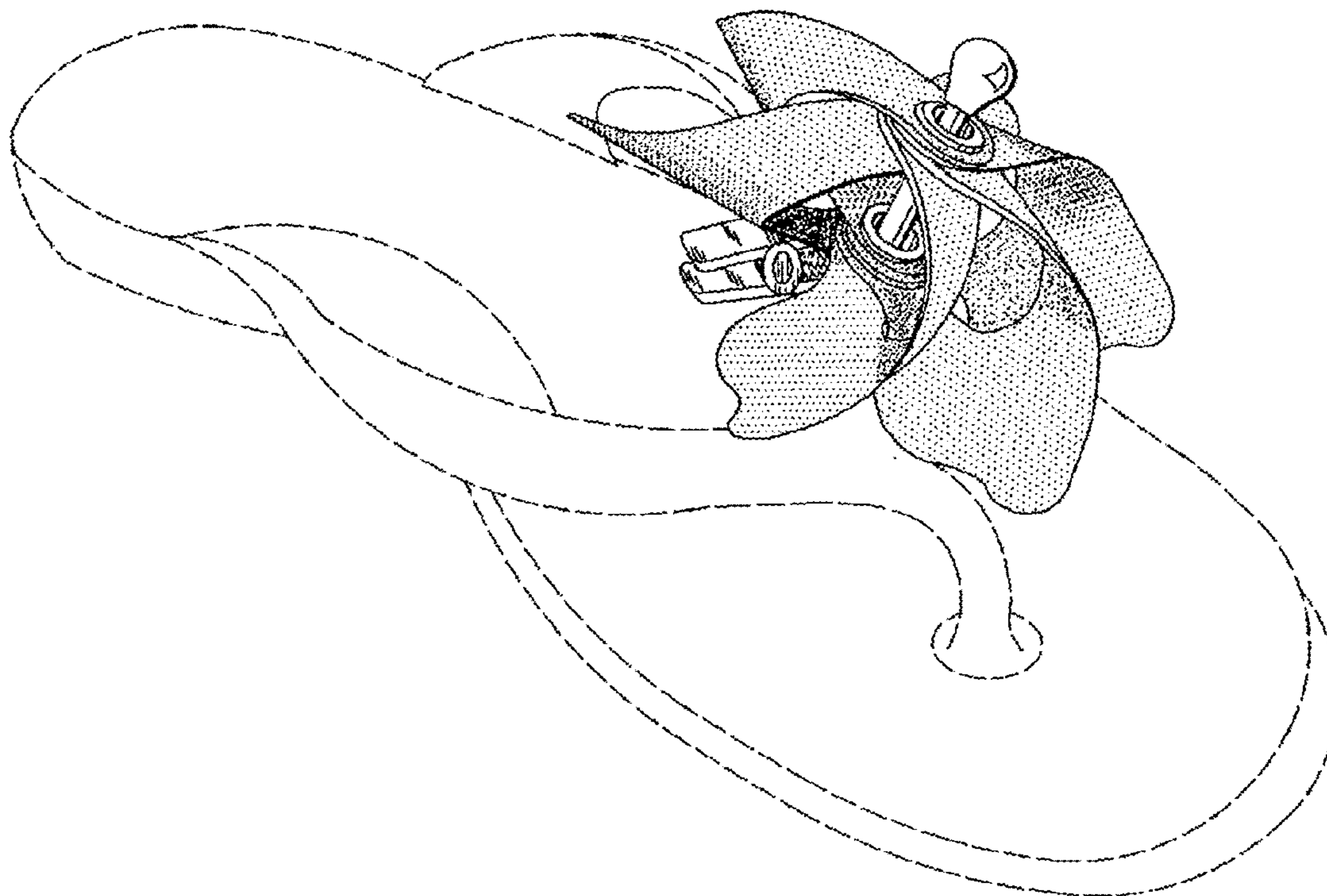
(57) **CLAIM**  
The ornamental design for a sandal with pinwheel clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a sandal with pinwheel clip showing my new design;  
FIG. 2 is a back perspective view of a sandal with pinwheel clip;  
FIG. 3 is a front perspective view of a sandal with pinwheel clip;  
FIG. 4 is a top view of a sandal with pinwheel clip;  
FIG. 5 is a bottom view of a sandal with pinwheel clip;  
FIG. 6 is a right side view of a sandal with pinwheel clip; and, FIG. 7 is a left side view of a sandal with pinwheel clip.

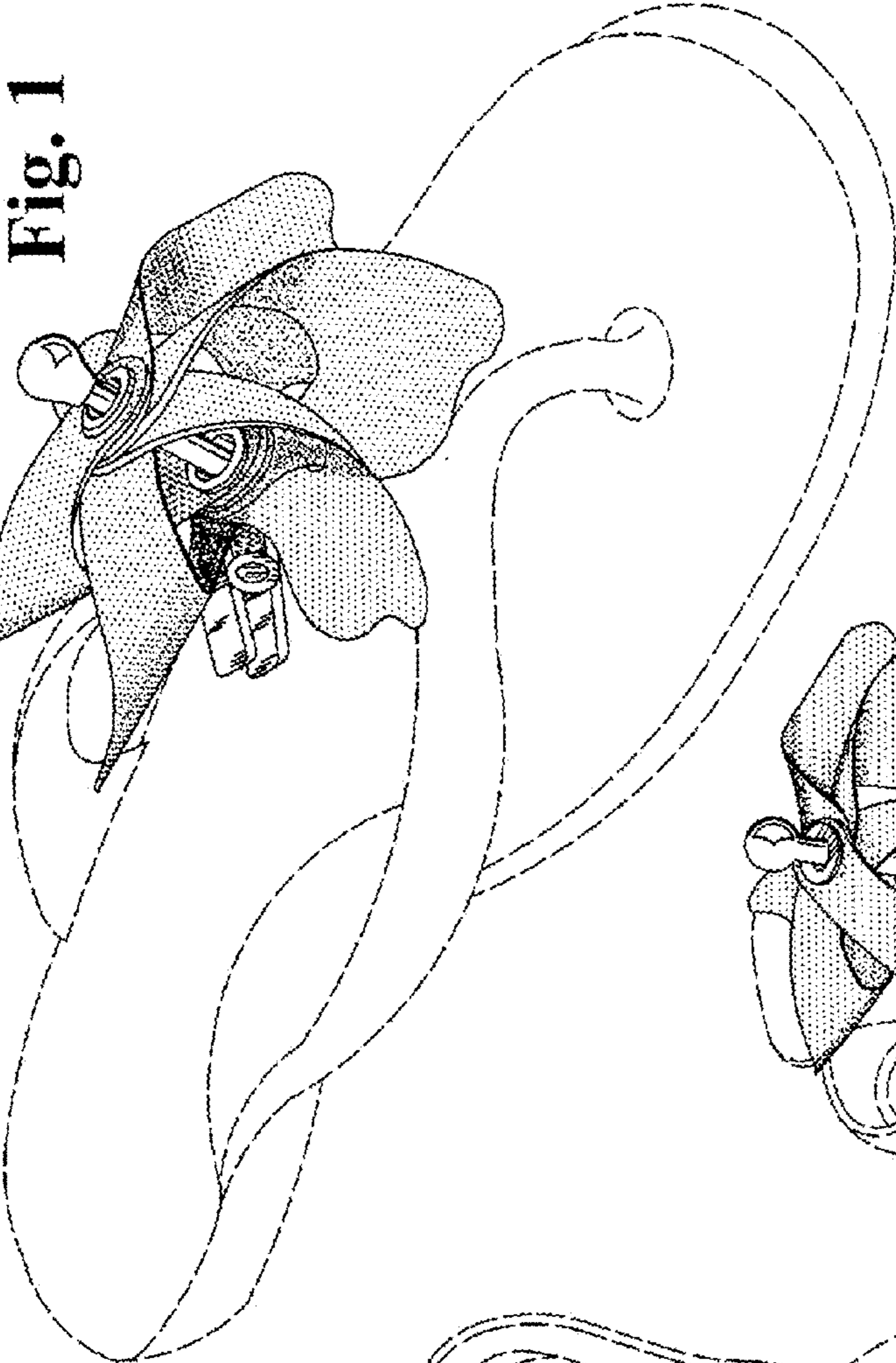

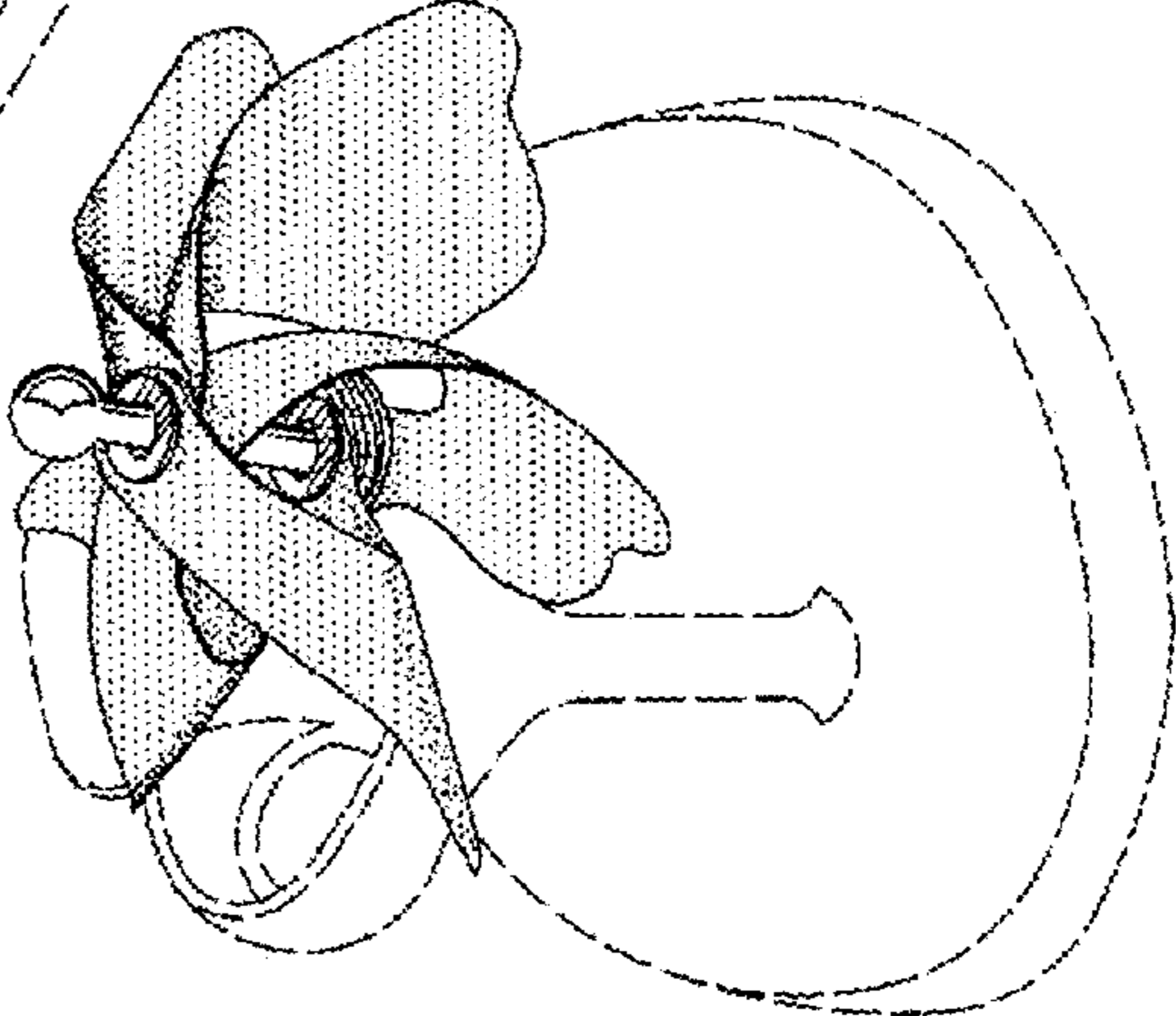

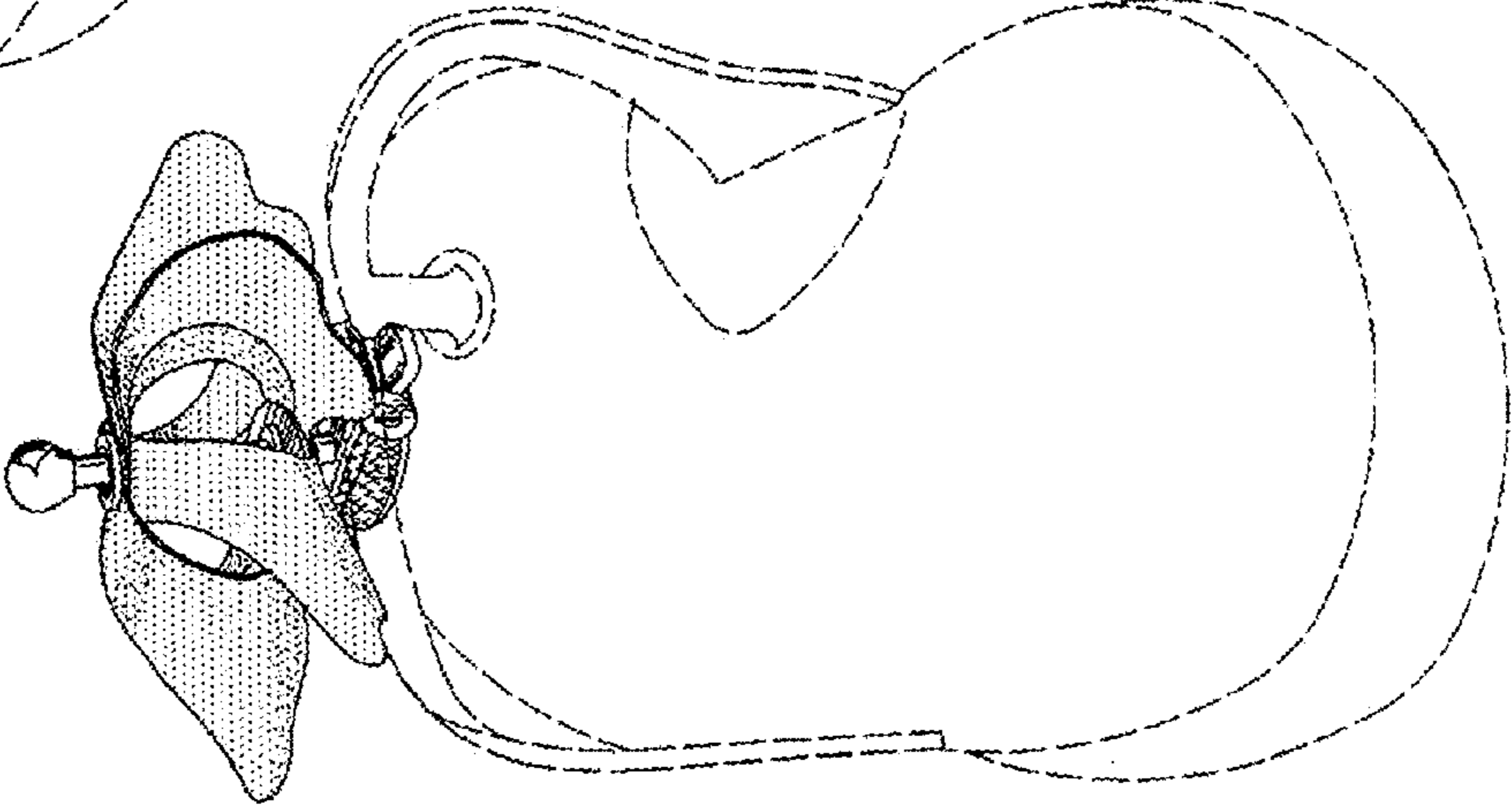

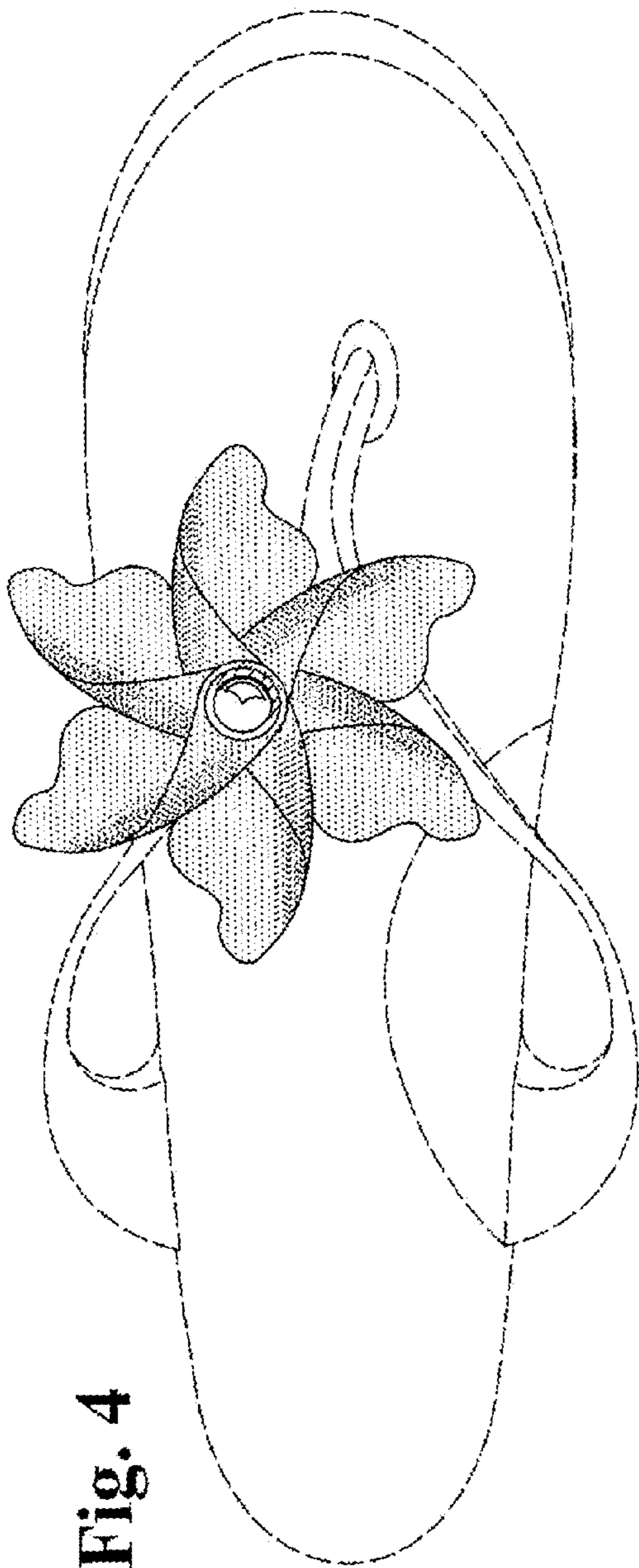

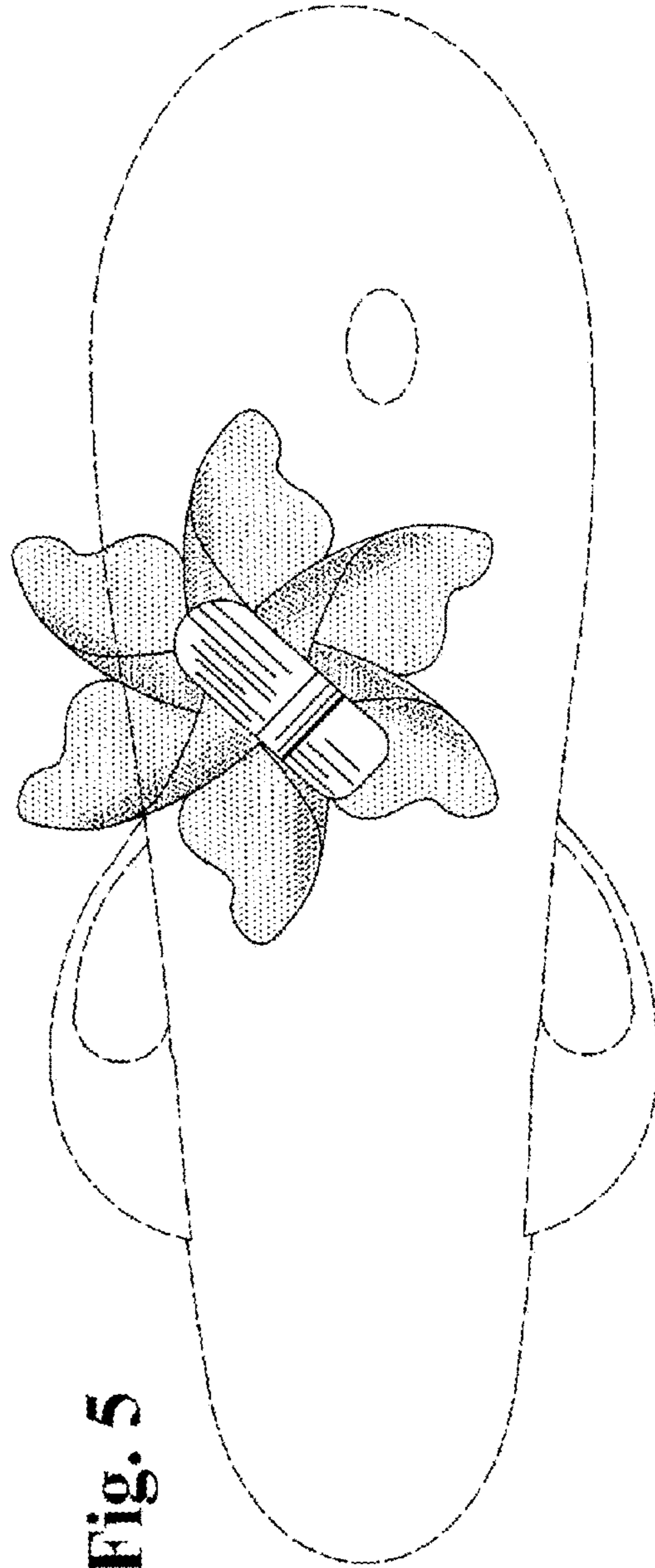

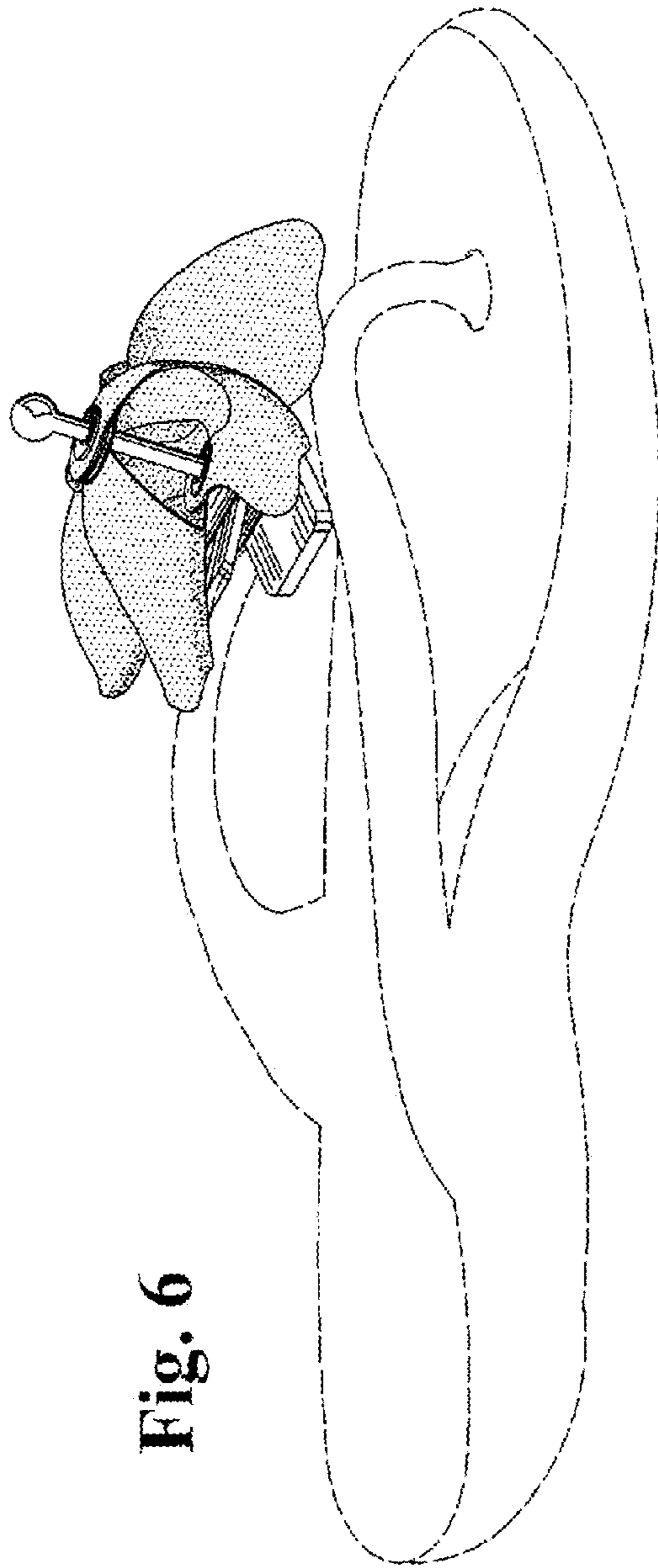

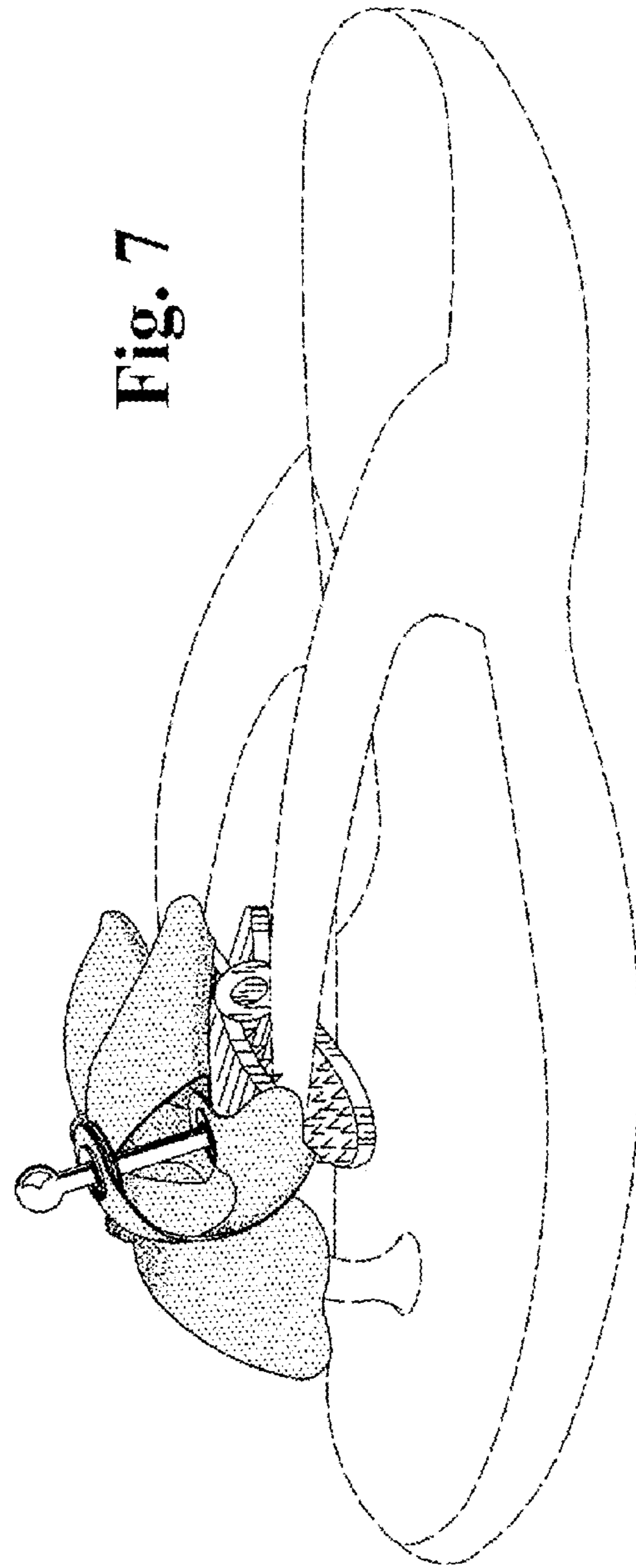
