identical view of the front side;

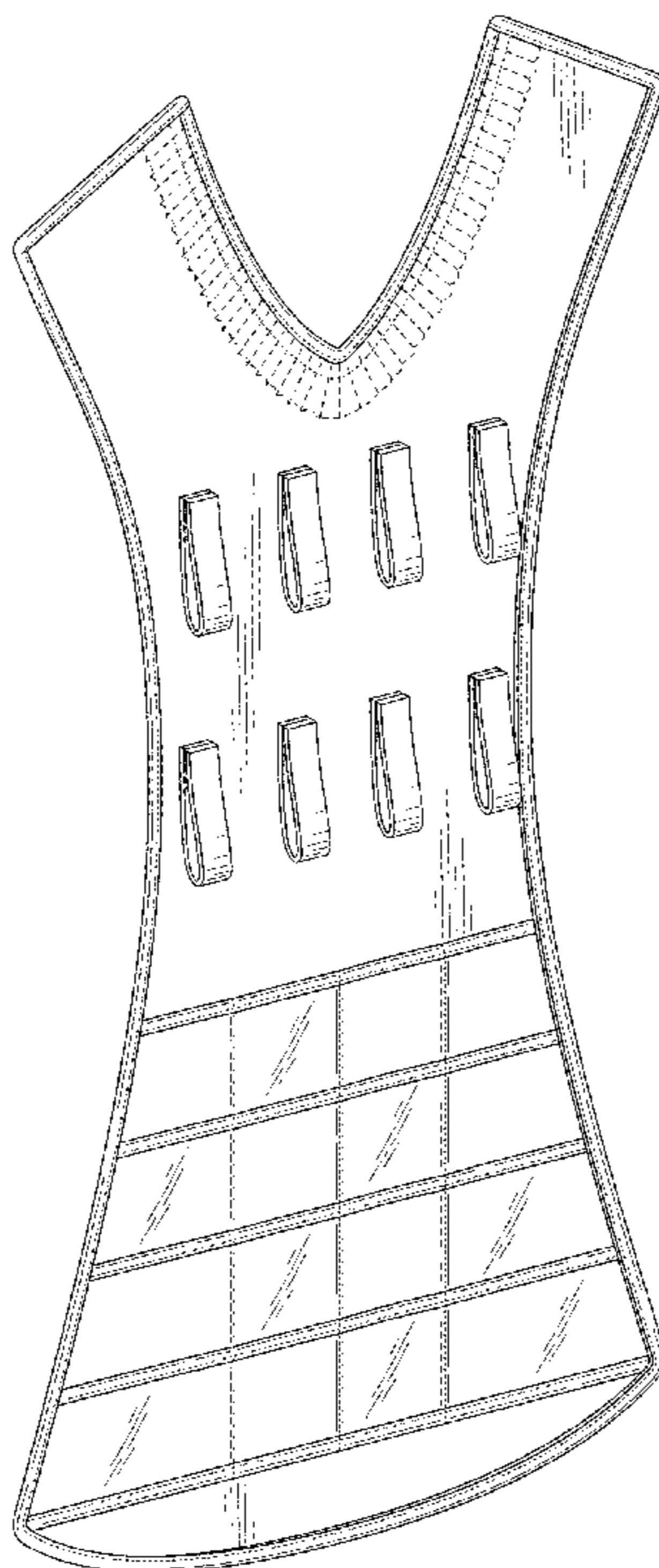
FIG. 3 is a right side view of FIG. 1, the left side being an

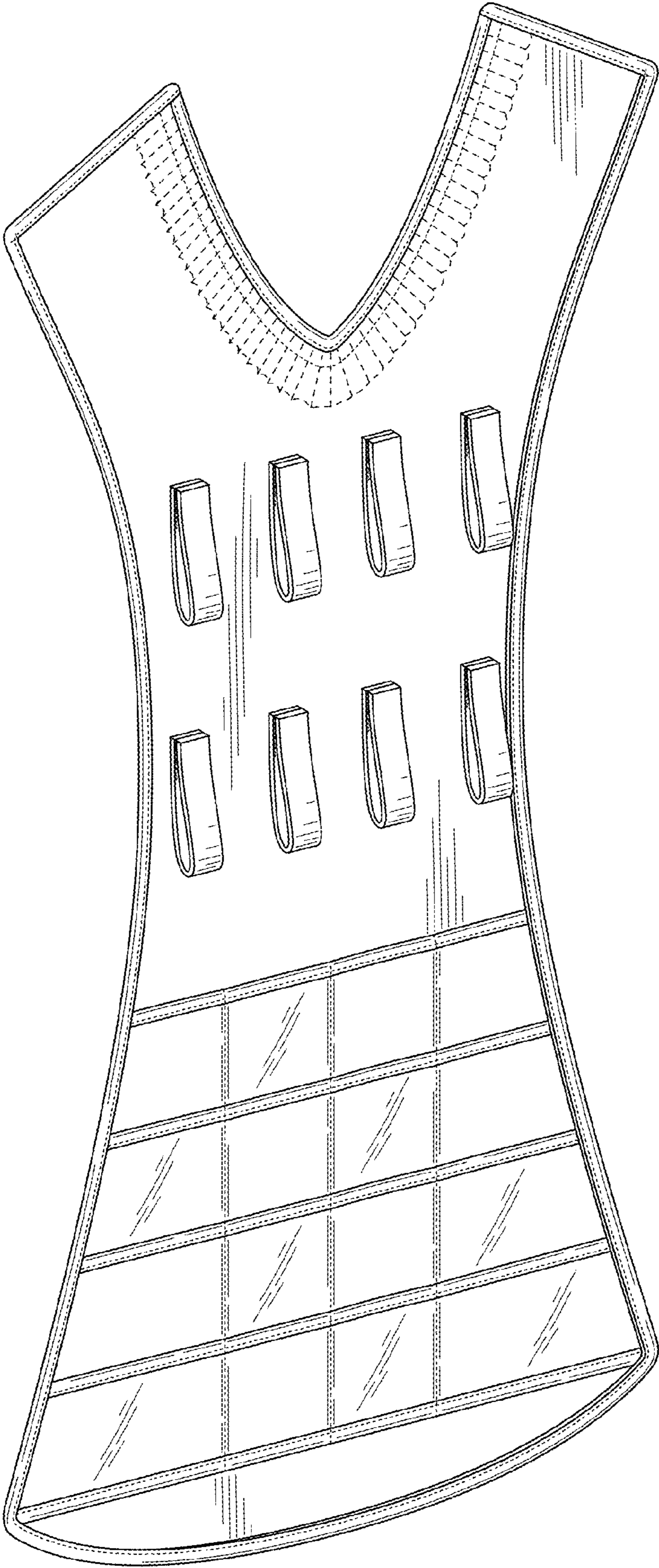

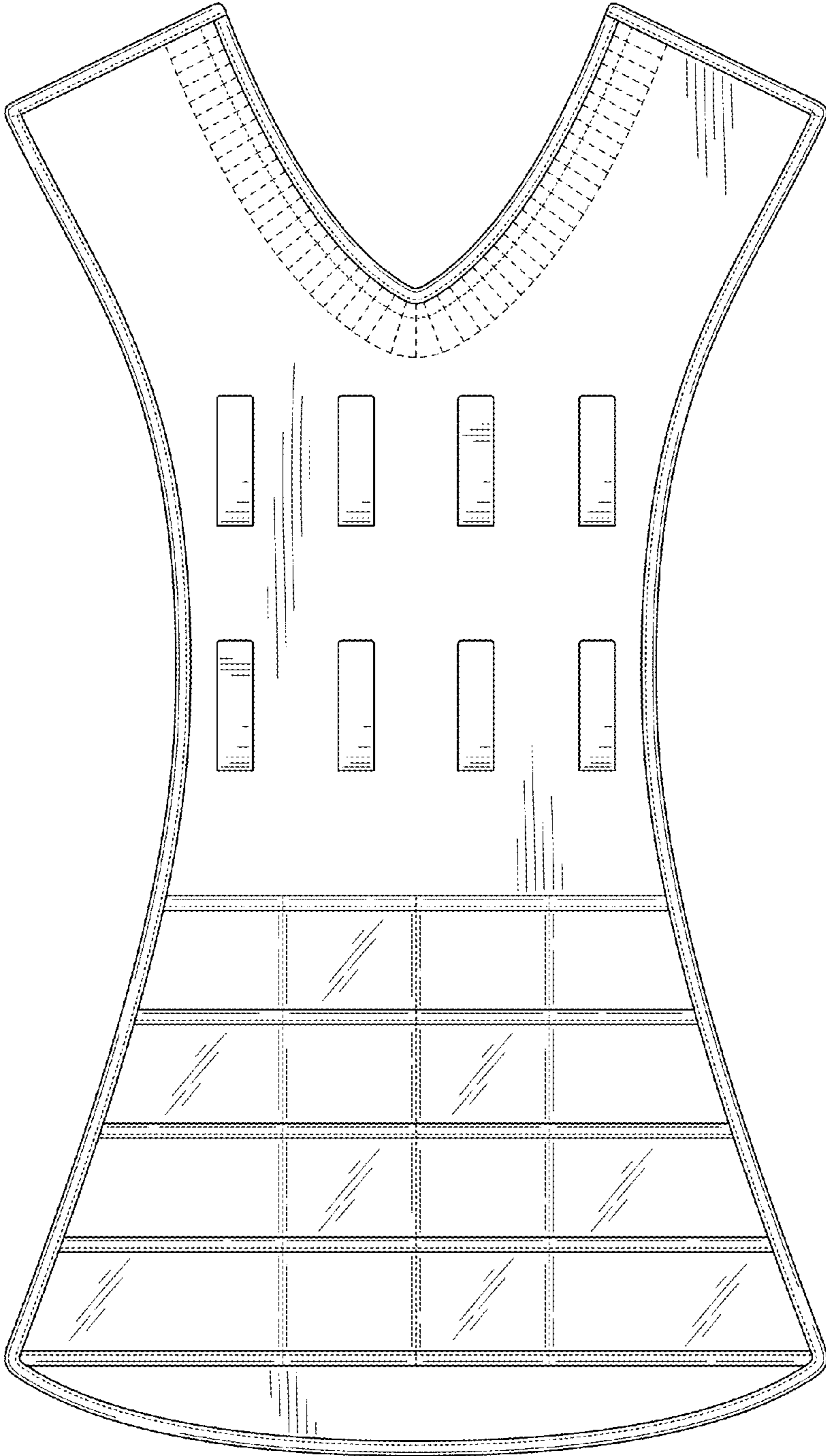

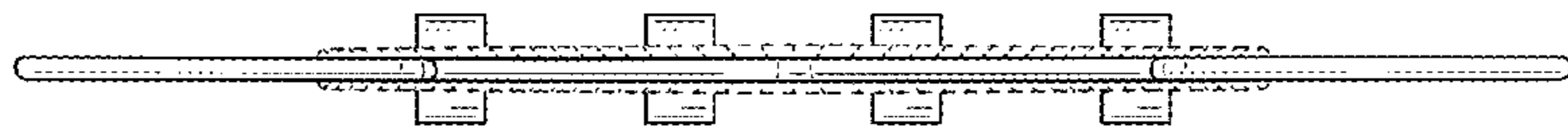

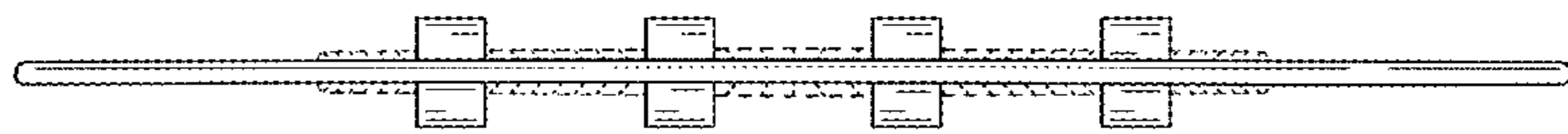
