The ornamental design for a drinking glass with inverted lightbulb enclosed within the drinking glass, as shown and described.

FIG. 4 is a rear elevational view thereof;

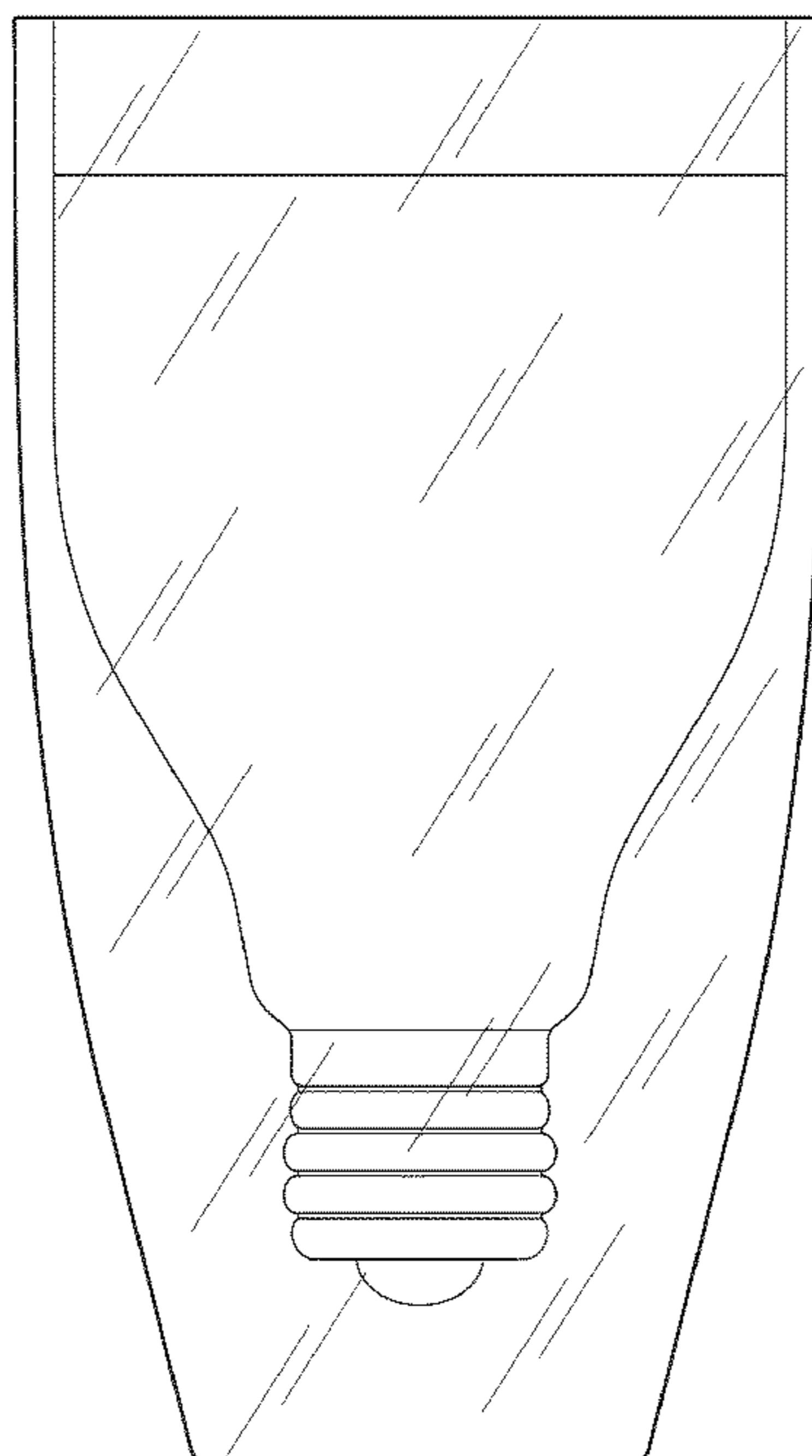
FIG. 5 is a top view thereof;

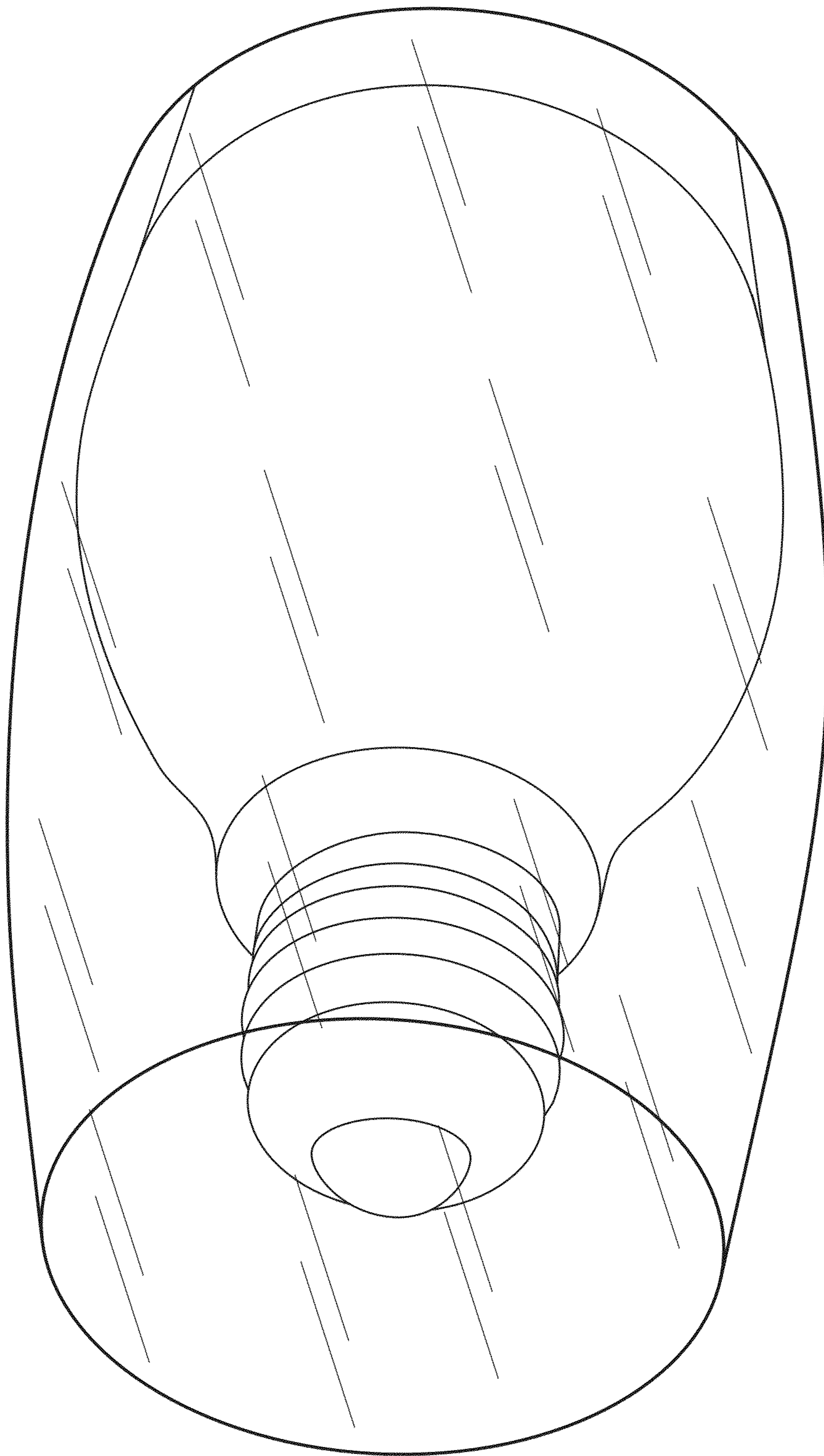

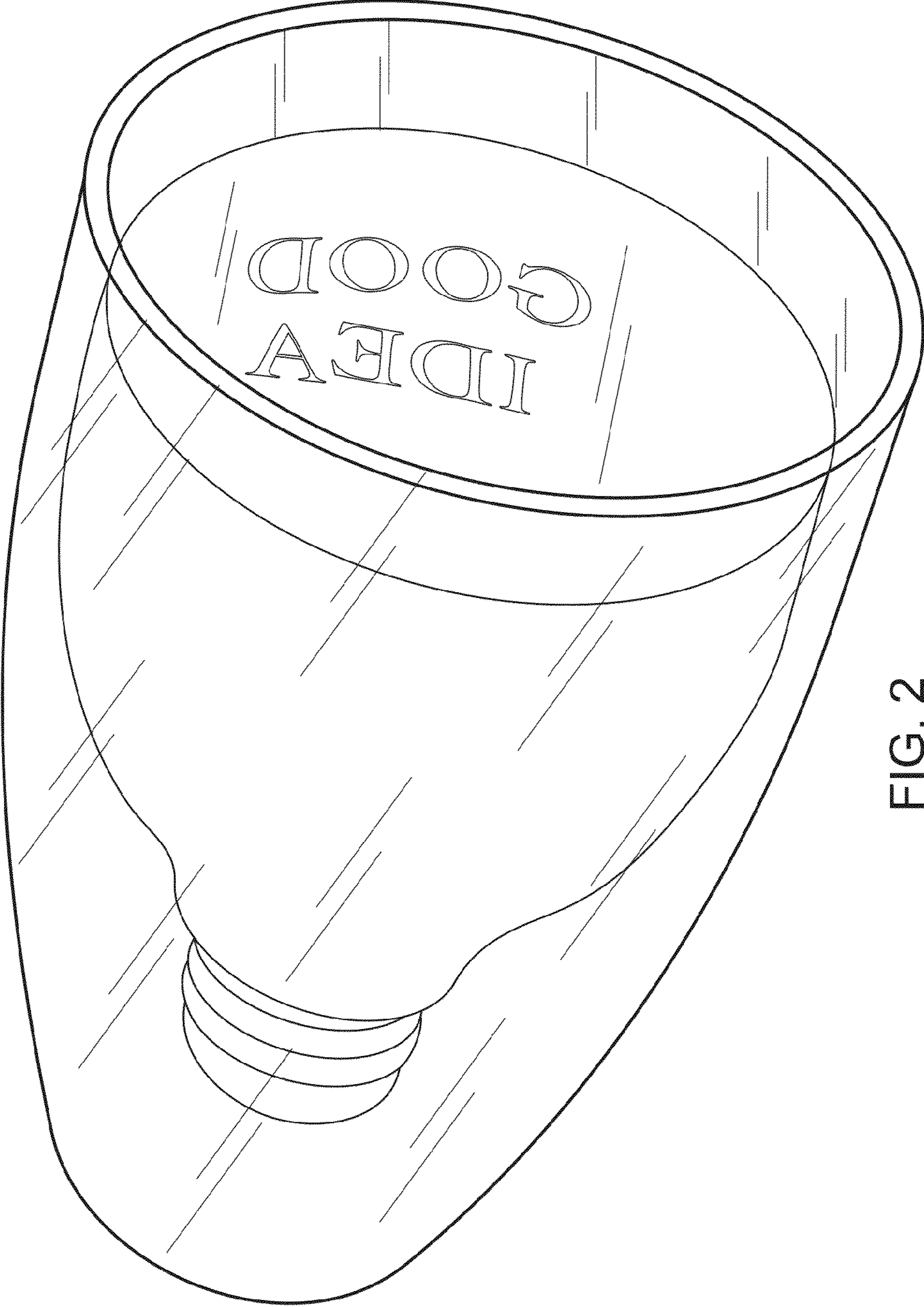

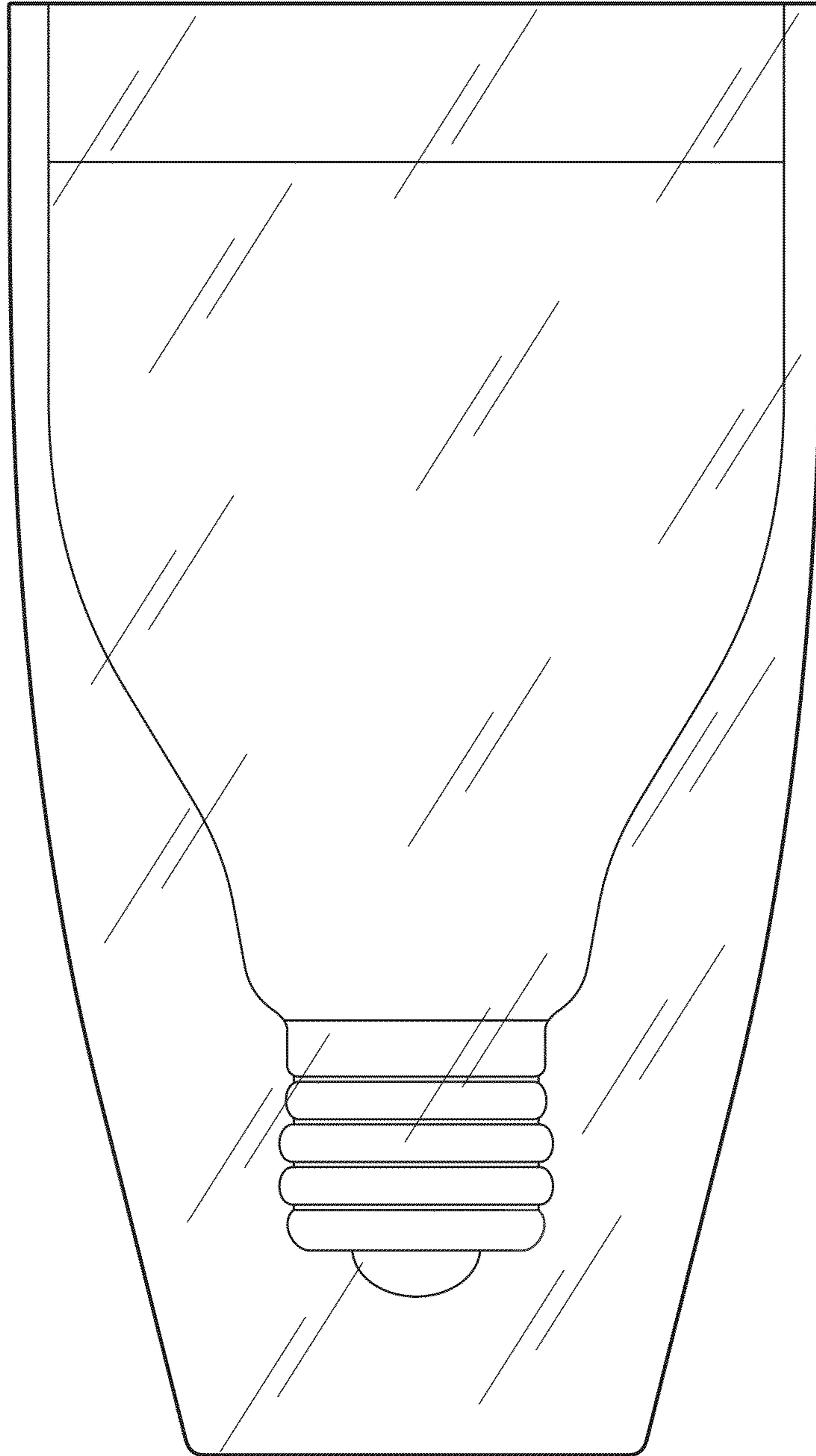

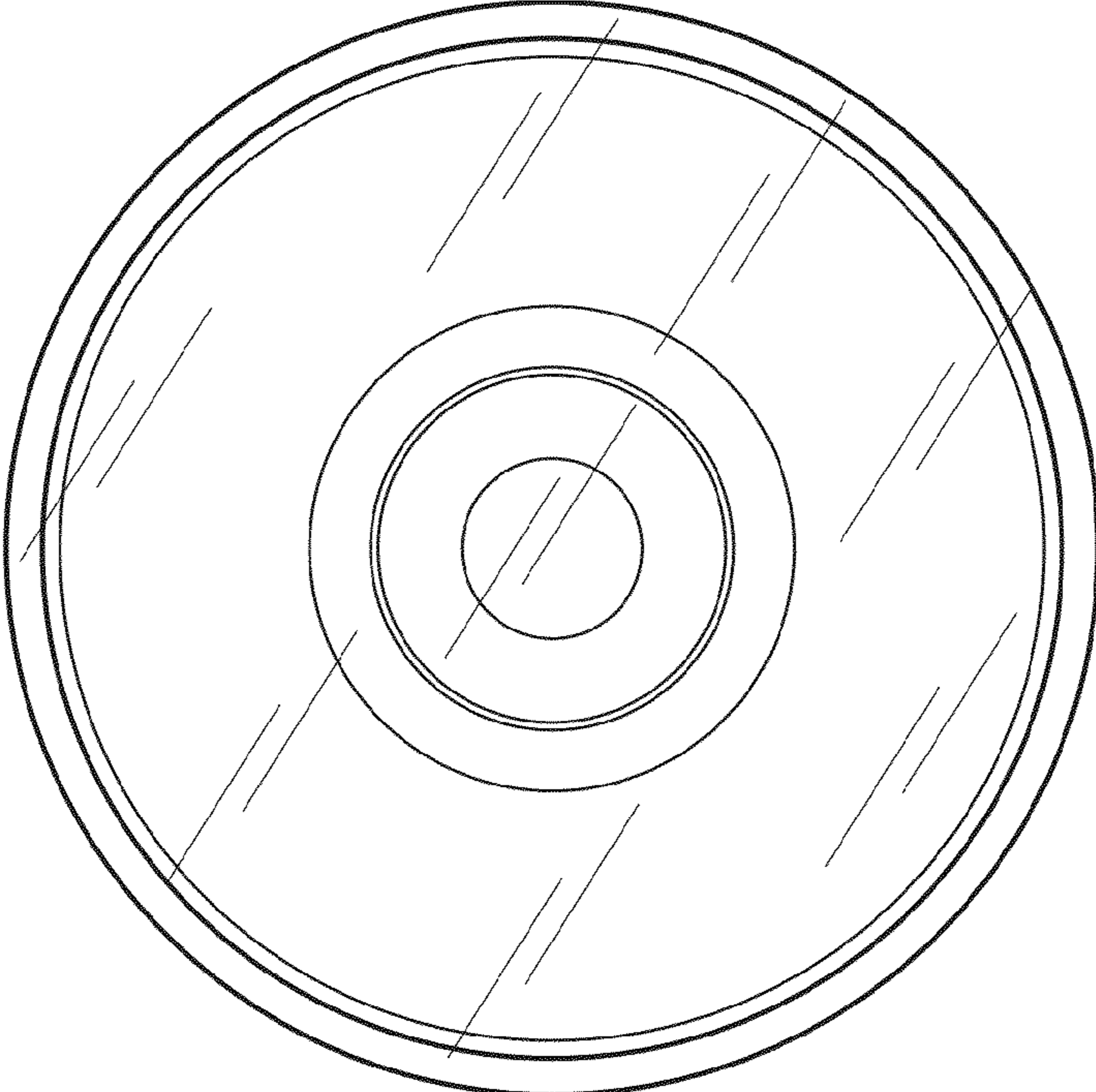

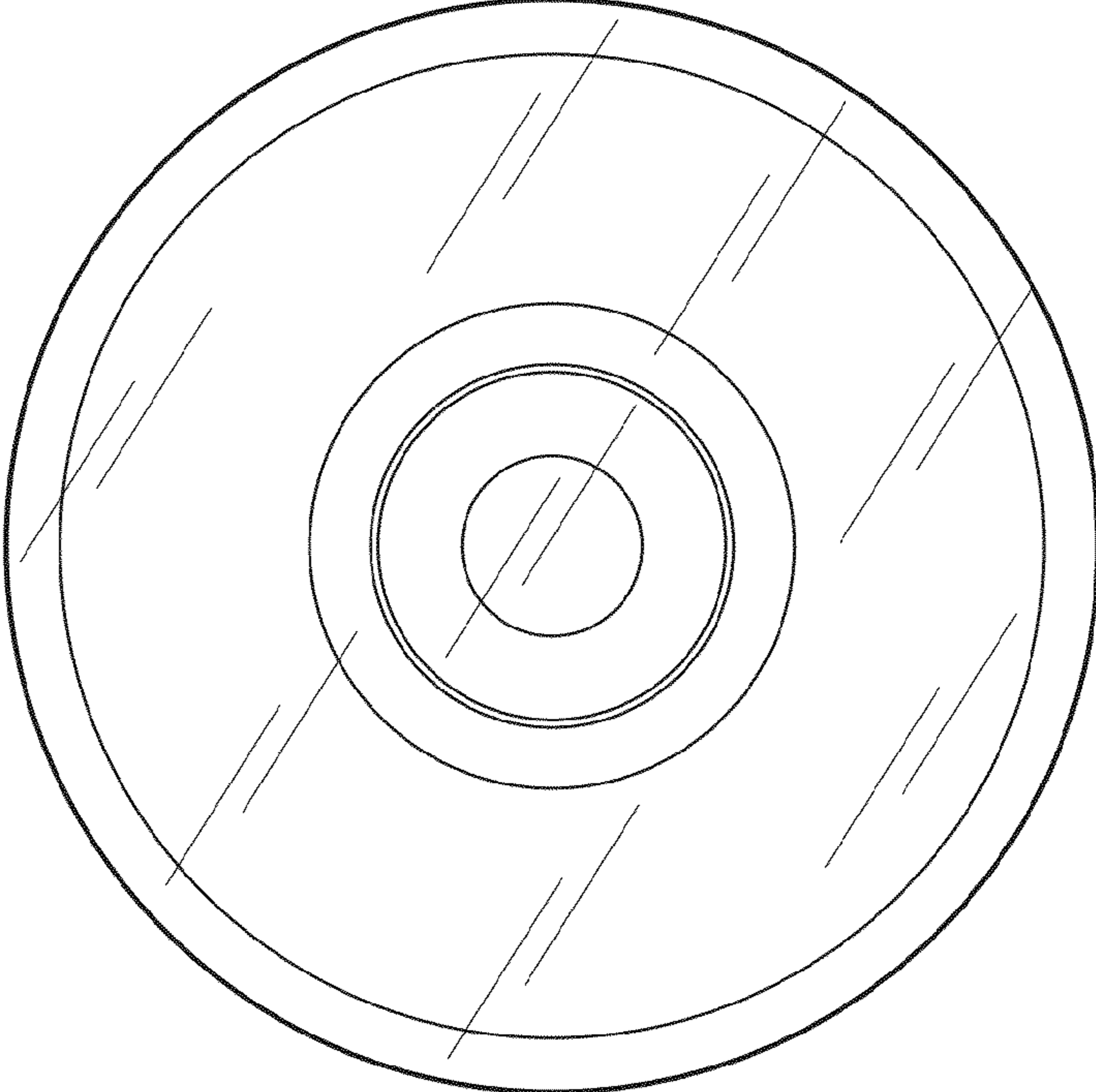

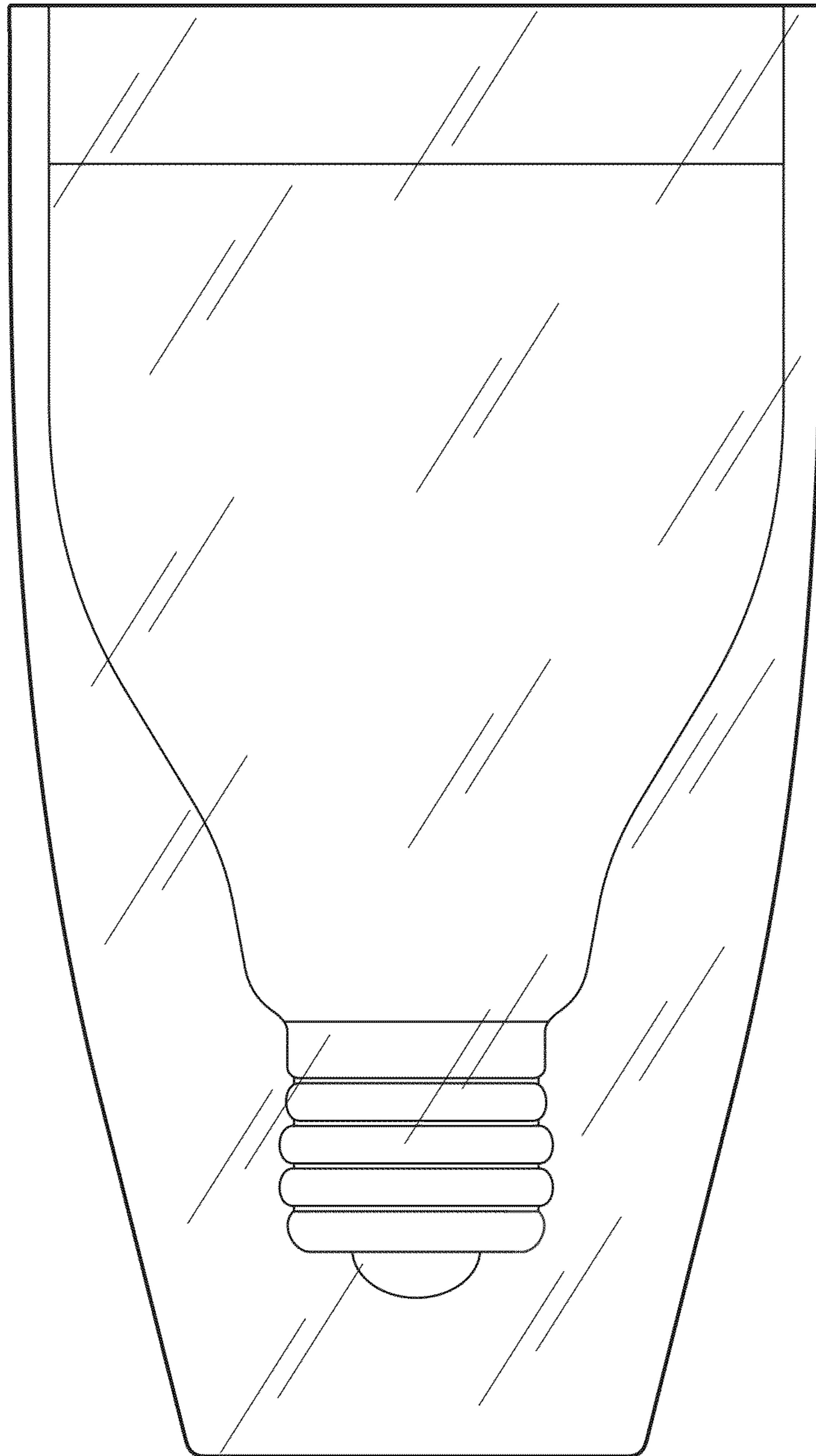

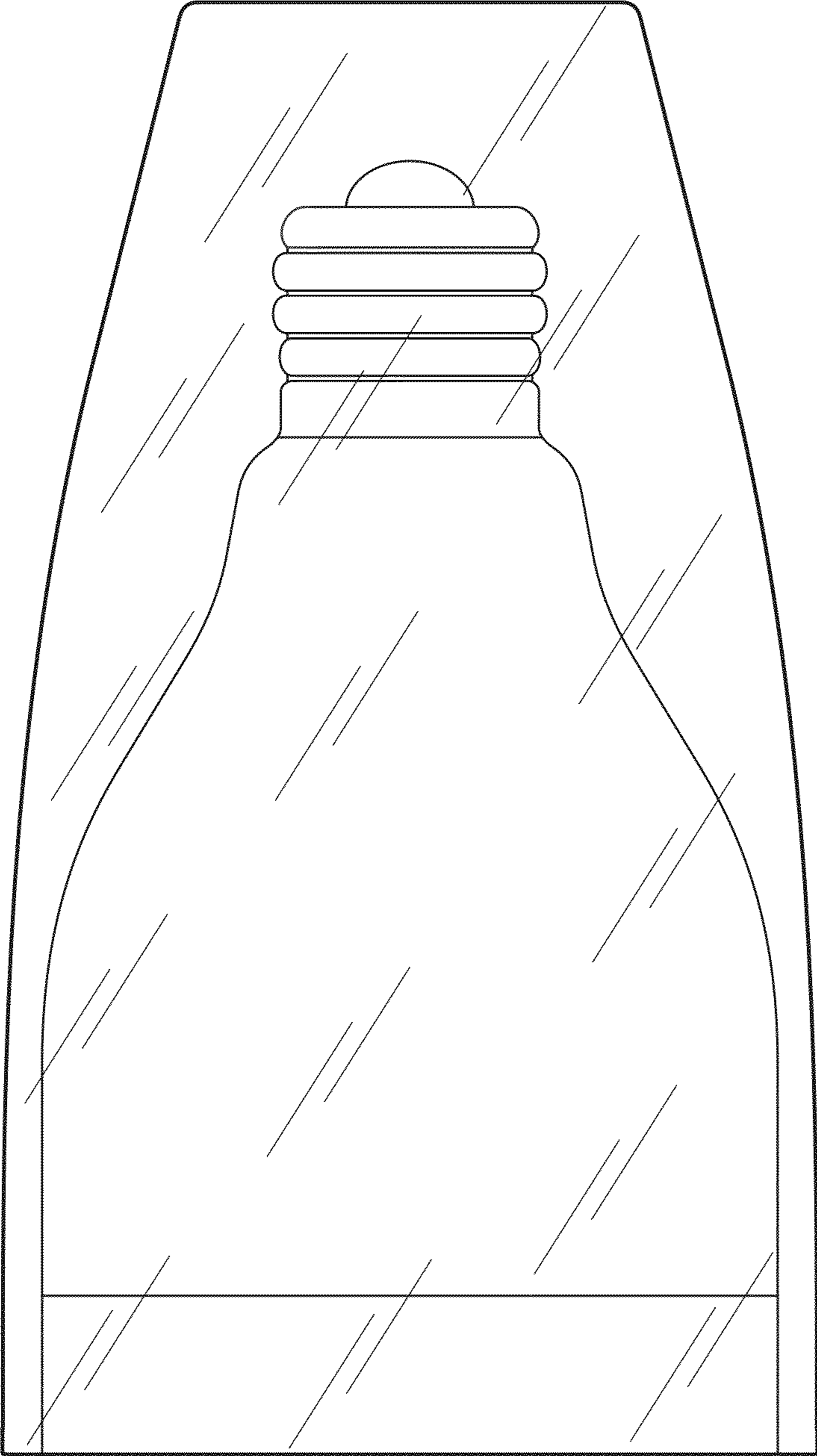
