FIG. 4 is a right-side view thereof.

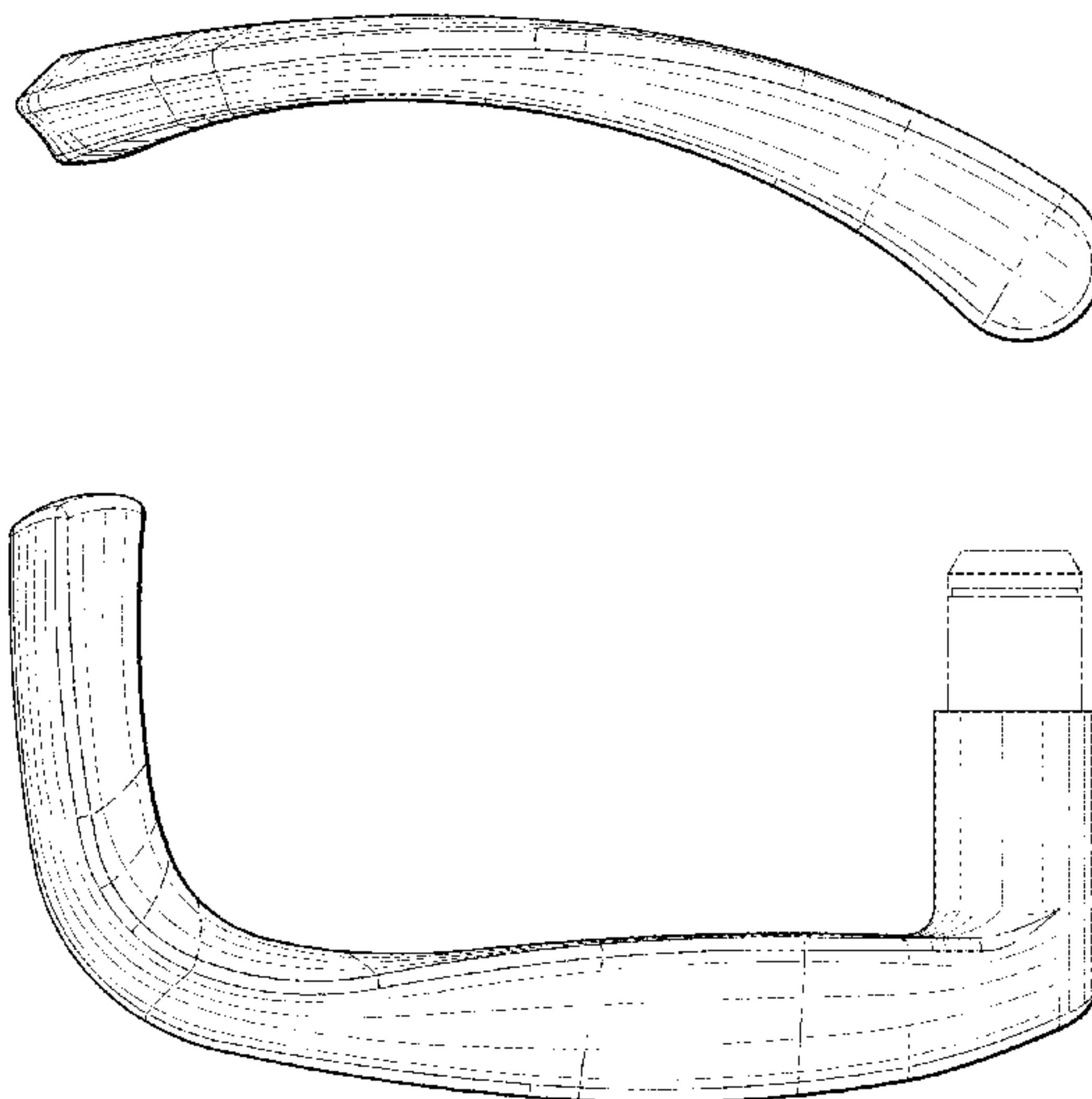
FIG. 5 is a left-side view thereof.

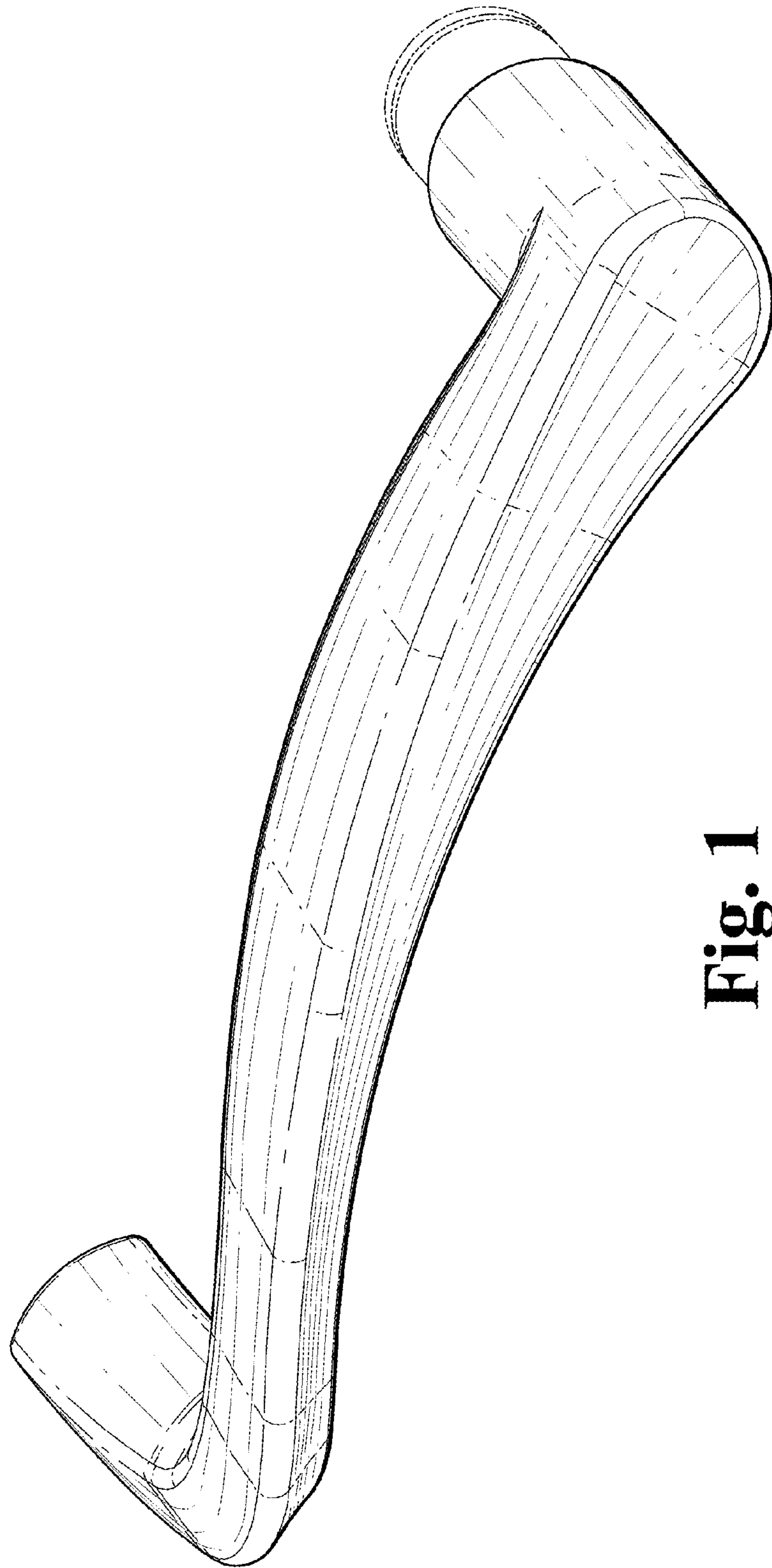
FIG. 6 is a bottom view thereof; and,

The broken lines are for the purpose of showing illustrative attachment shanks for the decorative lever, and they form no part of the claimed design.

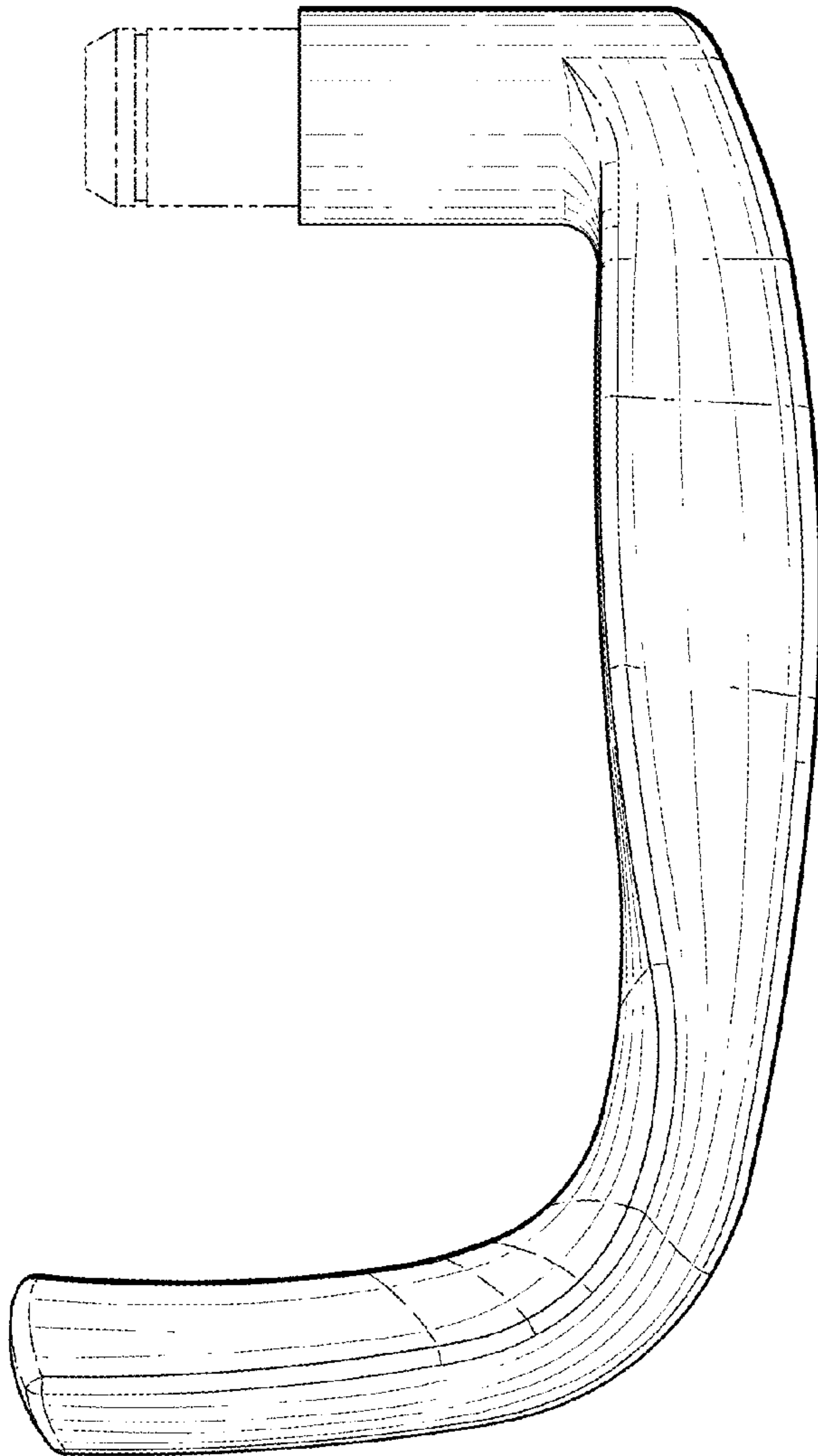

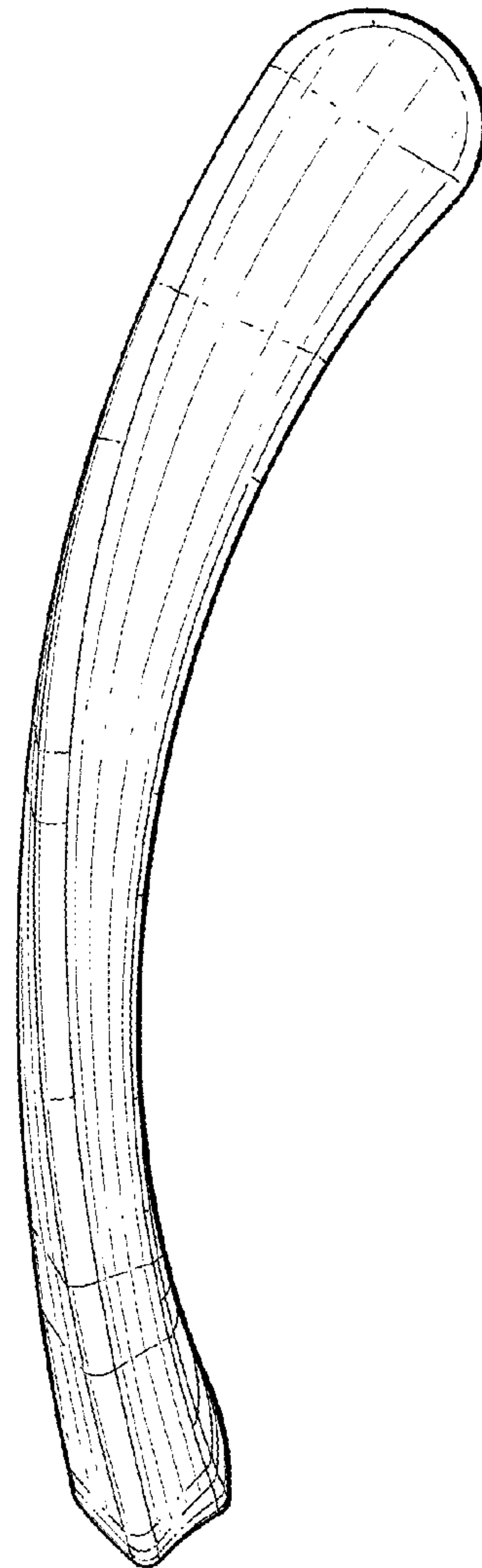


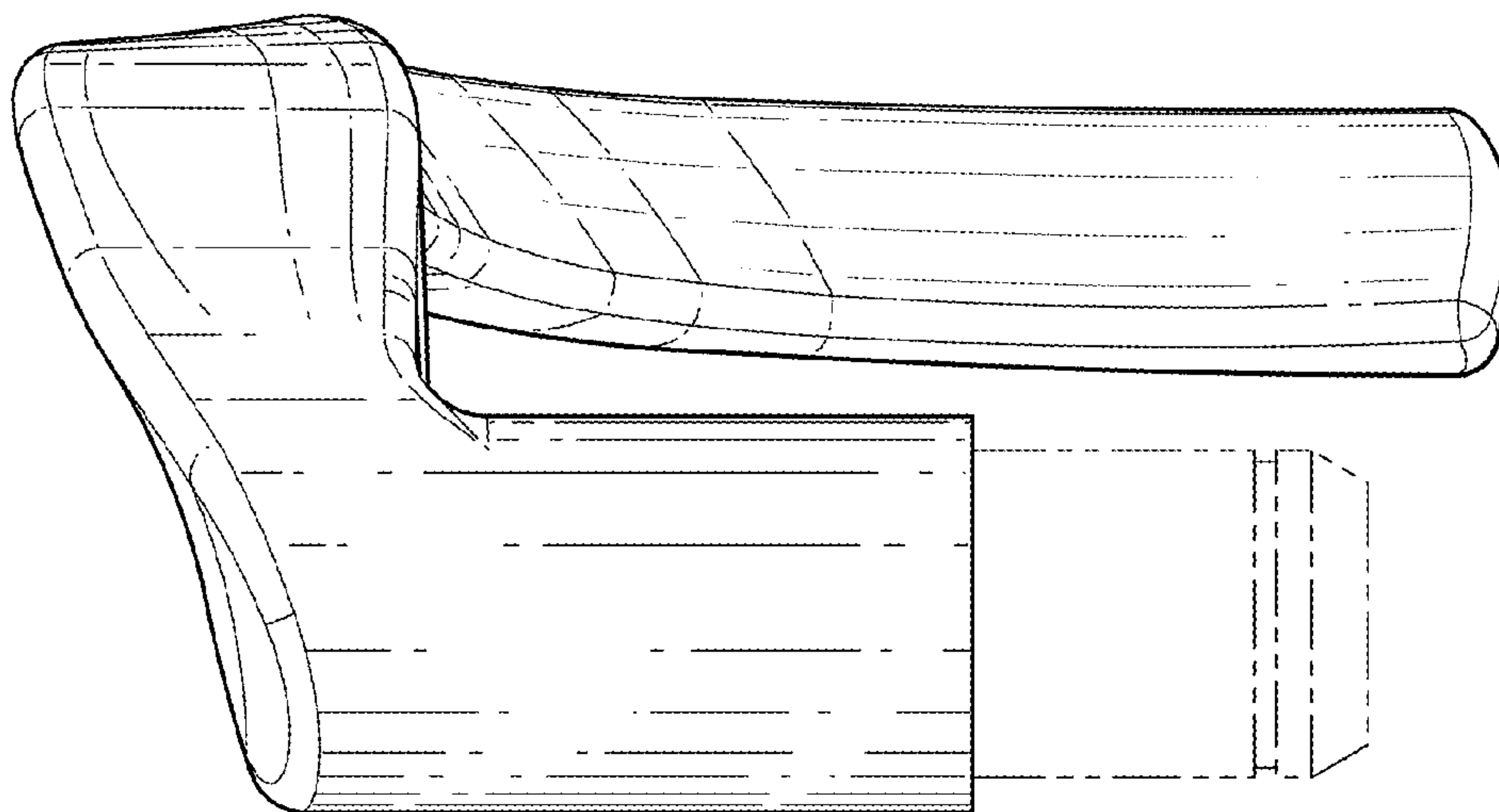

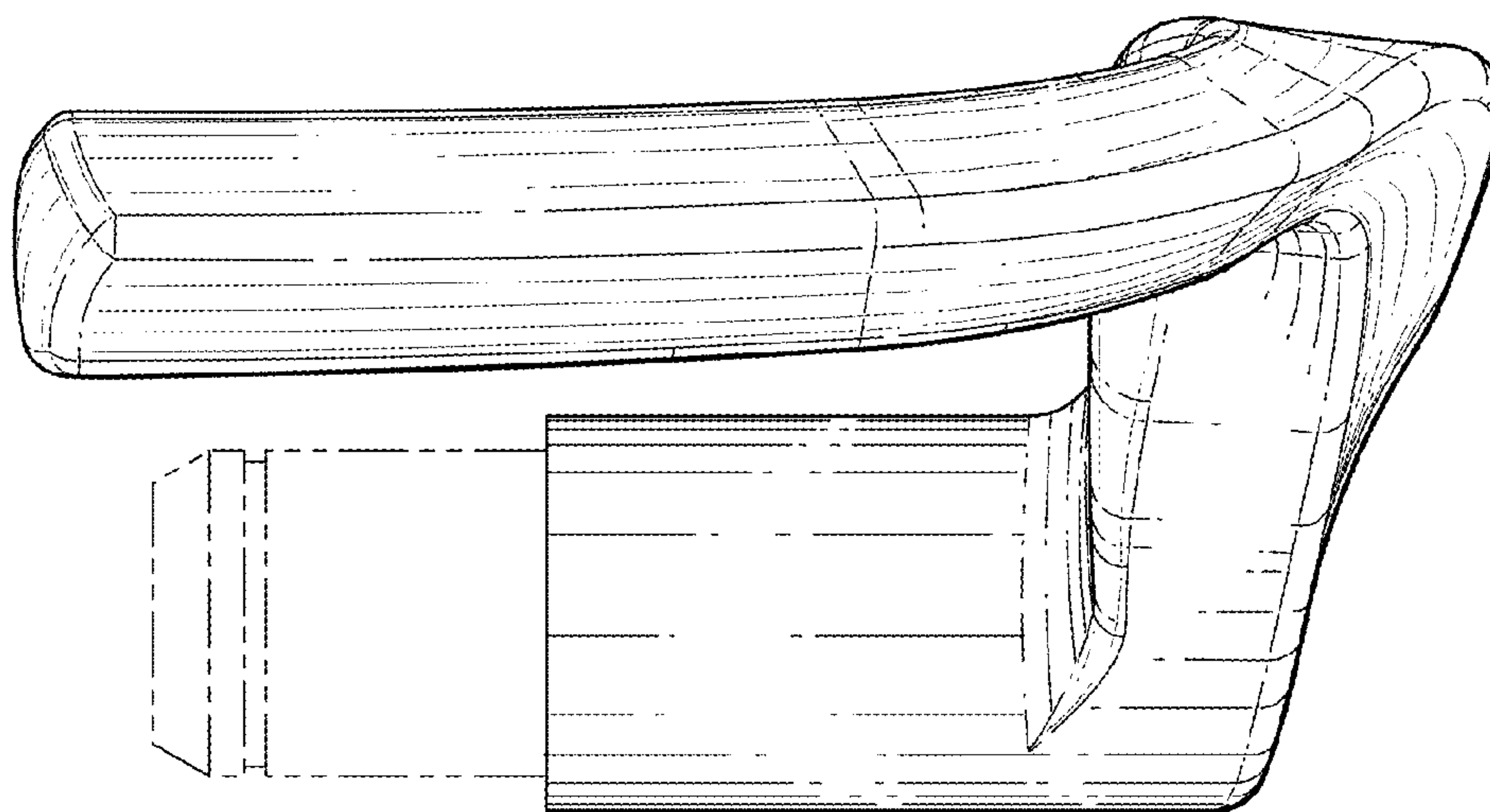

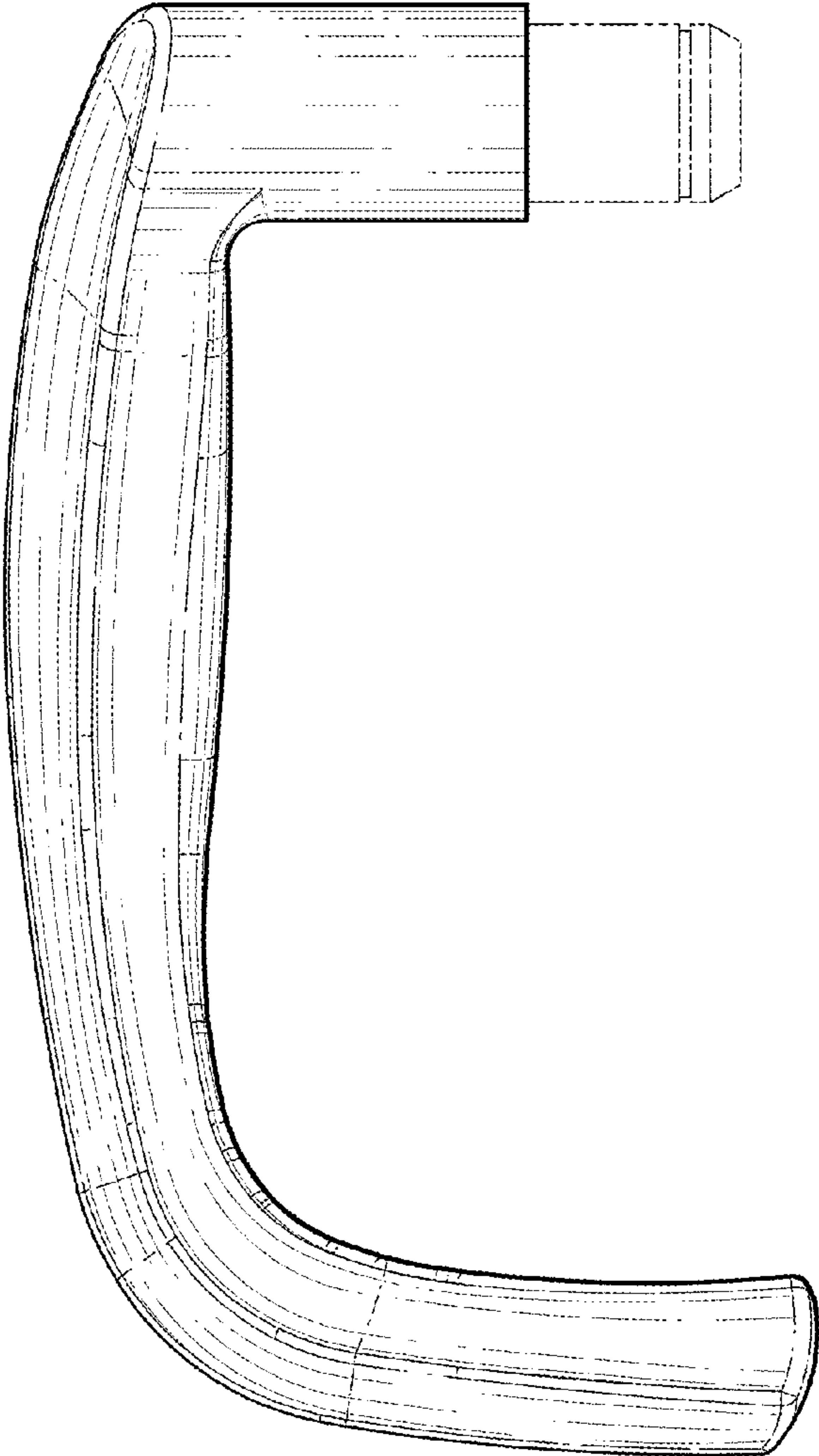
