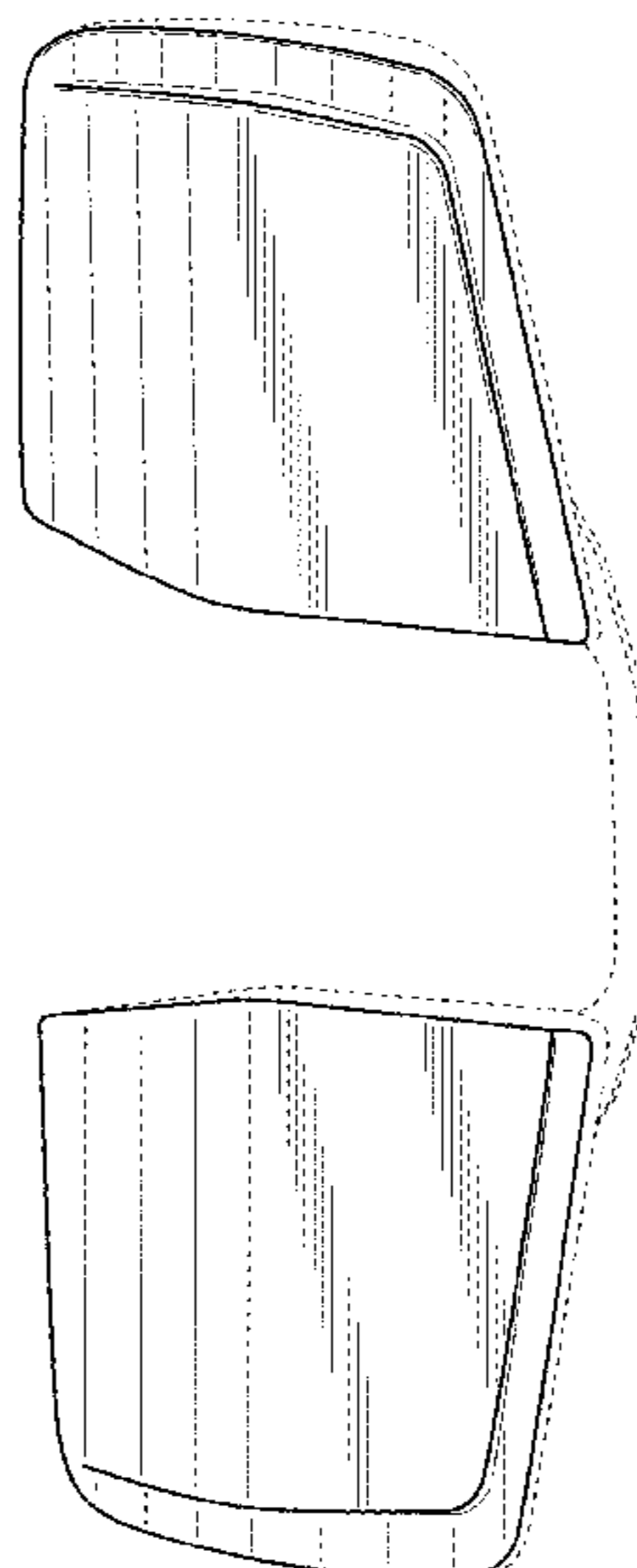
The ornamental design for a wedge for door lock of automo-

**DESCRIPTION**

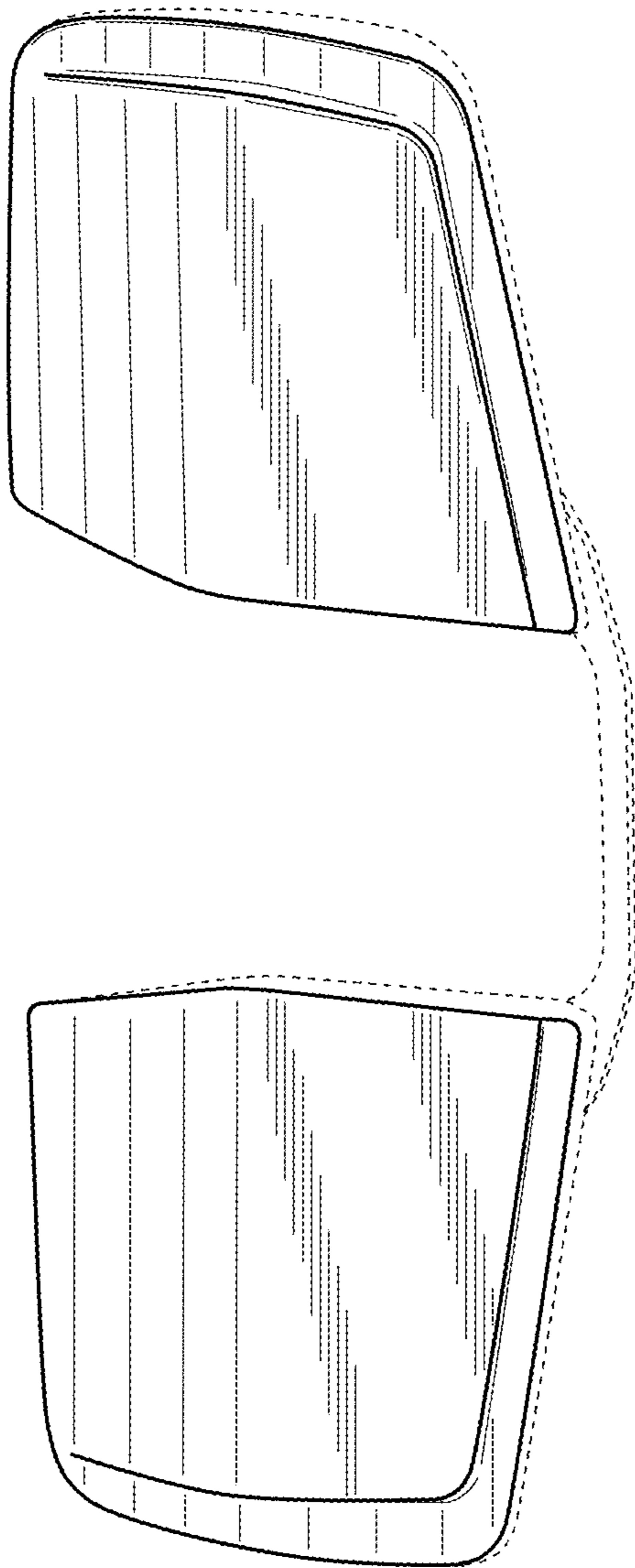
FIG. 1 is a front perspective view of a wedge for door lock of

claimed design.

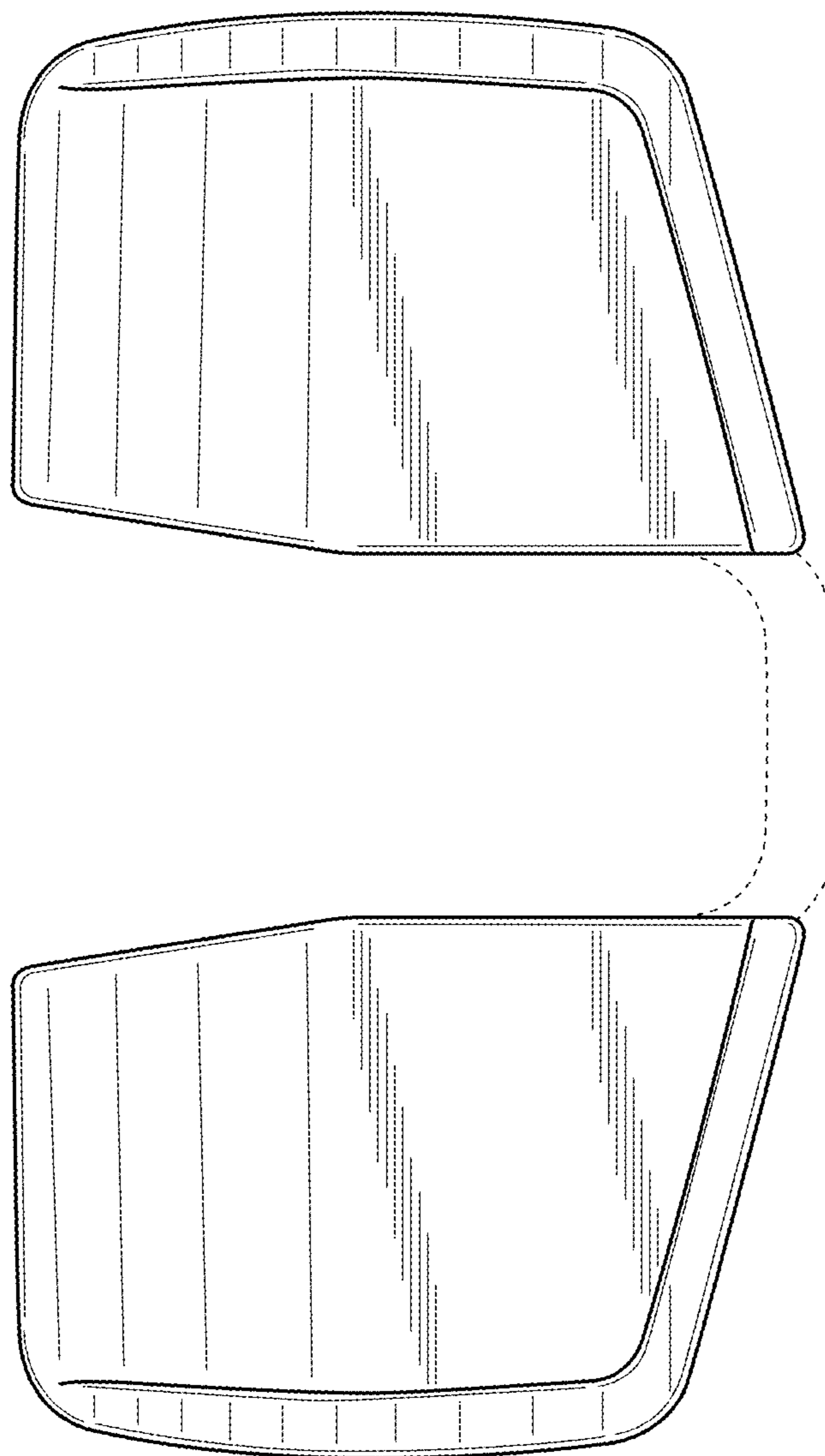

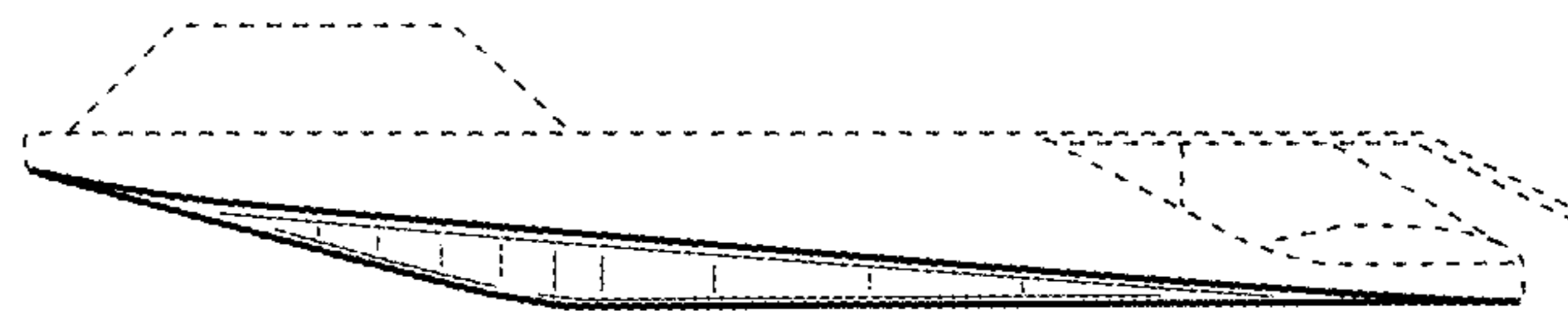

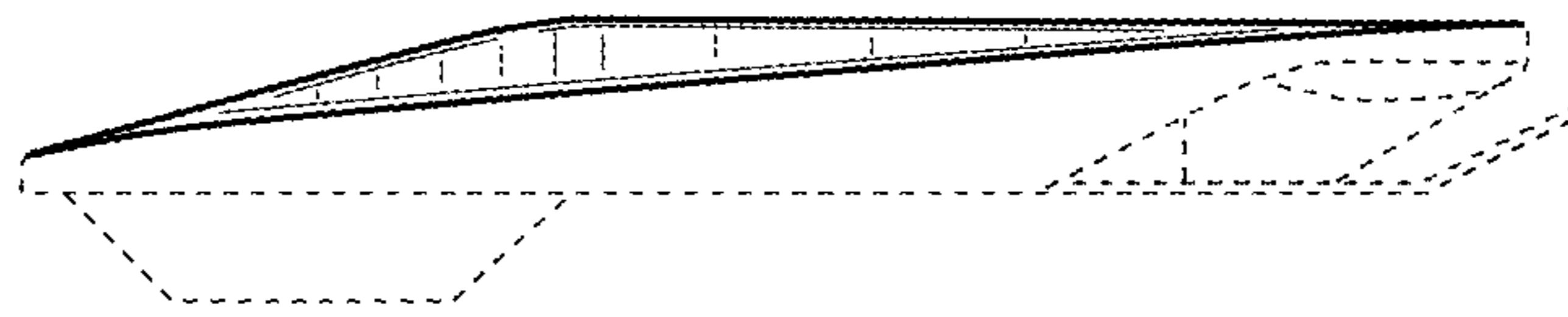

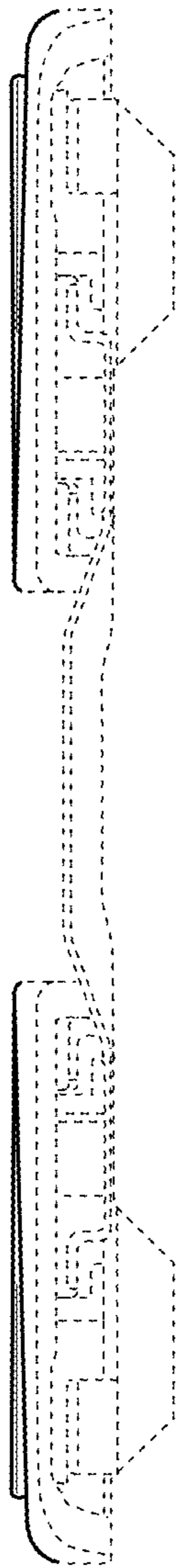
