FIG. 6 is a top plan view thereof.

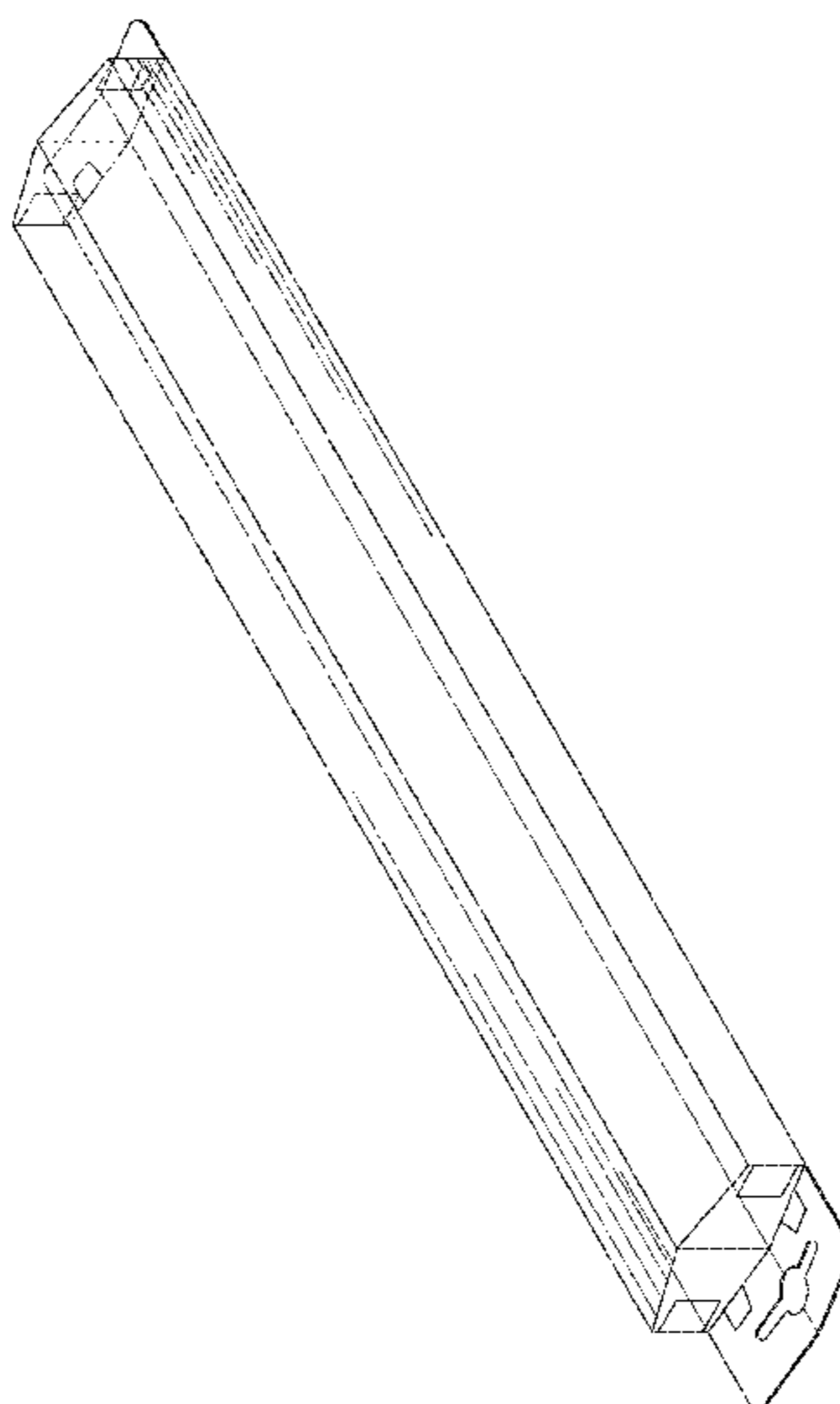
FIG. 7 is a bottom plan view thereof.

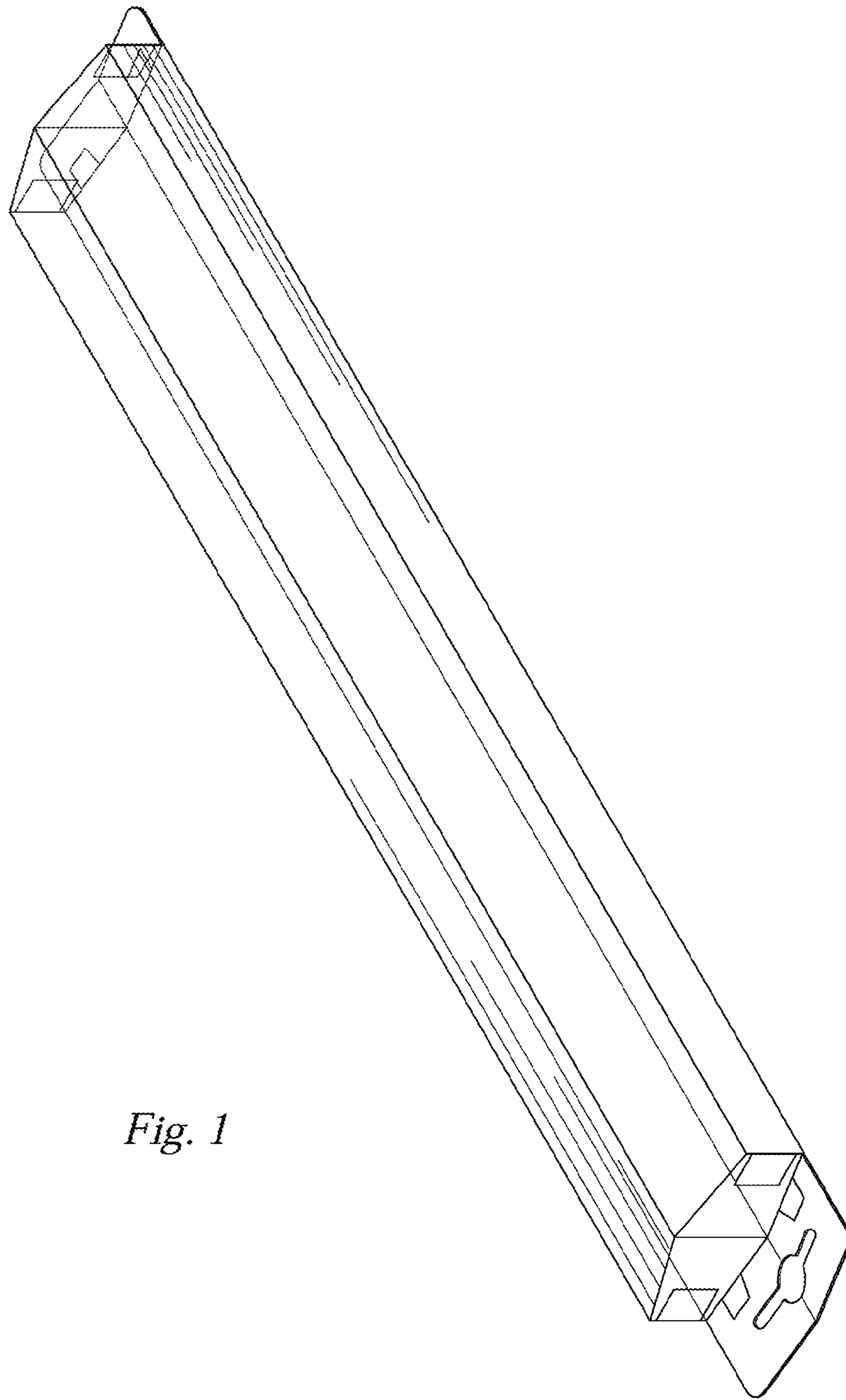
FIG. 8 is a plan view of the packaging container of this design in an unfolded planar configuration; and,

FIG. 9 is an isometric view of the packaging container of FIG. 1 with a wiper for automobile shown in the broken line.

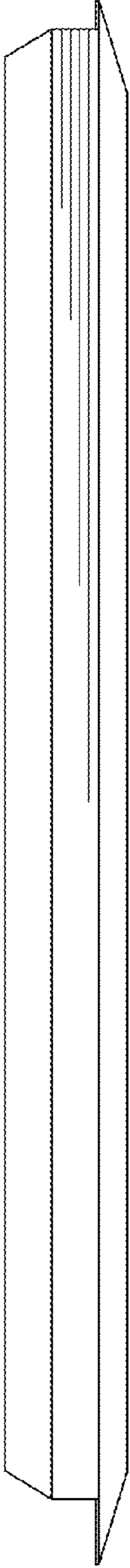
In the drawings, the broken lines in FIG. 9 of the wiper depict environmental subject matter only and form no part of the claimed design.

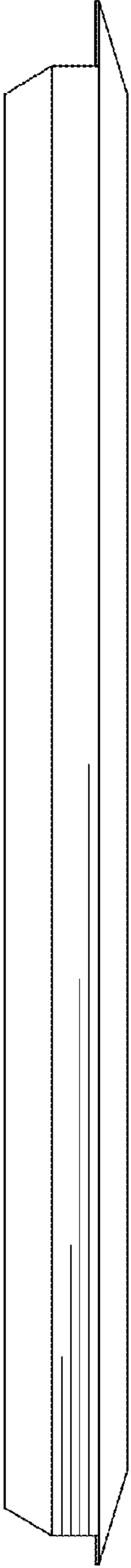




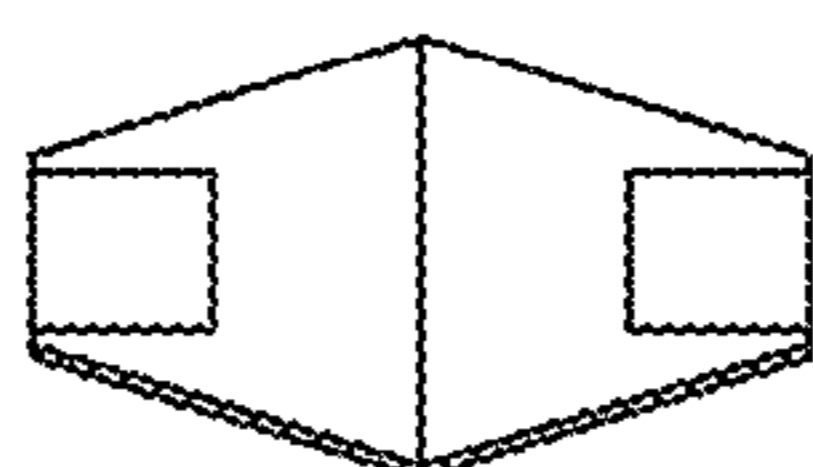

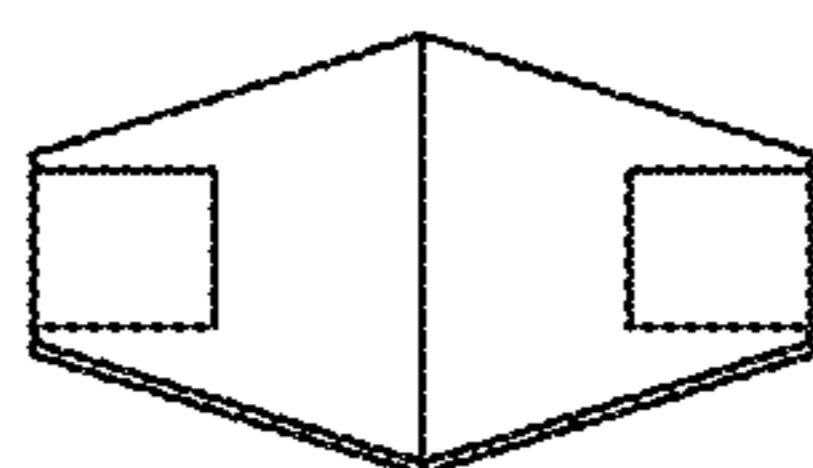

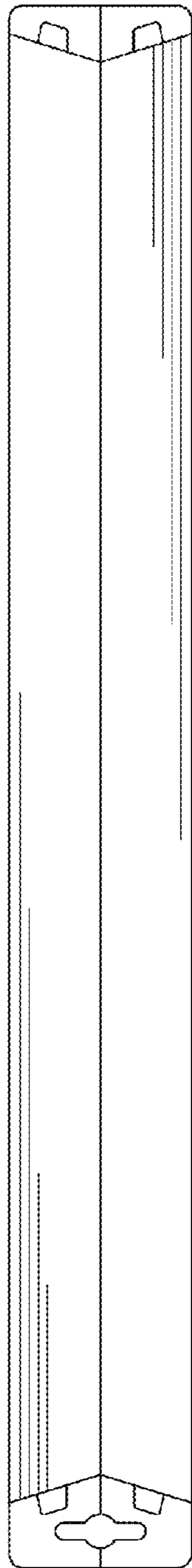

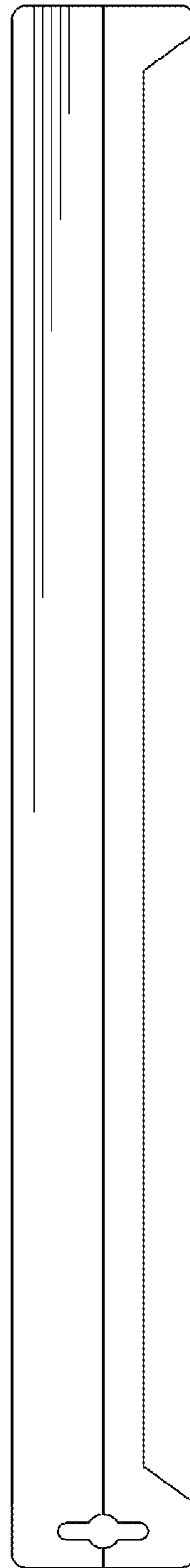

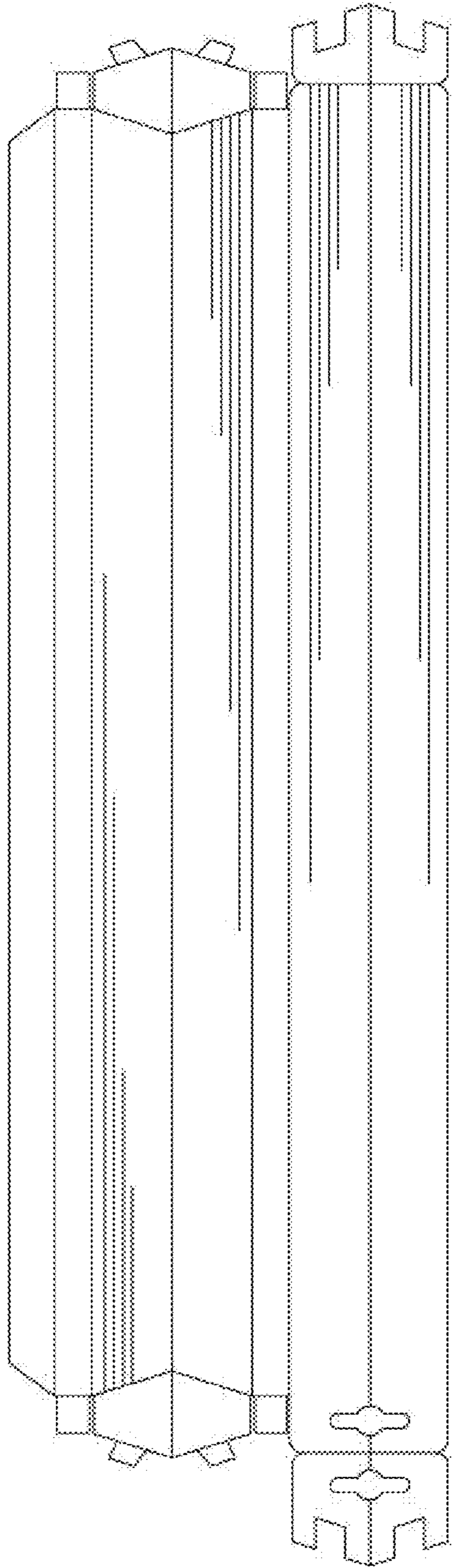

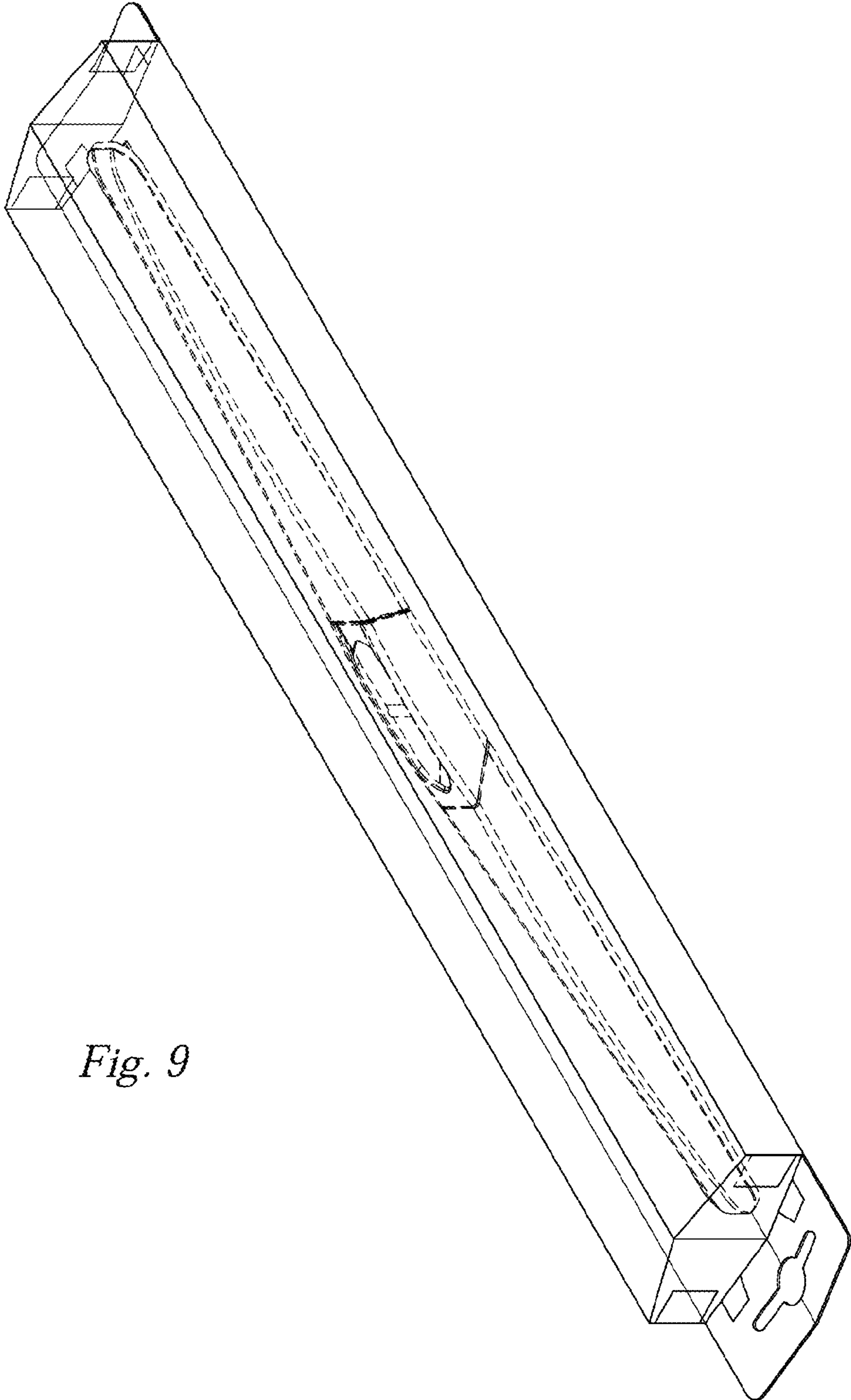
