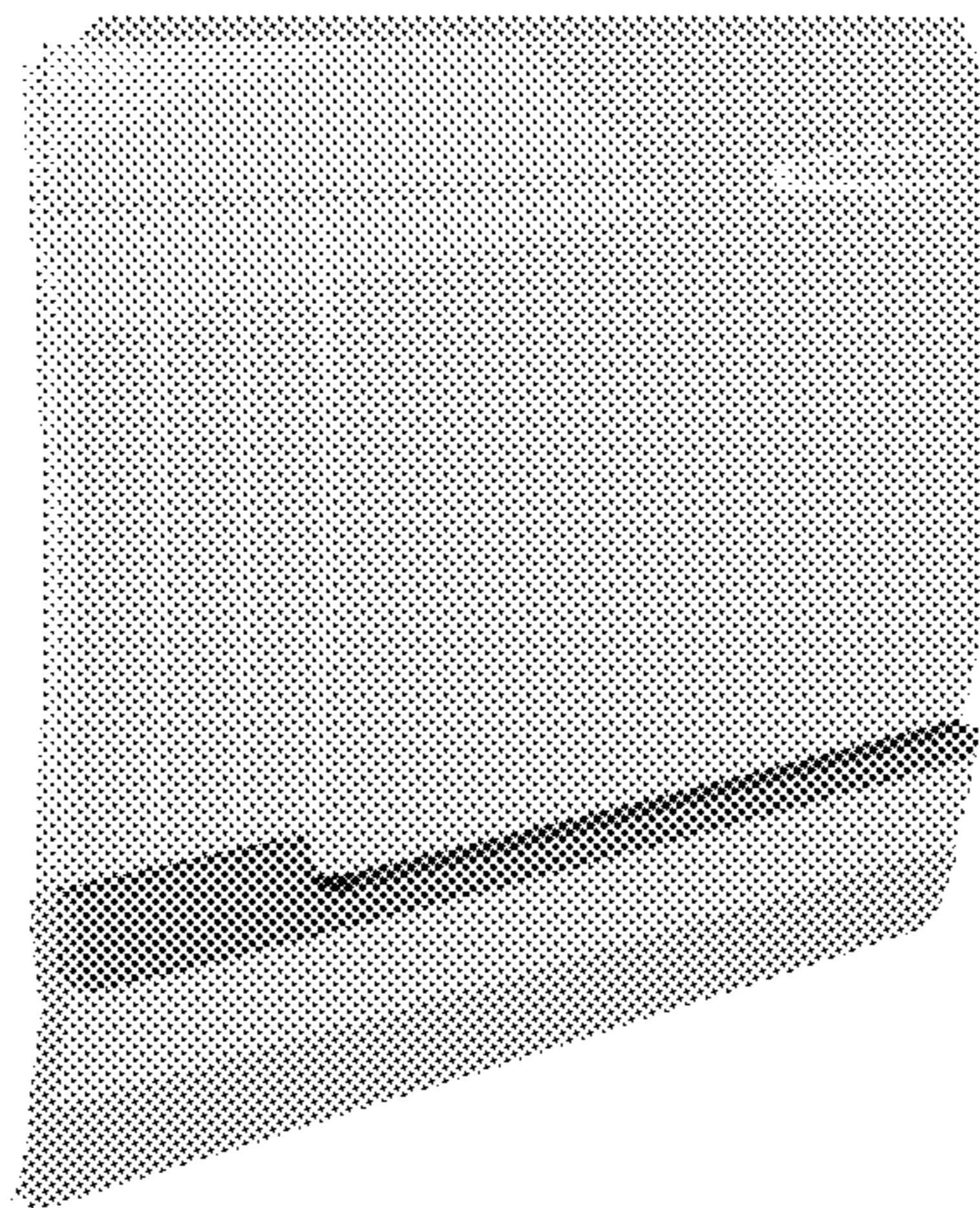
(57) **CLAIM**

The ornamental design for a vehicle door trim set, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the front left-side component for the vehicle door trim set;  
 FIG. 2 is a rear perspective view thereof;  
 FIG. 3 is an exterior side elevation view thereof;  
 FIG. 4 is an enlarged front view thereof;  
 FIG. 5 is an enlarged rear view thereof; and  
 FIG. 6 is a top plan view thereof.  
 FIG. 7 is a rear elevation view of the front left-side component for the vehicle door trim set installed into an environmental front door panel;  
 FIG. 8 is a front elevation view thereof;  
 FIG. 9 is a front perspective view thereof;

 FIG. 11 is an exterior side view thereof.  
 FIG. 12 is a front perspective view of the front right-side component for the vehicle door trim set;

 FIG. 25 is an exterior side elevation view thereof;  
 FIG. 26 is an enlarged rear elevation view thereof;  
 FIG. 27 is an enlarged front elevation view thereof; and  
 FIG. 28 is a top plan view thereof; and,  
 FIG. 29 is an exterior side view of the vehicle door trim set incorporated into the doors of a motor vehicle.  
 The de-emphasized and halftone portions shown in the drawings illustrate environmental structure for the vehicle door trim set that forms no part of the claimed design.

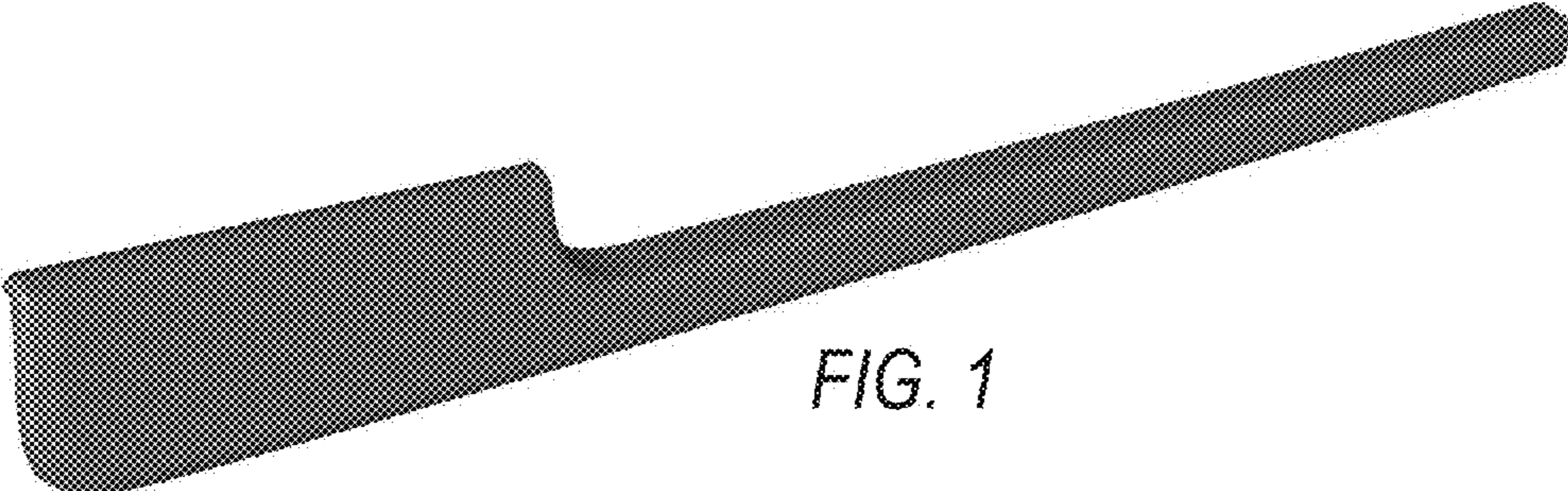

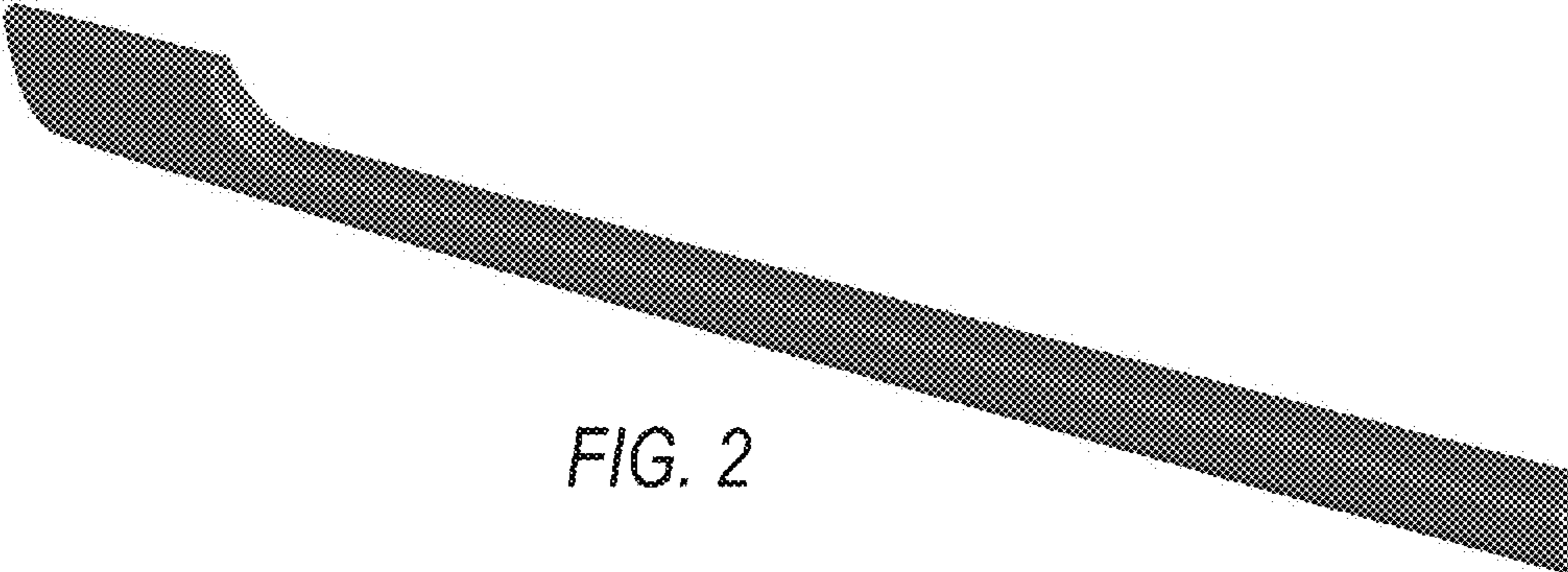

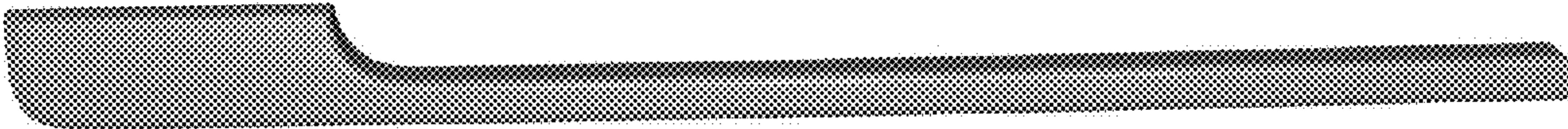

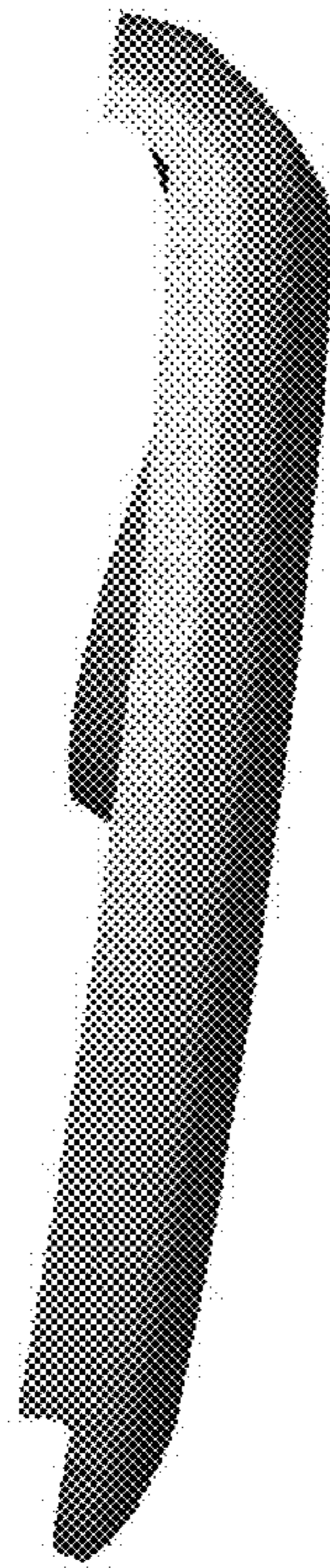

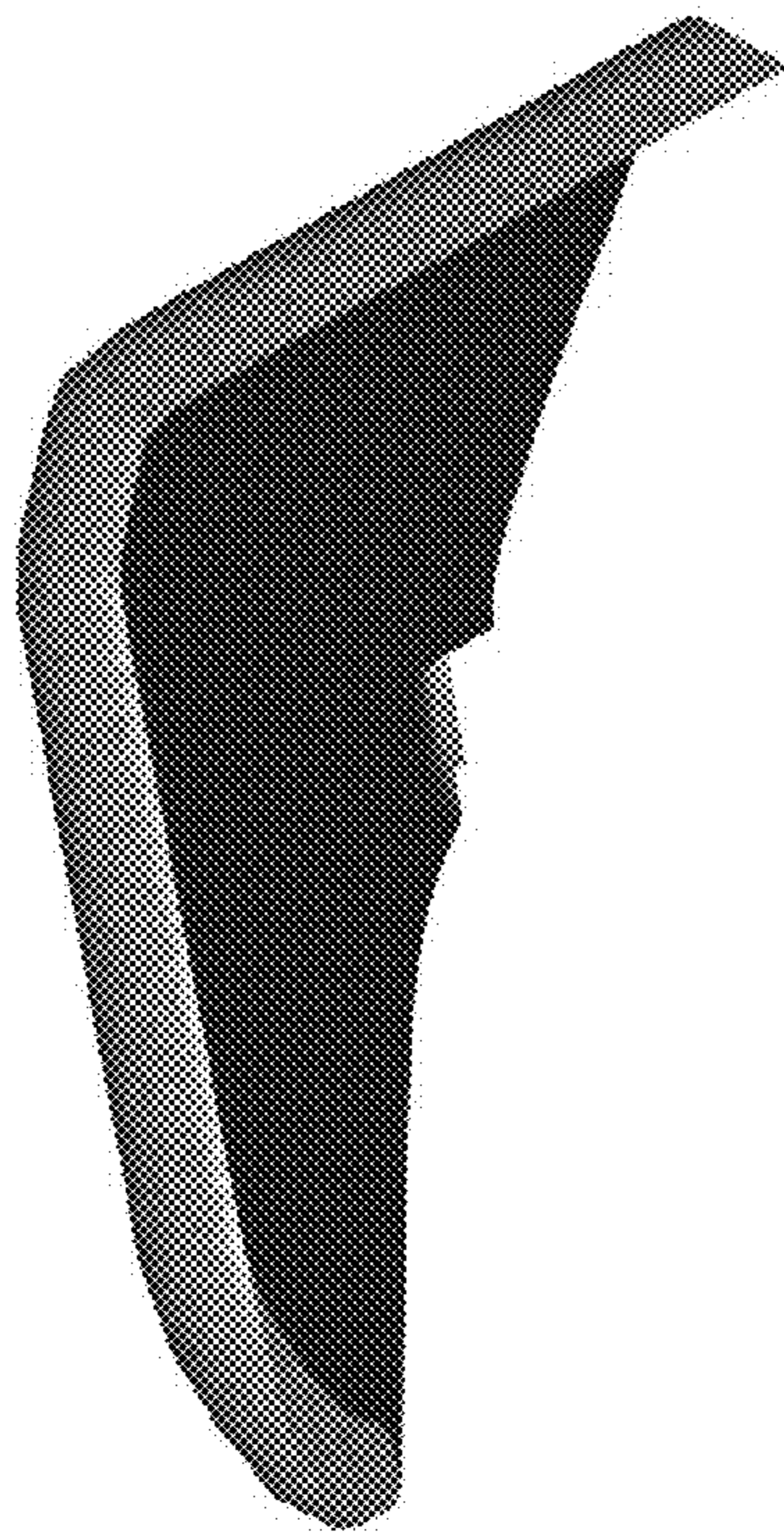

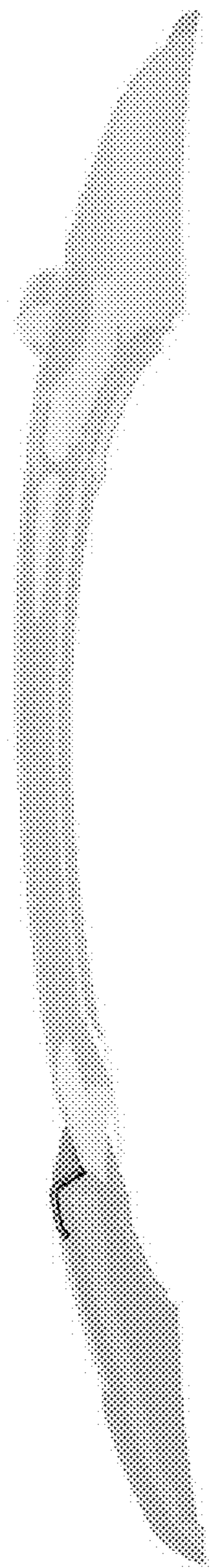

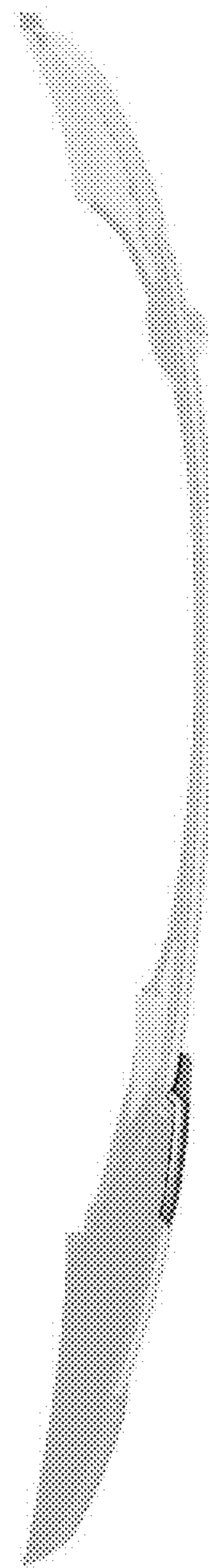

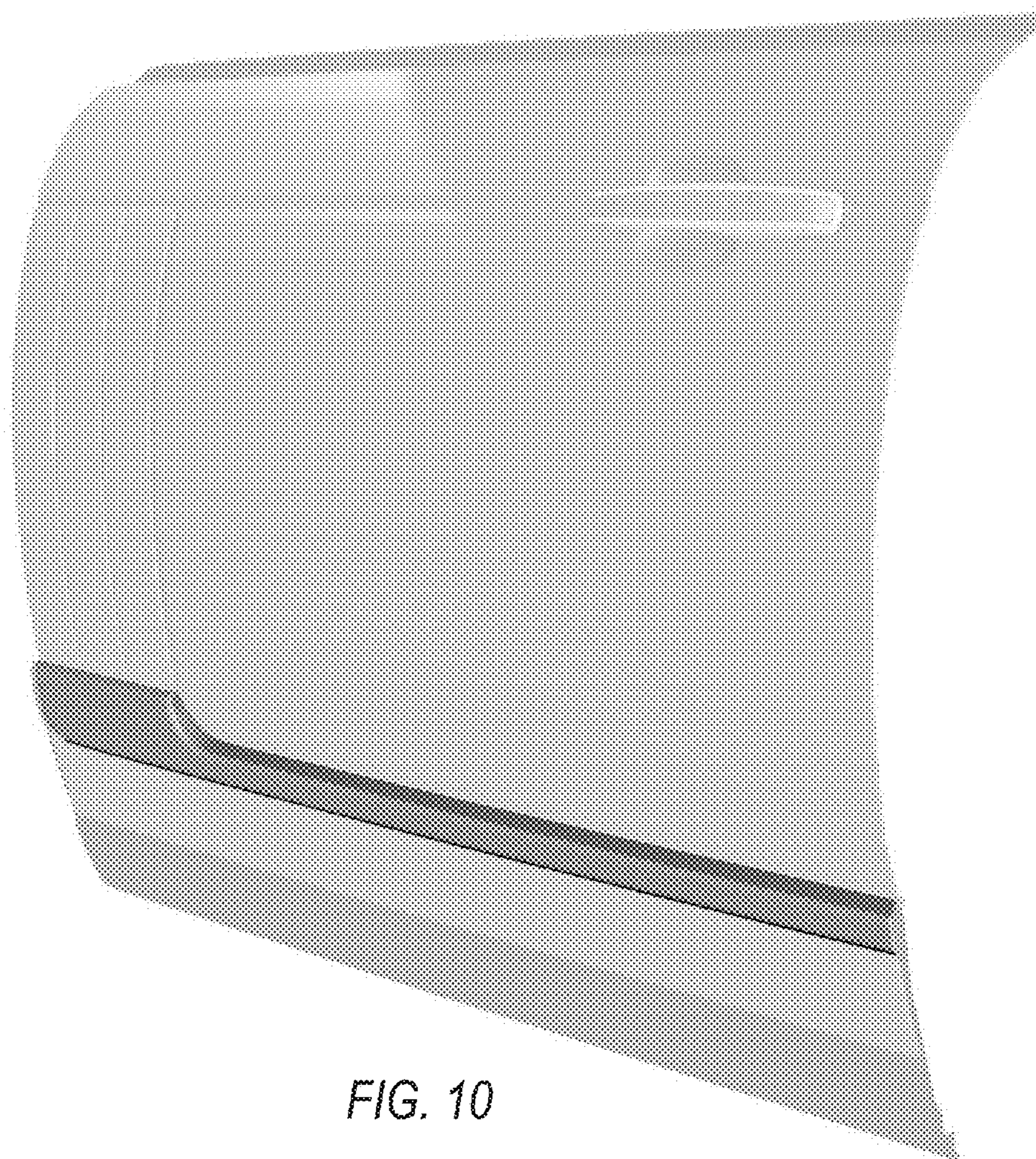

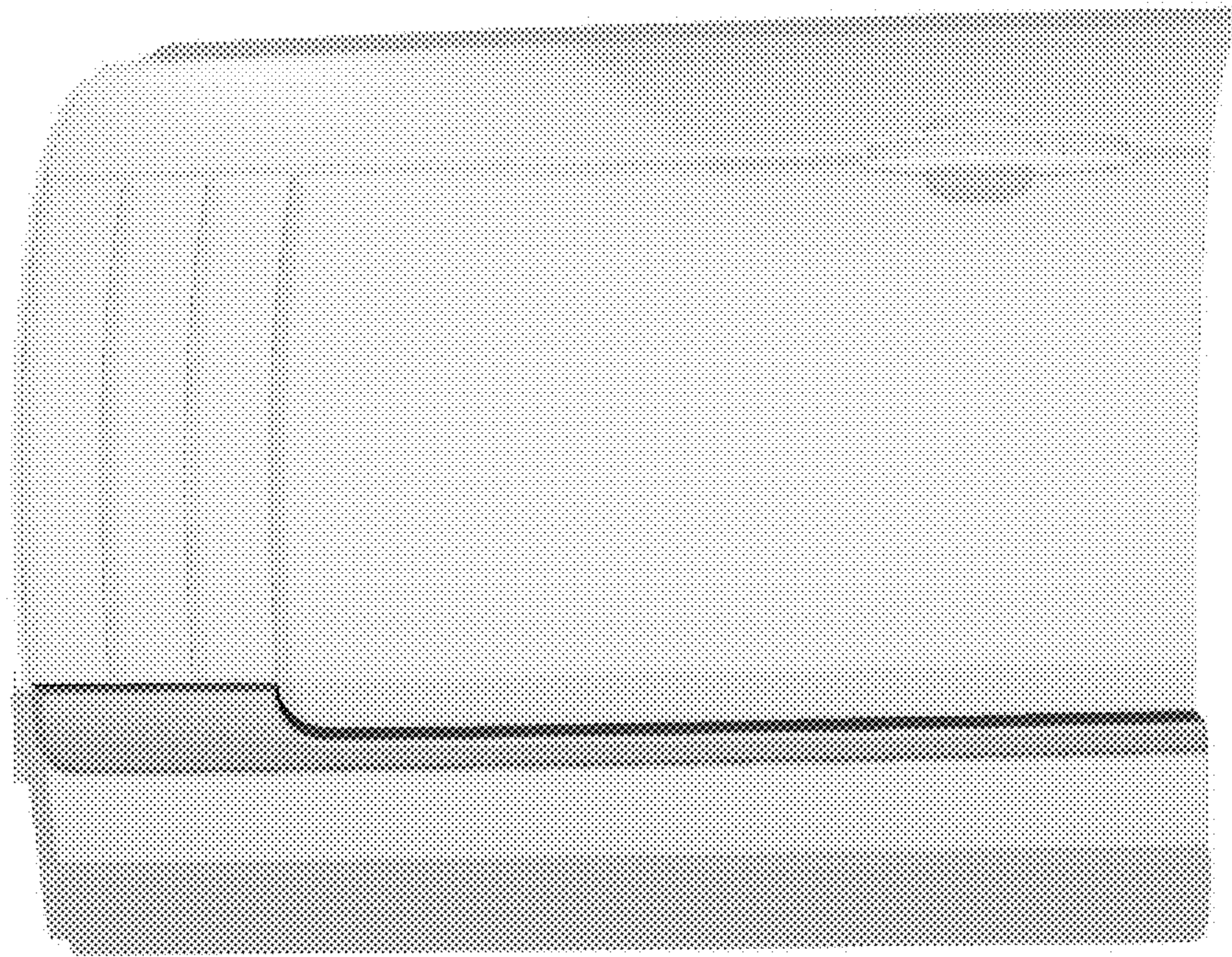

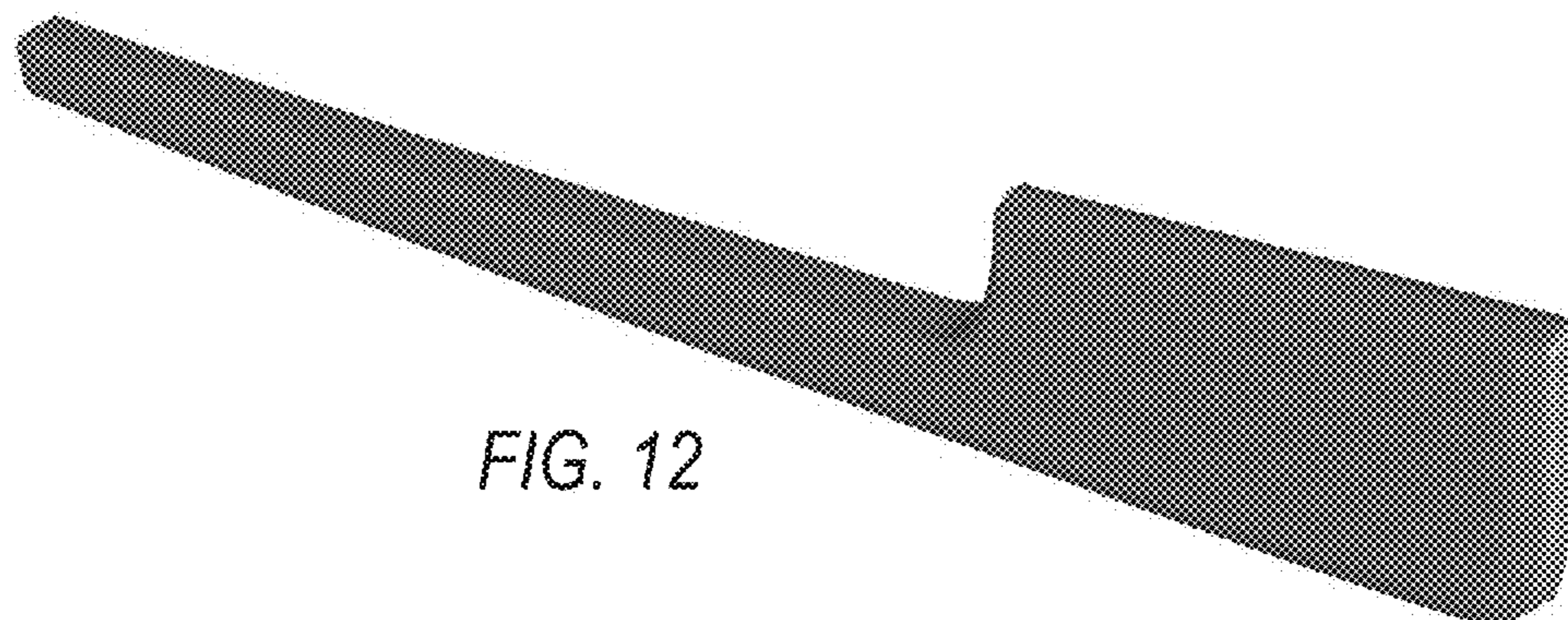

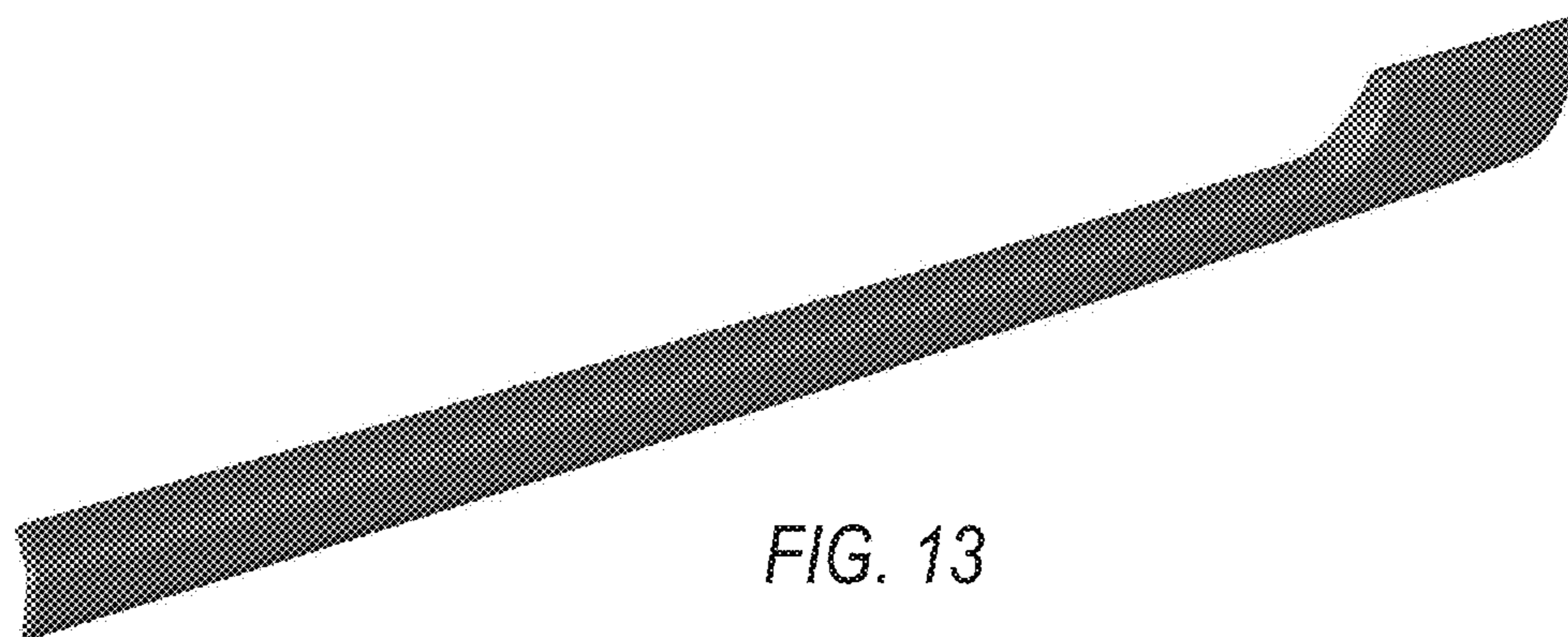

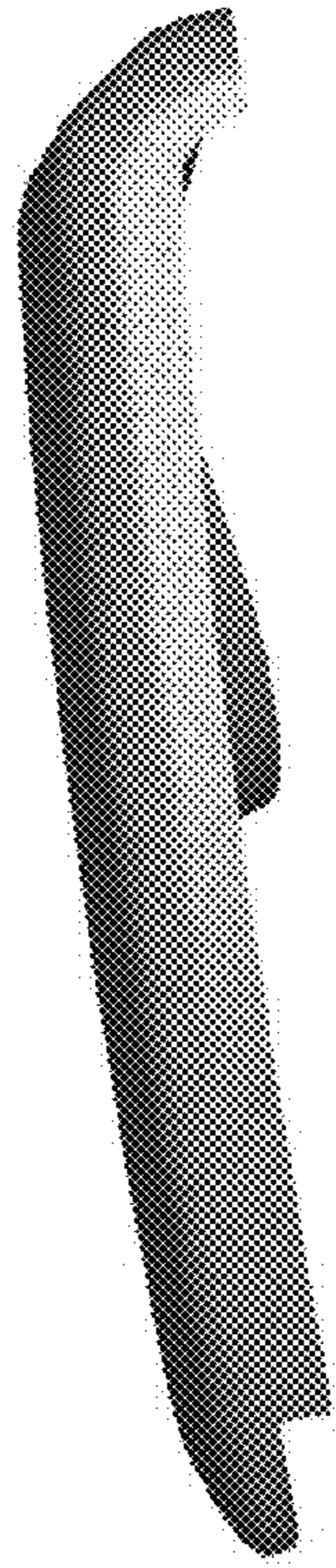

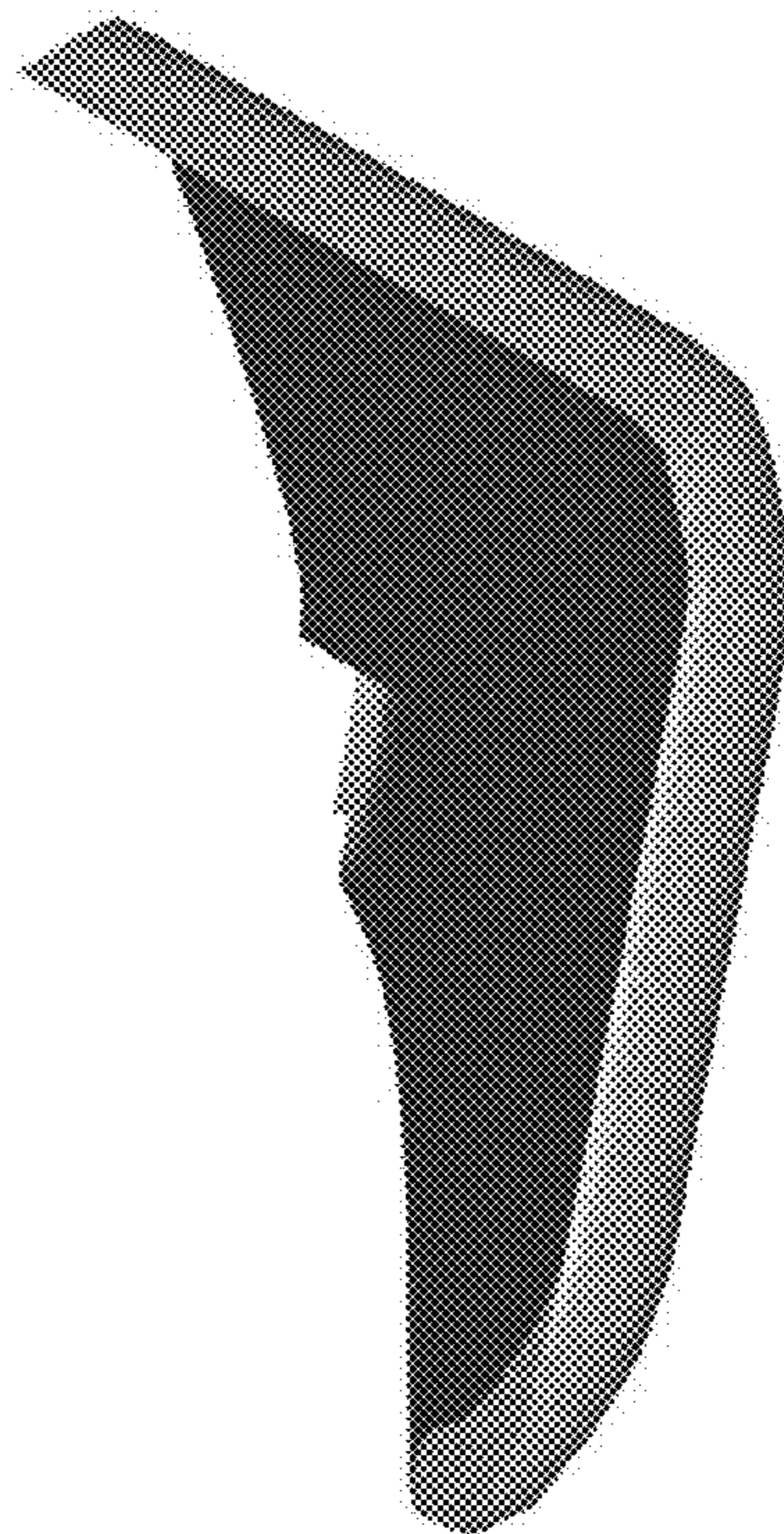

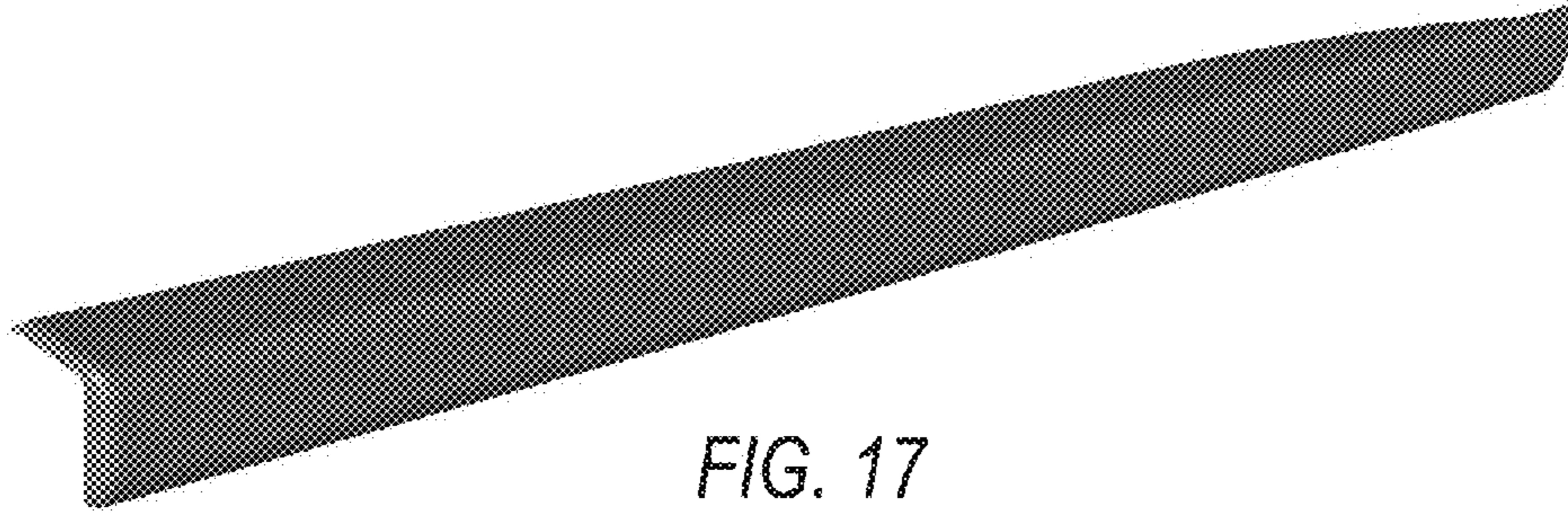

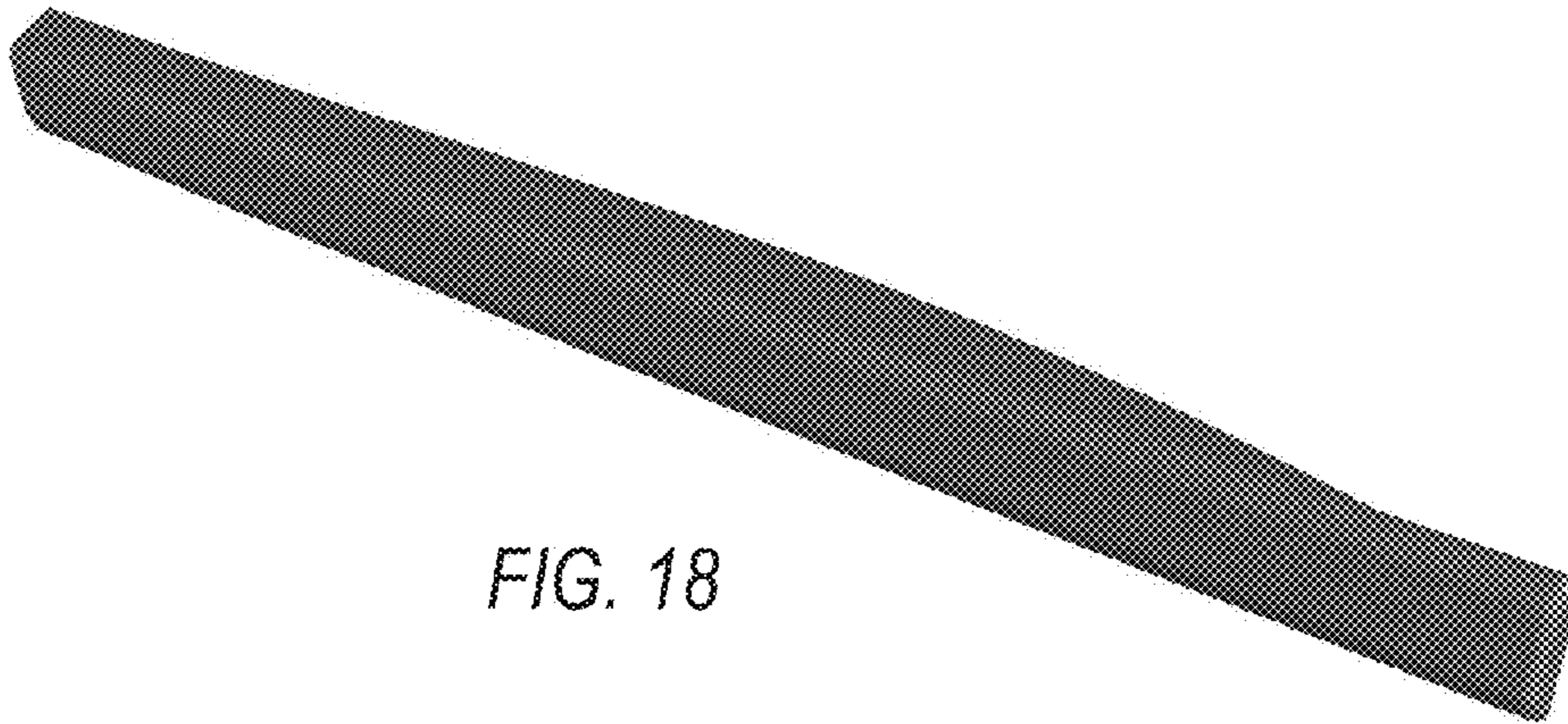

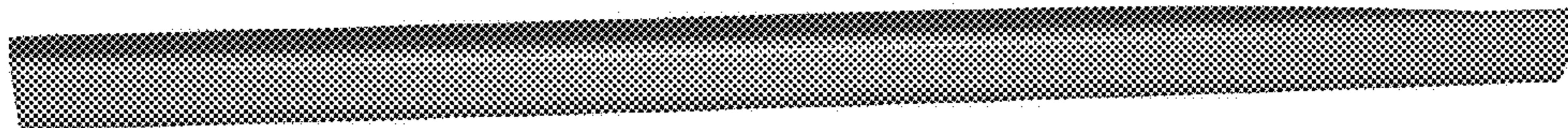

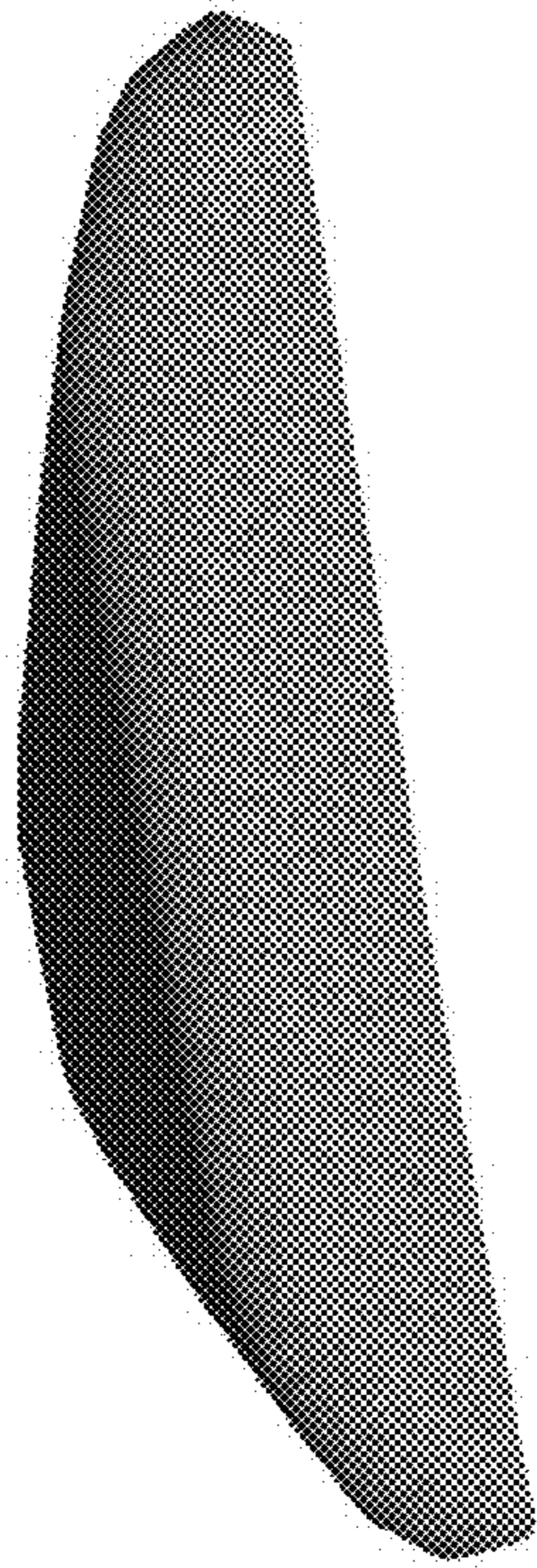

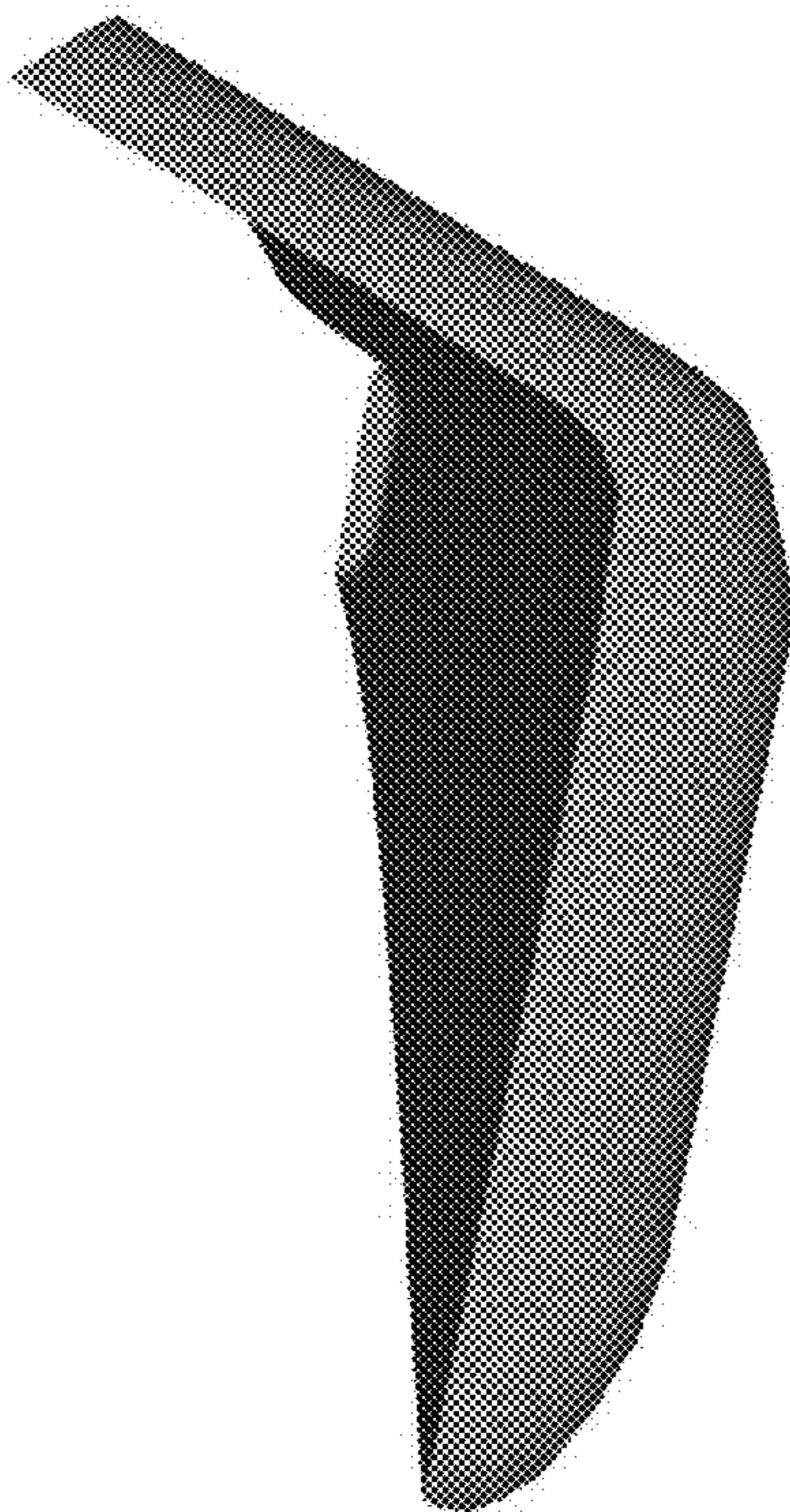

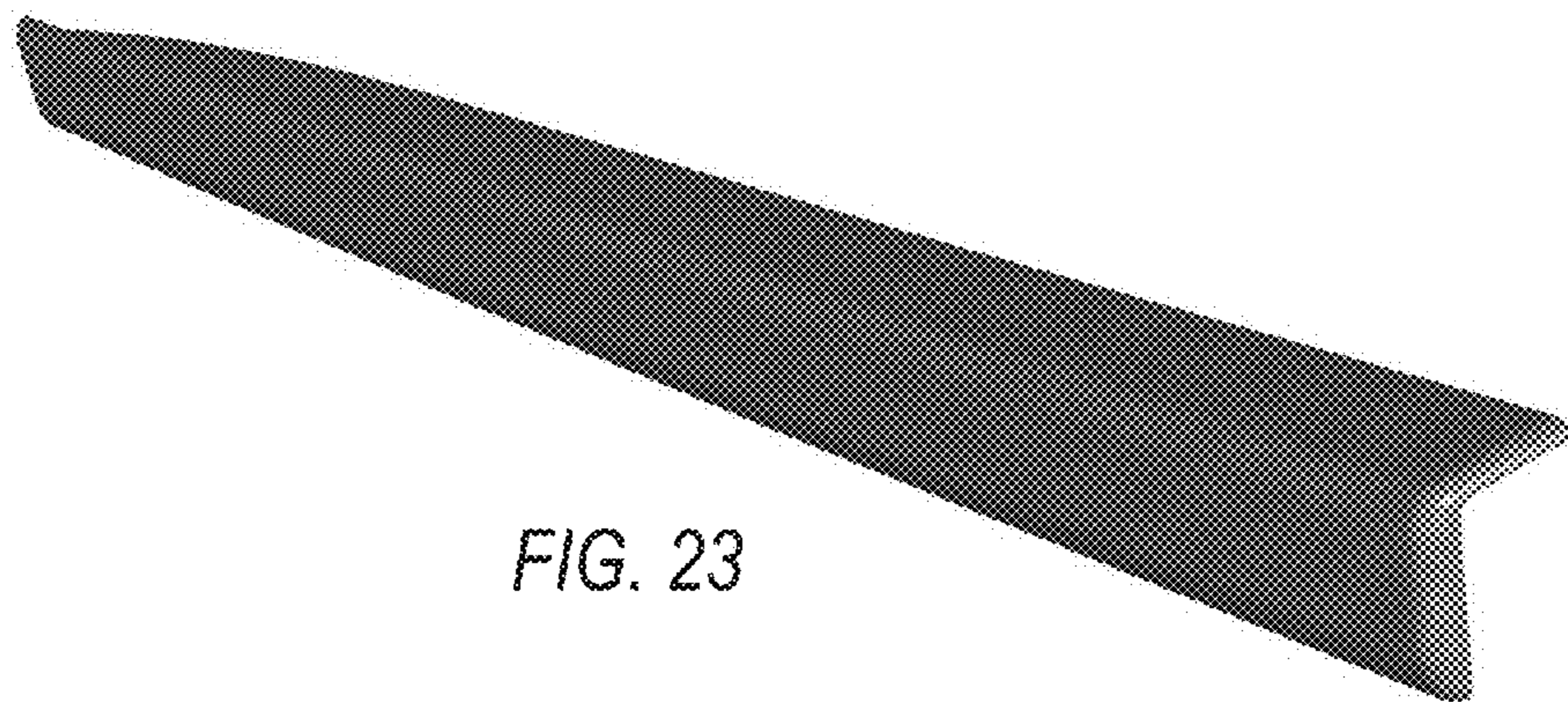

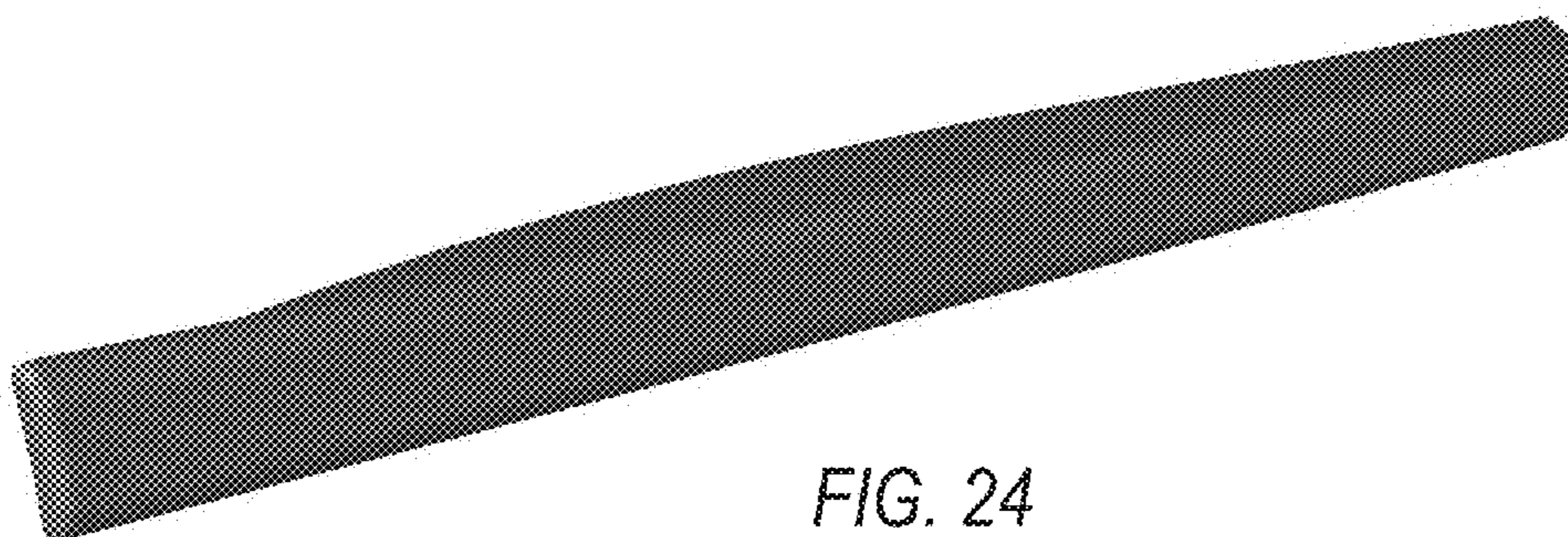

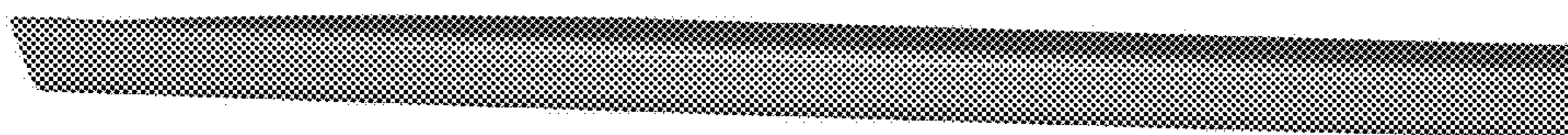

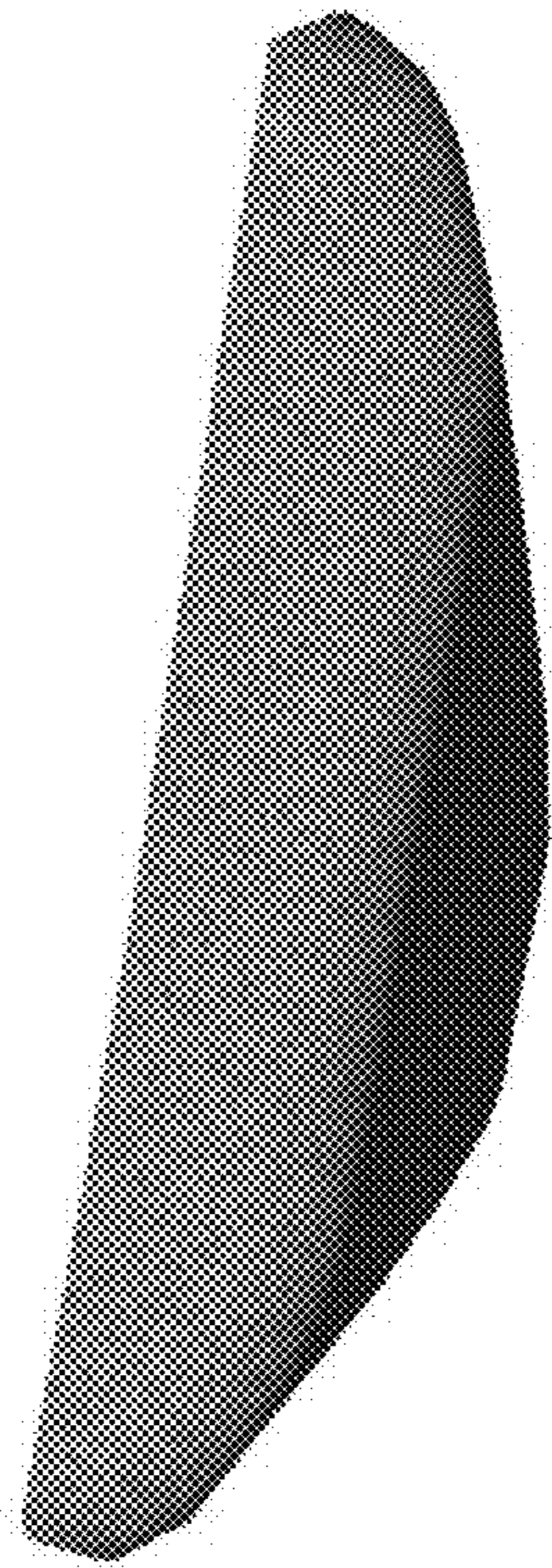

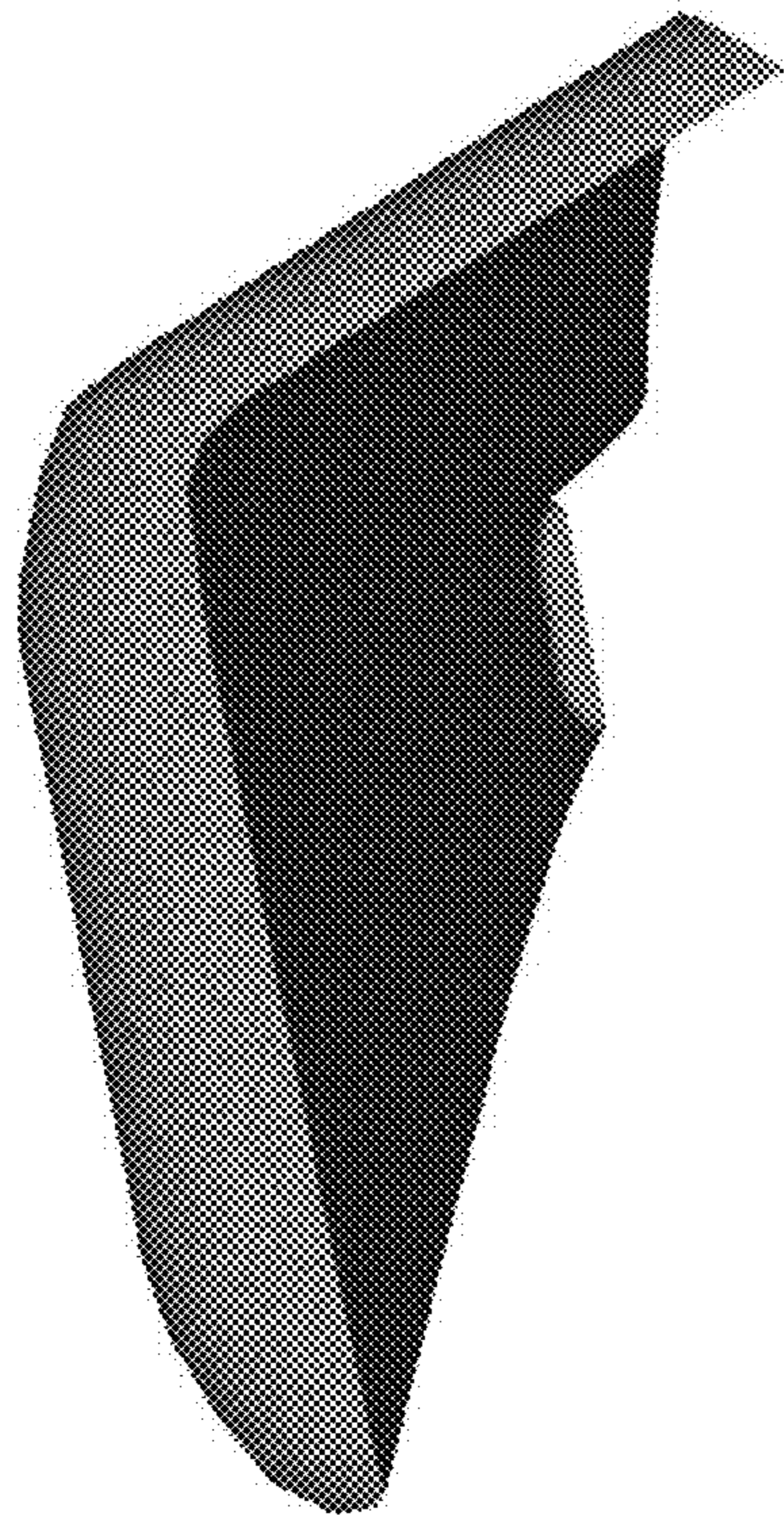

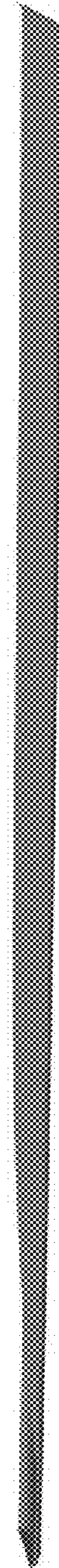

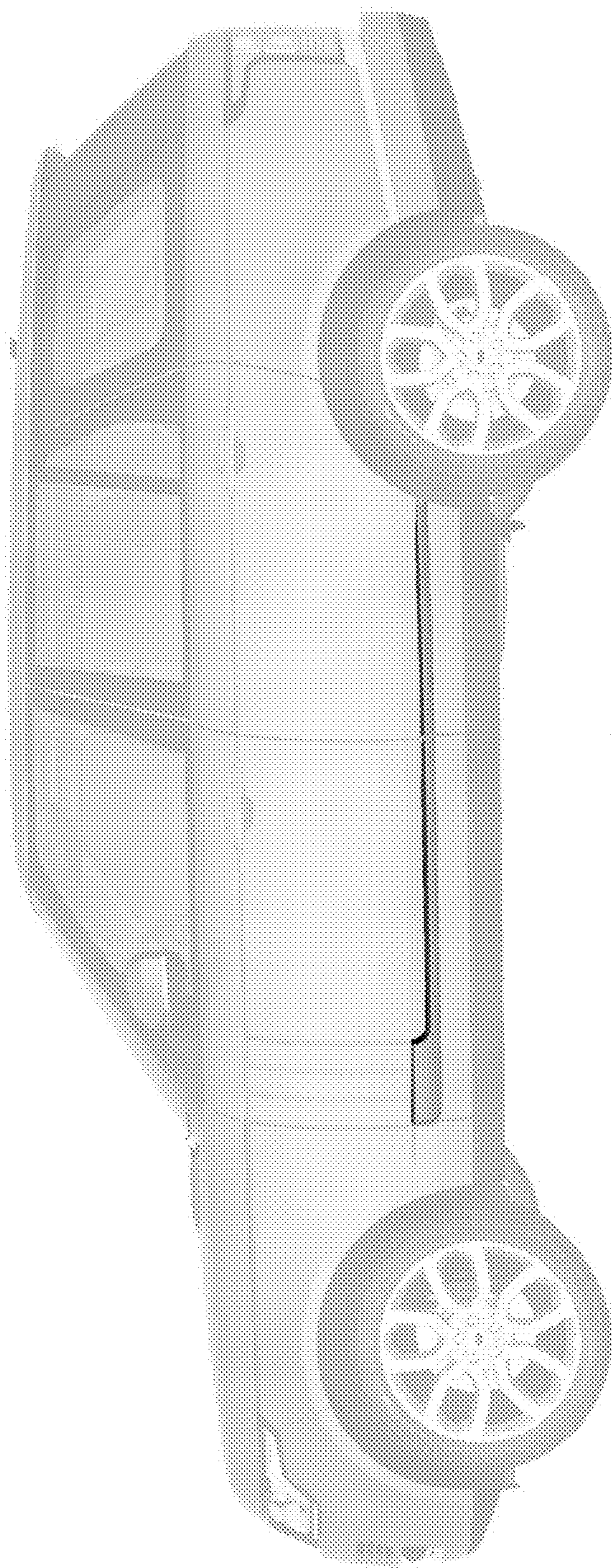
