FIG. 9 is a cross-sectional view thereof, taken along the line 9-9 of FIG. 2 with internal features being omitted.

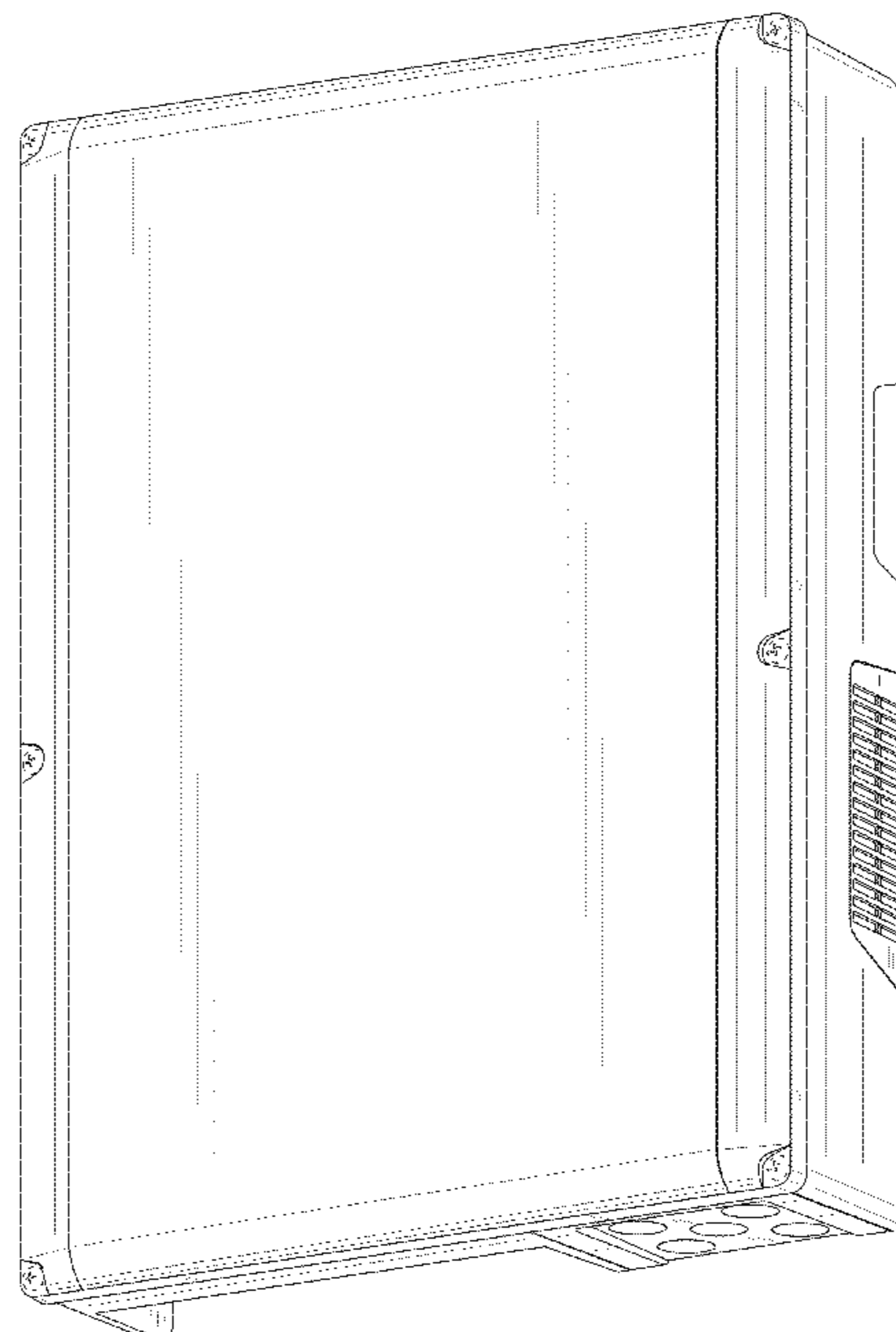

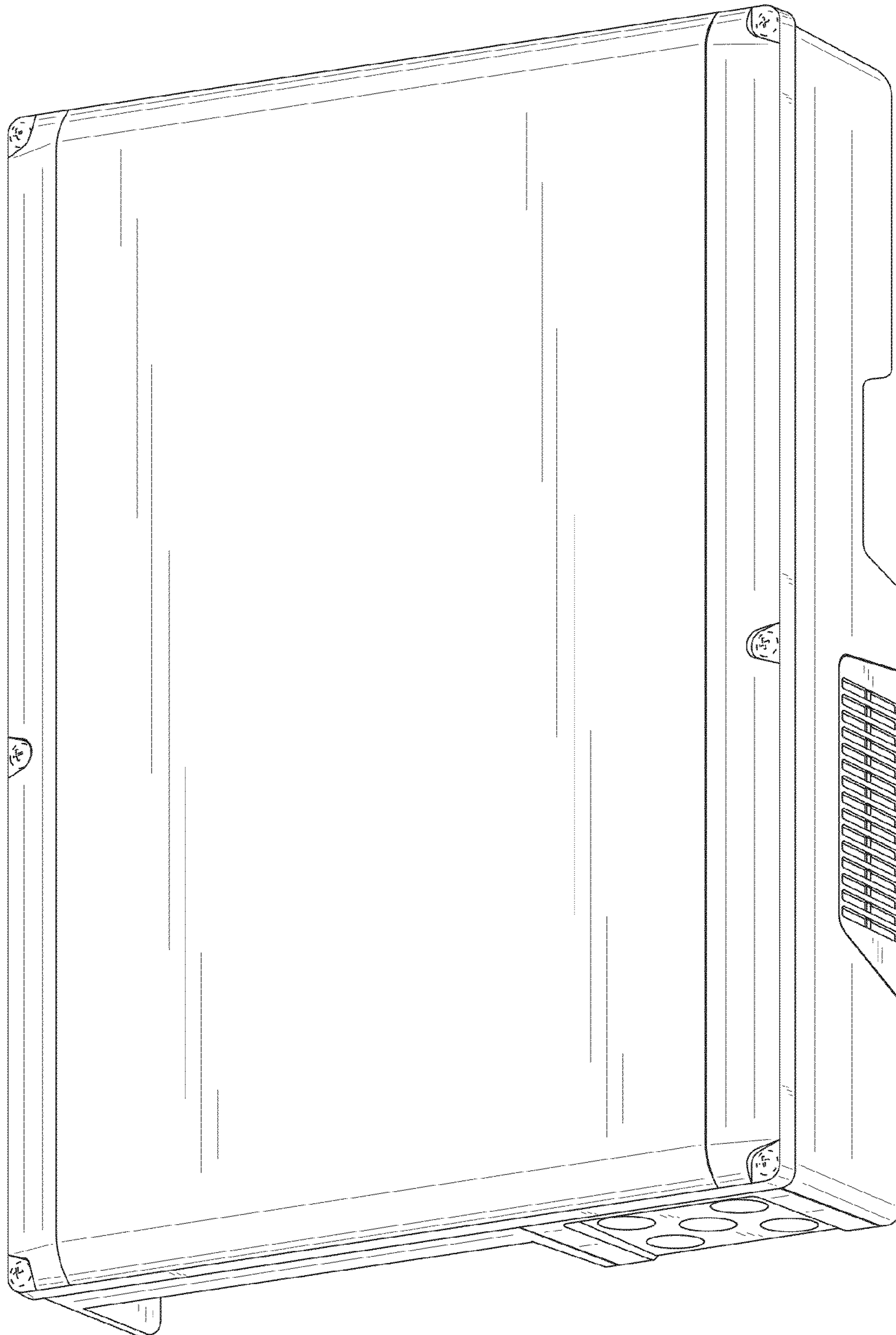

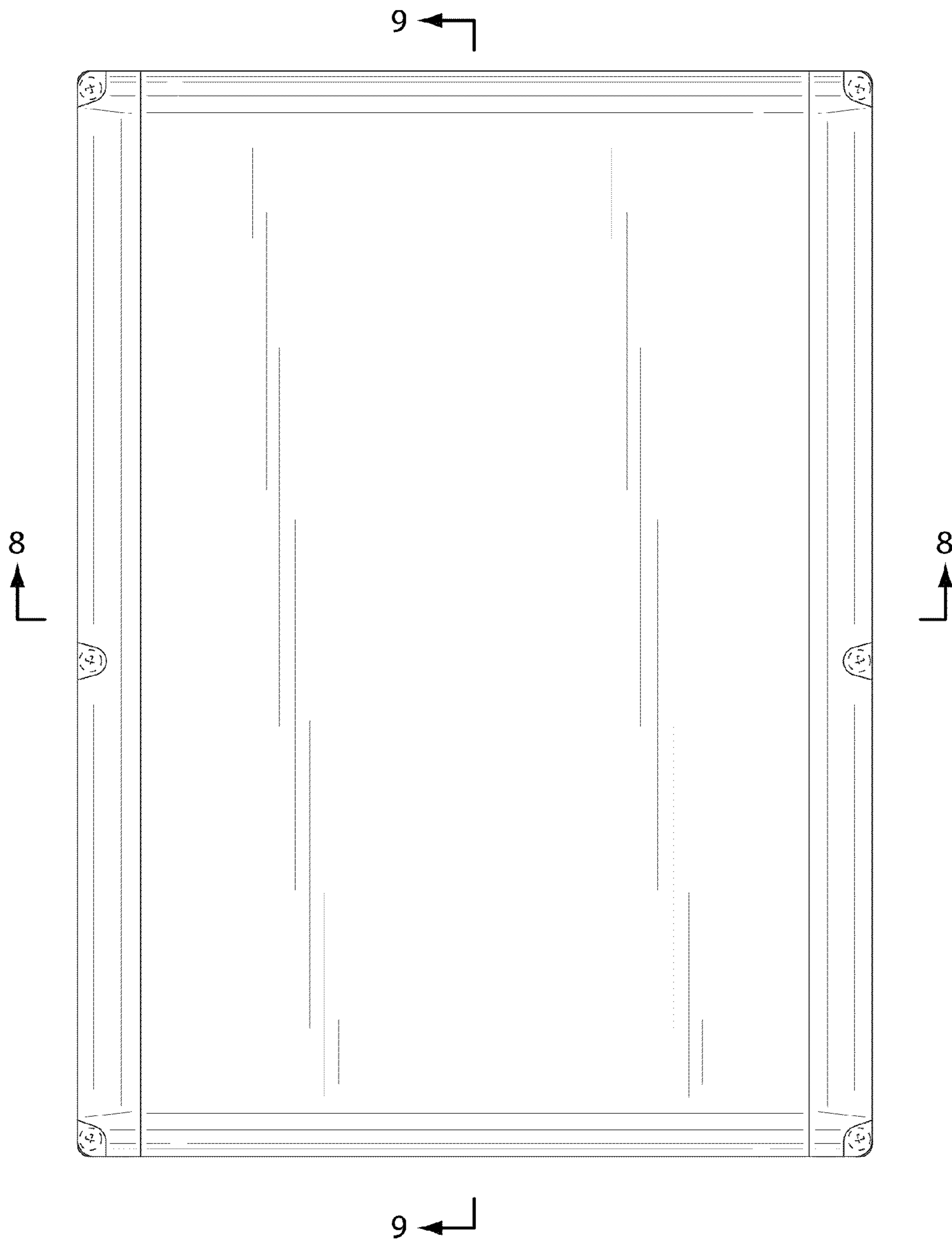

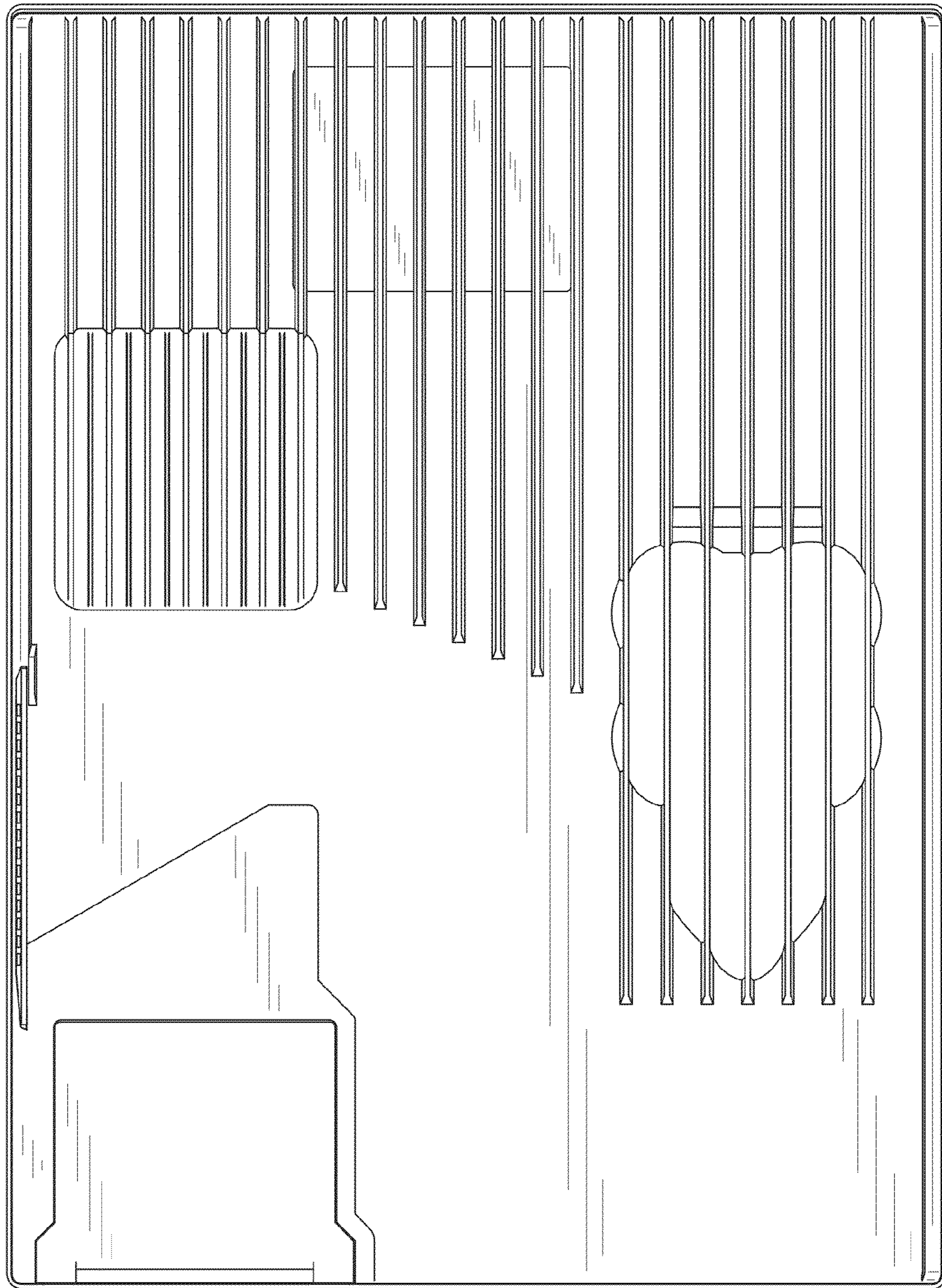

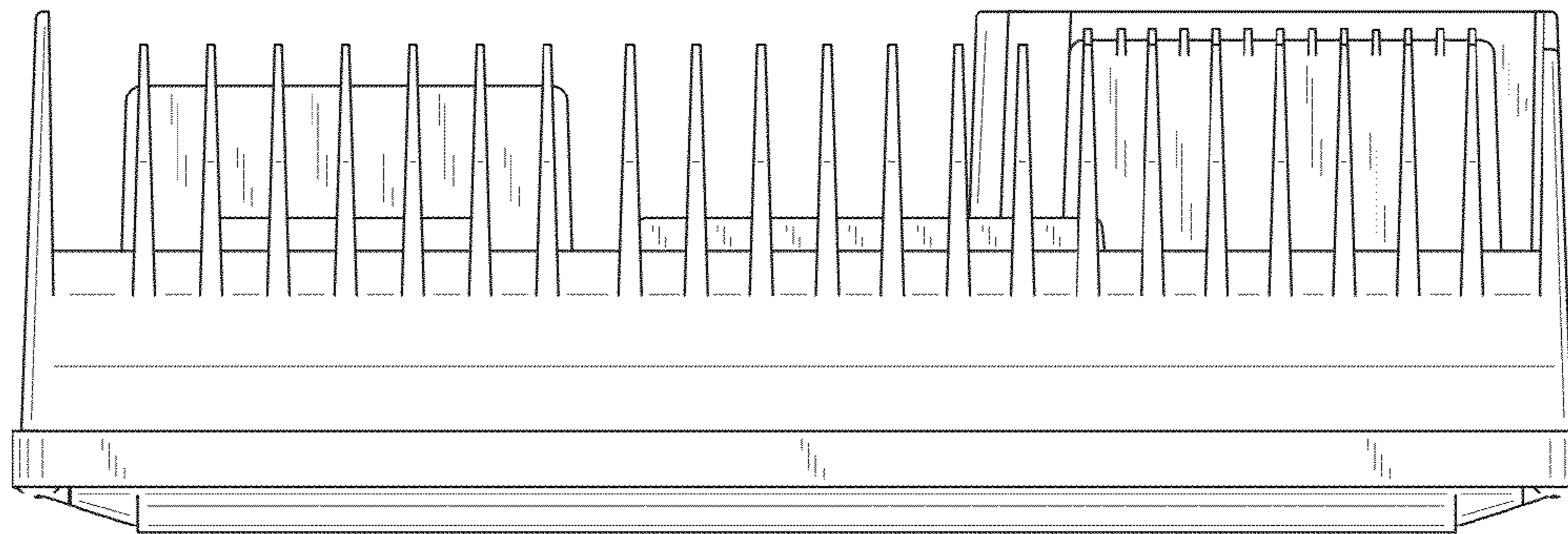

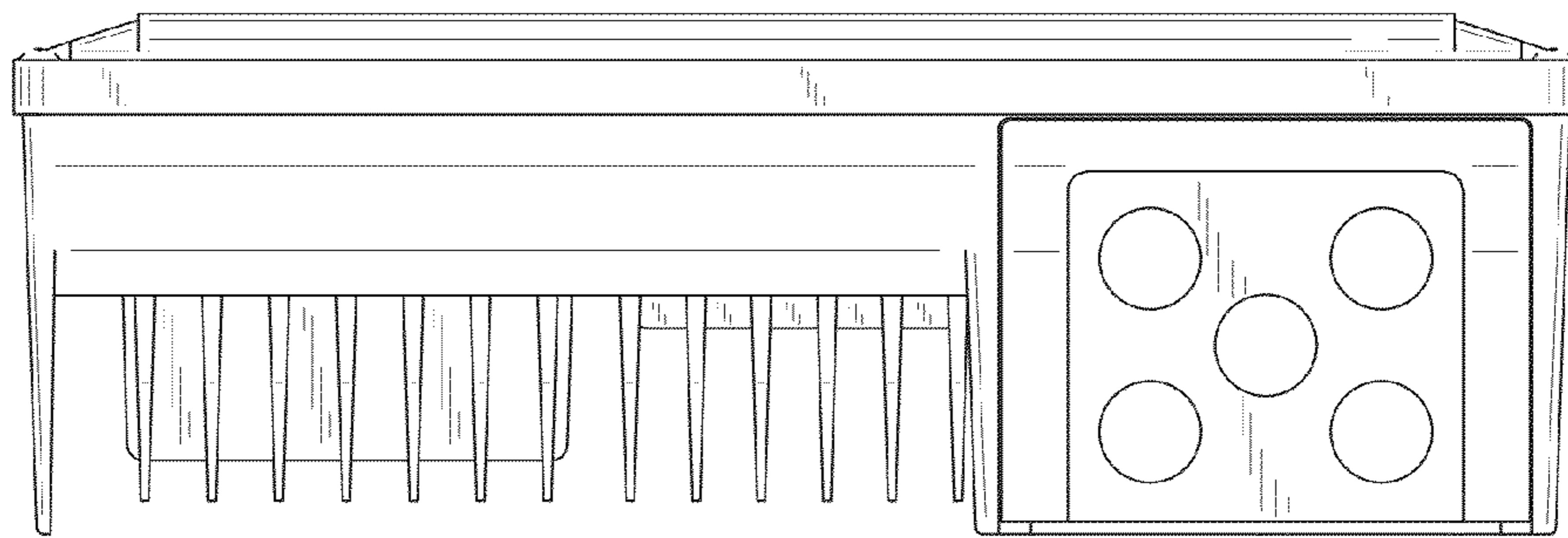

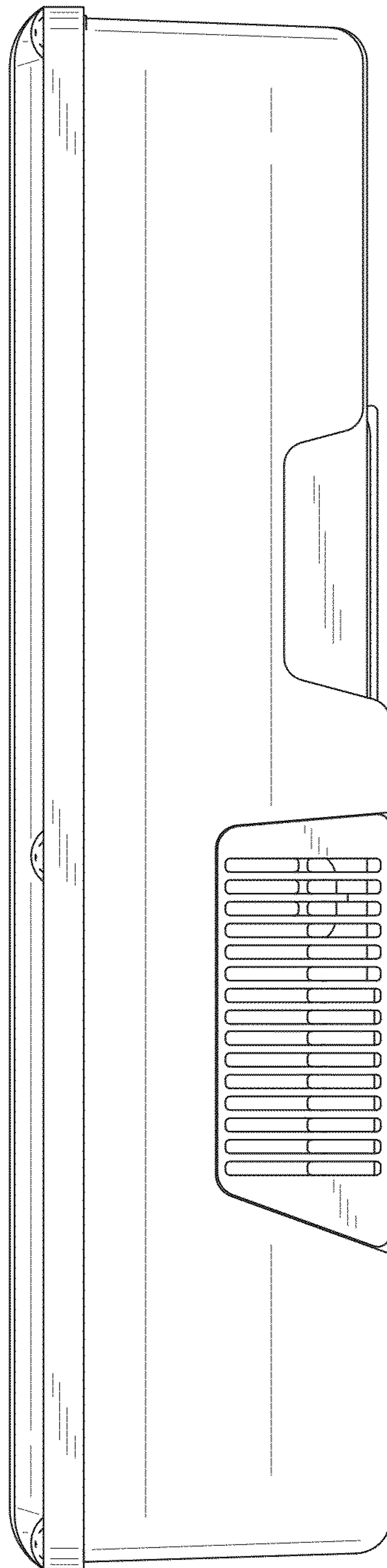

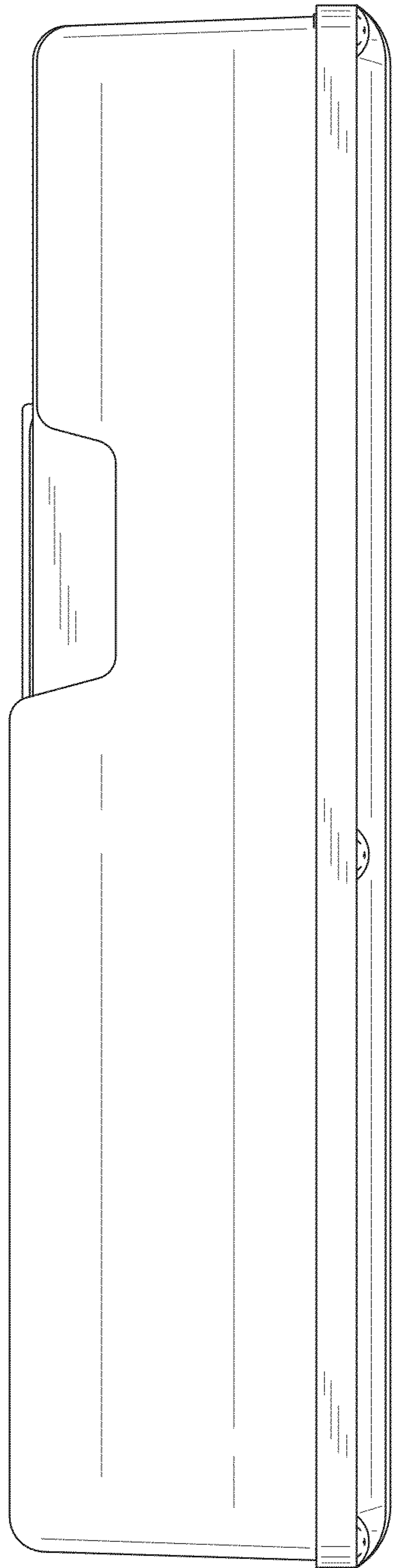

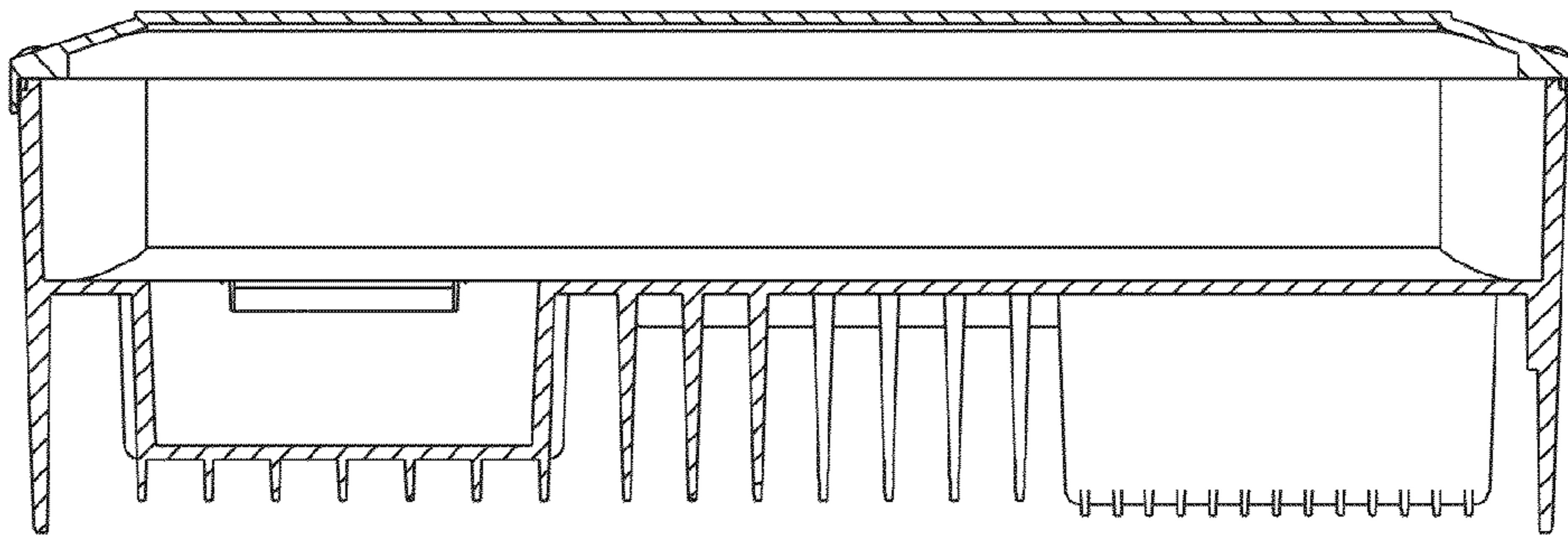

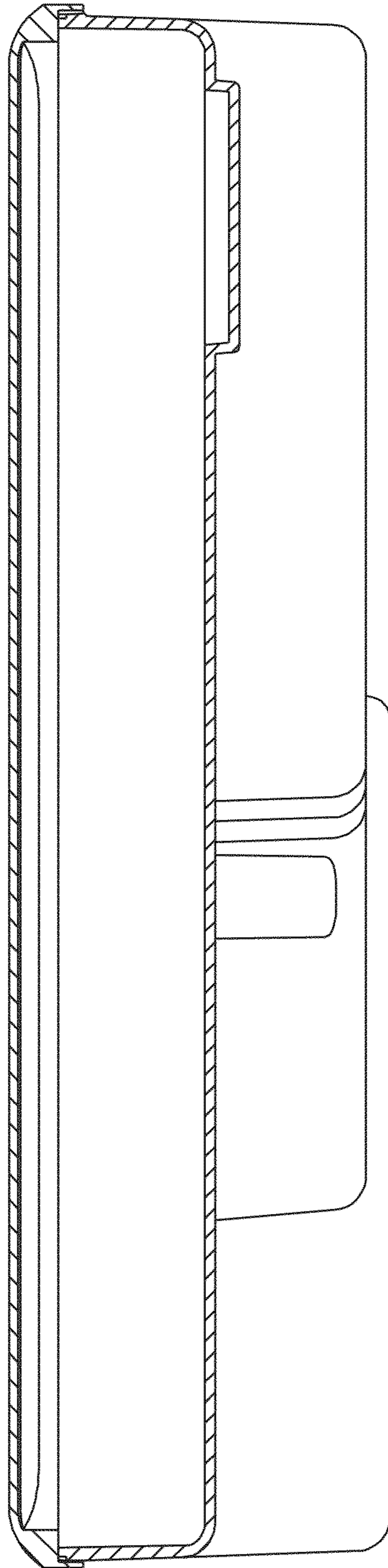
