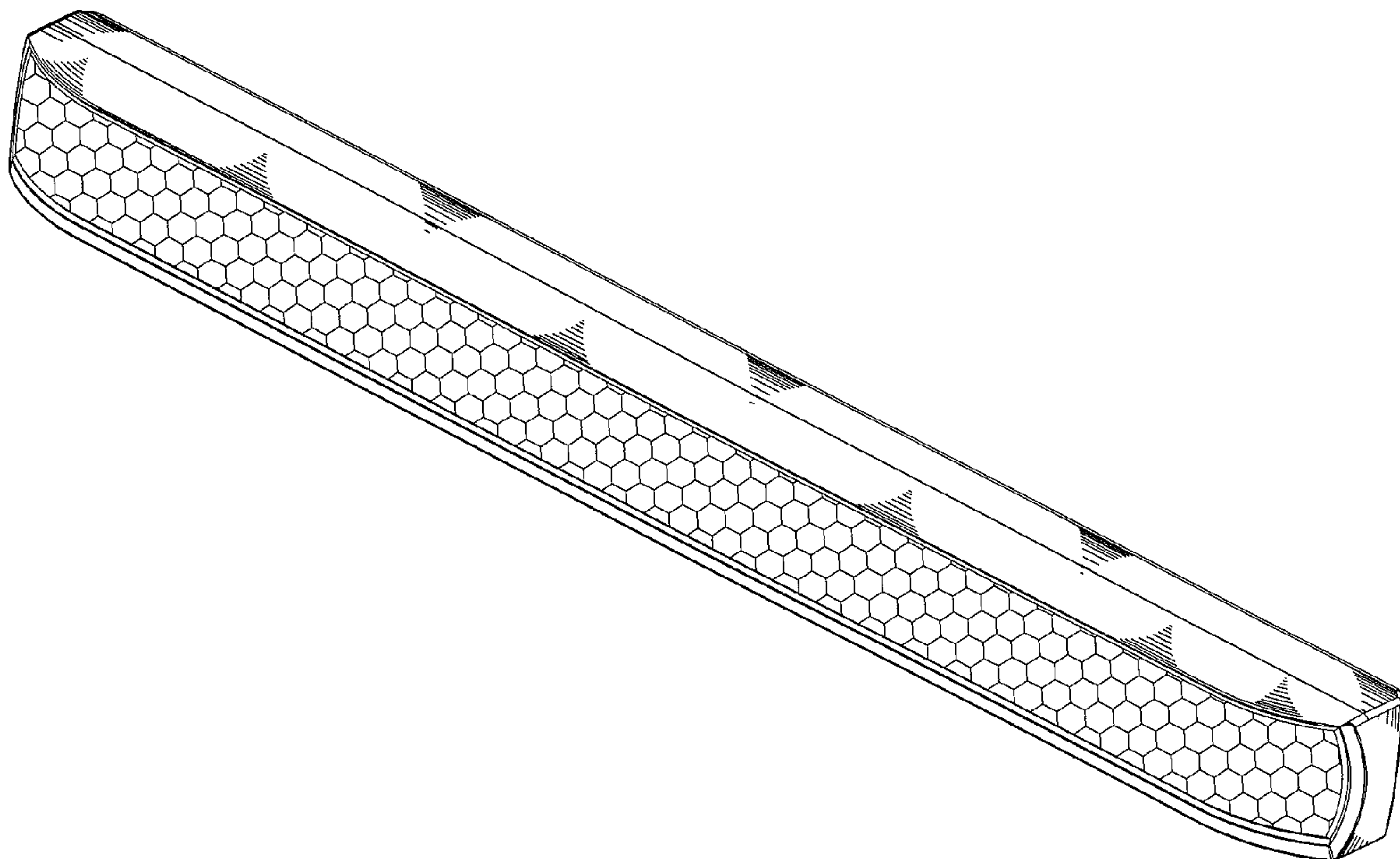
(57) **CLAIM**

The ornamental design for a speaker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a speaker showing my design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is an enlarged left side elevational view thereof; FIG. 5 is an enlarged right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a sectional view, taken along line 8-8 of FIG. 2; FIG. 9 is an enlarged view of the “Det-9” of FIG. 4; and, FIG. 10 is an enlarged view of the “Det-10” of FIG. 8. The features shown in broken lines depict environmental subject matter only and form no part of the claimed design.

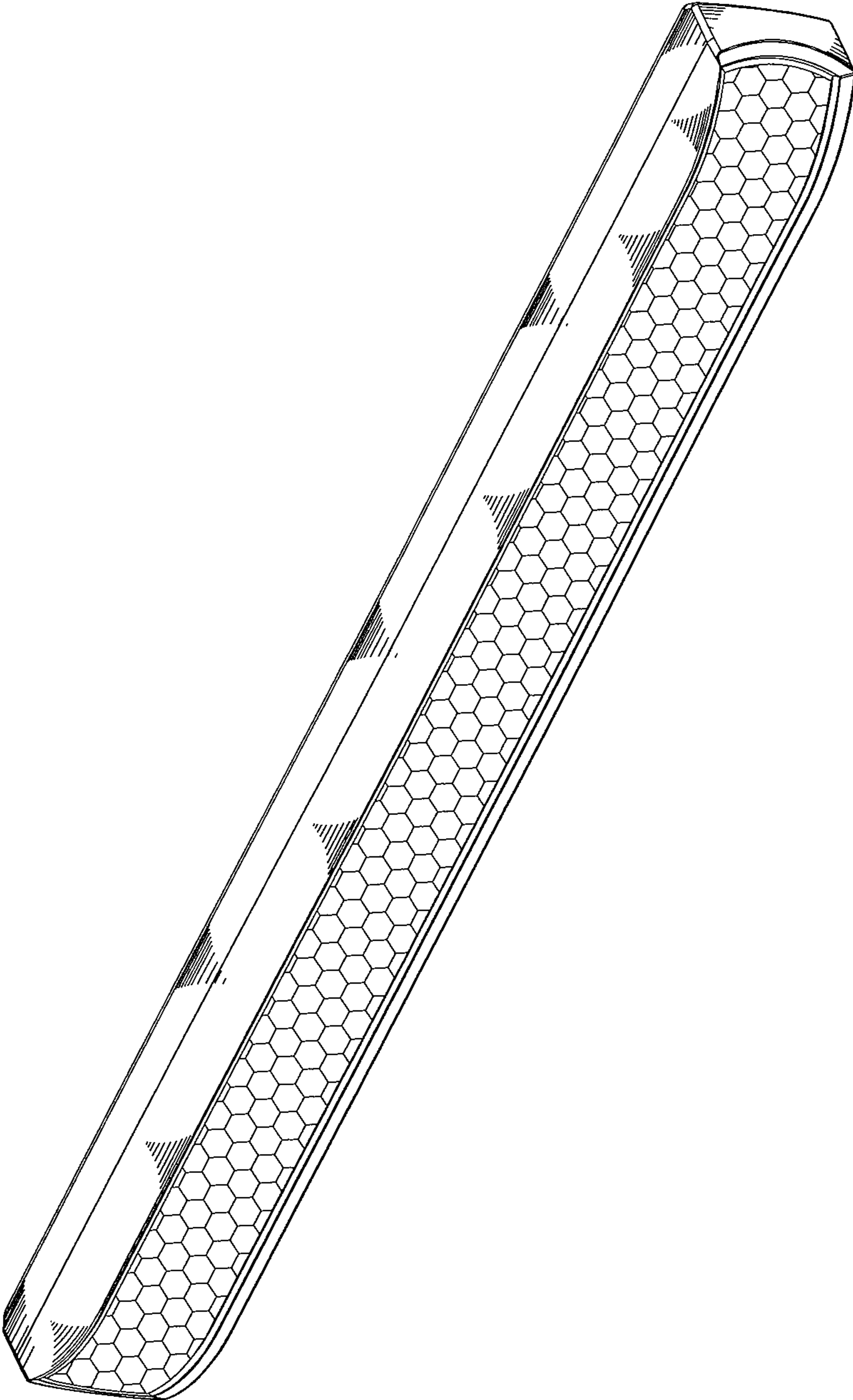

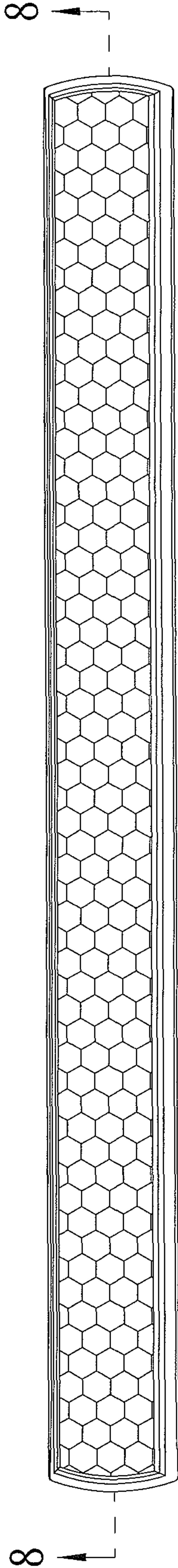

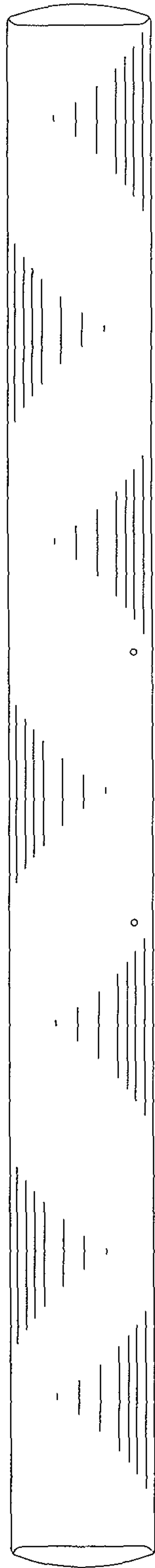

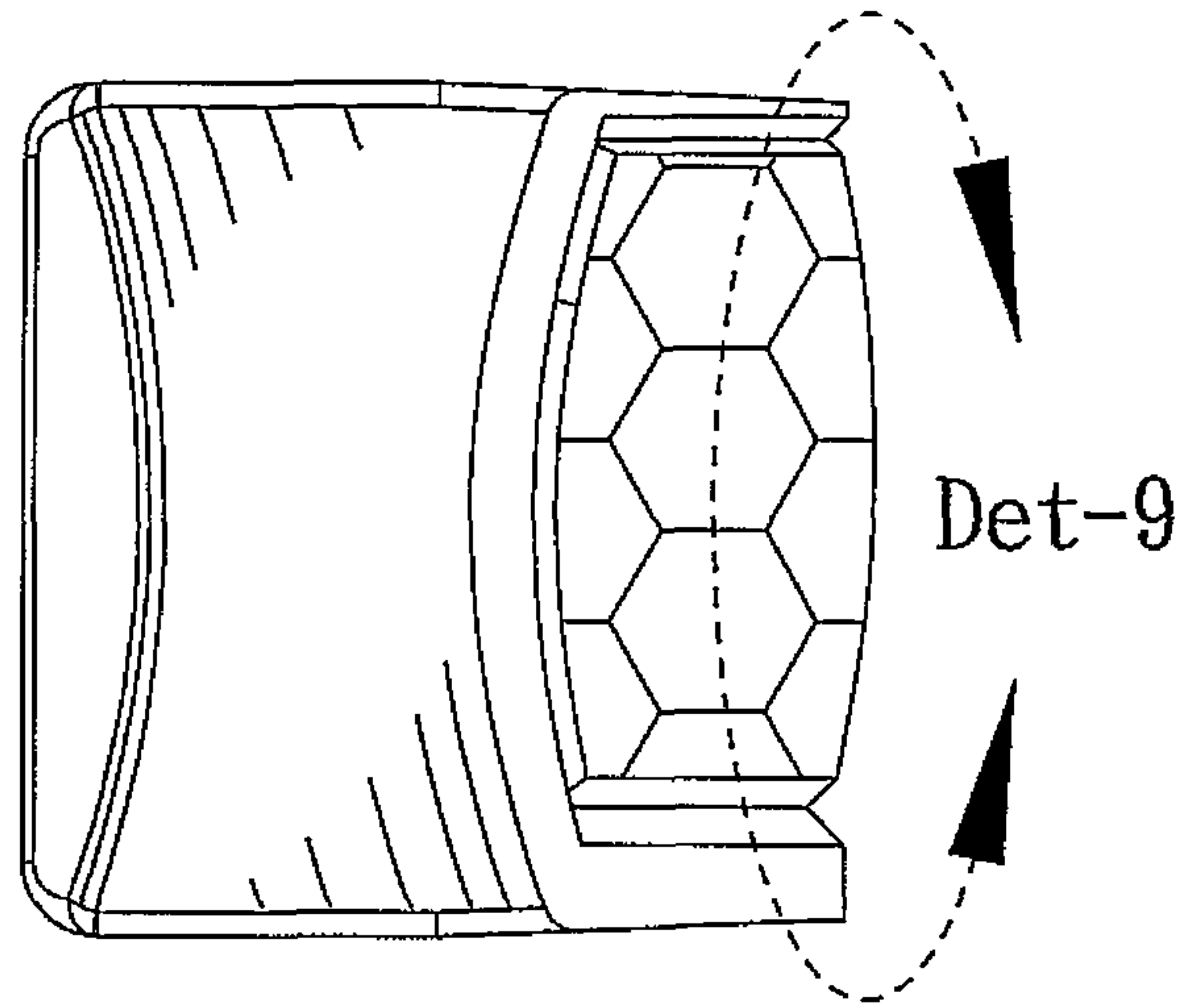

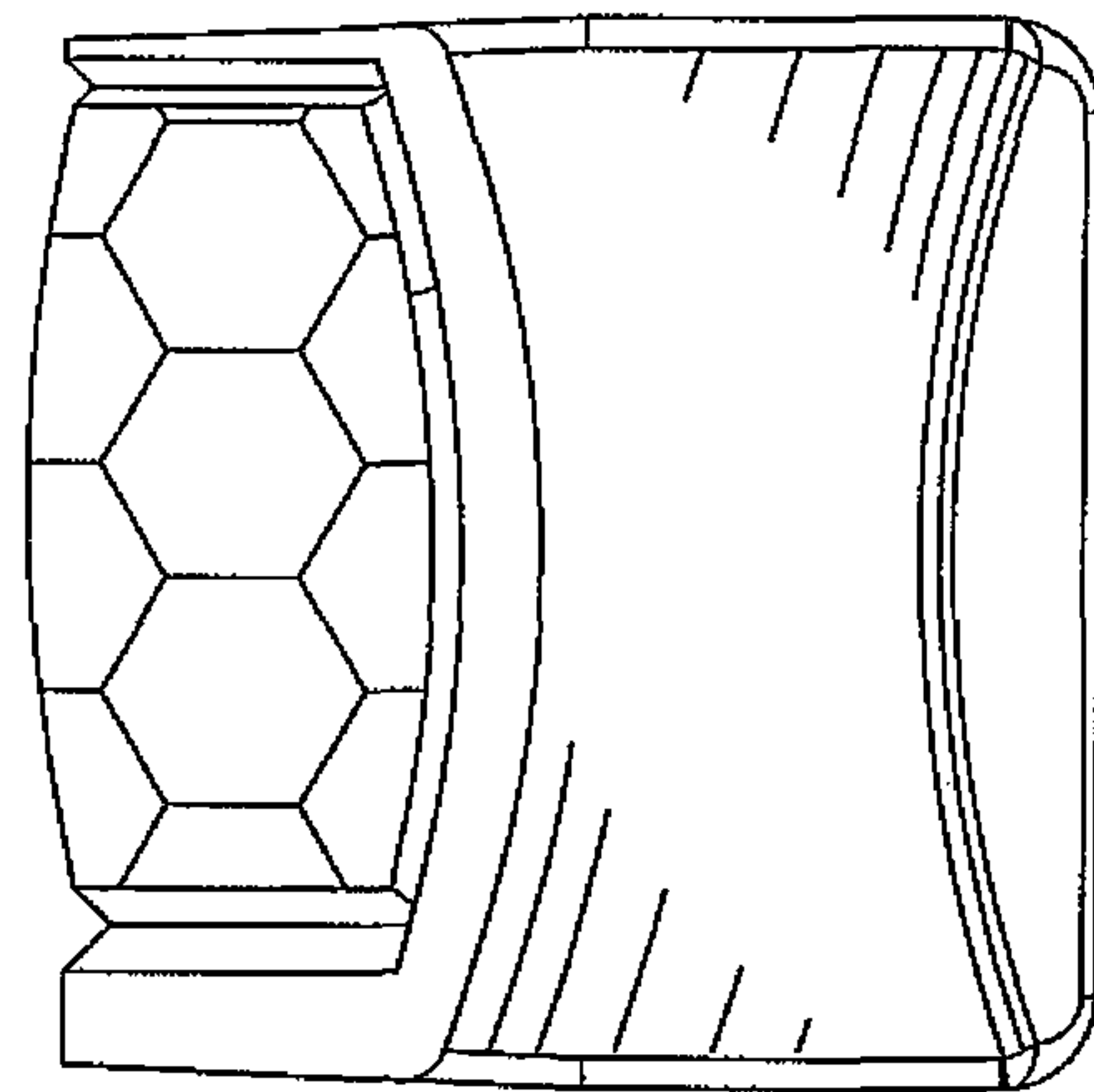

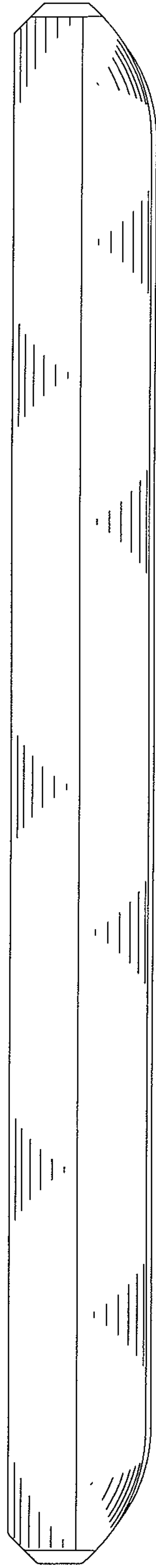

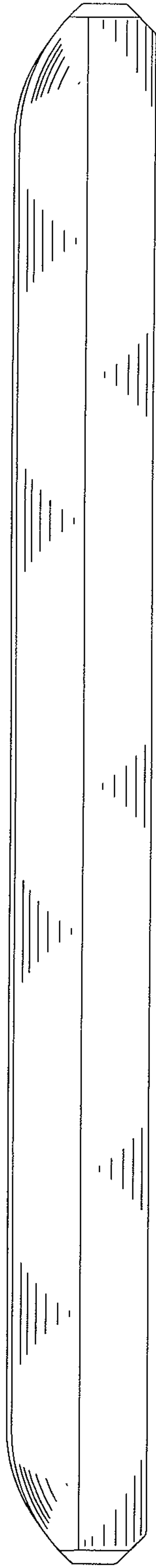

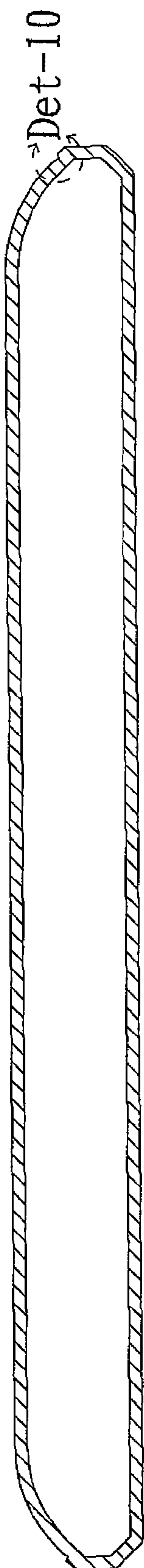

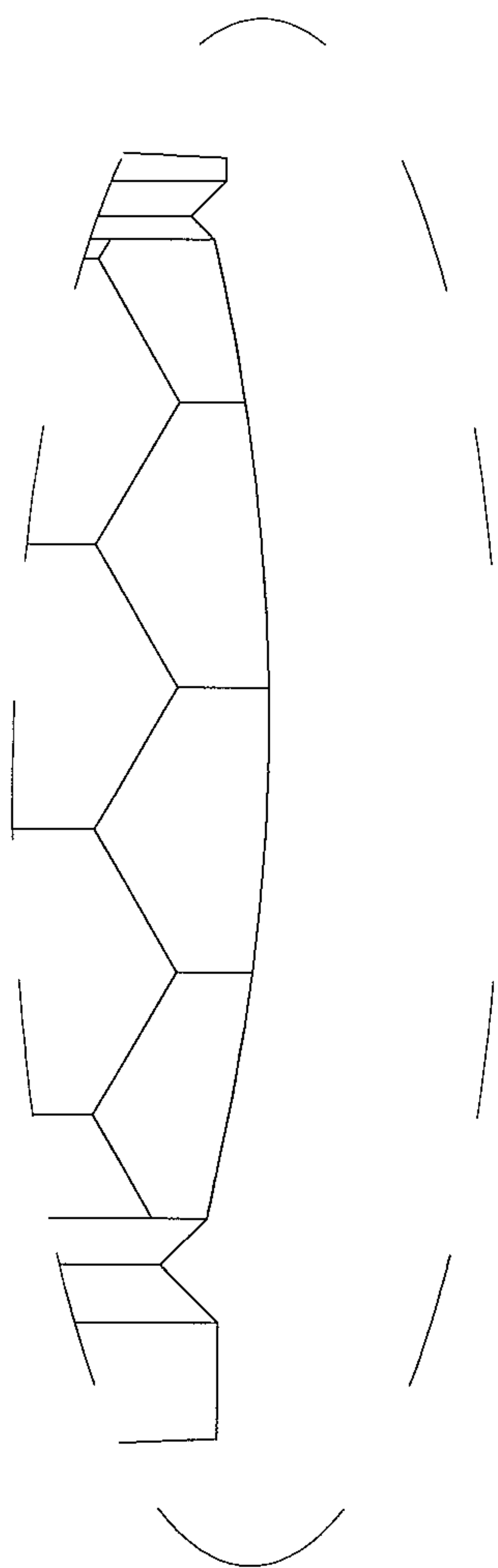

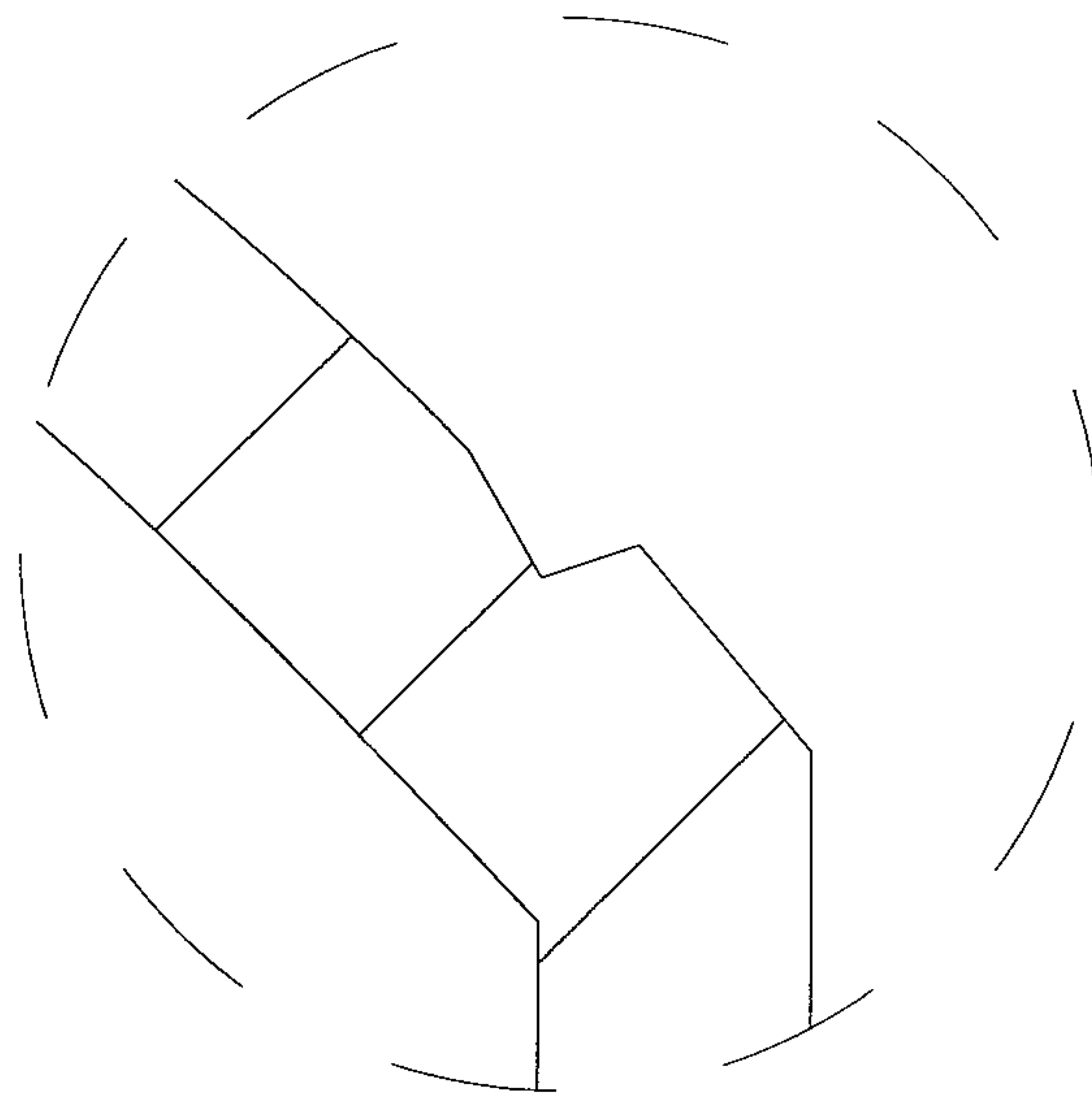
