(57) **CLAIM**

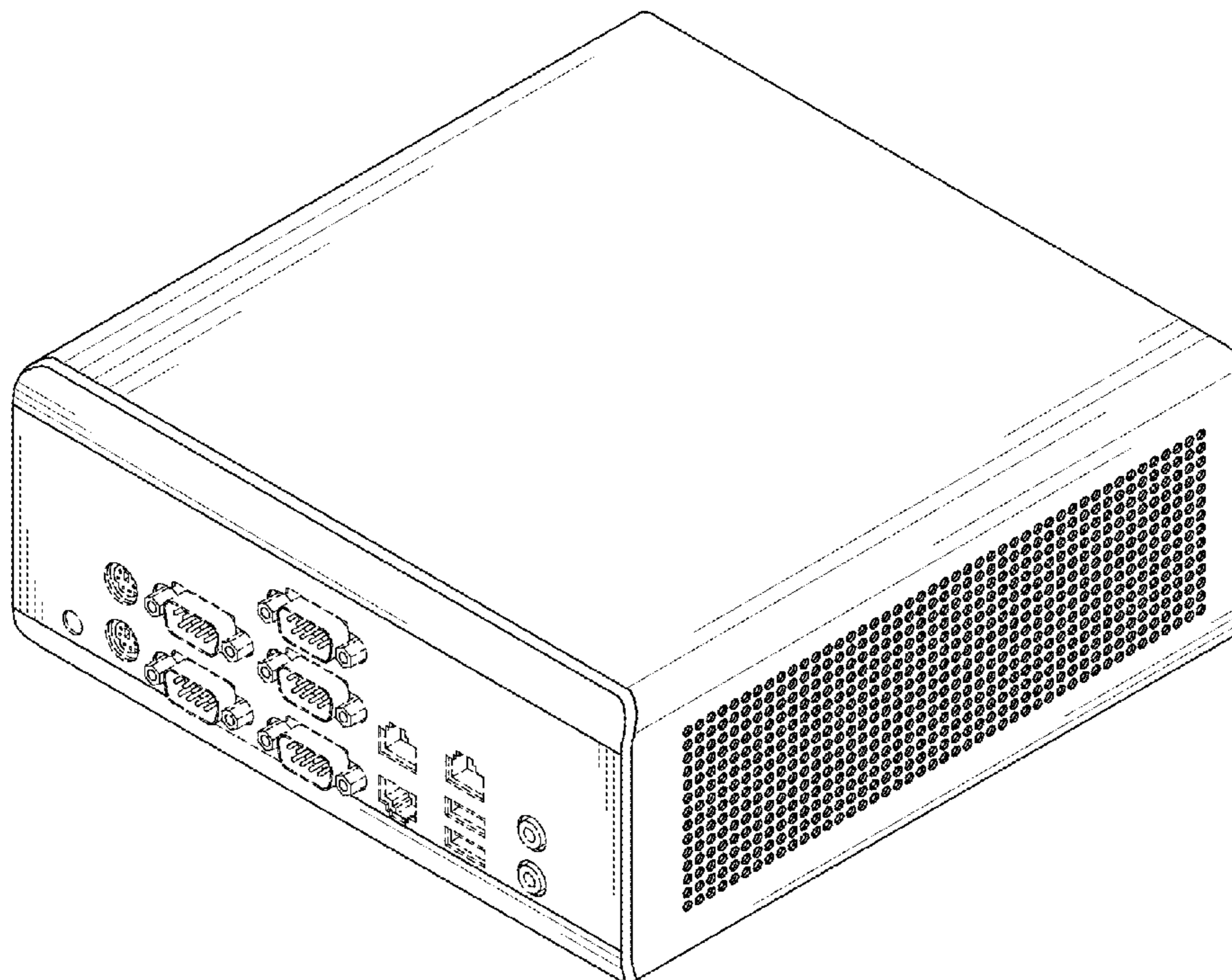
The ornamental design for an embedded computer, as shown

DESCRIPTION

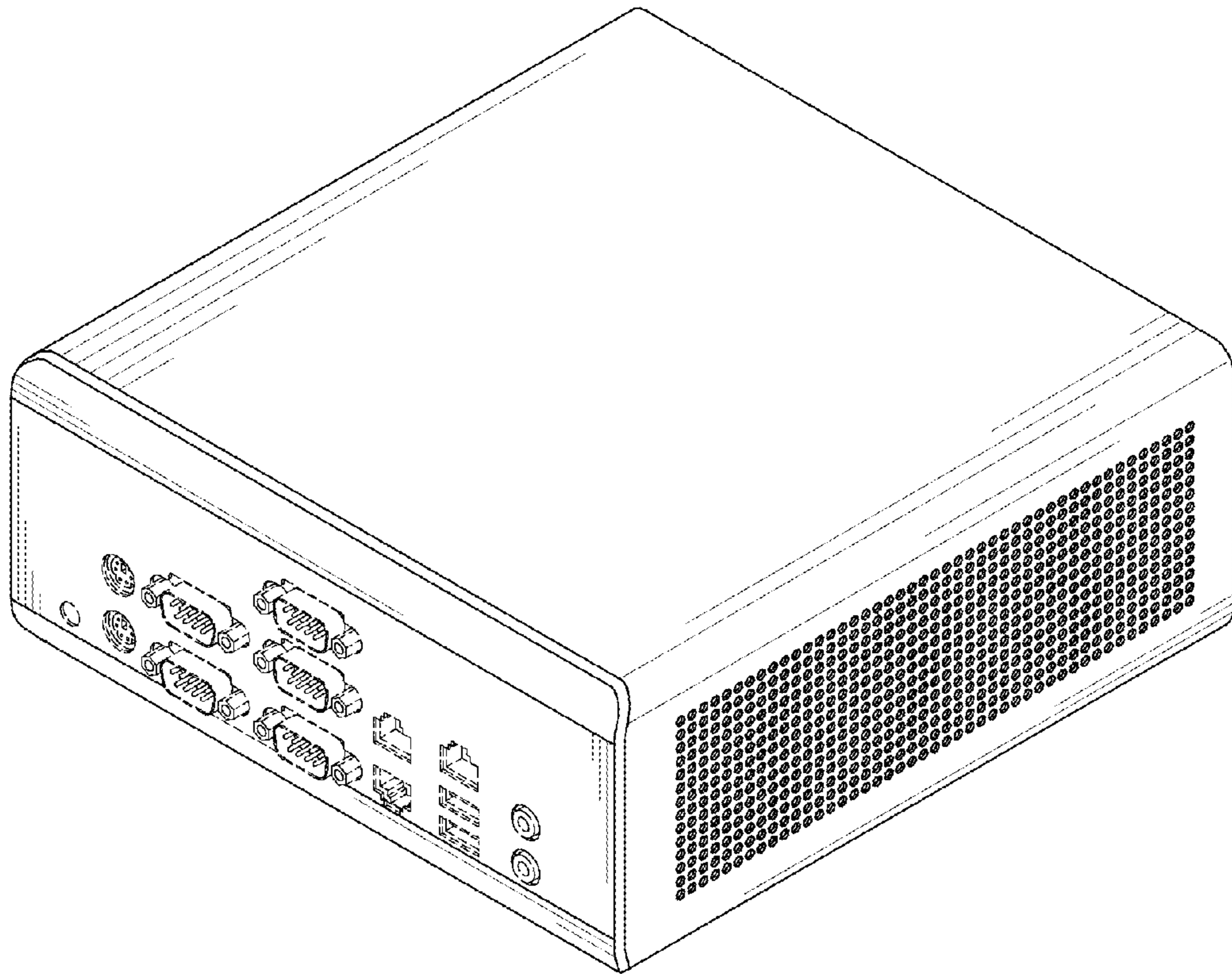

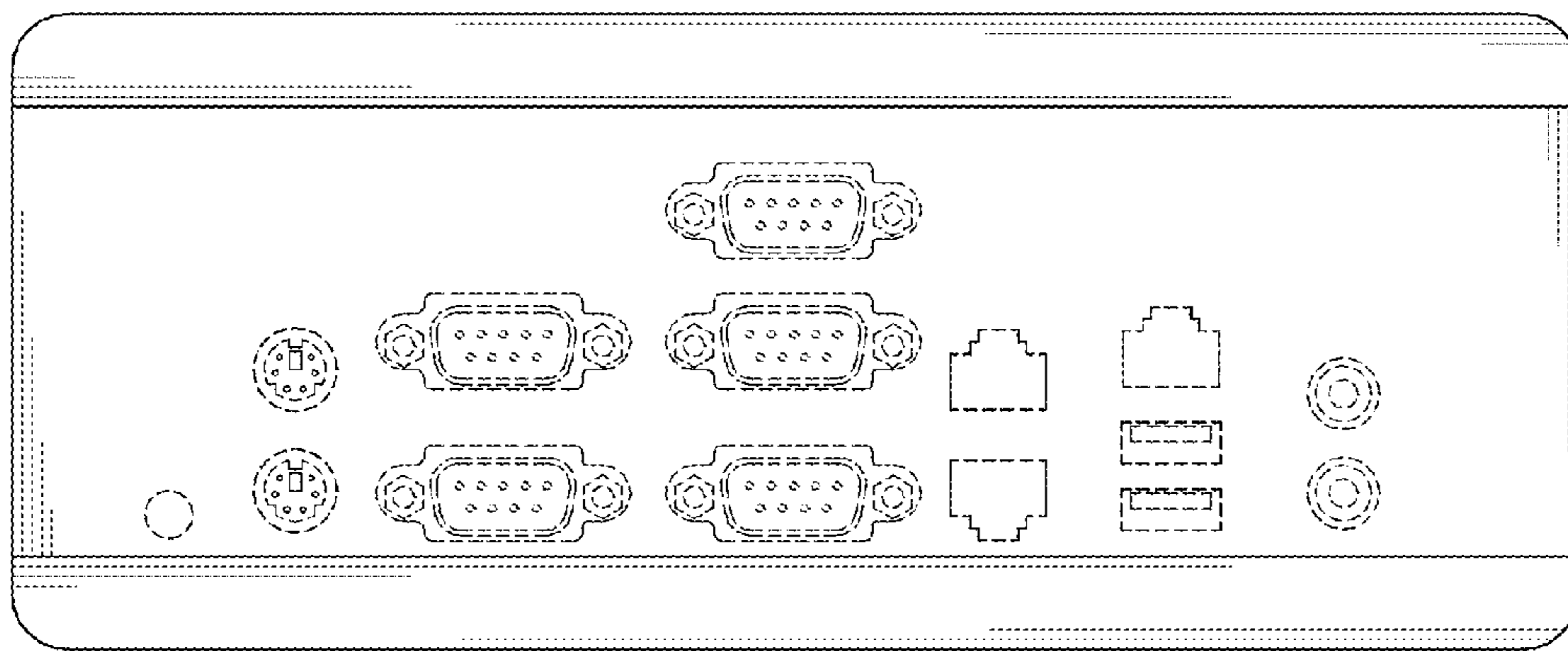

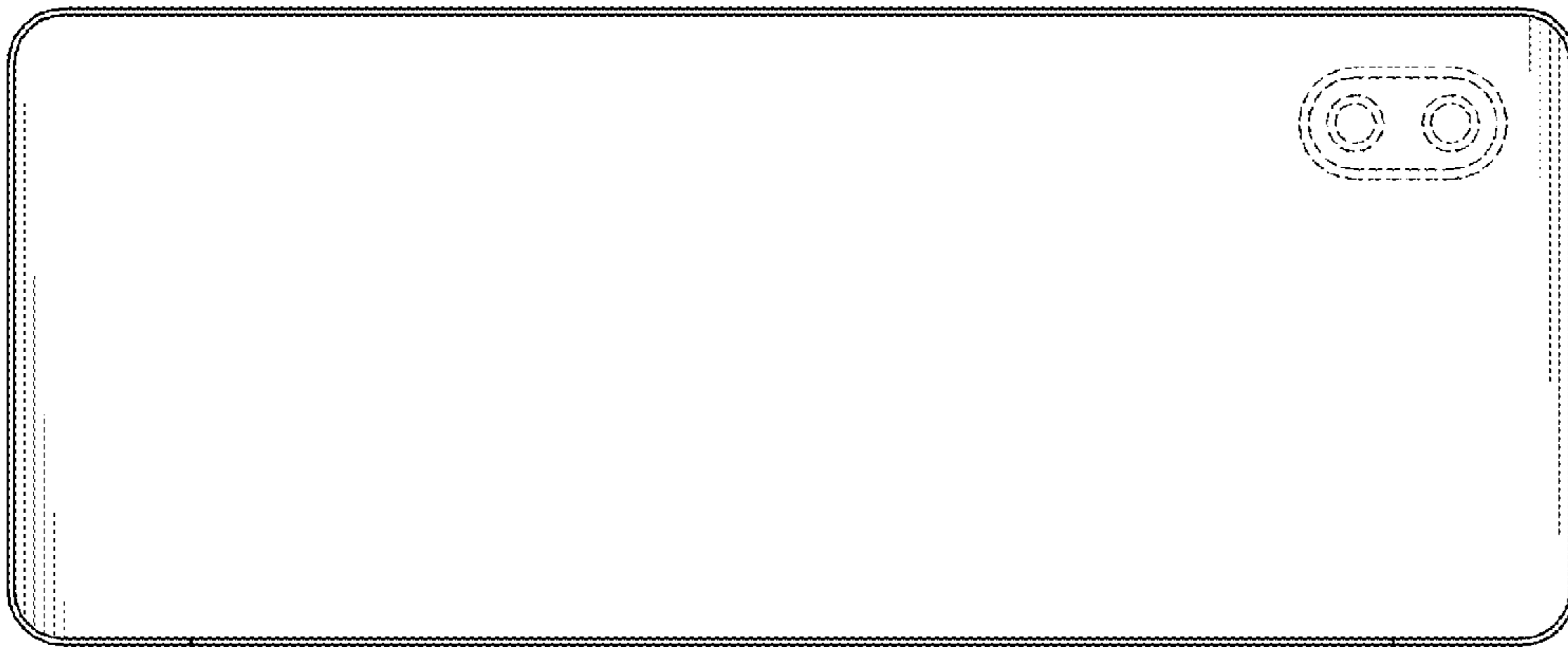

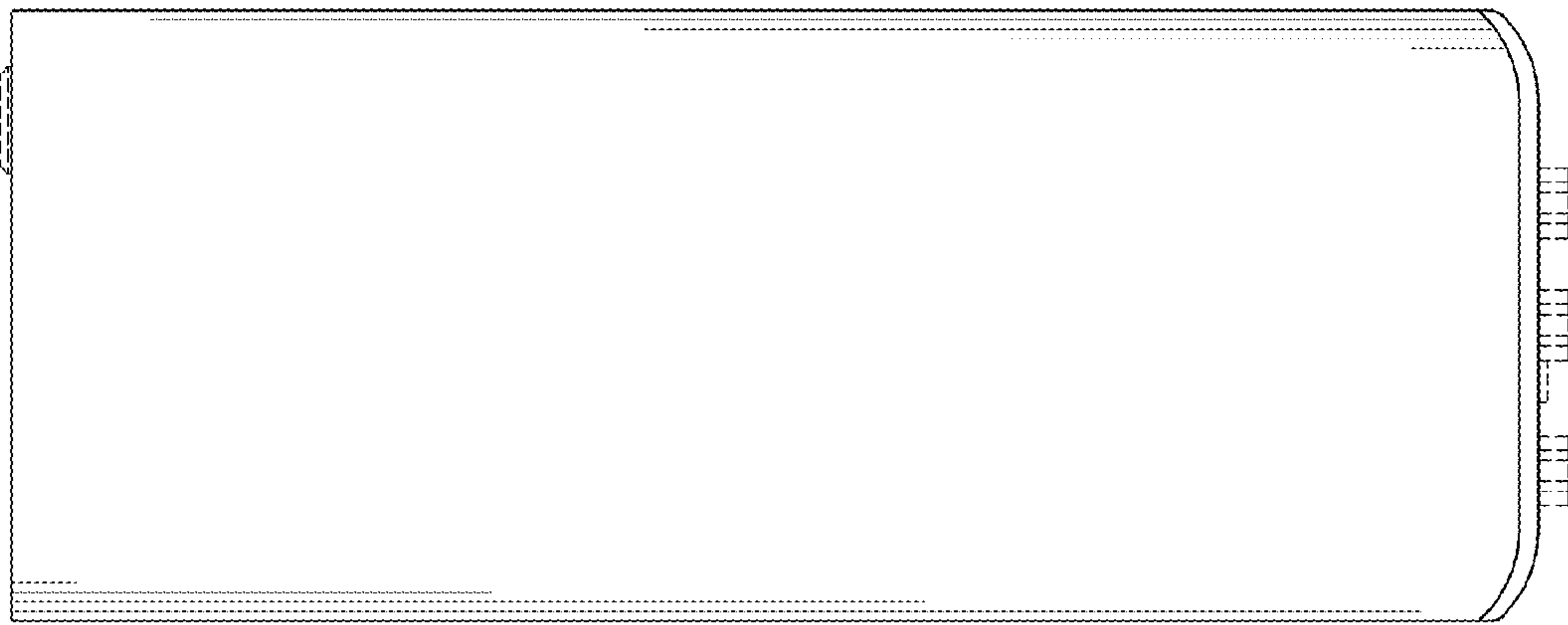

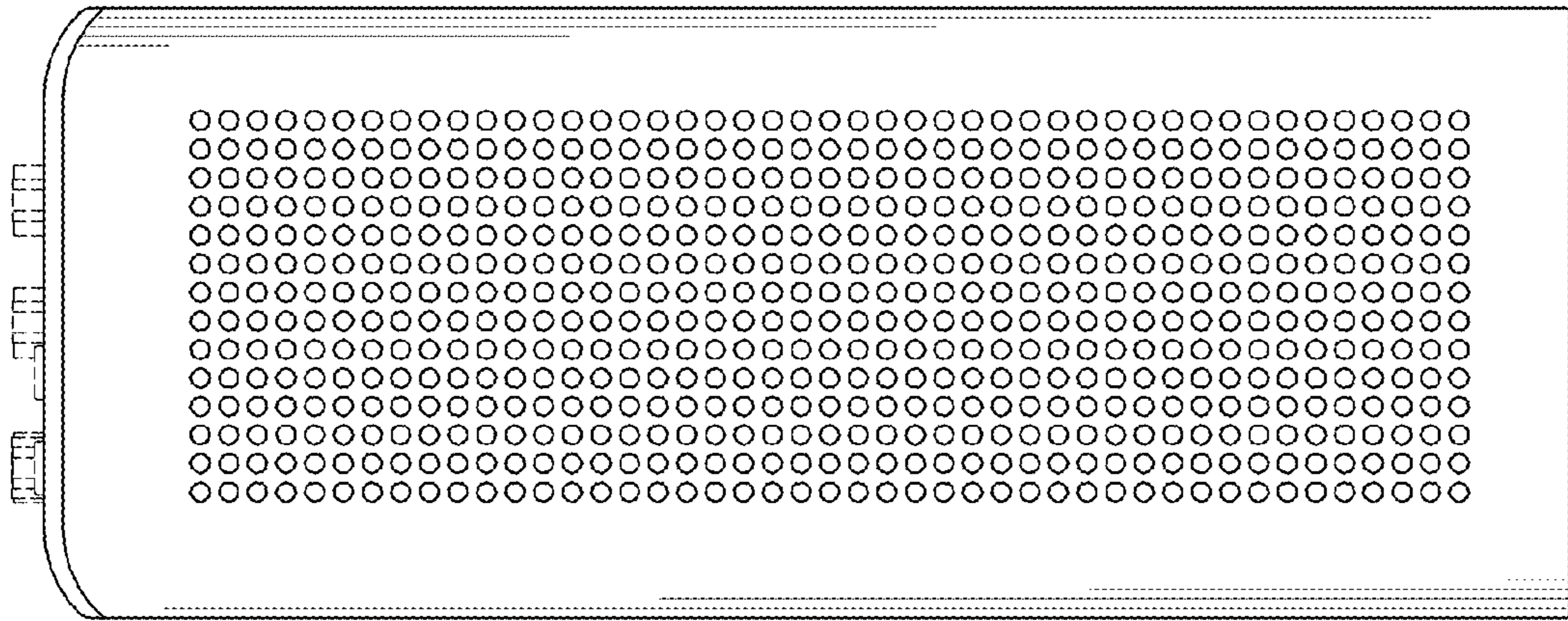

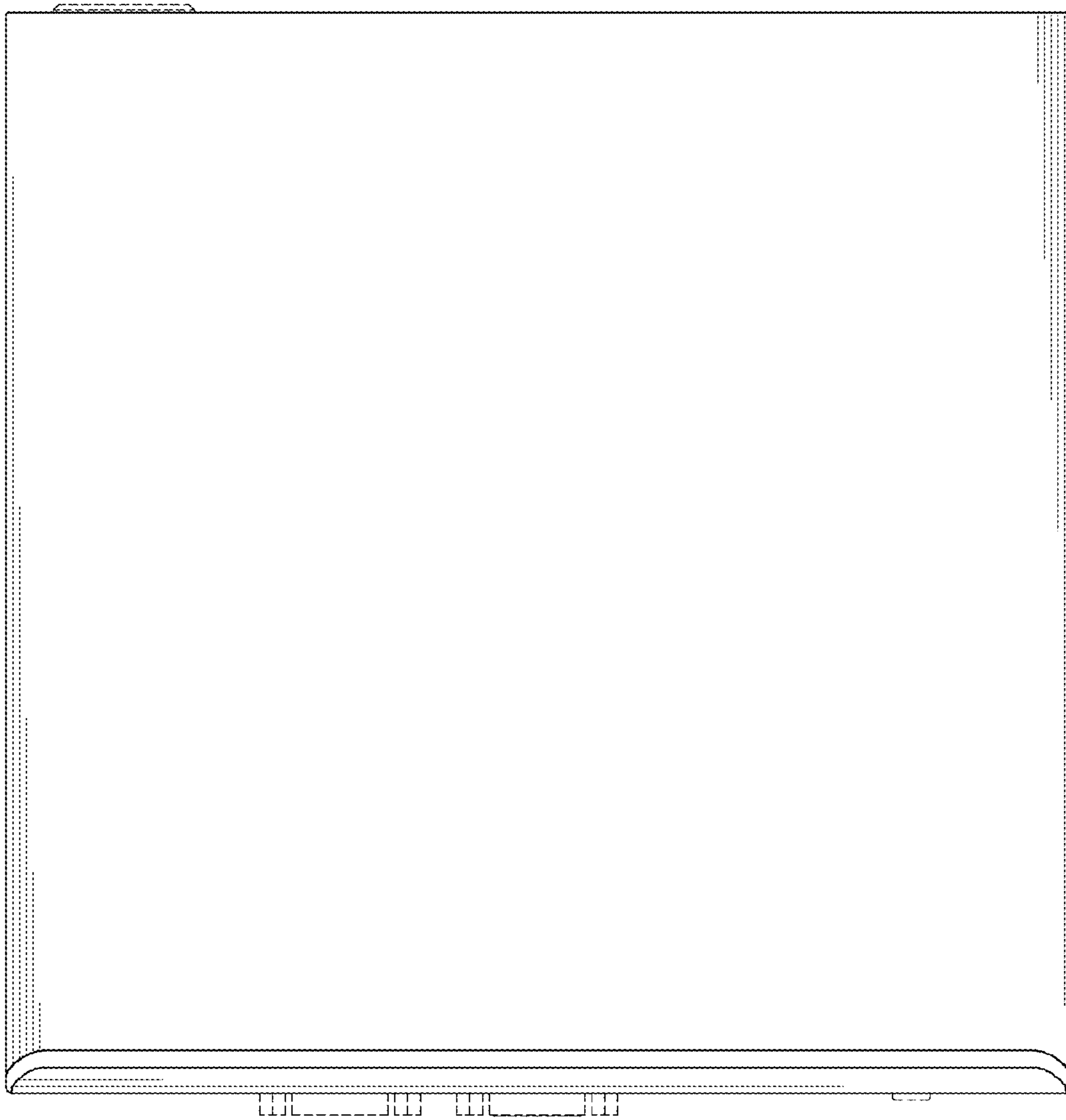

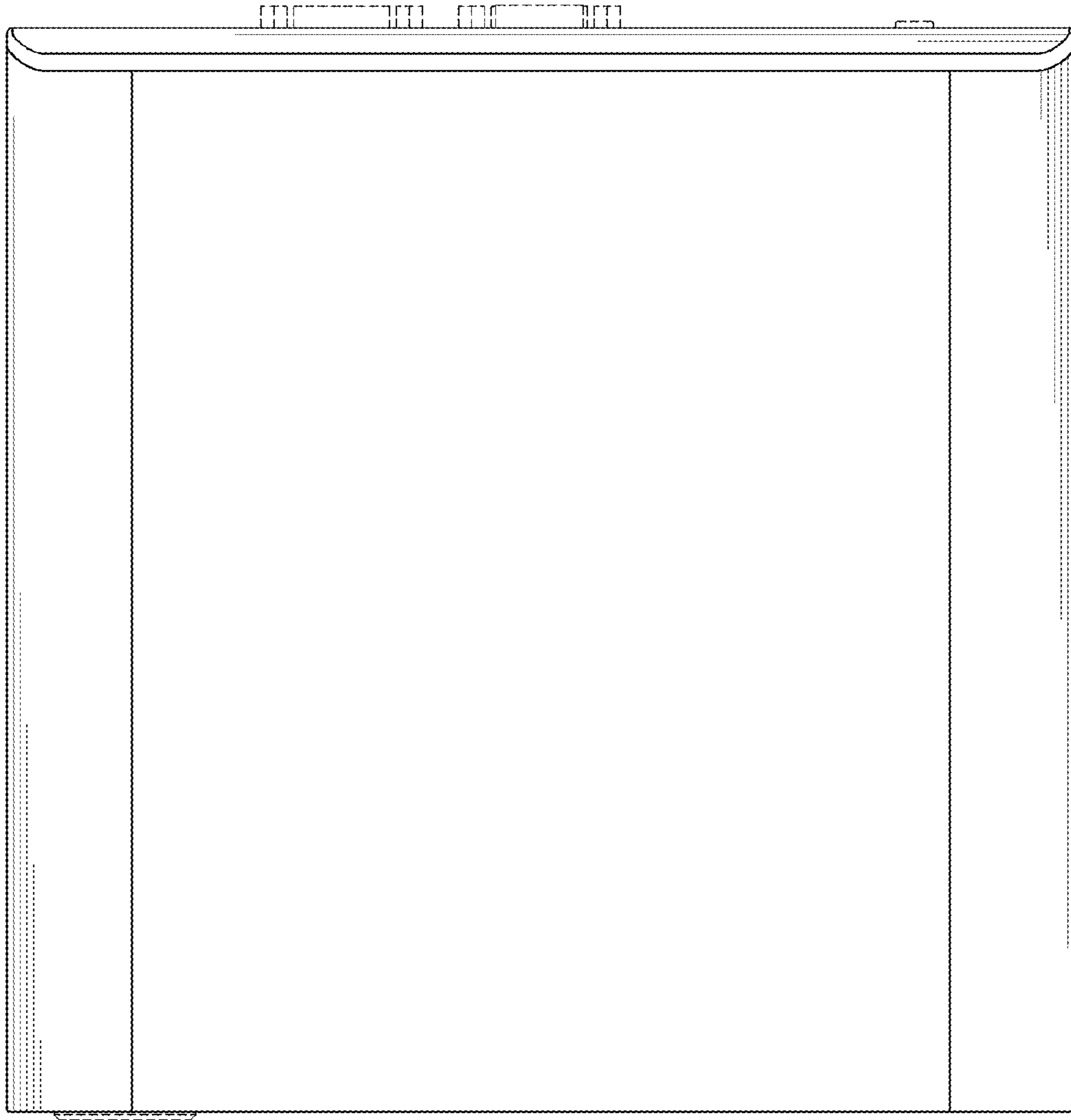
