**DESCRIPTION**

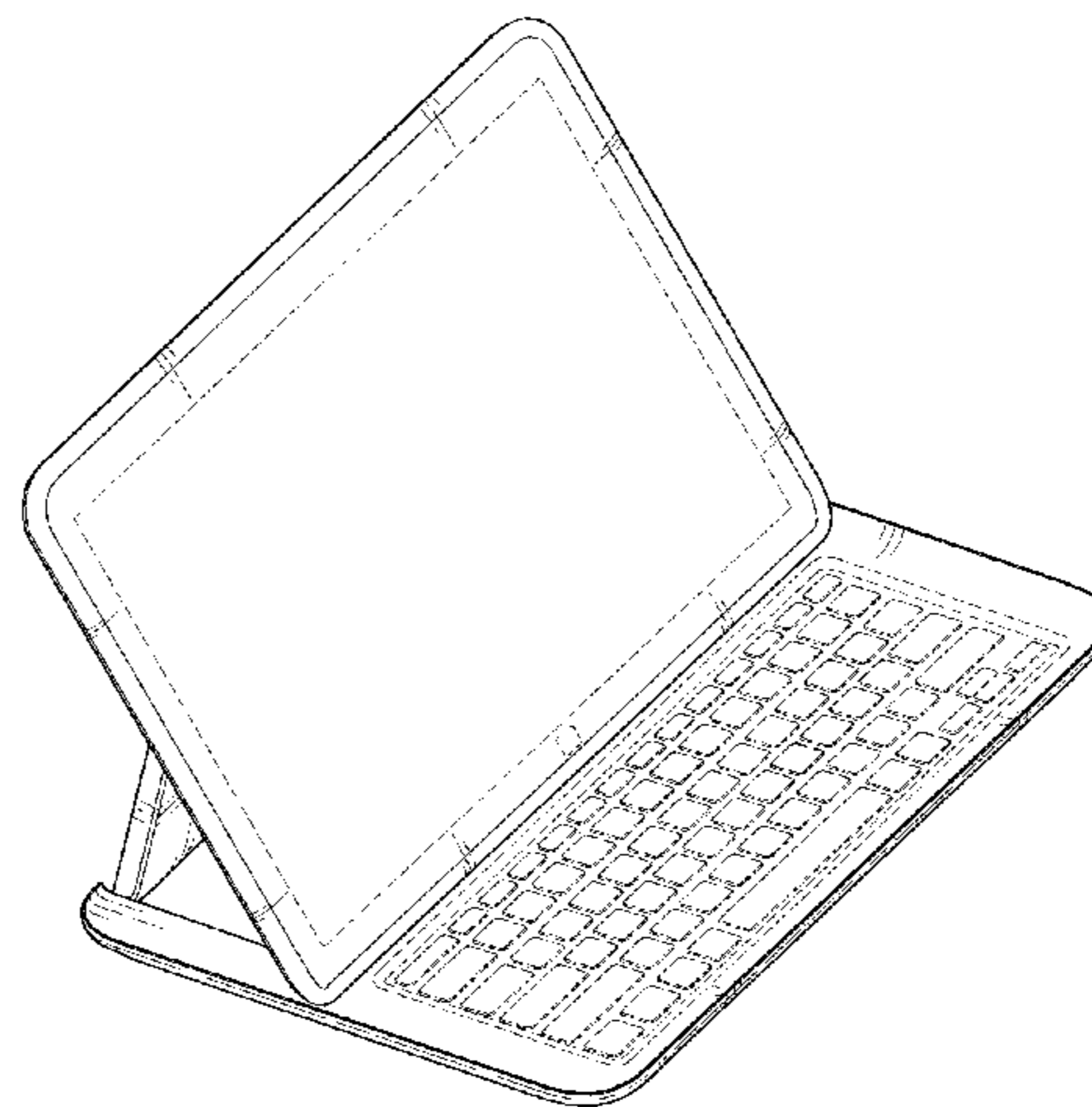
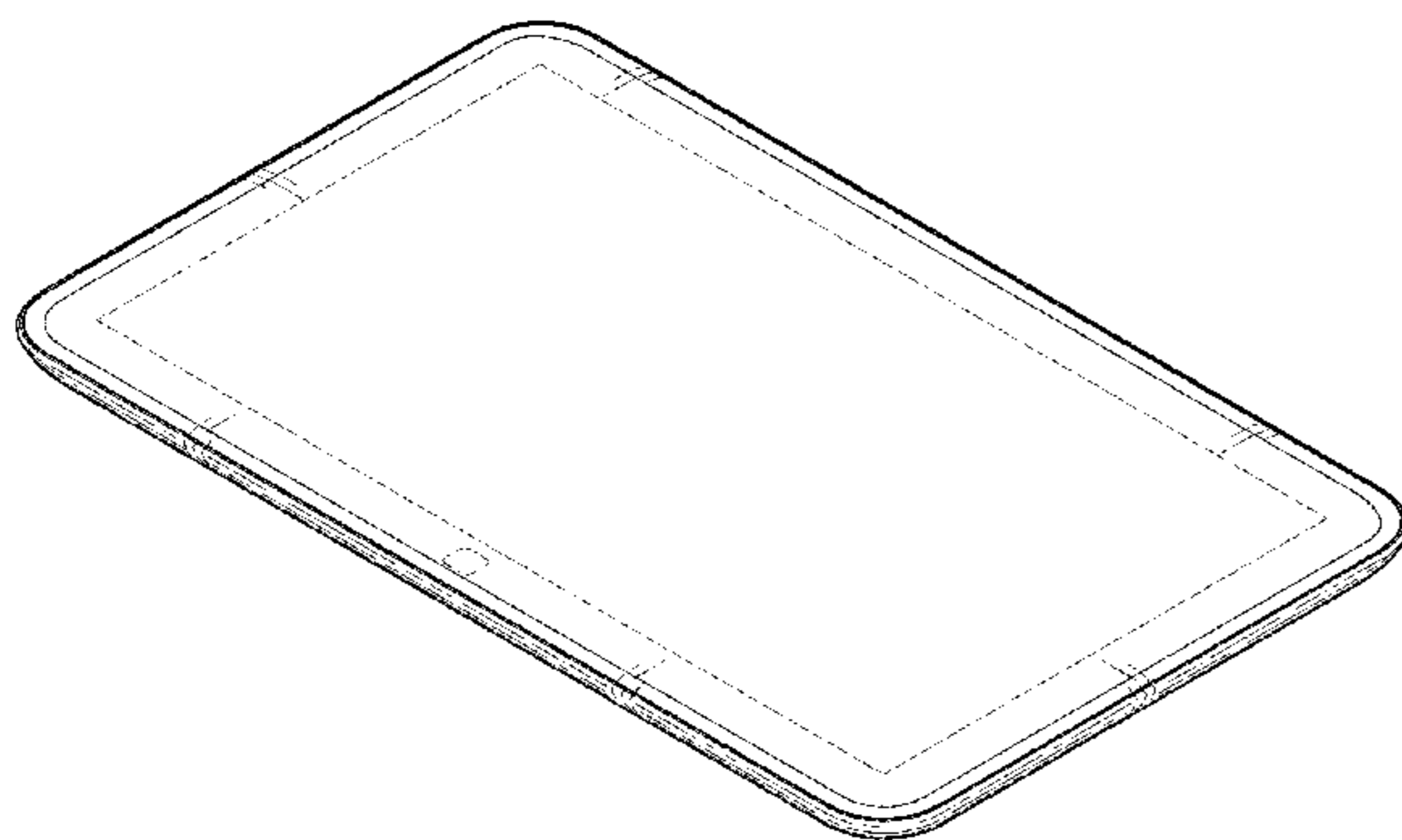

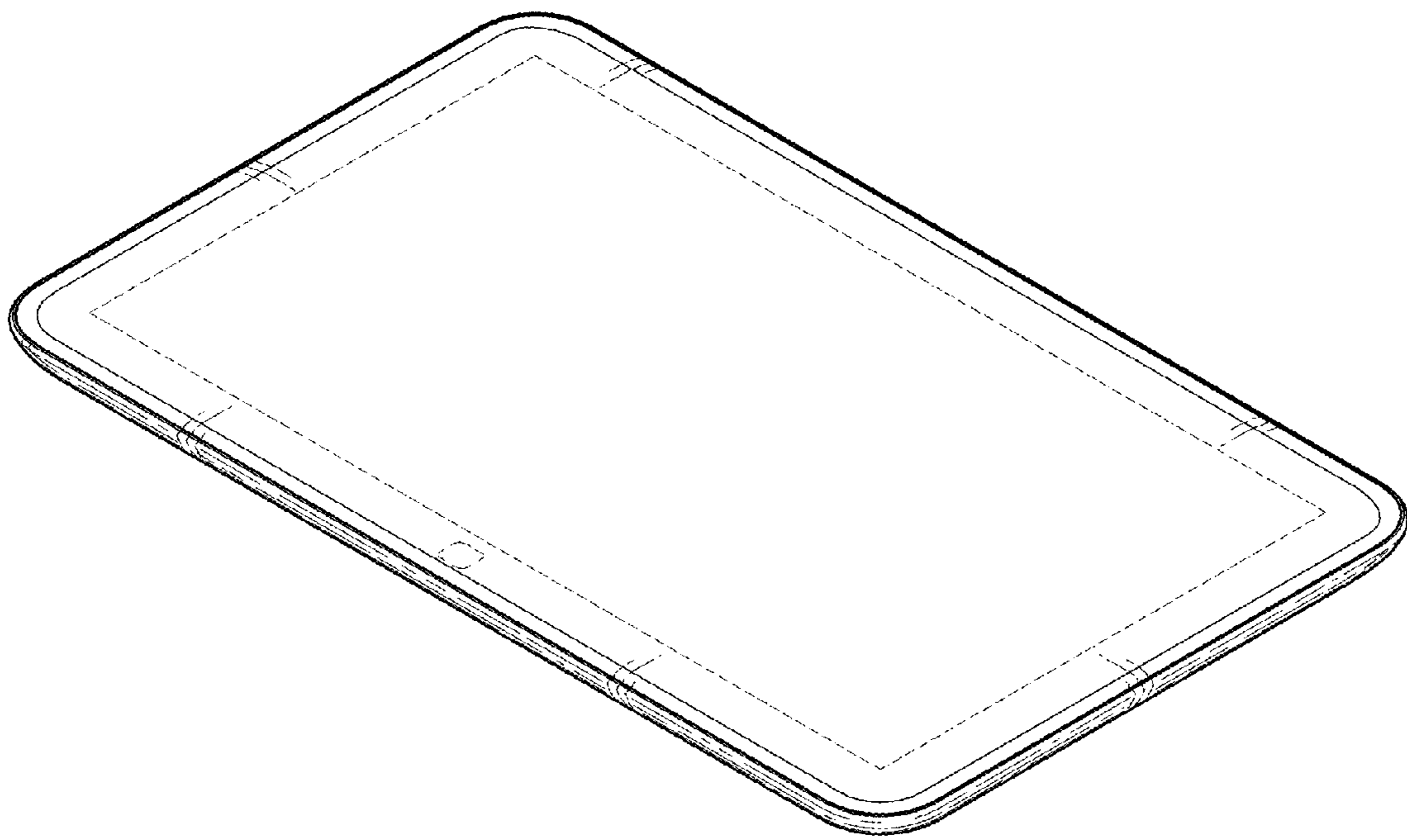

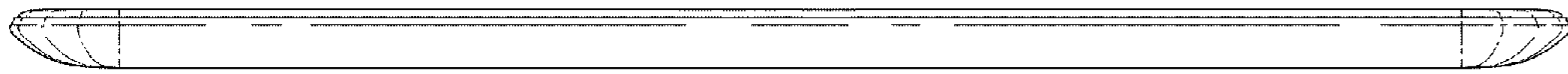

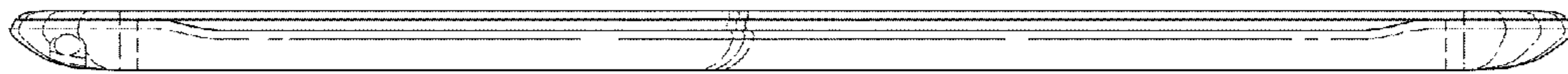

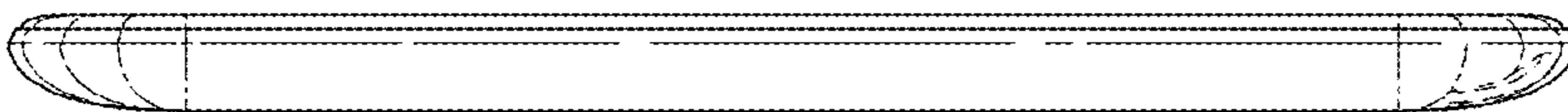

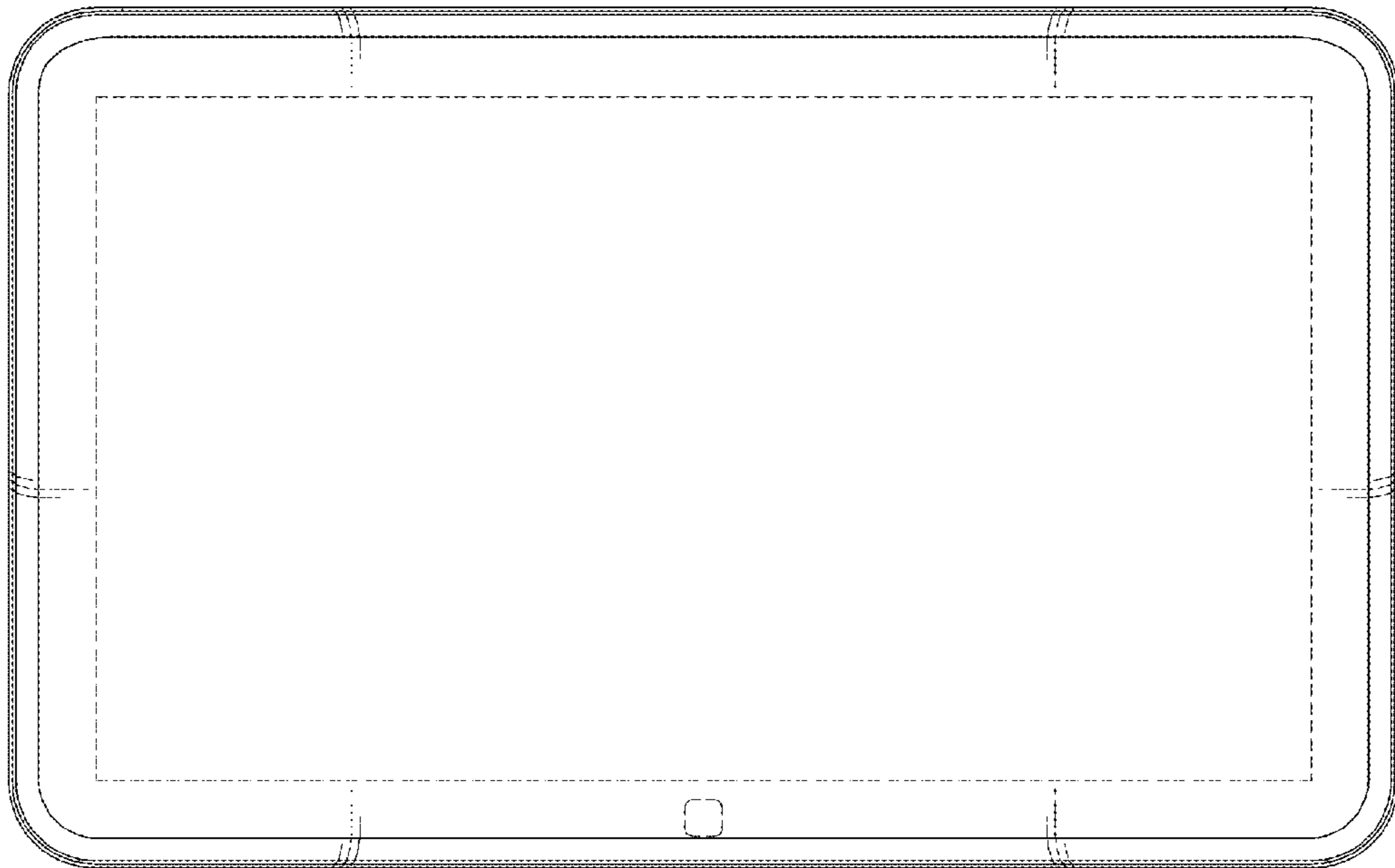

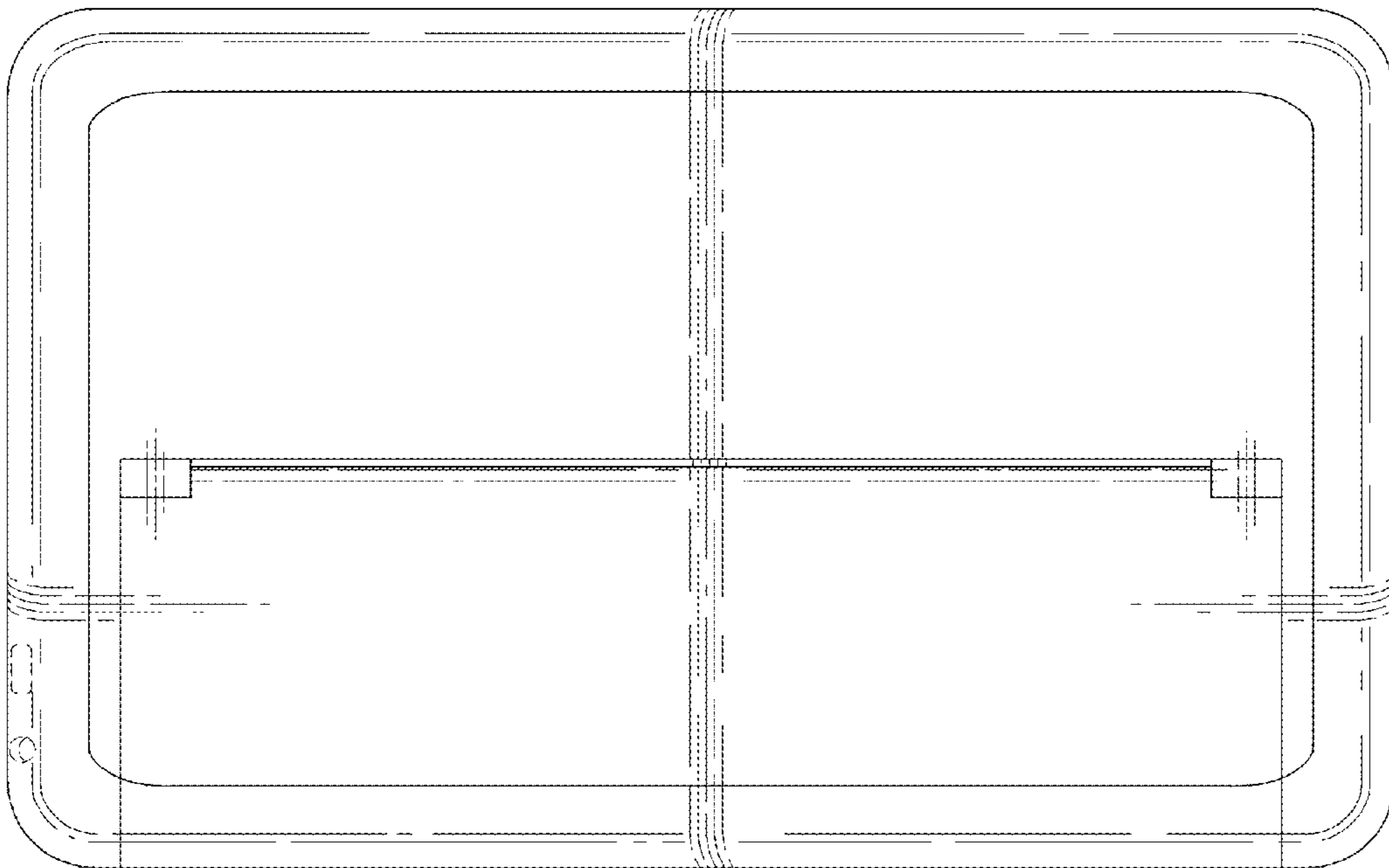

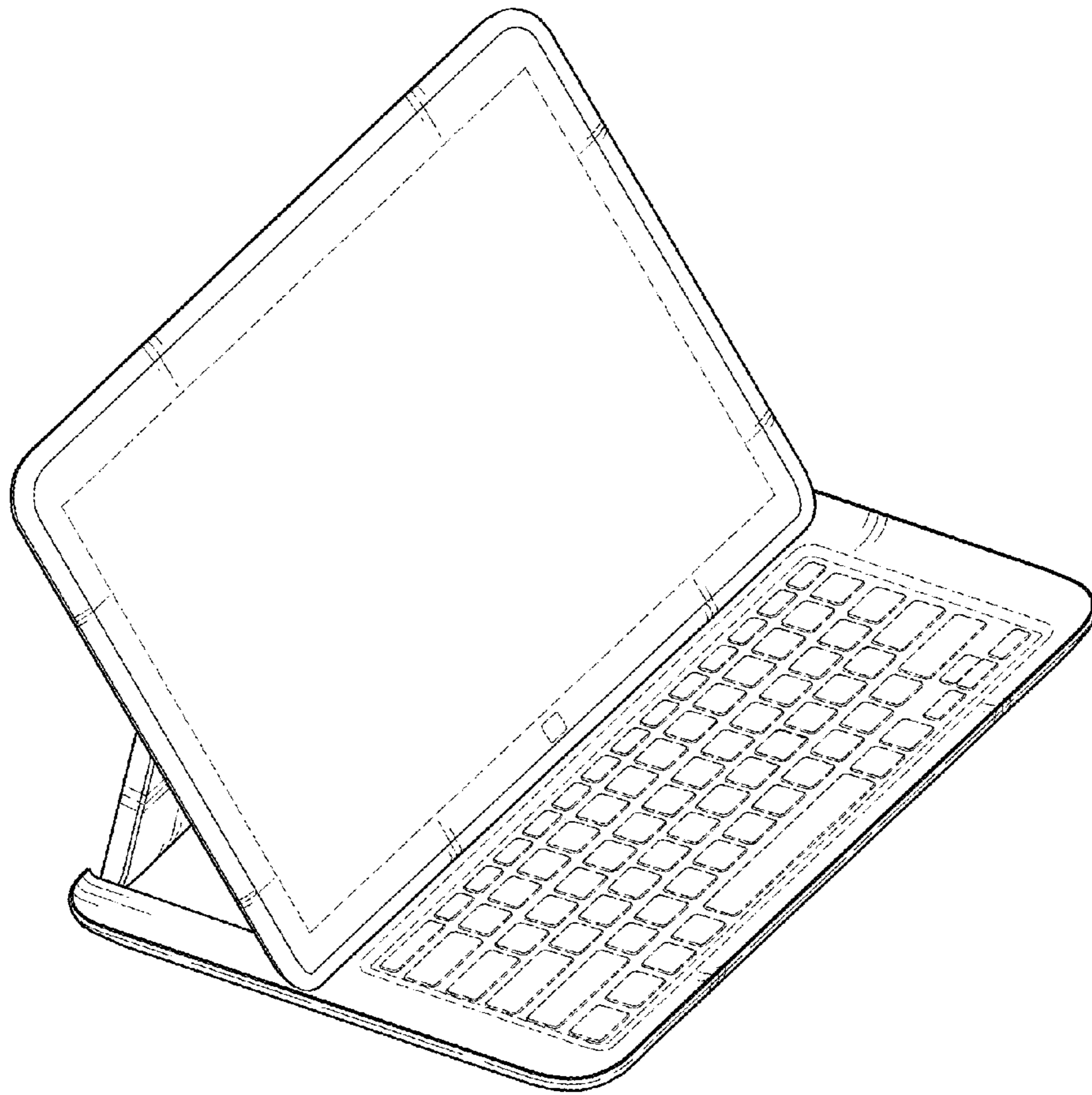

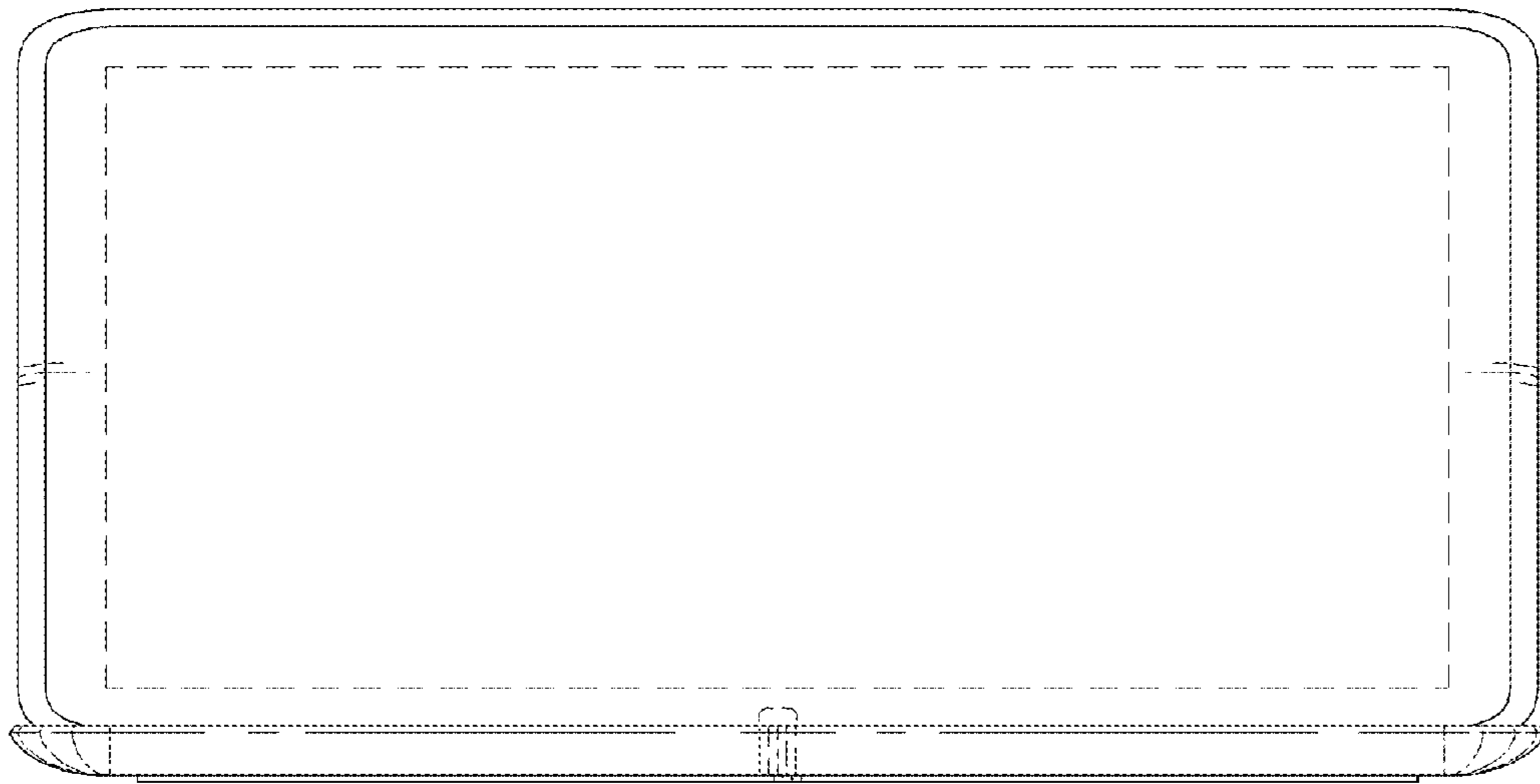

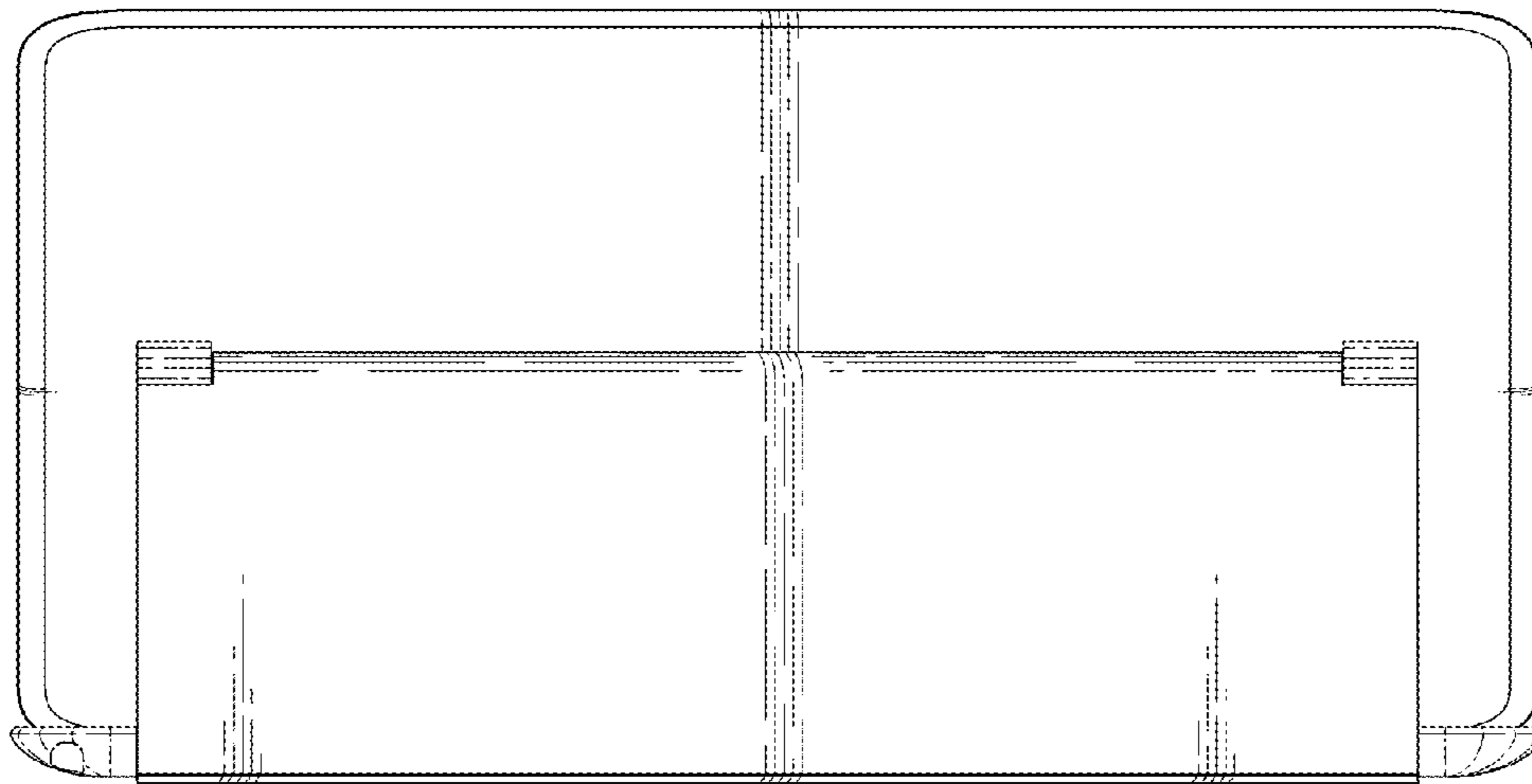

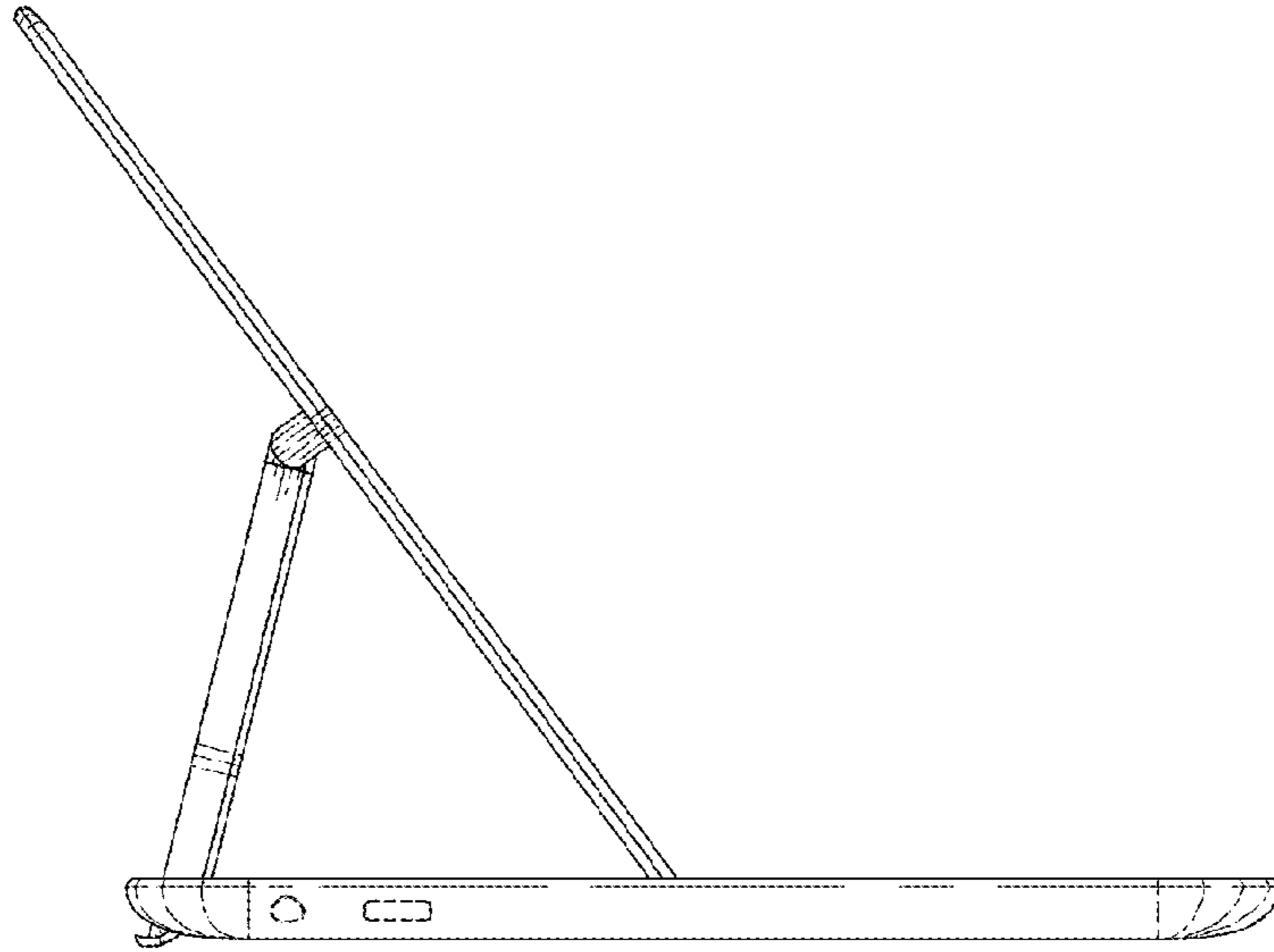

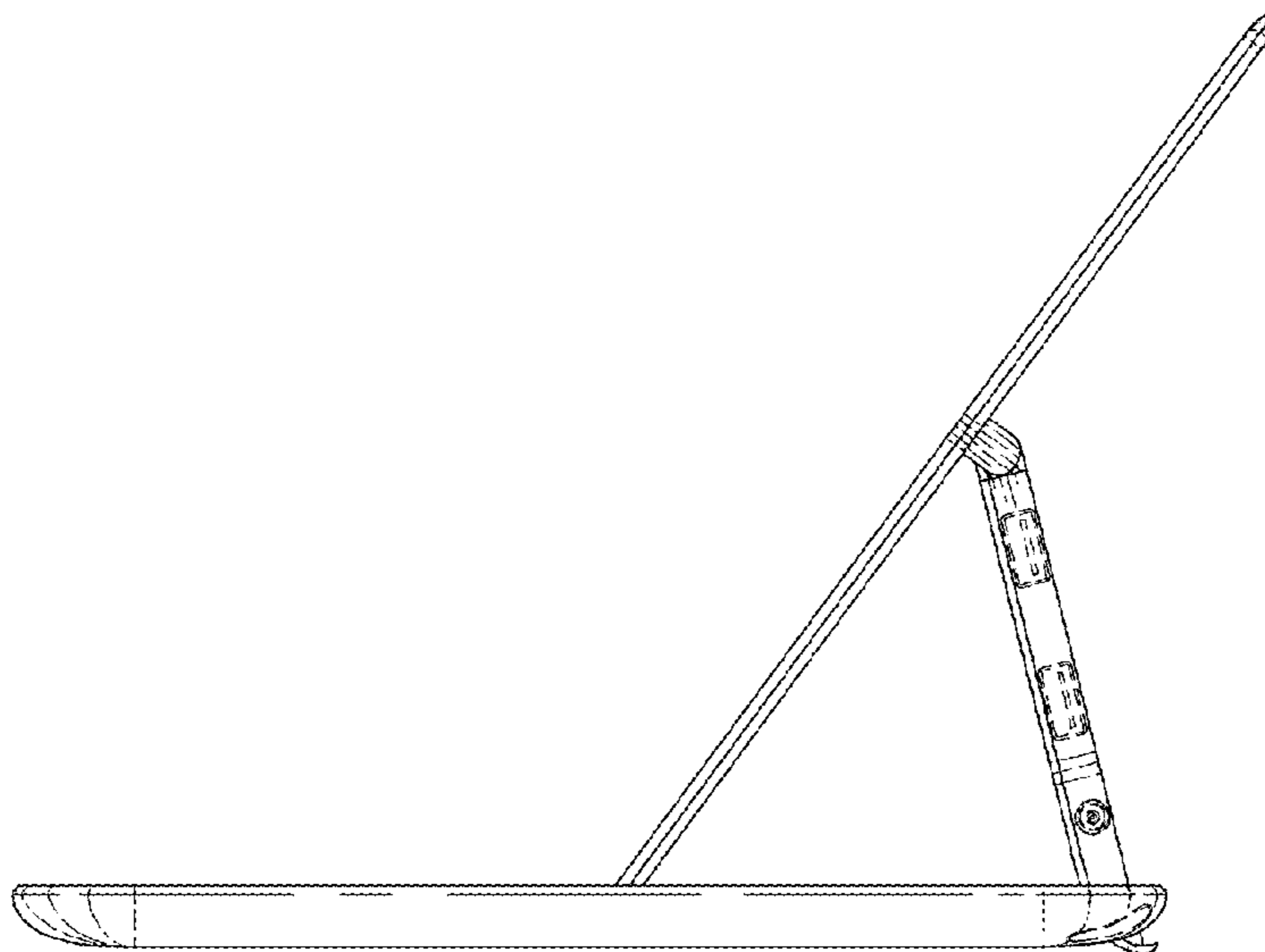

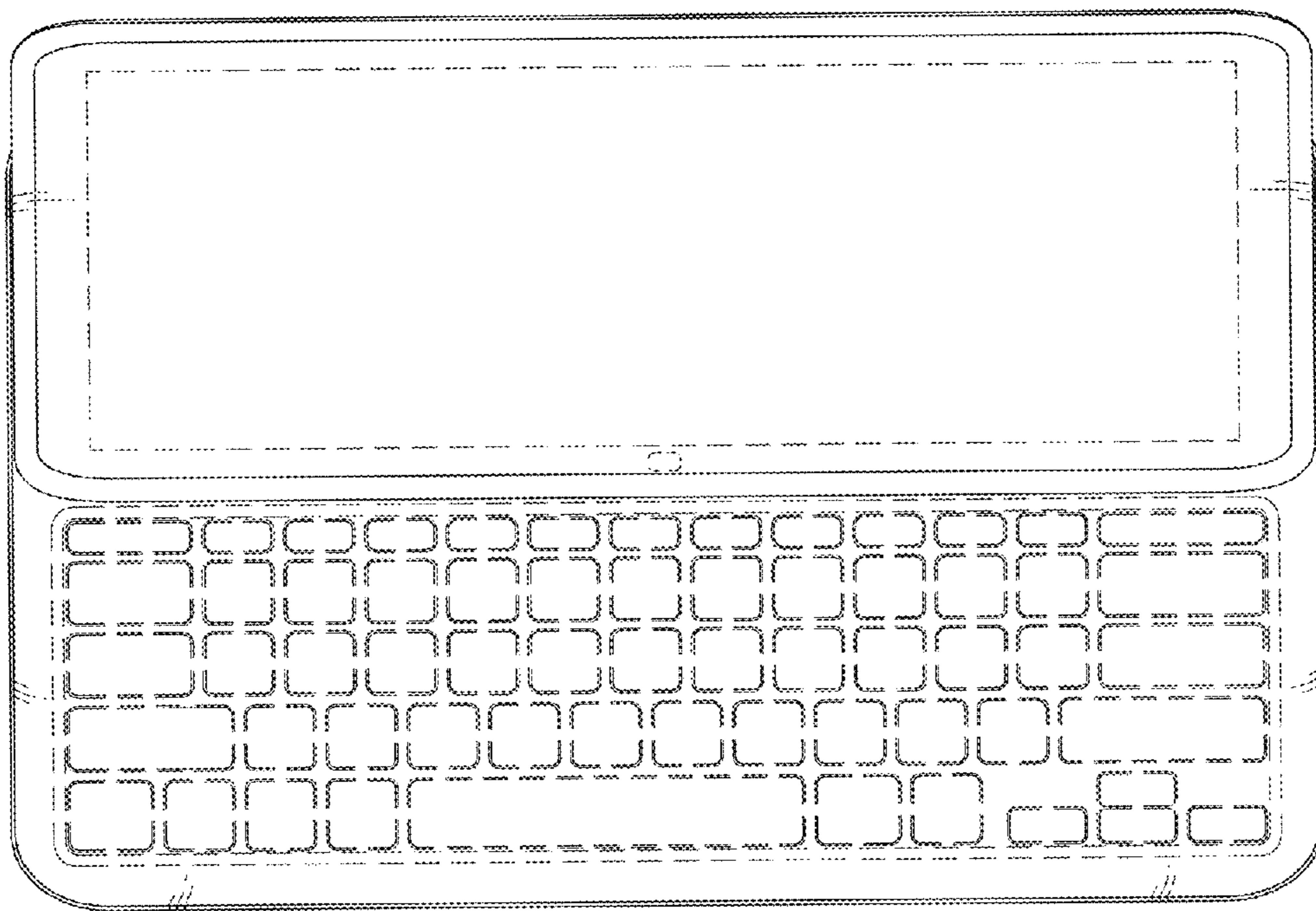
