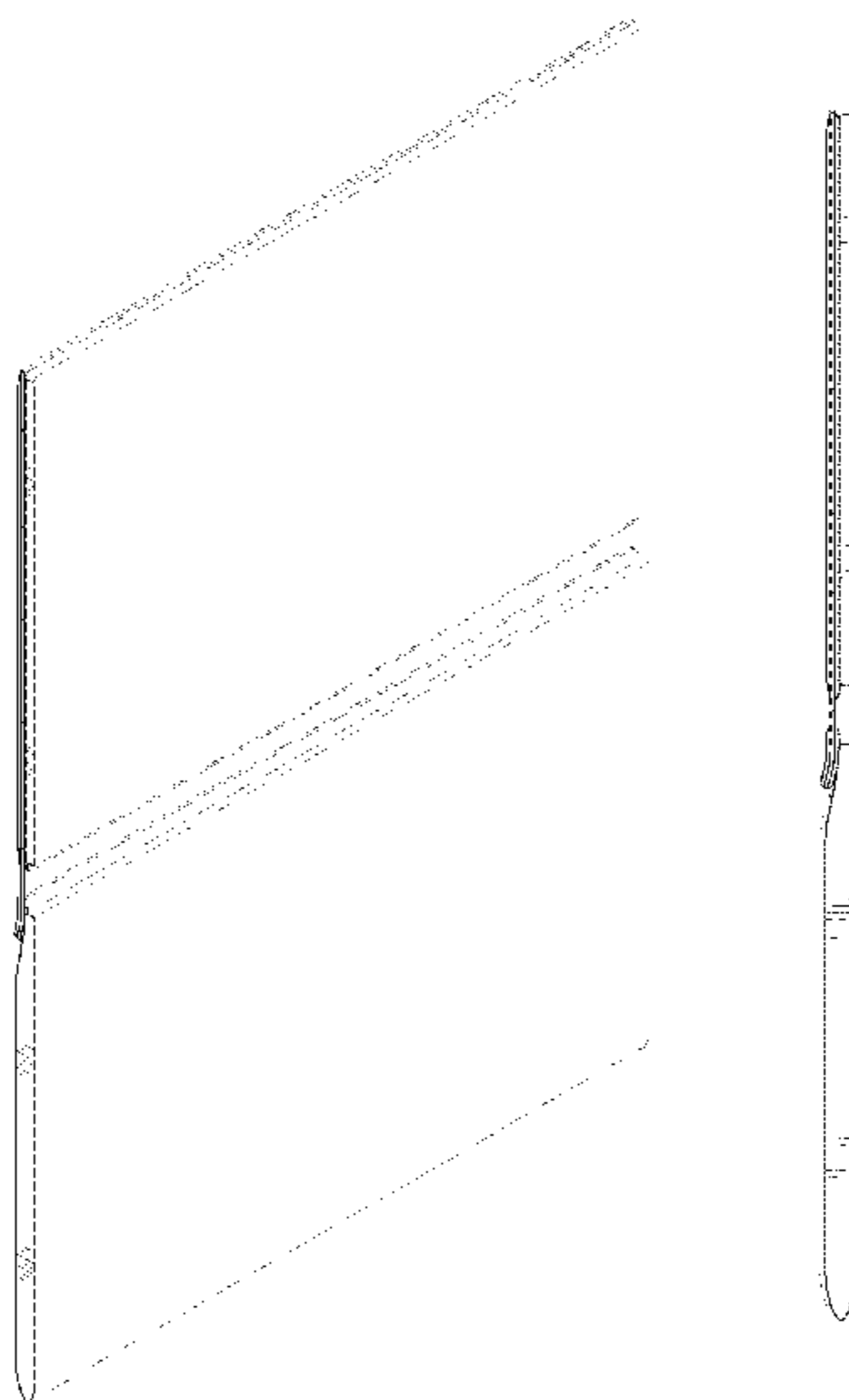
(57) **CLAIM**

The ornamental design for a tablet computer, as shown and described.

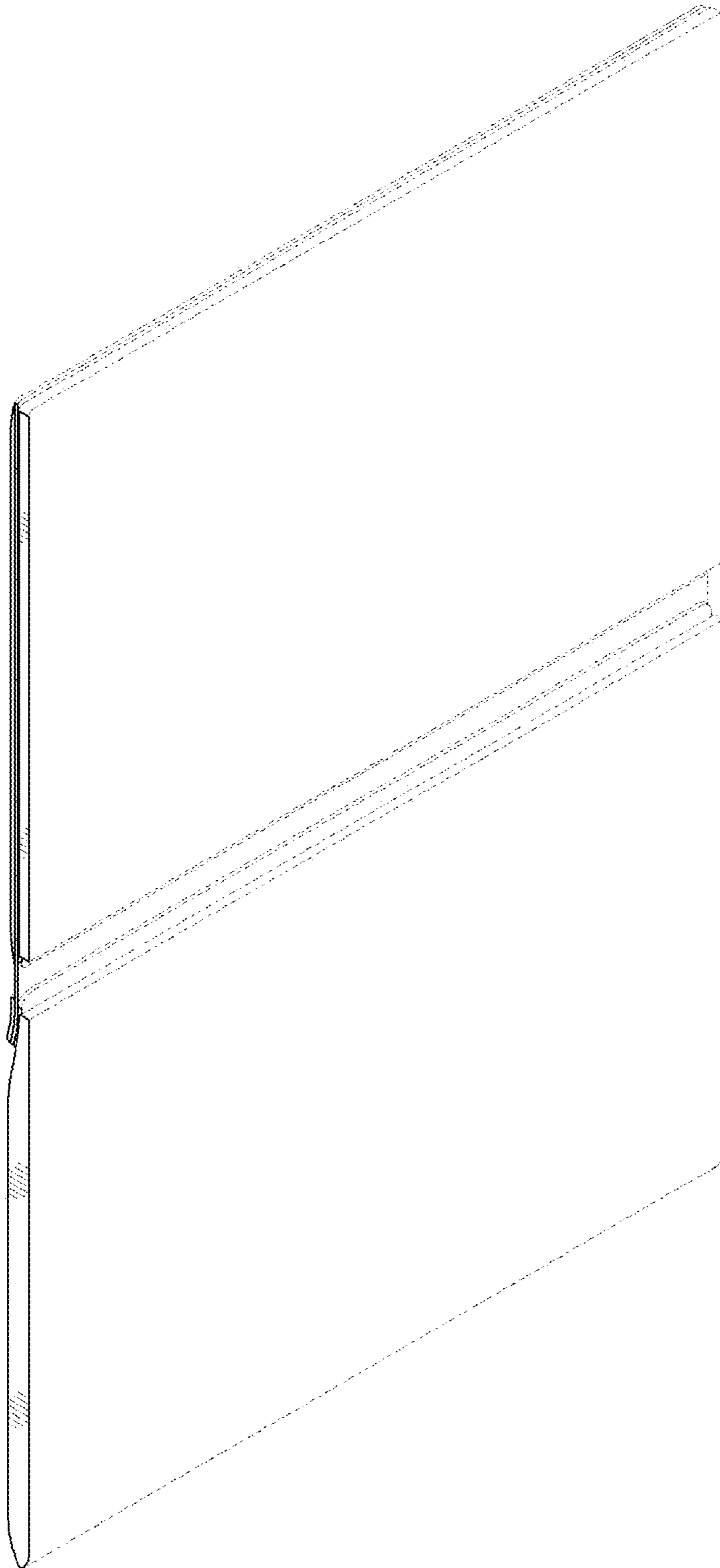
**DESCRIPTION**

FIG. 1 is a front perspective view of a tablet computer showing our new design;

 The broken lines shown in the drawings represent portions of the tablet computer which form no part of the claimed design.

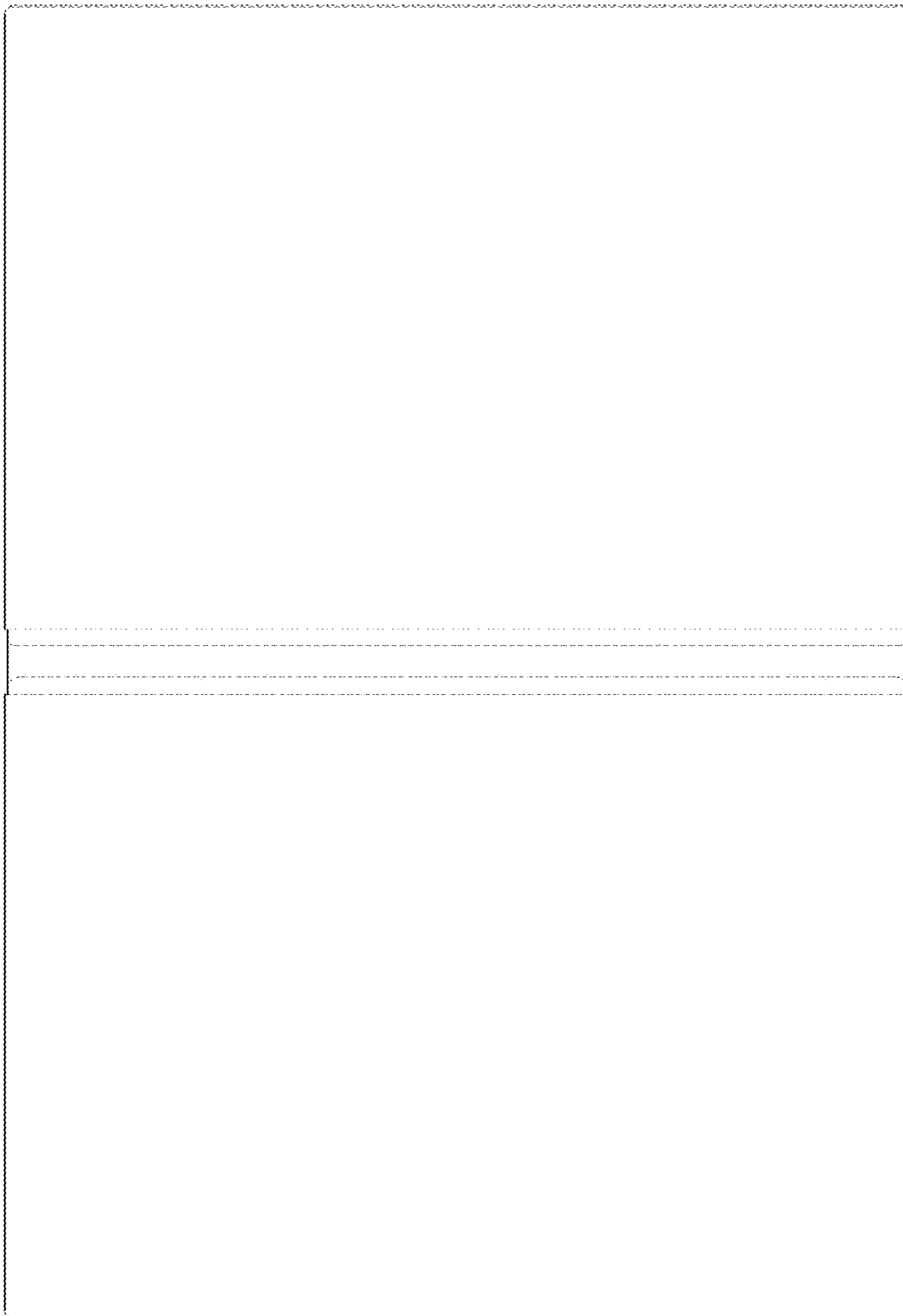

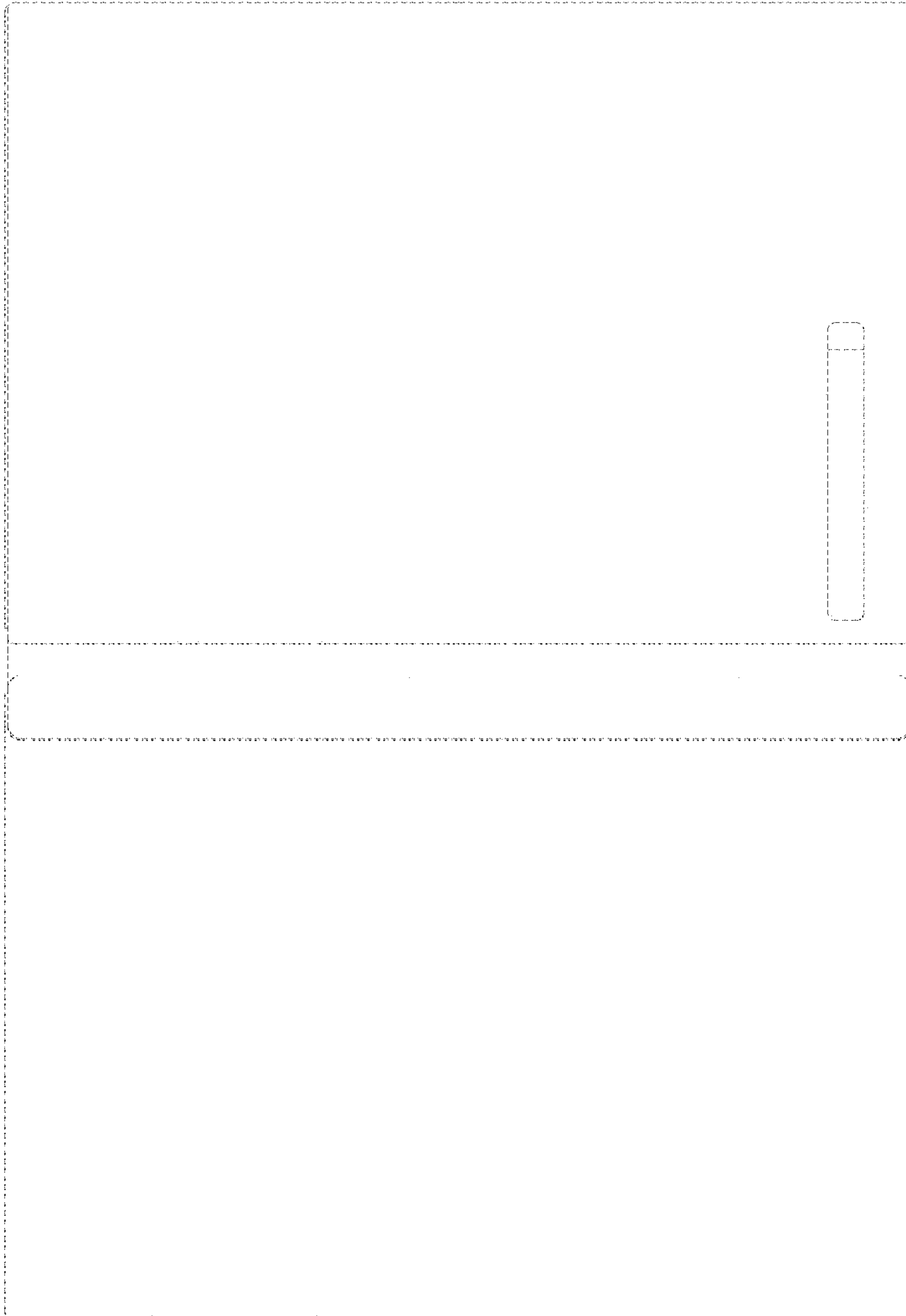

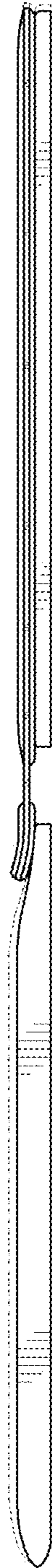

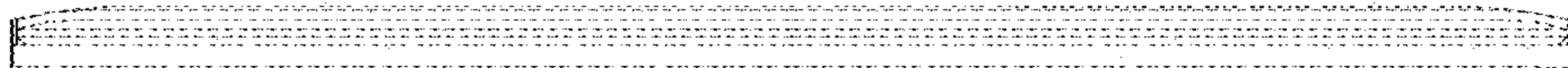

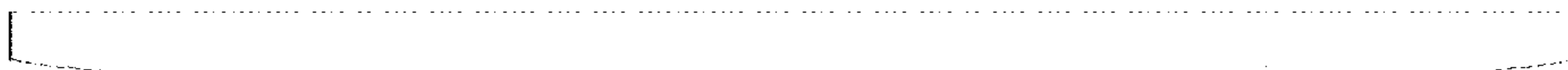

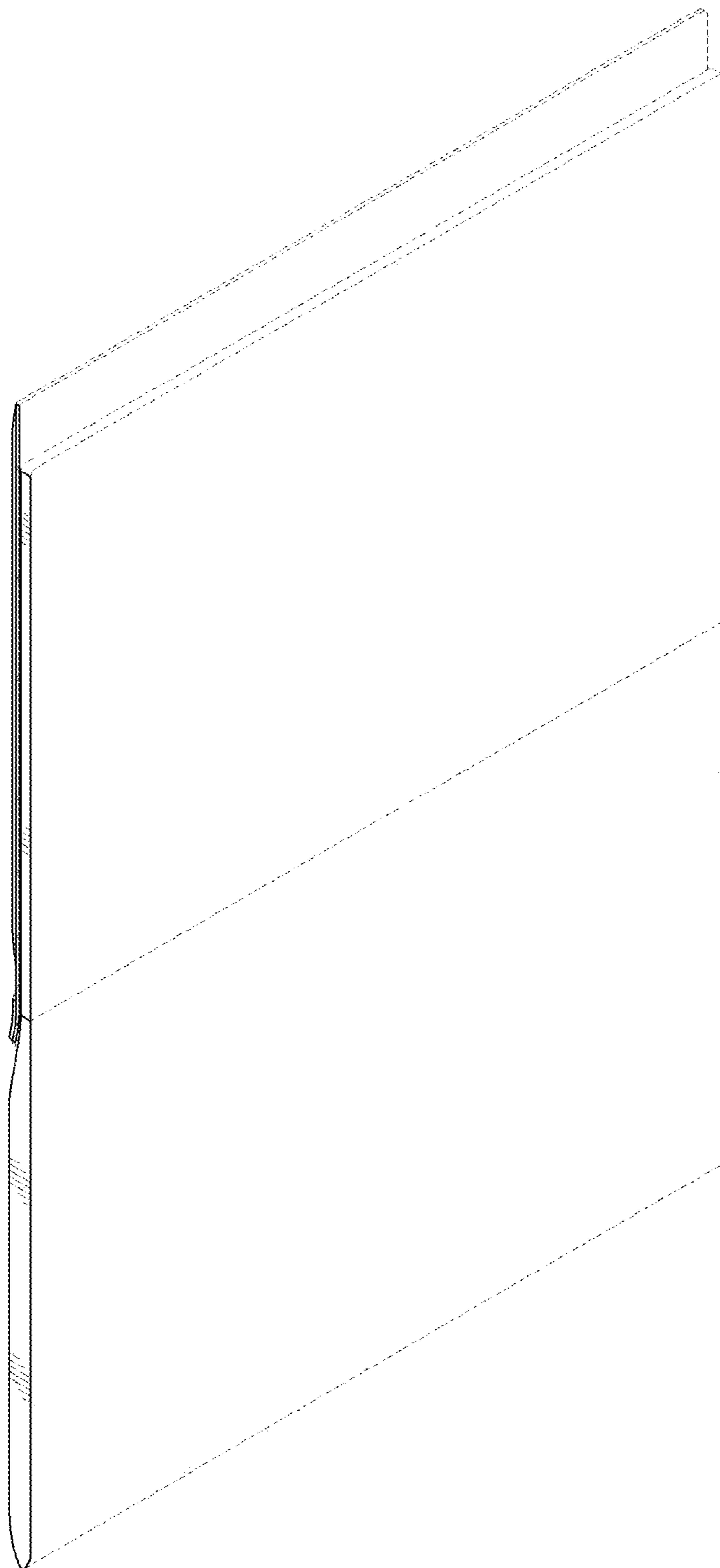
