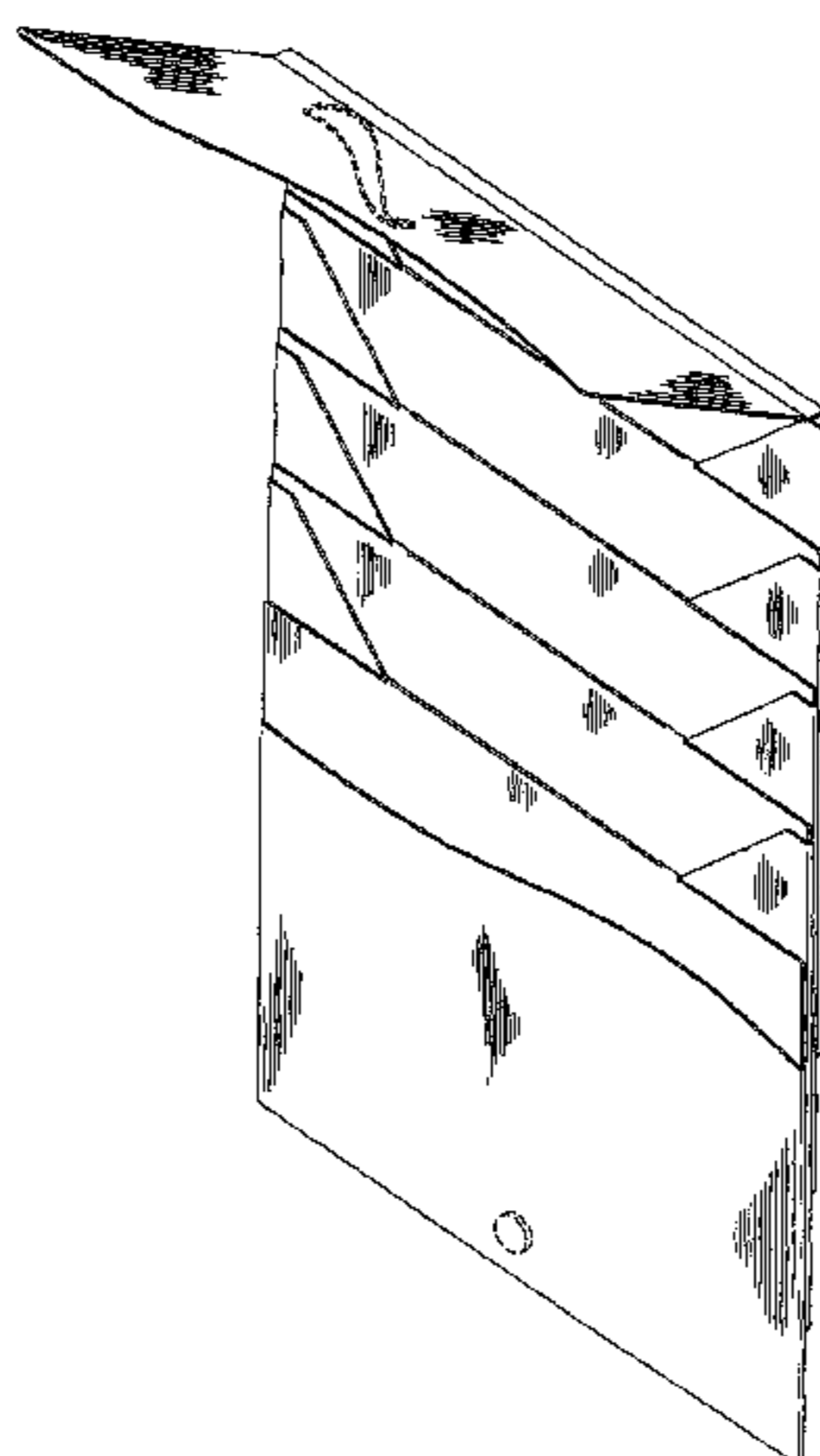

(57) **CLAIM**

We claim the ornamental design for a file folder assembly and folders for use therein, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a file folder assembly and folders for use therein showing our new design in an expanded state with the back folder cover flap partially opened;

FIG. 2 is a front elevational view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a front perspective view of the file folder assembly and folders for use therein shown in a compacted state with the back folder cover flap partially opened;
 FIG. 9 is a front elevational view thereof;
 FIG. 10 is a right side elevational view thereof;
 FIG. 11 is a left side elevational view thereof;
 FIG. 12 is a rear elevational view thereof;
 FIG. 13 is a top plan view thereof;

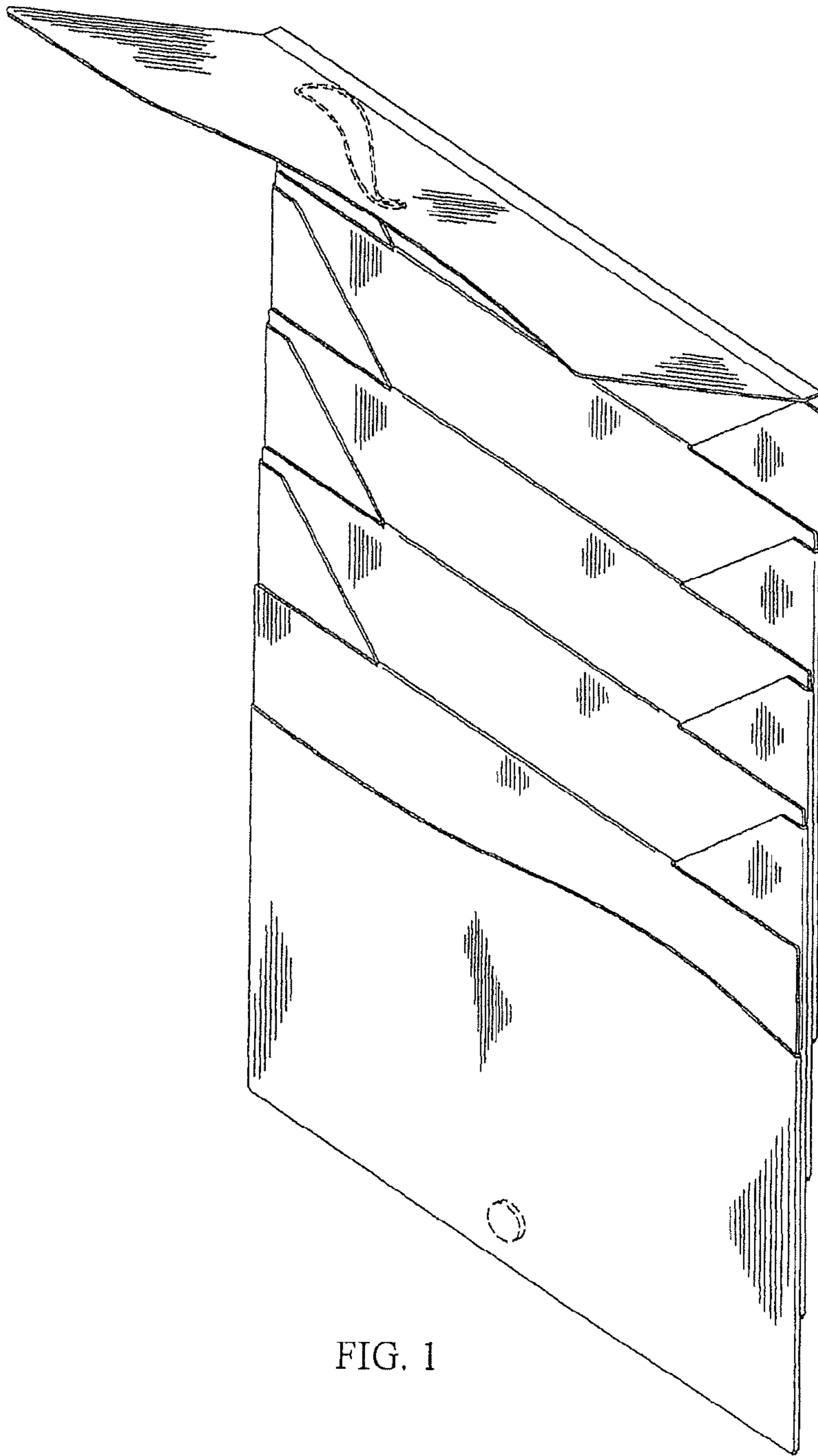

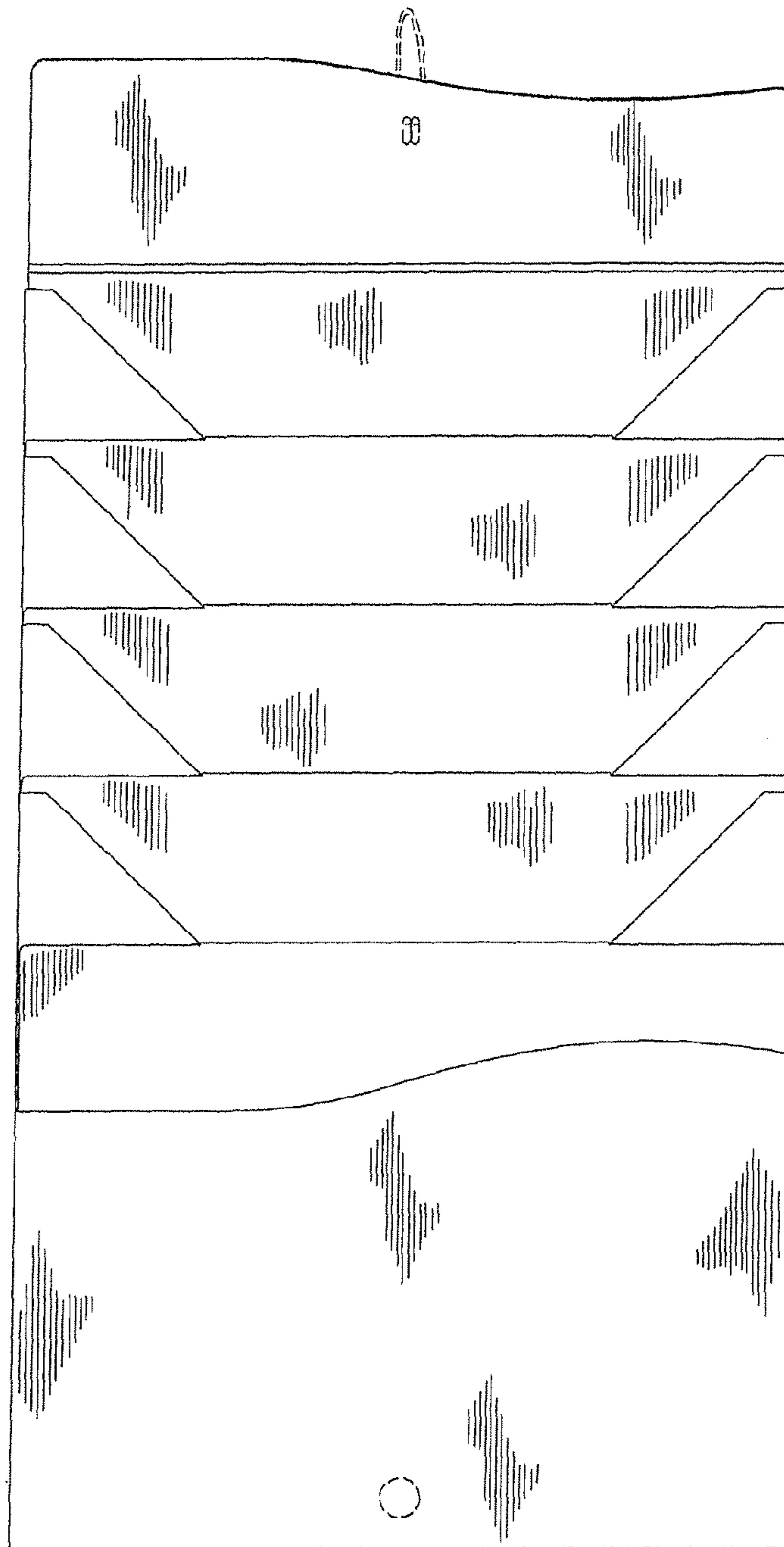

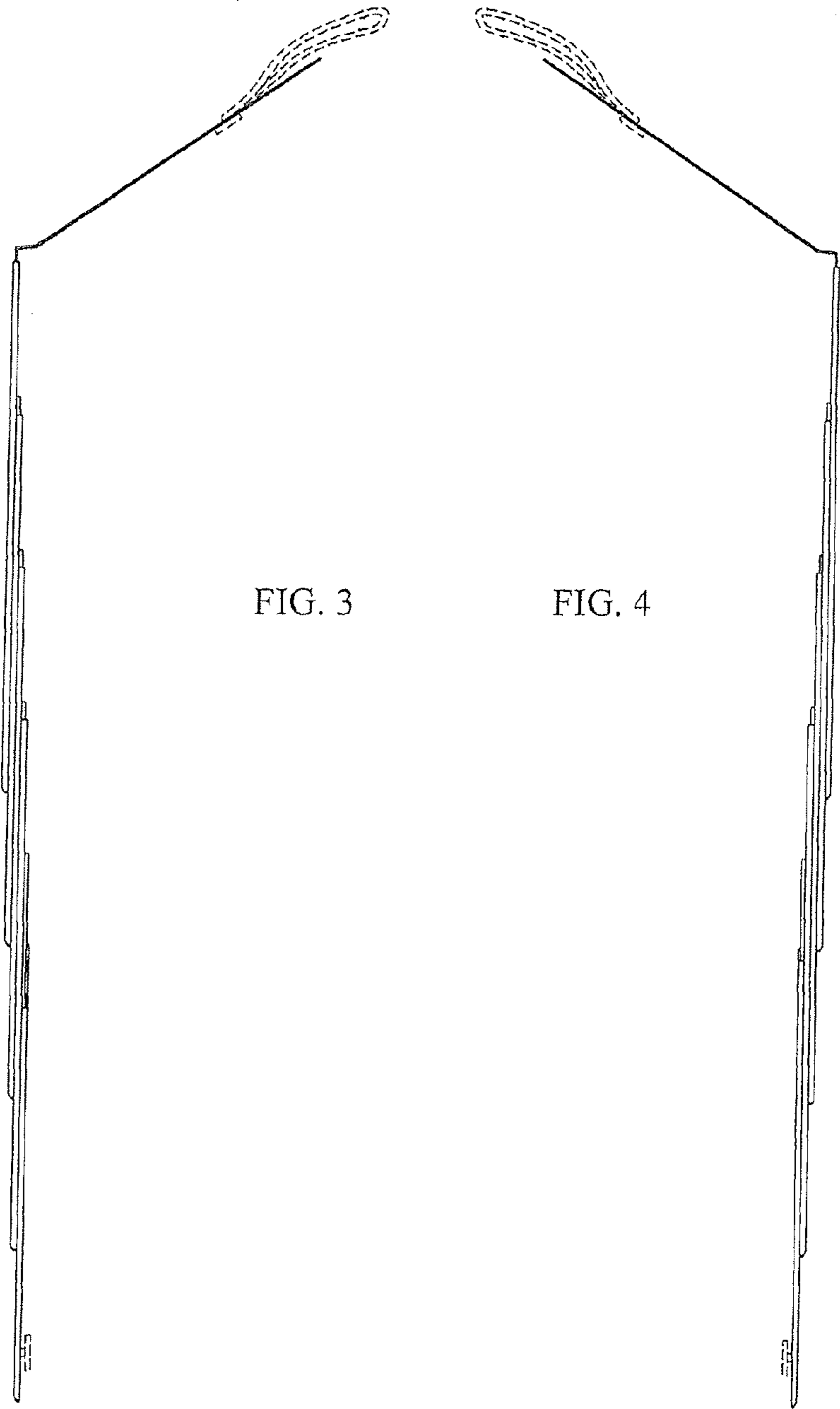
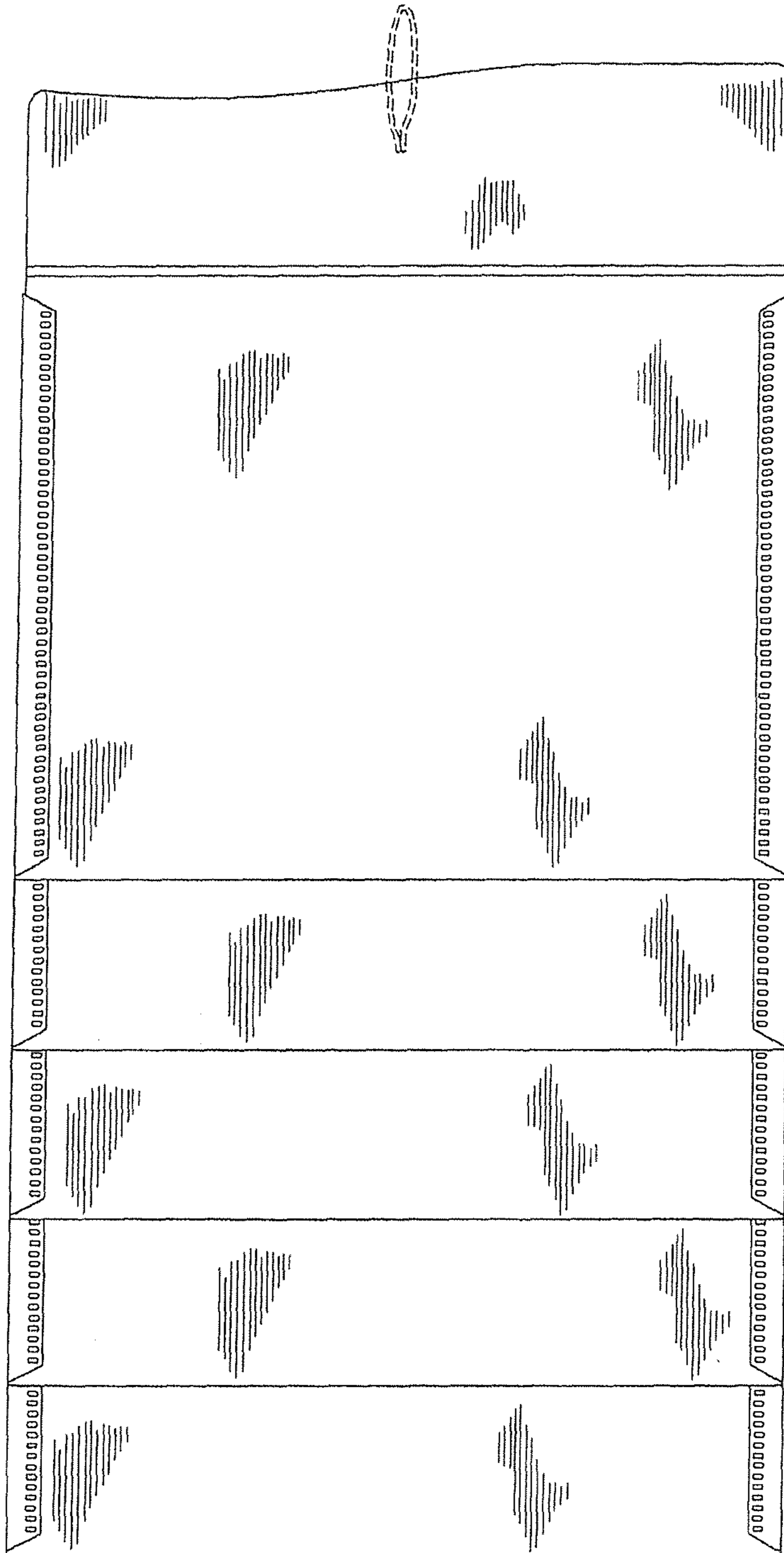

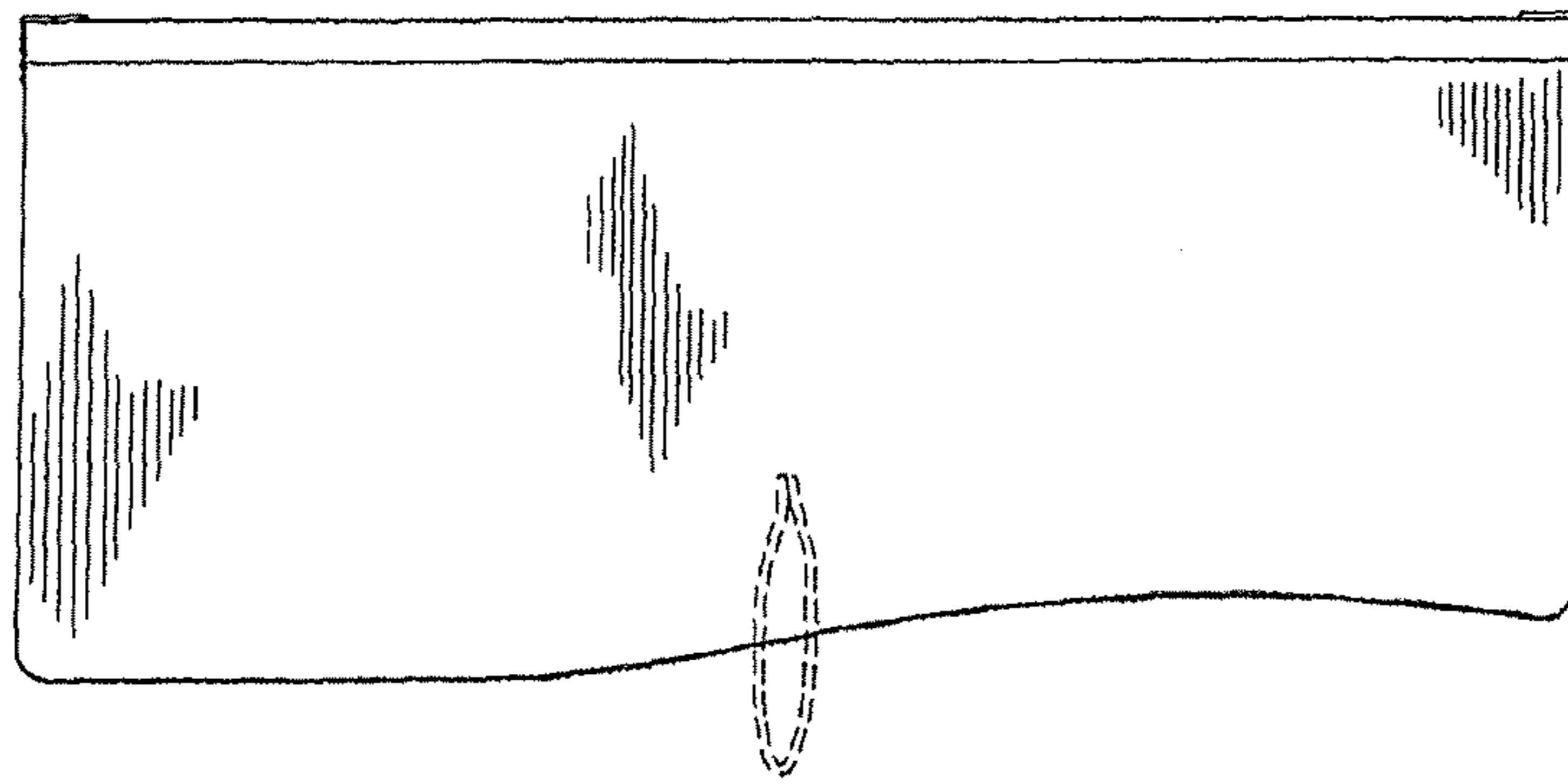

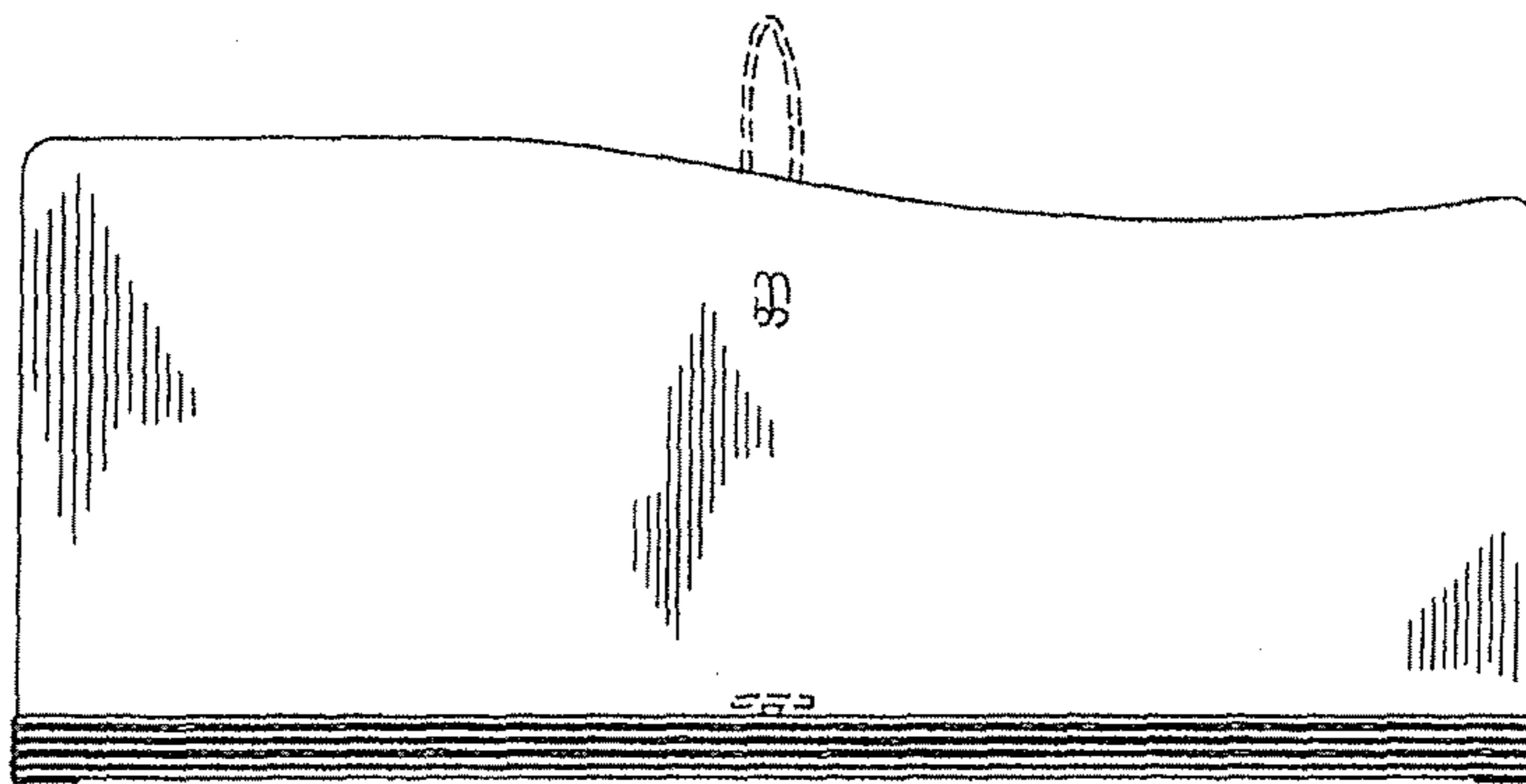

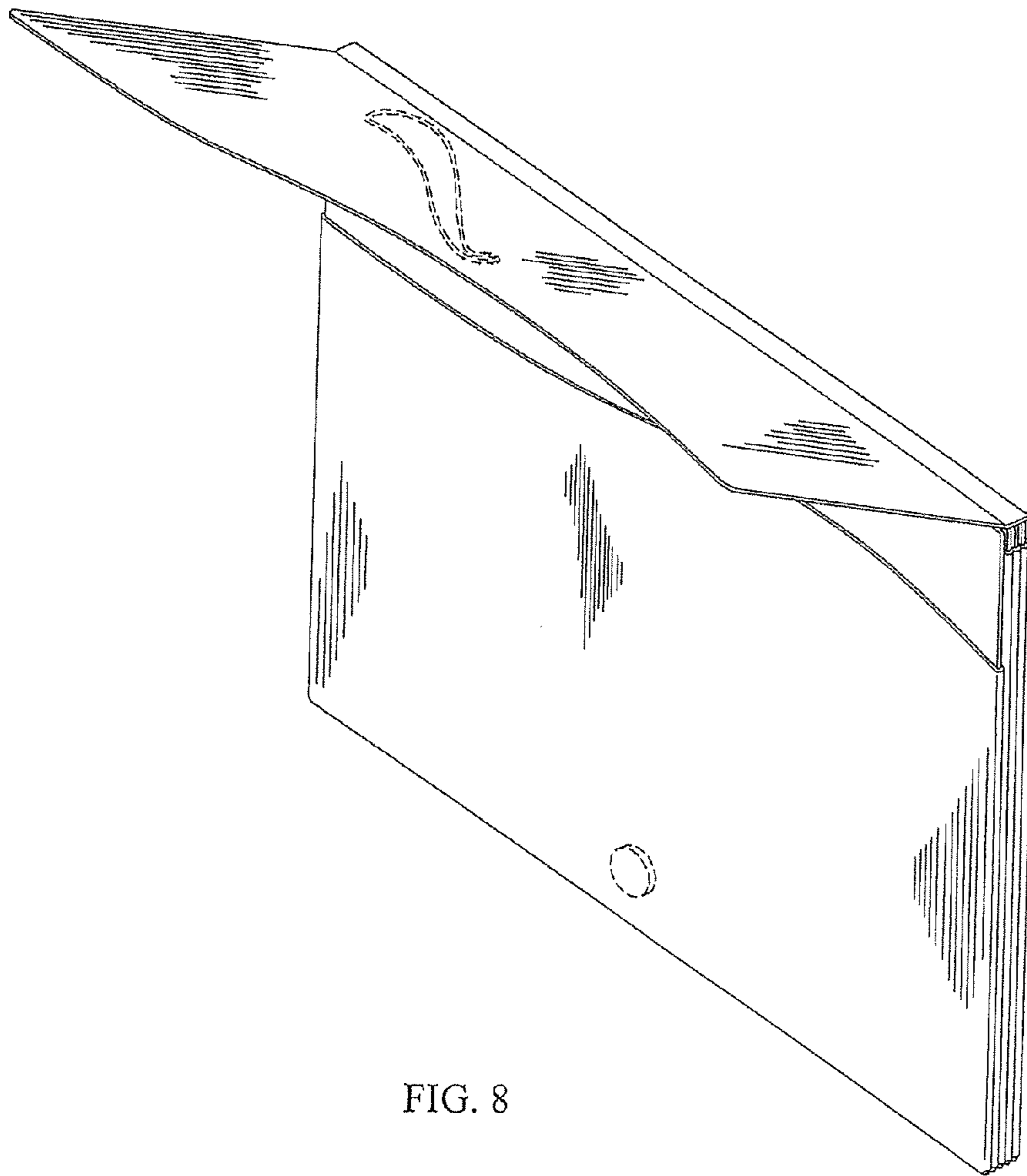

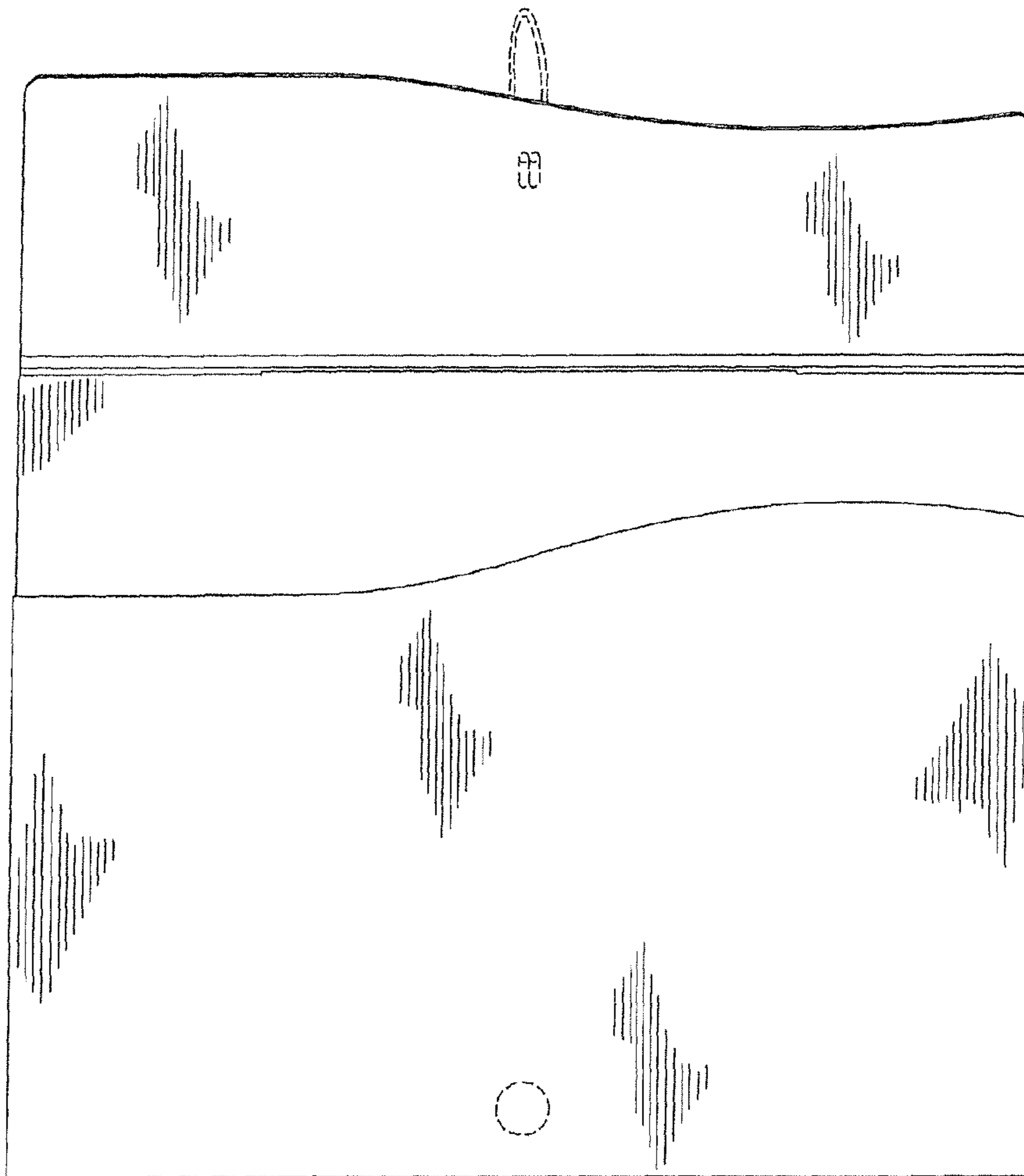
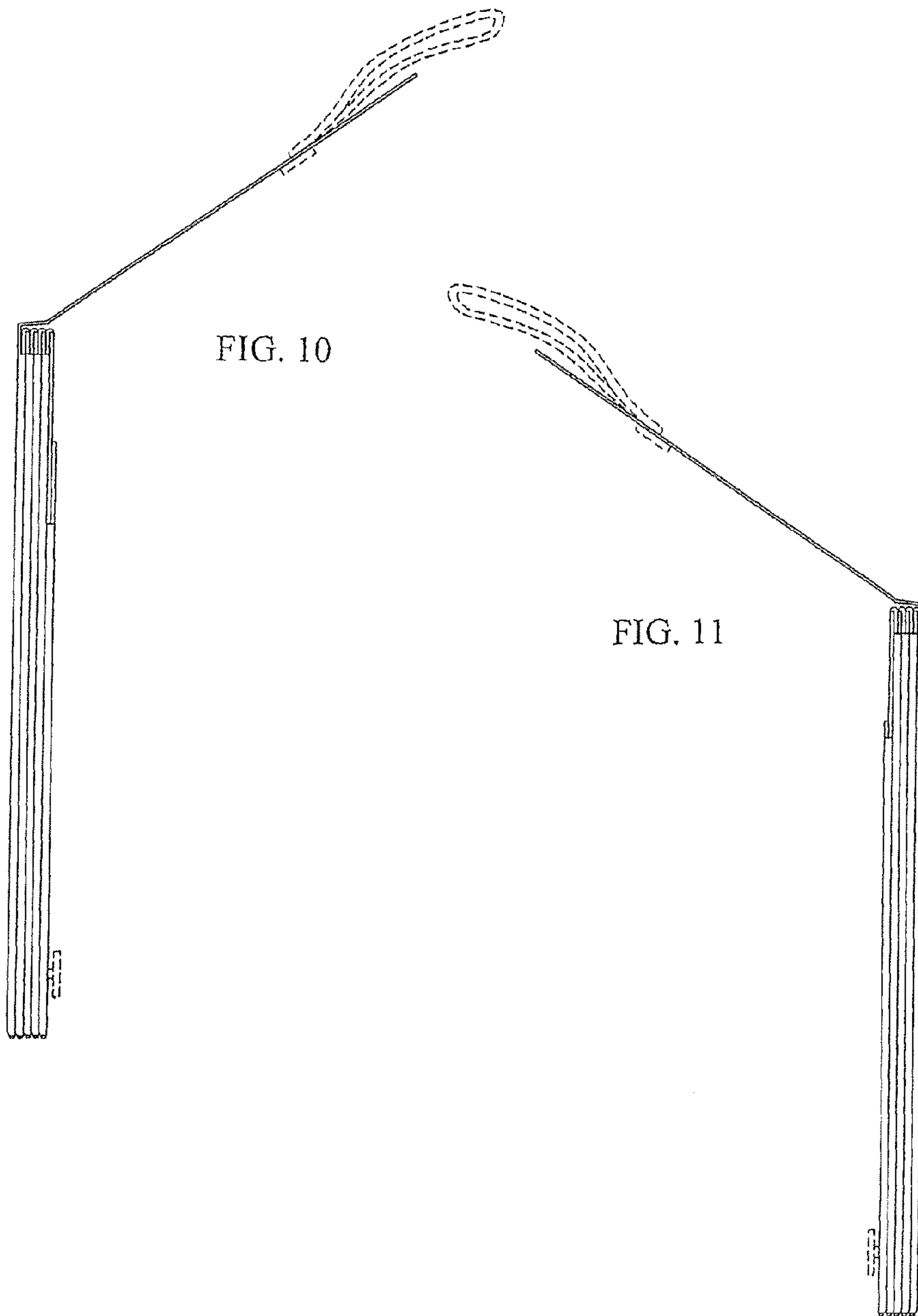

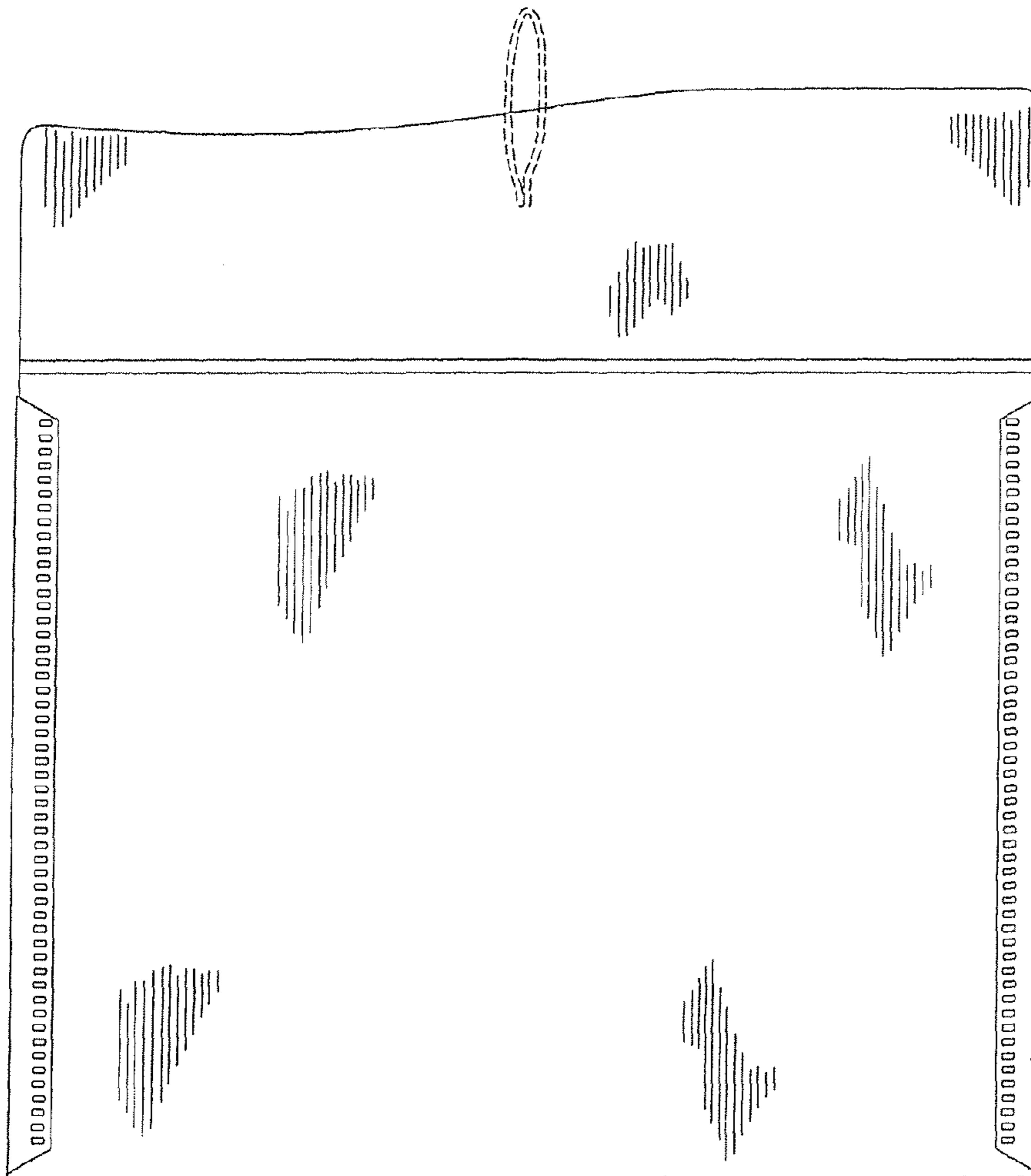

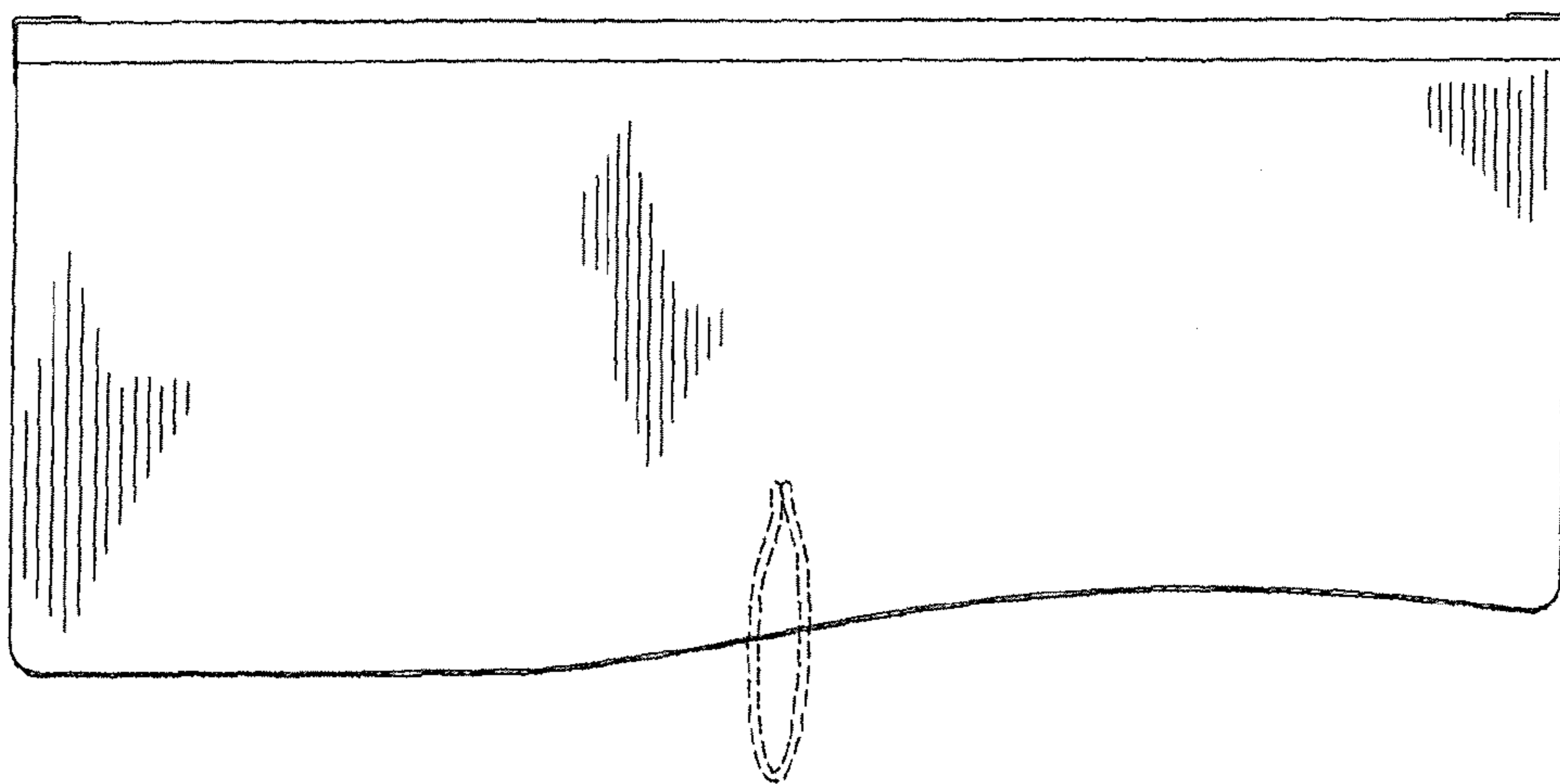

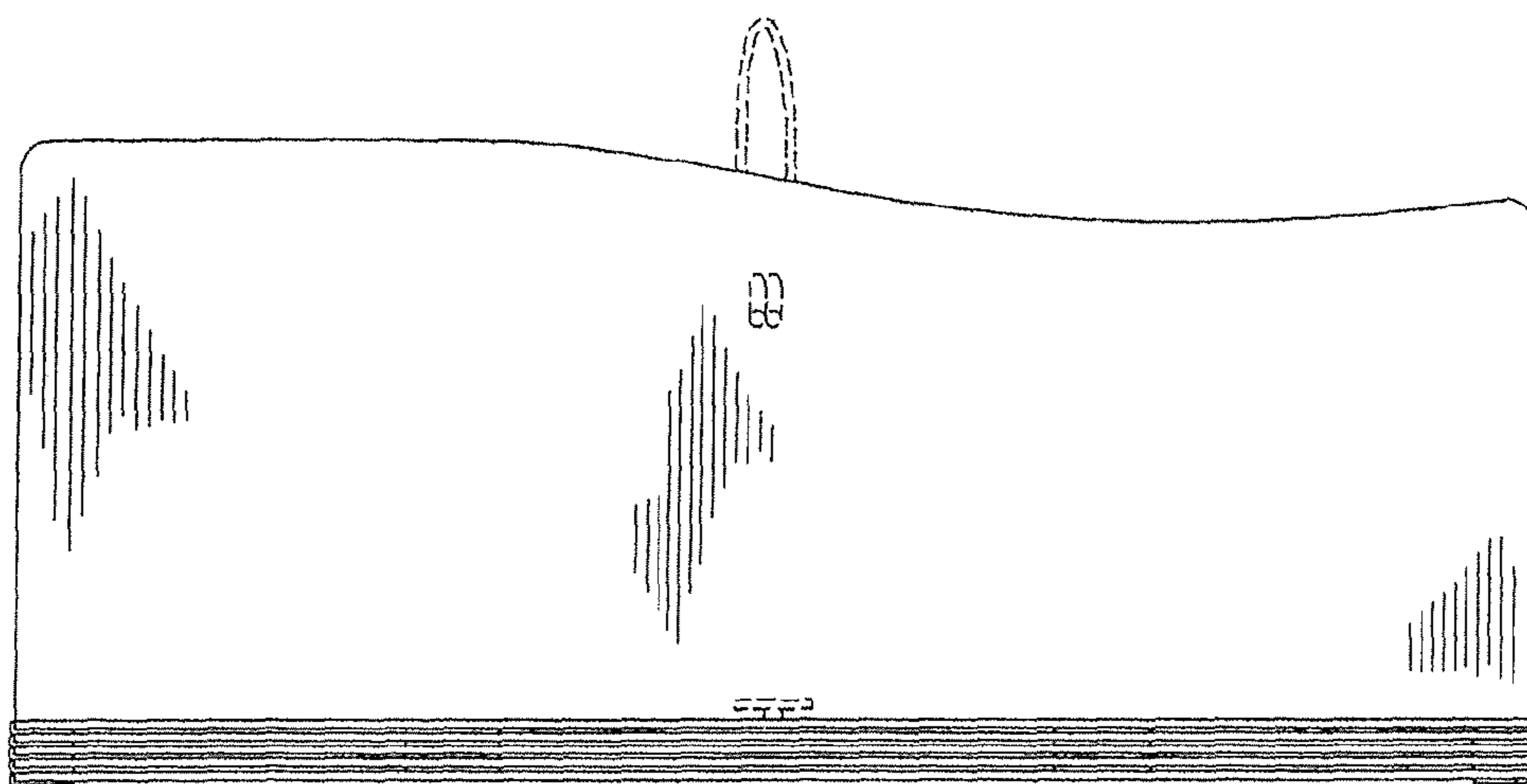

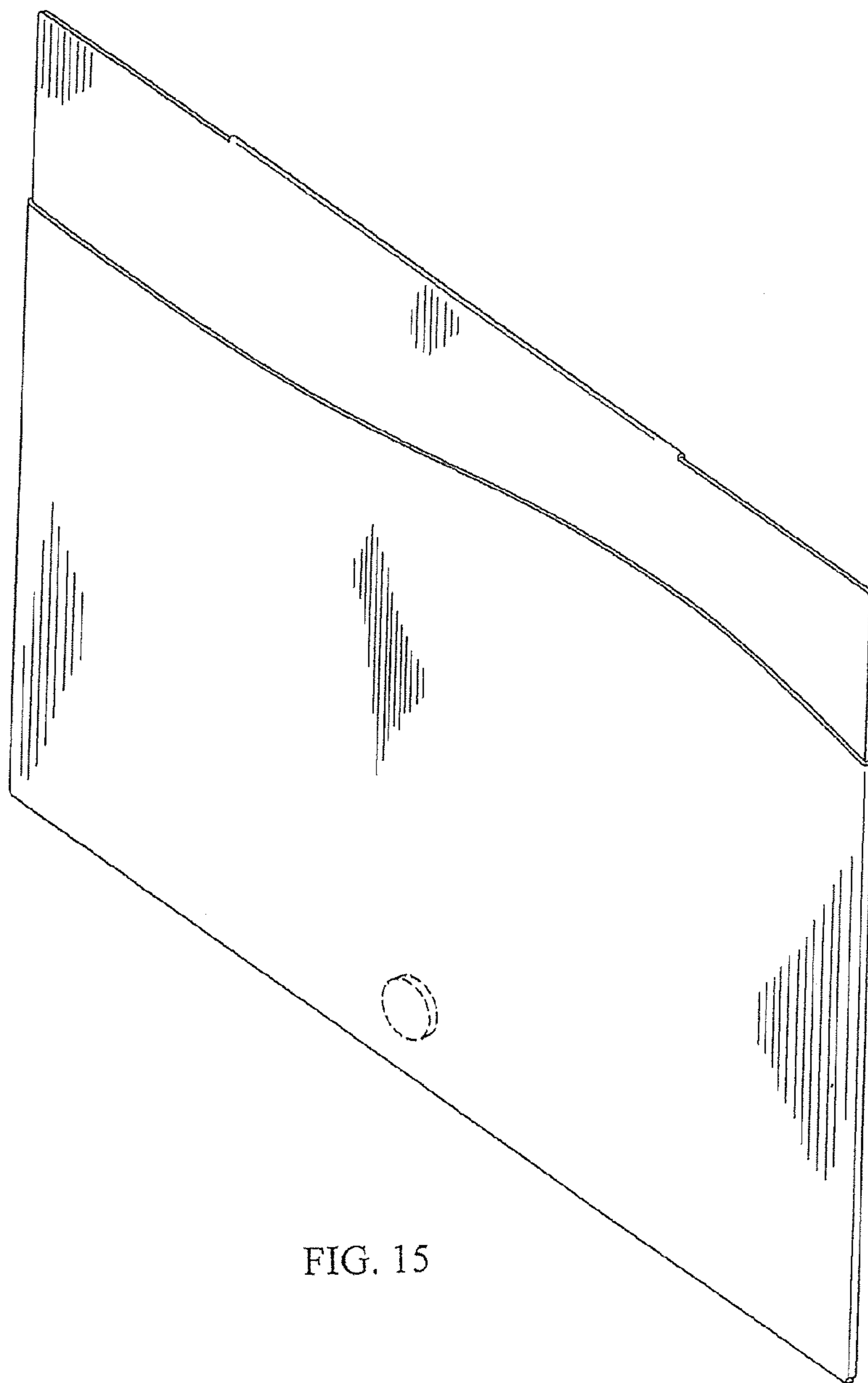

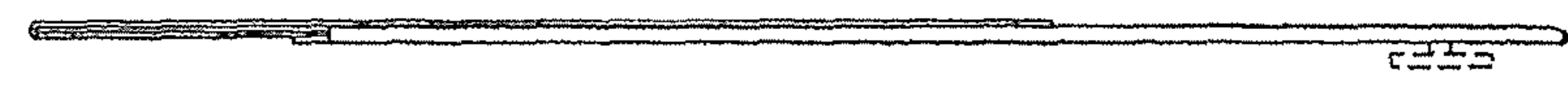

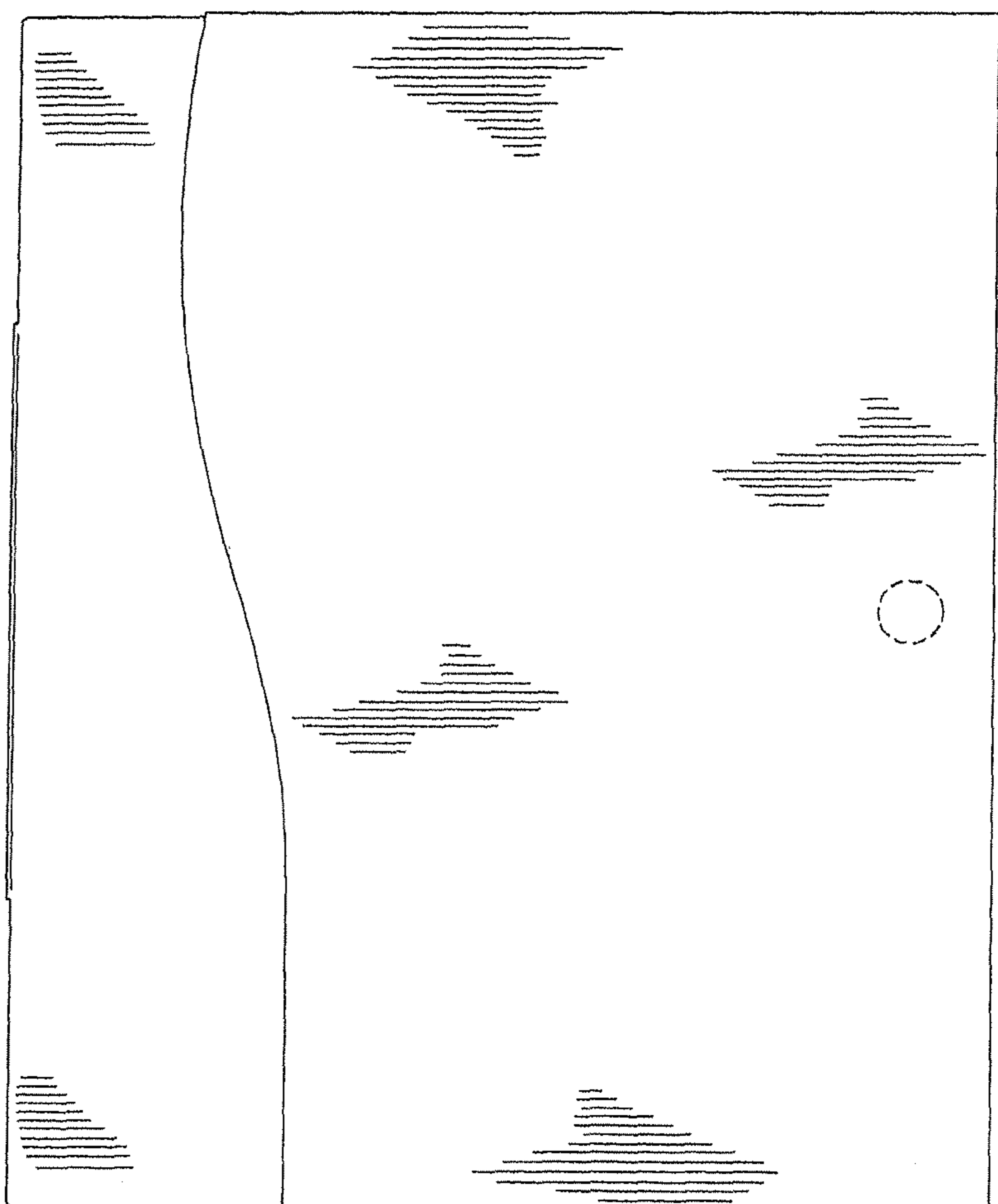

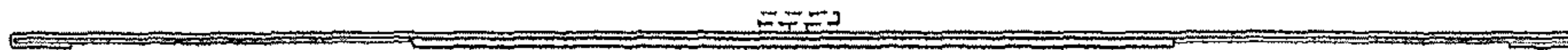

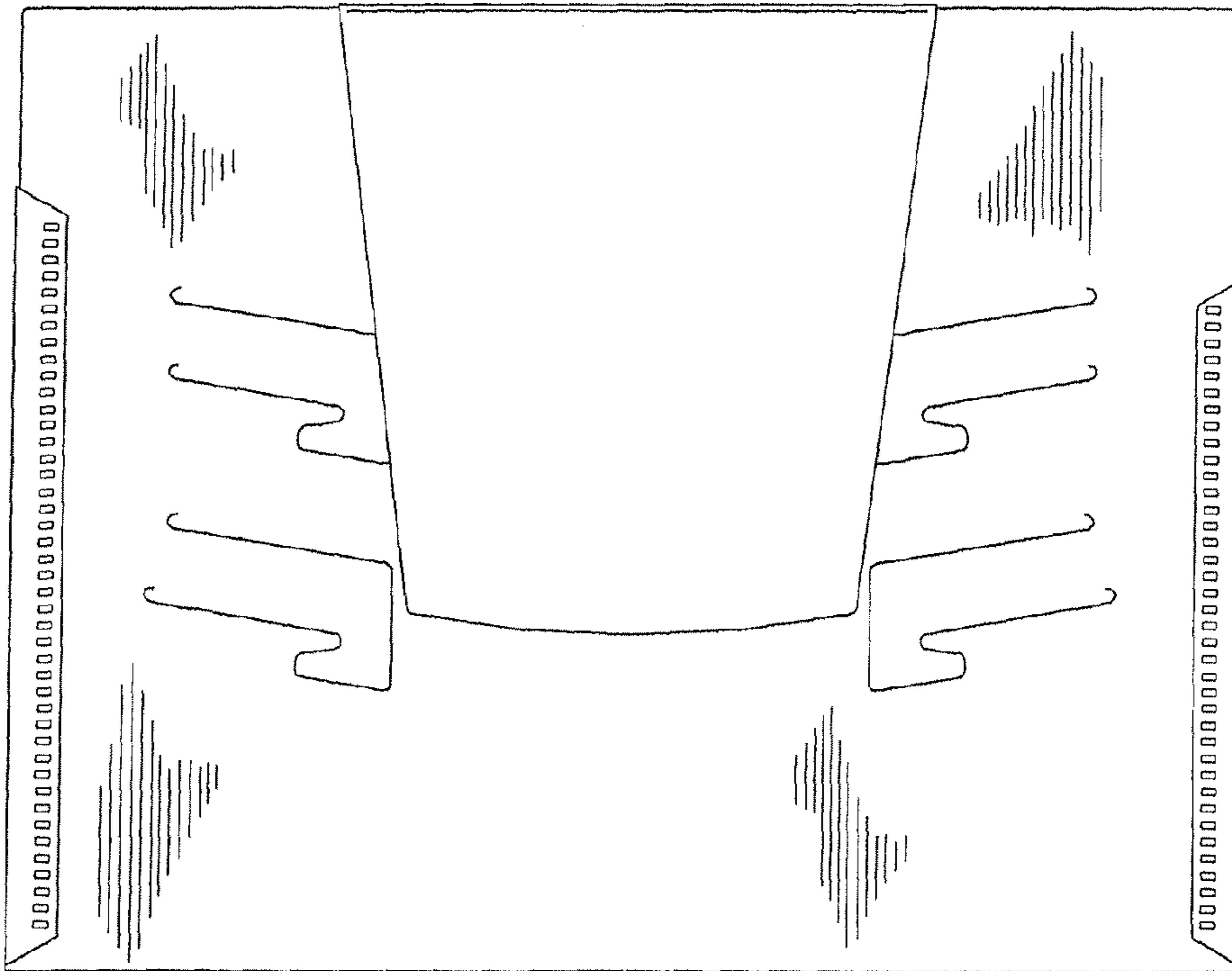

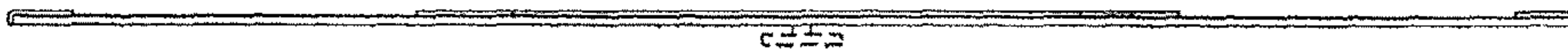

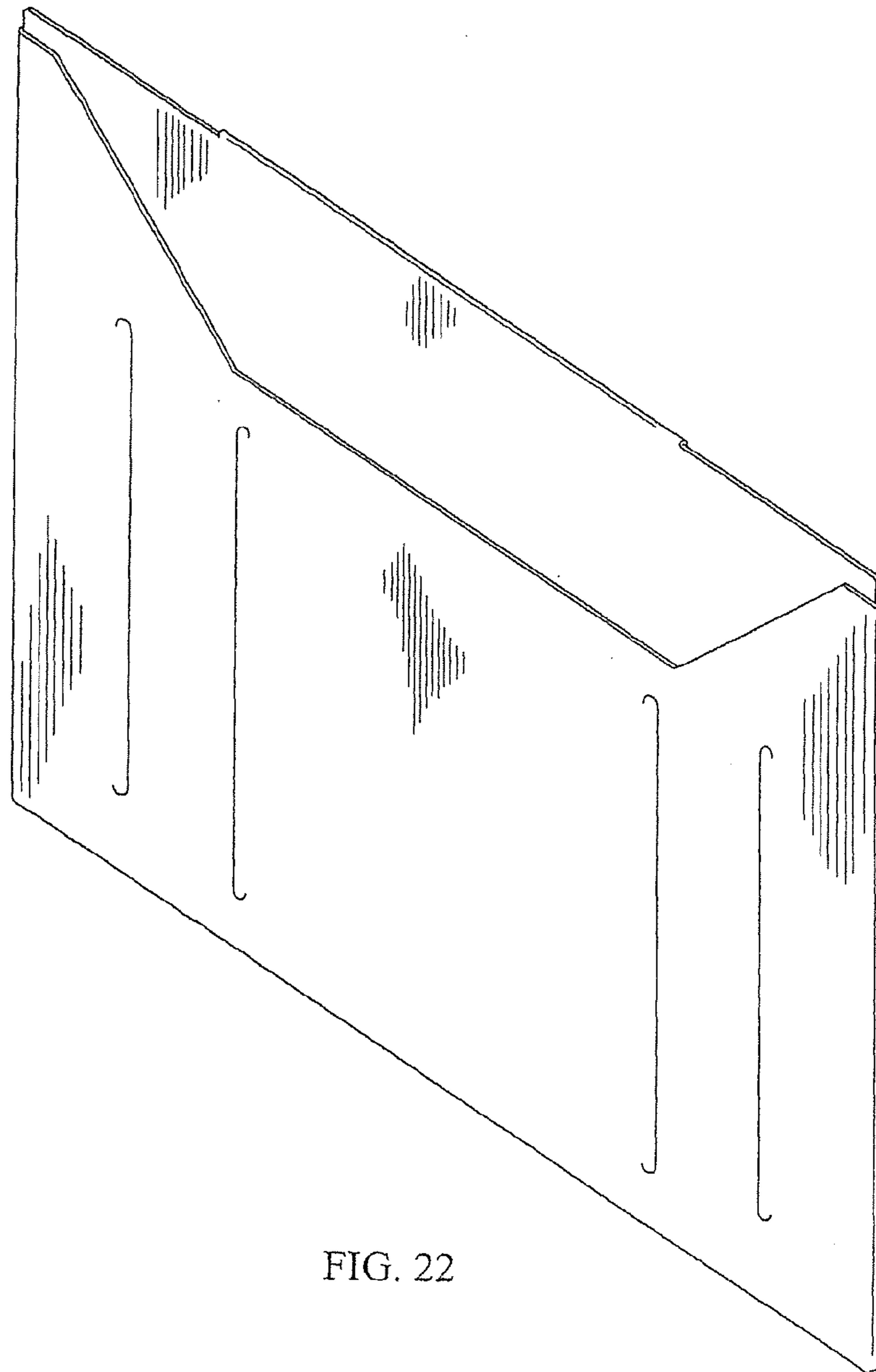

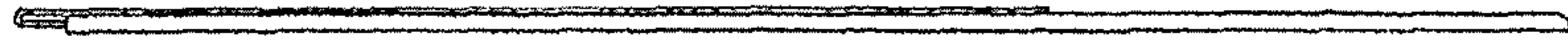

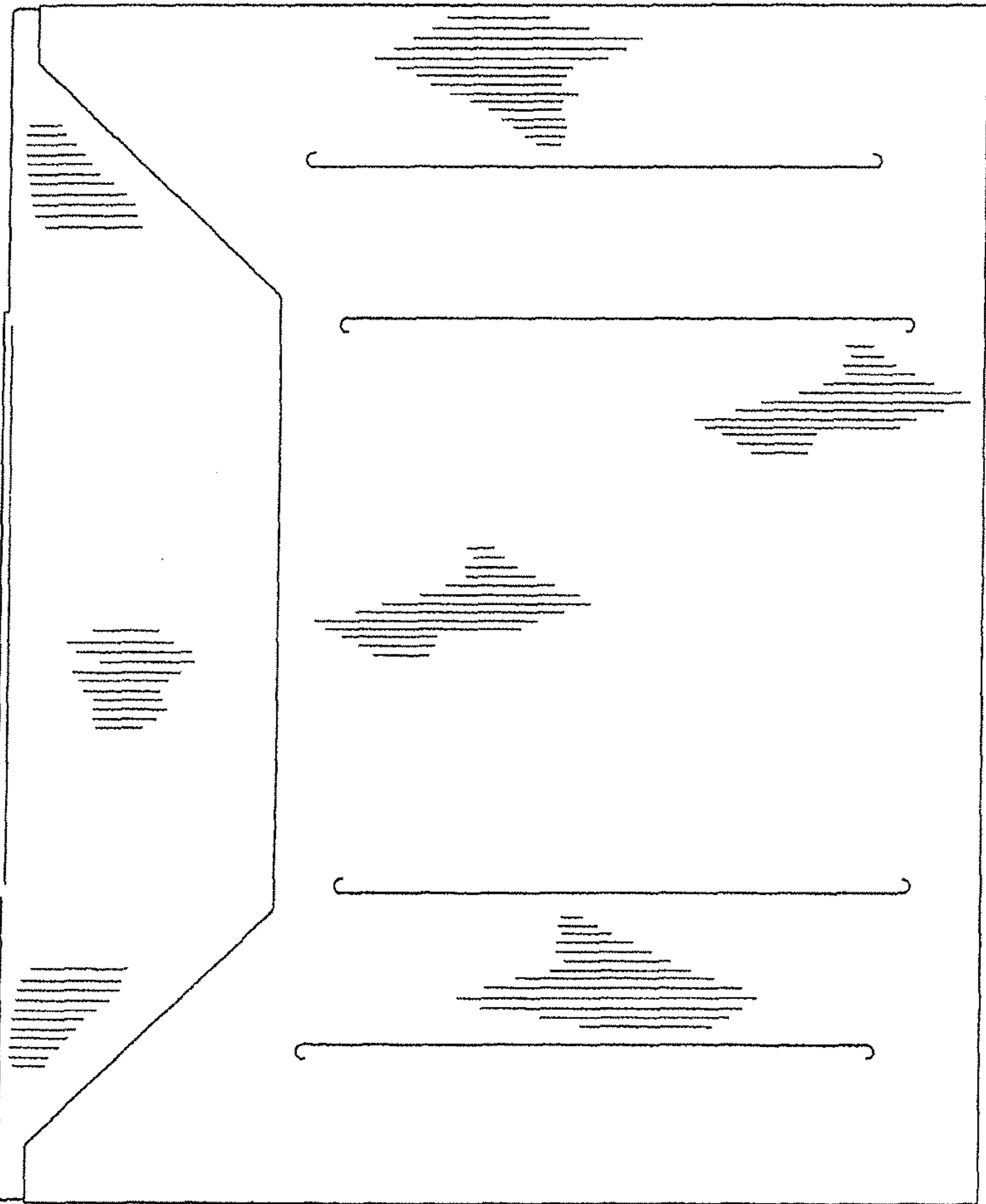

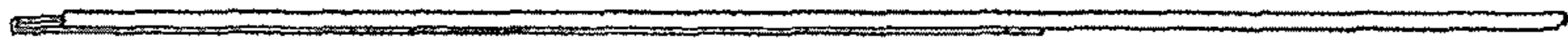

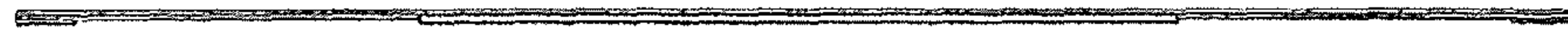

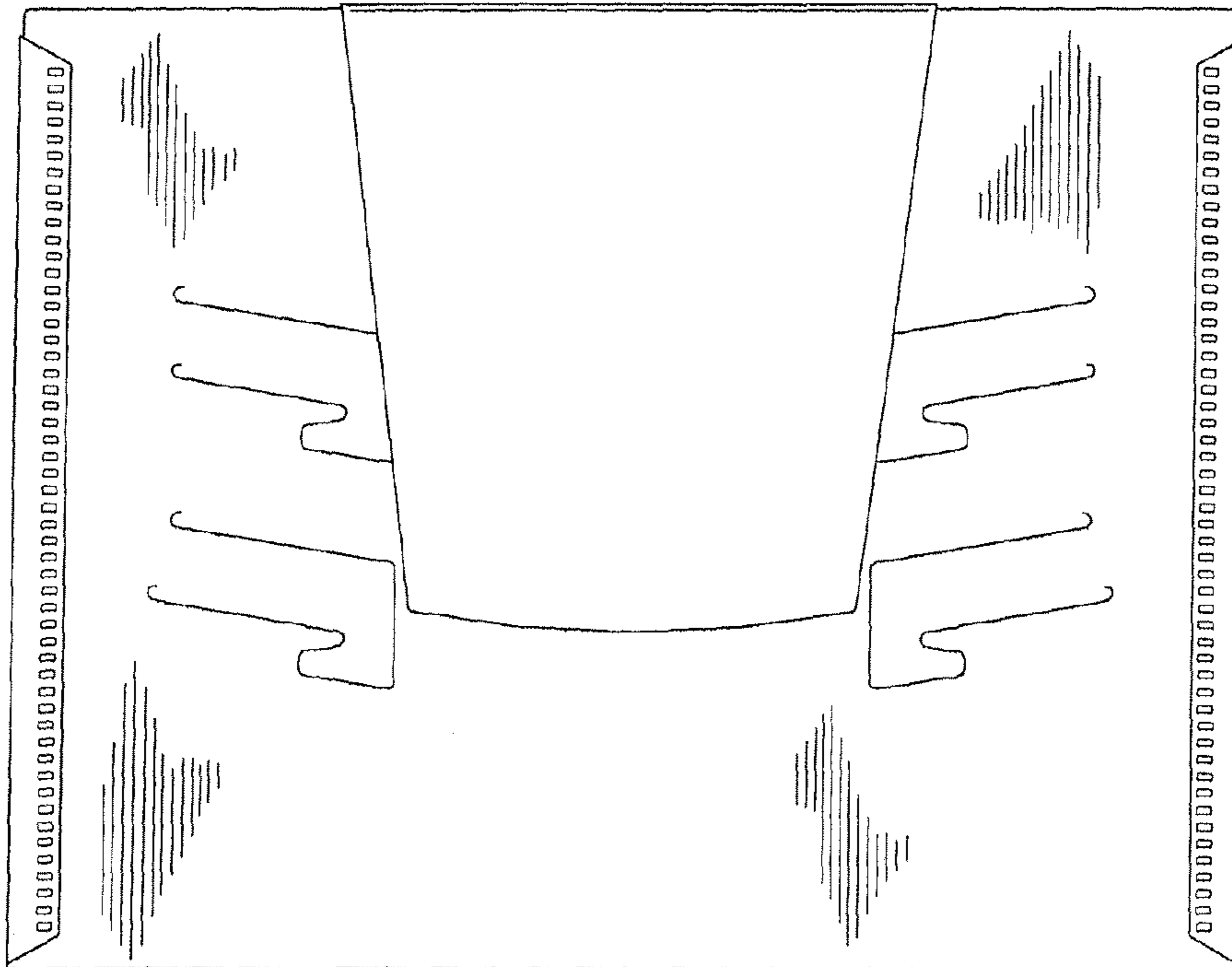

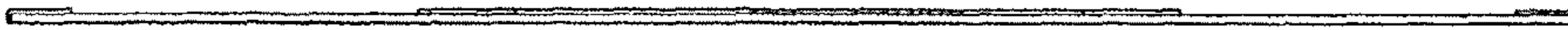

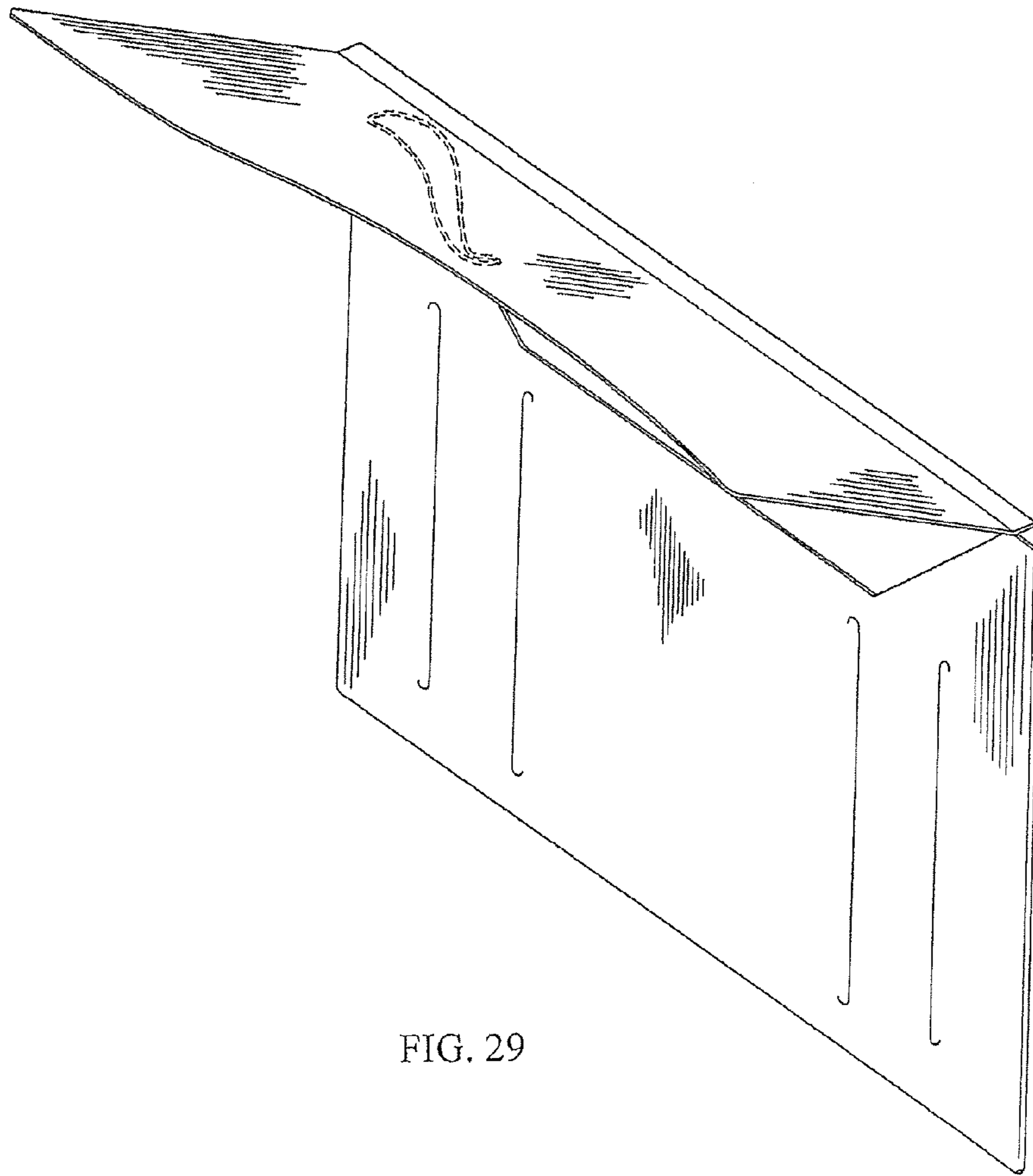

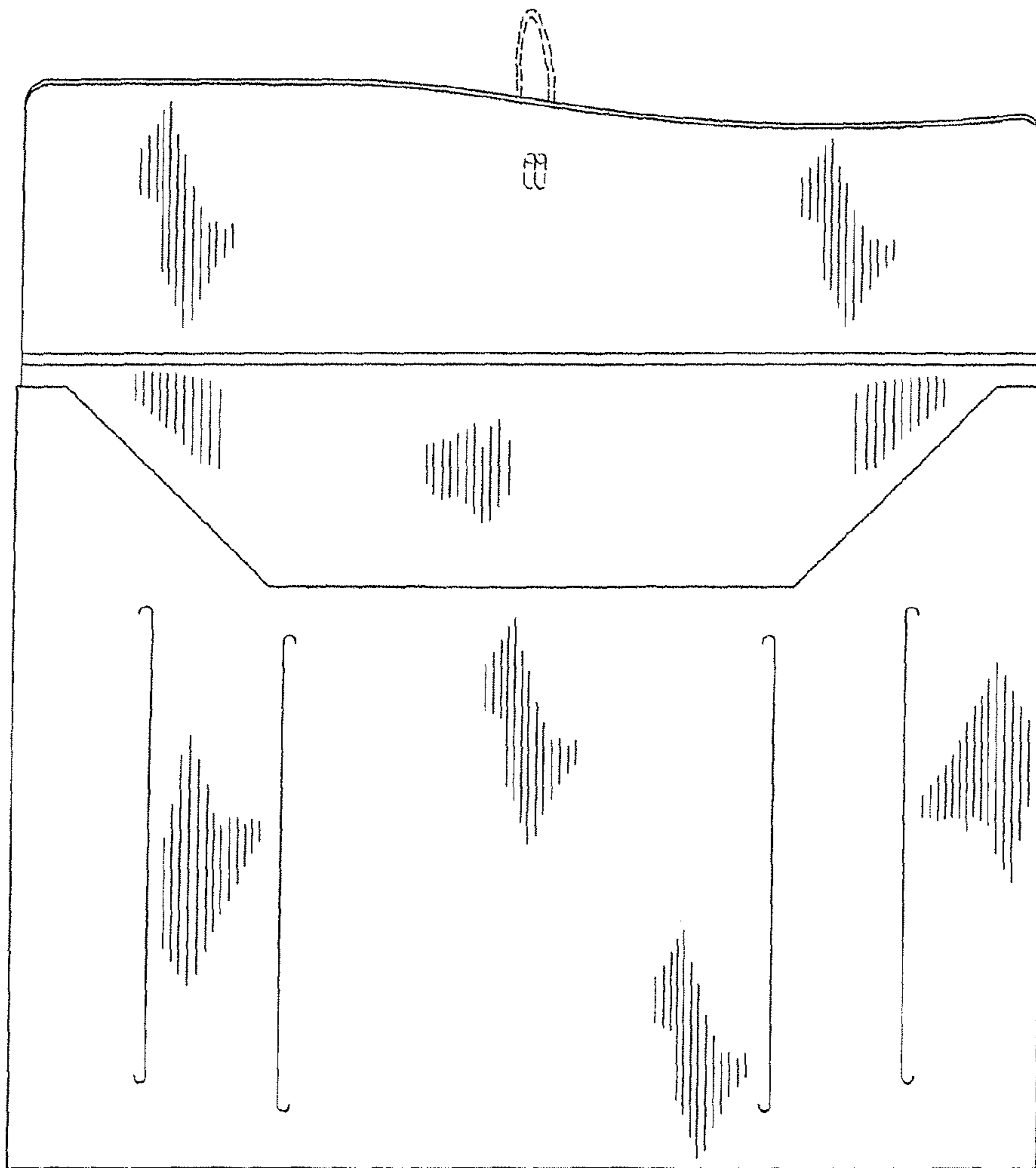

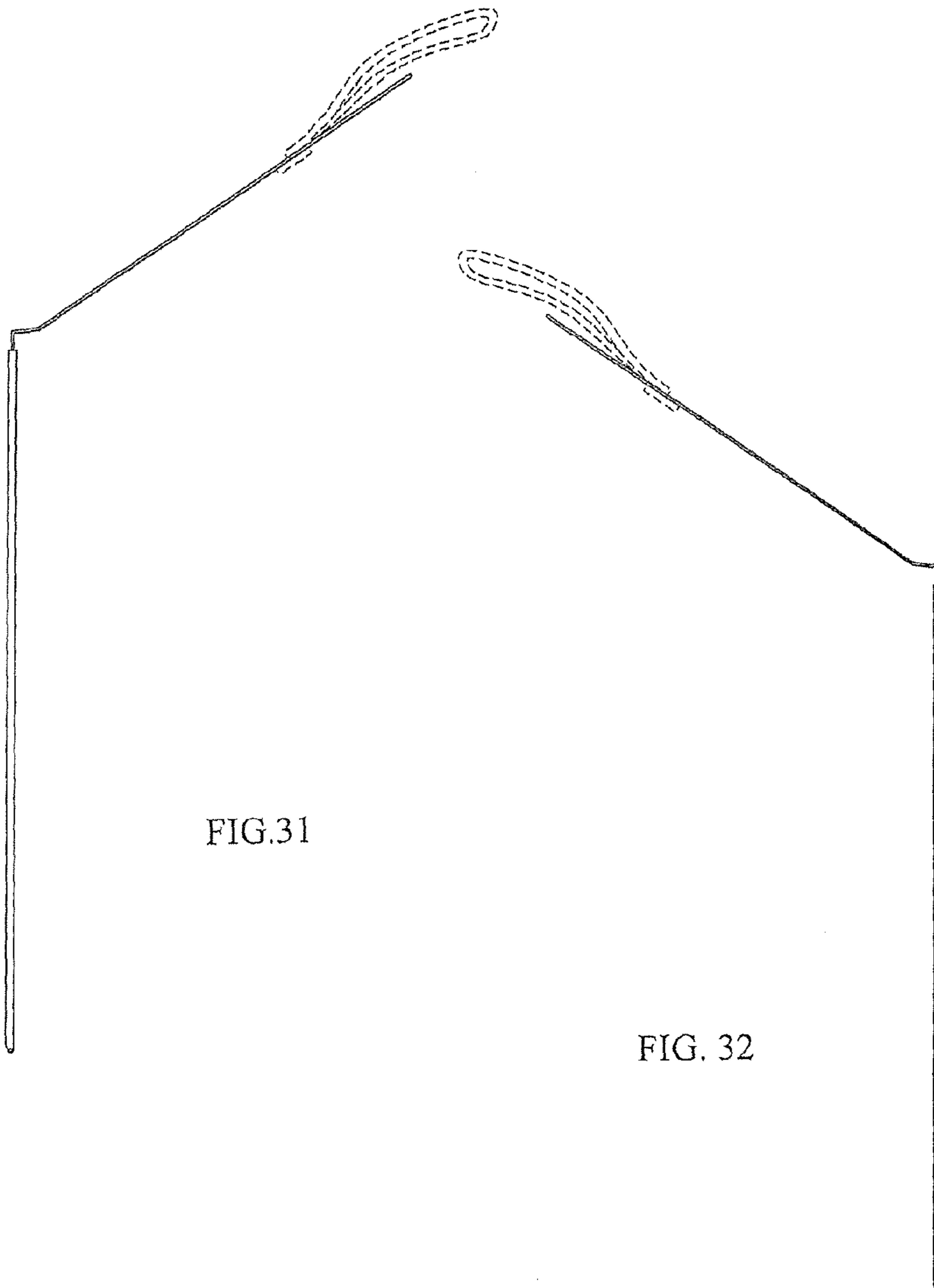

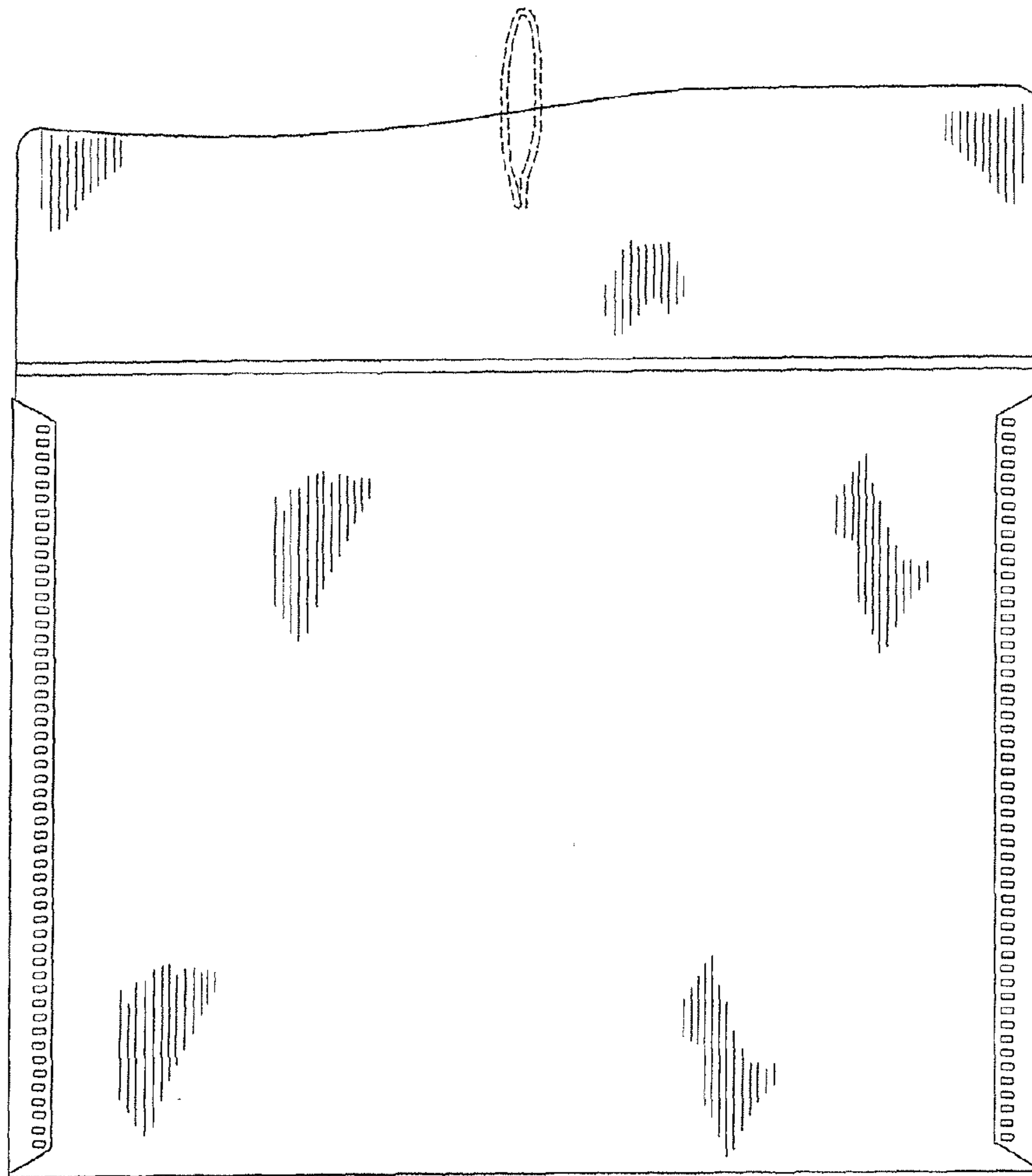

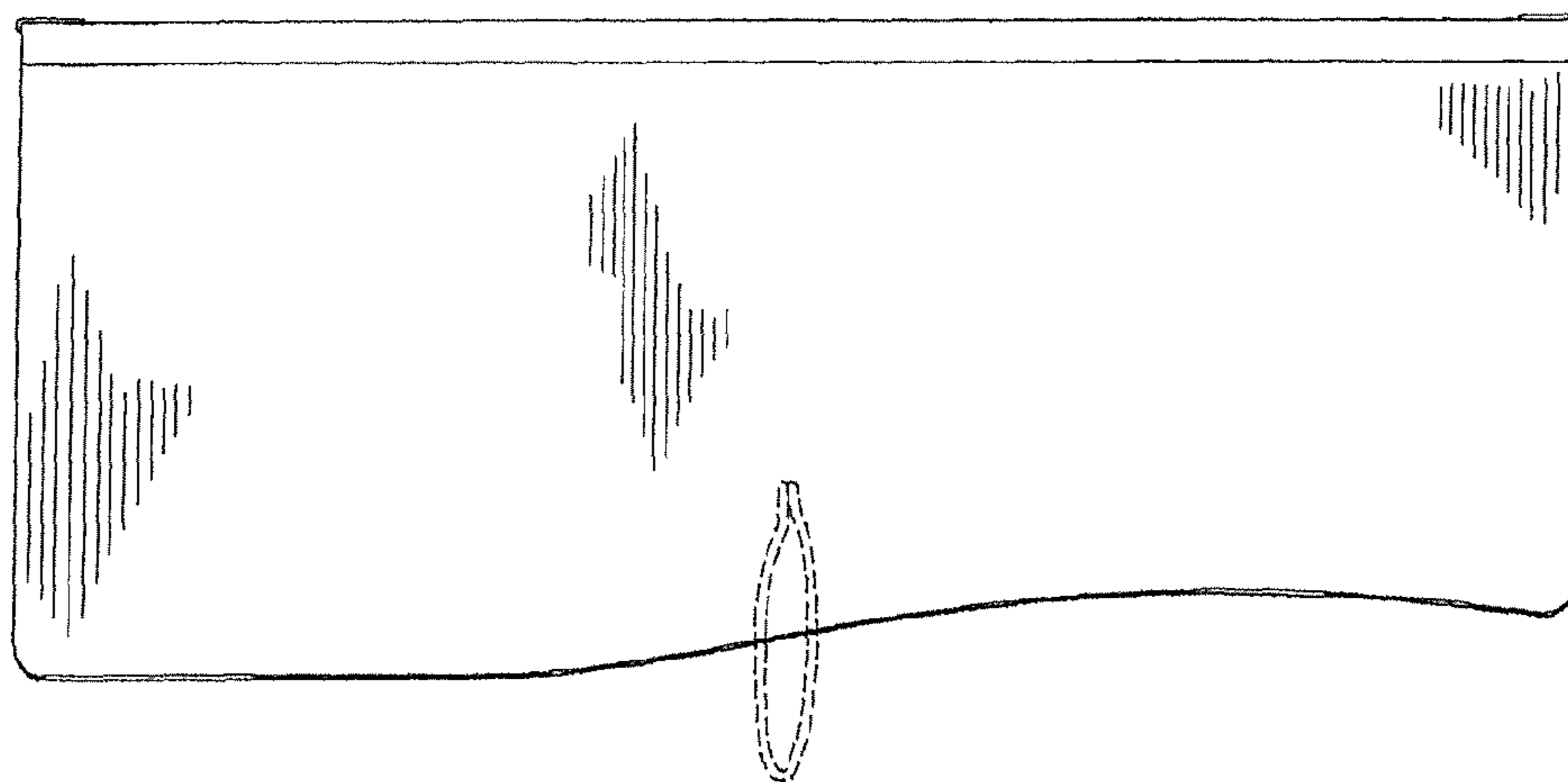

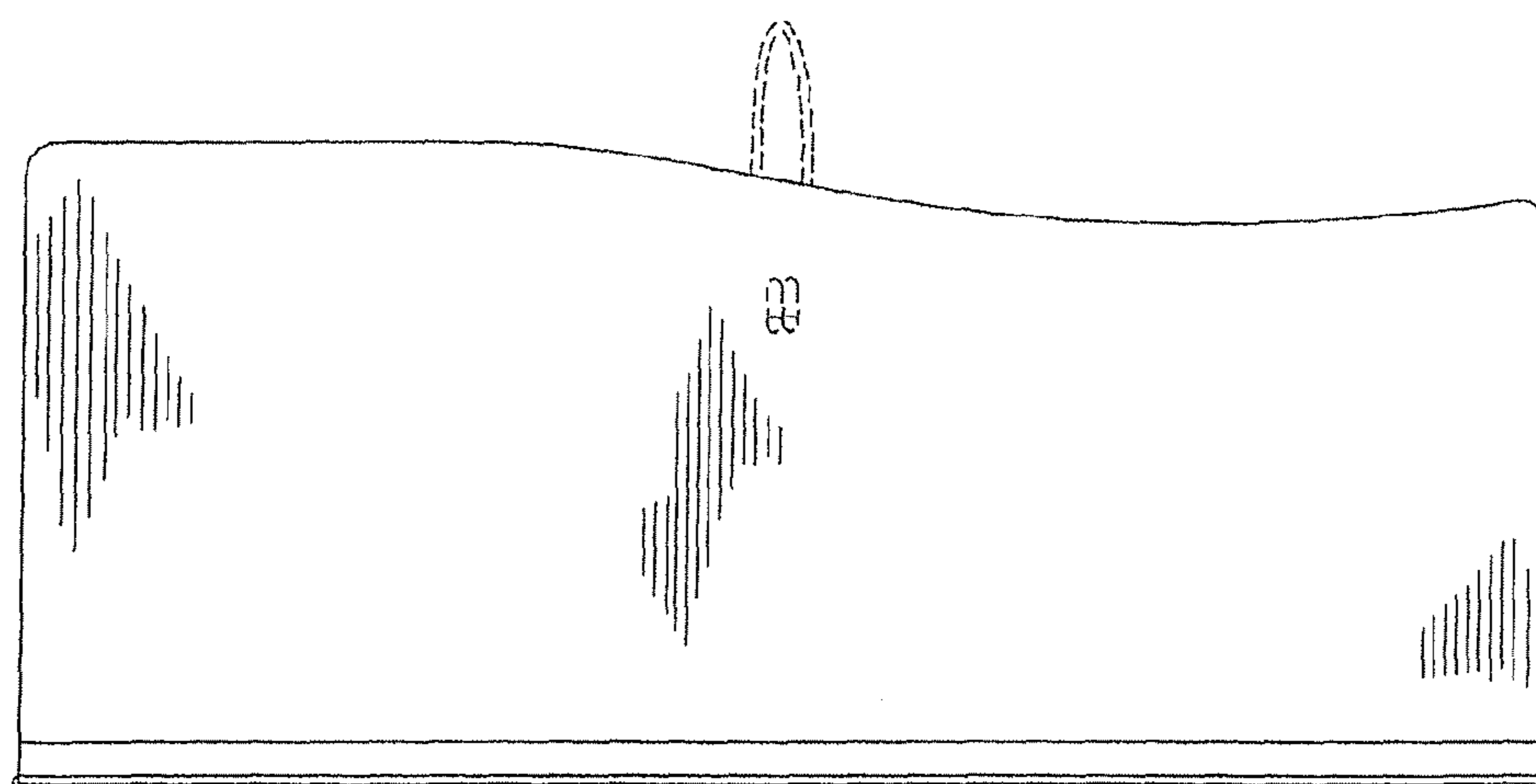
