DESCRIPTION

FIG. 1 is a perspective view of a design for a manicure set in accordance with a preferred embodiment of the present invention;

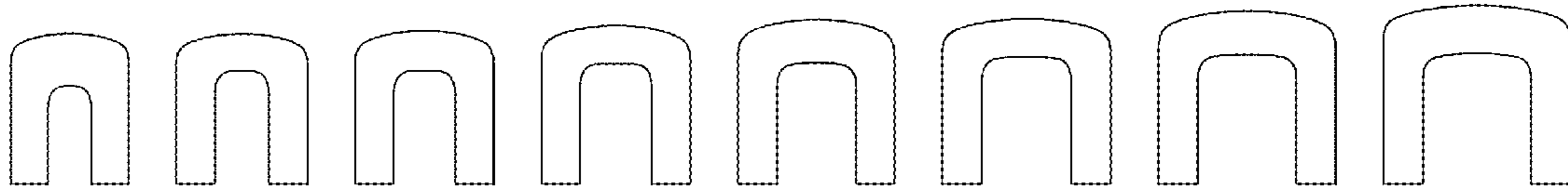
FIG. 2 is a front view of the design for a manicure set of FIG. 1, the rear view being a mirror image thereof;

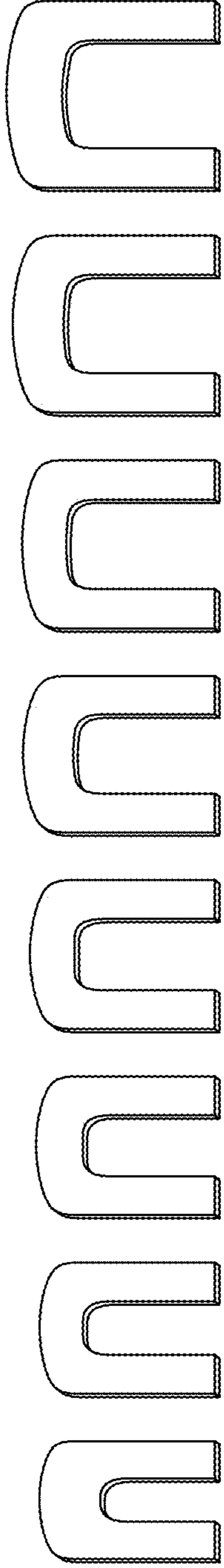

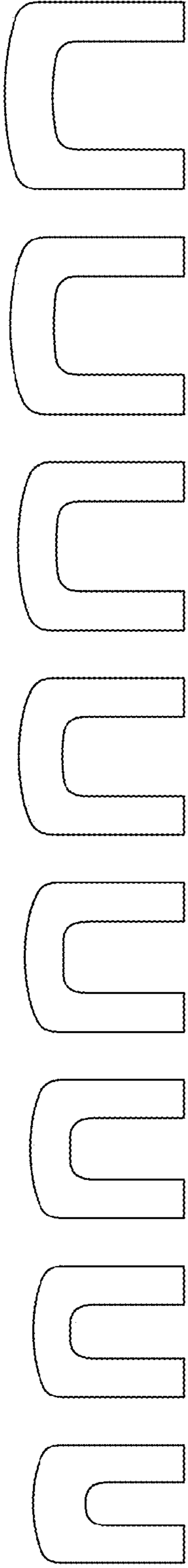
