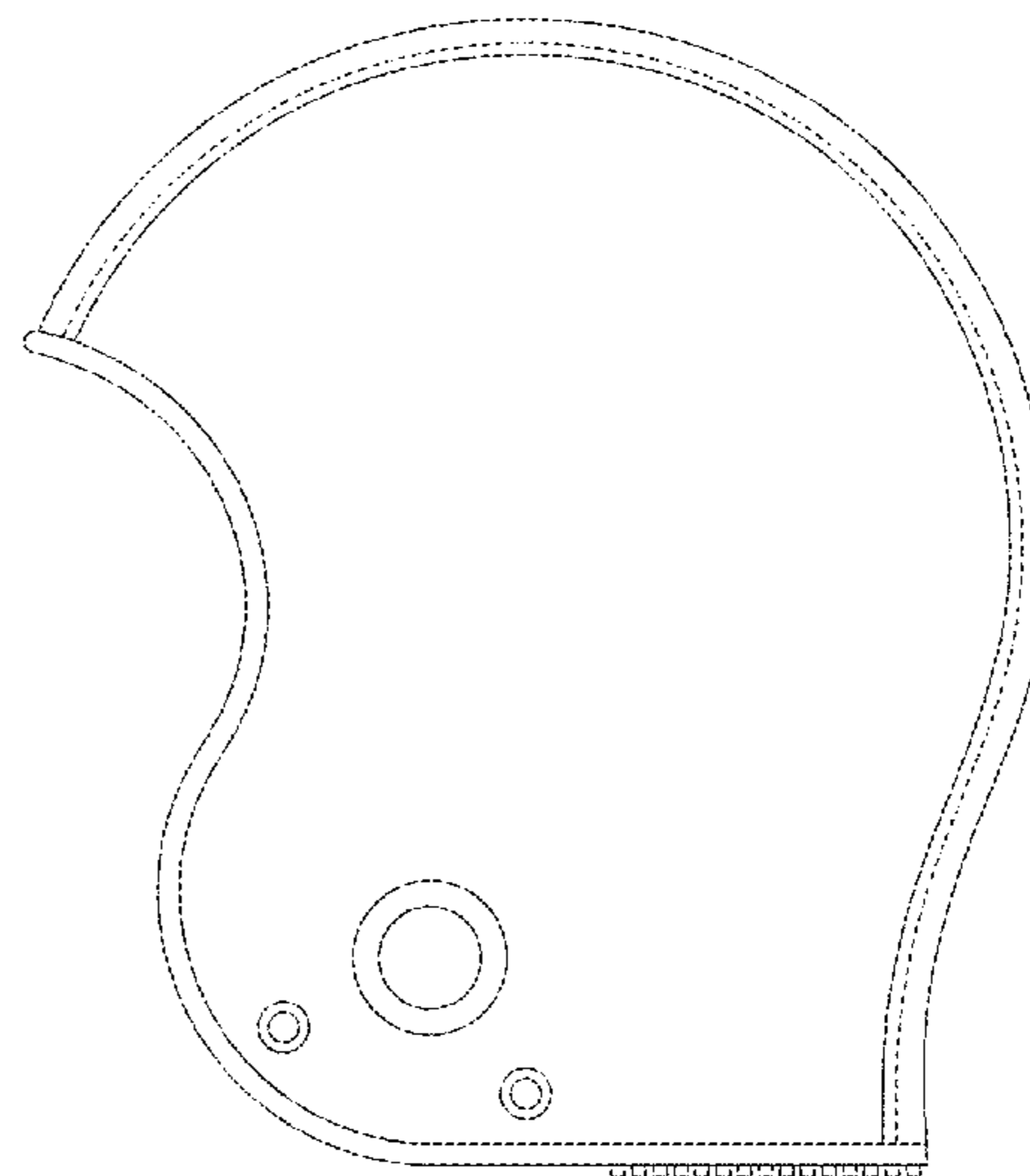
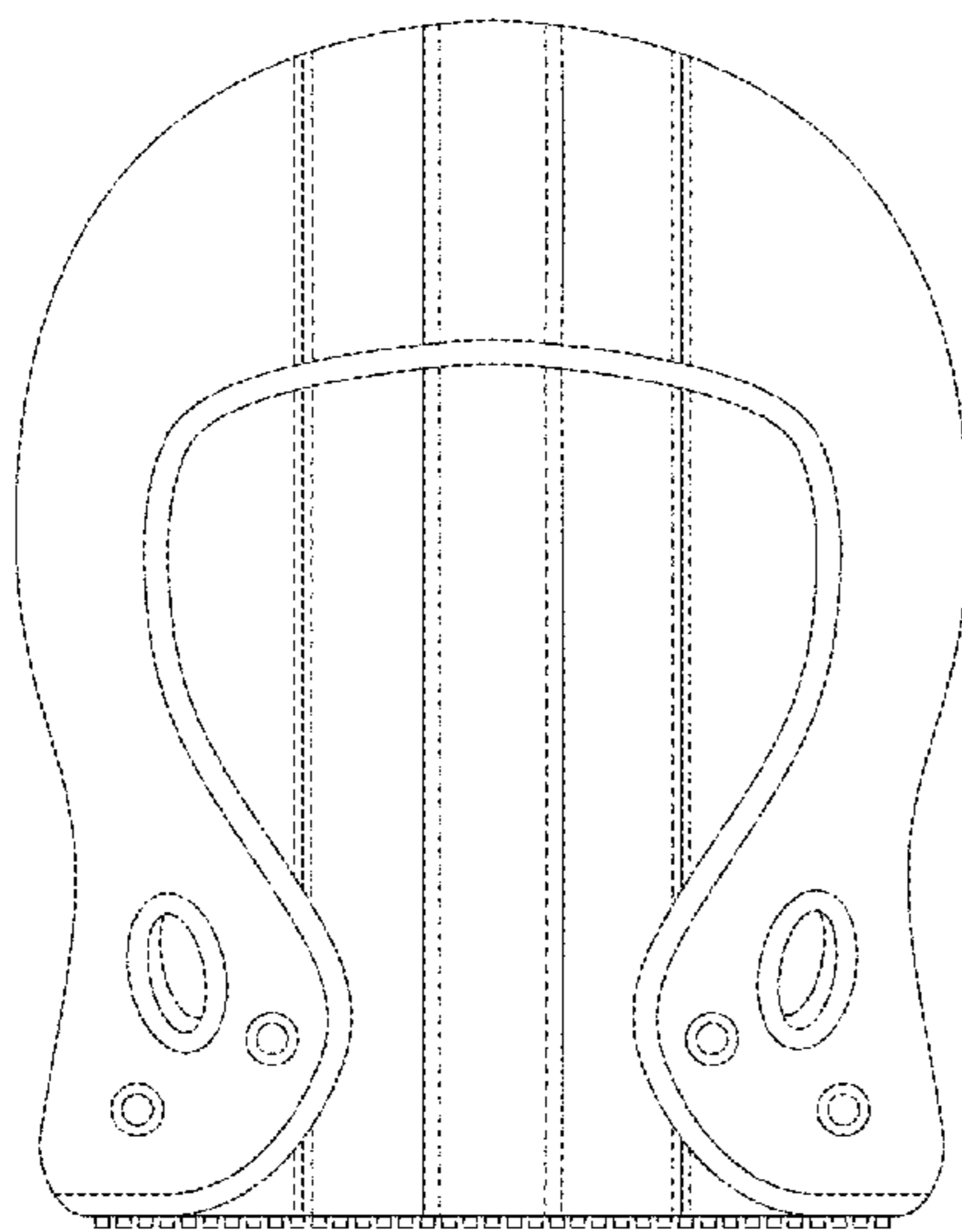
(57) **CLAIM**

The ornamental design for a helmet hoodie, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the helmet hoodie; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left side elevation view thereof; and, FIG. 4 is a right side elevation view thereof. The broken lines represent stitching, which is part of the claimed design.

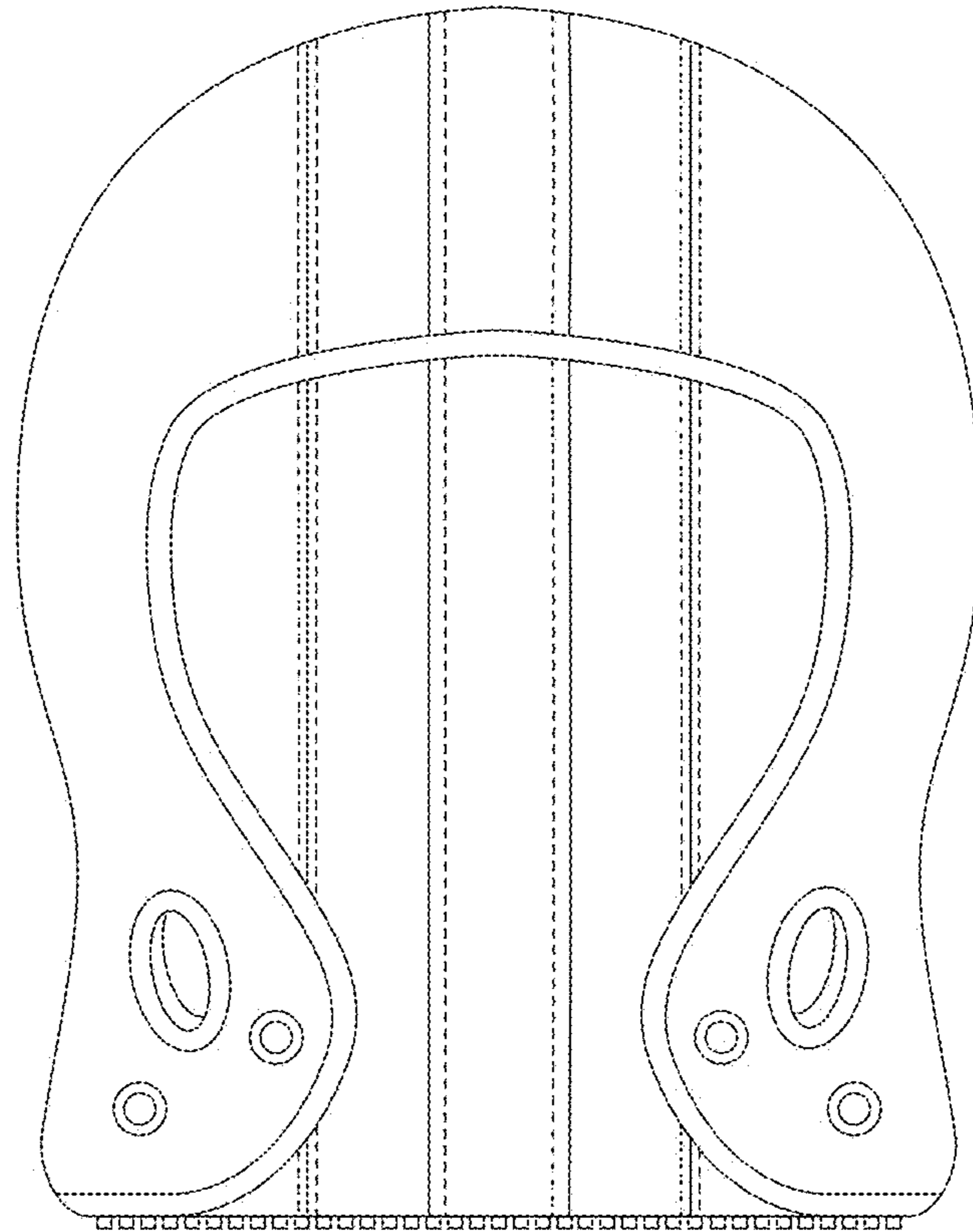

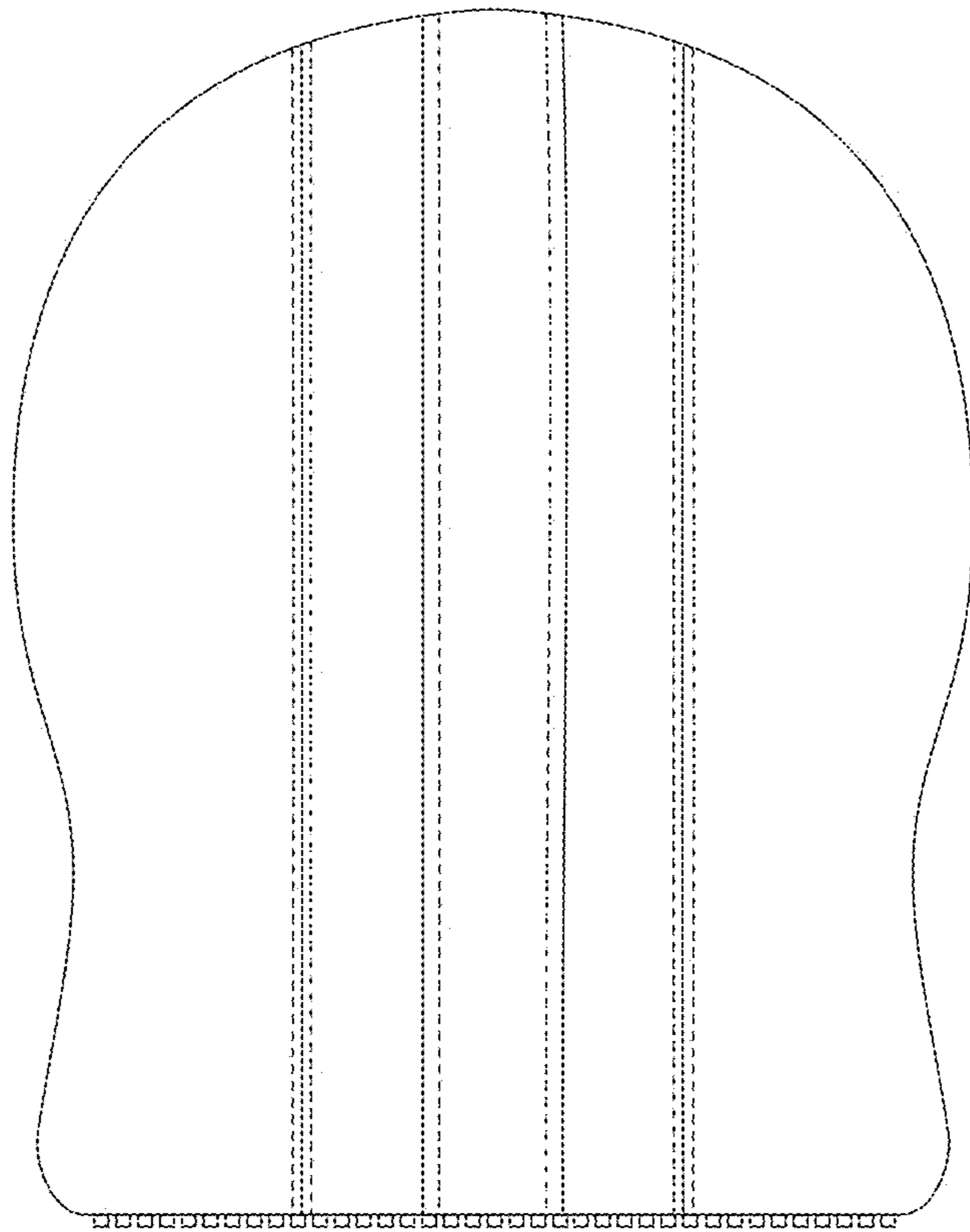

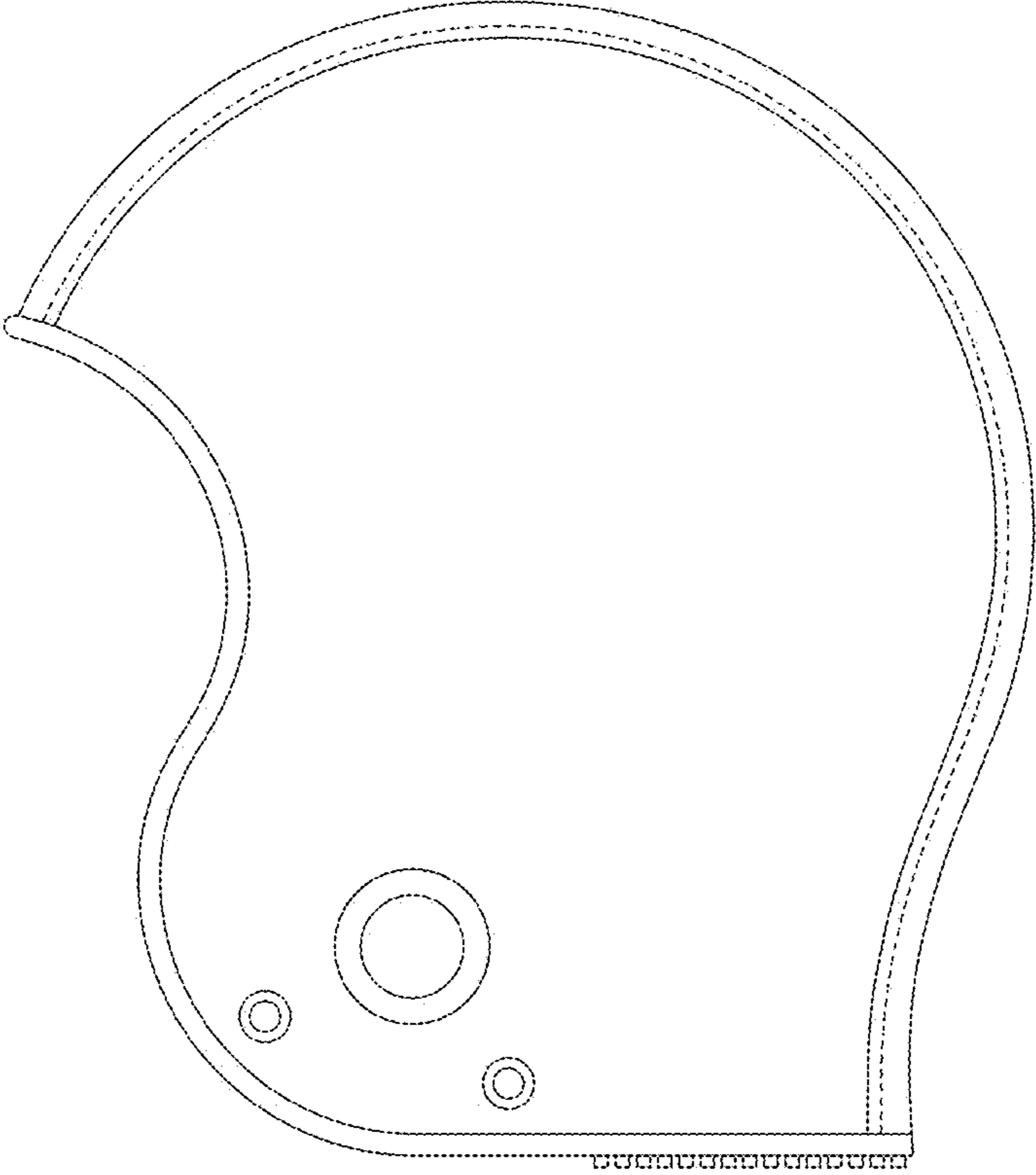

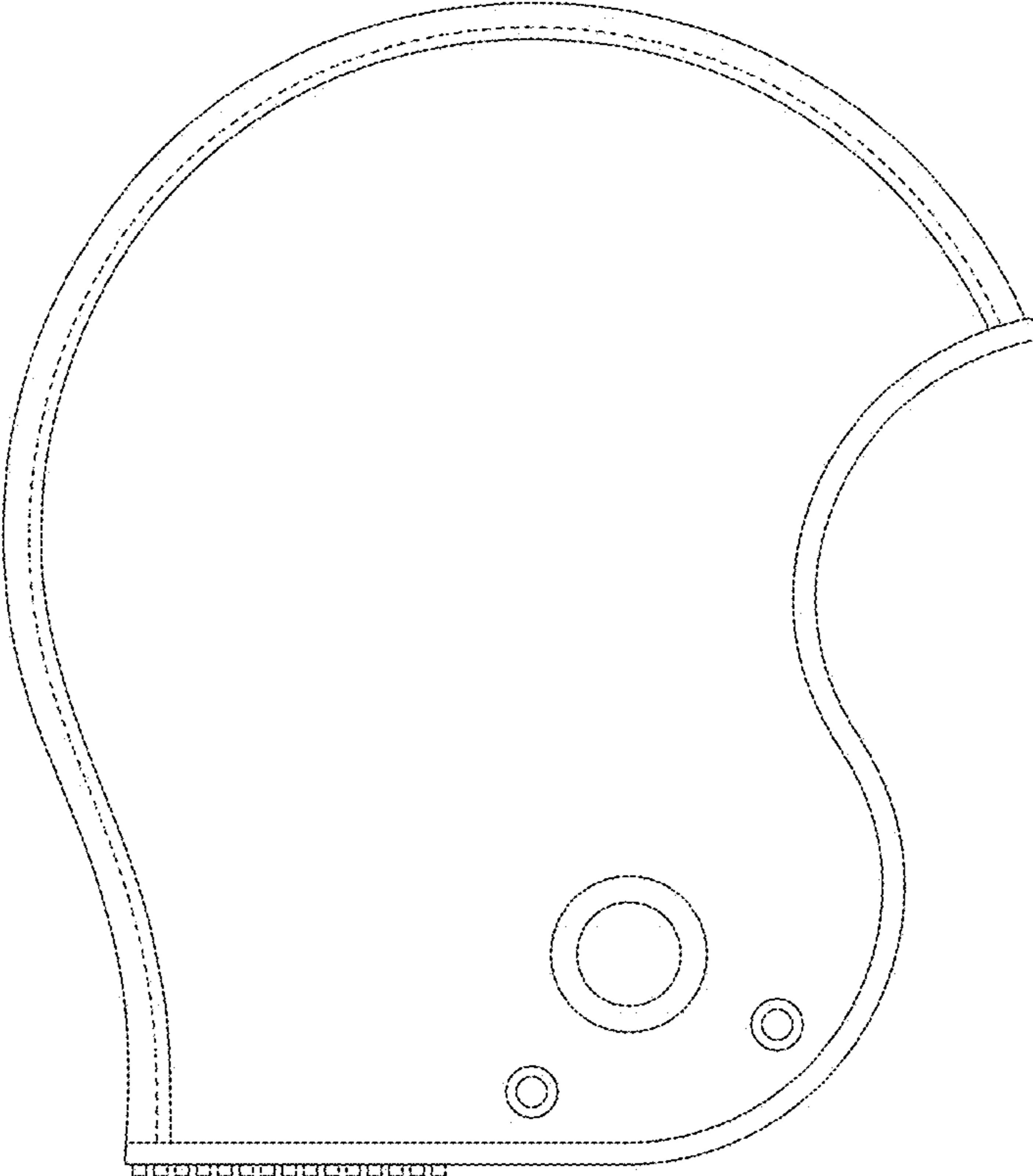
