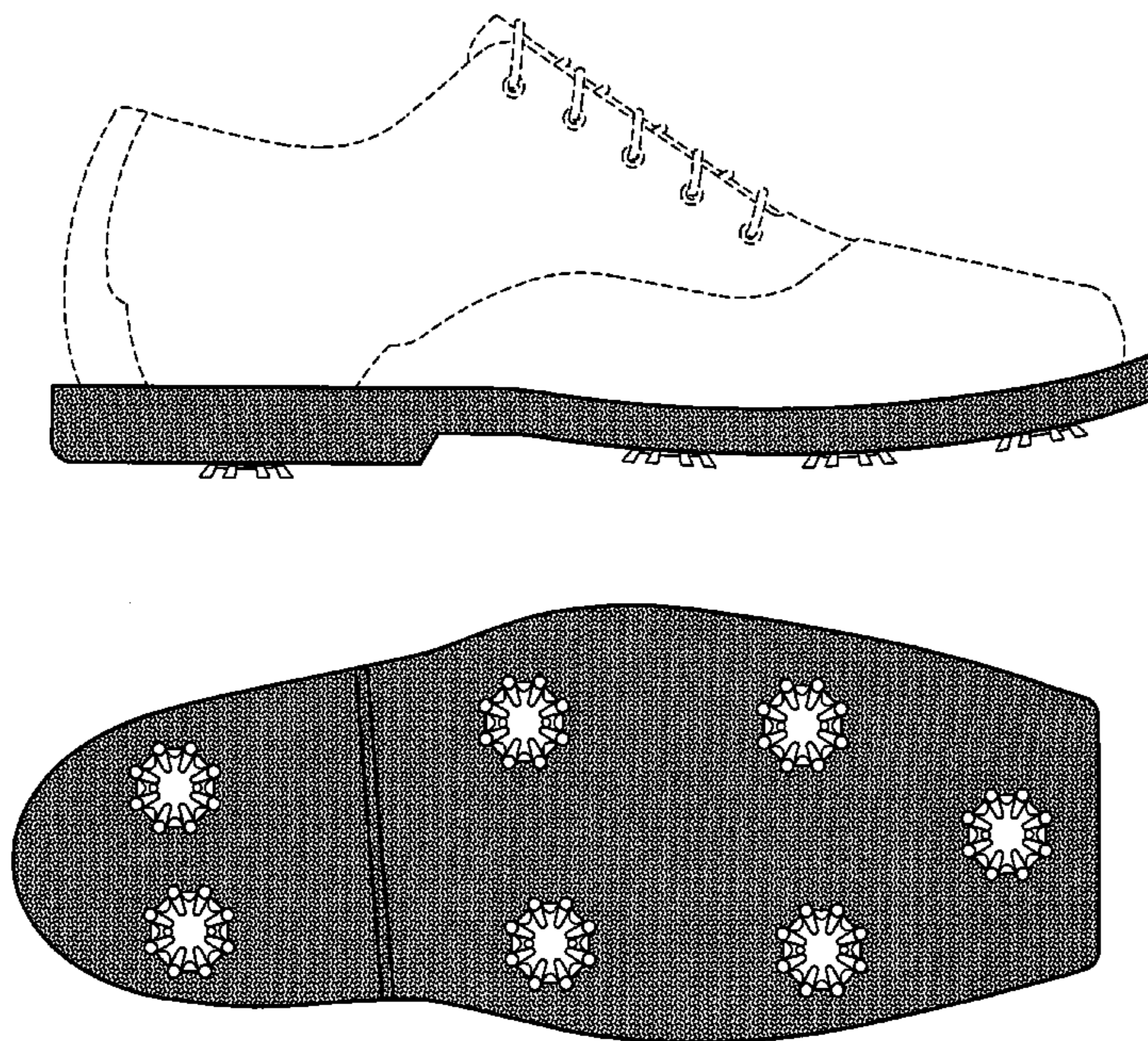

DESCRIPTION

FIG. 1 is a three-quarter front view of the shoe sole of the present invention;
FIG. 2 is a side view of the shoe sole of FIG. 1;
FIG. 3 is a top view of the shoe sole of FIG. 1;
FIG. 4 is a bottom view of the shoe sole of FIG. 1;
FIG. 5 is a front view of the shoe sole of FIG. 1; and,
FIG. 6 is a rear view of the shoe sole of FIG. 1.
The broken lines immediately adjacent the shoe sole represent unclaimed boundaries of this design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

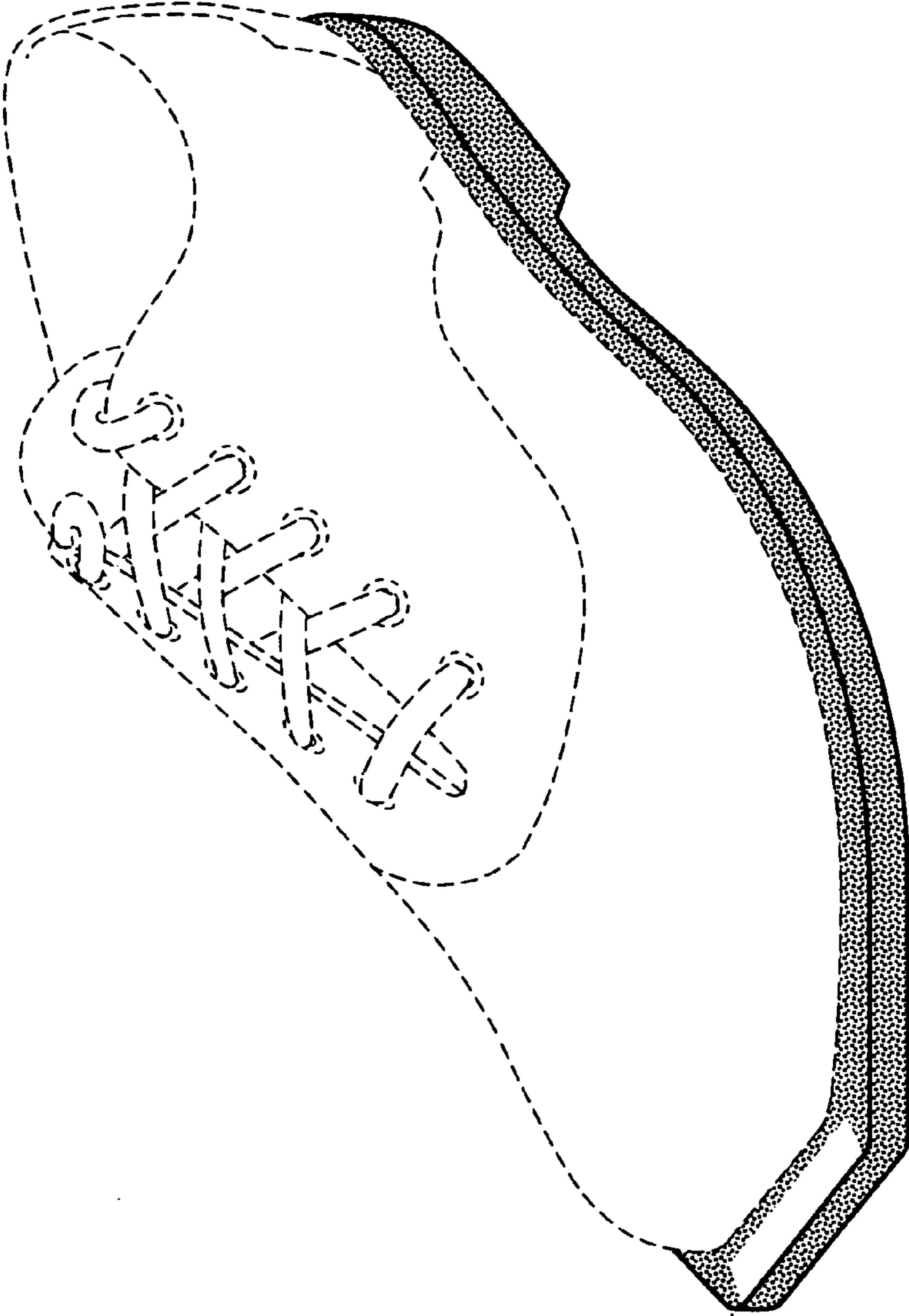

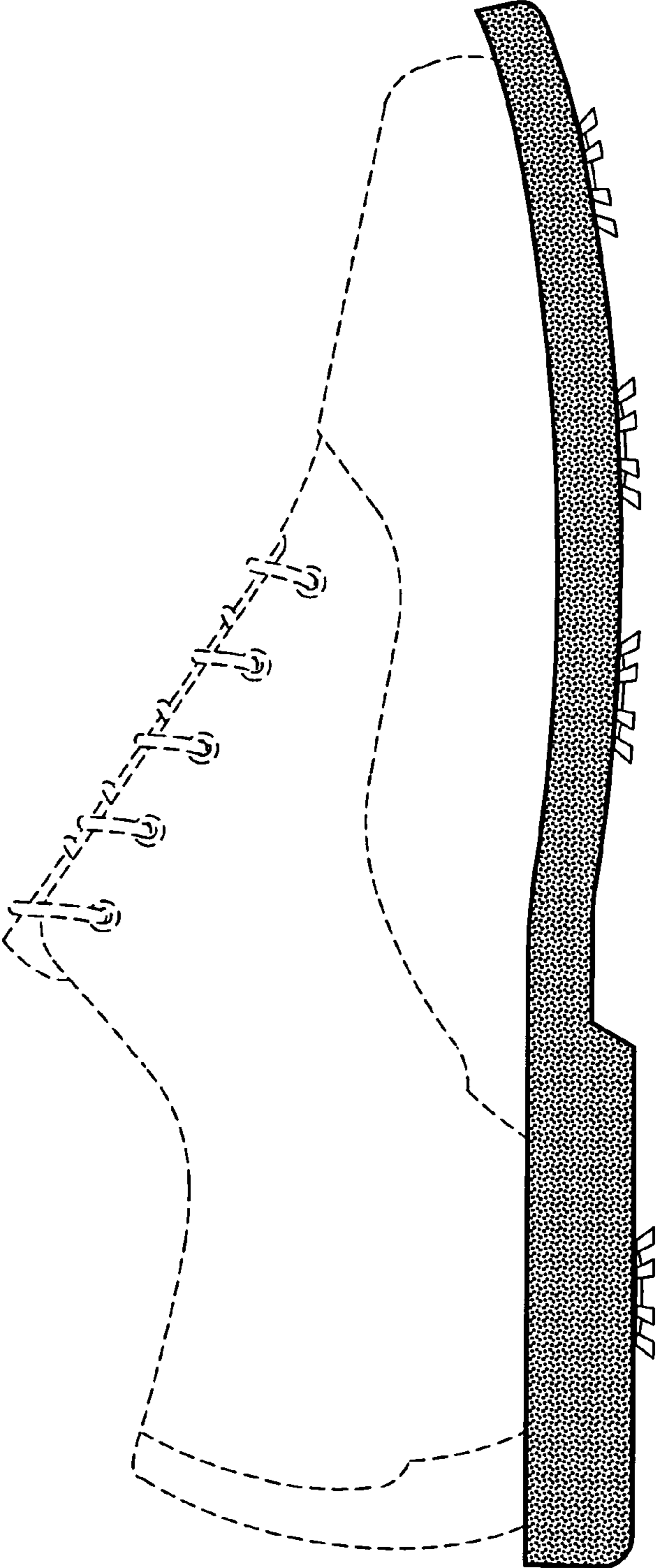

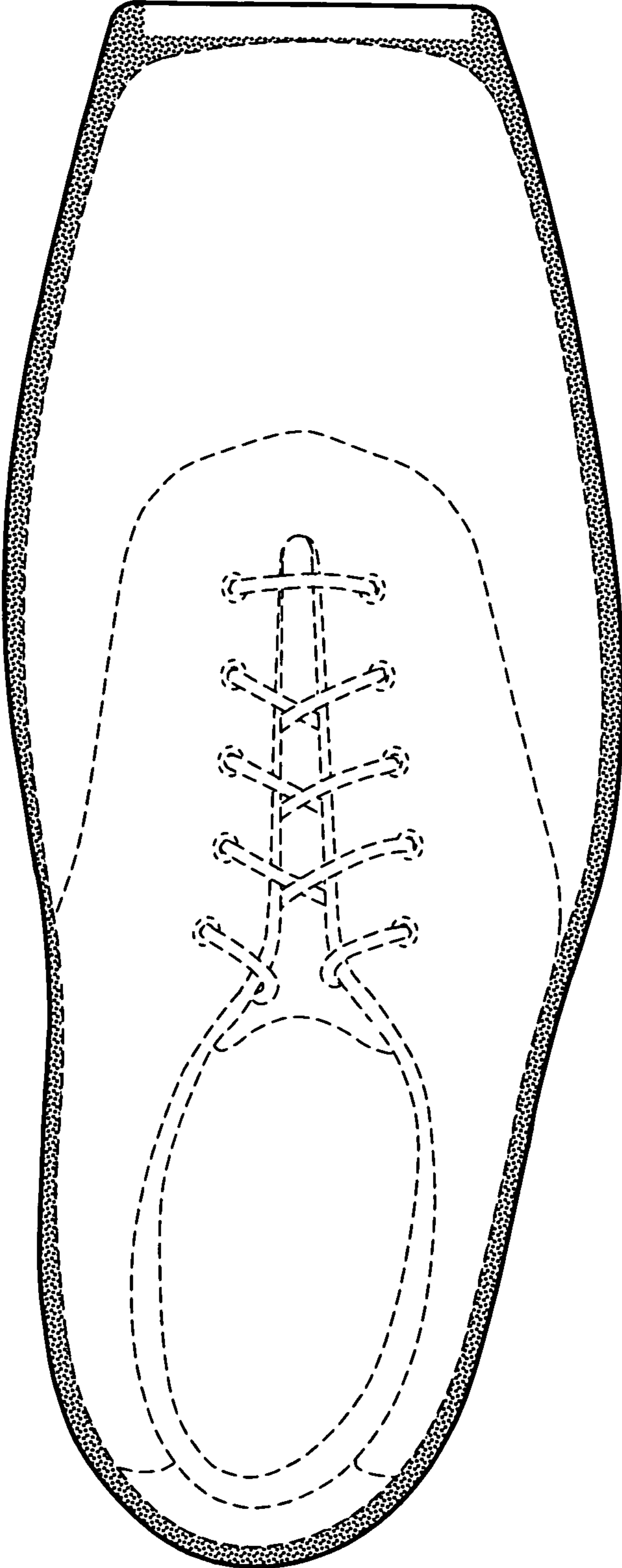

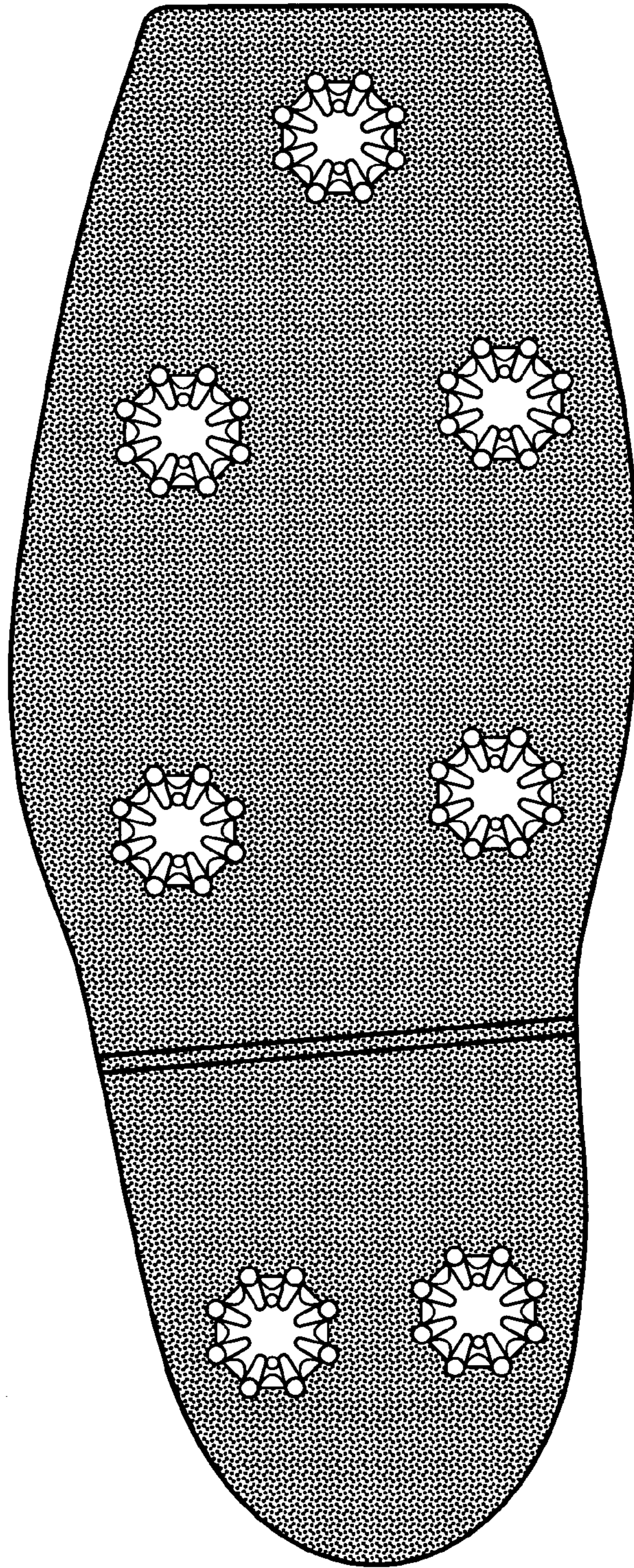

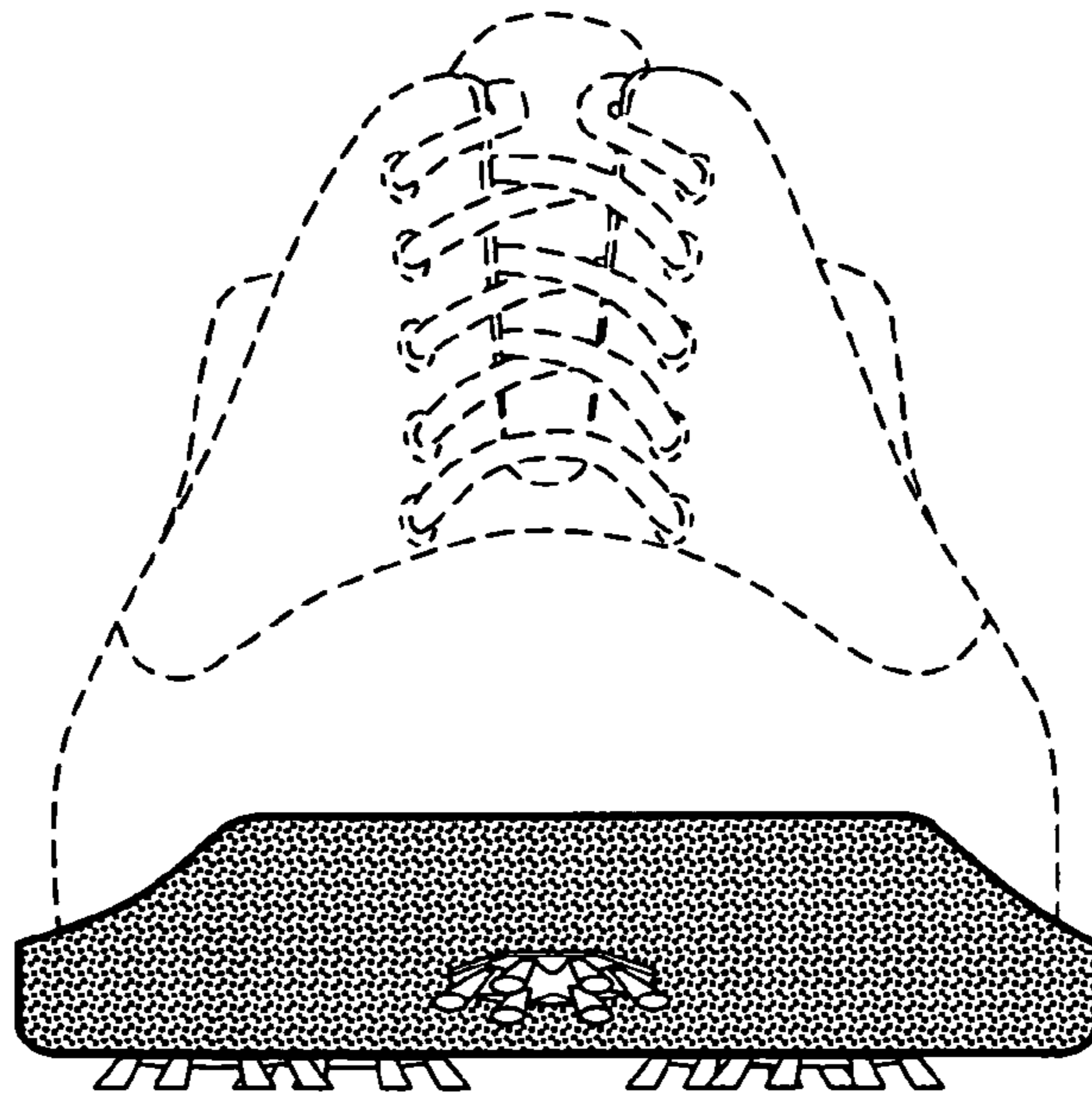

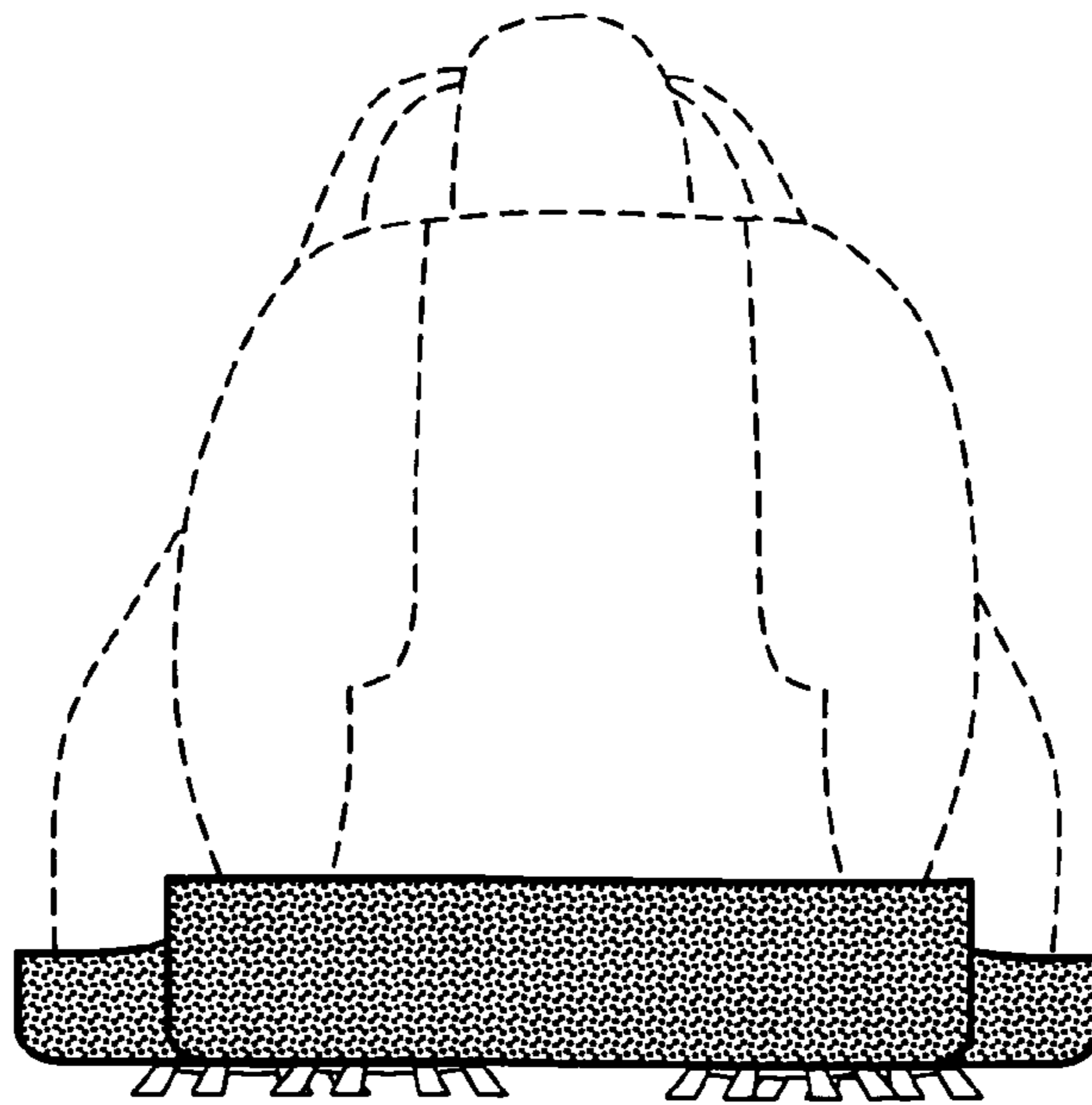
