DESCRIPTION

FIG. 8 is a left side elevation view thereof;

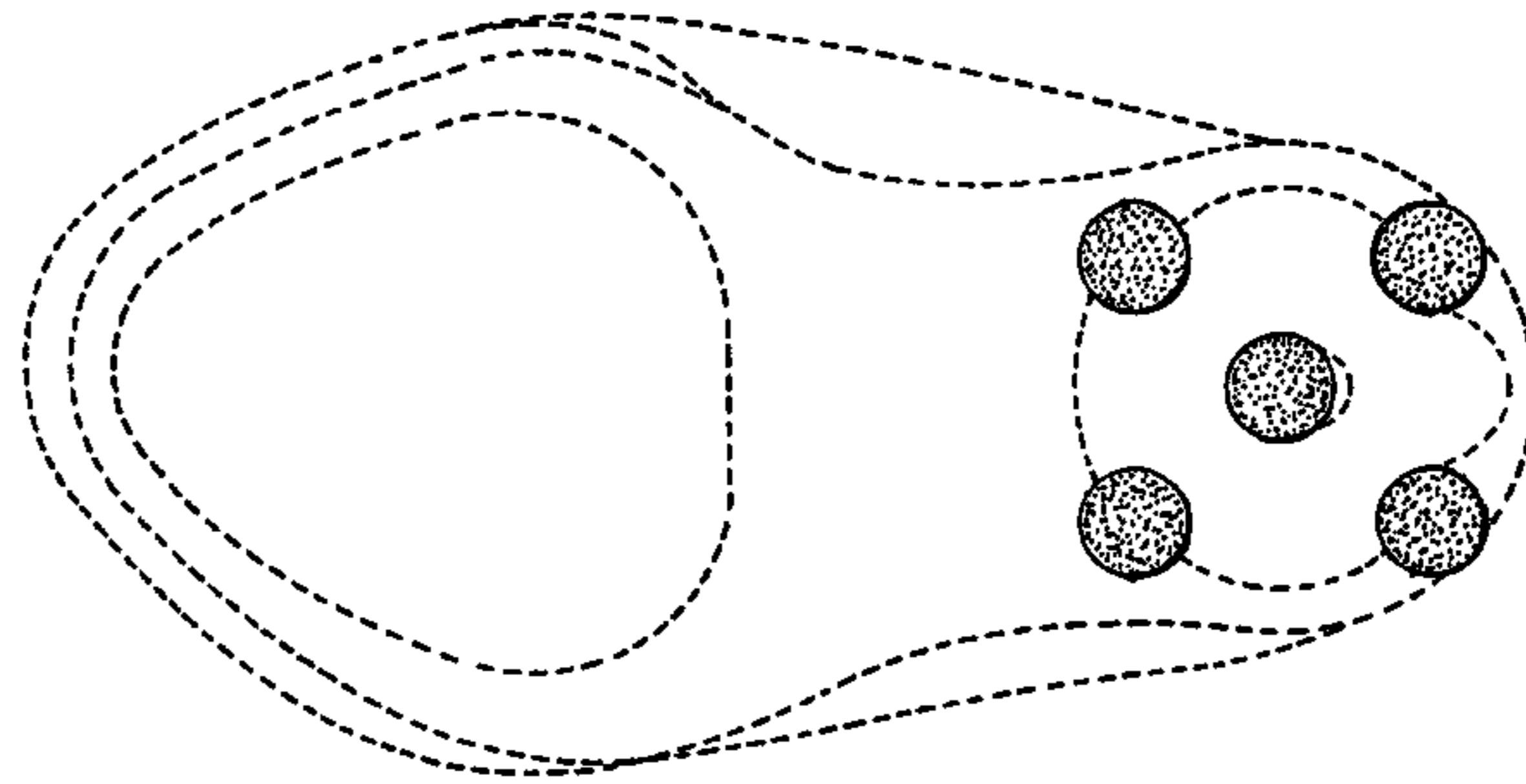
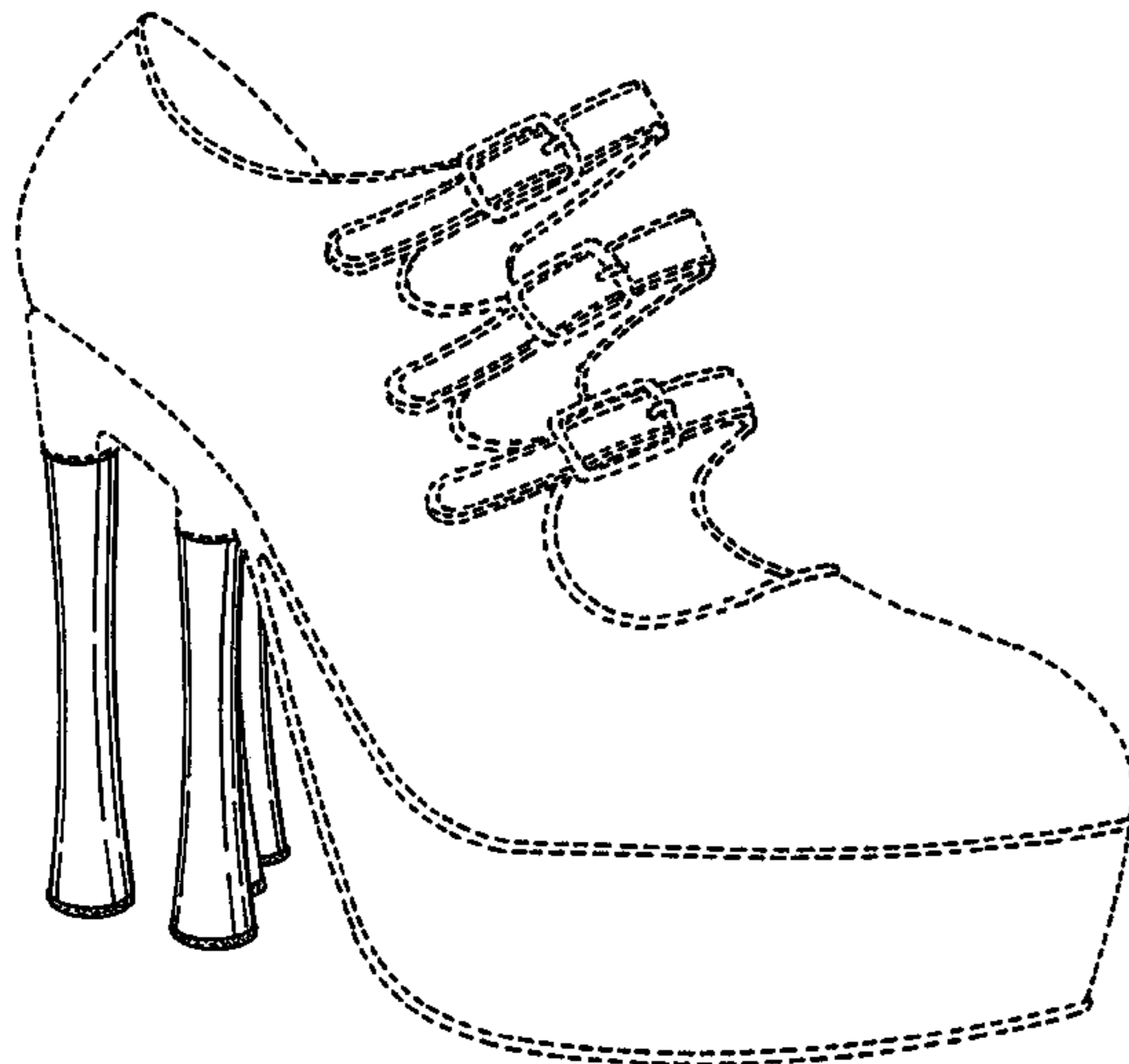
FIG. 9 is a rear view thereof; and,

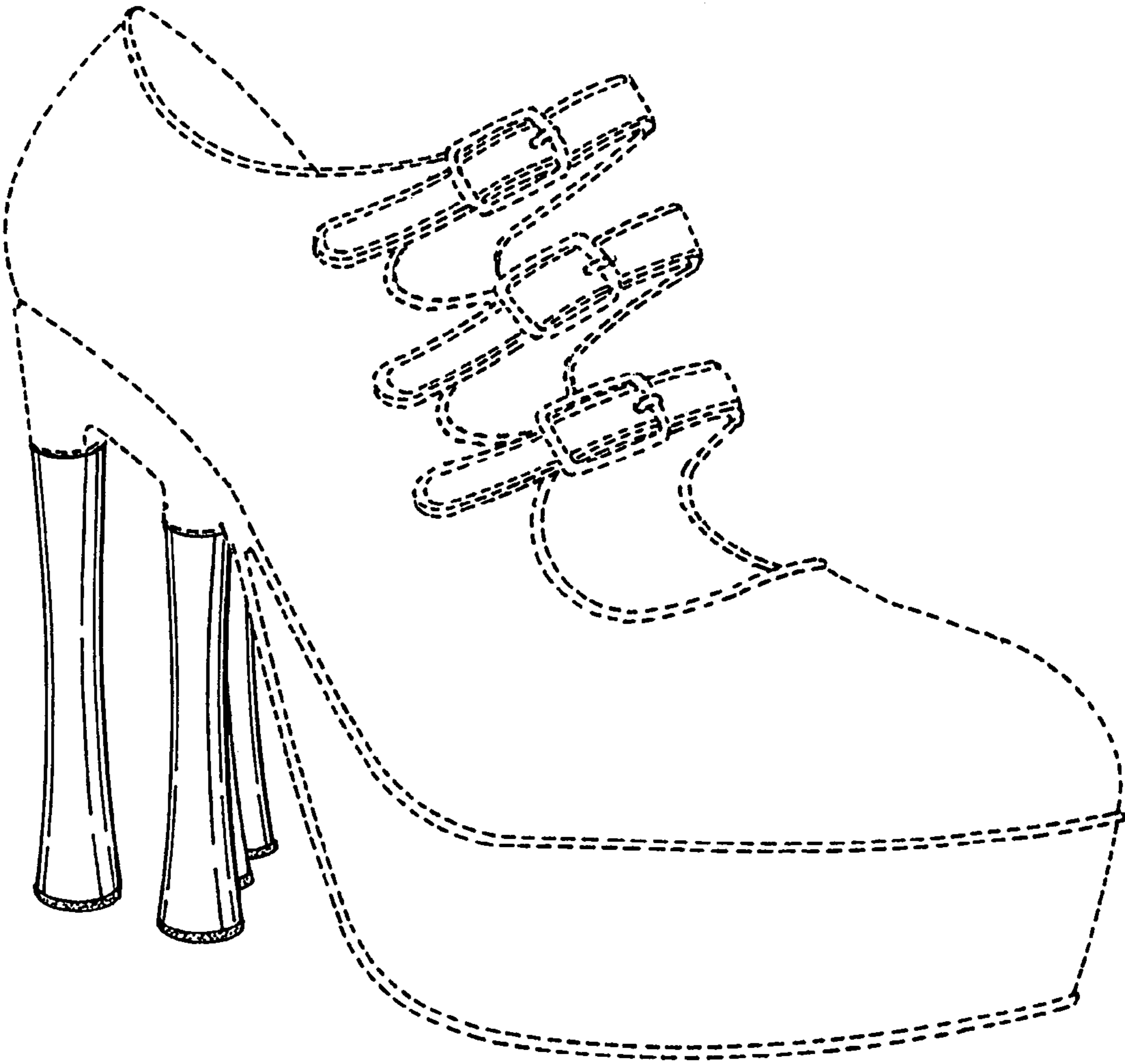

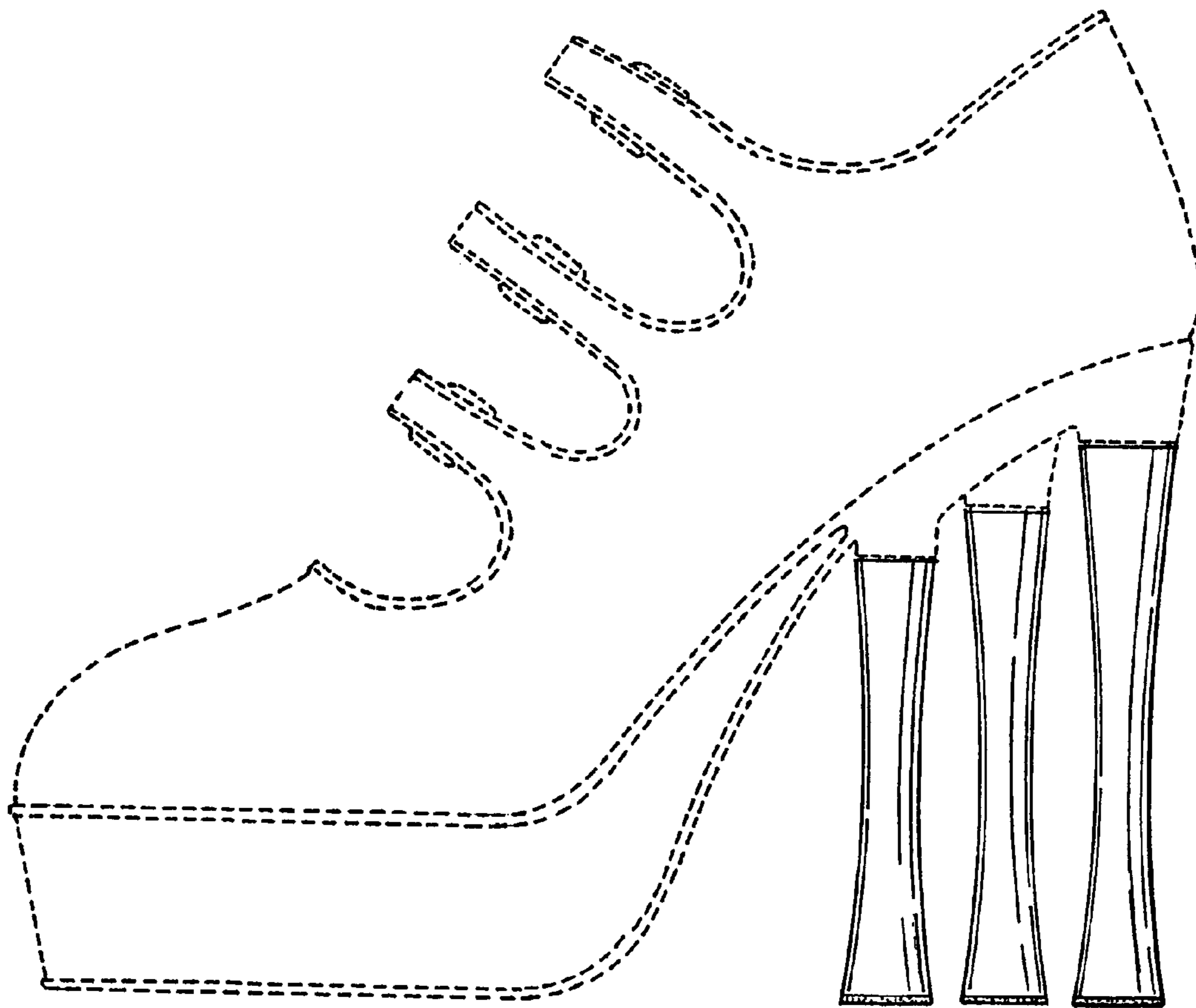

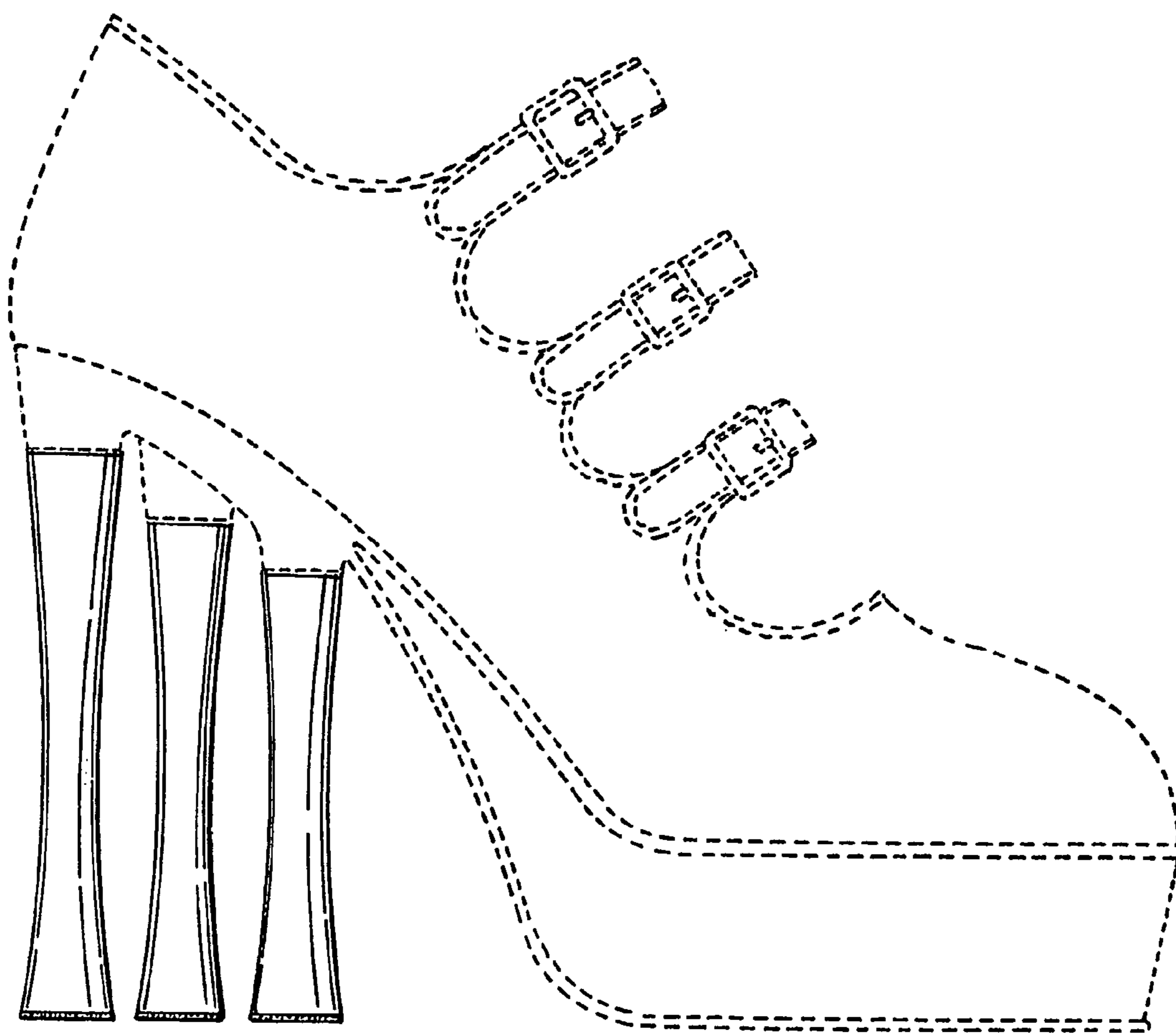

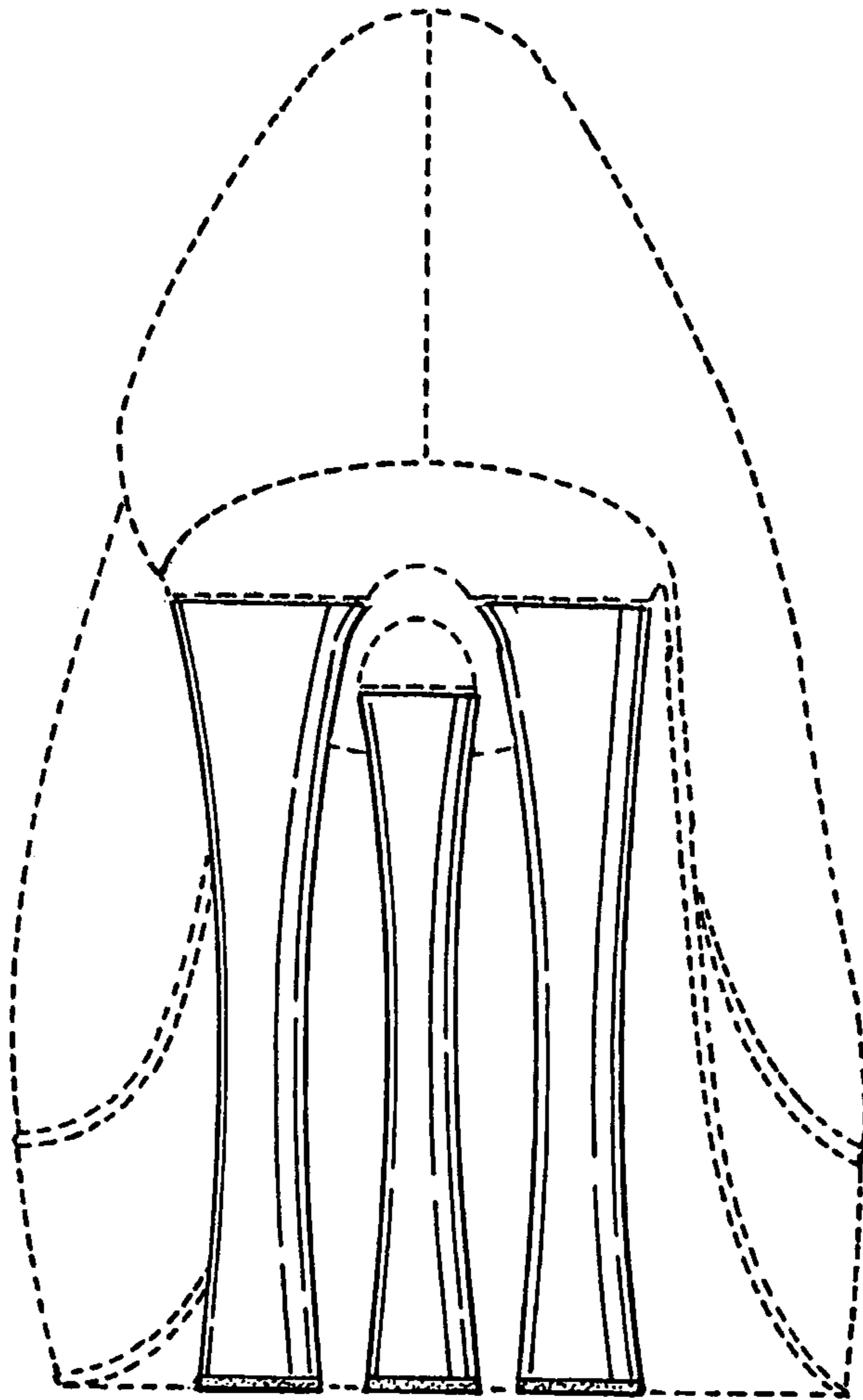

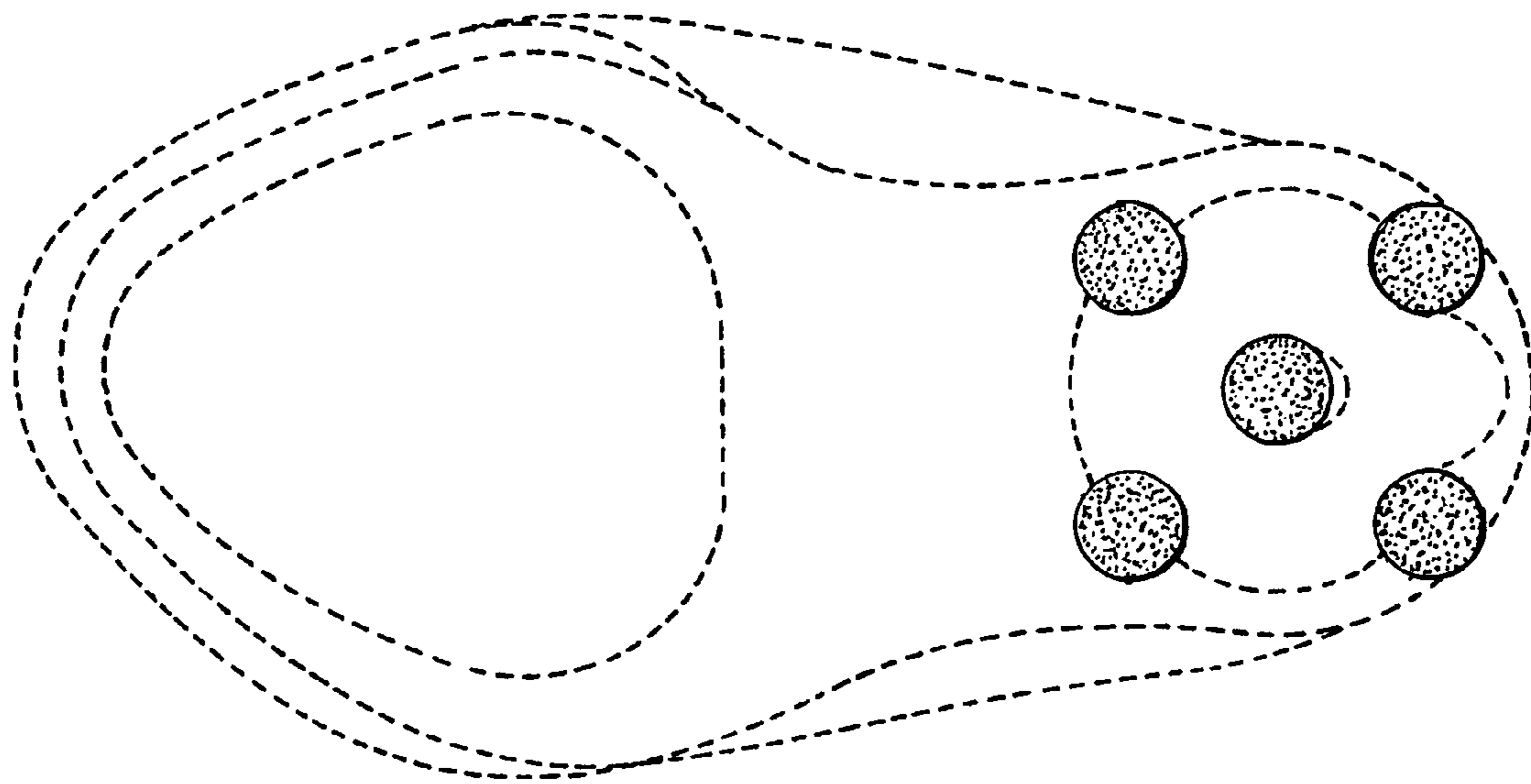

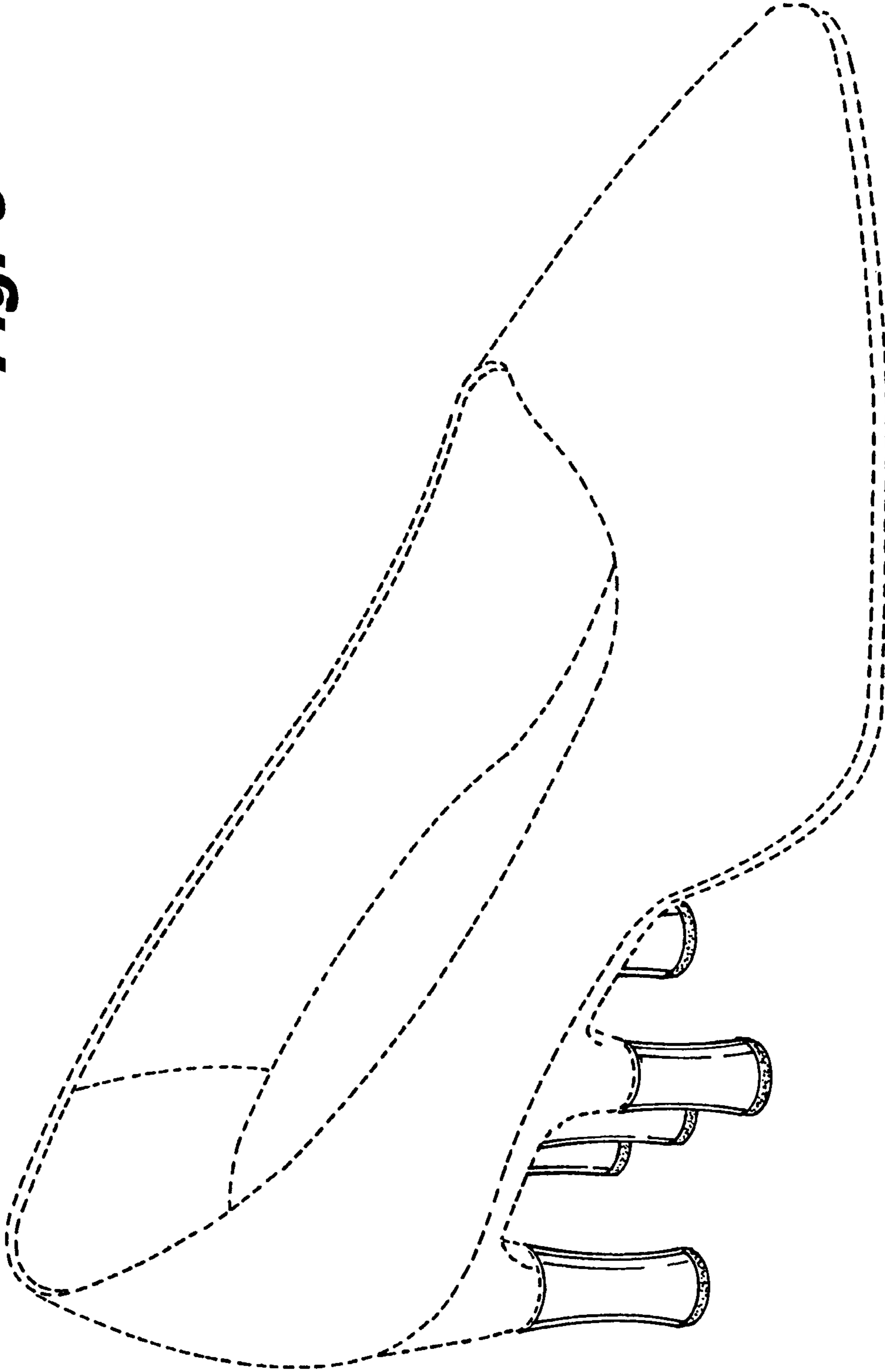

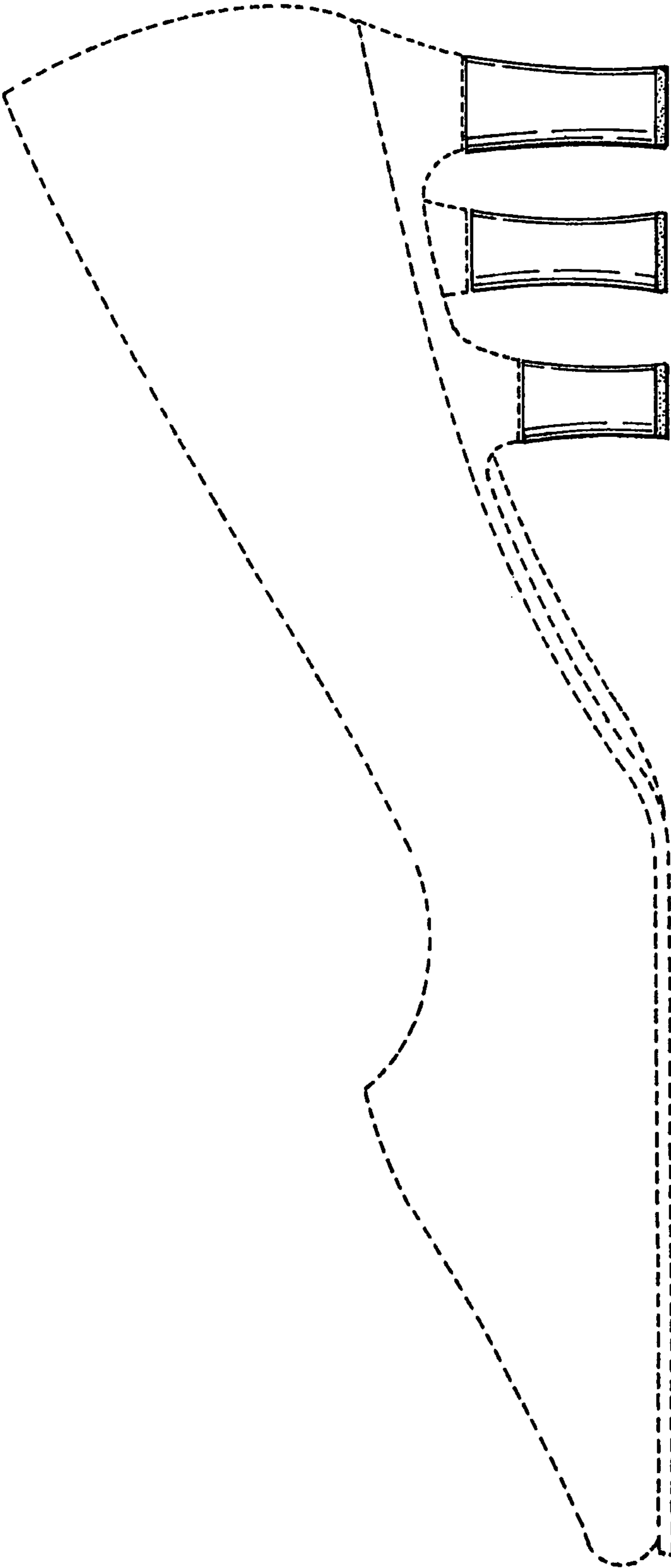
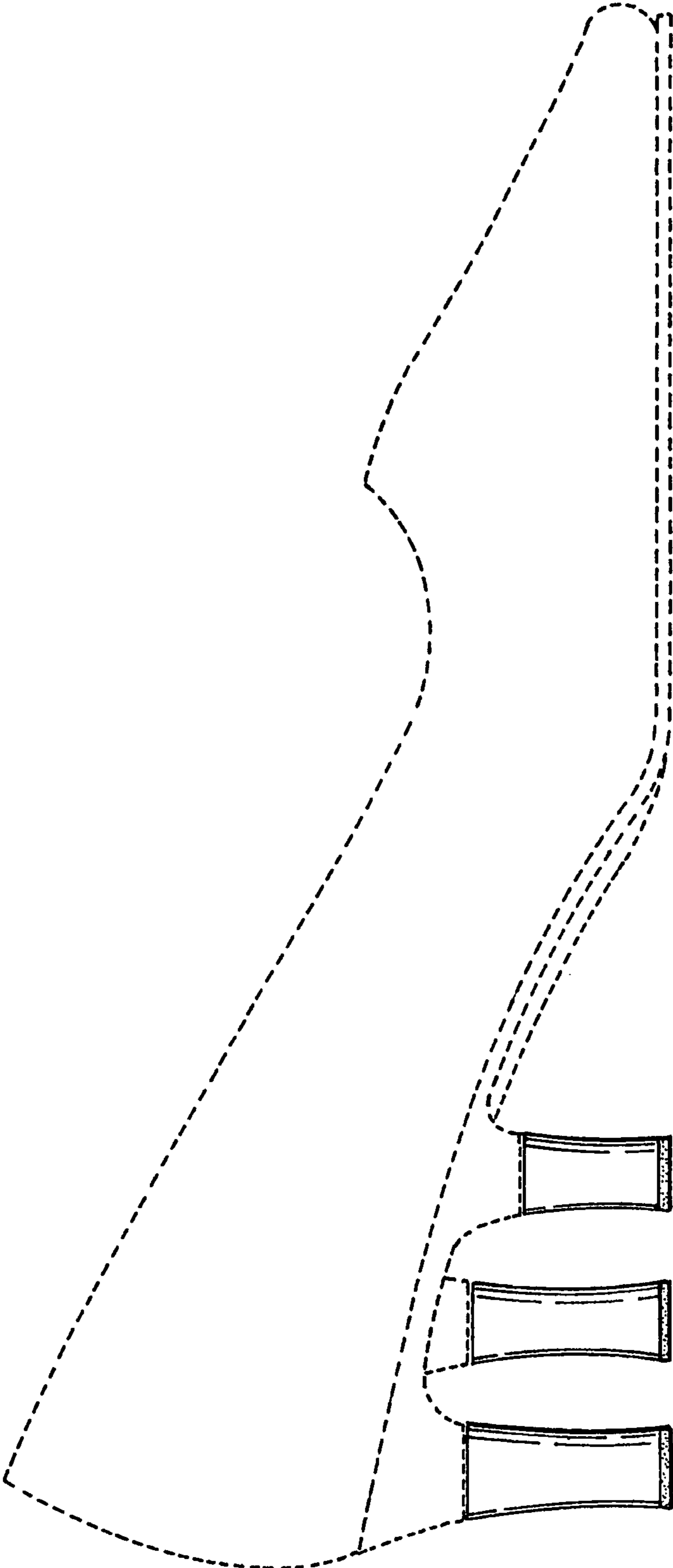

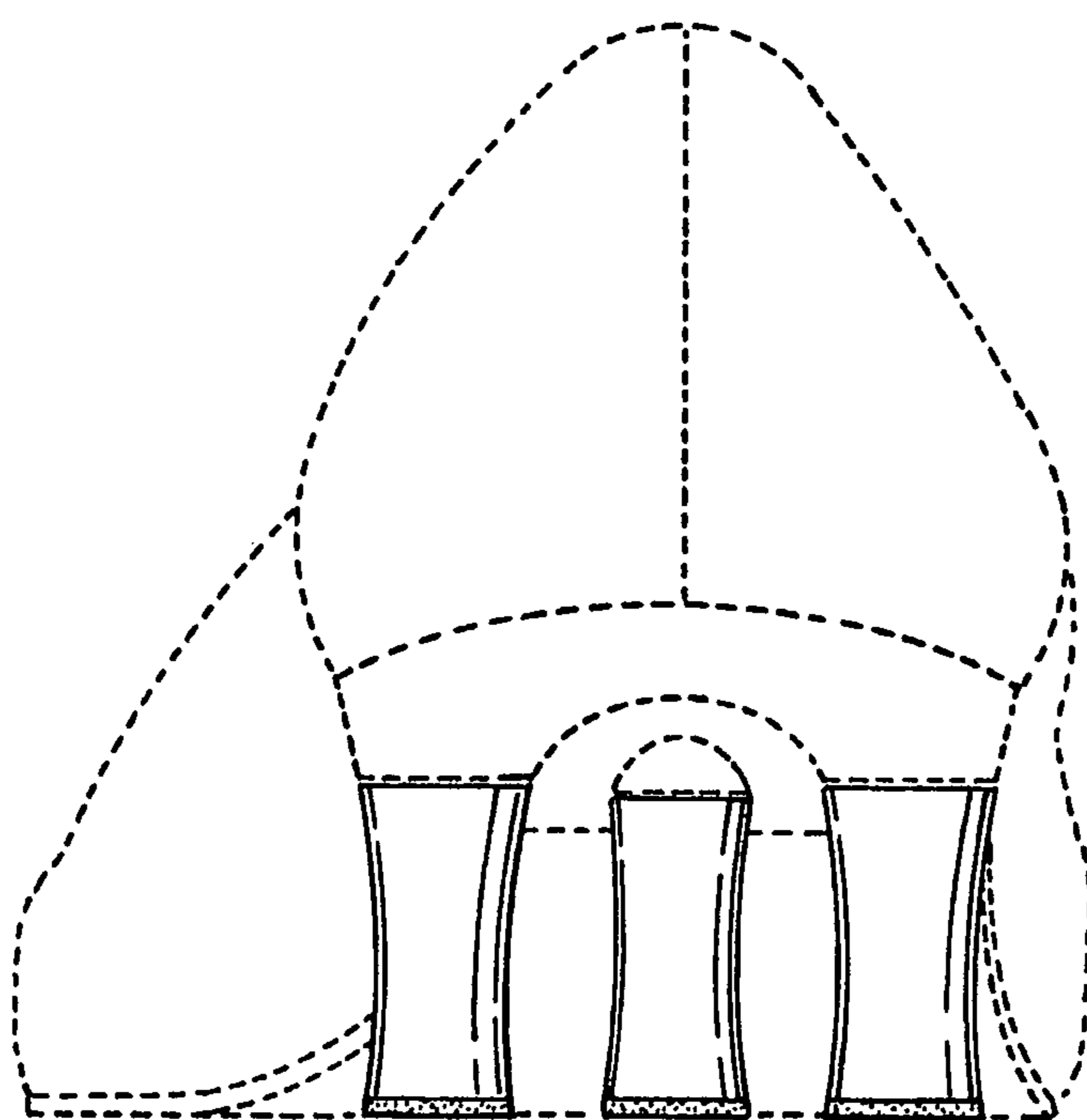

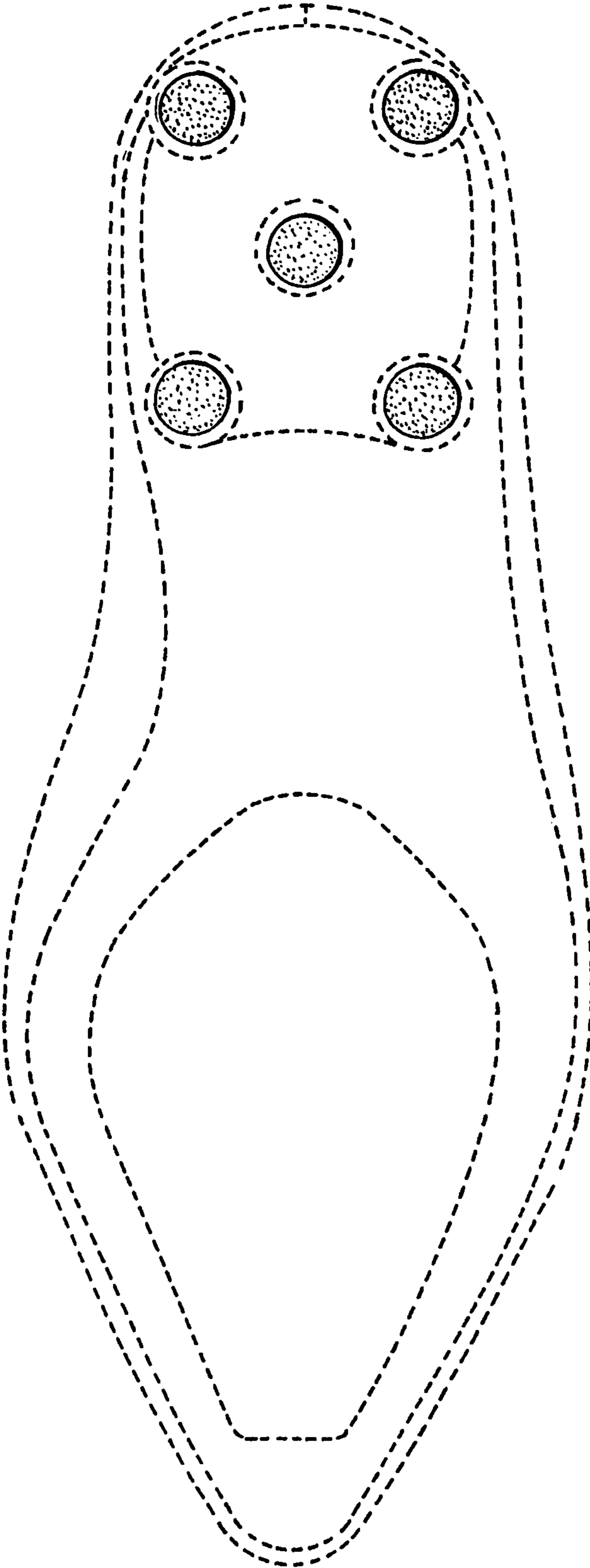
