The ornamental design for portable hanging pouch, as shown and described.

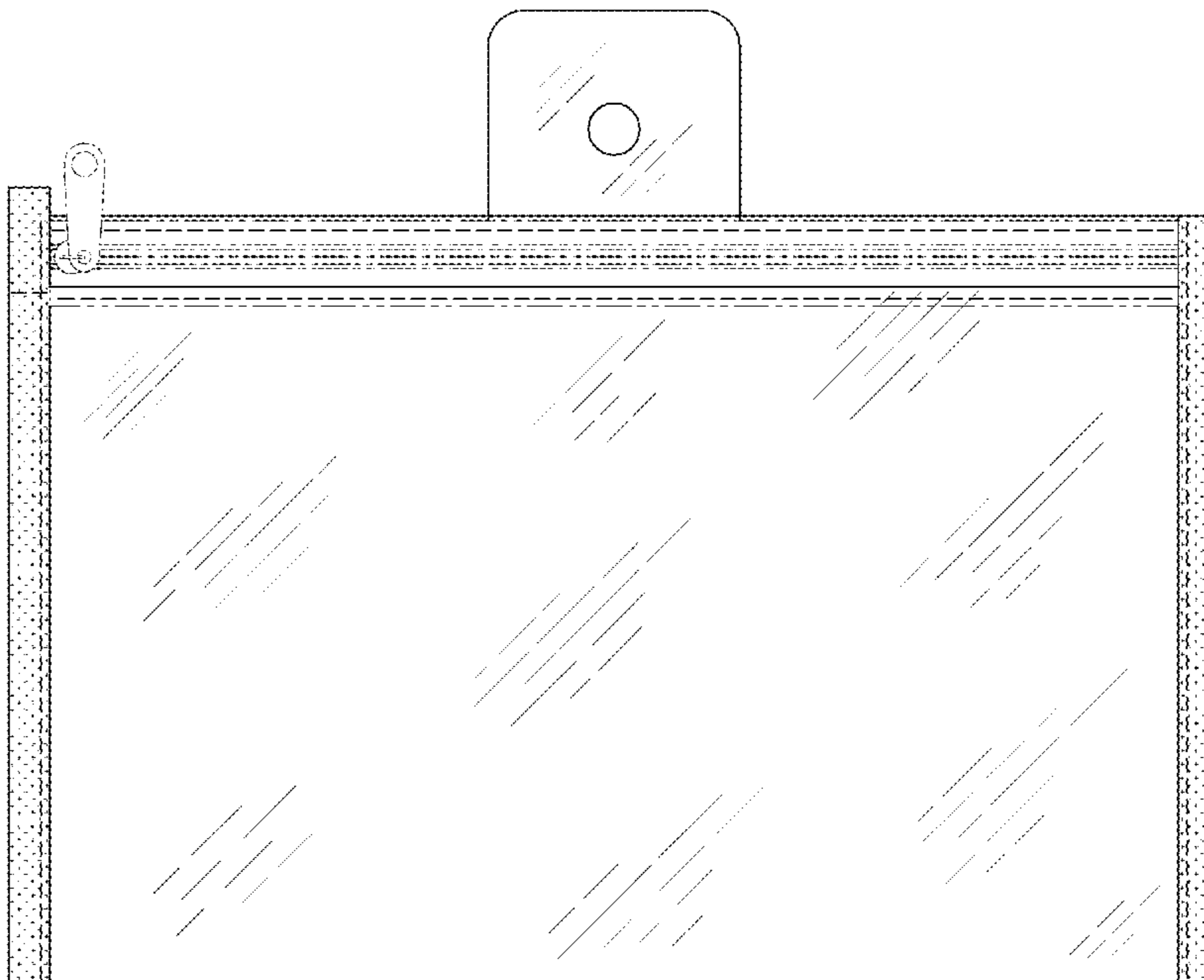
**DESCRIPTION**

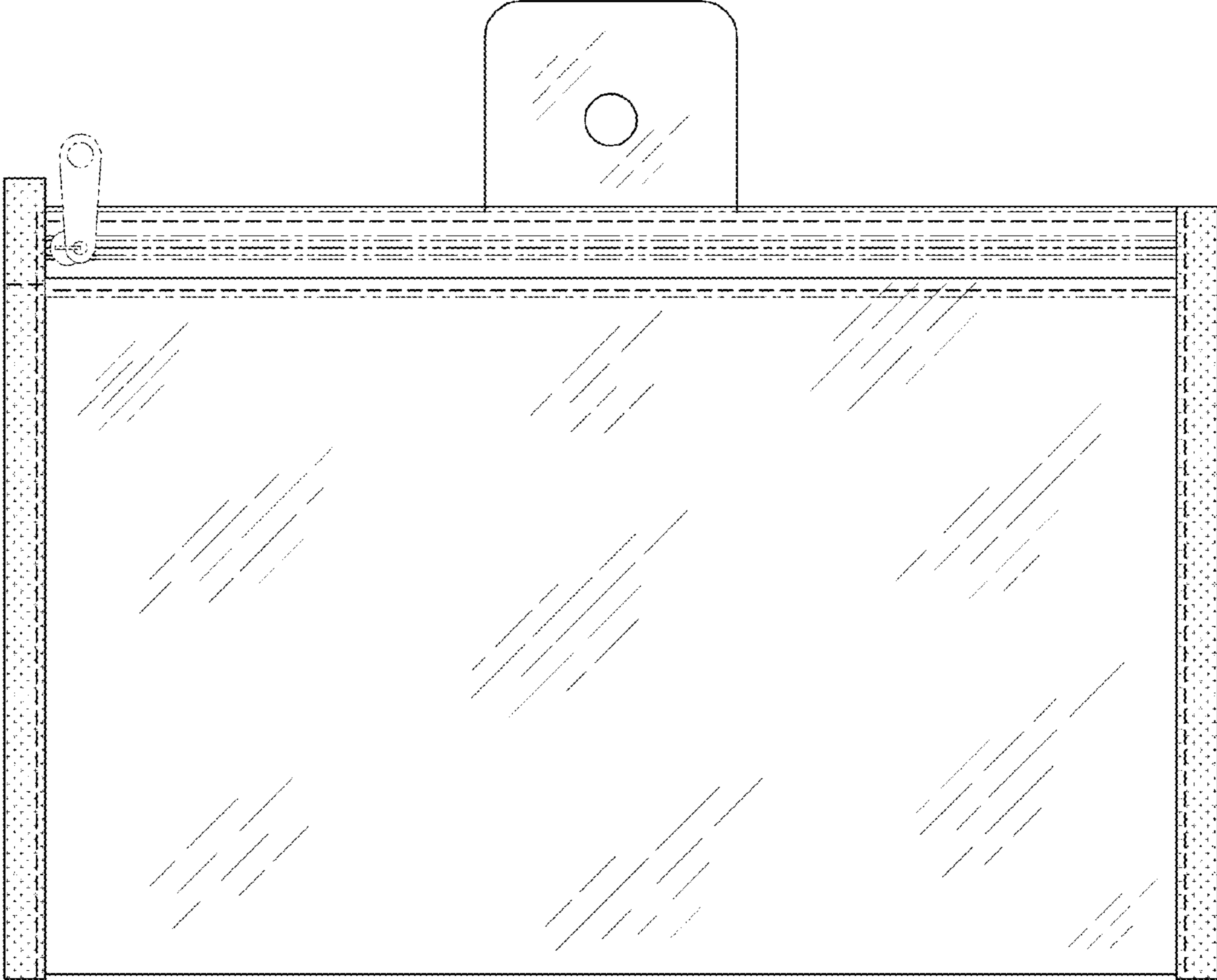

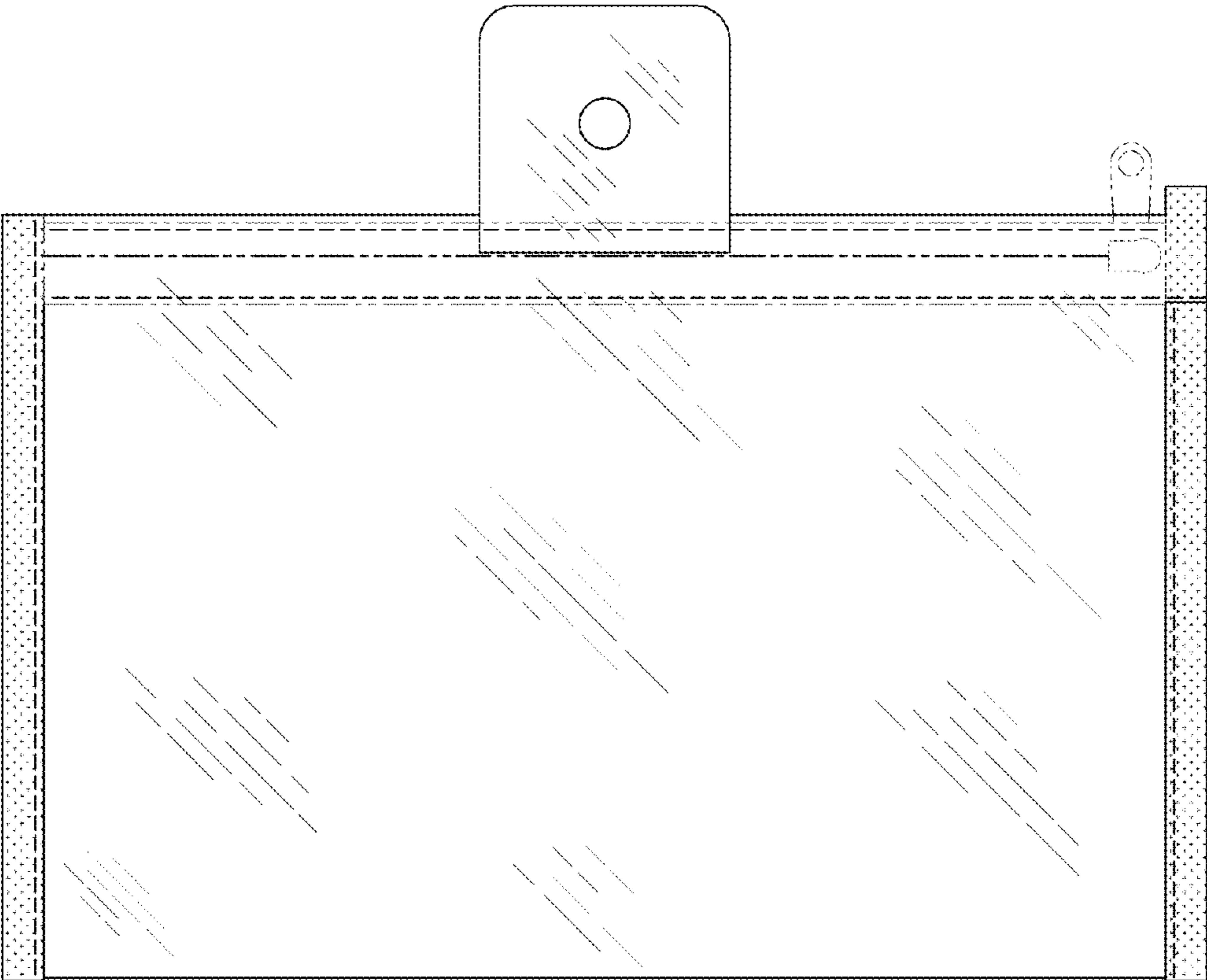

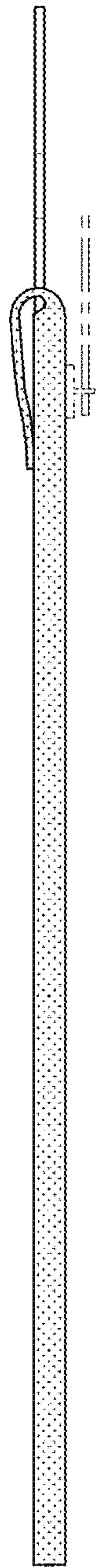

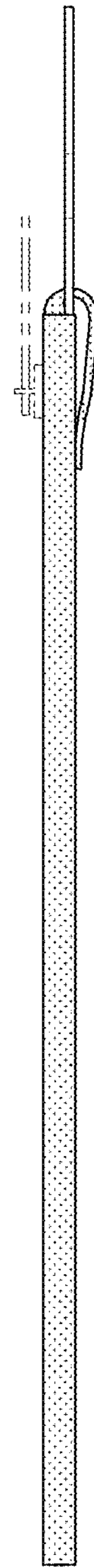

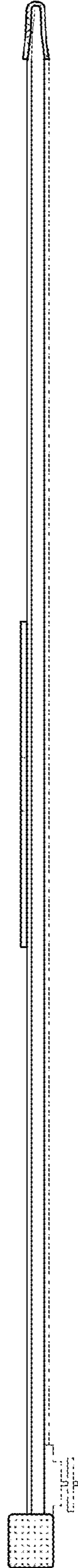
