**DESCRIPTION**

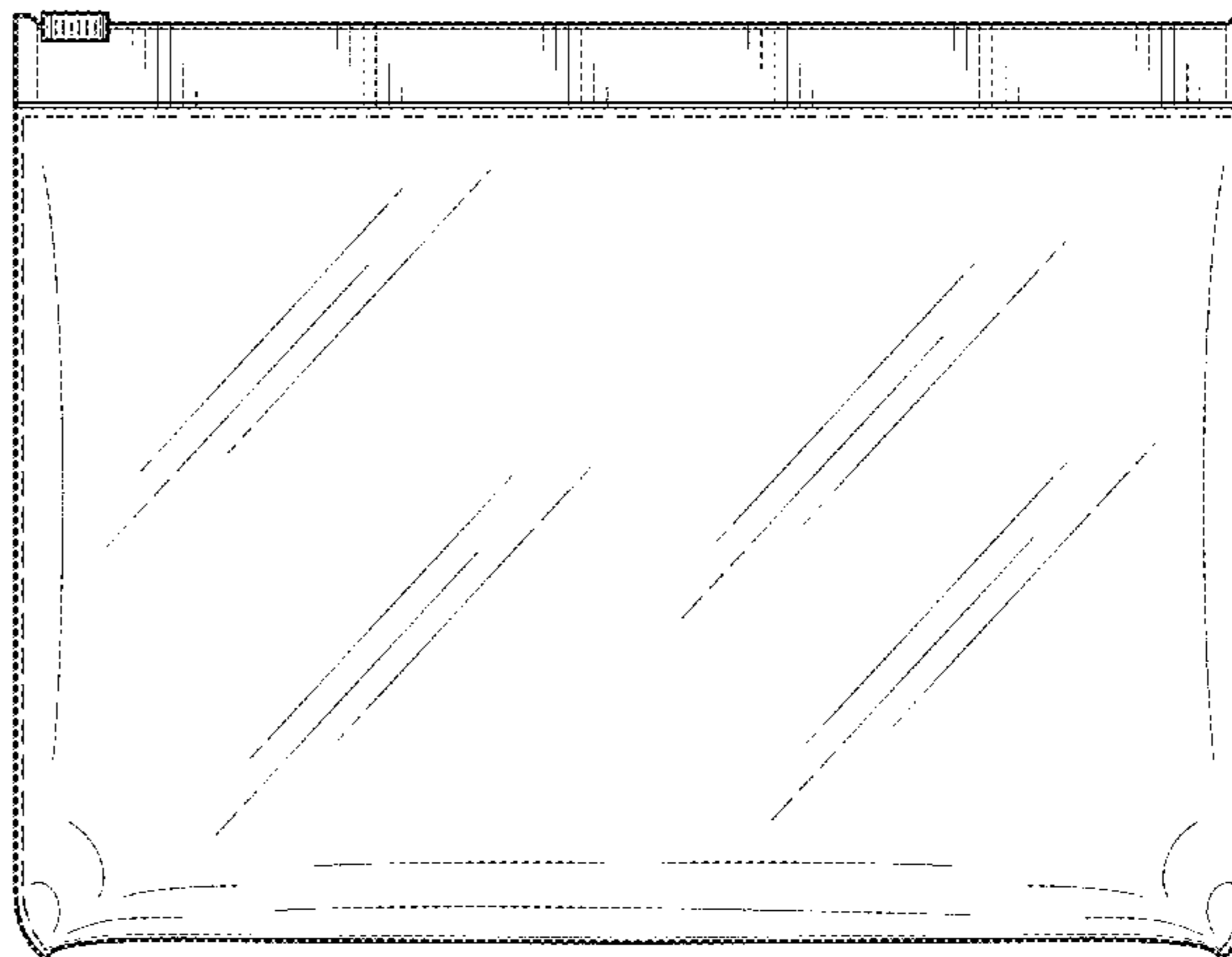
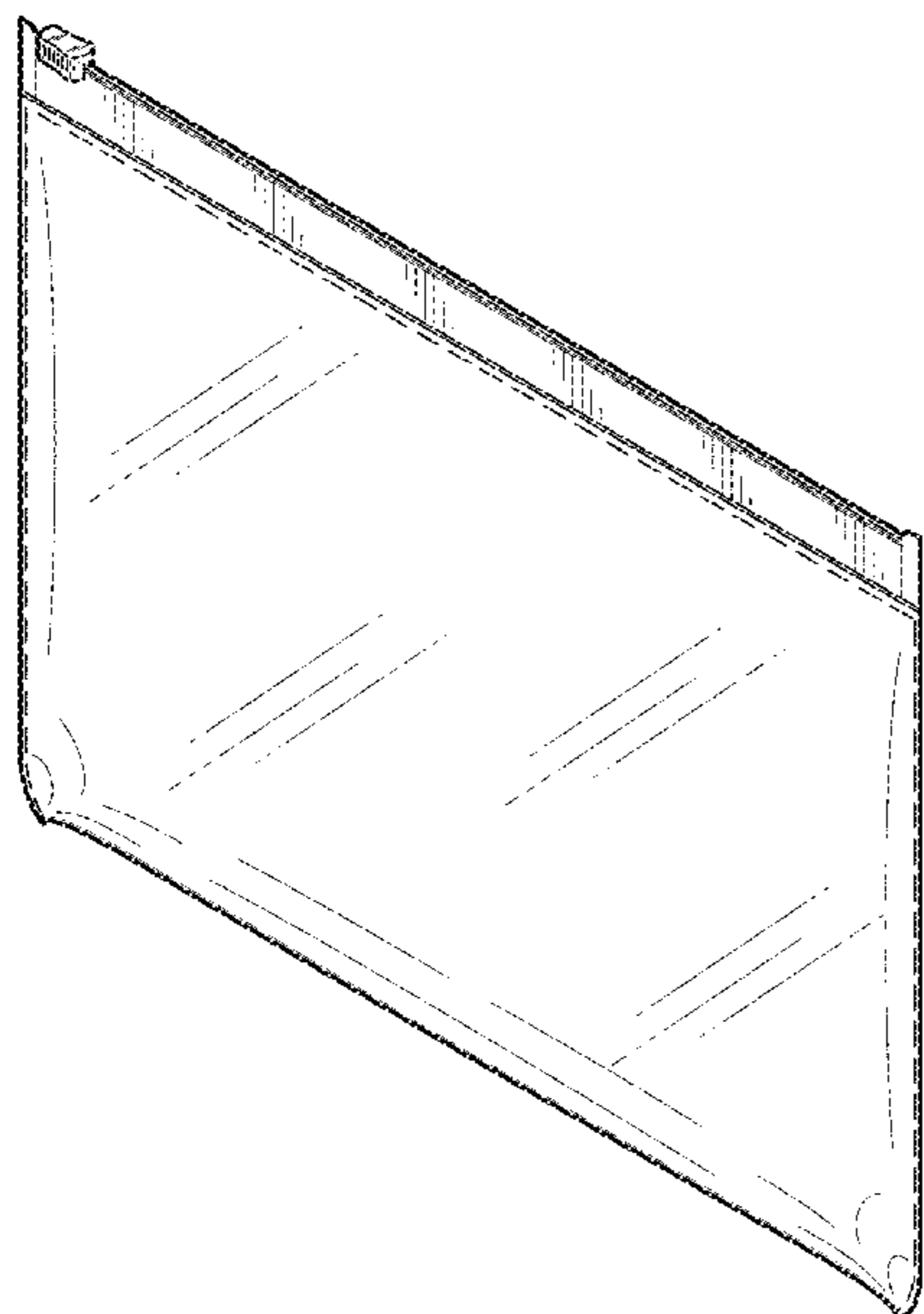
FIG. 1 illustrates a front perspective view of the new design for a water resistant pouch;

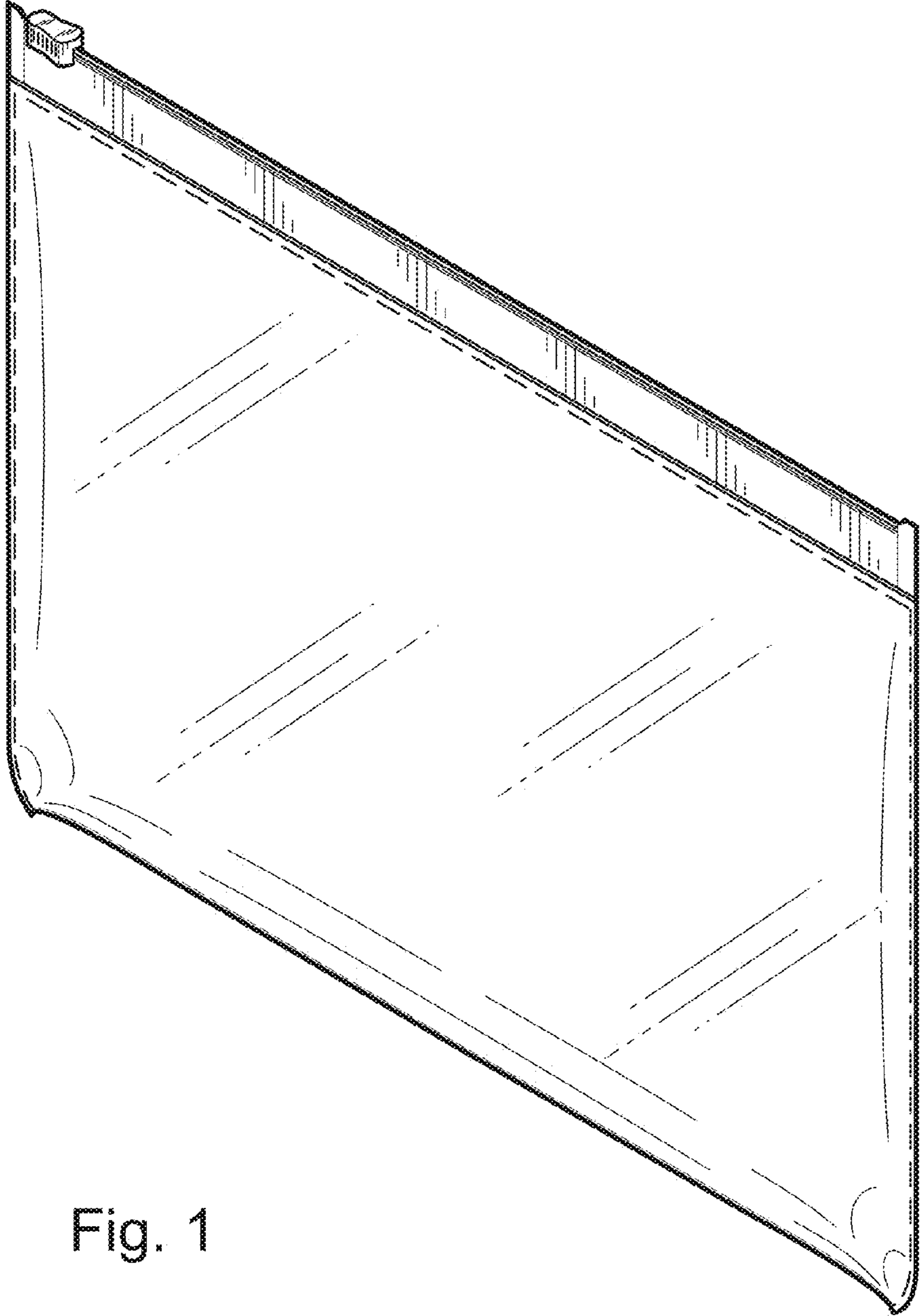

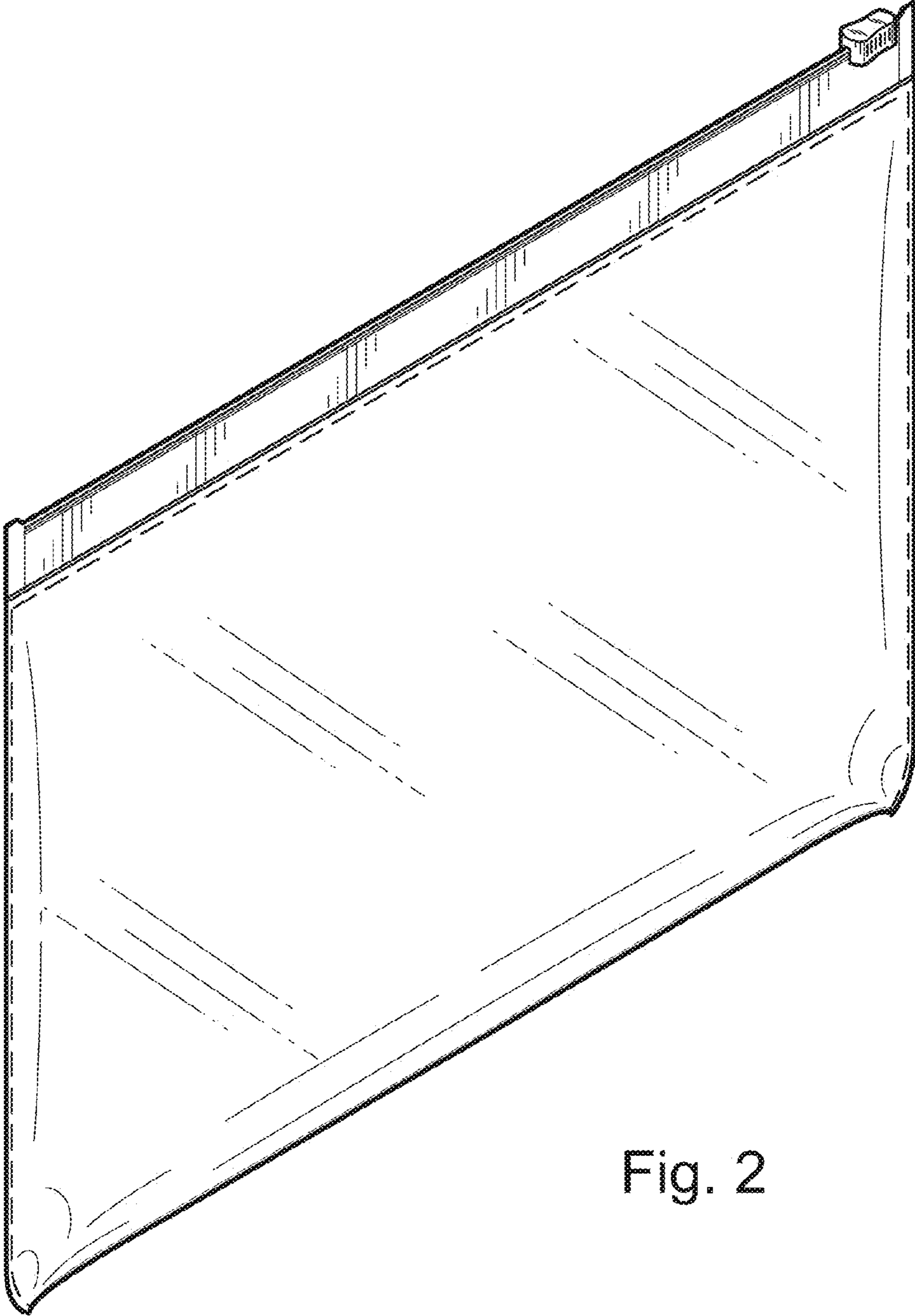

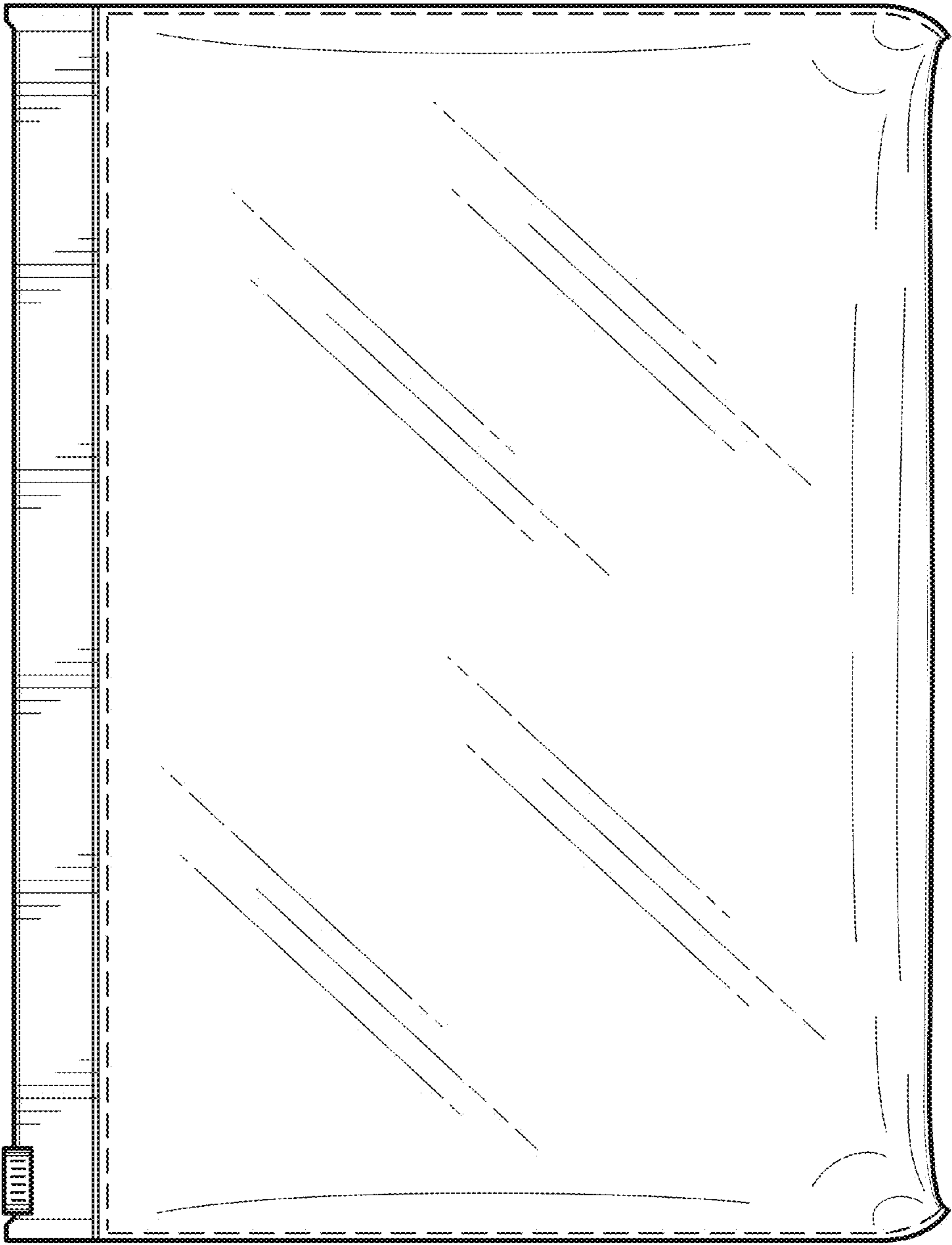

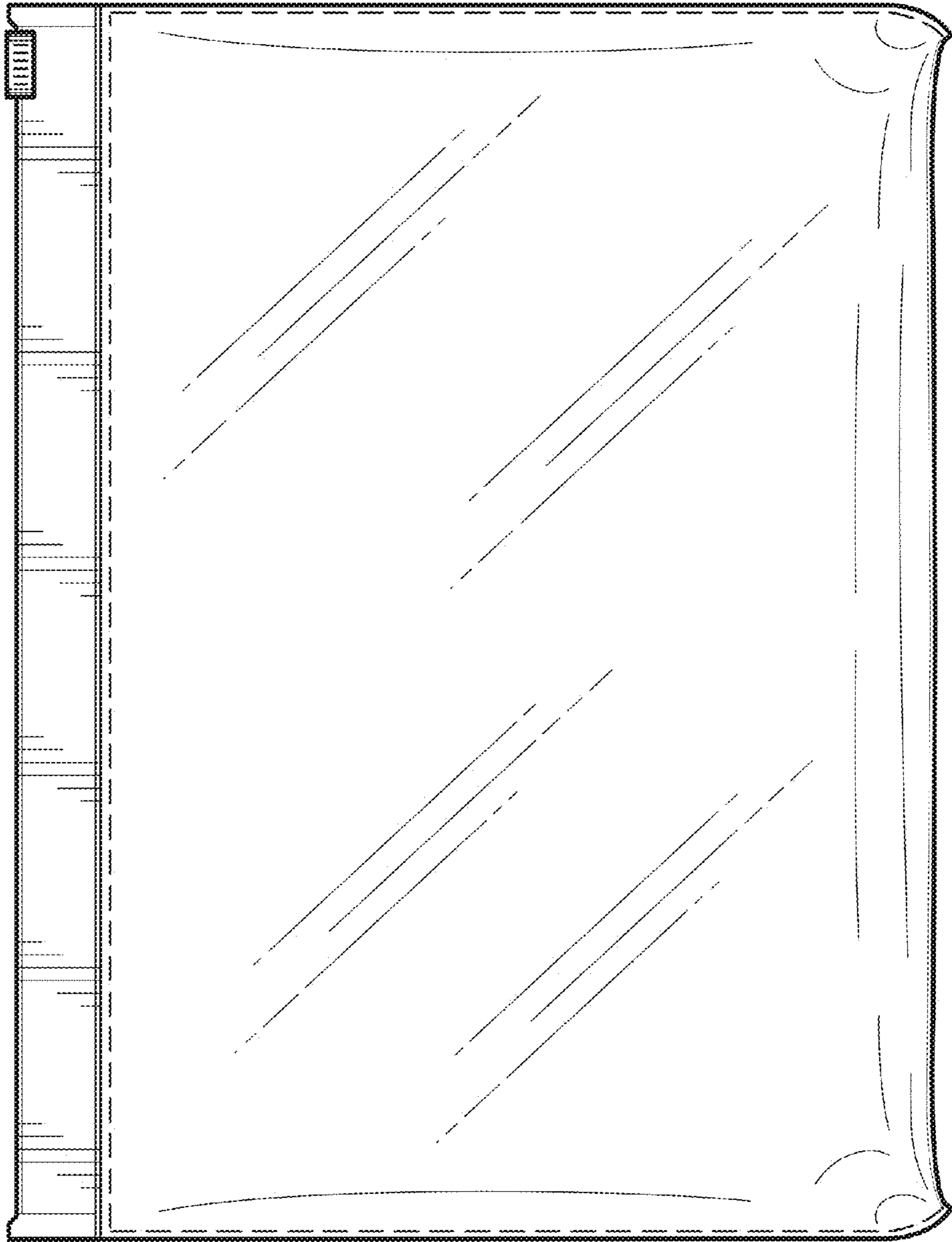

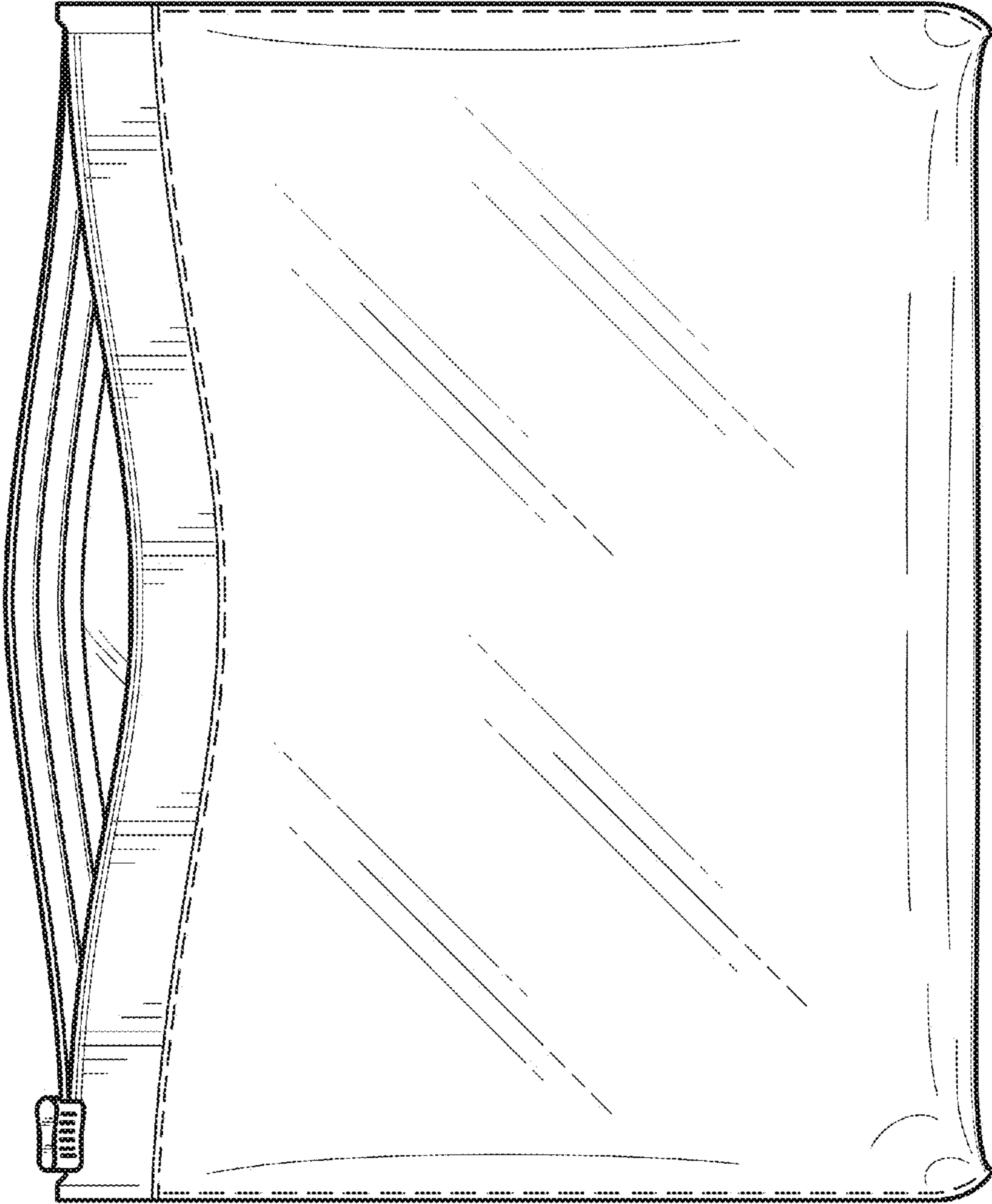
