**DESCRIPTION**

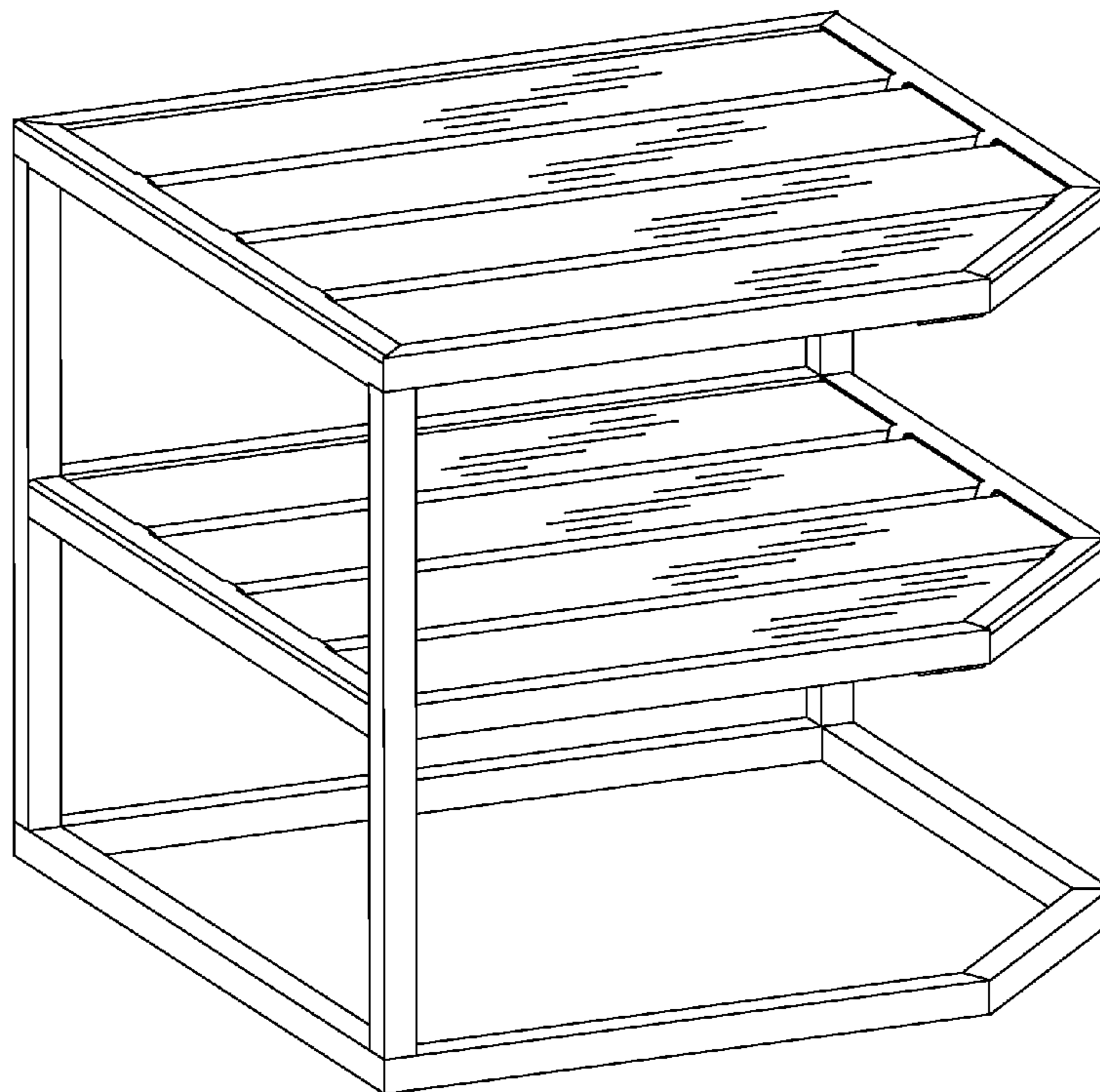
FIG. 1 is a perspective view of a corner shelf organizer showing the new design;

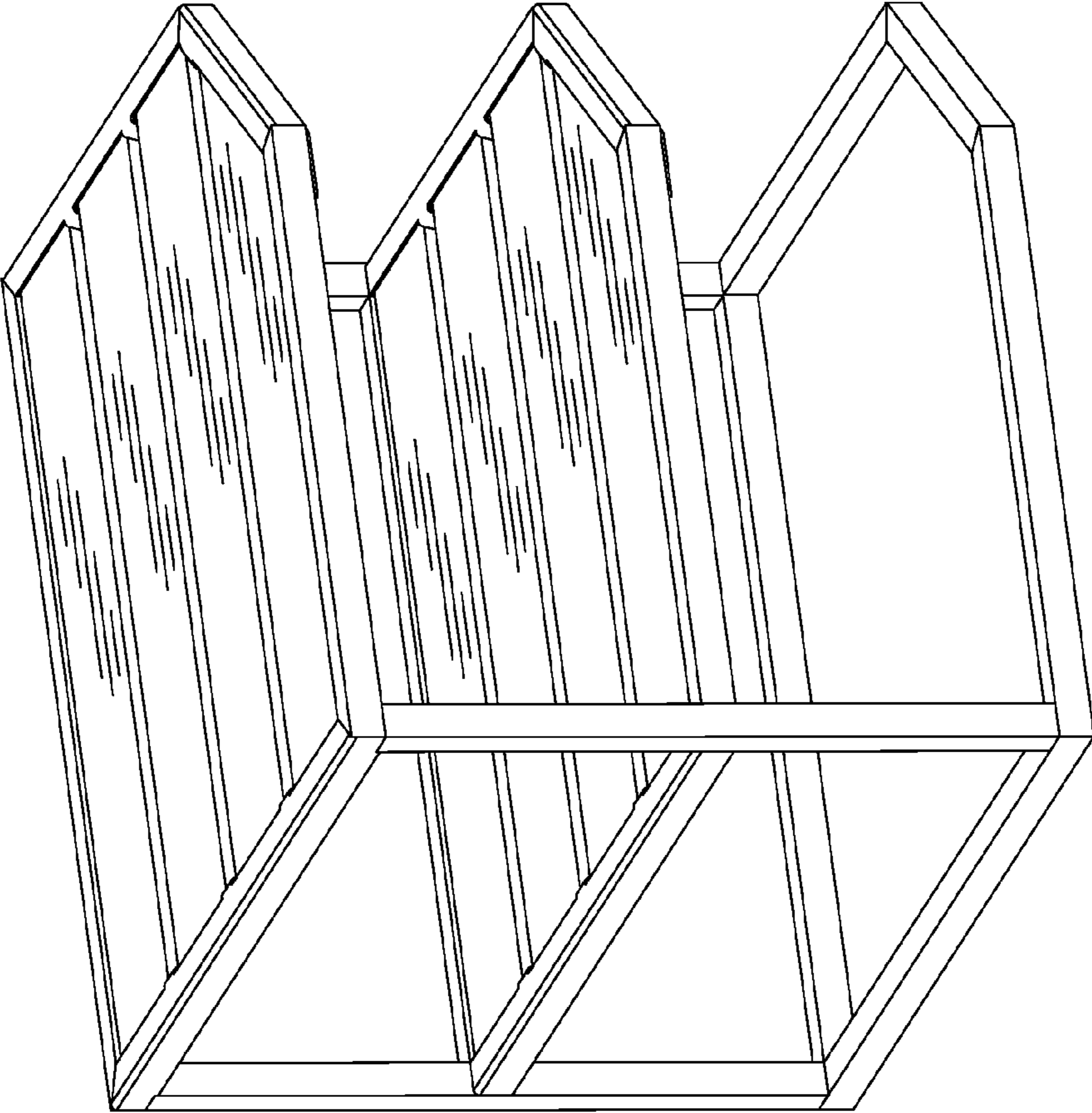

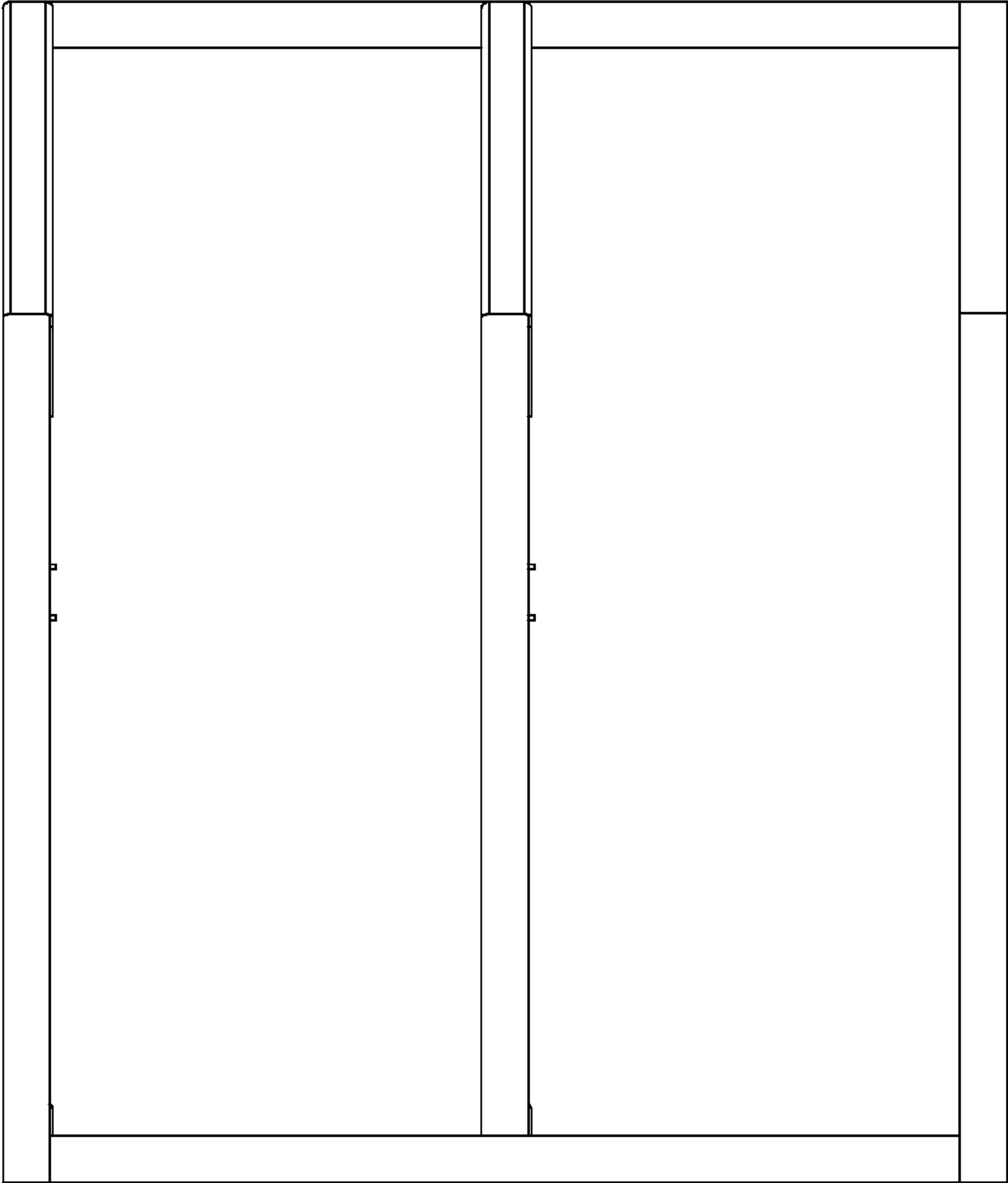

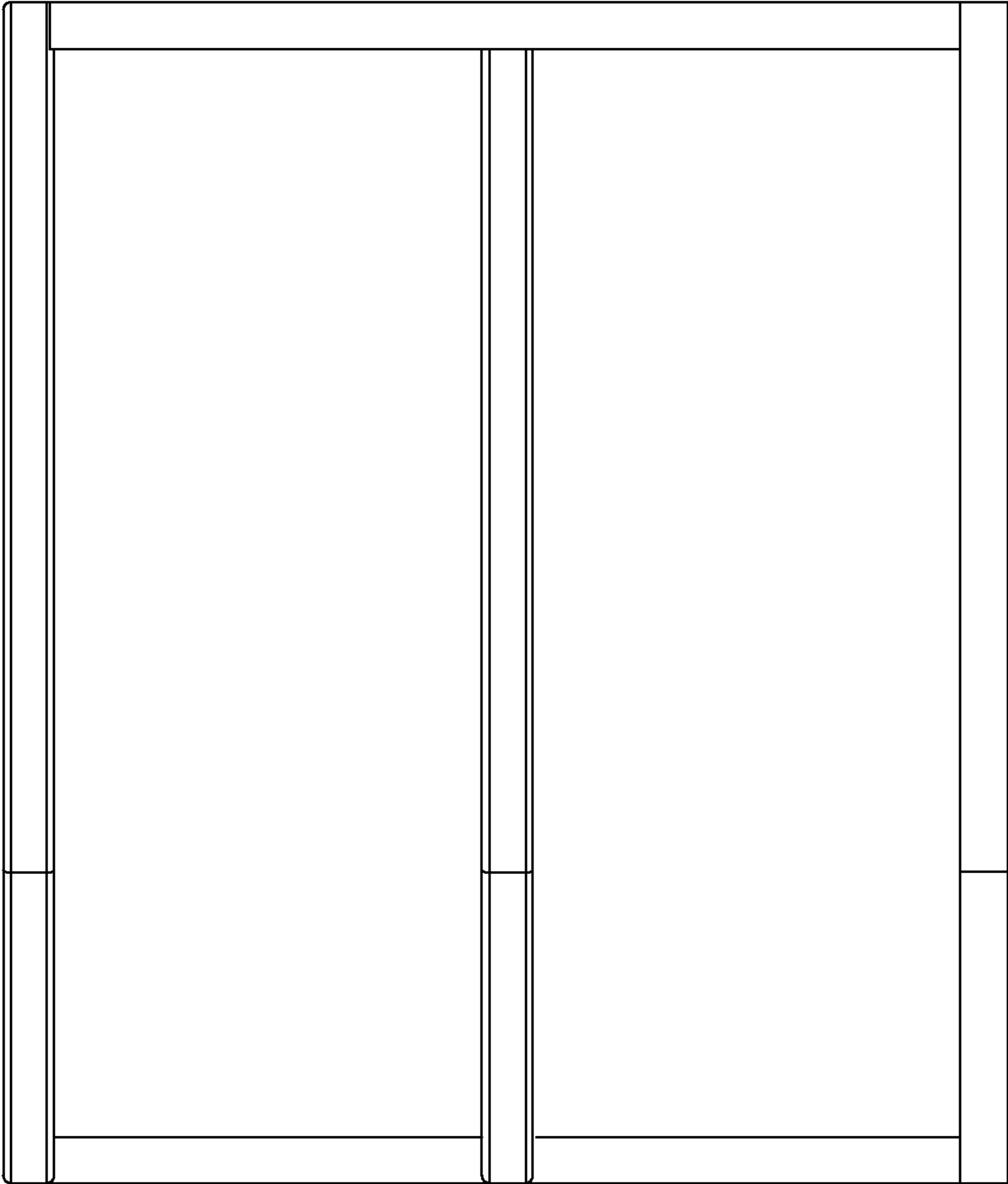

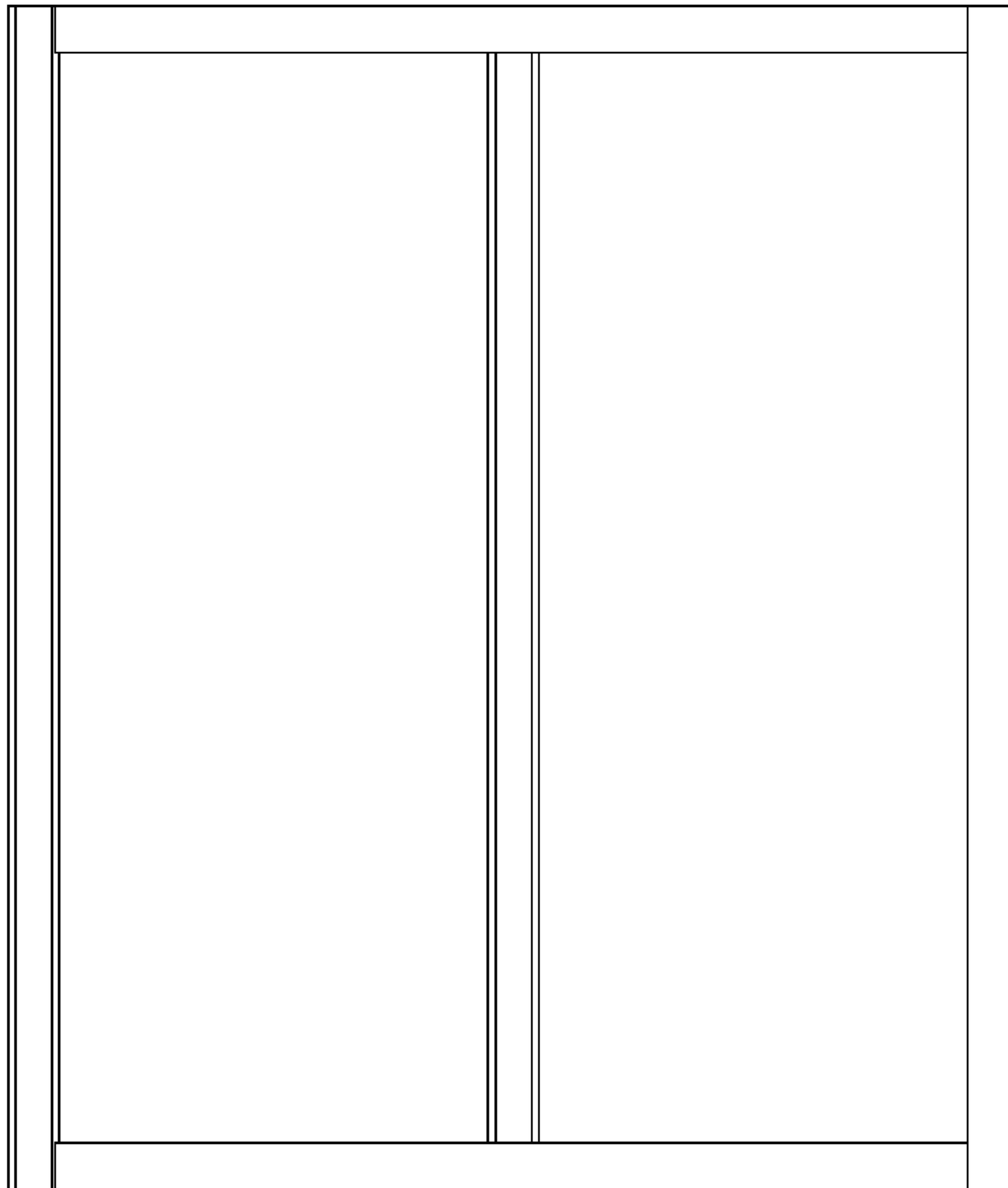

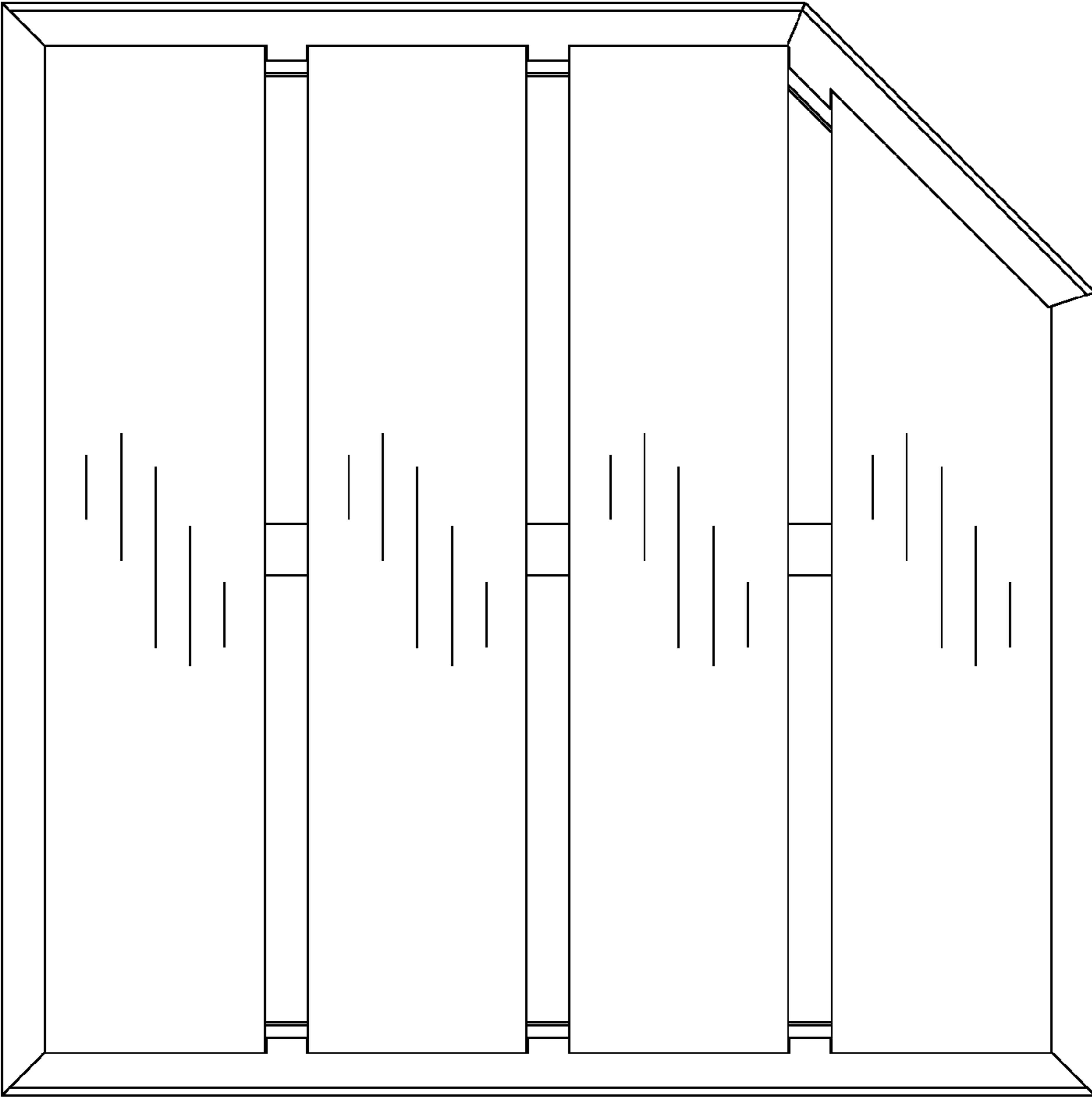

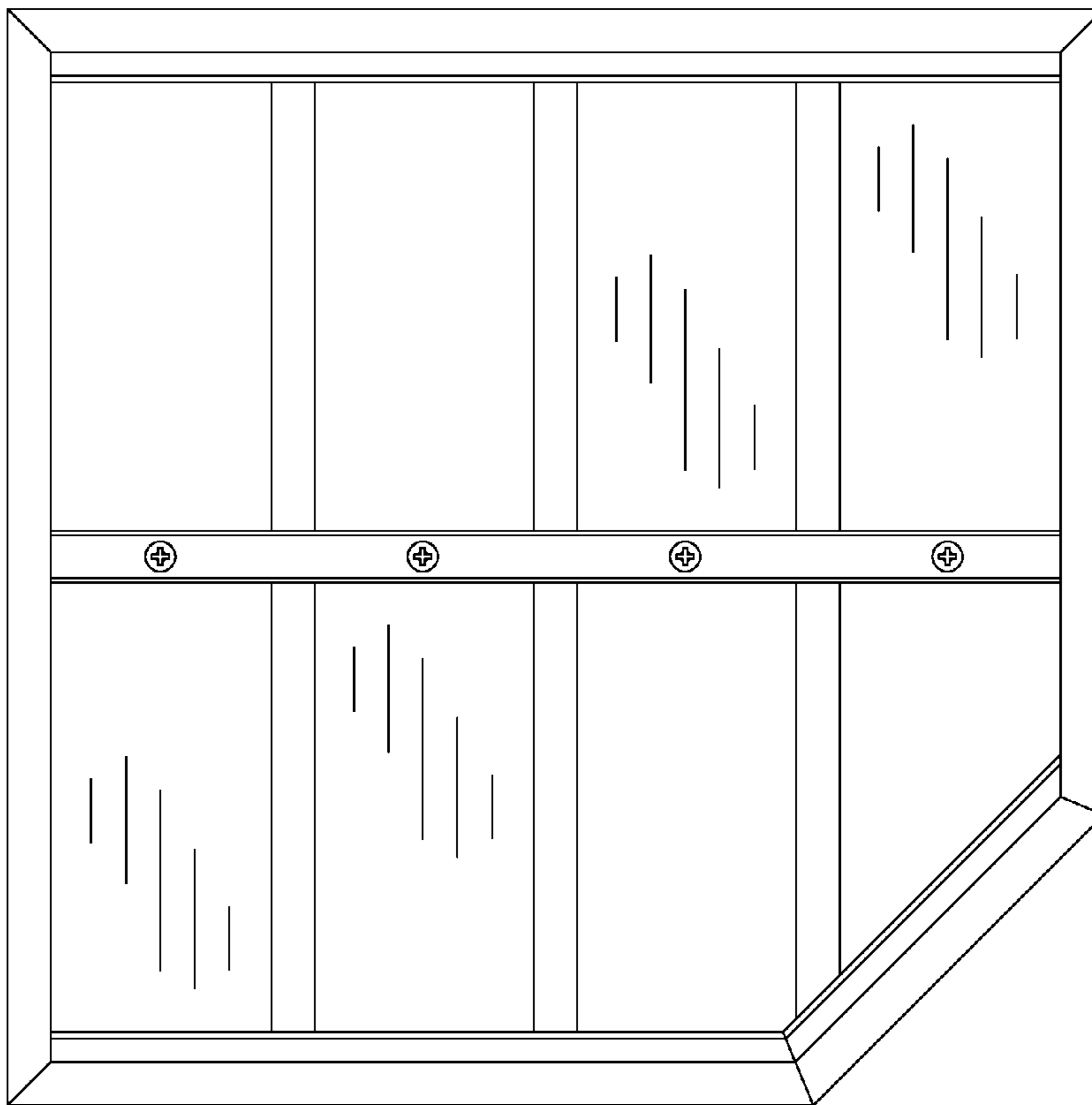

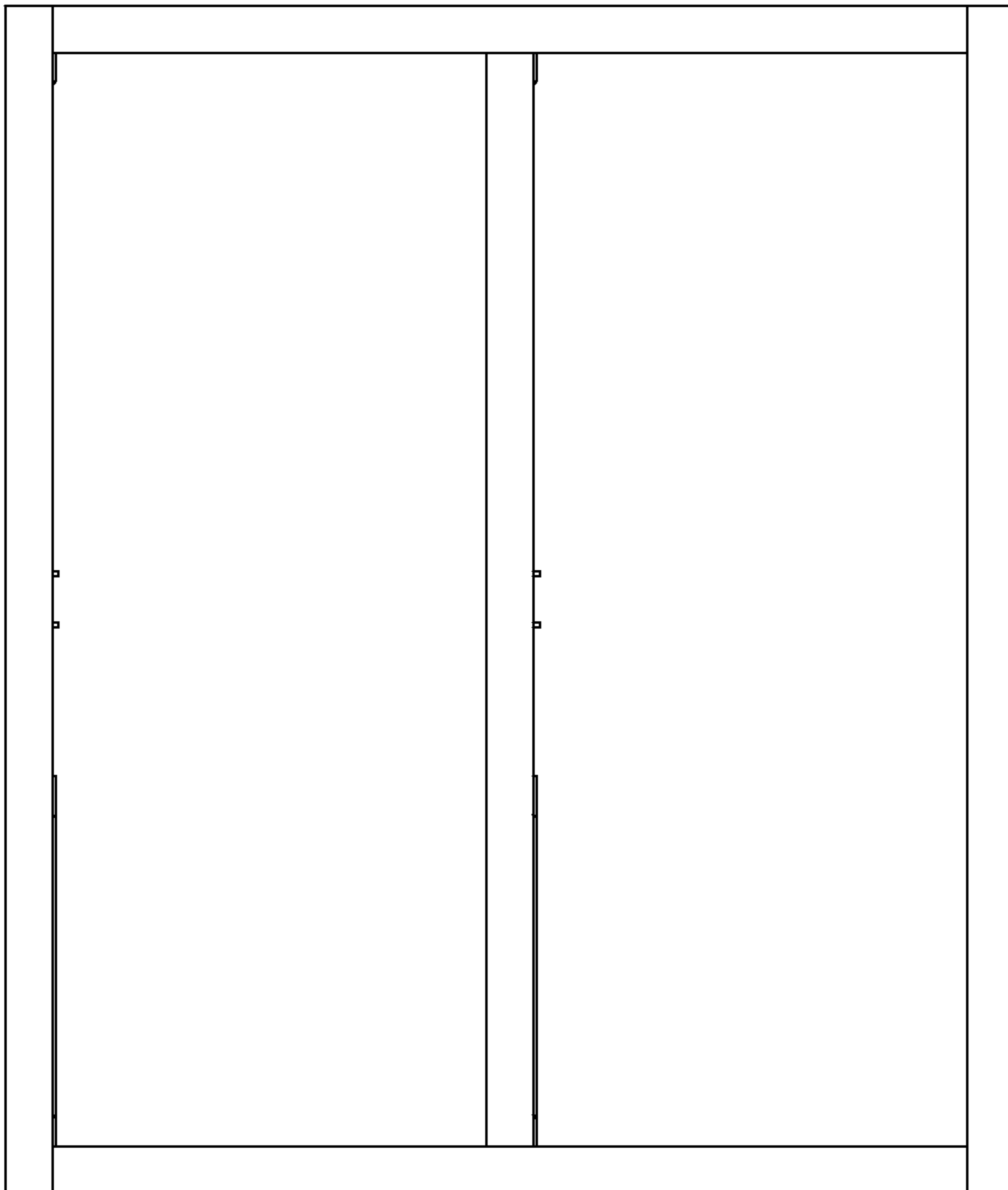
