(57) **CLAIM**

The ornamental design for a container with lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the container with lid according to a first embodiment of the present invention;  
 FIG. 2 is a back view of the container with lid as shown in FIG. 1;  
 FIG. 3 is a top view of the container with lid as shown in FIG. 1;  
 FIG. 4 is a left side view of the container with lid as shown in FIG. 1;  
 FIG. 5 is a right side view of the container with lid as shown in FIG. 1;  
 FIG. 6 is a front left side perspective view of the container with lid as shown in FIG. 1;  
 FIG. 7 is a front view of the container according to a second embodiment of the present invention;  
 FIG. 8 is a top view of the container with lid as shown in FIG. 7;  
 FIG. 9 is a left side view of the container with lid as shown in FIG. 7; and,  
 FIG. 10 is a front left side perspective view of the container with lid as shown in FIG. 7.  
 The back and right side views of the container with lid of the second embodiment of the design are the same as the corresponding views of the first embodiment of the design and are therefore not shown.
