FIG. 1 is a front view of a bottle showing my new design (with the rear view being the same);

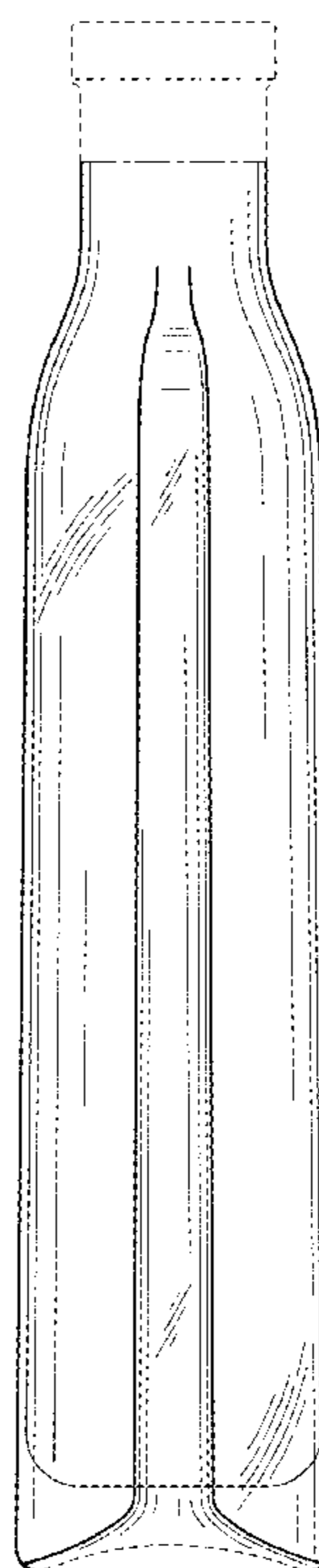
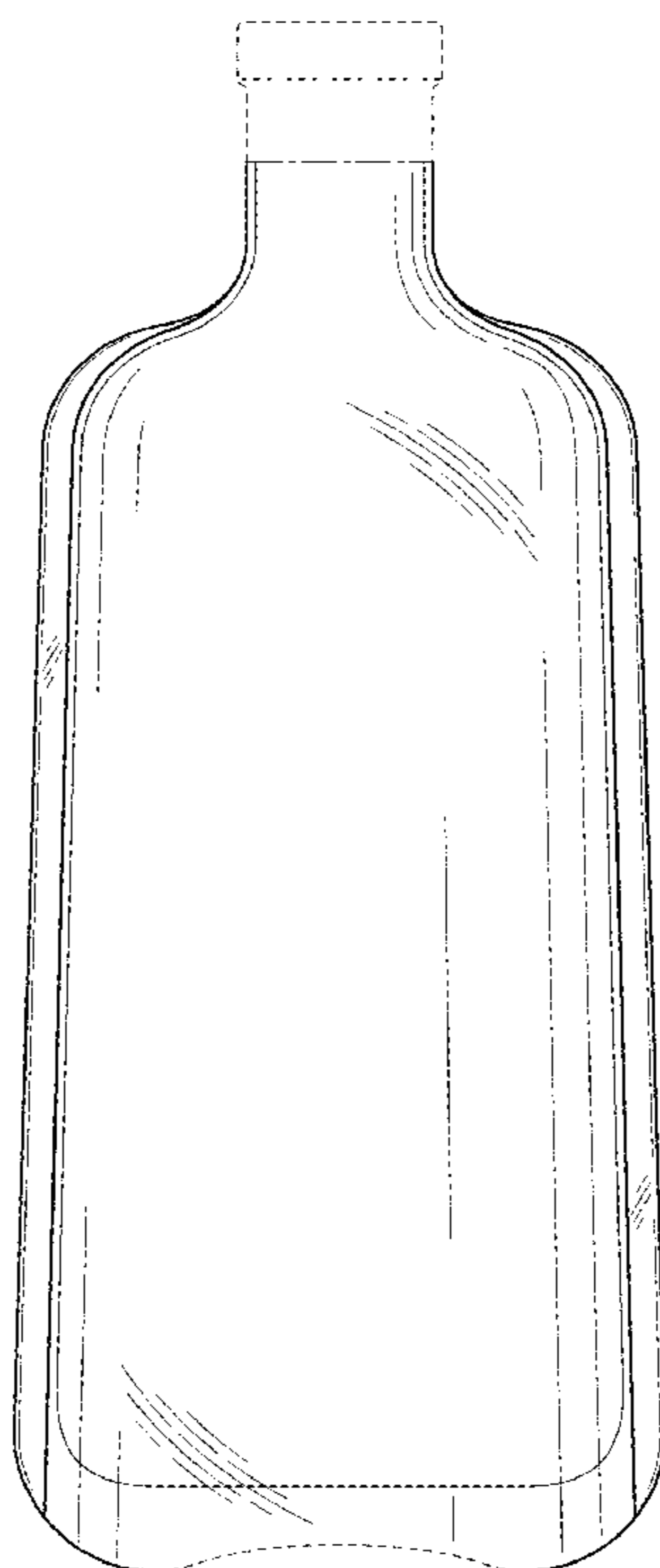
FIG. 2 is a side view of the bottle shown in FIG. 1 (with the opposite side view being the same);

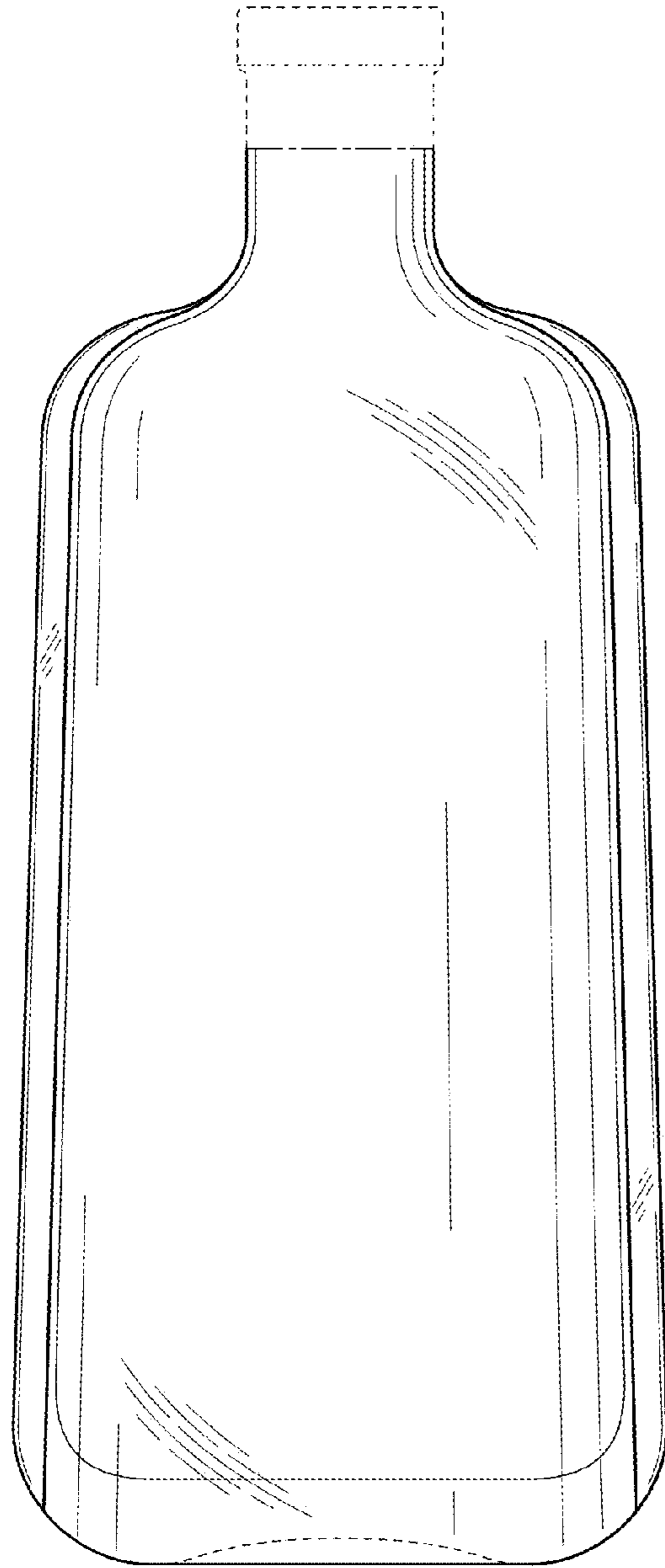

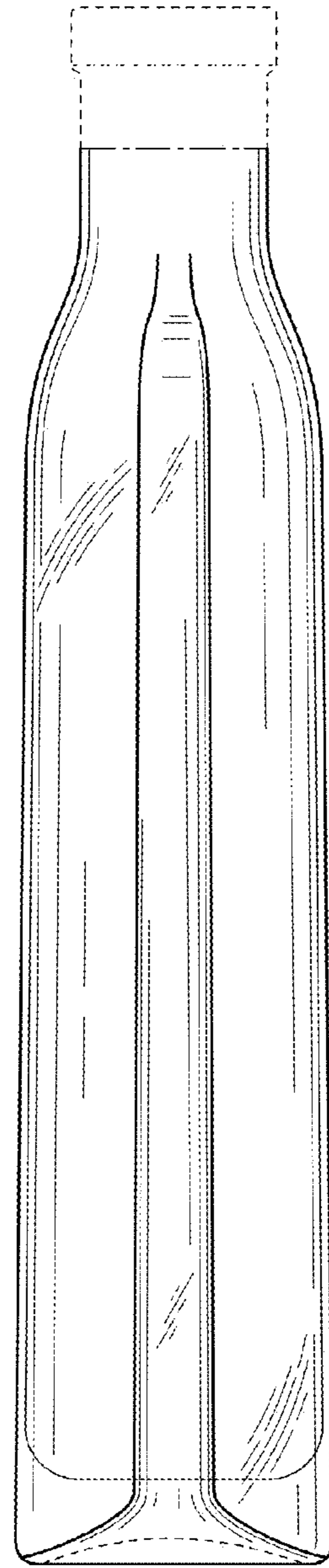

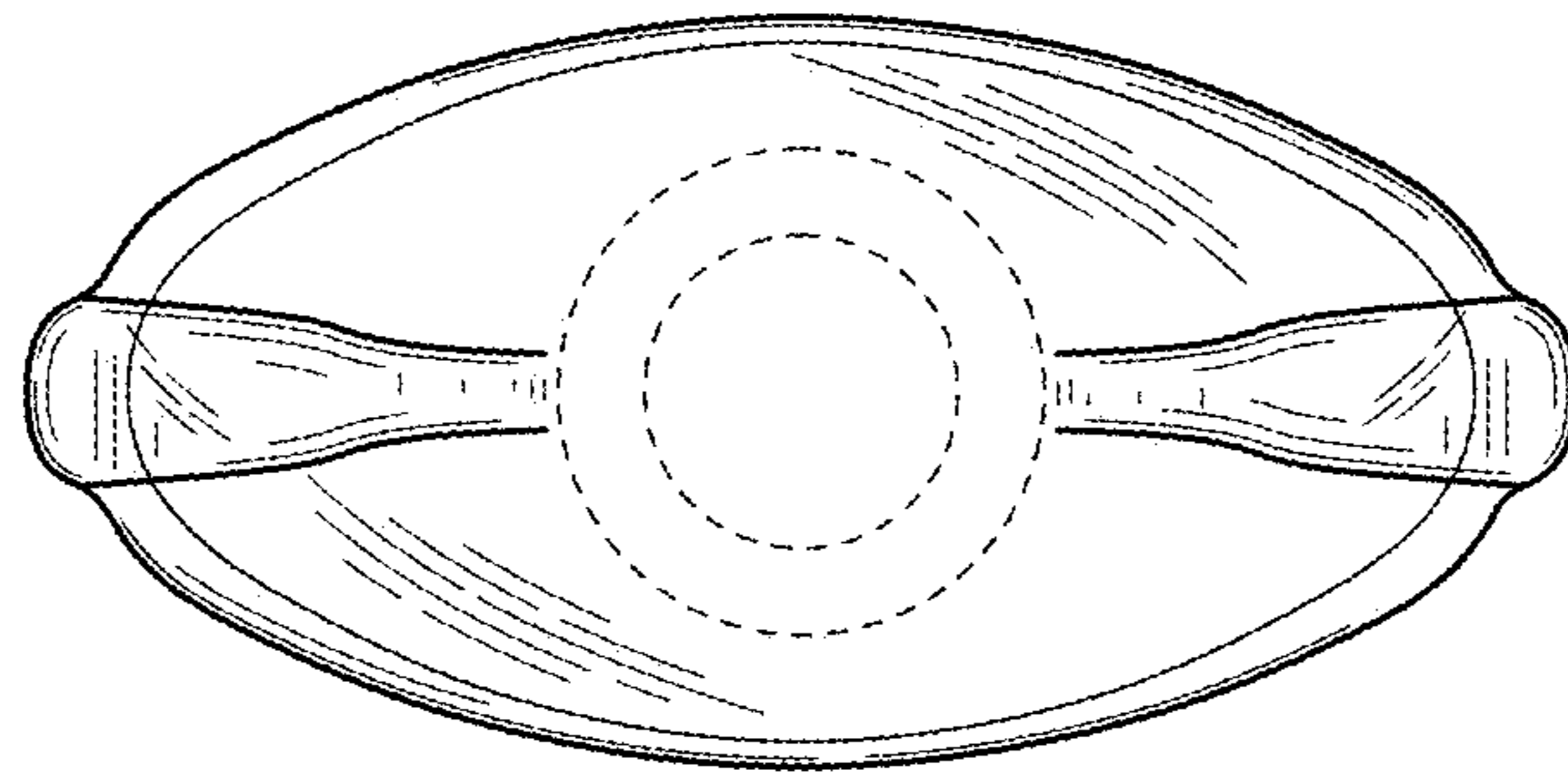

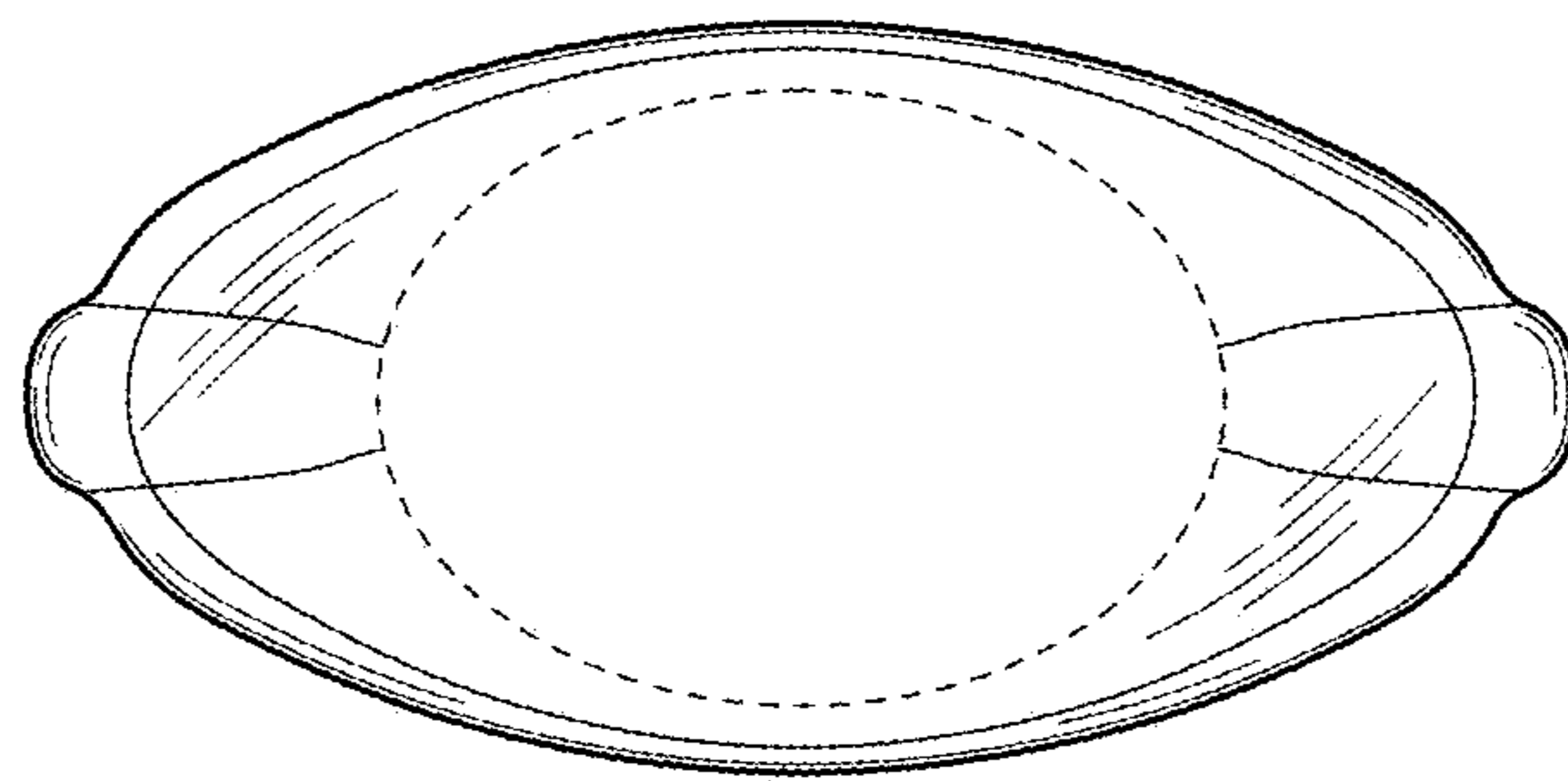
